Breakdown of Di usion in Dynamics of Extended W aves in M esoscopic M edia

We report the observation of nonexponential decay of pulsed m icrowave transm ission through quasi-one-dimensional random dielectric media that signals the breakdown of the di usion model of transport for temporally coherent extended waves. The decay rate of transm ission falls nearly linearly in time due to a nearly gaussian distribution of the coupling strengths of quasi-norm al electrom agnetic modes to free space at the sample surfaces. The peak and width of this distribution scale as L $^{2:05}$ and L $^{1:81}$, respectively.

The di usion model is widely applied to electronic, neutron, and therm al conduction as well as to acoustic and electrom agnetic propagation in multiply scattering media. The model is used not only when the phase of the wave is scram bled by inelastic scattering, but also when the wave is temporally coherent in mesoscopic sam ples [1, 2]. A lthough wave interference leads to large intensity uctuations within a particular sam ple, the ensem ble average of the ux reaching a point is generally assumed to be the incoherent sum of contributions of random ly phased, sinuating Feynm an paths reaching that point. In thism odel, the average intensity varies sm oothly in space and tim e and is governed by the di usion equation.

D i usion has been taken as the counterpoint to wave localization [3, 4, 5]. On one side are sharply de ned localized modes with the average level spacing exceeding the typical level width and on the other are di using waves, for which > with $D \stackrel{2}{=} I_{\mu}$ where D is the di usion coe cient and L is the sam ple thickness [5]. However, the mode picture is inescapably a wave picture and at variance with particle di usion in a num ber of respects. First, the di usion equation is of

rst order, whereas the wave equation is of second order in time. The time evolution of the wave at any instant should therefore depend not only upon the spatial distribution of the particle density or intensity at that instant, as it does in the particle di usion picture, but also on the previous history of the wave. Second, the particle picture represents the intensity as a discrete sum over di usion modes, whereas the wave picture describes the eld as a superposition of quasi-norm alm odes with a continuum of decay rates in a random ensemble. The decay rates of the di usion modes are given by $1 = n = n^2 {}^2D = (L + 2z_0)^2$, where n is a positive integer and z_0 is the boundary extrapolation length. A fter a time 1, the intensity distribution settles into the lowest di usion mode and decays at a constant rate, 1 = 1. In contrast, the decay rates of quasi-norm almodes in a random ensemble should be a continuum. As time progresses, long-lived quasimodes would contribute more substantially and the rate of ow out of the sam ple would slow down continuously. Nonexponential decay has been observed in acoustic scattering in reverberant rooms [6] and solid blocks [7] as well as in m icrow ave scattering in cavities whose underlying ray dynam ics is chaotic [8]. Sim ilarly, the decay rate of electronic conductance has been predicted to fall as a result of the increasing weight of long-lived, narrow-linew idth states [9]. The leading correction to the di usion prediction for the electron survival probability P_s (t) was calculated by M irlin [10] using the supersymmetry approach [11] to be, $\ln P_s$ (t) = (t= 1) (1 t=2 ²g 1), where g is the dimensionless conductance, which can be expressed as g = 0.

An ideal way to investigate the applicability of the di usion model to mesoscopic systems is to consider pulsed electrom agnetic transmission. Previous studies [12, 13, 14, 15] have found exponential decay for t > 1, as predicted by di usion theory. How ever, measurements of optical transmission [14] indicate that the pulse rises earlier than predicted by di usion theory. Even more puzzling is the nding by K op et al. [15] of an increase in the inferred value of the di usion coe cient with increasing L.

In this Letter, we report a dram atic breakdown of diffusion in m icrow ave measurements in nom inally dissive random samples for which >. We not that the decay rate of pulsed transmission falls nearly linearly in time, as predicted by M irlin [10]. These results are interpreted in terms of the distribution of decay rates of quasimodes of the sample, which is found by taking the inverse Laplace transform of the decaying signal. The distribution of the modal decay rates is nearly gaussian, with an average value that scales as L^{2:05}, which is close to the inverse square scaling for the decay rate in the diffusion m odel. The width falls as L^{1:81}, which is faster than predicted by Ref. [10].

Spectra of the in- and out-of-phase components of the steady-state transmitted microwave eld are measured in low-density collections of dielectric spheres using a Hew lett-Packard 8772C vector network analyzer. These spectra are multiplied by a gaussian envelope of width

f centered at $f_{\rm c}$ and then Fourier-transform ed to give

the response to a gaussian pulse in the tim e dom ain. C ircular homs are positioned 30 cm in front of and behind the sample. Linearly polarized m icrowave radiation is launched from one horn and the cross-polarized com ponent of the transmitted eld is detected with the other to eliminate the ballistic component of radiation. The sam ple is composed of alum in a spheres of diam eter 0.95 cm and refractive index 3.14, contained within a 7.3-cm diam eter copper tube at an alum ina lling fraction of 0.068 [16]. This low density is produced by embedding the alum in a spheres in Styrofoam spheres of diam eter 1.9 om and refractive index 1.04. M easurem ents for random ensem bles are obtained by m om entarily rotating the tube about its axis to create new random con gurations before each spectrum is taken. In this way, measurements are carried out in ensembles of 10,000 sample realizations at lengths of 61, 90, and 183 cm . In addition, m easurem ents are made in an ensemble of 2,300 realizations of a more strongly absorbing sample of 90 cm length (L = 90 cm) produced by covering 40% of the inside surface of the tube with a thin strip of titanium foil laid from end to end. The measurements are made within the frequency interval 14.7-15.7 GHz for L = 61, 90 and 90 cm and 15.0-15.4 GHz for L = 183 cm. The frequency intervals are chosen to be far from sphere resonances [16], so that the dynamics of transmission is uniform over the frequency range and the sample is far from the localization threshold. The closeness to localization, even in the presence of absorption, is indicated by the variance of the steady-state transmitted intensity normalized to its ensemble average value, var (I=hIi) [17]. In the absence of absorption, var(I=hIi)' 1 + 4=3g [17, 18]. At the localization threshold, var (I=hIi) ' 7=3. The values of var(I=hIi) in the sam ples of L = 61,90, 90, and 183 cm are 1.18, 1.25, 1.26, and 1.50, respectively.




FIG.1: (a) A verage transm itted intensity in the alum ina samples of L = 61 (red), 90 (purple), 90 (blue), and 183 cm (green). (b) Tem poral derivative of the logarithm of the intensity gives the rate of the intensity decay due to leakage out of the sample and absorption. The thin black curves are the decay rates of the di usion model with D , z_0 , and a from Table I.

The envelope of the tem poral response to a gaussian pulse peaked at t = 0 is squared to give the transm itted intensity I (t) for a particular sam ple realization. The average transmitted intensity hI (t) i is found by averaging over the ensemble, and then over the frequency interval by shifting f_c . The results are shown on a logarithm ic scale in Fig.1a. We nd that, when f >, the tail of hI(t)idoes not depend on f.We use f = 15 M Hz forL = 61, 90, and 90 cm and f = 7.5 M H z for L = 183cm, so that f >in all cases. The noise in the frequency spectra produces a constant background intensity in the time domain. Once this background is subtracted, a dynamic range of more than 6 orders of magnitude is achieved. This makes it possible to study transmission on time scales an order of magnitude longer than the time of peak transm ission, though the longest times are still smaller than the inverse level spacing, 1= which gives the time required for a photon to explore each coherence volum e of the sam ple. The m easured decay rate due to leakage out of the sam ple and absorption, = d lnhI (t) i=dt, is plotted in Fig. 1b. This rate is not




FIG.2: Fit of the di usion model to 95% of the full pulse energy (circles) transmitted in the alum ina sam ples of L = 61 (b), 90 (c), 90 (d), and 183 cm (e). The solid curves show the t. (a) is the incident pulse of f = 15 MHz used to obtain (b), (c), and (d); a pulse of f = 7.5 MHz was used to obtain (e). All the curves are normalized.

constant as predicted by di usion theory, but falls nearly linearly with time. The constant increase in the decay rate for the L = 90 sample over that for the L = 90sample, seen in Fig. 1b, indicates that the absorption rate 1 = a is constant in time. The decrease in with time is thus attributable solely to propagation out of the sam ple, which proceeds at a rate, ${}^{2}D$ (t)=(L + 2z₀)². The absorption rate is found from a tof the di usion model [12, 13, 14] to measurements of hI(t) i up to the time at which 95% of the full pulse energy has been transmitted (Fig. 2). The t is obtained by taking D (t) to be a constant, D , and by minimizing the parameter $^{2} = (^{2})^{1}$ [hI (t) i_i $I(t_i)^2$, where hI(t) i_i are the values of the measured intensity, is the uncertainty in $hI(t)i_{i}$, averaged over the time of the t, and I(t) are the values of the model intensity [14] calculated at t_i . The parameters D , $_{a}$, and z_{0} obtained from the $\ t$ are listed in Table I and the corresponding decay rates are shown by thin solid lines in Fig. 1b. For L = 61 cm, ² at the minimum depends only weakly on _a since the tem poral range used in the t is sm aller than the a. For this reason, we use the value a = 97 ns obtained in the t to the data for L = 183 cm for this length.

The di usion coe cient D obtained from the t is found to decrease slightly with increasing L. The equal-




FIG.3: (a) Leakage rates in alum ina sam ples with L = 61 (red),90 (purple),90 (plue), and 183 cm (green). The black curves are the best t to the data by a polynom ial of power 2. (b) T in e-dependent di usion coe cients", D (t) = ($1 = {}_{a}$) (L + $2z_{0}$)² = ², plotted versust⁰ = t=g ₁. (c) D (t) plotted versus t⁰ = t= \overline{g}_{1} .

ity of the values of D and z_0 for the sam ples with L = 90and 90 cm, seen in Table I, indicates that these param – eters are not sensitive to the absorption rate. M oreover, when 1 = a is subtracted from to give the decay rates without absorption in Fig. 3a, the sam e time-dependent decay is found for both sam ples with length of 90 cm.

The leakage rates in Fig. 3a give the \tim e-dependent di usion coe cient", D (t) = $(1=_a)(L + 2z_0)^2 = 2$. The values of D (t) found from the measurements may be compared to those from the theory of Ref. [10] for the survival probability, which yields D (t) = D (1 t = 2 g 1 + :::). This is done by plotting D (t) as a function of the dimensionless time $t^0 = t = g_1$ in Fig. 3b. The time g_1 is proportional to 1= and all the data are predicted to fall on a single curve. Although the data for sam ples with di erent values of L at a given time appear to coincide within the noise, there is a clearly discernable decrease in the slope of D (t^0) as L increases. As a result, the curves do not extrapolate to a constant bare di usion coe cient at t = 0. W hen D (t) is plotted instead versus the dimensionless time $t^{0} = t = p^{0} \overline{g}_{1}$ in Fig. 3c, the slope of D (t⁰⁰) appears to be the sam e for all values of

L, though the curves do not overlap. A strong deviation from exponential decay at t^{00} 1 has also been found in num erical simulations [20].

The changing slope of D (t) with L is associated with the scaling of the width of the distribution P () of decay rates of quasi-norm almodes of the sample. These are hypothesized to form a complete set [19], even when

> . Since the time evolution is given by the superposition of these modes [19], the average transmission can be expressed as hI(t)i / ${n \atop 0}^1$ P() exp(t)d, provided the mode coupling is, on the average, independent of . To nd P(), we use an approximate Laplace in-




FIG. 4: D istribution of the m odal decay rates, P (), in the alum ina sam ples of L = 61 (red), 90 (blue), and 183 cm (green). Inset: scaling of the average h i (circles) and of the width (squares) of P (), and the corresponding best t to (L + 2a) (solid) are shown on the log-log scale. The best ts are obtained with exponents of 2:05 and 1:81 for h i and , respectively.

version algorithm based on the W eeks method [21]. A polynom ial of power 2 is t to the decay rates in Fig.3a. These ts are then used to compute curves hI (t) i, which are inverted to obtain the distributions P () shown in Fig.4. Note that a linear decrease in (t) with time as (t) = a btwould correspond to a gaussian distribution of P () with h i = a and var() = 2 = b. Since the decay of (t) is nearly linear, P () is nearly gaussian.

The scaling of the average decay rate due to leak-age out of the sample, seen in Fig. 4, is given by h i / $(L + 2z_0)^{2:05}$. This is close to the inverse square scaling of the di usion model and suggests that the dynam ics observed is characteristic of extended waves and is not associated with the approach to localization with increasing L. The width of the distribution scales as $p/(L + 2z_0)^{1:81}$. This is close to the scaling, $/ \frac{b}{b} / 1 = g^{1=4} \frac{1}{1} / L^{1:75}$, and di ers from the scaling ing predicted by Ref. [10], $/ \frac{b}{b} / 1 = \frac{p}{g} \frac{1}{1} / L^{1:5}$.

The wide distribution of the modal decay rates in thin sam ples may be the source of the sharp spectral peaks observed in amplifying random media [22, 23]. In these sam ples, lasing would occur in the longest-lived modes, which have the lowest critical gain [24].

In conclusion, we have found nonexponential decay of pulsed transm ission through disordered m edia in which the level width exceeds the spacing between levels, even at long times and in thick samples. This departure from di usion theory is interpreted in terms of the decay rate statistics of electrom agnetic quasi-norm alm odes. The statistics of these m odes is fundam entalto understanding the static and dynam ic behavior of waves in both passive and active random m edia. D iscussions with X. Zhang, R L. W eaver, T.
