Urban tranport phenom ena in the street canyon

A bstract

A eld determ inistic model of the vehicular dynam ics in a generic urban street canyon with two neighboring canyons is considered. The assumed hydrodynam ical model of vehicular movement is coupled to the gasdynam ical model of the air and emitted pollutants. The vehicles are assumed to move on distinct left lanes and right ones. At the upstream and downstream ends there are coordinated traching clights which introduce control parameters to the eld model. The model of optimal control of street canyon dynamics is based on the two optimal multi-criteria control problems. The problems consist of minimization of the dimensionless functionals of the cumulative total travel time, global emissions of pollutants, and global concentrations of pollutants, both in the studied street canyon, as well as together with the two nearest neighbor substitute canyons, respectively.

I. THE FIELD MODELS OF VEHICLES AND POLLUTANTS.

In the present article we consider two coupled determ in istic eld model of the urban street canyon. The vehicular elds are one-dimensional in spatial variable x and they depend on time variable t. The considered elds are the vehicular number density $k_{\rm lyt}^{\rm s}$ (x;t), vehicular velocity $w_{lyt}^s(x;t)$, em issivity of exhaust gases $e_{lct,yt}^s(x;t)$, and vehicular heat em issivity s levt (x;t), where vt is emission type's number, ct is number of the constituent of emitted exhaust gases. It is assumed that there are $n_1 = n_L$ left lanes s = 1 and 1 is the left lane's number, $l = 1; :::; n_L;$ whereas for $n_2 = n_R$ right lanes s = 2 and l is the right lane's num ber, $l = 1; :::; n_R; vt = 1; :::; VT, ct = 1; :::; CT. VT is total num ber of types of ve$ hicular em issions, and CT is total number of em itted exhaust gases. The abovem entioned m odel consists of the equations of balances of vehicular numbers [5] and vehicular equations of state (G reenshields' equilibrium speed-density u-k model [6]) as well as exhaust gas em issivities and heat em issivities. The vehicular ow in the canyon is multilane bidirectional one-level rectilinear, and it is considered with two systems of coordinated signalized junctions at the upstream and downstream ends of lanes [1], [2], [3], [4]. The considered vehicles belong to distinct vehicular classes: passenger cars, and trucks. Em issions from the vehicles are based on technical measurements of the following types of pollutants: carbon m on oxide CO, hydrocarbons HC, nitrogen oxides NOx. The eld model of pollutants is gasdynamical. The gases are Newtonian viscous perfect and noninteracting. The considered elds are three-dim ensional in spatial variables (x;y;z) and one-dim ensional in temporal variable t and they are m ixture's density (x;y;z;t), velocity v(x;y;z;t), tem perature T(x;y;z;t), pressure p(x;y;z;t), as well as constituents' mass concentrations $c_i(x;y;z;t)$, and partial pressures $p_i(x;y;z;t); i = 1; :::;N$, where N is total number of mixture's elements. (N = N_E $1 + N_A$). The rst N_E 1 = 3 gases are the exhaust gases emitted by vehicle engines during combustion CO; CH; NO $_{\rm x}$. The remaining N $_{\rm A}$ = 9 gases are the constituents of air: 02; N2; Ar; CO2; Ne; He; Kr; Xe; H2. The eld equations are the balances of m ixture's mass, linear momentum, energy, and equation of state (Clapeyron's law) as well as the balances of masses of constituents and constituents' equations of states (Dalton's law). The studied sources are mixture mass source S (x;y;z;t), mixture energy source (x;y;z;t), and constituents' mass sources S_i^E (x;y;z;t) (exhaust gases and consumed oxygen). The boundary-initial problems are of mixed types (Dirichlet's and von Neumann's types). The equations of dynamics are solved by the nitedierence scheme. The two separate multi-criteria optim ization problem s are posed by de ning the dimensionless functionals of cum ulative total travel time, global em issions of pollutants, and global concentrations of pollutants, either in the studied street canyon or in the canyon and its two nearest neighbor substitute canyons. The vector of control is a ve-tuple composed of two cycle times, two green times, and one o set time between the traclights. The optimal control problems consists of m in in ization of the two functionals over the adm issible control dom ain m an ifold.

II. THE GOVERNING EQUATIONS.

Under the abovementioned speci cations, the set of governing equations is formulated as follows [7], [8]:

where $w_{l,vt;f}^s$ is maximum free ow speed, $k_{l,vt;jmm}^s$ is jam vehicular density, is the rst viscosity coe cient for the air, is the second viscosity coe cient, F=g is the gravitational body force density, g is the gravitational acceleration, $D_{im}=D_{mi}$ is the mutual dissivity coe cient from the i-th constituent to m-th one, and D_{ii} is the autodissivity coe cient of the i-th constituent, and $k_{T,m}$ is the thermodission ratio of the m-th constituent, is the mass density of intrinsic (internal) energy of the air mixture, T is the stress tensor, symbol denotes the contraction operation, q is the vector of ux of heat. We assume that [2]:

where $_{i}$ is the mass density of intrinsic (internal) energy of the ith constituent of the air m ixture, m $_{i}$ the molecular mass of the ith constituent, k $_{B}$ is Boltzmann's constant, $_{i}$ is the complete partial chem ical potential of the ith constituent of the air m ixture (it is complete since it is composed of chem ical potential without external force eld and of external potential), m $_{air} = 28.966$ [u] is the molecular mass of air, $_{mk}$ is K ronecker's delta, c $_{p;i}$ is the special cheat at constant pressure of the ith constituent of air mixture, his Planck's constant, $_{i}$ is the vector of ux of mass of the ith constituent of the air mixture, and is the coel cient of the mal conductivity of air. These magnitudes were derived from G rand C anonical ensemble with external gravitational New ton ian eld.

III.OPT IM AL CONTROL PROBLEM S.

Let us consider the measures of the total travel time (TTT): J_{TTT} [5], emissions (E): J_{E} , and concentrations (C): J_{C} of exhaust gases in the street canyon as well as in the canyon and two its nearest neighbor substitute canyons, $J_{TTT;ext}$ $J_{E;ext}$ $J_{C;ext}$, respectively. Therefore the appropriate optimization problems may be formulated as follows [2]. The measures depend on traclights at the upstream and downstream ends of the lanes. The vector of boundary control useds:

 g_m are green times, C_m are cycle times, F is o set time, and U^{adm} is a set of admissible control variables. The TTT, E, C functionals are given by:

The integrands $k_{l,vt}^s; e_{l,ct,vt}^s; c_i$ in the functionals depend on the control vector u through the boundary conditions, through the equations of dynam ics, as well as, through the sources. The value of the vector of control u directly a ects the boundary conditions for vehicular densities, velocities, and em issivities. It also a ects the sources. Next, it propagates to the equations of dynam ics and then it in uences the values of functionals. $_{STP}$ is the density of air at standard tem perature and pressure STP, $c_{i;STP}$ is concentration of the ith constituent of air at standard tem perature and pressure, a;b;c, are dimensions of the street canyon, T_S is time of simulation.

We do not two additional functionals. The strong is the composite total travel time, em issions and concentrations of the pollutants in the single canyon, whereas the second one in the canyon and two its neighbors:

The scaling parameters $_{TTT}$; $_{E}$; $_{C}$; $_{TTT,ext}$; $_{E,ext}$; $_{C,ext}$ make the two functionals dimensionless, and

where A^{adm} , A^{adm}_{ext} are the sets of adm issible scaling parameters. We formulate two separate multi-criteria optim ization problems consisting in minimization of the functionals H; Hextwith respect to control vector u over admissible domain and with respect to scaling parameters, while the equations of dynamics are fulled:

where H?; H $_{\text{ext}}^{?}$, are the m in imal values of the two functionals, (a $^{?}$; u $^{?}$), and (a $_{\text{ext}}^{?}$; u $_{\text{ext}}^{?}$), are scaling and control vectors at which the functionals reach the m in ima, respectively.
