Gain in Stochastic Resonance: Precise Numerics versus Linear Response Theory beyond the Two-Mode Approximation

Abstract

In the context of the phenom enon of Stochastic Resonance (SR) we study the correlation function, the signal-to-noise ratio (SNR) and the ratio of output over input SNR, i.e. the gain, which is associated to the nonlinear response of a bistable system driven by time-periodic forces and white Gaussian noise. These quanti ers for SR are evaluated using the techniques of Linear Response Theory (LRT) beyond the usually employed two-mode approximation scheme. We analytically dem onstrate within such an extended LRT description that the gain can indeed not exceed unity. We implement an e cient algorithm, based on work by Greenside and Helfand (detailed in the Appendix), to integrate the driven Langevin equation over a wide range of parameter values. The predictions of LRT are carefully tested against the results obtained from num erical solutions of the corresponding Langevin equation over a wide range of parameter values. We further present an accurate procedure to evaluate the distinct contributions of the coherent and incoherent parts of the correlation function to the SNR and the gain. As a main result we show for subthreshold driving that both, the correlation function and the SNR can deviate substantially from the predictions of LRT and yet, the gain can be either larger or smaller than unity. In particular, we nd that the gain can exceed unity in the strongly nonlinear regine which is characterized by weak noise and very slow multifrequency subthreshold input signals with a sm all duty cycle. This latter result is in agreem ent with recent analogue simulation results by G inglet al. in Refs. [18, 19].

I. IN TRODUCTION

Over the last twenty years or so, a large am ount of work has been devoted to the study of the dynam ics of noisy nonlinear systems driven by external periodic forces. One of the main reasons for this interest is related to the phenom enon of Stochastic Resonance (SR) [1, 2, 3, 4, 5] namely, the possibility of using the concerted action of noise and nonlinearity to augment selectively, for some parameter values, the output of the nonlinear system with respect to what it would be for a linear system dynamics.

The two common quantiers for Stochastic Resonance are the spectral amplication measure [2, 6, 7] and the signal-to-noise ratio (SNR) [2, 8]. They are defined in terms of the Fourier components of the correlation function associated to the stochastic variable, x (t). Due to the periodicity of the driving force, the stochastic process x (t) is explicitly nonstationary. Thus, the two-time function hx (t+)x (t) i depends on both t and . For very large values of t, this quantity is periodic in t with the period of the external driving. Thus, its cycle average over one period of tyields a function of just is the correlation function, C (). The analysis of its structure reveals that C () is the sum of two terms [2]: One term is periodic in with the same period as the driving force and it is called the coherent part, C coh (). The other term, the incoherent part C_{incoh} (), decays to zero for ! 1. The SNR of the output process, x (t), is defined as the ratio of the amplitude of the Fourierm ode of the coherent part taken also at the driving frequency. By definition, the SNR is thus a dimensional quantity.

The SNR of an input signal (SNR j_{np}) containing the sum of the external driving and the G aussian white noise can easily be evaluated. A convenient dimensionless parameter can then be de ned as follows: the gain, G, de ned by the ratio of SNR of the output over the (SNR j_{np}). For the case that the Langevin dynamics is linear in x driven by additive white G aussian noise, then the output SNR is exactly the same as SNR j_{np} ; i.e. the gain assumes precisely the value unity. In a general nonlinear case, neither the SNR nor the gain can be evaluated exactly by analytical means. As a consequence, their evaluation necessarily requires approximate procedures.

It was pointed out previously that the gain of a noisy nonlinear dynam ical system subject to subthreshold signals can not exceed 1 [9, 10]. This feature has been rationalized using the ideas of Linear R esponse Theory (LRT), thought to be valid for weak driving am plitudes and not too small noise strengths. It should be pointed out, however, that the validity of LRT critically depends also on the value of the frequency, as has convincingly been demonstrated in recent works [11, 12].

In the context of LRT theory it has been pointed out in [9] that a corollary of LRT is that \for sm all am plitude signals, the signal-to-noise ratio at the output of a system driven by a stationary G aussian noise does not exceed that at the input, even if the system displays SR". Moreover, in Ref. [10], the authors state that for \sm all signal in a G aussian noise background, it is a theorem that the SNR at the output of a non-linear device must be less than or equal to the SNR at the input". On the other hand, studies on nondynam ical system s [13, 14, 15, 16], on dynam ical system s driven by large am plitude sinusoidal forces [17], and on dynam ical system s driven by pulsed (multifrequency) periodic forces with subthreshold am plitudes [18, 19], have reported gains larger than unity. C learly, for this to occur, the stochastic system must operate in a regime where LRT does not apply. It is therefore of interest to delineate carefully the lim it of applicability of the LRT description of the correlation function, the SNR and the gain of a nonlinear noisy driven system.

In this paper we have tackled this challenge by carrying out a detailed numerical evaluation of the correlation function C () and its components, C_{coh} () and $C_{in\,coh}$ (), of the SNR and the gain of a bistable noisy system which is driven by time periodic forces. The numerical predictions have been compared with those provided by the LRT approximation which accounts for the full spectrum of all relaxation modes.

As it is well known, LRT requires the knowledge of the system susceptibility, or alternatively, of the correlation function of the noisy system in the absence of driving, K (t) [2, 11, 12, 20, 21, 22]. None of these quantities are known exactly for nonlinear systems. For su ciently small values of the noise strength, suitable analytical approxim ations to K (t) can been used [2, 11, 12, 20, 21]. On the other hand, for large values of the noise intensity, we have evaluated K (t) from the numerical solution of the Fokker-P lanck equation using an adaptation of the split operator technique of Feit et al. [23], as it has been detailed in [24]. In this paper, we also present a detailed proof of the statem ent that within LRT, the gain G_{LRT} 1, by use of the full spectral approach; this proof di ers from alternative attempts in Refs. [9, 10] which use additional restrictions such as a linear response theory for the uctuations them selves.

The \typical" procedure to evaluate the SNR involves the Fourier analysis of a very long

record of the stochastic trajectory, x (t). U sing the Fast Fourier Transform (FFT) of the record, the corresponding periodogram is constructed. There are several drawbacks with this procedure. There are subtleties inherent to the interpretation and evaluation of the periodogram (see for instance the critical comments in [25]). There are also major problems a associated with the fact that the power spectrum contains -peaks at the driving frequency and its higher harm onics arising from the coherent part of the correlation function. The contribution of the incoherent part at those frequencies is embedded in those peaks, and it is not a simple task to estimate the separate contribution to the peaks of the coherent and incoherent parts of the periodogram. The evaluation of the SNR-gain requires a good know ledge of both contributions, and any small error in the estimation of the incoherent estimate would be obtained if the periodic part of the output signal were subtracted from the data before performing its FFT.

In this work we propose such an alternative procedure. The Langevin equation is numerically integrated for a large number of noise realizations. The time evolution of the correlation function and its coherent part are directly evaluated from the numerical solution after averaging over the noise realizations. The incoherent part is obtained from the di erence $C_{incoh}() = C()$ $C_{coh}()$. As the de nition of SNR requires just the amplitude of the Fourier m ode of $C_{coh}()$ and the spectral density of $C_{incoh}()$ at the driving frequency, the SNR can readily be evaluated with two numerical quadratures; i.e. there is no need to construct the full spectrum.

The paper is organized as follows. In the next Section we introduce the model and provide de nitions of the quantities of interest. In Section III, the main points of the LRT description of the correlation functions are detailed. We also present in this Section a novel and straightforward proof of the fact that G_{LRT} 1, based on the spectral properties of the Fokker-P lanck operator, and its adjoint, in the absence of driving. In Section IV, we present the num erical procedure used to obtain the correlation function, the SNR and the gain from the num erical solution of the Langevin equation. The very e cient algorithm used in this work is sum marized in the Appendix. The num erical results are com pared with the predictions of LRT for a variety of param eters and two distinct types of driving forces: a monochrom atic force and a periodic sequence of pulses. Finally, we present conclusions for the main ndings of our work.

Let us consider a system characterized by a single degree of freedom, x, subject to the action of a zero average G aussian white noise with h (t) (s)i = 2D (t s) and driven by an external periodic signal F (t) with period T. In the Langevin description, its dynamics is generated by the equation

The corresponding linear Fokker-P lanck equation (FPE) for the probability density P (x;t) reads

In the expressions above, $U^{0}(x)$ represents the derivative of the potential U(x). The periodicity of the external driving F (t) allows its Fourier series expansion in the harm onics of the fundamental frequency = 2 = T, i.e.,

Here, we are assuming that the cycle average of the external driving over its period equals zero.

The two-time correlation function hx(t+)x(t) in the limit $t \leq 1$ is given by

where $P_1(x;t)$ is the time-periodic, asymptotic long time solution of the FPE and the quantity $P_{1jl}(x;t+jk;t)$ denotes the two-time conditional probability density that the stochastic variable will have a value near x at time t+ if its value at time t was exactly x^0 . It can been shown [2, 7] that, in the limit t ! 1, the two-time correlation function

 $hx (t +)x (t)i_{1}$ becomes a periodic function of t with the period of the external driving. Then, we de ne the one-time correlation function, C (), as the average of the two-time correlation function over a period of the external driving, i.e.,

The correlation function C () can be written exactly as the sum of two contributions: a coherent part, C_{coh} (), which is periodic in with period T, and an incoherent part which decays to 0 for large . The coherent part C_{coh} () is given by [2, 7]

where $hx(t)i_1$ is the average value evaluated with the asymptotic form of the probability density $P_1(x;t)$.

It is possible to carry out a form alanalysis of C () and its coherent and incoherent com – ponents by making use of the spectral analysis of the F loquet operator associated with the Fokker-P lanck dynam ics. But an explicit evaluation of the correlation function is generally in possible; thus, one has to rely on num erical results obtained from integrating either the Langevin or the FPE, or by use of approxim ate analytical descriptions.

A coording to M dN am ara and W iesenfeld [8], the SNR is de ned in terms of the Fourier transform of the coherent and incoherent parts of C (). As the correlation function is even in time and we evaluate its time dependence for 0, it is convenient to use its Fourier cosine transform, de ned as

Note that this de nition of the SNR di ers by a factor 2, stemming from the same contribution at ! = ..., from the de nitions used in earlier works [2, 7]. The periodicity of the coherent part gives rise to delta peaks in the spectrum. Thus, the only contribution to the numerator in Eq. (10) stems from the coherent part of the correlation function. The evaluation of the SNR requires the know ledge of the Fourier components of C_{coh} () and C_{incoh} () at the fundamental frequency of the driving force. The entire Fourier spectrum

is not needed. The evaluation of the SNR thus requires the evaluation of two well de ned num erical quadratures only; i.e.,

The so-called gain is de ned as the ratio of the SNR of the output over the SNR of the input; namely,

III. LINEAR RESPONSE THEORY BEYOND THE TWO-MODE APPROXIMA-

The Linear Response Theory provides a general procedure to describe the correlation function in an approximate way. The basic quantity of LRT is the system response function, (t). It is related to the equilibrium time correlation function of the system in the absence of external driving, K (t), via the uctuation-dissipation theorem (FDT) [2, 7, 20, 21], i.e.,

A s discussed in Refs.[2, 7, 20], LRT amounts to keeping the leading term in the perturbation treatment of the dynamics of the stochastic process x (t) in powers of the driving am plitude. Then, within the spirit of perturbation theory, the leading term in the expansion of the incoherent part corresponds to the correlation function of the system in the absence of driving force, i.e., $C_{incoh}^{(LRT)}() = K()$.

Taking into account that C_{coh}^{LRT} () is periodic in , it follows from Eqs. (9) and (24) that

where K () is the Fourier cosine transform of K (t), de ned according to Eq. (9). In arriving at Eq. (26) we have also used Eqs. (19), (20), (21) and (23).

Taking into account Eqs. (12), (13) and (26), one readily nds that the gain within LRT is given by

This is a general expression for $G^{(LRT)}$ valid for any shape of periodic driving.

The last expression will allow us to show that $G^{(LRT)}$ can, indeed, not exceed unity. A lthough this assertion has been discussed previously in Ref. [9, 10], we next will present a detailed and hopefully very clear proof for this prom inent assertion.

As shown in the Appendix of Ref. [2], see also in Ref. [11, 12], the susceptibility, (t), can be expressed as

Finally, inserting Eq. (36) into (27), we obtain the sem inal inequality that $G^{(LRT)}$ 1.

Put dierently, the gain of a nonlinear system operating in a regime where LRT provides a valid description cannot reach values greater than 1. This result is valid for any periodic external driving. Notice that this inding does not preclude the possibility of obtaining values for the SNR -gain larger than unity when the conditions are such that the use of LRT is not sensible.

IV. NUMERICAL RESULTS

In this Section, we will carry out the num erical evaluation of the di erent m agnitudes de ned above. Our goal is to compare the predictions of LRT with the results obtained from the num erical solution of the Langevin equation, Eq. (1). We will consider the dynam ics in the bistable potential U (x) = $x^2=2 + x^4=4$ driven by time periodic forces.

The evaluation of the di erent m agnitudes using LRT requires the know ledge of K (t) [cf. Eqs. (19, 24, 26, 27)]. For nonlinear problem s, explicit expressions for K (t) are unknown,

but useful approximations have been presented in the literature. For the bistable potential, $U(x) = x^2=2 + x^4=4$, Jung and Hanggi [21] have used the two-mode approximation. It is based on the existence of a large di erence in the time scales associated to inter-well and intra-well motions, and it is expected to be valid for small values of the noise strength D. W ith this model, one nds

and = 2. The weights, g_1 and g_2 , can be obtained from the moments of the equilibrium distribution in the absence of driving using the expressions

To leading order in D, we can replace $_1$ by $_{K} = \frac{p}{2} = \exp((1=(4D)), g_1 - 1 \text{ and } g_2 - D = .$ This is the limit considered in Ref. [26]. In the results reported below, we have also considered values of D so large that the two-mode approximation becomes inadequate. Therefore, the correlation function in the absence of driving has been evaluated numerically from the FPE in the absence of driving following the procedure discussed in Ref. [24].

The num erical evaluation of the correlation function C () and its coherent and incoherent parts proceeds as follows. Stochastic trajectories, $x^{(j)}$ (t), are generated by num erically integrating the Langevin equation for every realization j of the white noise (t), starting from a given initial condition x_0 . The num erical solution is based on the algorithm developed by G reenside and H elfand [27, 28]. The essence of the algorithm is brie y sketched in the Appendix. A fter allowing for a relaxation transient stage, we start recording the time evolution of each random trajectory form any di erent trajectories. Then, we construct the two-time (t and) correlation function, i.e.,

where N is the number of stochastic trajectories considered. The correlation function C () and its coherent part C_{coh} () are then obtained using their de nitions in Eqs. (7) and (8), performing the cycle average over one period of t. The difference between the values of C () and C_{coh} () allows us to obtain the values for $C_{in\,coh}$ (). It is then straightforward to evaluate the Fourier component of C_{coh} () and the Fourier transform of $C_{in\,coh}$ () at the driving frequency by numerical quadrature. W ith that information, the numerator and the denominator in the expression (10) for the SNR and the gain (Eq. (13)) are obtained.

We shall analyze two di erent types of periodic driving forces. First, let us consider the well known situation with a monochromatic, single frequency force, A $\cos(t)$, with amplitude strength A and angular frequency [2]. In this case, the formulas in Sect. III simplify considerably because $f_1 = A$, while all the other Fourier components of the driving force vanish. The second case corresponds to a periodic force with period T, with a sequence of pulses of length $t_c < T=2$; namely,

In this case, we have

where = 2 = T is the fundam ental frequency. This force is characterized by its am plitude, its period and its duty cycle, which is de ned as $2t_c=T$. Recently, G inglet al. [18, 19] have carried out analogue simulations of systems that are subjected to wideband G aussian noise and driving forces of this second type. They report values for the gain which greatly exceeds unity, for driving am plitudes below its threshold value. If this is the case, then strong deviations from the LRT should be observed as well.

A. M onochrom atic driving

In Fig. 1 we depict the results obtained for a monochrom atic driving force with angular frequency = 0.1, noise strength D = 0.2 and several values of the amplitude. In the determ inistic dynamics (D = 0), an external periodic force with the indicated frequency induces sustained oscillations between the minima of the potential for A A_{th} ' 0.419.

Note that this nonadiabatic frequency raises the threshold value for superthreshold driving beyond its adiabatic lower lim it of $A_{th}^{(ad)} = \frac{q}{4=27}$ / 0:3849. Thus, we will take this value as the amplitude threshold value at the frequency = 0:1. In panel (a), we plot the num erators of the SNR in Eq. (10) and of SNR (LRT) in Eq. (26) vs. A². The solid straight line represents the LRT result, while the circles correspond to the num erical results. The graph reveals that for am plitude strengths A < 0:1 the predictions of LRT m atch well the num erical results, as can be expected. When the amplitude increases, the deviations of LRT from the precise num erical results are large. LRT predicts a much larger am pli cation of the output am plitude than the one obtained num erically. In panel (b), we plot the denom inators of the SNR in Eq. (10) (circles) and of SNR (LRT) in Eq. (26) (solid line) vs. A². In LRT, the denom inator is independent of A. Once again, the predictions of LRT m atch the num erical results for A < 0.1. For larger values of A, the in using of the driving amplitude on the relaxation of $C_{in\,coh}$ () is very strong and the num erical results for the denom inator are much smaller than the ones obtained within LRT. It is then clear that LRT will yield a valid description of the signal-to-noise ratio for sm all driving am plitudes only as depicted in panel (c). We notice that the values for the SNR provided by the num erics are larger than SNR (LRT). This is so although linear response theory predicts larger spectral amplications, see in [7], of the average output than what really occurs. The modi cations in the behavior of the incoherent part of the correlation function with respect to its behavior in the absence of driving are more than enough to compensate for the behavior of the num erators. In panel (d) we plot the gain vs. A². There exists an optimum value for the driver am plitude 0:8) at which the gain becom es m axim ized. Nonetheless, the gain is always smaller (A) than unity. LRT requires that G^(LRT) 1. These strong deviations of the predictions of LRT about the behavior of the two components of the correlation function with respect to the num erical results tell us that LRT cannot be invoked to explain the fact that the gain is smaller than 1 for the range of parameter values considered in this qure; i.e. a gain below 1 occurs here within the nonlinear regime.

In Figs. 2 and 3 we analyze the same quantities as in Fig. 1, but now for larger noise values, D = 0.6 and D = 1.0, respectively. The most important difference with respect to the plots in Fig. 1 is that for these larger values of the noise, the gain can exceed unity for values of the amplitude well above its threshold value. This superthreshold feature has been corroborated already in Ref. [17]; a gain above 1 seem ingly does not occur form onochrom atic

subthreshold driving.

B. Pulsed, multichrom atic periodic driving

Next, we proceed to consider the case of pulsed driving forces. In Figs. 4 and 5 we compare the dependence of the output on the driving am plitude as given by the LRT approximation with the numerical precise results. The system is forced by a multifrequency driver with a period T = 2 = 0.1 ' 63 and a duty cycle of 10%. As in the case of a single frequency driving, the values of the diment quantities obtained from the numerics deviate significantly from the predictions of LRT as the amplitude of the driver is increased. Nevertheless, perhaps the most relevant dimence with respect to the monochromatic case is that we again do not nd gains larger than 1 in the range of parameter values considered in these gures.

C. The case of strong nonlinearity

A particularly interesting situation arises in the analogue studies of pulsed driving forces with a very small fundamental frequency: in Refs. [18, 19] G inglet al. report gains that significantly exceed the value 1 for a subthreshold, multifrequency driving force of very large period T = 2 = 0.0024 ' 2618 and a small duty cycle of 10%. This large gain is accompanied by a non-monotonic behavior of the SNR with the noise strength D. Therefore, this situation must correspond to a very sensible discrepancy of the actual behavior with respect to the LRT predictions. We have carried out detailed and carefulnumerics of the Langevin equation in this extreme regime for such a driving force with a subthreshold amplitude A = 0.35 and a noise strength D = 0.02. With the parameters considered, the problem becomes computationally very demanding indeed: this is so because of the very large period of the driving force. Moreover, in order to obtain reliable numerical results for the incoherent part of the correlation function a large number of stochastic trajectories needs to be generated. Our notings are summarized with the Table I.

To obtain a reliable convergence of the corresponding SR quanti ers at least up to 50000 random trajectories need to be considered. A sm aller sam pling size can induce severe errors, see in Table I. The main result is a num erically evaluated gain of 8:62; in clear contrast, the result predicted by LRT is the very sm all value of 0:018; i.e. LRT strikingly fails, cf.

in Table I for the corresponding values of SNR and its constituents. The SNR value of the analogue simulation in Refs. [18, 19] carried out with a pulsed input signal with the same characteristics as the one considered here, and wideband G aussian noise with a related strength roughly similar to ours, yields an experimentally determined gain of ca. 19, cf. Fig. 4 in [19]. This value is again signi cantly larger than 1 and compares favorably with our results in Table I.N ote, however, that the sam pling size of ca. 1000 realizations used in Refs. [18, 19] has been chosen substantially smaller than the number of realizations needed to achieve good numerical convergence, cf. Table I; this in turn may explain the overshoot of the experimentally determined gain value.

V. CONCLUSIONS

Let us sum marize the main results of this work: (i) First, we have provided an analytical proofbased on LRT beyond the commonly employed two-mode approximation that the gain of a noisy, periodically driven nonlinear system which operates within the regime of validity of LRT cannot exceed unity. This result holds for arbitrary noise strength D and is independent of the shape of the input signal. (ii) We have implemented a very e cient algorithm due to G reenside and Helfand [27, 28] to numerically integrate the Langevin equation. From the numerical solution, we have evaluated the time evolution of the correlation function and its coherent and incoherent components. (iii) We have also put forward a procedure, alternative to the usual one, to calculate the SNR. The numerator and denominator of the SNR are calculated by use of only two numerical quadratures. (iv) A detailed comparison between the predictions of LRT and the numerical results have been carried out. We have

assessed regions of parameter values where LRT gives an enconeous description, yet the gain, nevertheless, is less than unity. On the other hand, there exist regions in parameter space where the gain indeed exceeds 1 if driven with a superthreshold amplitude strength; this nding is in agreement with prior results in Ref. [17]. These regions are again characterized by substantial deviations from LRT.

M oreover, as previously established by use of analogue simulations by G inglet al. [18, 19] we also nd the surprising result, valid for dynam ical systems, that SNR-gains larger than unity can indeed occur for subthreshold (!) polychrom atic input signals: For this feature to occur one seem ingly needs, however, weak noise and a slow periodic driving signal with a very sm allduty cycle. In this context, the necessity of a su ciently large num ber of sam pling trajectories in order to obtain reliable, convergent results has also been stressed. It is in this very regime of sm all frequency driving and weak noise where the LRT description indeed fails notably [11, 12].

APPENDIX A: THE METHOD OF GREENSIDE AND HELFAND

The procedure proposed by G reenside and H elfand for num erically integrating stochastic di erential equations has been discussed in detail by their authors in [27, 28]. For the sake of completeness, we will brie y sketch in this Appendix the main reasoning of their procedure. By analogy with determ inistic R unge-K utta algorithm s, G reenside and H elfand developed schemes to estimate the value of the stochastic variable at time t + h if its value at time t is known. This is achieved by evaluating the right hand side of the Langevin equation at selected points within each interval of length h, so that, all m om ents of x (t + h) x (t) are correct to order h^k.

A sour Langevin equation contains an explicit time dependent driving force, it is convenient to rewrite it as a two-dimensional problem with variables $(y_1; y_2) = y$, where $y_1 = x$ and $y_2 = t$. The Langevin equation, Eq. (1) is then written in vector form as

The last term, S (h), represents the stochastic part. It is a series in $h^{1=2}$ with the order of the term s determ ined in probability.

By analogy with the Runge-Kutta procedures for determ inistic di erential equations, G reenside and Helfand propose an l-stage algorithm to write the solution of Eq. (A1) as

Here, (fy g) is the set (x;t). The Y_1 are Gaussian stochastic variables with zero average which are num erically generated by writing

where Z_j are m independent G aussian random variables of zero average and unit variance. The parameters A_i , $_{ij}$ and $_{ij}$ appearing in Eqs. (A 5-A 7) are independent of the component index . They are obtained by expanding Eq. (A 5) to the desired order h^k . This expansion gives rise to a deterministic and a stochastic part, S. Equating the coe cients of this expansion with those of the deterministic part in Eq. (A 4) leads to a set of equations for the parameters A_i , $_{ij}$ and $_{ij}$. Further equations are obtained by equating the moments of $hS^n i$ with those of the stochastic part in the expansion in Eq. (A 4) $hS^n i$.

A procedure correct to order h^k in the step size h, involving 1-stages and m G aussian independent variables is term ed a $k_0 l_s m_g$ algorithm. In this paper we have integrated the

Langevin equation using a $3_0 4_S 2_G$ algorithm with the values for A_i , $_{ij}$ and $_{ij}$ given in Table II taken from [28]. W ith this choice of parameters, the determ inistic part is of order h^4 , as in the fourth order Runge-Kutta procedure for ordinary di erential equations.




FIG. 1: The dependence of several SR quanti ers versus the square of the driving am plitude, A^2 , given by LRT (solid line) and by the num erical solution of the Langevin equation (circles). In panels (a) and (b), we plot, respectively, the num erator and denom inator appearing in the de nition of SN R, cf. Eq. (11). The behaviors of the SN R and the gain are depicted in panels (c) and (d). The driving force is monochrom atic with frequency = 0:1 and the white noise strength is kept constant at the value D = 0.2. In all panels, the vertical dashed line indicates the square of the value of the dynam ical threshold am plitude, A_{th} , at the angular driving frequency, . In panel (d), a dotted horizontal line is drawn at the gain value of 1 as a guide to the eye.




FIG.2: The same as in Fig.1 but now for = 0:1 and D = 0:6.




FIG.3: The same as in Fig.1 but now for = 0:1 and D = 1:0.




FIG. 4: The same as in Fig. 1, for the case of a pulsed, driving force with period T ' 63, duty cycle $2t_c=T = 0.1$ cf. Eq. (43), and a noise strength D = 0.6.




FIG.5: The same as in Fig.1 for a pulsed driving force with period T ' 63, duty cycle $2t_c=T = 0.1$, cf. Eq. (43), and a noise strength D = 1.0.
