In the slave boson mean eld treatment of the t-J model, the ground state for small doping is a d-wave superconductor. A conventional superconductor has collective modes associated with the am plitude and phase of the pairing order parameter. Here, the hopping matrix element $_{ij}$ is also a mean eld order parameter. We therefore expect that new collective modes will be introduced with these additional complex degrees of freedom . We compute the new collective modes and their spectral functions by num erically diagonalizing the matrix which describes the uctuations about the mean eld solution. We also show that the SU (2) gauge theory form ulation allows us to predict and classify these collective modes. Indeed, the SU (2) formulation is essential in order to avoid spurious collective modes as the doping x goes to zero. The most important new collective modes are the mode and the longitudinal and transverse gauge modes. The mode corresponds to uctuations of the staggered ux phase and creates orbital current uctuations. The qauqe m odes correspond to out-of-phase uctuations of the amplitudes of the pairing and the hopping m atrix elements. We compute the neutron scattering cross-section which couples to the mode and inelastic X-ray scattering cross-section which couples to the uctuation in the real part of $_{ij}$. In addition, we show that the latter uctuation at (;) may be coupled to the buckling phonon mode in the LTO phase of LSCO and may be detected optically. Experimental searches of these collective m odes will serve as important tests of this line of attack on the high T $_{\rm c}$ problem .

I. IN TRODUCTION

It is now a widely accepted view that the problem of high T_c superconductivity is that of doping into a M ott insulator. The simplest model which captures the physics of the strong correlation inherent in this problem is the t-J m odel. The no-double-occupant constraint leads naturally to a gauge theory. Them ean eld decoupling of this theory is the form al language which describes Anderson's physical idea of a resonating valence bond (RVB).¹ Them ean eld theory indeed en joys a num ber of successes. Notably it predicted the appearance of d-w ave superconductivity and the existence of a spin gap phase in the underdoped region.^{2 {4} The properties of this spin gap phase are in rem arkable agreem ent with those of the pseudogap phenom enology. M ost striking am ong these is that the quasiparticle spectral function becomes a coherent peak with sm all spectral weight. This property emerges naturally out of the mean eld picture of the condensation of bosons.

D expite these successes, the theory has not enjoyed wide following because the gauge uctuations are strong and the theory does not have a well controlled small expansion parameter, except form alones such as the large N expansion. For example, Nayak⁵ has raised a number of objections on general grounds. However, we believe these general arguments have been adequately answered in the ensuing comments and discussions.⁶⁹ Here we brie y summarize our point of view.

Initially, the gauge eld has in nite coupling in order to enforce the constraint on a lattice scale. Upon integrating out high energy ferm ionic degrees of freedom, the coupling constant becomes of order unity. Then there is a chance that the mean eld theory and uctuations about it may be qualitatively correct at intermediate temperature scales. At low energy scales, nonperturbative elects related to compact gauge theories may come in, giving rise to the phenom enon

of con nement. This phenomenon is well known at half-lling. The mean eld solution gives a - ux state with D irac spectrum centered about $\frac{1}{2}$; $\frac{1}{2}$. Coupling with compact U (1) gauge eld leads to con nem ent and chiral sym metry breaking in particle physics language, which is equivalent to Neel ordering.¹⁰ The idea is that with doping, the appearance of dissipation suppresses con nem ent_r^{11} and the N eel state is rapidly destroyed. Then the mean eld description may be qualitatively correct beyond a small, but nite, doping concentration. At low tem peratures characterized by the boson condensation scale xt, superconductivity emerges. In this theory the superconducting state is described as the H iggs phase associated with bose condensation. (W e prefer to refer to this as the H iggs phase rather than bose condensation because the bose eld is not gauge invariant.) How ever, here lies one of the signi cant failures of the weak coupling gauge theory description. As long as the gauge uctuation is treated as G aussian, the In e-Larkin law holds and one predicts that the super uid density $_{s}$ (I) behaves as $_{s}$ (I) ax bx² I. The ax term agrees with experiment while the $bx^{2}T$ term does not $t^{12;13}$. This failure is traced to the fact that in the Gaussian approximation, the current carried by the quasiparticles in the superconducting state is proportional to xv_F . We believe this failure is a sign that nonperturbative e ects again become in portant and con nem ent takes place, so that the low energy quasiparticles near the nodes behave like BCS quasiparticles which carry the full current $v_{\rm F}$. For the pure gauge theory, the con nem ent always occurs in (2+1)D how ever sm all the coupling constant of the gauge eld is. When the bose eld is coupled to the gauge eld, i.e., Higgs model, it is known that the con nement phase are sm oothly connected to each other.¹⁴ Recently, we showed that in (2+1)D Higgs model the phase should be considered con ned everywhere.¹⁵ Thus the appearance of con nem ent at low energy scale is not surprising, but the dichotom y between the success of the bose condensation phenom enology on the one hand (in explaining the quasiparticle spectral weight mentioned earlier) and the con nem ent physics needed to give the proper quasiparticle currents on the other, is in our opinion one of the most profound questions facing the eld today.

To sum marize, the current status of the gauge theory approach to the t-J model is the following. Within mean eld theory, a certain saddle-point solution m ay be regarded as the \m other state" at som e interm ediate energy scale. The m ost prom ising candidate for this \m other state" appears to be the staggered ux state, which is the saddle point for the SU (2) form ulation of the t-J m odel. This saddle point is an unstable xed point due to gauge uctuations. It ows to the Neel state at or near half lling and to the superconducting ground state at nite doping. This picture is in accordance with a recent insightful comment by Anderson, 16 except that we provide a concrete description of the unstable xed point. As discussed above, the issues raised by this picture are profound and probably di cult to treat analytically. In the past few years, we have focused on trying to substantiate this point of view by num erical methods and by predicting new experiments. On the numerical front, the study of projected wavefunctions have yielded remarkable insights. Ivanov et al.¹⁷ reported a nding which is surprising except from the SU (2) gauge theory point of view. They discovered that upon G utzw iller projection of a BCS d-wave state, the current-current correlation shows a staggered pattern, as expected for the staggered ux state. Thus there is strong num erical evidence that the staggered ux state and the d-wave superconducting state are intimately related. On the experimental front, predictions have been m ade that the staggered ux state m ay be stabilized in the vortex core and ways to m easure the e ect of the orbital currents have been proposed.¹⁸ In this paper we continue work in this direction and ask the question: is the superconducting ground state that emerges out of the gauge theory completely conventional, or are there detectable consequences of its unconventional origin?

The short answer to this question is that gauge theory predicts new collective modes in the superconducting ground state which have experimental consequences. Unlike conventional BCS theory, where the only order parameter is the complex pairing order parameter, here the hopping matrix element also functions as an order parameter. Thus it is natural to expect new collective modes. This problem is formulated generally in Sections II and III. In Section IV we show how the gauge theory allows us to predict the low lying collective modes. The new modes are the mode and the transverse and longitudinal modes. The mode generates staggered orbital current uctuations and is

related to the current uctuations found in the projected wavefunctions. However, while the projected wavefunctions give only equal time correlation, here we obtain the full dynamical spectral function. The gauge modes are new excitations related to amplitude uctuations of and . In Sections V and VI we present num erical results of the spectral functions and describe experiments which may couple to them.

The approximation employed in this paper is to treat the system in the Higgs phase by adopting the radial gauge for the bosons. Gauge uctuations are treated at the Gaussian level and nonanalytic corrections, such as instantons which m ay lead to con nement, are neglected. This can be just ed in term softhe 1=N -expansion with N being the number of ferm ion species. In the present case, N = 2 and one criterion for the validity of this Gaussian approximation is that the magnitude of the order parameter uctuation is less than that of the mean eld value. As is evident from the discussion in II and III, the magnitude of the uctuation diverges as $x \neq 0$ because the action for the SU (2) local gauge transform ation vanishes in this lim it. Hence the Gaussian approxim ation breaks down near x = 0, where the con nem ent physics is of vital in portance because the nonperturbative con gurations such as instantons contribute appreciably. Below we will show mainly the num erical results for x = 0.1. We have estim ted num erically the magnitude of the uctuation of the order parameters, e.g., $< (x)^2 >$ at zero tem perature, and found that it is of the order of unity at x = 0.1. Therefore the gaussian approximation is marginaly justimed in this case. As another test, recently Honerkamp and Lee¹⁹ have computed the shift in using a free energy which includes the gaussian uctuaions of the mode. They found a reduction to 55 % of the mean eld saddle point value for x= .06 but for x= 1 the reduction is only 80 %. Thus the e ect of the gaussian uctuation is relatively under control for increasing doping. Furtherm ore, since the collective m odes appear at fairly high energy (J) for experim entally relevant doping (x 0:1), it is possible that this approximation is valid at this energy scale, but the ultimate test must come from experiment.

II.U (1) AND SU (2) FORM ULATIONS OF THE T-J M ODEL

We begin with the fam iliar U (1) formulation of the t-J m $odel^{20}$

Then $S_i = S_j = \frac{1}{4}n_in_j$ can be written in terms of the rst two terms of Eq. (3) plus quadratic terms, provided we ignore the nearest-neighbor hole-hole interaction $\frac{1}{4}b_j^yb_ib_j^yb_j$. We then decouple the exchange term in both the particle-hole and particle-particle channels via the Hubbard-Stratonovich transformation. By introducing the SU (2) doublets^{22;23}

with $_{ij}$ representing ferm ion hopping and $_{ij}$ representing ferm ion pairing. In Eq. (7) $J_{ij} = J=4$ but in the literature J has sometimes been taken to be 3J=8. The latter has the advantage that the mean eld equation reproduces that which is obtained by the Feynman variational principle,²⁴ but these di erences are well within the uncertainties of the mean eld theory. (In the mean eld theory, $_{ij} = \frac{1}{2} < f_i^y f_j > and _{ij} = < f_{i''} f_{j\#} = f_{i\#} f_{j''} > .)$

A eck et al.²² pointed out that the t-J m odel at half-lling obeys an exact SU (2) sym m etry in the functional integral form ulation. The SU (2) doublet in Eq. (5) expresses the physical idea that a physical up-spin can be represented by the presence of an up-spin ferm ion, or the absence of a down-spin ferm ion, once the constraint is im posed. W en and Lee²⁵ proposed a form ulation which obeys the SU (2) sym m etry even away from half-lling. The SU (2) and the original U (1) form ulation are equally exact, but once approximations are introduced, the SU (2) form ulation has the advantage that the zero doping lim it x ! 0 can be sm oothly taken. We shall see an exam ple of this in the collective m ode spectrum described below. In the SU (2) form ulation a doublet of bosons is introduced

The angle $_{i}$ in z_{i1} and z_{i2} is the overall phase which is redundant and can be absorbed in the phase of b_{i} . An important feature of Eq. (12) is that L_{2} is invariant under the SU (2) gauge transform ation

We have rem oved the tilde from U_{ij} , \tilde{t}_i , f_i , a_0 because these are integration variables. Note that g_i has disappeard from the actions and Eq. (21) is the same as the U (1) Lagrangian L_1 , with the exception that t_{ij} is now replaced by $t_{ij} = t_{ij}=2$, i becomes a_{oi}^3 and, most importantly, two additional integrals a_{0i}^1 and a_{0i}^2 coupling to the fermions appear. We note that in the lim it of zero doping, thanks to these additional gauge elds, Eq. (21) manifestly invariant under SU (2) transformation, whereas Eq.(7) is not. This will have important consequences when we consider mean eld approximation and small uctuations, in that Eq. (21) will have smooth x ! 0 lim it while Eq. (7) does not.

III. M EAN FIELD THEORY AND COLLECTIVE MODES

We now consider the mean eld treatment of Eq. (21) and the quadratic uctuations about the mean eld, which will yield the collective modes. We work in the radial gauge, where b_i is considered real without loss of generality. As discussed after Eq. (16), the phase of b_i and i are redundant and one of them can be chosen as zero. We will discuss the alternative choice later, but here we choose b_i to be real. The saddle point solutions are

where = \hat{x} or \hat{y} and $_x = 1$; $_y = 1$ correspond to d-wave pairing of the ferm ions. The saddle point corresponds to a physical d-wave superconductor, as the order parameter $hc_{i^*}c_{i^+} \# c_{i^\#}c_{i^+} \# i = r_0^2_0$ is nonzero. The mean eld ferm ionic action is

where $^{0} = I$. Note U_{x}^{a} and U_{y}^{a} ; a = 1 to 3 are real variables, while for a = 0 are purely in aginary, and together make up a total of 8 degrees of freedom. These correspond to complex hopping $_{i;i+}$ and pairing $_{i;i+}$ in the x and y directions.

By setting the linear terms in the small expansion of the free energy to zero, we obtain the standard saddle point equations A 1 to A 3. The second order deviation is described by a 12 12 m atrix, where the variables are U^a , R, and a_b . The details are given in the appendix. As it stands the m atrix is not herm itian. On the other hand, if we

consider ia_0 as variables, the m atrix is herm itian for $!_n = 0$ but has negative eigenvalues, i.e., it corresponds to the saddle point of the free energy in the unprojected H ilbert space. In order to obtain positive eigenvalues, it is necessary to rst integrate out a_{0i} in order to project to the physical subspace. Since this is a G aussian integration, we may equivalently consider (U^a ; R) as the physical degrees of freedom, and solve for the local a_{0i} for each con guration. This is the idea behind the -m odel approach in ref. (24) where large uctuations in U_{ij} are considered. The present work should be considered the low-tem perature limit of the -m odel.

At this point we proceed num erically, evaluate the 12 12 m atrix and integrate out the a_0 elds. The remaining quadratic form gives a 9 9 m atrix with 9 eigenvalues. As expected, there is a soft mode associated with the phase of the pairing order parameter. In addition, we nd a number of soft modes in the small x limit. Before presenting the num erical results, we show how the SU (2) symmetry allows us to predict and classify all the soft degrees of freedom.

IV.SU(2) CLASSIFICATION OF SOFT MODES

In this section we make use of the SU (2) gauge symmetry to classify the soft modes. The basic idea is the following. As the temperature is decreased, the SU (2) symmetry is broken via a series of symmetry breaking at the meaneld level. For smallx, SU (2) is rst broken down to U (1) at a temperature scale of order J=2 to the staggered ux (s-ux) state.²⁵ At a lower temperature of order xt, the bosons condense and the gauge symmetry is broken completely. Of course, a local gauge symmetry cannot be broken, but the meaneld description is still a useful starting point to describe the low-lying collective excitations, which are physical. A familiar example is the pairing order parameter of superconductivity, which breaks the local U (1) gauge symmetry associated with the E & M gauge eld at the meaneld level. W hile strictly speaking, this order parameter is not gauge invariant, it is a useful starting point which leads to the correct description of the gauge eld via the Anderson-Higgs mechanism.

It is useful to distinguish between two kinds of sym m etry breaking as $x \downarrow 0$. First, at x = 0 the m ean eld solution is the -ux state, i.e., $_0 = __0$. This state has full SU (2) sym m etry, which is broken down to U (1) in the s- ux state, where $_0 \notin __0$. We shall refer to the remaining sym m etry as the residual U (1) sym m etry. As x becomes nonzero, $_0 = _0$ deviates from unity rather rapidly and we shall focus our attention on the zero m odes due to the residual U (1) sym m etry. Secondly, the bosonic degrees of freedom appear at $x \notin 0$. Boson condensation breaks the residual U (1) com pletely below an energy scale of order xt. The zero m odes then acquire a nite energy gap which is the subject of our analysis.

Starting from the d-wave superconductor mean eld solution described in the last section, we expect the soft modes to involve small uctuations of the boson about the radial gauge which can be parametrized by the SU (2) matrix g_i such that $h_i = g_i \quad {r_0 \atop 0}$. In addition, we include phase uctuation of the U_{ij} matrix which we paramaterize by

where a_{ij} ; '= 1;2;3 are three gauge elds living on spatial links. Since SU (2) has been broken down to U (1), only one out of three gauge elds remain soft in the s- ux state.^{27;28} To visualize this, it is convenient to make a gauge transform ation using Eqs. (17, 18, 19) to the s- ux order parameter

where $_{0}$ = A cos $_{0}$ and $_{0}$ = A sin $_{0}$. Equation (30) represents ferm ion hopping with a complex matrix element such that a ux 4 $_{0}$ threads the lattice plaquettes in a staggered manner. At the same time the boson is transformed to

and the mean eld a_0 becomes $a_0^{SF} = (0; i_0(1)^{i_x + i_y}; 0)$. We note that U_{ij}^{SF} describes a sem iconductor band with nodes at (=2; =2). If h_i were to remain as $h_i = r_0 \begin{bmatrix} 1 \\ 0 \end{bmatrix}$ and $a_0^3 \notin 0$, we would have described an s-ux state with small fermion pockets. Instead, h_i and a_0^{SF} are rotated such that a_0^{SF} couples to pair elds $f_{i''}^y f_{i\#}^y$ and the resulting state is gauge equivalent to the d-wave superconductor that we started out with. The advantage of the s-ux representation is that U_{ij}^{SF} is proportional to $_3$ and is invariant under $_3$ rotation. Thus the residual U (1) symmetry is apparent. We expect the soft modes to be described by

where h_i^0 is close to h_i^{SF} , i.e., g_i^0 is parametrized by Eq. (14) with close to $\frac{1}{2}$ and close to (1)^{i_x + i_y} $\frac{1}{2}$. In Eq. (32) we have ignored the a_{ij}^1 and a_{ij}^2 gauge elds as they have been pushed to nite frequencies by the Anderson-Higgs mechanism.

In order to visualize the di erent gauge choices, it is useful to introduce the local quantization axis




FIG.1. The quantization axis I in the SU (2) gauge theory. The north and south poles correspond to the staggered ux phases with shifted orbital current patterns. All points on the equators are equivalent and correspond to the d-wave superconductor. In the superconducting state one particular direction is chosen on the equator. There are two important collective m odes. The m odes correspond to uctuations in the polar angle and the gauge mode to a spatially varying uctuation in .

Note that I_i is independent of the overall phase i. In the s- ux representation the quantization axis has been rotated with w_i given by Eq.(29) to point along the y-axis in a staggered fashion. Sm all uctuations correspond to

deviation from the equator and in the azim uthal angle. This is illustrated in Fig.1.

It is useful to rotate the con guration specied by Eqs.(32) and (33) back to the radial gauge. We obtain

The advantage of the radial gauge is two-fold. The electron operator $c_i = r_0 f_i$ and we can consider U_{ij}^d as the electron H am iltonian for electron quasiparticles. At the same time, we can now make contact with the uctuation of the U_{ij} matrix in the last section and interpret the numerical results.

Equation (35) can be explicitly evaluated for arbitrary , and and a_{ij}^3 , resulting in




FIG.2. Geometrical interpretation of the uctuation of v_{ij} . The angle \sim_{ij} [given by Eq.(38)] is modulated around the ux $_0$ in a staggered manner, in such a way that the hopping am plitude \sim_{ij} and the pairing am plitude \sim_{ij} are modulated, also in a staggered manner.

Note that the only dependence on i, j is via the gauge invariant combination v_{ij} , which has the interpretation of the gauge current. Furtherm ore, for $i = j = \frac{1}{2}$, we see from Eqs.(36) and (37) that $\sim_{ij}e^{i(j-j)}$ and $\sim_{ij}e^{i(j+j)}$ play the role of the elective hopping and pairing parameters. Thus uctuations in i leading to nonzero v_{ij} means a uctuation in the amplitude of \sim_{ij} and \sim_{ij} in such a way that $j\sim_{ij}f + j\sim_{ij}f = A^2$ is xed. This is shown in Fig2.

To make contact with the collective modes, we write $i = \frac{1}{2} + i$ and expand Eqs.(36,37) to rst order in i, v_{ij} and i.

Equation (40) is a main result of this section, as it allows us to interpret the collective modes when compared with Eq.(26). It predicts the location in momentum space of the soft collective modes and gives the eigenvectors. We classify the modes as follows:

We consider u, s, u, s and $v_{i;i+}$ (= x;y) as six slow ly varying variables and the rst four variables are dened as follows

The notation $aU_x + bU_y$ m eans that each component of the eigenvector is $U_x = a$; $U_y = b$, etc.in Eq.(26) The nature of the collective m odes are readily identi ed from their eigenvectors. Two of these m odes were known before. The Goldstone m ode $_u$ is the standard one associated with the phase $_u$ of the superconducting order parameter

eⁱ² ". The s mode corresponds to the out-of-phase oscillation of the phase of the superconducting order parameter in the x and y directions, j x je^{i2'x} and j y je^{i2'y}, such that $s = \frac{1}{2} ('x 'y)$. This is a property of any d-wave superconductor and is labelled the internal phase mode.

The $_{s}$ mode corresponds to the uctuation in the phase of $_{ij}$. In BCS theory the hopping term is xed and not allowed to uctuate. So this is a new degree of freedom special to the gauge theory. The slow ly varying phase of $_{ij}$ plays the role of the spatial component of the gauge eld in the U (1) gauge theory.²⁰ This appears as a collective mode at q = (;). We shall see that just as in the U (1) theory, the $_{s}$ mode plays the crucial role in producing the correct answer for the super uid stimess $_{s} = x$.

The new modes that are of greatest interest to us in this paper are the mode and the gauge modes. These will be discussed in greater detail later.




FIG.3. The eigenvalues at q = (0;0) and ! = 0 of the 9 9 m atrix which describes uctuations about the mean eld as a function of doping x. Shown are the eigenvalues which vanish as x ! 0. The eigenvalues are given in units of J. In addition to the G oldstone mode corresponding to superconducting phase uctuations which has zero eigenvalue for all x (not shown), we not the staggered mode [called internal phase mode in Eq.(43)] and a continuation of the transverse -gauge mode from q = (; ;).




FIG.4. Same as Fig.3 but at q = (;). We not the uniform mode, two degenerate modes, and a staggered mode [called the mode in Eq.(44)].

Now we compare our analysis with numerical results described in the last section. In Figs.3 and 4 we plot all the eigenvalues of the 9 9 m atrix which vanishes at x = 0 as a function of x at ! = 0 and at q = 0 and q = (;), respectively. They can all be identified with our classication. At q = 0 the Goldstone mode has zero eigenvalue for all x as expected. The internal phase mode rises rapidly with increasing x. In addition, we india mode with an eigenvector that corresponds to the continuation of the transverse gauge mode we india the q = 0.

At q = (;) we not the mode and the two gauge modes (transverse and longitudinal) which are degenerate. In addition we not the mode. The vanishing of the eigenvalues of all these modes at x = 0 is a consequence of the SU (2) symmetry. However, as we discussed before, even if $j \neq j$, as long as x = 0 the mode still has zero eigenvalue and the gauge modes are protected by the residual U (1) symmetry. These modes are gapped only by the boson condensation.

We should mention that in addition to these soft modes, we found two unstable eigenstates for small x. If we use in Eq. (21) t=J = 16=3, i.e., t=J = 2 and t⁰ = 0.5t, which generates a realistic Ferm i surface, the eigenvalue corresponding to r_0 uctuation is negative for x < 0.084. Since r_0 corresponds to hole density, this signals an instability to phase separation. This instability is easily suppressed by long range interaction and is largely decoupled from the modes of interest. A second instability occurs for $x < x_c$ near q = (0;) and (; 0). The eigenvector corresponds to amplitude uctuations in $j f + j j^2$ which we identify as instability to columnar dimer formation. The eigenvector corresponds to amplitude uctuations in $j f + j j^2$ which we identify as instability to columnar dimer formation. This instability is well known for x = 0 and can be suppressed by be quadratic term s_c^{28} . For the parameters mentioned above, we not $x_c = 0.087$. Most of our detailed numerical results are for $x > x_c$. Furthermore these two modes are mostly decoupled from the low lying modes in Eq.(41), and does not disturb their behavior in the limit x ! 0 discussed in the followings.

We next discuss in greater detail the and the gauge modes. As seen in Fig.1, the mode is a uctuation of I towards the north and south poles, and describes the admixture of the s-ux phase. From Eq.(37) we see that u generates a staggered in aginary part to the hopping matrix elements which will produce staggered orbital currents. Thus the physical manifestation of the mode is staggered orbital current uctuations. The softness of the mode means that it is readily excited by thermal or quantum uctuations. This is clearly related to the strong staggered

orbital current uctuations found in the projected d-wave superconductor wavefunction.¹⁷ The energy cost is low because the s- ux and the d-wave superconductor are almost degenerate in energy. The energy di erence arises only because a_0 is di erent in the two states. At the mean eld level, the energy di erence comes from the Fermi pockets and is proportional to x^2 . However, we nd that after integrating out a_0 , the energy cost increases, apparently due to the enforcement of the constraint and the eigenvalue shown in Fig.3 is linear in x. We have also computed the eigenvalues for nite !. It should be noted that the 9 9m atrix is not Hermitian for nite ! m (M atsubara frequency). Then we make the analytic continuation as $i!_m$! ! + i with in nitestim al > 0. This can be neglected outside of the particle-hole continuum, and in this case the 9 9m atrix is Hermitian and its eigenvalues are real. We will present below the results for (q;!) outside of the particle-hole continuum. We found that the eigenvalue can be tted by ax $\frac{b}{x}!^2 - \frac{c}{x}k^2$ for small ! and k = q (;). The inverse x dependence of the coe cient m ight be suprising but the !² and k region shrinks as x become es small, so that the x = 0 limit is smoothly attained. Furtherm ore, the negative coe cient of k² indicates that the eigenvalue has a boalm aximum at q = (r;). A plausible dependence is $P \frac{(a_x)^2}{(a_x)^2} = \frac{b^0!^2}{c^0k^2}$, which is reduced to the above form in the limit j! j j j j < < x. Back to the M atsubara frequency,

the suggested e ective action for the mode is

in the region $j!_m j; j < x$. The small energy gap ax leads to a strong spectral weight. This is con m ed by direct num erical calculations in the next section. Here it is interesting to compare these results with the SU (2) form alism with those in the U (1) where only a_0^3 is integrated over. The suggested action in this case is

Therefore it is evident that the SU (2) sym m etry leads to quite di erent x-dependence in the lim it x ! 0.

To investigate the gauge modes we rst discuss x = 0. The mean eld solution is the - ux phase where the ferm ions obey the D irac spectra with nodes at $(\frac{1}{2}; \frac{1}{2})$. A first integrating out the ferm ions, it is known that the eld ective gauge eld action is purely transverse and given by³⁰

where a is the continuum version of $a_{i_{j_{1}+}}$ and k is measured relative to (;). We con m this by computing the eigenvalues for x = 0 at nite q = (1:03;). The transverse mode behaves as $p \frac{1}{k^2 + \frac{1}{m}}$ as expected while the longitudinal mode is exactly zero for all $!_m$. This is because the longitudinal mode is pure gauge (a = r) and is not a real degree of freedom. In constrast, if we worked with the U (1) formulation [Eq.(7)], we nd that the longitudinal mode has eigenvalue close to j! j. Thus the addition of the a_0^1 and a_0^2 in the SU (2) formulation is crucial. O therw is we would have gotten a spurious collective mode. This is a dram atic illustration of the advantage of the SU (2) formulation, if one is interested in obtaining meaningful results which are smoothly connected to the undoped case. For nite x we see from Fig.3 that the eigenvalue increases linearly with x for small x. A reasonable approximate for the transverse mode is [for k = q (;)]




FIG.5. The eigenvalue (in units of J) of the transverse and longitudinal gauge mode as a function of $k_x = (q_k) = w$ ith $q_y = and !_m = 0$ for x = 0.004. They show the expected behavior for small x and q near (;) because when x = 0 and $!_m = 0$, the transverse mode should be linear in k j and the longitudinal mode should be zero for all q and $!_m$.

is the continuum limit of $v_{i;i+}$ and $_{0}$ parameterizes the spectral weight. Thus we expect the transverse mode to show an edge singularity starting at $! = \frac{p}{(a \times x)^{2} + k^{2}}$. In Fig.5 we show the eigenvalues of the gauge modes as function of $(q_{x}) = at q_{y} = and !_{m} = 0$, which shows the expected dependence on q_{x} from eq.(48) for transverse mode.

At nite x the longitudinalm ode becom es a realdegree of freedom due to the breaking of the residual U(1) sym m etry. At $!_m = 0$ and q = (;) the eigenvalue is a x, degenerate with the transverse mode. For nite $k_x = q_x$, the eigenvalue shows a slow decrease and then saturates. This is shown in Fig.5. This is to be expected as the eigenvalue is zero for all $!_m$ and q for x = 0. As for the spectral function, we just invert the 12 12 m atrix num erically with $!_m ! ! + i$, and we do not have to worry about the non-H erm it in nature of the m atrix, which will be shown in the next section. It is worth noting that the longitudinal gauge mode is the only mode with signi cant coupling to R and therefore to density uctuations.

We next discuss the Goldstonem ode. We expect the eigenvalue to be of the form $_{s}(r)^{2}$, where is the continuum lim it of a slow ly varying $_{u}$. We indeed verify that upon diagonalizing the 9 9 matrix described in the last section, a soft eigenvalue emerges which is linear in q². Furtherm one the coe cient $_{s}$ is proportional to x. This is to be expected in our SU (2) formulation, as x = 0 is an insulator. It is interesting to analyze how this result emerges. The point is that the coe cient of $(r _{u})^{2}$ in the free energy computed using Eqs.(21,40) is $_{f}$, which corresponds to the super uid density of a nearly half-lied conventional superconductor, and $_{f}$ 1. How do we obtain $_{s} = x$? In the numerics we nd that the $_{s}q^{2}$ mode is a coupled mode between $_{u}$ and $_{s}$. Recall that $_{s}$ is related to the phase of $_{ij}$ and may therefore be identied with the U (1) gauge eld a in the U (1) formulation.²⁰ In that formulation the free energy in the superconducting (B ose condensed) state takes the form

The screening of r_u by the gauge eld a converts the ferm ion response f to the physical response s_x . When we express Eq.(50) in matrix form we see that the free energy has diagonal contributions $f(r_u)^2$ and $(f + b)a^2$ and an o-diagonal term fr_u a. When we examine the 9 9 matrix, we not that for small q_u is only coupled

to $_{s}$ and the form of the 2 2 sub-m atrix is just that given by the above discussion if we identify a with $_{s}$. Upon diagonalizing the 2 2 m atrix, the soft m ode with eigenvalue $_{s}q^{2}$ emerges. This simply con rms that our SU (2) form ulation contains the same U (1) gauge eld and the same exceening mechanism is at work. One consequence of Io e-Larkin screening is that at nite temperature $_{s}(T) = _{s}(0) Cx^{2}T$, i.e., the coe cient of the linear T term is proportional to x^{2} . We have also veriled numerically that this is the case by computing $_{s}$ at nite T. Experimentally, there is strong evidence that the coe cient of the linear T term is independent of x. ³¹ The fact that $_{s}$ is proportional to x can be seen m one readily if we associate the phase $_{i}$ with b_{i} in Eq.(13) instead of with z_{i} as we have done so far. Then it is clear that for static $_{i}$, only the last term in Eq.(12) depends on $_{i}$ $_{j}$ and the free energy change m ust be proportional to r_{0}^{2} x. Furtherm one, the coupling to ferm ion excitations is proportional to x, so that the response to therm al excitations of quasiparticles is proportional to x^{2} . Thus Io e-Larkin and our uctuation theory are in disagreem ent with experiment. We believe this is an indication that the ferm ions and bosons are conned to become electrons in the superconducting state and that connem ent physics is beyond the Gaussian uctuation considered here.

V.NUMERICAL RESULTS FOR THE SPECTRAL FUNCTIONS OF THE MODE AND THE GAUGE MODES

As shown in Appendix A, the collective uctuations about the saddle point is described by the quadratic form

and we focus on three cases, the mode (A = u), the transverse and longitudinal gauge modes ($A = v_{i,i+}$). Using Eq.(44) these are readily expressed in terms of

and computed numerically. We use parameters in Eq. (21) t=J = 16=3, i.e., t=J = 2 and $t^0=t = 0.5$, which gives realistic ferm ion bandstructure and we show results for x = 0.1. The mean eld parameters are $_0 = 0.376$ and

 $_0 = 0.255$. Note that the maximum energy gap is $E_g = k_{e(j;j)} = 4_0 J W e m$ easure energy in units of J and the lattice constant is set to unity.

It is in portant to note that we de ne the correlators in term softhe eigenvectors [(Eq.44)] which are the eigenvectors for q = (;) and $!_m = 0$. A way from (;), the overlap with the true eigenmode is modiled and other modes may mix in. Furthermore, for the -gauge modes, the assignment in Eq.(44) corresponds to \polarization" in the x and \hat{y} directions, and are the appropriate longitudinal and transverse modes only for q along the $(q_x;)$ direction. Thus the num erical results show n here should be viewed as providing a guide for the behavior of the modes near (;). In the next section we will compute correlation functions which are experimentally observable in the entire B rillouin zone.




FIG.6. Spectral function for the mode for $q = (q; q_y)$ from 0 to (;). A contour plot and a bird's eye view are shown. Frequency ! is in units of $J' = \frac{3}{8}J$.

Figure 6 shows the results for the mode S (q;!) with q along the diagonal $q_x = q_y$ in a contour plot and also in a bird's eye view. We see that the spectral function shows a strong peak near ! 1:1J (J is de ned after Eq.(8) and is suggested to take the value $J = \frac{3}{8}J$) which is strongly localized near q = (;). The spectral function disperses rapidly upwards as q deviates from (;). The very large peak height can be anticipated from the approximate form given by Eq.(45) because the small value of the gap ax gives a large spectral weight upon inversion of the elective action. The strong and narrow peak is responsible for the orbital current uctuations in the superconducting ground state.¹⁷




FIG.7. Spectral function for the transverse gauge mode for $q = (q_x;)$, i.e., from (0;) to (;). A contour plot and a bird's eye view are shown. Frequency ! is in units of $J' (= \frac{3}{8}J)$.




FIG.8. Contour plot of the spectral function for the longitudinal gauge mode for $q = (q_x;)$, i.e., from (0;) to (;). Frequency ! is in units of $J' (= \frac{3}{8}J)$.

Figures 7 and 8 show the transverse and longitudinal gauge modes along $q = (q_k;)$. The operators are chosen to be




FIG.9. The lineshape for the mode at q = (;). Frequency ! is in units of $J' (= \frac{3}{8}J)$.

are the uctuations of the real part of $_{ij}$ and $_{ij}$, respectively. Since $_0$, $_0$ are real, these correspond to an plitude uctuations. These correlators are readily related to the correlations involving U³ and U¹, respectively. Equations (56,57) are simply the resolution of the uctuations illustrated in Fig.2 into its components along the vertical and horizontalaxes. Near (;) the two modes are degenerate and show a peak around ! = 1.5T. The lineshape is show n in Fig.9. The mode is dam ped by particle-hole excitations and a sharp feature appears as the frequency drops below the particle-hole continuum. (Recall that the particle-hole continuum is set by the scale $! = 2E_g 2J$ with our param eters.) The transverse mode frequency remains low but loses spectral weight as q goes away from ; tow ards (0;). On the other hand, the longitudinalm ode disperses upwards and gains in strength.

Finally we discuss another important mode which is closely related to the gauge mode. It is the uctuation of the amplitude $A = \frac{p}{j_{i,i+1} + j_{i,i+1} + j_{i+1} + j_{i+1} + j_{i+1}}$ and is parametrized by




FIG.10. Spectral function of the amplitude mode at q = (;).

Unlike the modes discussed so far, the amplitude mode has nite eigenvalue in the x = 0 limit. However, for x 0.1 the $!_m = 0$ eigenvalue for the mode has reached the value 0.493, quite close to the amplitude mode eigenvalue of 0.669. As seen from Eqs.(56,57,60) both these modes involve the uctuation of the amplitudes of and , and they will admix for nite frequency. This complicates the interpretation of these collective modes. In contrast, the eigenvalue of the mode is quite low at 0.155 and its interpretation as a collective mode is more clear. In Fig.10 we show the spectral function for the amplitude mode at q = (; ;).

VI.EXPERIMENTAL OBSERVATION OF THE COLLECTIVE MODES

Finally, we discuss possible experimental consequences of these collective modes. As discussed earlier, the mode produces staggered orbital currents. These in turn generate a physical magnetic eld which is staggered and which is, in principle, observable by inelastic neutron scattering. Here we compute the scattering cross-section.




FIG.11. Neutron scattering intensity I (q;!) at zero tem perature vs. ! (in units of $J = \frac{3}{8}J$) at q = (;).

In this way the neutron scattering cross-section is evaluated numerically. We expect that the scattering is predom in nantly coupled to the mode and indeed the result is very similar to the mode spectral function shown in Fig.6. In Fig.11 we show the lineshape I (q;!) given by Eq.(62) in the zero temperature limit at q = (;). In order to estimate the experimental feasibility, we compare the total cross-section (integrated overall q and !) to the scattering from a lattice of $S = \frac{1}{2}$ moments. How et al. estimated the total cross-section to be about 1% of that of spin scattering and our results are in rough agreement. The experimental detection of this signal may be dicult because a resonance in the spin scattering exists around 30 m eV at q = (;) for underdoped cuprates. This resonance is very narrow in q and !, but its integrated weight near (;) is also about 1% of the total spin scattering. The scattering due to the mode is of comparable total strength but more spread out in !, making it harder to detect. However, unlike the spin uctuation which is isotropic, the orbital currents give rise to an elective moment which is perpendicular to the a-b plane. Since neutron is sensitive only to the compare of the moment normal to the quector, the orbital contribution can in principle be extracted by varying the quector from normal to parallel to the a-b plane.

A nother probe which couples to the orbital current is R am an scattering. However, since the excitation is epected to peak at (;), the large m om entum transfer requires X -ray R am an scattering. It is known that X -ray couples to

m agnetic m om ents as well as orbital m om ents.³³ T he m om ent due to the orbital current is weak and corresponds in strength to roughly 0.1 $_{\rm B}$. W hile Bragg scattering from an ordered spin m om ent has been observed,³⁴ inelastic scattering from a short-range order of such a sm all m om ent is beyond the current capability of X -ray scattering. W e note, how ever, that polarization dependence is a powerful tood to distinguish between spin and orbital contributions in X -ray scattering.³³

Next we discuss the possible measurement of the gauge modes. As discussed before, these modes involve the modulation of the amplitude of the hopping parameter $_{ij}$ and the pairing parameter $_{ij}$ in a staggered fashion, i.e., with momentum (;). The amplitude uctuations of the superconducting order parameter is not easy to detect and has been experimentally observed only in the special case of superconductivity in a charge density wave system $.^{35;36}$ On the other hand, the uctuations in $_{ij}$ couples to the quasiparticle hopping matrix element. In the mean eld theory we can write an elective coupling as

where we include $A_{ijit} = aA$ as the lattice version of the electrom agnetic eld A. Expansion of Eq.(66) to rst order in A_{ij} yields the standard j A coupling. When expanded to second order we obtain $\frac{1}{2}xt \frac{e}{c}^2 A_{ij}^2 f_i^y f_j + cc:$. This gives rise to R am an scattering which is coupled to uctuations in $_{ij}$. This kind of coupling was discussed by Shastry and Shraim an³⁷ as an explanation of the continuum background due to incoherent electronic excitations. Here we expect that R am an scattering will couple to the transverse and longitudinal gauge mode. Physically, a modulation of j_{ij} j is a modulation of the bond charge density which should couple to R am an scattering. Standard R am an scattering provides essentially zero momentum transfer. In order to couple to the gauge mode at (;) and to follow its dispersion, X-ray R am an scattering will be needed. The leading contribution to inelastic X-ray scattering originates from the $\frac{e^2}{2m c^2}A^2$ term in the single particle H am iltonian and the scattering cross-section is usually written as³⁸

Apart from $\frac{m}{m}$, which is of order $\frac{1}{2}$, we see that the coupling is similar to the continuum theory, except that the number operator $f_i^y f_i$ is replaced by $\frac{1}{4} f_i^y f_{i+} + cc:$. Furtherm ore, a factor x arises due to the strong correlation. We see from Eq.(69) that X-ray R am an scattering directly couples to the uctuating in $_{ij}$ and therefore to the gauge mode. It seems that high resolution inelastic X-ray scattering is a promising technique to observe the appearance of the gauge mode at low temperatures. The cross-section for X-ray scattering is proportional to $< j (q; !)_j^2 >$ where




FIG.12. Spectral function S (q;!)(= x) for the correlation of the kinetic energy operator $\mathbb{E}q.(71)$ which is measured by inelastic X-ray scattering. A contour plot and a bird's eye view are shown. q ranges from (0;) to (;), i.e., q = (q;). Frequency ! is in units of $J'(= \frac{3}{8}J)$.

The spectral function is peaked at (;) as expected. Note that along the $(q_x;)$ direction (Fig.12) the spectral function has similar structure as the longitudinal gauge mode (Fig.8).




FIG.13. The lineshape of the kinetic operator correlator S; (q;!) (= \Re) as a function of ! (in units of $J = \frac{3}{8}J$) at q = (;). This is the curve labeled as RPA. A loo shown is the curve labeled as bare bubble, which is computed by coupling to particle-hole excitations without allowing any collective enhancement.




FIG.14. The spectral function S (q;!) at q = (;).

The spectral function at q = (;) is shown in Fig.13. We note that its shape is quite similar to that of the amplitude mode shown in Fig.10. For completeness, we also computed the correlation S = < > where

was de ned in Eq.(59). This describes the uctuations of the real part of $_{ij}$ and would correspond to the conventional superconducting am plitude mode. As shown in Fig.14, its shape is similar to that of the gauge mode.

G iven that and are linear superpositions of A and according to Eqs. (56,60), it is surprising that their spectral functions are not simply weighted averages of the amplitude and gauge modes. The reason is that there is signi cant cross-correlation between , as well as between A and , i.e., the am plitude and and uctuations are not truly eigenmodes. This is a consequence of the signi cant mixing at x = 0.1 between these modes at nite frequencies as discussed earlier. It is perhaps better to focus on S ; which is experim entally measurable. The peak observed in S 🚊 corresponds to collective oscillations of the hopping m atrix elem ent. This is a new degree of freedom not present in conventional superconductors. To emphasize this point we have also computed the \bare bubble" response, i.e., using M $^{\rm F}$ without the collective enhancem ent shown in in Eq.(65). As seen in Fig.13, the latter is much more spread out in frequency. Finally we note that for the relatively high doping considered here, the gauge m ode appears to be closely related to the more conventional superconductor am plitude uctuation (albeit at q = (;) and is di cult to detect.

We note that since ij couples to the quasiparticle hopping matrix element, it in turn is coupled to phonons. In

Appendix B we consider the possibility that the collective modes may appear as phonon sidebands which may be detected optically.

V II. C O N C LU S IO N

We have shown that in the gauge theory description of the t-J model, new collective modes appear in the superconducting ground state. The SU (2) gauge theory allows us to classify these collective modes and predict them analytically. These predictions are con m ed by num erical computation of the collective mode spectra. In particular, we see that the SU (2) form ulation allows us to smoothly connect to the x = 0 lim it, whereas in the U (1) form ulation, spurious modes would have appeared.

In this paper we describe the bosons in the radial gauge. It is then clear that boson dynamics do not play a role and that collective modes dynamics are entirely determined by the fermions via the fermion bubbles which make up the matrix M^F. In Ref. (24) we proposed a -model formulation where the low-lying excitations are parametrized by the boson $h = \frac{p}{xz} = \frac{p}{x} \frac{z_1}{z_2}$. We proposed an elective action which included a term $xz^{y}D_{0}z$ where $D_{0} = (P + eA_{0} + a_{0}^{3})^{3}$ [Eq.(78) Ref. (24)]. Note that this term produces a coupling between the and modes of the form (P . This Berry's phase term is absent in the present paper. Thus Eq.(78) of ref. (24) disagrees with the present work and we believe that it is incorrect. Within the -m odel approach in ref. (24), one should have absorbed the z^{y} (P z term into the $z^{y}a_{0}^{3}$ 3 z term by a gauge transform ation and solve for the a_{0}^{0} term s by in posing the constraint locally. That is in fact what is done in this paper for small and . A similar procedure can be adopted for arbitrary and to generate a -m odel. Thus the -m odel should be view ed as a way to parametrize the low-lying uctuation of the U_{1j} matrix [as in Eq.(40)] and the elective action depends only on the fermion dynamics.

The appearance of the new collective m odes answers the question of whether the superconducting state described by the gauge theory is any dierent from a conventional BCS state. The mode is coupled to staggered orbital currents. The importance of these currents was already revealed in the Gutzwiller projected BCS wavefunction.¹⁷ In principle, they should be observable by neutron scattering or X-ray Raman scattering. A new collective degree of freedom is the moduation of the hopping amplitude which is observable by high resolution inelastic X-ray scattering. We also show how they give rise to side-bands in certain phonon modes. However, the weakness of the coupling makes its observation di cult. The predictions of these collective modes are unique features of the slave-boson/gauge- eld approach to the t-J model and experimental searches for the collective modes will serve as important tests of this line of approach to the high T_c problem.

APPENDIX B:COUPLING OF THE GAUGE MODE TO PHONONS

Let us consider the m ode where the planar oxygen m oves in and out of the plane. We focus on the oxygen m ode because the m ass is light and the frequency relatively low, and both features tend to enhance the coupling. In LSCO and YBCO, the oxygen is buckled out of the plane. This problem was considered by Norm and et al.³⁹ who concluded that in YBCO

Note that a uctuation of v_{ij} couples to a (;) phonon mode as expected. It turns out that the modulation of J given by Eq.(B2) does not couple to the gauge mode. The reason is that in mean eld, the modulation of the J term is $J_{ij}(_{ij} + _{ij} + _{ij})$. This couples to the amplitude mode. On the other hand, in the gauge mode, the total modulus $j_{ij}f + j_{ij}f$ is held xed, as shown in Fig. 2. Thus there is no coupling between the gauge mode and the phonon via the J_{ij} term.

We next approximate the phonon as an Einstein model. The energy is given by $\frac{1}{2}(!^2 + !_0^2)a^2M - \frac{u}{a}^2$ where $!_0$ is the frequency and M is the mass. We estimate 1 because we can see from Fig. 9 that the spectral weight of the gauge mode at (;), is of order unity. Unfortunately, g^2 turns out to be very sm all.

The small spectral weight (5 10 ³ of the main phonon peak) means that it is probably in possible to observe the side-band by neutron scattering. Optical measurements of erhigher precision. LSCO of ers a special opportunity in that at low temperatures, the lattice is in the low temperature orthorhom bic phase (LTO) where the buckeling of the oxygen is staggered, i.e., $u_{ij} = u_0 (1)^{i_x + i_y}$. Then a q = 0 distortion $u_{ij} = u_{ij}^0 + u_{ij}$ couples to the staggered modulation in $_{ij}$. Hence in LSCO the gauge mode is coupled to the q = 0 phonon mode which can be studied optically either by absorption or by R am an, depending on its activity. The signature of the side band is that it should appear only in the superconducting phase, because in the norm all state (pseudogap state) the I vector rotates out of the plane and is disordered, so that the mode is expected to be smeared out. Similarly, the weight of the side band will be reduced by applying a magnetic eld by the fraction of the sam ple occupied by the vortex core. This is because the I vector is rotated to the north pole near the vortex core and the mode will be its identity.

The above discussion was based on the assumption that the gauge mode is a well de ned mode and that the amplitude mode A is much higher in frequency and plays no role. This is correct for small doping but we have seen that for x = 0:1, the numerical results show a strong admixture of the gauge mode and the amplitude mode. Nevertheless, it is still correct that the phonon couples to S , which produces a sideband with a lineshape given in Fig.13. However we should include the fact that the phonon also modulates the exchange constant according to Eq.(B2) and couples to the amplitude uctuation as well. Since the amplitude uctuation has a very similar lineshape (see Fig.10) to that of S , the nal result may still be interpreted as a modulation of the hopping amplitude, a new collective degree of freedom not present in conventional superconductors. Finally, we remark that we only have results for T = 0, and in the x = 0:1 case the issue of how much of the spectral weight in S survives above T_c remains open.
