M odularity and Extrem e Edges of the Internet

We study the spectral properties of a di usion process taking place on the Internet network focusing on the slowest decaying modes. These modes allow us to identify an underlying modular structure of the Internet roughly corresponding to individual countries. For instance in the slowest decaying mode the di usion current ows from Russia towards US military sites. These two regions thus constitute the extreme edges of the Internet. Quantitatively the modular structure of the Internet manifests itself in approximately 10 times larger participation ratio of its slow decaying modes compared to the nullmodel { a random scale-free network. We propose to use the fraction of nodes participating in slow decaying modes as a general measure of the modularity of a network. For the 100 slowest decaying modes of the Internet we measured this fraction to be around 30%. Finally we suggest, that the degree of isolation of an individual module can be assessed by comparing its participation in di erent di usion modes. Using the proportionality of response as a criterion we not that the independent module approximation works well for the Internet.

Virtually any complex system has an underlying network that de nes the backbone of interactions among its components. Examples of such networks include the Internet and the W orld W ide W eb, m olecular networks of living cells, food webs in ecosystem s, etc. An important question is whether nodes of such a network can be divided into smaller sub-networks (modules), which interact with each other relatively weakly [1]. Estim ating the strength of inter-modular interactions, localizing crucial links connecting these modules to each other, and nding pairs of modules which are the most distant from each other is important for several reasons. First of all, it serves as a test of stability of the system with respect to breaking it up into truly isolated components. Such a break-up would be undesirable in, for example, the Internet. C reation of extra connections between the m ost distant m odules in the network and reinforcem ent of crucial links is an e cient way to increase its stability. Secondly, by m easuring the relative strength of interand intra-modular connections one directly assesses the quality of the independent module approximation, which may turn out to be important in modeling the actual dynamics of a given complex system .

In this work we explore the modular structure present

in the physical layout of the Internet. To this end we study an auxiliary di usion process taking place on this network. The slowest modes of di usion, easily identi able from the spectrum of its transfer matrix, allow us to detect the weakly interacting modules of the Internet. These modules turn out to roughly correspond to individual countries or for large countries to cultural or geographical regions within the country. Of course, the di usion process studied in this work does not describe the real dynam ics of the inform ation ow over the Internet. However, the detected modular features play an important role in any local dynam ical process taking place on this network including the real Internet tra c.

A nalysis of spectral properties of a similar di usion process lies at the heart of the popular search engine www.google.com [2]. Its variants have also been applied to social networks (the correspondence analysis) β], random and sm all-world networks (the Laplace equation analysis) [4], arti cial scale-free networks, [5, 6] and the community structure of the W orld W ide W eb [7].

In this work we explore the physical layout of the Internet on a coarse-grained level of the so-called A utonom ous System s (AS), which are large groups of routers and servers belonging to one organization such as a university or a business enterprise (e.g. an Internet Service P rovider). To this end we use the January 3, 2000 dataset when the Internet consisted of 6474 A utonom ous System s exchanging inform ation via 12572 undirected links [8]. A s expected for the Internet, any pair of A utonom ous System s is connected to each other by at least one path, so

that topologically the network consists of just one large cluster. The di usion process we analyze here describes the dynamics of a large number of random walkers moving on the network at discrete time steps. Statistical properties of returns to the origin of such random walks have recently been used to measure the e ective dimensionality of several com plex networks [10]. At each timestep every walker moves from its current node to one of the neighboring nodes along a random ly selected link. The average dynamics of this process is described by

$$_{i}(t+1) = T_{ij j}(t) ;$$

where $_{i}(t)$ is the expectation value of the num ber of random walkers at site i and time t. The elements T_{ij} of the transfer matrix are equal to $1=K_{j}$ for neighboring nodes i and j and zero otherwise. Here K_{j} is the connectivity (the number of immediate neighbors) of the pode j from which a walker steps to the node i. Note that $_{i}T_{ij} = 1$, so that the total number of walkers is conserved at all times. Eq. (1) can also be rewritten as a discrete time di usion equation $_{i}(t+1) = _{j}(T_{ij} = j) = _{j}(t)$. Hence the di usion matrix D is related to the transfer matrix T simply as

$$D = T \ 1 \ (2)$$

As time advances the distribution of random walkers approaches a steady state $_i(1)$ in which the di usion current owing from a node ito a node j is exactly balanced by that owing from j to i. This is satisfied when the average number of walkers $_i(1)$ on every node i is proportional to its connectivity K $_i$.

The relaxation of any initial distribution of random walkers among nodes, $_{i}(0)$, towards the steady state conguration $_{i}(1)$ is determined by the spectral properties of the matrix T [11] (or alternatively D). For instance, the steady state conguration $_{i}(1)$ itself is proportional to the principal eigenvector $_{i}^{(1)}$ of T corresponding to its largest eigenvalue $^{(1)} = 1$, which is unique for single component networks such as the Internet. The remaining eigenvectors $^{(-)}$ describe the decay of the initial conguration towards the steady state with a characteristic decay time $^{(-)}$ related to the corresponding eigenvalue $^{(-)}$ through exp($1 = ^{(-)}) = j^{(-)}j$. Note that in general there exist both non-oscillatory ($^{(-)}$, 1) slow ly decaying modes.

The modularity of a given complex network rejects itself in statistical properties of its dijusion eigenvectors $_{i}^{()}$. One such property is the Participation Ratio (PR), which quantiles the elective number of nodes participating in a given eigenvector with a signil cant weight. In the Internet the components of the principal eigenvector $_{i}^{(1)}$ / $_{i}(1)$ / K i as well as those of other slow decaying modes are broadly distributed (scale-free) [12] and as such tend to be localized on just a few highly connected nodes. In this case participation ratios are best calculated using the norm alized eigenvector

of outgoing currents owing from node i along each of its links. M one form ally $c_i^{(\)}$ is also the eigenvector of the transposed transferm atrix T^Y with the same eigenvalue ⁽⁾. For such a vector normalized by $c_i^2 = 1$ the participation ratio is de ned as: PR = $P_{i=1}^{P} c_i^4$.




FIG.1: The participation ratio PR⁽⁾ (top, A) and the eigenvalue density (bottom, B) as a function of the eigenvalue $1 < {}^{()} < 1$ m easured in the Internet (lled circles) and in its random ized counterpart (open squares) { a R andom Scale-Free N etwork (R SFN). The participation ratio was averaged over -bins of size 0.05 excluding eigenm odes ${}^{()} = 0$ [15], and ${}^{(1)} = 1$. Notice that for j j' 1 participation ratios in the Internet signi cantly exceed those in an R SFN indicating the m odular character of the form er network.

In Fig. 1 the participation ratio of eigenvectors $c_i^{()}$ (top) and the eigenvalue density (i.e. the spectrum of the matrix) (bottom) is plotted as a function of the corresponding eigenvalue $1 < \frac{()}{i} < 1$. The data for the

Internet (led circles) is displayed together with the data for its random ized counterpart (open squares). The random ization of the Internet was performed in such a way that the connectivity of every node is strictly preserved [13]. It was argued [13, 14] that such a network constitutes a proper null model of a given com plex network. Since this random network has the same scale-free distribution of connectivities as the Internet [12] it will be referred to as a R andom Scale-Free N etwork (R SFN).

C om paring the data for the Internet and an RSFN we note that while the density of states is rather sim ilar in these two networks (Fig. 1 B), the participation ratio of the slowly decaying modes (especially for the non-oscillatory ones with close to 1) is markedly higher in the Internet than in an RSFN (Fig. 1 A). In these non-oscillatory modes the di usion current ows from relatively isolated regions (modules) along the few links connecting them to the rest of the network. If for such a module these links would be hypothetically cut

one by one, the corresponding eigenvalue would gradually increase towards unity, ()! 1, while the eigenvector would become more and more localized on the module. When nally the module is completely disconnected from the network the eigenvector has evolved to the steady state solution on the module, which has the participation ratio equal to its size. Thus the PR of slow ly decaying eigenmodes serves as a good quantitative estimate of the size of modules in the network. In an RSFN these modules are small consisting of just a handful of nodes that accidentally happen to be loosely connected to the rest of the network. The fact that the participation ratios of slow decaying modes on the Internet signi cantly exceed those in an RSFN indicates that the corresponding modules are real and not accidental. The average participation ratio of slow lyplecaying modes PR⁽⁾j⁽⁾^{*}[±] j⁽⁾^{*}. For can be quanti ed by 5 k 10 this average changes only slow ly in both the Internet and an RSFN and equals approxim ately 60 and 5, respectively. A rough estim ate for the num ber of different m odules is given by the num ber of slow ly decaying non-oscillatory states in Fig. 1 A that have a participation ratio signi cantly exceeding that of an RSFN. For the Internet the number is around 100. The sum of the participation ratios for these st 100 m odes, 5400 , is a rough estim ate of the total num ber of nodes in the modular part of the network. This should be compared to the same sum being approximately equal to 520 in an RSFN. If one takes special care to avoid double counting nodes that appearm ore than once among the set of PR⁽⁾ nodes with the largest $jc_i^{()}$ jtaken for each eigenm ode 1 < 100, this num ber gets reduced to 1800. Thus the overall modularity of the Internet network is at least 1800=6500 ' 30% .




FIG. 2: Components $c_i^{(2)}$ of the slowest decaying di usion mode in the Internet (eigenvalue $\ ^{(2)}$ = 0.9626) as a function of the AS number. The AS known to be geographically located in Russia are marked with circles. The scale of the negative part of the y-axis is increased for clarity. Out of 100 A utonom ous System s with the most negative components $c_i^{(2)}$, those 23 for which we were able to nd the description are associated with the US M ilitary.

To determ ine the organizing principle behind these Internet modules in Fig.2 we plot the outgoing current $c_i^{(2)}$ in the slow est decaying di usion mode ($^{(2)} = 0.9626$) as a function of the AS number (note that som e AS numbers are not yet in use). Autonom ous System s known to be located in Russia are marked with a circle. The PR for this eigenmode is 107, while the total number of Russian AS in our dataset is 174. In Fig. 2 one can see that alm ost all the A utonom ous System s that significantly participate in this mode (large positive $c_i^{(2)}$) are Russian. We have checked that the few exceptions to this rule are in fact Autonom ous System's closely related to Russia. Thus in the slowest decaying mode the di usion current ows from a module that may be identied with Russia tow ards the rest of the Internet. Curiously enough the set of A utonom ous System s furthest away from Russia (the most negative $c_i^{(2)}$) are located in the US and belong to the US M ilitary. This possible legacy of the cold warm akes Russia and the USM ilitary the extreme edges of the Internet. Perform ing a sim ilar analysis for other slowly decaying modes we get a similar picture, just with other pairs of countries being pulled out. For the Internet the modules thus correspond to individual

countries, or for large countries { to organizational or geographical features within the country.

It is interesting to note that these country-modules cannot be detected using the spectral analysis of the adjacency matrix of the network [5, 6, 9]. The elements of this matrix, closely related to T, are equal to 1 for a pair of neighboring nodes and 0 otherwise. The largest eigenvectors of the adjacency matrix are known to be localized primarily on the highest connected hubs and their neighbors [5, 6]. However, unlike in the case of T, this undesirable localization cannot be properly eliminated simply by dividing the components of the eigenvectors by the connectivity K_i. Hence eigenvectors of the adjacency matrix do not properly related to country-based modular structure uncovered in this work.

Having established that the Internet is indeed modular we now address the question of how good these individual modules are. To this end we compare di erent eigenmodes $c_i^{()}$ to each other. Although the primary feature in a slow ly decaying eigenmode $c_i^{(\)}$ is the ow between a dominant pair of country-modules (such as between Russia and the USM ilitary in $c_i^{(2)}\xspace$), other $\ensuremath{\mathsf{m}}\xspace$ odd ules may also participate in it but to a smaller extent. This gives rise to a ne structure within slow decaying modes that is not captured by the participation ratio. The hallmark of a good module is that even though it participates in di erent eigenmodes to a di erent extent, the relative distribution of -currents within the module stays approximately the same. In other words it enters di erent eigenmodes as just one degree of freedom . In this case the ratio $c_i^{(\)}=c_j^{(\)}$ is approximately independent of the eigenmode $\$ for any pair of nodes iand jwithin the module. This is equivalent to the condition that for any two di erent eigenmodes and ,




FIG.3: The Internet clustering: Coordinate of the i-th AS in this plot are its components $(c_i^{(2)};c_i^{(3)})$ in the two slowest decaying non-oscillatory di usion modes. The color code reveals the geographical location of the AS:Russia - red squares, France - green circles, USA - blue crosses, Korea - orange triangles). Note the straight lines corresponding to good country-modules.

 $c_i^{(\)} = c_i^{(\)} = {\rm const}$ for every node i belonging to the given m odule. In Fig. 3 we plot the outgoing currents in the two slowest decaying non-oscillatory eigenm odes { $c_i^{(2)}$, and $c_i^{(3)}$ { as a function of each other. Sim ilar plots can bem ade for other pairs of slow decaying eigenm odes. The

principal feature in this kind of plot is a star like shape, where di erent rays of the star correspond to individual country-m odules. This type of plot is more powerful in identifying individualm odules than the participation ratio alone. Indeed, in Fig. 3 one can easily detect not only the most excited modules like Russia, France, and US (red squares, green circles, and blue crosses), but also less excited ones like Korea (orange triangles). We believe that the idea of measuring the quality of individual modules by how proportionally their nodes participate in di erent slow ly decaying modes, can be easily generalized to other dynam ical processes taking place on the network such as e.g. spin dynam ics, vibrationalm odes, etc.

Finally, we would like to point out another interesting feature of Fig. 1. Both the density of states and the participation ratio are nearly symmetric around = 0for both the Internet and an RSFN. This near symmetry indicates that both these networks are alm ost bipartite [16], a feature also observed in citation networks, but not in metabolic networks [10]. In fact, a more detailed analysis shows that while alm ost every slow oscillatory mode (^(osc) / 1) is related to the corresponding nonoscillatory mode with ' j ^(osc) j the reverse is not true as there are roughly 30% m ore modes near = 1 than near = 1. Those country-modules that are present in both the oscillatory and non-oscillatory parts of the spectrum are internally almost bipartite. The simplest bipartite graph is a tree and this seems to be the dom inant structure within the Internet modules.

In sum ma, we have demonstrated how a di usion process taking place on the Internet network allows one to extract information about its modules and extrem e edges. For many \real-world" com plex networks the bcalcontext of a node (in term s of the linkage pattern) re-

ects, or, perhaps, even determ ines the importance and function of the given node. For instance, in biology one can successfully assign putative functions to unclassi ed proteins based on the function of their interaction partners [17]. In general the di usion process introduced in this work can be seen as a system atic way to explore the local linkage structure of a network beyond just the nearest neighbors. The detection of the modular structure of a network is just one possible application of such a process [2, 10].

More generally zeromodes are localized on small substructures in the network where every second node is of low connectivity.
