## Comment on \Stability of SmallCarbon-Nitride Heterofullerenes"

In a recent Letter [1], Schultz et al. proposed the existence of heterofullerenes  $C_n \times N_x$  (40 50) n based on the pattern of the peaks in the mass spectrum of carbon-nitride nanostructures produced by the arcdischarge technique. U sing PM 3 sem iem pirical calculations, they predicted the most stable structures of the N-substituted fullerenes,  $C_{33}N_9$  and  $C_{44}N_6$ , to have  $C_3$ sym metry. W hile som e level of sym metry seem s to maxim ize stability, the highest symmetry often sacrices it, as in the case of fullemene  $C_{84}$  [2]. U sing PM 3 and density functional theory (DFT), we argue that a highly system atic investigation is needed to determ ine the most stable structures of both pristine and N-substituted fullerenes. W e dem onstrate this explicitly for two particular cases,  $C_{40}$  and  $C_{44}N_6$ , for which the authors of Ref. [1] only considered four and two isom ers, respectively.

M athem atically, there are 40 possible isom ers for C<sub>40</sub> [3]. We optim ized the geometries of the 37 isom ers with non-vanishing HOMO-LUMO gaps using the PM 3 Ham iltonian and the B3LYP functional with STO-3G, 3-21G and 6-31G \* basis sets as im plemented in G aussian 98 [4]. The closed-shell form alism was used and the topological sym metry was maintained throughout. Isom ers 1, 30 and 40 (note: the isom er index follows Ref. [3]) have zero HOMO-LUMO gaps at the Huckel level of theory. G eom etric convergence could not be achieved for these cases at the PM 3 level and no further calculation was perform ed.

The most stable isom er of C<sub>40</sub> is predicted to be isom er 38 (D<sub>2</sub>) by all levels of theory. A nalysis of the heats of form ation (not show n) indicated that isom er 38 is not am ong the four isom ers studied in Ref. [1], although the authors did not identify the isom ers. Isom ers with low relative energies include isom er 39 (D<sub>5d</sub>, 10.9 kcal/m ol) and isom er 31 (C<sub>s</sub>, 16.1 kcal/m ol), see F ig. 1. All other isom ers have energies higher than 20 kcal/m ol. These results are in agreem ent with earlier predictions [5,6]. The stabilities from di erent levels of theory agree with each other.

In Ref. [1], Schultz et al. showed an isom er with  $C_3$  sym metry as the most stable structure for  $C_{50}$  substituted with six nitrogen atoms (Fig.4b in Ref. [1]). Here we present a complete search of the N<sub>6</sub>-substituted isomers within the frame of  $C_{50}$  270 (D<sub>3</sub>). Dividing the six

N atom s into two groups of three atom s and substituting di erent groups of carbon atom s in C  $_{50}$  270 gives 64 possible structures. We rst perform ed calculations at PM 3 and B 3LY P/STO-3G levels, which gave sim ilar relative energies. Three structures have relative energies lower than 16 kcal/m ol, whereas all others have relative energies higher than 40 kcal/m ol. Further calculations at the B 3LY P/6-31G \* level gave relative energies as 0.00 (D  $_3$ ), 6.78 (C  $_3$ ) and 9.63 (D  $_3$ ) kcal/m ol, con rm ing results from low er levels. The HOM O -LUM O gaps, 2.70 eV, 2.85 eV and 2.58 eV, respectively, are large by DFT standards, indicating their kinetic stability. Fig.2 shows the m ost stable structure of C  $_{50}$  270 w ith N  $_6$ -substitution having D  $_3$  symmetry.

In sum m ary, quantum chem ical calculations at both DFT and PM 3 levels indicate that either a com plete survey or a m ore rational selection schem e is needed to determ ine the ground state structures of fullerenes.
