Three-Fluid Description of the Sympathetic Cooling of a Boson-Ferm ion Mixture

Abstract

W e present a model for sympathetic cooling of a mixture of fermionic and bosonic atom ic gases in harmonic traps, based on a three-uid description. The model con m s the experimentally observed cooling limit of about $0.2 T_F$ when only bosons are pumped. W e propose sequential cooling { rst pumping of bosons and afterwards fermions { as a way to obtain lower temperatures. For this scheme, our model predicts that temperatures less than 0:1 T_F can be reached.

Recent attempts to cool down a trapped gas of ferm ionic atoms, such as 40 K [1] or 6 Li [2,3], have reached temperatures below the Ferm i temperature. Degenerate atom ic Ferm i gases o er the intriguing possibility to create a paired ferm ion state such as a Bardeen-Cooper-Schrie er phase in a novel and highly controllable system. However, until now the temperatures obtained in the experiments with ultracold ferm ionic atoms are not low enough to observe such phenomena. In this paper, we propose a straightforward description of the cooling mechanism, discuss its inherent limitations, and we investigate strategies to alter the cooling procedure in order to achieve lower temperatures.

The cooling process used to create Bose-E instein condensates in trapped bosonic gases is evaporative cooling, whereby the most energetic atoms are removed from the gas, leaving the remnant colder after rethermalization. However, due to the antisymmetrization requirement of the fermionic wave function, identical fermionic atoms cannot undergo the s-wave collisions necessary for rethermalization, and thus they cannot be directly cooled using evaporative cooling. This problem was circum vented by simultaneously trapping two atom species or two di erent hyper ne spin states of a given atom species. In [2], ⁶Li is trapped together with its bosonic isotope ⁷Li. W hereas the s-wave scattering length of ⁶Li is zero by symmetry, the s-wave scattering length for a collision between a ⁶Li and a ⁷Li atom is 2.2 nm, which is enough to thermalize both species together. This version of evaporative cooling is denom inated 'sympathetic cooling'.

We describe the sympathetic cooling process, using the three-uid model presented in Sec. II, as a sequence of evaporation and retherm alization steps so that in the evaporation steps the energetic atoms are removed from the mixture and in the retherm alization steps the new (lower) equilibrium temperature is reached, as explained in Sec. III. The results obtained with this model are discussed in Sec. IV, and an improvement on the current sympathetic cooling process is proposed to reach lower temperatures (< $0:1 T=T_F$).

II.THREE-FLUID MODEL

The trapped system which will be subjected to sym pathetic cooling consists of N_b bosons with mass m_b and scattering length a_b ; and N_f fermions with mass m_f, all at initial temperature T in a parabolic trap with trapping frequency ! and characteristic length $a_{HO_{b,f}} = \frac{1}{2} \sim = (m_{b,f}!)$. The scattering length for a collision between a boson and a fermion will be denoted by a_f . The three- uid model [4] distinguishes the fermion gas, the Bose-E instein condensed (BEC) bosons and the non-condensed or therm all bosons. The number of BEC bosons is N_c = N_b (1 (T=T_c)³) for T < T_c and zero otherwise, where [5]

The number of therm albosons is $N_t = N_b$ N_c . We use the notation

where $m_r = 2m_b m_f = (m_b + m_f)$ is twice the reduced m ass of a ferm ion and a boson. $n_c(r)$ is the density of BEC bosons, $n_t(r)$ is the density of therm albosons, and $n_f(r)$ is the density of ferm ions. In the three-uid m odel, the BEC bosons, the therm albosons and the ferm ions are described as ideal gases in elective one-body potentials. The elective one-body potential for the BEC bosons (V_c), for the therm albosons (V_t) and for the ferm ions (V_f) are given by:

In these expressions, = 1=($k_B T$) and $_f$; $_b$ is the chem ical potential of the ferm ion gas and boson gas respectively. The set of equations (3)-(5) and (6)-(8) form a self-consistent description of the three uids, in which the chem ical potentials are set by xing the total number of ferm ions and the total number of bosons; $N_b = d^3r (n_c (r) + n_t (r))$ and $N_f = d^3r n_f (r)$: Note that the interaction between the bosonic atom s, and the interaction between the bosonic and ferm ionic atom s, is taken into account on the level of the mean-eld approximation.

The total energy of the BEC bosons (E $_{\rm c})$, of the therm albosons (E $_{\rm t})$ and the ferm ions (E $_{\rm f})$ is given by

From the above set of equations (3)-(11), the tem perature, and the chem ical potential of the bosons and the ferm ions can be calculated if the total num bers of bosons and ferm ions,

and their total energy are given. Note that the Bose-E instein condensate is treated in the Thom as-Ferm i approximation as if it were at zero temperature. For the thermal bosons we have experimented using the Maxwell-Boltzman distribution instead of a Bose-E instein distribution in the expressions for the density (7) and the energy (10). In the experiment, this approximation is routinely performed in order to determine the temperature of a trapped atom ic gas by thing the Maxwell-Boltzman distribution to the tail of the measured velocity distribution or density pro le. A lso in our calculations, we found that the Maxwell-Boltzman distribution provides an accurate description of the thermal bosons.

III.SYM PATHETIC COOLING

We describe the cooling process as a two-step process. The rst step is the evaporative stage, whereby either just the bosons can be 'evaporated', or just the ferm ions, or both bosons and ferm ions. The e ect of the evaporative stage is truncating the radial distribution by rem oving the outer atom s. The energy of these atom s is higher than the average energy of the m ixture and so this rem oval allows us to obtain a lower tem perature. The second step is the retherm alization stage, where the collisions between the bosons and between bosons and ferm ions bring the truncated (non-equilibrium) distribution obtained in the evaporative stage into a new equilibrium distribution. This new equilibrium distribution will be at a lower tem perature if the atom s rem oved have m ore energy than the average atom energy. We will describe the sym pathetic cooling as a discrete succession of evaporation and retherm alization stages. In reality, the evaporation and retherm alization goes on simultaneously. However, previous studies have shown that the discrete treatment of the cooling process provides an accurate description [6].

The evaporation is realized by a radiofrequent (or microwave) eld which induces a transition between the trapped hyper ne state of a selected atom species and an untrapped hyper ne state. The frequency suited for this transition depends on the distance from the atom to the center of the trap, due to the Zeem an e ect of the spatially varying m agnetic trapping eld. By tuning the frequency, atom s that are beyond a cut-o distance R from the center of the trap are rem oved. If the bosons are evaporated in this way, then the number of bosons which are rem oved from the mixture is

and the total energy rem oved in the evaporation is

If ferm ionic atom s are rem oved from the mixture, then the corresponding number of rem oved ferm ions N $_{\rm f}$ and the total evaporated energy of the ferm ion gas E $_{\rm f}$ are found from

expressions analogous to those above. Note that evaporating the Bose-E instein condensed bosons will not lead to cooling. The Bose-E instein condensed bosons are always the lowest-energetic bosons in the mixtures – removing them would only lead to heating of the system. Thus it is important that the cut-o distance R_c is larger than the Thom as Ferm iradius of the condensate.

The evaporative stage results in a new total number of bosons $N_b^0 = N_b$ N_b, and a new total energy $E_{total}^0 = E_c + E_t + E_f$ E_t, if only bosons are removed from the trap. If also ferm ions are evaporated, E_f has to be subtracted too, and $N_f^0 = N_f$ N_f is the new number of ferm ions. U sing the equations (3)-(11), the new system parameters N_f^0 ; N_b^0 ; E_{total}^0 are expressed as a function of the new temperature T⁰ and the new chem ical potentials $\frac{0}{b}$ and $\frac{0}{f}$. The new temperature and chem ical potentials are then solved from these equations. A fler this retherm alization stage, a new evaporative stage can be initiated.

Losses due to three-body collisions lead to heating, since the three-body collisions will be prominent in the condensate which harbors the coldest atom s. Such losses introduce another depletion of the number of atom s. For the bosons,

where K₃ is the three-body collisional cross section and t is the time duration of one step. For ⁷Li, K₃ is about 2:6 10²⁸ cm⁶ = s [7]. This additional loss process can be taken into account during the evaporative stage.

IV.RESULTS AND DISCUSSION

A . Evaporating the bosonic atom s

In the experim ents on sym pathetic cooling by Schreck et al. [3,8] a m ixture of bosons and ferm ions is cooled from 2 m K to around 9 K, starting with 2 10^{8} ⁷Libosons and about 10^{6} ⁶Li ferm ions, in an anisotropic trap (!_r = 2 4050 Hz, !_a = 2 71:17 Hz). We have simulated this process and compared with the experimental data [8]. The suited number of steps can be determined by noting that the time needed for the system to retherm alize is 200 m s and that the reported cooling process takes 35 s [8]. The number of 200 m s steps must be of the order of 100-200. For the evolution of the cut-o radius in time, we have used the same as in [8]. The agreement between theory and experiment, shown in gure 1, is reasonably good.

In the next simulation we have started from 9 K, trying to cool further by evaporating only bosons, as is done in the experiment reported in Ref. [3]. We simulate the evaporative cooling of a system, starting with $N_f = 4$ 10³ fermions and $N_b = 10^6$ bosonic atoms at an initial temperature of T = 9 K which is 6:12 times the Fermi temperature for this amount of fermions. Figure 2 shows the cooling process as a function of the time (number of evaporation-retherm alization steps), when the evaporation is performed at decreasing cuto radius starting from 20 $a_{\rm HO}$ and decreasing with 0:32 $a_{\rm HO}$ each time step. The lowest

tem perature which is obtained is $0.22 \, T_F$, in agreem ent with the tem perature reported by Schreck et al. [3]. We have perform ed the simulation for dierent values of the three body boson decay constant (K 3) and one can see that in our model there is only an e ect on the num ber of bosons, not on the naltem perature.

Figure 3 illustrates the in uence of the initial cut-o radius on the cooling process, showing the tem perature at step 10,20,30,40 and 50 of the cooling process, as a function of the initial cut-o radius. During each step the cut-o radius was decreased by $0.32 a_{\rm HO}$. An optim al radius exists around 18 $a_{H O}$, which is small enough to rem ove enough bosons, but su ciently large in order not to remove too m any bosons in the initial steps and not being energy selective. The simulations have a maximum of 50 steps or stop when the cut-o radius becomes smaller than the condensate. In gure 4 we investigate how the tem perature obtained by cooling is a ected by reducing the cut-o radius with di erent am ounts during the cooling process. At each time step, the cut-o radius is decreased by a size a. The di erent curves in the gure show the tem perature as a function of time (step in the cooling process) at di erent values of a. We nd that a faster rate of decrease of the radius leads to a faster cooling, but that no lower tem peratures can be reached. If the radius is decreased too fast, it reaches the radius of the condensate too soon, and the cooling process is stopped. For a xed time of the cooling process, which is determ ined by the loss rate of the trap, an optim al value of a can be determ ined. For the 50 steps that we took in qure 4, this is a between 0.32 and 0.6 trap oscillator lengths. Figure 5 shows the dependence of the tem perature on the initial number of bosons, keeping the number of ferm ions xed. We nd the counterintuitive result that the initial ratio between bosons and ferm ions has only a m inor e ect on the nalter perature that can be reached: it is always around $0.2 T_F$. This can be understood by noticing that the number of therm allosons (which are responsible for the cooling) is alm ost independent of the total num ber of bosons for tem peratures below

the condensation temperature. (N_t = N_b $\frac{T}{T_c}^3$ T³ (3)).

Truscott et al. [2] note that the cooling process seem s to stall as soon as the speci c heat of the bosons is sm aller than the speci c heat of the ferm ions, because the energy which can be carried away by evaporating a bosonic atom then becomes smaller than the energy of a ferm ionic atom. This result is con rm ed by the present simulation, which explains why the naltem perature is insensitive to the initial ratio of bosons to ferm ions. Basically, when the num ber of therm albosons is sm all compared to N $_{\rm F}$, the energy which can be carried away by evaporating the bosons is small compared to the energy of the Fermigas. The temperature does not decrease signi cantly and the bosons are quickly lost, because the spatial extent of the cloud remains big.

B.An improved cooling process: sequential evaporation

This leads us to suggest another cooling process. When evaporative cooling by removing bosons has led to a naltem perature, and continued evaporation of the bosons no longer leads to substantial further cooling, we suggest to switch to evaporating the ferm ions, or ferm ions and bosons. Removing the bosons from the trap does not cool the system any more because the bosons can no longer carry away the necessary energy - but the ferm ions still can.

A ssum e that by the evaporation of bosons, the tem perature has already decreased to 0:3 T_F ; and there are $N_b = 5 \quad 10^4$ and $N_f = 5 \quad 10^4$ atom s left in the trap. This system is experimentally achievable by evaporating bosons alone. Figure 6 shows the resulting tem – perature as a function of time, after switching from evaporating the bosons to evaporating only the fermions. The cut-o radius was chosen at $R_c = 15 a_{H\,0}$ and decreases each time step. In this way the tem perature can be low ered to 0:06 T_F : A salso illustrated in the gure, the number of bosons has alm ost no in uence on the cooling process.

Losses due to three particle collisions involving two bosons and one ferm ion is expected to lim it the achievable temperature, as pointed out by T immerm ans [9]. The elect of this type of loss can be investigated in the present formalism in the same way as the elect of the three-boson collisions. The results are shown in the inset of gure 6, for a cooling process starting with 5 10⁴ bosons and 5 10⁴ ferm ions. The dilerent curves correspond to dilerent values of the three particle recombination constant K $_{\rm 3B\,F}$. If the product of the time to achieve equilibrium (t) and the recombination constant is K $_{\rm 3B\,F}$ t / 10 7 we ind that the lowest achievable temperature is raised by less than 0.05 $T_{\rm F}$. For K $_{\rm 3B\,F}$ t / 10 8 there is no appreciable elect on the naltem perature of the cooling process.

V.CONCLUSIONS

We have proposed a versatile, and straightforwardly in plementable three-uid model to describe the sympathetic cooling of bosons and fermions. Our model reproduces well the cooling observed in an experiment with ⁶Li and ⁷Li, and we not that the naltern perature $T=T_F$ 0.2 which is reached is not sensitive to the initial ratio of the number of bosons to the number of fermions. Lower temperatures can be reached if the stage where the only the bosonic atoms are evaporated is followed by a stage where also the fermionic atoms are evaporated. When this procedure is applied, a temperature of $T=T_F = 0.06$ could be reached, which in combination with the tunability of the interaction strength through the Feshbach resonance, brings the Fermi jgas closer to temperatures where pairing may be observed.
