Hydrodynam ic M odes for G ranular G ases

Abstract

The eigenfunctions and eigenvalues of the linearized Boltzm ann equation for inelastic hard spheres (d = 3) or disks (d = 2) corresponding to d + 2 hydrodynam ic modes, are calculated in the long wavelength limit for a granular gas. The transport coe cients are identified and found to agree with those from the Chapman-Enskog solution. The dom inance of hydrodynam ic modes at long times and long wavelengths is studied via an exactly solvable kinetic model. A collisional continuum is bounded away from the hydrodynam ic spectrum, assuring a hydrodynam ic description at long times. The bound is closely related to the power law decay of the velocity distribution in the reference hom ogeneous cooling state.

The simplest model for a granular gas at low density is given by the Boltzm ann equation for smooth, inelastic hard spheres or disks [1]. It provides an appropriate context in which to address a number of fundam ental issues. Prim ary among these is the existence of a macroscopic uid dynamics analogous to the Navier-Stokes description for real gases. The derivation of hydrodynamic equations from the inelastic Boltzm ann equation and identi – cation of expressions for the transport coe cients has been a problem of interest for two decades [2, 3, 4, 5].

A courate prediction of the transport coe cients as a function of the restitution coe cient [6], and con m ation via M onte C arb simulation [7], has been accomplished only within the last few years. However, the m ethod used in these derivations (C hapm an-Enskog) is form al and has been susceptible to debate. It is of interest therefore to bok for a hydrodynam ic description in the simplest context of linear response to a sm all perturbation of the \universal" hom ogeneous cooling state (H C S). This response is provided by the linearized B oltzm ann equation, and the existence of hydrodynam ics depends on the spectrum of the operator. A nother issue is the isolation of the hydrodynam ic spectrum from the remaining \m icroscopic" excitations, such that the hydrodynam ic m odes dom inate on the long space and time scales. For elastic collisions, this has been proven for \hard" potentials (including hard spheres) [8].

Here a calculation of the hydrodynam ic spectrum from the linearized inelastic Boltzm ann equation is reported. The transport coe cients are identi ed and shown to agree with those from the Chapman-Enskog method. Moreover, some support for the isolation of the hydrodynam ic spectrum is provided by an exact analysis of a model Boltzm ann equation [6, 9]. The model exhibits the dom inant features of granular gases, including a non-trivial HCS with algebraic decay at large velocities, discussed extensively for related M axwell models [10]. It is shown that the pure point spectrum for elastic collisions develops a continuum for any degree of inelasticity, extending toward the hydrodynam ic spectrum. However, it remains bounded away from the latter by an amount that is controlled by the power law of the decay of the velocity distribution. This relationship of the spectrum to the reference HCS is unexpected, but it is argued that it is more general than the limitations of the model.

The inelastic nonlinear Boltzm ann equation for the density f(r; v; t) of particles of mass m at position r w ith velocity v at time t has the form

where J [f; f] is a bilinear functional of f [1]. There is no stationary solution to this equation for an isolated system . However, a hom ogeneous cooling solution (HCS) is assumed to exist with a scaling property similar to the M axwellian,

Here n_H is the hom ogeneous density and v_0 (t) = $\frac{q}{2T}$ (t)=m is the therm all velocity de ned in terms of the temperature T (t). The latter obeys the equation T ${}^1 O_t T = {}_0$, where the cooling rate ${}_0 = {}_{0}; {}_{0}$] also is a specified bilinear functional. Both ${}_0$ and ${}_0$ must be determined self-consistently from the Boltzm ann equation

The existence of f_{H} is supported by approximate polynomial expansions [11] and by M onte Carlo simulation [12].

To study the relaxation of small spatial perturbations of the HCS, is defined by $f = f_{HCS} [l +]$, and terms up through linear order in are retained in the Boltzmann equation. The resulting equation is then written in dimensionless form with the velocities scaled relative to v_0 (t) and the time expressed in terms of $s = {}^{R_t} dt^0_0$ (t⁰), where $_0$ (t) is the average collision frequency, proportional to T(t). It is su cient to consider a single Fourier component $\tilde{}(k)$ that obeys

The solution is sought in a Hilbert space de ned by the scalar product

It is understood that the index i m ay be discrete or continuous. The hydrodynam ic spectrum can be de ned precisely as follows. The linearized Boltzm ann equation provides exact balance equations for the moments of corresponding to the density, ow velocity, and temperature. The latter are the d + 2 hydrodynamic elds. The spectrum of these balance equations can be calculated without approximation in the limit k = 0. For elastic collisions, there is a (d + 2)-fold degenerate point at zero eigenvalue, corresponding to the conservation laws for binary collisions. Their perturbation at nite k de nes the hydrodynamic modes more generally. For inelastic collisions, the spectrum is again d + 2 points, now at 0; $_0=2$; $_0=2$, with the latter being d-fold degenerate. Again, the hydrodynamic modes more generally are de ned as those solutions to (7) that are continuously connected as functions of k to these special k = 0 solutions. For elastic collisions, it is possible to prove analyticity about k = 0 [8], and it is assumed this is the case here as well.

The rst step is to show that L includes the spectrum of the balance equations at k = 0, and to determ ine the corresponding eigenfunctions. For elastic collisions, the stationary state is given by J [f_M; f_M] = 0, whose solution is the M axwellian. D i erentiating this stationary equation with respect to the hydrodynam ic elds leads to the linearized B oltzm ann operator acting on combinations of 1; c; c² independently being zero. These are the d+ 2 eigenfunctions with zero eigenvalue. A similar analysis works for the inelastic case, using the stationary condition (3). Straightforward calculations give

The evaluation of the hydrodynamic spectrum at nite k is now a well-de ned technical problem. In general, the eigenvalues depend on both k and the restitution coe cient . It is known from the Navier-Stokes equations that the behavior for small k () is not uniform with respect to (k), so that a perturbation expansion in one or the other does not provide the entire mode structure. Here, for illustration, only the results for small k are reported. The expansion is de ned by $!_i(k) = !_i^{(0)} + ik!_i^{(1)} + k^2!_i^{(2)} + .$, and $_i(k) = !_i^{(0)} + ik!_i^{(1)} + k^2!_i^{(2)} + .$ The leading term s are those of Eqs. (9) and (10). Since L is not self-adjoint, it is necessary to introduce a set of functions f $_i$ g that are biorthogonal to f $_i$ g. The leading term s of a sim ilar expansion in k are found to be

where $f_{k}^{b}; \mathbf{e}^{(i)}g$ are d pairwise orthogonal unit vectors. The results to second order in k are $!_{i}^{(1)} = 0$,

The operators $Q_i = 1$ P_i are projections orthogonal to ${}_{i}^{(0)}$ with $P_i a = {}_{i}^{(0)}$ ${}_{i}^{(0)}$; a. The constants $!_{i}^{(2)}$ are transport coe cients which are identified from a similar calculation using the N avier-Stokes equations. For example, the shear viscosity is

This agrees with the result obtained from the Chapman-Enskog method [13]. A more com – plete connection with the latter can be established as follows. Assuming that the hydrodynamic spectrum dominates for long times and small k, the solution to the Boltzmann equation for small perturbations becomes

The connection between these elds and the macroscopic density, temperature, and ow velocity is obtained for small k by using $i! i^{(0)}$ in (17). The elds y_i^h (k;s) represent components of the initial distribution that obey the hydrodynam ic equations for all times, whereas the density, temperature, and ow velocity become equal to these only on the long space and time scales [8]. Use of $i(k)! i^{(0)} + ik i^{(1)}$ for small k in (16) leads to a result that is in agreement with the N avier-Stokes approximation of the Chapman-Enskog method [14].

The existence of a hydrodynamic spectrum is relevant only if the corresponding modes dom in the for long times and long wavelengths. A su cient condition is that the magnitude of the hydrodynamic eigenvalues be smaller than that of all other parts of the spectrum. This is the case for elastic collisions, but the proof does not extend directly to ik c+L here and the question remains open in general [15]. In fact, the mode at $_0=2$ gives reason for concern since it m ight become comparable to the m icroscopic excitations at large inelasticity. To explore this point, it is instructive to consider a m odel for the Boltzm ann equation that preserves the essential physics of a non-trivial HCS, exact balance equations, and hydrodynam ic m odes, as described above. The Boltzm ann collision operator can be written

where f is the \loss" contribution and g is the \gain" contribution. Both the collision frequency and g are specified positive functionals of f.

The class of models to be considered here are characterized by the following two simplications: 1) is independent of v and, 2) and g are functionals of f only through its moments with respect to $1;v;v^2$. The rst condition is similar to that of M axwell models" that have been introduced recently [10]. The second condition means that and g depend on the state of the system only through the hydrodynamic elds. The form softhese functionals are subjected to preserve the exact properties of the collision operator required by the balance equations,

Here u is the ow velocity and 2 1 = . In principle, is the same functional of f as obtained from the Boltzmann equation, although it can be eventually approximated similarly to and g. I any case, Eq. (21) must be preserved. In the following, we will assume that both and scale as $T^{1=2}$ in order to minic hard sphere behavior. With the above class of models, it is obtained from Eq. (3)

where P (x) $px^{(1+p)}$ with p = 2 = . The dimensionless gain function $gv;y^{h}(r;t) = n_{H} (v_{0})^{3}g$ (c=) has been introduced. Further investigation requires speci cation of g (c=). However, it is easily veried that moments of degree equal or greater than p are not nite if the corresponding moments of g exist. This is consistent with a similar result for the M axwellm odels where algebraic decay of $_{0}$ (c) is observed for large velocities, also due to a slower decay of the loss term than the gain term.

Linearization of the kinetic model around this HCS leads again to Eq. (4), but with a simpler form for L. It has a decomposition into the subspace of $_{i}^{(0)}$ and its complement, L = P LP + Q LQ, where $P = _{i}^{P} P_{i}$ and Q = 1 P. In the subspace of $_{i}^{(0)}$ the spectrum is just the d+ 2 points of (10),

Interestingly, there is no explicit dependence on the gain function g except through 0. For elastic collisions, the second term is missing and the model becomes the linearized B hatnager-G ross-K rook model [16], with a single degenerate point in the spectrum representing all the microscopic excitations of the Boltzmann operator. It is somewhat easier to analyze the corresponding adjoint problem

where Q $^{\rm y}$ is the adjoint of Q . Solutions to this equation exist from the class of hom ogeneous functions

The property $Q^{y} = can be satisfied with a suitable choice of the linear combinations. The corresponding eigenvalue is <math>! = q_{0}=2$. Thus the spectrum of L includes a continuum with < ! . Of critical interest for hydrodynamics is whether the lower bound for this continuum on the real axis intersects the hydrodynamic point spectrum. The bound is determined by the maximum degree of such hom ogeneous eigenfunctions admitted in the H ilbert space. The condition is that $kc^{q}k^{2} = (c^{q};c^{q})$ exists. U sing Eq. (20), this becomes

For nite M $_q$, the value of q is bounded from above by $< q < q_n = p=2 = =_0$. The continuous spectrum therefore is restricted by =2 < <!. This means that the discrete spectrum is isolated from the continuum for all $_0 = < 1$. But $_0 =$ must be smaller than

unity because of the third condition required by Eq. (19). This condition is related with the fact that only a fraction of the energy of the particles can be lost in collisions. The continuum is singular in the sense that it is independent of the restitution coe cient but it is present only for nite inelasticity.

For this class of m odels, it is seen that the hydrodynam ic spectrum at k = 0 is isolated from the rest of the spectrum. The m odel also allow s exact calculation of the hydrodynam ic eigenvalues $!_i(k)$ at nite k, without the restrictions of the perturbation theory calculation above. For elastic collisions, such a calculation show s that the hydrodynam ic m odes exist only for k less than som e m aximum value. It is expected that a similar condition applies in the granular case as well.
