High Tem perature Super uid and Feshbach Resonance

A bstract

We study an elective eld theory describing cold ferm ionic atoms near a Feshbach resonance. The theory gives a unique description of the dynamics in the limit that the energy of the Feshbach resonance is tuned to be twice that of the Fermi surface. We show that in this limit the zero temperature super uid condensate is of order the Fermi energy, and obtain a critical temperature $T_{\rm C}$ $^\prime$ 0:43 $T_{\rm F}$

A fler the successful achievem ent of Bose E instein condensation in ultracold atom ic gases, a natural question is whether one can achieve super uidity in a degenerate ferm ion gas. Sam ples of ferm ionic alkali atom s have already been cooled below their Ferm i tem perature of several hundreds nano-K elvin [1], where quantum degeneracy phenom ena such as Cooperpairing of atom s are potentially important [2].

It was suggested that the super uidity gap m ay be made as large as of order the Ferm ienergy in the alkaliatom ic gases [3,4,5], using a Feshbach resonance [6], at which the scattering length becomes very large. For weak coupling, the scattering length away from resonance is usually much smaller than the typical wavelength of ferm ions near the Ferm i surface, jaj $k_{\rm F}^{\,1}$ and the Cooper pairing gap is then given in terms of scattering length as

where E_F is the Ferm ienergy and $hk_F=p_F$ is the Ferm im omentum. The elective strength of attraction is related to the scattering length as V=4 h^2 an=m, where n is the number density and m is the ferm ion mass. Therefore, a weakly bound Cooper-pair gap is typically much smaller than the Fermi energy. However, if the scattering of fermions occurs at the Feshbach resonance, whose energy is nearly equal to twice that of the Fermi surface, the elective scattering length becomes quite large and so does the gap. In this paper we analyze this enhancement at the Feshbach resonance in detail.

At ultralow tem perature, the atom ic gas can be described by a Ferm i liquid a la Landau, whose (e ective) Lagrangian density is given as, suppressing the spin indices,

where $L_{\rm int}$ describes the interaction of atom s. The interaction Lagrangian can be expanded in powers of and \tilde{r} ,

Near the Ferm i surface, interactions with non-Cooper pairing kinematics, as well as derivative corrections to the Cooper pairing interaction, are irrelevant and ow to zero [7]. For scattering of atoms of opposite momenta, only the leading term is marginal, and, if attractive $(g_1 > 0)$, a gap opens at the Fermi surface, given as

where $_{\rm F}$ is the energy density of states at the Ferm i surface.

However, when the resonance scattering occurs at energy near twice the Fermienergy, E_R '0, we have to include the resonance degrees of freedom in the elective Lagrangian, since such a resonance state is easily excited and has a long lifetime:

where denotes the (spin-0) resonance eld of mass M and a decay width . The ellipsis denotes the higher-order terms involving , \tilde{r} , and/or , \tilde{r} , which are negligible near

the Ferm i surface. Note that the resonance energy E_R is measured from the Ferm i surface. Namely, it is the binding energy minus twice the Ferm i energy. As the coupling g has dimensions of [energy] $^{1=2}$ in natural units, we introduce a dimensionless coupling g,

which is simply the Yukawa coupling between the scalar resonance and the ferm ionic atom that would appear in a relativistic formulation of the model. (We can obtain the kinetic energy in (5) from the usual kinetic term @ @ by rescaling the eld by $e^{\mathbb{M}} \stackrel{!}{=} \overline{2M}$.) By comparing on-resonance scattering in the relativistic and non-relativistic formulations, one can see that $g^2 = p_F$.




FIG. 1. The resonance decays into two atoms in medium. The circle denotes the Fermi surface.

We now consider the decay process of the resonance in medium (Fig. 1):

The dierential decay rate in the rest frame of medium is




FIG. 2. The allowed angles in decay of the resonance.

The T m atrix in the non-relativistic lim it is $M \ j^2 \ g^2$. Because of the Pauli blocking, the decay process is restricted by kinem atics. For a two-body decay, the Ferm i-D irac distribution restricts the angle, , between p and q (p p)=2 (see Fig. 2).

where jq $p=2j=p_F$ at = and jqj=q. When $p_F+j_P=2< q$, the angle is not restricted and = (=0). Finally, when p_F^2 $p^2=2>q^2$ or $p^2< p_F^2=m$, the resonance does not decay, = 0, as the nal states allowed by kinematics are Pauli-blocked.

The decay rate of the resonance in free space can be similarly calculated. We not that the resonance in free space decays at rest with a rate,

where $\hat{E_R} = E_R + 2E_F$ is the resonance energy in free space. A coording to a recent measurem ent [8] of a Feshbach resonance between optically trapped 40 K atoms in the two lowest energy spin-states, j9=2; 9=2i and j9=2; 7=2i, the resonance peak occurs at a magnetic eld of 201:5 1:4 G with a width of 8:0 1:1 G, which corresponds to $\hat{E_R} = 10^6$ eV and $= 4 - 10^8$ eV. For experimentally realizable ultracold atoms, $E_F = k_B$ 600 nK or $E_F = 6 - 10^{11}$ eV. The dimensionless coupling g is much less than one.

Now let us consider the medium e ect on the propagation of the resonance. Even though the gas of atoms is dilute, the medium e ect is important when the de Broglie wavelength is larger than the interatom is distance. The self energy of the resonances is

We perform the q_0 integration rst and rewrite the self-energy as sum of the vacuum part and the matter part from the states in the Ferm isea:

which is irrelevant for our purpose, and the matter part becomes

We note that the medium gives a nite contribution to the resonance energy:

When the resonance energy is large or of order of $E_{\rm F}$, the resonance degrees of freedom are irrelevant and can be integrated out in favor of a four-Ferm i interaction. However, if the resonance energy is tuned to be much smaller than the Ferm i energy, it must be included in the low energy dynamics of the cold atomic gas. A drastic elect occurs when the resonance energy is negative (or less than twice the Ferm i energy of atoms). Namely, the resonance cannot decay into two atoms due to the Pauliblocking. The lifetime is proportional to 1=T and becomes in nity at zero temperature. The system can reduce its energy by removing ferm ions from the Ferm isea and storing them as condensed bosons. In this regime we expect Bose-Einstein condensation of the resonance [3,5].




FIG. 3. The dashed line denotes the resonance and the triangle denotes the super uid gap.

Here, we are most interested in the case of zero detuning, when the resonance is very close to the Ferm i surface, and our elective theory applies with great accuracy. The Cooper theorem then tells us that the Ferm i surface becomes unstable to atom-pairing, which is described here as a condensate of resonances (see Fig. 3).

We determ in the value of the condensate by calculating the Colem an Weinberg potential for the resonance [9], using a formalism developed for a Fermi surface elective theory [10].

where B is the counter term and higher orders are suppressed, as we discuss in more detail below. Choosing the renormalization condition at g = to be

Taking the renormalization point $= E_F$, we not the super uidity gap

where E_R is the resonance energy in medium measured at the Fermimom entum. The renormalization condition (18) resums the medium corrections to the resonance propagator (i.e. vacuum polarization due to atom loops). These elects modify the resonance-induced interaction between atoms (see Fig. 3), as well as the denition of zero detuning. If we tune the resonance energy in medium to be zero, the gap becomes as large as $e^{-1-2}E_F$. This result is a robust consequence of the elective theory, depending only on the existence of a resonance near the Fermisurface.

Corrections to our results come from two sources: (1) higher order graphs within the extive theory, and (2) corrections to the extive theory itself.

It is straightforward to estimate corrections of type (1), which are obtained by inserting, e.g., in Fig. 3, an additional resonance exchange on the internal atom line. The resulting expression is suppressed by an additional factor of g^2 , but does not produce additional powers of k_F^2 (the area of the Fermi surface) for kinematical reasons. For this reason, the Cooper pairing channel already considered gives the dominant contribution and additional resonance exchange interactions are negligible.

On the other hand, when the gap is as large as $= e^{-1-2} E_F$, some of the pairing atom s are far from the Ferm i surface. The elective theory description there may suler corrections of type (2) which are order over E_F , and might decrease the size of the gap. However, by self-consistency, the resulting cannot be much smaller than E_F (perhaps by an order of magnitude at most).

Let us now consider nite temperature e ects. Strictly speaking, the calculation of the critical temperature involves uctuations which are far from the Fermi surface, and hence

 $^{^1}$ This is in agreement with an earlier result [11] using elective eld theory to write the gap directly in terms of the two-particle phase shift: $E_F \exp(\frac{1}{2} \cot)$. At a resonance, cot goes through zero, so is of order E_F . A simple estimate using the gap equation obtained from Fig. 3 also yields $E_F \exp(0(1))$ when the scalar exchange is exactly on-resonance.

is not fully described by the e ective theory. A lso, we must assume that the resonances maintain thermal equilibrium with the atoms without being destroyed by the uctuations. The Coleman-Weinberg potential becomes

As the tem perature approaches the critical tem perature, the gap vanishes and the m in im um therefore should occur at = 0, which gives, taking the renormalization point to be E_F ,

The critical tem perature at which the gap vanishes is therefore

which is twice the BCS value ($^{\prime}$ 0:577 is the Euler constant). At the Feshbach resonance in m edium , E $_{R}$ = 0 or E $_{R}$ = $g^{2}m$ p_{F} =(2 2), we $% = 10.68\,E_{F} = k_{B}$. This is slightly larger than the value obtained by H olland et al. [3] At the Feshbach resonance the ultracold Ferm i gas becomes a super uid if it cools below 0:68 T_{F} , where T_{F} is the Ferm item perature.

Because the critical tem perature obtained is large (of order $T_{\rm F}$), this calculation must be modiled to correctly account for atom number conservation. In other words, we must impose the condition that the number density of atoms

where N $_0$ is the number density in the absence of the resonance and N $_{\rm F}$ and N $_{\rm B}$ are functions of a chem ical potential $\,$ which m ay di er from E $_{\rm F}$. U sing the free particle Ferm i-D irac and B ose-E instein distributions in N $_{\rm F,B}$ along with the relation T $_{\rm C}$ = :68 , we obtain $\,$ ' :63E $_{\rm F}$, which suggests that number conservation reduces the critical temperature by roughly one third. A more sophisticated expression for the number densities N $_{\rm F,B}$ can be obtained by including the e ect of interactions on the therm odynam ic potential [5]. We note that the uctuation contribution to the number density is

Unless the resonance-atom coupling is taken to be very large (so large as to render a controlled calculation doubtful), the e ect of interactions on (26) is quite small near the critical temperature.

In sum mary, we used an elective eld theory describing modes near the Ferm i surface to compute the Coleman-W einberg (mean-eld) potential for the resonance in medium, obtaining a robust super uidity gap of $= e^{-1=2}\,E_F$ at zero detuning. We not that the critical temperature for the super uid phase transition is T_C '0:43 T_F , taking into account the constraint from conservation of atom number.
