E lectron and nuclear pressures in electron-nucleus m ixtures

It is shown for an electron-nucleus m ixture that the electron and nuclear pressures are de ned clearly and sim ply by the virial theorem; the total pressure of this system is a sum of these two pressures. The electron pressure is di erent from the conventional electron pressure being expressed as the sum of two times of kinetic energy and the potential energy in that the nuclear virial term is subtracted; this fact is exemplied by several kinds of de nitions for the electron pressure enumerated in this work. The conventional de nition of the electron pressure in terms of the nuclear virial term is shown inappropriate. Sim ilar remarks are m ade about the de nition of the stress tensor in this m ixture. It is also demonstrated that both of the electron and nuclear pressures become e zero at the same time for a m etal in the vacuum, in contrast to the conventional view point that the zero pressure is realized by a result of the cancellation between the electron and nuclear pressures, each of which is not zero. On the basis of these facts, a sim ple equation of states for liquid m etals is derived, and exam ined num erically for liquid alkaline m etals by use of the quantum hypernetted chain equation and the A shcroft m odel potential.

x1. Introduction

In order to determ ine the properties of solids, liquid metals and plasm as as electron-nucleus m ixtures, the nuclei (ions) are usually treated as classical particles, which are considered as giving an external potential for the electrons: as a result, we can apply the density-functional (DF) theory to this inhom ogeneous electrons. Thus, the DF theory provides the inhom ogeneous properties of the electrons under this external potential. Therefore, som e problem s occur to determ ine hom ogeneous quantities of an electron-nucleus mixture including the nuclear contribution from the results of the DF theory, where the nuclei appear only as providing an external potential. Such an example of problem s occurs in the determ ination of the total pressure of electron-nucleus m ixtures on the basis of the DF theory. The electron pressure is frequently discussed from the DF theory; nevertheless, the term, electron pressure' P_e , is di erently used in two ways in its meaning. Som e investigators^{1),2)} take the electron pressure P_e for the electrons con ned in a volume V together with the xed nuclei at the positions fR g to be $3P_eV = 2T_e + U_e$ in terms of the exact kinetic and potential energies, Te and Ue, respectively. On the other hand, many kinds of de nitions for the electron pressure lead to an expression $\mathfrak{P}_{e}V$ = F with use of the force F on -nucleus, as will be shown in this $2T_e + U_e$ R work. This di erence is not only a problem of the de nition, since the total pressure of an electron-nucleus mixture as a hom ogeneous system is to be determined from the electron pressure in conjunction with the nuclear contribution: the de nition of electron pressure should be consistent with this purpose, as will be done in this

work. Therefore, it is important to see the meaning of the electron pressure in the calculation of the total pressure taking account of the nuclear contribution.

Following Slater,³⁾ many investigators^{1),2),4)} phave identi ed the electron pressure with the total force on the nuclei; $3P_eV = \frac{1}{2}$ R F. As a consequence of this de nition which leads to the relation $\mathscr{Y}_e V = 2T_e + U_e$, the 'electron pressure' becom es di erent from others as mentioned above. Sim ilarly, the same problem was seen in the de nition of the stress tensors⁴) in terms of the total force on the nuclei. This de nition of Pe is based on the assumption: an electron-nucleus mixture con ned in a volum e V by wall potentials, U_w^{ele} and U_w^{nuc} , for the electrons and the nuclei, respectively, is therm odynam ically identical with the mixture with only the nuclei con ned in V by U_w^{nuc} , since in the latter system the electrons seem to spill out outside the nuclei a distance only on an atom ic scale even if $U_w^{ele} = 0$. In this work, we will exam ine the validity of this assumption with use of the virial theorem which leads to a de nition of the electron pressure in a more general form. From this new de nition of the electron pressure, the total pressure of an electron-nucleus mixture is shown to be represented as a sum of the electron and nuclear pressures.

A lso, we can give an important remark about the fact that the pressure in solids or liquid m etals becomes zero in the vacuum; it is a standard view point^{5),6)} that the electron pressure is negative because of the electrons yielding a main part of cohesive energy, while the nuclear pressure is positive, and the total pressure becomes zero as a result of cancellation between two pressures in the vacuum. C ontrary to this assertion, the total pressure becomes zero, since both the electron and nuclear pressures are zero at the same time in the vacuum, as we will see. In this work, we discuss on these problems from fundamental and simple virial relations.

Based on the fact that the total pressure of an electron-nucleus m ixture is a sum of the electron and nuclear pressures, we obtain a simpler pressure formula for a liquid metal, where the e ective interaction among nuclei (ions) are approximately represented by a pair interaction; the nuclear pressure is expressed in the virial form using this pair interaction and the radial distribution function. On the other hand, the electron pressure in a simple m etalm ay be described by the jellium m odel. How ever, the electron pressure determ ined from the jellium model becomes zero only at the electron density of r_s 4 and the jellium surface energy becomes negative 2, while the jellium bulk modulus is negative at r_s 6. These draw backs for r_s of the jellium model are rectied by the stabilized jellium (SJ) model¹ (or the ideal m etal m odel^{8),9)}, where an in nitesim ally thin dipole layer is added to the surface of the uniform background in the jellium; this dipole layer produces a uniform eld in the jellium to make it stable at any metallic densities. On use of this SJ model to obtain an electron pressure expression, we derived a pressure form ula for a simple liquid m etal in the present work.

In the next section, we show that the electron and nuclear pressures are clearly de ned on the basis of the simple and fundam ental virial theorem, and construct three systems by changing the wall potentials con ning the electrons and the nuclei in a nite volume. Based on these systems, we make several statements about the pressures for an electron-nucleus mixture. Sim ilar remarks are made about the de nition of the stress tensors for this mixture in x8. In x4, we enumerate several kinds of the de nitions of the electron pressures proposed up to date. Equation of states (EOS) for liquid m etals is set up in x5.1; a num erical exam ination of this EOS is perform ed in x5.2. The last section is devoted to sum m ary and discussion. In Appendix A, the electron pressure form ula is derived from the internal energy by perform ing a volum e derivative in the fram ework of the DF theory.

x2. V irial theorem for an electron-nucleus m ixture

The Ham iltonian for an electron-nucleus m ixture is represented by

A flerwards when the nuclei are regarded as classical particles, we use the symbols fR ; P q instead of f \hat{R} ; \hat{P} q. In the standard approach to hom openeous liquid and solid metals, it is commonly assumed that the nuclei are treated as classical particles (or in the adiabatic approximation), and the electrons are considered as an inhomogeneous electron system under the external potential U_{ex} caused by the nuclei xed at their equilibrium positions. Here, it is important in treating an electron-nucleus m ixture to recognize that there are four stages of approxim ations to the nuclear behaviour: (i) the nuclear mass is approximated as in nite, where the external potential Uex is determ ined uniquely from a nuclear con guration, since the nuclei do not move but remain to stay at their equilibrium positions; (ii) the nuclei are approxim ated as classical particles in the sense that its position and momentum are com m utable; (iii) the nuclei are regarded as quantum particles, but can be treated in the adiabatic approximation; and nally (iv) the nuclei can not be treated in the adiabatic approximation. Therefore, we can apply the DF theory to the electrons in the electron-nucleus m ixture without any approximation, if the nuclear mass is taken to be in nite.

Generally, the therm odynam ic pressure P of an inhom ogeneous system caused by an external potential U_{ex} (r) is clearly de ned in terms of free energy F or internal energy E,

under the condition that the volum e parameter V of particles con ned by a wall potential U_w (r) remains to specify the state as a natural variable when the external potential U_{ex} (r) is imposed, as is described in detail.¹⁰⁾ In addition to the therm odynamic pressure, there is another 'kinetic' de nition of the pressure using a wall potential U_w on the basis of a standard assumption^{11),12)} concerning the relation between the force exerted by the wall U_w on the various particles and a hydrostatic pressure P:

Furtherm ore, the therm odynam ic pressure of this system is shown to be identical with the kinetic' pressure in the form :

where the potential operator \hat{U}_p is interpreted as involving the external potential U_{ex} , and \hat{T} is the kinetic operator.^{12){15)} Therefore, it is necessary from (2.5) that the pressure takes a constant value at every point of the surface QV for the volum e parameter V to be a natural variable. A simple example of this inhom ogeneous system is an atom con ned in a spherical wall with a nucleus xed at its center.

[i-a] As the set step to treat an electron-nucleus mixture on the basis of ℓ -4) which a ord to use the DF theory, let us consider a mixture of electrons and nuclei with the in nite nuclear mass, con ned in a nite volum eV by wall potentials, U_{w}^{ple} and U_{w}^{nuc} , respectively. Here, we assume this mixture constitutes a crystalline state in equilibrium, which is used as a model for the electron-band calculations. Since the nuclei remain at their xed equilibrium positions, the nuclei make an external potential U_{ex} (r) for the electrons, and the volum eV is a natural variable of this system. As a result, the pressure of this inhom ogeneous electrons is determined by (2-4) in term softhe electron free energy F_{e} , which is explicitly de ned later in (4-2). It is in portant to notice that the derivatives must be performed under the external potential being xed. Therefore, the nuclei producing the external potential U_{ex} for the electron free energy F_{e} can be described exactly in terms of the other pressure is the electron pressure in the similar meaning to that of a noninteracting electron gas under the external potential. Since the electron free energy F_{e} can be described exactly in terms of the DF theory,¹⁰ the electron pressure F_{e} is shown (see Appendix A) to be

where the bracket with a su x e denotes the average over the electron states at a xed nuclear con guration. Really, this can be also proven from 2.6 and (2.3). Therefore, the electron pressure given above is a therm odynamic quantity, that is,

a physical quantity de ned uniquely. A lso, note that the electron pressure can be de ned by a wallpotential U_w^{ele} . However, it should be kept in m ind that this pressure is not de ned as a quantity of the hom ogeneous m ixture.

[i-b] In the second step to relate the above inhom ogeneous system to a hom ogeneous electron-nucleus mixture, we consider this system to be a binary mixture of electrons and nuclei. Then, the total pressure of this hom ogeneous mixture is written as

since the nuclei have in nite m ass and do not m ove, but stay at their equilibrium positions. Note that the pressure of this hom ogeneous m ixture is described in terms of the electron pressure P_e de ned by 2.7 for the inhom ogeneous system. A lso, all of the nuclear forces F are zero except for nuclei near the surface in the short range of the wall potential, since the nuclei are in their equilibrium positions. On the other hand, the wall forces satisfying $F^w = F$ near the surface describe the nuclear pressure. Thus, we can see that the total pressure is composed of the electron and nuclear pressures. In the derivation of (2.9), we have used the virial theorem for a hom ogeneous binary m ixture con ned in the volum e V by a wall, which produces potentials, U_w^A and U_w^B , for A and B particles, respectively;

[ii] Furtherm ore, when the nucleus has a nite m ass, but behaves as a classical particle which m akes the relations in the adiabatic approximation exact, the electron pressure of an hom ogeneous electron-nucleus m ixture is given by the conguration average over fR g of the electron pressure in the inhom ogeneous electrons under the external potential U_{ex} (rjfR g):

as will be discussed later in x6. [iii] Even when the nuclei behave as quantum particles, Eq. (2.11) is valid in the adiabatic approximation.¹⁰⁾ Therefore, this virial theorem (2.10) suggests that we can de not the electron pressure in a general form even when the adiabatic approximation becomes invalid, as is described in the following. [iv] From the Ham iltonian (2.1), we can obtain the following relation:

where the trace is taken over a complete set of states of the electron-nucleus mixture.

Therefore, when the electrons and the nuclei are con ned in a volume V by a wallwith wallpotentials, U_w^{ele} and U_w^{nuc} , respectively, Eqs. (2.13) and (2.14) for this system are written in the following forms relating the electron and nuclear kinetic energies, \hat{T}_e and \hat{T}_N , respectively:

where the wallpotentials should be taken into account in the ensemble average (2.15) by adding them to the H am iltonian^{16),17)} or as the boundary condition^{12){15)} to solve the wave equation. At this point, it should be kept in m ind that the interactions of the particles with the wall can be om itted from the new H am iltonian if the boundary condition that = 0 for any particle on the wall is m ade.^{12),14),15)} A s a result, with use of the H am iltonian (2.1) and this boundary condition, the electron and nuclear pressures are expressed respectively in the form s:

In the above, Eq. (2.19) is derived by the relation (2.3), and the force on -nucleus is given by <math display="inline">\hat{F} = r \ \hat{U}$. The denition of the electron pressure 0.18) can be used even when the nuclei behave as quantum particles without use of any approximation.

At this stage, we can construct the following three systems of electron-nucleus mixtures by choosing the electron and nuclear wall potentials in di erent ways.

(I) System -I, where the electrons and nuclei are con ned in the volum e V. In this system, the total pressure is given by

At this point, it should be noted that the zero pressure relation (2.23) is used in the derivation of (2.25) from (2.24).

(III) System -III, where $U_w^{nuc} = 0$ and $U_w^{ele} = 0$. This system represents nothing but an electron-nucleus m ixture in the vacuum, where $P_e = 0$ and $P_N = 0$ due to (2.18) and (2.20). Consequently, the total pressure of this system becomes zero: $P = P_e + P_N = 0$.

On the basis of the fundam ental relations derived here in conjunction with System -I, II and III constructed in the above, we can make the following statem ents from (A) to (E):

- (A) : The electron pressure P_e and the nuclear pressure P_N can be clearly de ned for an electron-nucleus mixture by (2.19) and (2.21), respectively; the total pressure is a sum of the electron and nuclear pressures, as shown in (2.22).
- (B) : The electron pressure is described by (2.19), where the nuclear virial is subtracted.
- (C) : The pressure of System –I is the therm odynam ic pressure of an electron-nucleus mixture. It has been shown that the pressure de ned by the sum of (2.21) becomes identical with the therm odynam ic pressure determined by the volume derivative of free energy.¹²⁾⁽¹⁷⁾
- (D) : The pressure P_I in System –I has an identical expression to P_{II} in System II. Therefore, some investigators^{1),2),4)} believe that System –II is identical to

System -I in the sense that both system sprovide the same therm odynam ic quantities (e.g., the pressure). However, the pressures, P_I and P_{II} , are equal with each other only when these system s are nearly equal to the system -III ($P_e = P_N = 0$). It should be noticed that System -II is in general an inhom ogeneous system, since this model involves a superatom in the extreme limit (V ! 0) with all nuclei compressed to become a point charge as this mathematical model. On the other hand, System -I is always hom ogeneous, since the walle ect can be replaced by periodic boundary conditions for this system. Therefore, System -I and System -II are di erent from each other in general, although (2.22) and (2.25) have the identical expression; a physical quantity P_e is not zero in the one and zero, in the other as Eq. (2.23) indicates.

(E) : A metal in the vacuum is de ned as an electron-nucleus mixture without the wallpotentials to con ne the electrons ($U_w^{ele} = 0$) and the nuclei ($U_w^{nuc} = 0$) in a nite volume. Therefore, by de nition the therm odynamic pressure of a metal in the vacuum is zero, which is realized by the condition $P_e = 0$ and $P_N = 0$, as System-III exhibits: this results from the virial theorem for single particle, (2.13) and (2.14). This fact makes a contrast to the usual treatment of a metal where the pressure of a metal becomes zero as a result of the cancellation in a sum : $P = P_e + P_N = 0$ with $P_e < 0$ and $P_N > 0.5^{1,6}$

x3. E lectron and nuclear stress tensors

In the present section, we derive form ulae of stress tensors by the same arguments that were advanced in the preceding section treating the pressure in an electron-nucleus mixture. In the electron-nucleus mixture where the electrons and nuclei are con ned in the same volume V (System -I), N ielsen and M artin $[NM]^{18}$ proved that the stress intrinsic to the system is given by a sum of the electron and nuclear parts:

in terms of the exchange-correlation part F_{xc} of the free-energy for electrons in the xed nuclei, and $f(_k)$ denotes the occupation probability for a state $_k$ determined by the K ohn-Sham equation with its wave function $_k$. Also, the electrostatic energy $E_{es}[h]$ of the nucleus-electron mixture is written as

In a metallic system under high pressure, the electron stress tensor T^{ele} plays an important role compared with the nuclear stress tensor T^{nuc}.

x4. De nitions of electron pressure

As mentioned in x2, the virial theorem shows that the total pressure of an electron-nucleus mixture is given by a sum of the nuclear and electron pressures; the concept of the electron pressure is clearly de ned by using the wallpotential U_w^{ele} for the electrons in the form of (2.19), which is applicable to this mixture without use of the adiabatic approximation. On the other hand, many types of de nitions for the electron pressure have been proposed up to date within the adiabatic approximation. At the rst, the therm odynam ic electron pressure is de ned on the basis of the therm odynam ic relation¹⁰

x5. Equation of states for liquid m etals

In x2, we have proven that the pressure of an electron-nucleus m ixture is expressed by a sum of the electron and nuclear pressures, which are clearly de ned in the virial form s. In the present section, we derive a virial pressure form ula for simple liquid m etals based on this fact, and the zero pressure condition is exam ined num erically for this pressure form ula.

5.1. Derivation of a virial pressure form ula

The standard virial pressure form ula for a simple metal as an electron-ion mixture is written in a complicated form to calculate owing to the volume derivative of the elective ion-ion interaction in the form ula³⁶⁾ In contrast to this standard expression, the virial theorem described in x2 provides the equation of states (EOS) in a simple form :

52. Num erical examination of the QHNC equation by the zero-pressure condition

In this subsection, we exhibit how the zero-pressure condition, $(5\cdot18)$, can be used as a check of num erical consistency in the calculation by applying it to some alkaline liquid m etals at the norm all pressure on the basis of the QHNC equation⁴³⁾ as an example. Since we can regard liquid m etals at the norm all pressure as those in the vacuum, the pressures determ ined from $(5\cdot17)$ m ust be zero in this circum stance: that is, $P_N = 0$ while $P_e = 0$ by de nition. In order to exam ine this relation we calculated the nuclear virial term and nuclear kinetic pressures from $(5\cdot17)$, which are shown in Table I for Li, Na and Rb.

In the case of Li, the nuclear virial term becom es -0.2871 GPa, which provides alm ost zero total pressure 0.0017 GPa by canceling out the nuclear kinetic pressure 0.2888 GPa. Thus, the QHNC equation can be considered to give a reasonable result for Lito full 11 5.18) in comparison with -1.7 GPa of K um aravadivel.⁴⁴⁾ H ow ever, the QHNC equation does not provide even negative values of the nuclear virial term for the Na and Rb cases; as a result, the nuclear pressure remains to be a large positive value for each case.




Fig.1. The e ective ion-ion interactions of Rb (313K) determ ined by the QHNC equation and by the use of A shcroft m odel potential ($r_c = 1.275$), which are shown by the full and dotted curves, respectively.

To see where this discrepancy comes from, we calculated the pressure of Rb from an elective ion-ion interaction determined by the Ashcroft model potential with the core parameter $r_c = 1.27A^{36}$ on the basis of (5.17): the nuclear pressure becomes -0.0013 GPa, which satis es the condition 5.18) to a considerable extent compared to other calculation⁴⁴⁾ shown in Table I. Inversely, the condition (5.18) can be used to determ ine the Ashcroft core parameter r_c ; this condition generates $r_c = 1.275A$ for Rb case. In Fig. 1, the elective ion-ion interactions for a Rb liquid m etal obtained from the Ashcroft model with $r_c = 1.275A$ are plotted together with that from the QHNC method. Although we ind a visible difference between these

two e ective potentials in this scale, these potentials yield almost the same structure factors showing a good agreement with experiments as is displayed in Fig. 2. In contrast to the A shcroff model potential, the pseudopotential $C_{eI}(r)$ = determined from the QHNC equation has a complicate inner structure in the core region. As a consequence, the term $C_{eI}^{R}(r)$ of $[C_{eI}^{R}(r)$: the non-C oulomb part] which appears in (5.18) is di cult to calculate with a su cient accuracy; the discrepancy of the QHNC result for the zero-pressure condition is attributed to this problem in the Rb and Na cases in contrast to the case of a Lim etal which has a simpler inner core structure of a pseudopotential is not signi cant to determ ine the e ective ion-ion interaction, but is important to calculate the therm odynam ical quantities, as the QHNC results indicate. It is worth noting that the condition (5.18) provides a check of num erical consistency in the calculation for determining the elective ion-ion interaction, the structure factor and the therm odynam ical quantities for a liquid m etal in the vacuum.

x6. Sum m ary and discussion

In general, the virial theorem (2.10) teaches us that the partial pressure associated with each component in a mixture can be uniquely de ned by using the wall potential for each component, and the total pressure is represented as a sum of them : this de nition is assured by the virial theorem for single particle, (2.13) and (2.14). A lso, the partial pressure can be actually measured as an osm otic pressure, for example. Therefore, in an electron-nucleus mixture, the electron and nuclear pressures




Fig.2. The ion-ion structure factors $S_{II}(Q)$ of Rb obtained by use of the e ective ion-ion interactions based on the QHNC and A shcroft models, which are displayed by the full and dotted curves, respectively. The full and white circles indicate the experimental results by the neutron⁴⁵⁾ and X-ray⁴⁶⁾ di raction methods, respectively. The A shcroft model with $r_c = 1.275A$ determined by the condition $P_N = 0$ provides an indistinguishable structure factor from the QHNC result in a good agreement with the experiments.

are clearly and simply de ned as the partial pressures ow ing to the virial theorem (2.10) as is shown in x2, and the therm odynam ic pressure of this system is given by a sum of the electron and nuclear pressures. To be consistent with this fact, the electron pressure in this mixture is de ned by

It should be pointed out that the pressure represented by (6.2) is neither the electron pressure nor the total pressure for this system, and that this pressure is associated with the total pressure of another inhom ogeneous system (System -II as is named in x2), where only the nuclei are con ned in the volum e V and the electron can move over all space under the external potential caused by the con ned nuclei. Sim ilar remarks are made about the de nition of the stress tensor for this mixture as is discussed in x3

In x4, we have enumerated several kinds of de nitions for the electron pressure, which lead to the electron-pressure expression (6.1), where the nuclear virial term is subtracted. It is important for the calculation of the total pressure by adding the nuclear pressure that we should recognize which de nition is adopted to determ ine the electron pressure. For exam ple^{33} as was shown by $(4.1\frac{5}{H})$, the electron pressure calculated by use of the surface integral expression, $3P_eV = {}_{eV} r P_e dS$, is di erent from the pressure determ ined on the basis of the relation, $3P_eV = 2T_s[n] + E_{es} +$

tr P_{xc}^{DF} dr, in that the latter contains a part of the nuclear pressure R F, which is approximated by the Madelung energy term : $N C Z_{out}^2 = 4a$ as is given by Janak.¹⁾

W hen the nucleibehave as classical particles, the partition function of an electron-nucleus m ixture with the H am iltonian (2.1) is written exactly in the form 20

Thus, the pressure of this system is obtained by perform ing the volume derivative of the free energy $F = k_B T \ln Z_N$ without use of any approximation in the form ²⁷⁾

which is identical with (5·2); this relates the electron pressure determ ined in x4 under the adiabatic approximation to the total pressure and to that by the virial theorem (5·1) owing to (4·1). That is, the relation, $P = P_e + P_N$, is proven without use of the wallpotentials by (6·6) in the adiabatic approximation.¹⁰⁾ W hen we approximate F_e involved in (6·3) as

and perform the volum e derivative of F, we obtain the standard virial EOS³⁶⁾ for simple liquid m etals. On the other hand, the virial EOS (5.17) is derived by applying the approximation (6.7) only to the nuclear virial term of (6.6); the rst term of 6.6) is treated appropriately as the electron pressure in contrast with the standard virial form ula,³⁶⁾ in which derivation the approximation (6.7) is applied to both terms involving F_e in (6.6). As a result, the electron pressure in the exact expression (6.6) becomes to be represented by

in the standard virial formula for a liquid metal. Therefore, the EOS (5.17) is more accurate than the standard virial formula in spite of its simpler structure.

A metal in the vacuum is de ned as an electron-nucleus mixture without the wall potentials, which con ne the electrons (U_w^{ele}) and the nuclei (U_w^{nuc}) in a nite volume. From this de nition, we can give another important remark that the zero pressure of an electron-nucleus mixture in the vacuum is realized by both electron and nuclear pressures being zero at the same time: this can also be veried directly from therm odynamics as described in Appendix A. In the adiabatic approximation, the electron pressure is given by therm odynamics in the form

which is zero in the vacuum due to $(2\cdot13)$, since a metal in the vacuum is not conned by the wall. Similarly, $P_N = 0$ due to $(2\cdot14)$. Therefore, in the rst-principles molecular dynamics (MD) performed on liquid metals in the vacuum, for example, the nuclear pressure should become zero ($P_N = 0$); this relation also can be used to check numerical consistency in the MD calculation.

A ppendix A — E lectron pressure determ ined by the DF theory — —

The electron pressure can be expressed in terms of the internal energy of the interacting electrons in the presence of the external potential caused by the xed

nuclei at fR g as follow s:¹⁰⁾

the pressure given by $(B \cdot 8)$ becomes the total pressure of System -II with in nite nuclear mass. In contrast with the above fact, Eq. $(B \cdot 6)$ with the surface-integral term is identical with (4.15) or (2.9): the sum of the electron and nuclear pressures are equal to the total pressure of System -I with in nite nuclear mass. In reality, Janak's pressure form ula for num erical calculation becomes that of System -I, since the surface-integral terms in $(B \cdot 2)$ and $(B \cdot 4)$, in comparison with his equation (7), are taken into account in his equation (23) at this stage.
