## Superconducting uctuations in the Luther-Em ery liquid

The single-particle superconducting G reen's functions of a Luther-Em ery liquid is computed by bosonization techniques. Using a formulation introduced by Poilblanc and Scalapino Phys. Rev. B 66, 052513 (2002)], an asymptotic expression of the superconducting gap is deduced in the long wavelength and small frequency limit. Due to superconducting phase uctuations, the gap exhibits as a function of size L a  $(1=L)^{1=2K}$  power-law decay as well as an interesting singularity at the spectral gap energy. Similarities and differences with the 2-leg t-J ladder are outlined.

Superconductivity in cuprate m aterials has sparked an important theoreticale ort to investigate superconducting order in strongly correlated m aterials. A long-ranged superconducting ground state (GS) is characterized by a non-zero superconducting Gorkov's o -diagonal one-electron M atsubara Green function [1] de ned as

As proposed recently [2], basing on the Nambu-Eliashberg theory[1], the Matsubara frequency-dependent gap function  $_{SC}(q;!_n)$  can be directly computed from the diagonal and o -diagonal Green functions  $G(q;!_n)$  and  $F(q;!_n)$  as

$$_{SC} (q;!_n) = \frac{2i!_n F (q;!_n)}{G (q;!_n) G (q; \frac{1}{h})} : \qquad (2)$$

Such an expression has been used in num erical com putations for the two-dim ensionalt-J m odel[2] and for two-leg t-J ladders[3]. A one dim ensional system such as the twoleg t-J ladder is actually far rem ote from a norm al Ferm i liquid or a conventional superconductor[4, 5, 6]. The t-Jladder belongs to the the class of Luther-Emery (LE) liquids[7], which are characterized by spin/total charge separation, with a spectral gap in spin excitation and gapless charge excitations[8]. The gapless charge excitations lead to a perfect metallic conductivity [9] without any long range superconducting order[10]. The spectral gap in the spin excitations generates a gap in the oneelectron spectral functions[11, 12]. In an in nite system, the absence of long range superconducting order in plies that the correlation function (1) has to vanish. However, in a nite system, the function (1) does not vanish and the quantity de ned in (2) may provide useful inform ation on the pairing processes [3]. As a complementary study to num erical studies, it is interesting to investigate analytically the behavior of SC (q;!) in a nite size LE liquid. A complication in the case of the two-leg ladder

is that interband (but not total) charge excitations contribute to the form ation of the spin-gap [5]. A simpler example of a LE liquid is a orded by the U < 0 H ubbard chain [13, 14] or the related spin-gap phase of the t J chain [15] in which the gap is developed purely in the spin mode. Moreover, this model of a LE liquid is integrable both on the lattice [14] and in the continuum limit [16]. Progress in the theory of integrable systems has made it possible to calculate correlation functions using the form factor expansion [17]. In the case of gapful systems, it has been shown that the rst few terms of the expansion usually lead to good approximations of the physical quantities [18]. In the present paper, we will calculate  $_{\rm SC}$  in the case of an attractive one-dimensional Hubbard chain. The Hamiltonian reads:

Although the Hubbard model in one-dimension is integrable, its form factors have proved very dicult to obtain [19]. Since we are mostly interested in the low-energy and long-wavelength, it is more convenient to take the continuum limit. The continuum Hamiltonian H = H + H reads:

where and are the bosonic elds describing respectively the spin and charge excitations, and their conjugate variables, is a short distance cut-o (lattice spacing) and L N is the system size. Note that we assume here a unique velocity v for spin and charge excitations. The spin excitations are described by the sine-G ordon model. The term  $\cos^2 8$  is marginally

relevant and opens a spin gap M . The excitations above the ground state are known [16] to consist only of massive solitons (spinons) carrying the spin 1=2 and charge zero, in agreement with the exact solution of the lattice Hubbard model [14]. It is important to note that with the usual denition of the spin gap as the gap between the ground state and the lowest triplet excited state, = 2M . The fermion operators can be decomposed as  $c_p$ ; =  $c_p^{ik_F rx}$  r; (x) (x = p, r = or 1) and the fermionic elds r; can be expressed as [7]:

are the dual elds. Ferm ion propagaw here tors thus factorize into the product of a holon propagator and a spinon propagator. Since the charge Ham iltonian is quadratic, the calculation if the holon propagator is straightforward. For the spinon propagator, one needs to know the expression of the form factors of solitoncreating operators  $e^{-i(m-r-r)}$  in the sine-G ordon m odel. These have been obtained recently in in nite volume [20] and these results have been applied to the calculation of the diagonal Green's functions [12] con ming the ansatz of Ref.[11]. In our case, we need form factors in a system of nite size. However, if the system size L is much larger than the correlation length = v=M, since the dom inant contribution to sc (q;!) comes from integration on the , it is a good approximation to replace nite volum e form factors by in nite volum e ones. Keeping this in m ind, we de ne the diagonal and o -diagonal G reen's functions as:

Following [12], the asymptotic (long-distance) behaviors of the diagonal and o -diagonal Green's functions is then obtained as,

where =  $\frac{p}{x^2 + (v)^2}$ , =  $\frac{1}{8}$  (K + 1=K 2),  $^0$  =  $\frac{1}{8}$  (K 1=K),  $Z_1$  is a dimensionless constant calculated in [20] and M the single particle gap. These expressions show that G and F have a similar exponential decay at large distances above the characteristic length-scale = v=M. More rapidly decaying terms like e  $^{3M}$  = v and higher that involve more than one spinon in the intermediate state have been neglected. Note that the SC G reen's function decays with system size like as  $(1=L)^{\frac{1}{2K}}$  due to SC phase uctuations. However, apart from this overall power-law scaling factor, we expect the SC gap




FIG.1: Superconducting gap (norm alized to its Q = 0 value) vs Q .

 $_{\rm SC}$  to remain nite and bear interesting q and ! dependence. Using the Fourier transforms of the above expressions (8), the momentum and Matsubara-frequency dependence of the gap is given by

where y =  $(Q^{\frac{2}{3}},Q^2) = (q^{-1}k_F)^2 + (!_n)^2 = v^2, {}_2F_1$  is the hypergeom etric function [21] and C =  $\frac{2}{6}$  2 0) = (2 2 ). The approximate expression (9) although a long-wavelength limit still applies up to momentum Q 2 = . Note that (Q) 2 terms are dropped since .  $_{SC}$  is maximum (minimum) at Q = 0 (i.e. at the Fermimo-mentum) for K < 1.57 (K > 1.57) and shows only a very moderate dependence in Q as shown in Fig. 1.




FIG. 2: Real (a)) and imaginary (b) parts of the superconducting gap vs! obtained by bosonization results for a 1D LE liquid (energies are in units of the spectral (solitonic) gap M ) for K = 13 and q=  $k_{\rm F}$ . Data for two lengths are shown.

The real-frequency expression of the gap is obtained by the analytic continuation  $(!_n)^2$ !  $(!+i\mathring{})$  in Eq. (9). For j! j > M , the hypergeom etric functions have branch cuts, leading to a nonzero in aginary part in  $_{SC}$  (0;!) as can be seen on Fig. 2(b). Above the threshold, the gap function presents a singular behavior: (0;!)  $(0;0)\,(1-\frac{(!+i0)^2}{M-2})^{-\frac{1}{2K}}$ . The divergence at != M is in fact cut-o once j! M j < 1=L since we are really dealing with a system of nite size, so that  $_{SC}$  (q;!! M) = M. The full!-dependence of  $_{SC}$  plotted in Fig. 2(a) indeed reveals a strong singularity

In the absence of data for a single attractive Hub-

at! = M increasingly pronounced as system size is in-

bard chain or a single t J chain, we compare our results to numerical calculations on the t-J ladder model at 1=8-doping and J=0.4 [3]. The numerical calculations on 2 12 ladder show that there are two spinon gaps, M ( $q_y=0$ ) = 0.08t and M ( $q_y=0$ ) = 0.12t such that F ( $q_y=0$ ; ), G ( $q_y=0$ ; ) and ( $q_y=0$ ; ) develop an imaginary part for ! > ( $q_y$ ). The comparison of these spinon gaps with the actual spin gap of a 2 24 ladder [24] (de ned as the gap between the lowest triplet excitation and the singlet ground state) gives

 $(q_V=0)=0:11t'$  2M  $(q_V=0)$  and  $(q_V=)=0:17t'$  M  $(q_V=)+M$   $(q_V=0)$ . The discrepancies could result from a spinon-spinon attraction or from the overestimation of the spinon gaps in the 2 12 ladder. It is also important to note that in [3], the correlation length is of the order of magnitude of the system size. We note that no sharp peak is present in the imaginary part at the threshold, in contrast to the prediction of (9), but the prediction of a rather constant behavior of below the threshold is in agreement with (9).

A more detailed comparison between analytic and numerical result is possible. In the case of the ladder system, away from half-lling, the gapped modes is expected to present an approximate SO (6) SU (4) symmetry [22, 26]. This allows a description of the gapped modes by the SO (6) G ross-N eveu (GN) model[23] and a form factor calculation of the superconducting gap

 $(q;!_n)$  along the lines of the present paper[26]. The novelty in the case of the SO (6) GN m odel is that on top of the spinon excitations of m ass M (known as kinks in the literature on the GN m odel), there are also m assive

ferm ion excitations (bound states) with a mass M  $\frac{p}{2}$ . This implies a second threshold in  $(q;!_n)$  at the energy  $!=M(1+\frac{p}{2})$  besides the threshold at energy !=M. Whether this could be related to some higher energy features seen in numerics  $[\beta]$  needs further clarications. This will be discussed in more details in a separate publication.

In conclusion, we have computed the uctuating SC gap of the LE chain. A simple form is obtained with a factorization into a power-law factor accounting for SC suppression due to quantum phase uctuations multiplied by a function containing the dynamics of the pairing interaction. We point out somed i erences with the case of the 2-leg t-J ladder and suggest that the gapped sectors of the latter could be better described by the SO (6) GN model.
