W ave m ixing of hybrid Bogoliubov modes in a Bose-Einstein condensate

M ode-m ixing of coherent excitations of a trapped Bose-E instein condensate is modelled using the Bogoliubov approximation. Hybridization of the modes of the breather (1=0) and surface (1=4) states leads to the formation of a Bogoliubov dark state. Calculations are presented for second-harmonic generation between the two lowest-lying even-parity m=0 modes in an oblate spheroidal trap. Two hybrid modes are strongly excited near second-harmonic resonance, and the coupling strength, and hence conversion rate, to the breathermode is halfthat given by an equivalent hydrodynam ic estimate.

Observations of coherence of matter wave elds such as four-wave mixing [1], squeezing [2] and harm onic generation [3], in atom ic Bose-Einstein condensates have recently been reported. The well-de ned phase of the condensate means that small amplitude quasiparticle excitations can be produced that combine, through elastic coherent (phase preserving) atom ic collisions, to produce frequency-m ixed modes. In this Letterwe analyse, within the Bogoliubov model [4], second-harm onic generation of excitations in trapped spheroidal atom ic condensates: a process recently observed in experim ent [3]. We not the quantal results are signi cantly dierent from hydrodynam ic predictions [5]. In addition to the quantal frequency shifts, we observe mode hybridization due to coupling of degenerate Bogoliubov states and the creation of coherent-matter dark states. The hybridization process strongly a ects second-harm onic conversion. Two m odes are strongly excited near resonance, and the coupling strength, and hence conversion rate, to the breather mode is half that given by an equivalent hydrodynam ic estim ate.

Consider then a nite number of atoms, N, each of mass ma, occupying a Bose condensate trapped by a spheroidal potential such that the angular frequency along the polar z axis, axis of cylindrical symmetry, is $!_z$, and the corresponding radial frequency is $!_r$. We dene the trap aspect ratio as $!_z=!_r$, so that the trapping potential can be written: $V_{trap}=\frac{1}{2}m_a!_r^2(r^2+\ ^2z^2)$. The symmetry means that, in the limit of small amplitude excitations, the acoustic equation is separable and the axial, z, radial r and angular coordinate provide good hydrodynamic quantum numbers [6, 7]. The azim uthal angular momentum quantum number is denoted by m .

The lowest-frequency excitations of sym m etry m = 0, are the quadrupole (!₁) and breathing (!₂) m odes, and in the N -independent hydrodynam ic approximation [8]: $!_{1;2}^2 = \frac{1}{2}!_r^2 (4 + 3^2)^{\frac{1}{2}} = \frac{1}{2}!_$

This coupling is most strongly pronounced when temporal phase matching occurs, that is when second-harm onic resonance arises: $!_2 = 2!_1$. The corresponding values of , the trap aspect ratio, are thus $_{\rm r} = \frac{1}{6}$ 77 5 145 0:683 and 1:952 [8].

The e ect was rst observed in an oblate trap by Foot and coworkers [3] for the following parameters: 20000 atoms of 87 Rb, T < 0:5Tc, with !r = 126Hz. In measurements carried out within the range 1:6 < 2:8, strongly-enhanced second-harm onic generation was found when = 1:930:02. The corresponding them ical potential of this condensate, such h!r, lie within the range where hydrodynam ic theory should be valid. And indeed both the frequency of the breathing mode, !2, [6] and the resonant aspect ratio, r, m easured by experim ent are in very good agreement with linear hydrodynamic theory [8]. Subsequently a hydrodynam ic model of the nonlinear mixing of quasiparticles [4] was applied to estimate the rate of secondharm onic generation [9] and gave results consistent with experim ent. However, this consistency hides potentially im portant quantal features not previously considered or observed. This Letter examines the process of mode mixing and harm onic generation using a detailed quantal treatment of the process [4] taking into account atom num ber and quantum pressure corrections.

The form alism for wave-mixing processes in Bose condensed gases was developed by Burnett and cow orkers [4]. At low temperatures, $T=T_{\rm c}$ 0.5, the dynamics of Bose condensed gases are dominated by single quasi-particle excitations. The atom interactions are represented by an swave pseudopotential corresponding to a scattering length, $a_{\rm s}$. The spectrum and mode densities of collective excitations can be obtained from the Hartree variational principle:

where $g = (4 h^2 = m_a)N a_s$, $H_0 = (h^2 = 2m_a)r^2 + V_{trap}$




FIG. 1: Frequency spectrum of the the lowest four even-parity, m=0, excitations. The frequencies are in units of the radial frequency, $!_r$. Bogoliubov theory for N=4650 atom s, C=1000, is compared with hydrodynamic predictions (inset) (C:1). The labelling of the curves in the main graph corresponds to the quantum numbers for a spherical trap: =1. The frequency of the (+) hybrid mode is marked by the short-dashed line, and the () hybrid mode by the long-dashed line. The lowest frequency is the l=2; m=0 quadrupole (solid line). Hybridization of the Bogoliubov breather mode l=0 occurs near l=0.80;1.63;2.60. Second-harmonic resonance between the quadrupole and (+) hybrid occurs at l=1.989.




FIG. 2: Hybridization and form ation of the Bogoliubov dark state. The normalized quasiparticle amplitudes u (r;z) are plotted as a function of radial coordinate r (horizontal axis) and axial coordinate z (vertical axis) for C = 1000. Red indicates positive values and blue negative values. Values of increase from left to right: = 1:35;1:60;1:65;1:75. Below the crossing, at = 1:35, the surface (upper) and breather (lower) modes are distinct. At = 1:65 the modes combine to form the dark state (+) hybrid. As increases the monopole symmetry transfers to the upper(+) hybrid (Fig. 1)

, and plays the role of a Lagrange multiplier. The condensate and excited modes can be described by the linear response ansatz [4] where:

and where presents the highly-occupied condensate; that is, \mathfrak{z}_0 j N \mathfrak{z}_j j j > 0. From the variation , and linear expansion in the smallparam eters b_j ; b_j taken as constant, the stationary G ross-P itaevskii equation and B ogoliubov equations follow:

with (;) = 1. The Bogoliubov modes are solutions of the coupled linear equations:

We take the conventional normalization of modes: $(u_i;u_j)$ $(v_i;v_j)=_{ij}$. Although the spectrum $!_j$ is unique, them ode amplitudesm ay contain arbitrary components of the kernel, the !=0 component. After diagonalization, it is convenient, though not necessary, to enforce orthogonality [4]. Gram-Schm idt orthogonalization ensures the eigenmodes do not overlap the condensate: $u_j=u_j$ (; u_j) and $v_j=v_j+$ (; u_j). Suppose that the condensate (mode 0) contains N particles, and a single quasiparticle mode i of excitation is weakly populated. Then mode-mixing collisions of the type, i+ i! 0+ j, and all crossing symmetries, will be signicant in redistribution of population if phases (energies) match and/or the scattering amplitude is large.

A llowing for variation of the constants b_j of the trial function (3) in the variational principle (1), and neglecting transitions far from resonance, then we get [4]

where $_{ij}$ = $!_{j}$ 2 $!_{i}$ is the detuning. The mode conversion equations are exactly analogous to those in classical nonlinear optics, allowing for two or more excited modes (j) to be populated from the pump mode (i). The coupling strength (scattering amplitude) for the process, M $_{ij}$, is given by [4]:

and for a condensate with uniform phase throughout, all modes can be written in term of real functions.

The quasiparticle amplitudes and excitation spectra were found through discretization of the set of equations




FIG. 3: Coupling strength m $_{ij}$ from the m = 0 quadrupole state for C = 1000 as a function of trap aspect ratio : Coupling to (+) hybrid mode (short-dashed line), to the () hybrid mode (long-dashed line), and to the n = 1;1 = 2 state (dot-dashed line). The hydrodynam ic calculation for the breather mode [9] is shown as the dotted line. Second-harmonic resonance for the (+) hybrid mode occurs near = 0.68 and = 1.95 according to hydrodynam ic theory [8] and g.(1) as indicated by the vertical lines.

(3,4,5) using the method of [10]. We de ne a dimensionless interaction parameter, proportional to the number 8 N a, $(h=2m_a!_r)^{\frac{1}{2}}$, so that of atom s condensed: C C! 0 represents the ideal gas lim it. In the hydrodynam ic approximation, $h = (15C = 64)^{2-5}h!_r$, and the hydrodynam ic regim e can be very roughly characterised $(h = h!_r)$ 1. An example of the spectra of Bogoliubov states for C = 1000 (that is 7) is shown in g.1. This would correspond, for example, to N 4500 atoms of 87Rb with scattering length a 110a within a trap of frequency $!_r = 2$ 126Hz. Inset, for reference, are the equivalent N -independent hydrodynam ic results. The main feature of the quantal spectrum, compared with the hydrodynam ic results, are the very large di erences in the high-l state frequencies. We nd that in the quantal regime these surface (high-1) modes, in particular the state labeled 1= 4, interact with the secondharm onic breather mode and play an important role in harm onic generation.

For low-n; l states, the quantum corrections for the frequencies are rather small for this number of atoms. For example, at = 1 the solution of equations (4,5) for the quadrupole state gives $!_1 = 1.4808!_r$ for C = 1000. This changes to $!_1 = 1.457!_r$ for C = 2000, and reaches the hydrodynamic limit (C ! 1) at $!_1 = 1.4142!_r$. The n = 1; l = 0 breather frequency is $!_2 = 2.2101!_r$ for C = 1000, shifting to $!_2 = 2.2195$ for C = 2000, tending to $!_2 = 2.2361!_r$ for C ! 1. However while the quantal frequencies for these low-lying modes agree well with hydrodynamic theory for C = 1000, the agreement does not extend to wave-mixing process where quantale ects are much more pronounced.

The quantal breather state undergoes a series of




FIG. 4: Mode conversion for C=1000 and 10% pump population: (a) = 2:00: Population of fundamental (n = 0;1 = 2;m = 0) quadrupole mode (full line). Population of the o-resonant () mode (n = 0;1 = 4;m = 0) (long-dashed line). Population of resonant second-harmonic (+) mode n = 1;1 = 0;m = 0 (short-dashed line)

avoided crossings with higher-1 states as varies (gure 1). The frequency of the l= 4 quantal modes is significantly dierent from the hydrodynamic predictions for this regime. For example, at = 1 the l= 4; m = 0 mode has angular frequency != 2:426! r (C = 1000), and != 2:291! r (C = 2000) compared with != 2:000! r as C ! 1 . While at = 2, != 3:164! r (C = 1000), and != 3:042! r (C = 2000), compared with != 2:732! r as C ! 1 . As a result, hydrodynamic theory does not predict a degeneracy of the l= 4 and monopole states.

Near the avoided crossings in qure 1, the Bogoliubov m odes m ix sym m etries. The hybridization of the m odes is illustrated by the the excitation functions, u(r;z), shown in g2; a key nding of this Letter. Below the crossing, at = 1:35, the l = 0 and l = 4 am plitudes resemble the spherical pattern and the 1-labelling is certainly appropriate. The radial density of the l= 4 m ode is dom inated by the presence of the centrifugal barrier pushing the mean radius towards the surface of the condensate. At = 1:60 (g. 2) the l= 0 and l= 4 states hybridize and lose the character of conventional classication schemes [6, 7]. Above the degeneracy the modes separate and regain their character. Identical features were found at the other crossings near = 0.80 and = 2.60corresponding to interaction with l = 4 and n = 1; l = 2states, respectively. The hybridization, although prim arily a quantal feature, persists for much larger numbers of atoms. Considering C = 2000, that is N = 10^4 , the second-harm onic resonance occurs at $_{\rm r}$ = 1:980 and we nd a slight displacement of the avoided crossing from $_{\rm c}$ = 1:65 to = 1:54, but hybridization of the type discussed is still present.

The results for the coupling strengths are shown in qure 3. The data are presented in scaled dimensionless units in order to compare with hydrodynamic theory [9]: $m_{ij} = 2 (h=m_a!_r)^{3=2} (h=h!_r)^{5=6} M_{ij}$. The states are labelled and identi ed by the adiabatic noncrossing curves in gure 1. At the degeneracy 1:65 the strong m ixing of states is re ected in the changes in coupling strength. Coupling to the upper (+) hybrid mode drops suddenly at this point due to destructive interference between the mode components. The e ect is analogous to an optically dark state, that is a coherent superposition of states such that the dipole moments cancel [11]. The interference e ect is still apparent near = 2 when the state is predom inantly breather-like and resonant with the quadrupole second harm onic. In contrast the o resonant () hybrid, which is surface-like for 2 is strongly coupled near the degeneracy.

Sim ilare ects, including the form ation of another dark state, occur at 2.6 corresponding to the crossing between 1=0 and 1=6 as shown in gure 3. The result of hydrodynam ic theory for the quadrupole to breather coupling strength [9] is shown in gure 3 as the dotted line. The agreement with the quantal calculation is quite good near =1 but near and beyond the crossing point $_{\rm c}=1.65$, the hydrodynamic model does not recet the rapid quantal variation due to hybridization. At the harmonic generation resonance near =2 the hydrodynamic model severely overestim ates the coupling strength of the breather mode by a factor of two, and neglects the contribution of the 1=4 state.

The solutions of the equations (6,7) describing the relative populations in m odes i and j are well known [12]. For a resonant two state m odel the characteristic coupling time is T = $\frac{1}{2}$ h=gM $_{ij}b_i^r$ (0) . In term s of the dimensionless matrix elements m $_{ij}^q$ this can be written;

1:95, and C = 1000 the quantal prediction is only 5% of atom swere initially in the pump mode, then $\vec{p}_{i}^{r}(0)\vec{j} = 0.05$. It follows, for c = 1000 and i = 1.95, that the respective coupling tim es are T q = 14.60 m s com pared with $T^h = 6.78 \text{ m} \text{ s}$, which is a substantial and measurable di erence. However two excited hybrid modes are present near second-harm onic resonance. A num erical solution of equations (6,7) for a pum p population of 10% at = 2 shows the interplay of the hybrid modes: qure 4 (a). The nonresonant surface hybrid grows faster due to the larger coupling strength, but is not as e ciently converted as the resonant breather hybrid state. The fundam entalm ode revives [4] after 40m s for these param eters. Since the two hybrid modes dier in frequency and sym m etry this phenom enon should be detectable by observation of the radial and axial density variations as developed in current experiments [3]. In gure 4 (b) corresponding to = 1:65, very low conversion e ciency is observed due to poor phase-m atching. M oreover, in this case the dark-state hybrid (short-dashed line) is completely suppressed.

In conclusion, we nd the hybridization of Bogoliubov modes plays a vital role in mode mixing, both in the coupling strength and resonant frequency. A nother consequence is the creation of dark coherent states. The conversion rate for second-harm onic generation to the breather mode is substantially lower than the hydrodynam ic theory, while the o -resonant surface mode is converted with almost equal e ciency. This hybridization persists for much larger numbers (N 10^t) of atom s where quantale ects were thought to be neglible. Another potentially interesting case [13] is second-harm onic resonant coupling between the m = 2 quadrupole and the m = 0 m onopole m ode. In this case an accidental degeneracy of the monopole with a m = 4 mode occurs exactlyat the predicted resonance = 16=7 and the e ects of hybridization would be more extreme. The investigation of this particular transition would provide the clearest experim ental evidence of the e ect we have discussed.
