# A nom abus di usion and collapse of self-gravitating Langevin particles in D dimensions

#### A bstract

We address the generalized therm odynam ics and the collapse of a system of selfgravitating Langevin particles exhibiting anom abus di usion in a space of dimension D. This is a basic model of stochastic particles in interaction. The equilibrium states correspond to polytropic con gurations sim ilar to stellar polytropes and polytropic stars. The index n of the polytrope is related to the exponent of anom abus di usion. We consider a high-friction limit and reduce the problem to the study of the nonlinear Sm oluchow ski-Poisson system. We show that the associated Lyapunov functional is the T sallis free energy. We discuss in detail the equilibrium phase diagram of self-gravitating polytropes as a function of D and n and determ ine their stability by using turning points argum ents and analyticalm ethods. When no equilibrium state exists, we investigate self-sim ilar solutions of the nonlinear Sm oluchow skiPoisson system describing the collapse. Our stability analysis of polytropic spheres can be used to settle the generalized therm odynam ical stability of self-gravitating Langevin particles as well as the nonlinear dynam ical stability of stellar polytropes, polytropic stars and polytropic vortices.

### 1 Introduction

In preceding papers of this series [1, 2, 3, 4], we have studied a model of self-gravitating B row nian particles enclosed within a spherical box of radius R in a space of dimension D. This model can be considered as a prototypical dynamical model of system s with long-range interactions possessing a rich therm odynam ical structure. For simplicity, we considered the Sm oluchow ski-Poisson (SP) system which is deduced from the K ram ers-Poisson (KP) system in a high friction limit (or for large times). These Fokker-Planck-Poisson equations were rst proposed in [1] as a simplied dynamical model of self-gravitating systems. Their relation with therm odynamics (rst and second principles) was clearly established in terms of a maximum entropy production principle (MEPP) and their rich properties (self-organized states or collapse) were described qualitatively in this preliminary work. A thorough study of this system of equations was undertaken more recently in [2, 3, 4], complemented by rigorous mathematical results (see [5, 6, 7, 8, 9] and references therein).

The Sm oluchowski equation is a particular Fokker-Planck equation involving a di usion and a drift [10]. In our model, the drift is directed toward the region of high densities due to the gravitational force which is generated by the particles them selves. This retroaction leads to a situation of collapse when attraction prevails over di usion [2, 3, 4]. The SP system also provides a simplified model for the chemiotactic aggregation of bacterial populations [11] and for the form ation of large-scale vortices in two-dimensional hydrodynamics [12, 13, 14, 15, 16, 17]. It can be shown that the SP system decreases continuously a free energy constructed with the Boltzm ann entropy [1, 2]. A coordingly, the stationary solutions of the SP system are given by the Boltzm ann distribution which minimizes Boltzm ann's free energy at xed mass. The equilibrium state is then determined by solving the Boltzm ann-Poisson (or Emden) equation, as in the case of isothermal gaseous stars and isothermal stellar systems [18, 19]. However, depending on the value of the temperature T, an equilibrium solution does not always exist and the system can undergo a catastrophic collapse. We determ ined analytically and num erically self-similar solutions leading to a nite time singularity [2, 3]. In [3, 4], we showed that the evolution continues after the collapse until a D irac peak is form ed.

In this paper, we propose to extend our study to a generalized class of Sm oluchow ski equations [20]. They can be obtained from the fam iliar Sm oluchowski equation by assuming that the di usion coe cient depends on the density while the drift coe cient is constant (or the opposite). They can also be obtained from standard stochastic processes by considering a special form of multiplicative noise [21, 20] or an extended class of transition probabilities [22, 23]. These equations are consistent with a generalized maximum entropy production principle [20]. For simplicity, we shall assume that the di usion coe cient is a power law of the density. In the absence of drift, this would lead to anom alous di usion. If we take into account a drift term and a self-attraction, we have to solve the nonlinear Sm oluchow ski-Poisson (NSP) system. It can be shown [20, 24] that the NSP system decreases continuously a free energy associated with T sallis entropy [25]. A coordingly, the stationary solutions of the NSP system are given by a polytropic distribution which m inim izes T sallis' free energy at xed m ass. The equilibrium state is then determ ined by solving the Lane-Em den equation, as in the case of polytropic stars and stellar polytropes [18, 19]. Depending on the value of the control parameter and on the index n of the polytrope, three situations can occur: (i) the NSP system can relax toward an incomplete polytrope maintained by the walls of the con ning box (ii) the NSP system can relax toward a stable complete polytrope of radius R < R, una exted by the box (iii) the NSP system can undergo a catastrophic collapse leading to a nite time singularity.

The paper has two parts that are relatively independent. In the rst part of the paper (Secs. 2 and 3), we study the dynam ical stability of stellar systems, gaseous stars and twodim ensional (2D) vortices by using a therm odynam ical analogy [26, 20, 23]. Stellar polytropes maxim ize T sallis entropy (considered as a H -function) at xed mass and energy. This is a condition of nonlinear dynam ical stability via the V lasov equation. Polytropic stars m inim ize T sallis free energy (related to the star energy functional) at xed mass. This is a condition of nonlinear dynam ical stability via the Euler-Jeans equations. Polytropic vortices maxim ize T sallis entropy (considered as a H -function) at xed circulation and energy. This is a condition of nonlinear dynam ical stability via the 2D Euler equation. We perform an exhaustive study of the structure and stability of polytropic spheres by determ ining whether they are maxim a or m in in a (or saddle points) of T sallis functional. For sake of generality, we perform our study in a space of dimension D. We shall exhibit particular dimensions D = 2, D = 4, D = 2(1 + 2)and D = 10 which play a special role in our problem. The dimension D = 2 is critical because the results established for D > 2 cannot be directly extended to  $D = 2 \beta$ . On the other hand, the nature of the caloric curve changes for D = 4 and D = 10. This extends the study perform ed by Taruya & Sakagam i [27, 28] and Chavanis [29, 26] for D = 3.

In the second part of the paper (Sec. 4), we study the dynam ics and therm odynam ics of selfgravitating Langevin particles experiencing anom alous di usion. Their equilibrium distribution m in in izes T sallis free energy at xed m ass. This is a condition of therm odynam ical stability in a generalized sense. This is also a condition of linear dynam ical stability via generalized Fokker-P lanck equations (in the present context the NSP system) [2, 24, 20]. Thus, the stability analysis of Sec. 3 can also be used in that context. W hen the static solution does not exist or is unstable, the system undergoes a catastrophic collapse. In Sec. 4, we show that the NSP system adm its self-sim ilar solutions describing the collapse and leading to a nite time singularity. The density decreases at large distances as r . In the canonical situation (xed T), the scaling exponent is n = 2n = (n - 1) where n is the polytropic index. We also consider a microcanonical situation in which the generalized tem perature T (t) varies in time so as to rigorously conserve energy. In that case, the scaling equation has solutions for n  $_{m ax}$  (n;D) where  $m_{ax}$  (n;D) is a non-trivial exponent. The value of expression exponent is determ ined by the dynam ics. In Sec. 5, we perform direct num erical simulations of the SP and NSP systems with higher accuracy than in Ref. [2]. We con m the scaling regime and discuss the value of the scaling exponent. In the microcanonical situation, we give num erical evidence that = n so that the tem perature T (t) is nite at the collapse time (this observation has been made independently by [9] for the SP system). However, the convergence to this value is so slow that the evolution displays a pseudo-scaling regime with n $_{max}$  for the densities achieved. We explain the physical reason for this behavior and we conjecture that max will be reached in more realistic models with non-uniform temperature [30]. This paper closely follows the style and presentation of our companion paper for isotherm al spheres [3]. These two papers complete the classical monograph of Chandrasekhar on self-gravitating isotherm aland polytropic spheres in D = 3 [18].

## 2 D ynam ical stability of system s w ith long-range interactions

#### 2.1 Stellar system s

Let us consider a collection of N stars with mass m in gravitational interaction. They form a H am iltonian N -body system with long-range (N ewtonian) interactions. W e work in a space of dimension D and enclose the system within a spherical box of radius R. Let f (r;v;t) denote the distribution function of the system, i.e.  $f(r;v;t)d^{D} rd^{D} v$  gives the mass of stars whose position and velocity are in the cell (r;v;r +  $d^{D} r;v + d^{D} v$ ) at time t. The integral of f over the velocity determ ines the spatial density

The totalm ass of the con guration is

In the mean-eld approximation, the total energy of the system can be expressed as

where K is the kinetic energy and W the potential energy. The gravitational potential is related to the density by the Newton-Poisson equation

where  $S_D$  is the surface of a unit sphere in a D-dimensional space and G is the constant of gravity.

For xed N 1 and t ! +1, the system is expected to reach a statistical equilibrium state described by the classical B oltzm ann entropy  $S_B [f] = \int f \ln f d^D r d^D v$ . However, the relaxation time  $t_{relax}$  due to \collisions" (m ore properly close encounters) is in general considerably larger than the dynam ical time  $t_D$  so that this statistical equilibrium state is often not physically relevant [31, 32]. This is the case in particular for elliptical galaxies where  $t_{relax} = \frac{N}{\ln N} t_D$  with N  $1 d^2$ , while their age is 100 [19]. For t  $t_{relax}$  and N ! +1, the dynam ics of stars is described by the V lasov equation

where F = r is the gravitational force determ ined by the Poisson equation (4). For any H-function

where C is convex, i.e.  $C^{0} > 0$ , it can be shown that the variational problem

determ ines a stationary solution of the V lasov equation with strong (nonlinear) dynamical stability properties [33, 34]. Such solutions can result from a process of (possibly incomplete) violent relaxation [26]. Introducing Lagrange multipliers, the rst order variations S E

M = 0 lead to

Therefore, f = f() where  $=\frac{v^2}{2}$  + is the energy of a star by unit of mass. These distribution functions, depending only on the energy, form a particular class of stationary solutions of the V lasov equation. O ther solutions can be constructed with the Jeans theorem [19] but their stability is more di cult to investigate. The conservation of angular momentum can be easily included in the foregoing discussion [35].

#### 2.2 Barotropic stars

Let us now consider a self-gravitating gaseous system described by the Euler-Jeans equations

We assume that the gas is barotropic with an equation of state p = p(). The most important examples of barotropic uids are those that are isentropic or adiabatic, that is those whose specic centropy is constant. If s = C st; the rst principle of therm odynamics du = pdv + T ds (where v = 1 =) reduces to du =  $\frac{p}{2}d$ , where u is the internal energy by unit of mass. The total energy of the uid is therefore

The rst term is the internal energy, the second the gravitational energy and the third the kinetic energy associated with the m ean motion. As argued in [26], the variational problem

determ ines a stationary solution of the Euler-Jeans equations with strong (nonlinear) dynam ical stability properties. We shall not prove this result here but it is expected to follow from relatively standard methods of stability theory. The solutions of this variational problem satisfy the condition of hydrostatic balance

between pressure and gravity. The foregoing results can be extended to barotropic stars rotating rigidly with angular velocity [35].

#### 2.3 Two-dim ensional vortices

Let us nally consider a collection of N point vortices with circulation in 2D hydrodynam ics. They form a Hamiltonian system with long-range (logarithmic) interactions. We call the vorticity, the stream function and u = z r the velocity eld. We also note =  $!d^2r$  the circulation and E =  $\frac{1}{2}$  !  $d^2r$  the energy. For xed N 1 and t ! +1, the system is expected to reach a statistical equilibrium state described by the classical Boltzm ann entropy  $S_B$  [!] = ! ln ! d^2r [36]. However, the relaxation time  $t_{relax}$  due to \collisions" is in general considerably larger than the dynam icaltime  $t_D$  so that this statistical equilibrium state is often not physically relevant [15, 16]. For t  $t_{relax}$  and N ! +1, the dynam ics of point vortices is described by the 2D Euler-Poisson system

The Euler equation also governs the dynamics of 2D incompressible and inviscid continuous vorticity elds. For any H -function

(16)

where C is convex, i.e.  $C^{0} > 0$ , it can be shown that the variational problem

determ ines a stationary solution of the 2D Euler equation with strong (nonlinear) dynamical stability properties [37]. Such solutions can result from a process of (possibly incomplete) violent relaxation [17]. Introducing Lagrange multipliers, the condition S = 0 leads to

Therefore, ! = ! ( ), which is the general form of stationary solutions of the 2D Euler equation for dom ains with no speci c symmetries. The conservation of angularmomentum and impulse can be easily included in the foregoing discussion [20].

#### 2.4 Therm odynam ical analogy

Since the variational problem s (7), (12) and (17) are similar to the usual variational problem s that arise in them odynam ics (with the Boltzm ann entropy), we can develop a them odynam ical analogy to analyze the dynam ical stability of stellar systems, gaseous stars and 2D vortices [26, 20, 23, 17]. In this analogy, the functional S plays the role of a generalized entropy, is a generalized inverse temperature, (E) a generalized caloric curve etc... The variational problem (7) is similar to a condition of microcanonical stability. We can also introduce a generalized free energy F [f] = E [f] TS [f] which is the Legendre transform of S [f]. The minimization of F [f] at xed T and M [f] is similar to a condition of canonical stability. This is equivalent to rst minimize F [f] at xed (r) to get f (r;v) and then to minimize F [] = F [f], calculated with f, at xed M []. Now, it can be shown [26] that F [] is precisely the functional (11) with u = 0. Therefore, the variational problem (12) is similar to a condition of canonical stability (but not the converse) [20], we conclude that \stellar system s are stable whenever corresponding barotropic stars are stable" which provides a new interpretation of Antonov's rst law [26].

In 2D hydrodynam ics, the variational problem (17) is sim ilar to a condition of microcanonical stability. It is stronger than the maxim ization of J[!] = S[!] E[!] at xed and [!] (canonical stability), which is just a su cient condition of nonlinear dynam ical stability. It is not a necessary condition of stability if the ensembles are inequivalent (i.e. if the \caloric curve" presents bifurcations or turning points). The A mold's theorem s just provide su cient conditions of canonical stability (see, e.g., [20]). Therefore, in the dom ain of inequivalence (corresponding to a region of \negative speci c heats") a ow can be nonlinearly dynam ically stable while it violates A mold's theorem s. This has in portant in plications in jovian uid dynam ics [37, 38].

The preceding arguments also apply to other systems with long-range interactions such as the HMF model for example [39]. This opens the route to many generalizations by changing the potential of interaction and the \generalized entropy" (H-function). In this paper, we shall specialize in the case of particles interacting via a New tonian potential (e.g., self-gravitating systems, 2D vortices,...). We shall also consider a special form of H-function, known as T sallis entropy, leading to power-laws distributions (polytropes).

## 3 Equilibrium structure of polytropic spheres in dim ension D

#### 3.1 Stellar polytropes

Let us consider a particular class of stationary solutions of the V lasov equation called stellar polytropes [19]. Nonlinearly dynam ically stable solutions maxim ize the T sallis entropy

at xed mass M and energy E, where q is a real number. For q ! 1, Eq. (19) reduces to the ordinary Boltzm ann entropy describing isotherm al stellar system s. We emphasize that, in the present context, T sallis and Boltzm ann entropies are particular H -functions (not true entropies) that are related to the dynamics, not to the therm odynamics. Still, due to the therm odynam ical analogy discussed in Sec. 2.4, we shall use a therm odynam ical langage to study the dynam ical stability problem. In this analogy, the dynam ical stability criterion for stellar polytropes corresponds to a microcanonical stability condition. The critical points of entropy at xed m ass and energy satisfy the condition

where = 1=T and are Lagrange multipliers (T is the tem perature and the chem ical potential in the generalized sense). The variational principle (20) leads to the polytropic distribution function

We rst consider the case  $(q \ 1) = q > 0$  and allow to take negative values. Then, Eq. (21) can be rewritten

If n > D = 2 (i.e., q > 1 and > 0),  $f^{0}() < 0$  where  $= \frac{v^{2}}{2} + is$  the stellar energy. Therefore, high energy particles are less probable than low energy particles, which corresponds to the physical situation. Equation (23) is valid for  $v < v_{max} = \frac{1}{2}$  ( ). If  $v > v_{max} = \frac{1}{2}$  ( ), we set f = 0. This distribution function describes stellar polytropes which were

rst introduced by P lum m er [40]. If n = D = 2 (i.e., q ! 1), the distribution f() is a step function. This corresponds to the self-gravitating Ferm igas at zero tem perature (white dwarfs). In D = 3, classical white dwarf stars are equivalent to polytropes with index n = 3=2 [18]. In D -dimensions, classical white dwarf stars" are equivalent to polytropes with index

(25)

If n + 1 (i.e. q + 1), we recover isotherm all distibution functions. If n < D = 2 (i.e., q < 1 and q < 0), high energy particles are more probable than low energy particles:  $f^0( ) > 0$ . This situation is unphysical but it can be considered at a form allevel. The distribution function diverges like  $(1 \quad v=v_{max})^{n \quad D=2}$  as  $v + v_{max}$ . The moments of f converge if and only if n > D = 2 1. Therefore, if D = 2 1 < n < D = 2 (i.e., q < 0 and > 0), stellar polytropes exist m athem atically but they are not physical. If n < D = 2 1 (i.e., 0 < q < 1 and < 0), stellar polytropes do not exist.

We now consider the case (q = 1) = q < 0. Then, Eq. (21) can be rewritten

If n > D = 2 (i.e., q > 1 and < 0), the model is ill-posed because f (v) diverges for v ! + 1. If n < D = 2, the distribution function goes to zero like  $v^{(D-2n)}$  for v ! + 1. If 0 < n < D = 2(i.e., q < 1 = 2=D), the density = fd<sup>D</sup> v does not exist. If  $\frac{1}{P} < n < 0$  (i.e., 1 = 2 = D < q < D = (D + 2)), the density exists but not the pressure  $p = \frac{1}{D} fv^2 d^D v$ . If n < 1 (i.e., D = (D + 2) < q < 1 and > 0), the density and the pressure exist.

In conclusion, only positive temperatures states are physical. If D = 2 (i.e. q > 1), the system is described by the distribution function (23). If n < 1 (i.e., D = (D + 2) < q < 1), the system is described by the distribution function (26). In this paper, we shall only consider stellar polytropes with index n = D = 2. Using Eq. (23), the spatial density  $= fd^{D}v$  and the pressure  $p = \frac{1}{D} fv^{2}d^{D}v$  can be expressed as

with B (a;b) being the beta-function. In obtaining Eq. (29), we have used the identity B (m + 1;n) = m B (m;n)=(m + n). E lim inating the gravitational potential between these two relations, we recover the well-known fact that stellar polytropes satisfy the equation of state

like gaseous polytropes (see below). In the present context, the polytropic constant is given by

The distribution function (32) can also be obtained by maximizing  $S_q[f]$  at xed M, E and (r), or equivalently at xed K =  $\frac{1}{2}$  fv<sup>2</sup>d<sup>D</sup> rd<sup>D</sup> v and (r). It is then possible to express the energy (3) and the entropy (19) in term s of (r) and T.U sing Eq. (32), it is easy to show that

In arriving at Eq. (35), we have used the identity B (m; n+1) = nB (m; n) = (m+n). Proceeding carefully, we can check that for q! 1, Eq. (35) reduces to the Boltzm ann entropy expressed in terms of hydrodynam ical variables (see Eq. (9) of [3]). The problem of the stability of stellar polytropes now amounts to determ ining maxim a of S<sub>q</sub>[] at xed E[] and M[].

#### 3.2 Gaseous polytropes

W e shall consider a particular class of barotropic stars called gaseous polytropes. They are characterized by an equation of state of the form

where K is a constant. We recall that gaseous polytropes are described by a local therm odynam ical equilibrium condition and not by a distribution function of the form (21), except in the isotherm alcase n ! +1 (see [29]). Their energy (11) is

U sing Eqs. (34) and (35), we note that the free energy of stellar polytropes  $F_q = E$  T  $S_q$  is

within an additional constant. Taking u = 0, we check on this speci c example that  $F_q[] = W[]$ . In fact, this relation is general as shown in [26]. Therefore, the dynam ical stability of gaseous polytropes can be settled by studying the minimization of  $F_q[]$  at xed mass. In the therm odynam ical analogy of Sec. 2, this corresponds to a canonical description. We note nally that the free energy (38) can be written explicitly

This can be viewed as a free energy F = E KS associated with a T sallis entropy in position space  $S = \frac{1}{1}$  ( )d r, where plays the role of the q parameter and K the role of a tem perature. The parameters q and are related to each other by = 1+2 (q 1)=[2+D (q 1)]. The equilibrium distribution can be written

An equivalent equation can be obtained by substituting the equation of state (30) in the condition of hydrostatic equilibrium (13), as for gaseous polytropes (the equivalence between these two approaches is shown in [26]). 


Figure 1: Phase portrait of the Lane-Em den equation in the (u;v) plane for D < 2 (speci cally D = 1). The value of the polytropic index is indicated on each curve. For n + 1, denoted  $n_{isoth}$ , we recover the phase portrait of isotherm all spheres.




Figure 2: Phase portrait of the Lane-Em den equation in the (u;v) plane for D = 2. At this dimension  $n_5 + 1$ , so that the 2D-Schuster solution (65) becomes equivalent to the 2D-isotherm al solution [3]. In the (u;v) plane this corresponds to a straight line.




Figure 3: Phase portrait of the Lane-Em den equation in the (u;v) plane for 2 < D < 10 (speci cally D = 3).




Figure 4: Phase portrait of the Lane-Em den equation in the (u;v) plane for D > 10 (speci cally D = 15). For D = 10, n + 1. Therefore, for  $n > n_5 = 3=2$ , the phase portrait is always a spiral except for the index n = +1 for which the spiral is reduced to a point.

The points where () is extrem um are determined by the intersections between the solution curve in the (u;v) plane and the curve de ned by Eq. (117). The number of extrem a can thus be determined by a graphical construction using Figs. 1-4. This graphical construction depends




Figure 5: M ass-central density prodes for polytropic congurations in a space of dimension 2 < D < 10 (speci cally D = 3). A mass peak appears for the forth index  $n_3$ . For  $n > n_5$  the prode displays an in nity of peaks. For n < 1, is a decreasing function of . For D = 2, the () curves are monotonic.




Figure 6: M ass-central density pro les for polytropic con gurations in a space of dimension D > 10 (speci cally D = 15). For  $n_5 < n < n$  (speci cally n = 1.321) the pro le displays an in nity of peaks. For n > n (speci cally n = 2.5) the function ()! s for ! +1 w ithout oscillating.




Figure 7: Graphical construction determining the extrem a of () for D < 2 (speci cally D = 1). The solid lines correspond to the solution curves and the dashed lines to the curves de ned by Eq. (117). The curves are labeled by the value of the polytropic index n. The vertical lines correspond to the asymptote u = u. For D < 2, there is no intersection so that () has no extrem um.




Figure 8: Same as Fig. 7 for 2 < D < 4 (speci cally D = 3). The geometrical construction changes for  $n = n_{3=2}$ , n = D 1 and  $n = n_5$ . Typical cases are represented.




Figure 9: Same as Fig. 7 for  $4 < D < 2(1 + \frac{p}{2})$  (speci cally D = 4:5). The geometrical construction changes for  $n = n_{3=2}$ ,  $n = n_5$  and n = D 1. Typical cases are represented. The indices label both the solid curve and the closest broken curve.




Figure 10: Same as Fig. 7 for  $2(1 + \frac{p}{2}) < D < 10$  (speci cally D = 6). The geometrical construction changes for  $n = n_5$ ,  $n = n_{3=2}$  and n = D 1. Typical cases are represented. The indices label both the solid curve and the closest broken curve.




Figure 11: Evolution of the energy along the series of equilibria (parameterized by ) for 2 < D < 4 (speci cally D = 3). For  $n < n_5$ , the curve has no extrem um . For D = 2, the () curves are monotonic.




Figure 12: Evolution of the energy along the series of equilibria (parameterized by  $\)$  for 4 < D < 10 (speci cally D = 4:5). For  $n < n_5$ , the curve has one maximum . For D > 10, the () curves are similar to the () curves in Fig. 6.




Figure 13: Generalized caloric curve for D < 2 (speci cally D = 1). Note that according to Eq. (98), the potential energy is necessarily positive for D < 2, so the region 0 is forbidden. We have plotted in dashed line the branch of complete polytropes with R < R de ned by Eq. (109).




Figure 14: Generalized caloric curve for D = 2. We have plotted in dashed line the branch of complete polytropes with R < R de ned by Eq. (110).




Figure 15: Generalized caloric curve for 2 < D < 4 (speci cally D = 3). For  $n_3 < n < n_5$ , the inverse temperature presents a maximum but not the energy. For  $n > n_3$ , there exists a region of negative (generalized) speci c heats C = dE = dT < 0 in the microcanonical ensemble. We have plotted in dashed line the branch of complete polytropes with R < R dened by Eq. (109).




Figure 16: Generalized caloric curve for 4 < D < 10 (speci cally D = 4.5). For  $n < n_3$  (speci cally  $n_3 = 1.8$ ), the energy presents a minimum but not the inverse temperature. For  $n_3 < n < n_{3=2}$  (speci cally  $n_{3=2} = 2.25$ ), both the energy and the temperature present a minimum and the caloric curve () rotates anti-clockwise. This implies that equilibrium states with positive as well as negative speci c heats C = dE = dT are stable in the canonical ensemble. This \therm odynamical anom aly" arises because, as discussed in Sec. 3.1, stellar polytropes with  $n < n_{3=2}$  are unphysical (the temperature is negative). For  $n = n_{3=2}$  (white dwarfs), the curve makes an angular point (see Appendix C).




Figure 17: Continuation of Fig. 16. For  $n_{3=2} < n < n_5$  (speci cally  $n_5 = 2.6$ ) both the energy and the tem perature present an extrem um and the curve rotates clockwise (the curve makes a \loop"). The region of negative speci c heats is now unstable in the canonical ensemble, as it should. For  $n > n_5$  (speci cally  $n_5 = 2.6$ ), the energy and tem perature present an in nity of extrem a.




Figure 18: Generalized caloric curve for  $D > 2(1 + \frac{p}{2})$  (speci cally D = 5:1) and  $n = n_{3=2}$ . For this particular index, the curve presents an in nity (because  $n_{3=2} > n_5$ ) of angular points towards the singular sphere (see Appendix C).




Figure 19: This gure summarizes the structure of the caloric curve as a function of the dimension D and the polytropic index n. The symbols are dened in the text. If we lim it ourselves to n D = 2 (physical stellar polytropes), the region  $A B^0$  showing a \therm odynamical anomaly" is not accessible.

on the values of D and n and the di erent cases are shown in Figs. 7-10. For D < 2, there is no extrem um (case  $A^0$ ). For 2 < D < 4, there is no extrem um for n < n<sub>5</sub> (case  $A^0$ ) and there is an in nity of extrem a for n > n<sub>5</sub> (case  $C^0$ ). They exhibit dam ped oscillations toward the value s corresponding to the singular solution (47). For 4 < D < 10, there is one maximum for n < n<sub>5</sub> (case  $B^0$ ) and there is an in nity of extrem a for n > n<sub>5</sub> (case  $C^0$ ). For D > 10, there is one maximum for n < n<sub>5</sub> (case  $B^0$ ) and there is an in nity of extrem a for n > n<sub>5</sub> (case  $C^0$ ). For D > 10, there is one maximum for n < n<sub>5</sub> (case  $B^0$ ), there is an in nity of extrem a for n<sub>5</sub> < n < n (case  $C^0$ ), and there is no extrem um for n > n (case  $D^0$ ). This last case corresponds to an overdam ped evolution towards the value s (in our mechanical analogy of Sec. 3.3). The appearance of a maximum for n < n<sub>5</sub> when D > 4 was a surprise in view of preceding analysis for D = 3 [27, 29, 26]. The parameter is restricted by the inequalities (see Figs. 11 and 12)

In Figs. 13–18, we have plotted the generalized caloric curve , giving the inverse temperature as a function of the energy, for di erent dimensions D and polytropic index n. This extends the results of our previous analysis in D = 3 [29]. The number of turning points as a function of D and n is recapitulated in Fig. 19.

#### 3.7 The generalized therm odynam ical stability

We now come to the generalized therm odynam ical stability problem. We shall say that a polytrope is stable if it corresponds to a maximum of T sallis entropy (free energy) at xed mass and energy (temperature) in the microcanonical (canonical) ensemble. The stability analysis has already been performed for D = 3 [27, 29, 28, 26] and is extended here to a space of arbitrary dimension. This stability analysis can be used to settle either (i) the dynam ical stability of stellar and gaseous polytropes (see Sec. 2) or (ii) the generalized therm odynam ical stability of self-gravitating Langevin particles (see Sec. 4).

We start by the canonical ensemble which is simpler in a rst approach. A polytropic distribution is a local minimum of free energy at xed mass and temperature if, and only if, the second order variations (see Appendix D)

The second order variations of free energy can be negative (in plying instability) only if the di erential operator which occurs in the integral has positive eigenvalues. We need therefore to consider the eigenvalue problem

with q(0) = q(R) = 0 in order to satisfy the conservation of mass. If all the eigenvalues are negative, the polytrope is a minimum of free energy. If at least one eigenvalue is positive, the polytrope is an unstable saddle point. The point of marginal stability in the series of equilibria is determined by the condition that the largest eigenvalue is equal to zero ( = 0). We thus have to solve the dimential equation

with F(0) = F(R) = 0. The same eigenvalue equation is obtained by studying the linear stability of the Euler-Jeans equation [29, 26]. Introducing the dimensionless variables de ned previously, we can rewrite this equation in the form

This relation determ ines the points at which a new eigenvalue becomes positive  $(=0^{+})$ . Comparing with Eq. (113), we see that a mode of stability is lost each time that is extrem um in the series of equilibria, in agreement with the turning point criterion of Katz [41] in the canonical ensemble. When the curve () is monotonic (cases A and D), the system is always stable because it is stable at low density contrasts (! 0) and no change of stability occurs afterward. W hen the curve () presents extrem a (cases B and C), the series of equilibria becomes unstable at the point of minimum temperature (or maximum mass) 1. In Fig. 15, this corresponds to a point of in nite speci c heat C = dE = dT ! 1, just before entering the region of negative specic heats C < 0. When the curve () presents several extrem a (case C), secondary modes of instability appear at values  $_2$ ,  $_3$ ,... (see [29] in D = 3). We note that complete polytropes (with  $n < n_5$  if D > 2) are stable in the canonical ensemble if D 2 and  $n_{\rm b}$ ). They are unstable otherwise. In the therm odynam ical analogy developed in if (D > 2, n [29, 26], this is a condition of nonlinear dynam ical stability for gaseous polytropes with respect to the Jeans-Euler equations. In particular, the self-gravitating Ferm i gas at zero tem perature (a classical white dwarf star) is dynamically stable if  $n_{3=2} < n_3$ , i.e. D < 4, and unstable otherw ise.

A coording to Eq. (125), the perturbation promethat triggers a mode of instability at the critical point = 0 is given by

The density perturbation becomes zero at point(s) i such that  $v(i) = v_s$ .




Figure 20: Location of the turning points of tem perature in the (u;v) plane for system s with dimension 2 < D < 10 (speci cally D = 3). The line  $u = u_s$  determ ines the extrem a of and the line  $v = v_s$  determ ines the nodes of the density prodes that trigger the instabilities in the canonical ensemble.

It can be determined by straightforward graphical constructions in the M ille plane, using Figs. 1-4 (see, e.g., Fig. 20). When the solution curve is monotonic

(case B), the density perturbation pro le has only one node. In particular, for  $n = n_5$ , the perturbation pro le at the point of marginal stability is given by

For high modes of instability, the zeros asymptotically follow a geometric progression with ratio 1 : expf2 =  ${}^{P} \overline{g}$  (see Ref. [29] for D = 3).

In the microcanonical ensemble, a polytrope is a maximum of entropy at xed mass and energy if, and only if, the second order variations (see Appendix D)

which result from simple integrations by parts and from the properties of the Lane-Emden equation (45), it is found that the point of marginal stability is determined by the condition (117). Therefore, the series of equilibria becomes unstable at the point of minimum energy in agreement with the turning point criterion of Katz [41] in the microcanonical ensemble. W hen the curve () is monotonic (cases A  $^{0}$  and D  $^{0}$ ), the system is always stable. W hen the curve () presents extrem a (cases  $B^{0}$  and  $C^{0}$ ), the series of equilibria becomes unstable at the point of m in imum energy  $\frac{0}{1}$ . In Fig. 15, this corresponds to the point where the speci c heat C = dE = dT = 0, passing from negative to positive values. Note that the branch of negative specic heats between CE and MCE is stable in the microcanonical ensemble although it is unstable in the canonical ensemble. When the curve () presents several extrem a (case C $^{0}$ ), secondary modes of instability appear at values  $\frac{0}{2}$ ,  $\frac{0}{3}$ ,... We note that complete polytropes (with  $n < n_5$  if D > 2) are stable in the microcanonical ensemble if D < 4 and unstable if 4. Owing to the therm odynam ical analogy, this is a condition of nonlinear dynam ical D stability for stellar polytropes with respect to the V lasov equation [26]. The di erence between the dynamical stability of gaseous polytropes (n  $n_{\rm B}$ ) and stellar polytropes (n n<sub>5</sub>) was related in [29, 26] to a situation of ensemble inequivalence (and the existence of a negative speci c heat region) in therm odynam ics. Since the caloric curve is monotonic in D = 2, we also conclude that polytropic vortices [20] are always nonlinearly dynam ically stable with respect to the 2D Euler equation.

A coording to Eqs. (134) and (146), the perturbation profile that triggers a mode of instability at the critical point = 0 is given by

## 4 Self-gravitating Langevin particles

#### 4.1 The nonlinear Sm oluchow ski-Poisson system

Let us consider a system of N self-gravitating B rownian particles described by the stochastic equations (i = 1; ...; N)

where  $i = (r_i;t)$  is the self-consistent gravitational potential created by the particles,  $\psi$  is a friction force originating from the presence of an inert medium and  $R_i(t)$  is a white noise satisfying h $R_i(t)i = 0$  and h $R_{i;a}(t)R_{j;b}(t^0)i = i_{j,ab}$  (t<sup>0</sup>). To simplify the problem, we consider the high friction limit ! + 1, where is the friction coe cient [2]. This regime is achieved for times t<sup>1</sup>. In the mean-eld approximation, the evolution of the density of particles is governed by the Sm oluchow ski equation [10]

coupled to the Newton-Poisson equation (4). In the usual case [2, 3, 4], the di usion coe cient D is constant and the condition that the Boltzmann distribution  $e^{=T}$  is a stationary solution of Eq. (152) is ensured by the Einstein relation D = T. It can be shown [2] that the SP system decreases the free energy F = E TS constructed with the Boltzmann entropy. Hence, the equilibrium state minimizes

We want to consider here a more general situation in which the di usion coe cient D depends on the density while the drift coe cient is still constant. In the absence of drift, this would lead to a situation of anom abus di usion. In the presence of drift, a notion of generalized therm odynamics emerges [20]. Indeed, writing the di usion coe cient in the form D () =  $\frac{1}{p}$ () = , we obtain the generalized Sm oluchow ski equation

In Ref. [20], it is shown that generalized Sm oluchow ski equations of this type satisfy a form of canonical H -theorem. The Lyapunov functional decreasing m onotonically with time is

This can be interpreted as a free energy associated with a generalized entropy functional (see [20] for more details). The equilibrium state minim izes F at xed M. In the present context, this is a condition of generalized therm odynam ical stability in canonical ensemble.

The generalized Sm oluchowski equation (154) can be obtained by combining the ordinary Fokker-Planck equation with a Langevin equation of the form [20]:

Since the function in front of R (t) depends on r, the last term in Eq. (156) can be interpreted as a multiplicative noise. Note that the noise depends on r through the density (r). K aniadakis [22] has also introduced generalized Fokker-P lanck equation arising from a modi ed form of transition probabilities. In these works, the Langevin particles evolve in an external potential. The case of Langevin particles in interaction was considered by Chavanis [20]. He introduced a generalized Fokker-P lanck equation (see in particular Eq. (81) of [20]) valid for an arbitrary equation of state p = p(), or di usion coe cient D (), and for an arbitrary binary potential of interaction u (r  $r^2$ ). This equation has been studied recently in [1, 2, 3, 4] for an isotherm al equation of state p = T (constant D) and a gravitational interaction. This study has been extended in [43] to a Ferm i-D irac equation of state. In this paper, we consider the case where the function D () is a power law and write D () = K  $r^1$ . This corresponds to a polytropic equation of state p = K. Then, Eq. (152) can be rewritten

It can be interpreted as a free energy associated with T sallis entropy. In this context, the polytropic index plays the role of the q-parameter and the polytropic constant K plays the role of the temperature (see R ef. [20] for details and subtleties). Therefore, keeping K xed corresponds to a canonical situation [29]. For ! 1, we recover the Boltzm ann free energy studied in [2, 3]. For = 5=3, i.e. n = 3=2, Eq. (157) describes self-gravitating B row nian ferm ions at T = 0 (in D = 3) [43].

The nonlinear Sm oluchow ski equation can be obtained from a variational principle, called M axim um Entropy P roduction P rinciple, by maxim izing the rate of free energy F-for a xed totalm ass M [1, 20]. It is straightforward to check that the rate of free energy dissipation can be put in the form

where is the growth rate of the perturbation de ned such that  $\ddagger$ . This relation shows that a stationary solution of the nonlinear Sm oluchow skiPoisson (NSP) system is dynamically stable for sm all perturbations (<0) if and only if it is a local minimum of free energy ( ${}^{2}F > 0$ ). In addition, it is shown in Refs. [2, 20] that the eigenvalue problem determining the growth rate of the perturbation is similar to the eigenvalue problem (128) associated with the second order variations of free energy (they coincide form arginal stability). This shows the equivalence between dynam ical and generalized therm odynam ical stability for self-gravitating Langevin particles exhibiting anom alous di usion (this result was obtained independently by Shiino [24] in the speci c context of T sallis therm odynam ics). In fact, our form alism is valid for more general functionals than the Boltzm ann or the T sallis entropies [20]. These functionals (155) arise when the di usion coe cient is of the general form D (), not necessarily a power law. We note that the NSP system satis es a form of Virial theorem [20]. For D € 2, it reads

Our model of self-gravitating Brownian (or Langevin) particles has no clear astrophysical applications, so it must be regarded essentially as a toy model of gravitational dynam ics. It may

nd application for the form ation of planetesim als in the solar nebula since the dust particles experience a friction with the gas and a noise due to small-scale turbulence [44]. However, even in this context, the model has to be rened so as to take into account the attraction of the Sun and the rotation of the disk. Anyway, the self-gravitating Brownian (or Langevin) gas model is well-posed m athem atically, and it possesses a rigorous therm odynam ical structure corresponding to the canonical ensemble. Therefore, it can be used as a simple model to illustrate som e aspects of the therm odynam ics of self-gravitating system s. Since it m inim izes F = W [] at xed mass, it can also be used as a powerful num erical algorithm to construct nonlinearly dynam ically stable stationary solutions of the Euler-Jeans equations (see Sec. 2.2). Coincidentally, the SP system also provides a simple model for the chemotactic aggregation of bacterial populations [11]. The name chem otaxis refers to the motion of organisms induced by chem ical signals. In some cases, the biological organisms secrete a substance that has an attractive e ect on the organism s them selves. This is the case for the bacteria E scherichia coli. In the simplest model, the bacteria have a di usive motion and they also move system atically along the gradient of concentration of the chemical they secrete. Since the density (r;t) of the secreted substance is induced by the particles them selves, the drift is directed toward the region of higher density. This attraction triggers a self-accelerating process until a point at which aggregation takes place. If we assume in a rst step that (r;t) is related to the bacterial density (r;t) by a Poisson equation, this phenom enon can be modeled by the SP system. Now, it has been observed in many occasions in biology that the diusion of the particles is anom alous [11]. This is a physical motivation to study the NSP system in which the di usion coe cient is a power law of the density. In the following section, we show that the NSP system admits self-similar solutions describing the collapse of the self-gravitating Langevin gas or of the bacterial population. These theoretical results are con med in Sec. 5 where we num erically solve the NSP system .

### 4.2 Self-sim ilar solutions of the nonlinear Sm oluchow ski-Poisson system

From now on, we set M = R = G = 1 without loss of generality. The equations of the problem become

The quantity can be seen as a sort of generalized tem perature (sometimes called a polytropic tem perature [29]) and it reduces to the ordinary tem perature T for n + 1. We note that the proper description of a gas of Langevin particles in interactions is the canonical ensemble where

is xed. However, we can form ally set up a microcanonical description of self-gravitating Langevin particles by letting the temperature (t) depend on time so as to conserve the total energy:

Note that for n ! 1, we recover the result of  $\beta$ ],  $_1 = 2$ . Equation (182) in plies that for large x, (D ) S > 0, which enforces < D (this also guarantees that the mass of the power-law prole = Cr at  $t = t_{coll}$  is nite). The limit value  $_n = D$  corresponds to  $n = n_3$ . Therefore, there is no scaling solution for  $n < n_3$ . This is consistent with our nding that the collapse occurs only for  $n > n_3$ . For  $n < n_3$  and  $> !_n$ , the system converges toward a complete polytrope with radius R < 1 which is stable (see Sec. 3.7 and Fig. 15). For  $n_3 < n < n_5$  and > (1), we can form ally construct a complete polytrope with radius R < 1, but this structure is unstable (Sec. 3.7) so that the system undergoes gravitational collapse.

In the microcanonical ensemble, the value of  $_{n}$  cannot be obtained by dimensional analysis. It will be selected by the dynamics. In the case n + 1, we have found in [3] that Eq. (181) for the scaling prole has physical solutions only for 2  $_{max}(D)$  (with  $_{max}(D = 3) = 2209733...$ ). For arbitrary n, such a  $_{max}(D;n)$   $_{n}$  also exists (see Sec. 5). It is easy to see that the maximum value for leads to the maximum divergence of temperature and entropy. Therefore, it is natural to expect that the value  $_{max}$  will be selected by the dynamics except if some kinetic constraints forbid this natural evolution (see below). In fact, as already noted in [2], a value of > \_\_n poses problem with respect to the conservation of

In a rst series of num erical experim ents reaching m oderately high values of the central density [2], we measured (by dierent methods) a scaling exponent  $'22 > _1 = 2$  (for the isotherm al case n = 1). Combined with the fact that the Sm oluchow ski-Poisson system must lead to a diverging entropy, we argued that  $m_{ax}$  is selected by the dynam ics (while being careful not to rigorously reject the possibility that = 1 = 2). Then, in order to account for energy conservation, we proposed a heuristic scenario showing how subscaling contributions could lead to the divergence of potential energy. In fact, the num erical simulations were not really conclusive in showing the divergence of tem perature, as the expected exponent is very small  $2 = m_{ax} = 0.09491$ ::;, for D = 3 and n ! +1). Recently, we have conducted a new (2= n series of num erical simulations allowing to achieve much higher values of density (see Sec. 5). These simulations tend to favor a value of = n leading to a nite value of the tem perature at  $t_{coll}$ . However, the convergence to the value n is obtained for values of t very close to  $t_{coll}$ and, at interm ediate tim es for which the tem perature has not reached its asym ptotic value, the num erical scaling function tends to display an elective exponent between n and  $m_{ax}$ . This situation is rem in iscent of the (D = 2; n = +1) case studied in [3], although the situation is not exactly equivalent. Numerical simulations of the (D = 3; n = +1) case have been conducted independently by [9] and favor also a value of  $= n \cdot N$  ote that there is no rigorous result proving that = n in the microcanonical situation, so this point remains an open mathematical problem.

However, in the microcanonical ensemble, the system is expected to reach a self-con ned polytrope for  $n < n_5$  and > n since it is stable (see Sec. 3.7 and Fig. 15). Probably, the choice of evolution will depend on a notion of basin of attraction as in [2].

We now focus on self-gravitating B rownian particles (n = 1). In case of collapse, the previous discussion shows that the system has the desire to achieve a value of > 2 leading to a

divergence oftem perature and entropy. This is indeed a natural evolution in a therm odynam ical sense. This is also consistent with the notion of gravotherm al catastrophe introduced in the context of globular clusters [45, 46, 47, 48]. However, the energy constraint (168) seem s to prevent this natural evolution (the divergence of entropy occurs in the post-collapse regim e [4]). This is related to the assumption that the tem perature is uniform although this assumption clearly breaks down during the late stage of the collapse. Therefore, we expect that if the tem perature is not constrained to remain uniform, the system will select a value of > 2 as in other models of m icrocanonical gravitational collapse [46, 47, 48]. Below, we give a heuristic hint so as how this can happen. We consider the Sm oluchow ski equation

Such a scaling is indeed observed in the globular cluster model of [48]. The decay exponent is obtained by using the de nition of  $T_0 = {}_0r_0^2$  and the fact that the tem perature at distances  $r = r_0$  should be of order unity. The precise density and tem perature process and the value of depend on the model considered for the energy transport equation. It is not our purpose to discuss a precise model in the present paper and we postpone this study for a future work [30].

However, we can give an analytical argument showing why > 2 should now be selected in a unique way. Equation (190) shows that temperature scales as the potential since

Equations (190), (191) and (192) in ply that both the kinetic and potential energies remain bounded for all times t  $t_{oll}$ , at least for  $\langle D + 2 \rangle = 2$ , even if the central temperature  $T_0$  (t) diverges. Indeed, the temperature increases in the core but the core mass goes to zero so that the kinetic energy of the core  $M_0T_0$  goes to zero. On the other hand, the temperature remains of order unity in the hab leading to a nite kinetic energy in the hab. This \corehab" structure for the temperature ismore satisfactory than a model in which the temperature is uniform everywhere, even in the collapse phase. Before introducing a precise equation for T (r;t) [30], we make the reasonable claim that the temperature and the potential energy are sim ply proportional in the core region as they exhibit a sim ilar scaling relation. D e ning  $T_0$  (t) such that (0) = 1, we end up with the hypothesis

The above argument is a strong indication that if the uniform temperature constraint is abandoned, a non trivial value for > 2 will be selected. We conjecture that this eigenvalue will be close to  $_{max}$  ' 2:21 as found in other models of microcanonical gravitational collapse with a non-uniform temperature [46, 47, 48].

## 5 Num erical sim ulations

In this section, we illustrate num erically some of the theoretical results presented in the previous sections, but we restrain ourselves to D = 3.




Figure 21: Evolution of the density pro le (r;t) for n = 3=2 and = 0:1 (corresponding to  $> !_n$ ). The pro le converges to a complete polytrope strictly con ned inside the box (thick line). The dashed line is the initial uniform density pro le.




Figure 22: For n = 4 ( $_4 = 8=3$ ) and = 0:1 (canonical description), we plot S (r;t)=S (0;t) as a function of  $r=r_0$  (t), where  $r_0$  (t) is defined by Eq. (173), for different times corresponding to central densities in the range  $2:10^2$   $4:10^5$  (bottom data collapse). This is compared to the scaling function obtained by solving Eq. (181) numerically (dotted line). The same is plotted in the case n = 1 ( $_1 = 2$ ), for which the scaling profile is known analytically [3]: S (x)=S (0) =  $(1 + x^2)^{-1}$  (upper data collapse). The two curves have been shifted for clarity. In the n = 1 case, the asymptotic scaling profile (dotted line) is almost indistinguishable from the data collapse. D ashed lines have respective slopes 8=3 and 2.

We rst consider the dynamics in the canonical ensemble (xed ). In Fig. 21, we show the di erent steps of the formation of a self-con ned polytrope of index  $n = 3=2 < n_3 = 3$ similar to a classical \white dwarf" star. In this range of n, the system always converges to an equilibrium state (see Fig. 15). If  $< !_n$  the equilibrium state is con ned by the box (incom plete polytrope) while for  $> !_n$  the density vanishes at R < R (com plete polytrope). In Fig. 22, we illustrate the collapse dynamics at low temperatures for  $n = 4.2 [n_3;n_5]$  and

 $n = 1 > n_5 = 5$ . This is compared to the predicted scaling proles. The convergence to scaling is slower for n = 4 (= 8=3) than for n = 1 (= 2). This is expected since, in the former case,  $r_0 = 0^{1-1}$  decreases more slowly as is bigger. Thus, the scaling regime  $r_0 = 1$  is reached in a slower way. For instance, for comparable naldensities of order  $10^6$ , and for the considered temperatures, we not that the minimum  $r_0$  obtained for n = 4 is roughly 4 times bigger than in the n = 1 simulations. For n = 1 and in the large D limit, we have shown in [3] that the scaling function S (x) takes the form




Figure 23: We plot S (0) as a function of n (full line), and compare it to a simple theory explained in the text, which is inspired by the large D perturbation introduced in [3] (dashed line). Note that S (0) ' 4 + C = n + O (n<sup>2</sup>) for large n with C ' 19.

where  $x_0$  is such that  $S(x_0) = -D$ . The quantities z = D S(0)=2 and (z) have been exactly calculated in this limit. In the present case, and for a given n (yielding  $_n = 2n=(n - 1)$ ), we compute S(0), by assuming the above functional form. The parameter  $x_0$ ,  $x_1$  and S(0) are numerically calculated by imposing the exact value for  $S^{(0)}(0)$  extracted from Eq. (181), as well as the two conditions that  $x_0$  must satisfy (see [3] for more details). The comparison of this approximate theory with actual numerical data is satisfactory (see Fig. 23). Note that we have been unable to develop a large n perturbation theory in the same spirit as the large D expansion scheme detailes in [3].




Figure 24: We plot  $\max_{max} (D = 3; n)$  as a function of n (top plot), as well as the associated value of  $\frac{1}{4} \ln S(0)$  (bottom plot). The horizontal dashed line represents the asymptotic value of  $\max_{max}$  for n ! +1, and we nd  $\max_{max} (D = 3; n)$   $\max_{max} (D = 3; n = 1) + C_3 = n + 0$  (n<sup>2</sup>) for large n, with  $C_3$  2:7. For n  $\mathfrak{g} = 5$ ,  $\max_{max} = D = 3$  (strictly speaking, the scaling solution associated to = D = 3 does not exist below  $n_5 = 5$ ). We observe that  $\ln S(0)$  (n 5)<sup>1=4</sup> provides an excellent t of S(0) for n 2 [5;10]. We have also plotted n = 2n = (n - 1) (thick line). The scaling equation (181) admits solutions for n = max. The two curves intersect when n = D which corresponds to  $n = n_3$ . There is no scaling collapse solution for  $n = n_3$ .




Figure 25: For n = +1 and E =0:45 (m icrocanonical description), we plot S (r;t)=S (0;t) as  $_{0}$  (t)<sup>1=</sup> , for times corresponding to central densities in the a function of  $r=r_0$  (t) where  $r_0$  (t) range  $2:10^2$  $4:10^{\circ}$  (for comparison, our previous simulations [2] did not exceed \_0 1000). We try both values  $_1 = 2$  (bottom plot) and  $= _{max} = 2209733$ ::: (top plot), and com pare both data collapses to the associated scaling function (dotted lines). The two curves have been shifted for clarity. The scaling associated to  $m_{ax}$  is clearly more convincing than that for = 2,  $_{0}$  (t)<sup>1</sup> <sup>2= max</sup> especially at large distances. However, our simulations also suggest that (t) does not diverge at  $t_{coll}$  (see the insert where a line of slope 1 0:09491::: has been  $2 = m_{ax}$ drawn as a guide to the eye), so that the asymptotic scaling should correspond to = 2. This apparent \paradox" clearly shows that the convergence to the lim it value n is extrem ely = slow, suggesting an interm ediate pseudo-scaling regime with m ax •

As explained in the previous section, the situation in the microcanonical ensemble (where = (t) evolves with time in order to conserve energy) is less clear. Like in the case n = 1 studied in [3], the scaling equation admits a physical solution for any  $_{n} _{max} (D; n)$ . In Fig. 24, we plot  $_{max} (D = 3; n)$ , as well as the corresponding value of S (0), as a function of n. As explained previously, it is doubtful that a scaling actually develops with  $> _{n}$  when the temperature is uniform. However, a pseudo-scaling should be observed with '  $_{max}$ . In Fig. 25, we present new simulations (D = 3, n = 1) con ming that the observed scaling dynamics is better described by  $= _{max}$  than by = 2, in the time/density range achieved. Such a value of implies that the temperature would diverge with a small exponent

However, in the range of accessible densities  $_{0} = 2.10^{-1}$  10, numerical data tend to suggest that the temperature converges to a nite value with an in nite derivative  $\frac{d}{dt}(t_{coll}) = +1$  as t !  $t_{coll}$ . This convergence of the temperature has been observed independently by [9]. Thus, we conclude that the system rst develops an apparent scaling with .  $_{max}$ , before slow ly approaching the asymptotic scaling regime with = 2. In any case, it is clear that if the = 2 scaling is the relevant one, the scaling regime is approached much more slow ly than in the canonical ensemble (com pare Fig. 25 and Fig. 22). This is a new aspect of the inequivalence of statistical ensembles for self-gravitating system s.

## 6 Conclusion

In this paper, we have discussed the structure and the stability of self-gravitating polytropic spheres by using a form alism of generalized therm odynam ics [20]. This form alism allows us to present and organize the results in an original manner. W hat we mean by generalized therm odynam ics is the extension of the usual variational principle of ordinary therm odynam ics (maxim ization of the Boltzmann entropy  $S_B$  at xed mass M and energy E) to a larger class

of functionals (playing the role of \generalized entropies"). This variational problem can arise in various dom ains of physics (or biology, econom y,...) for di erent reasons. In any case, it is relevant to develop a therm odynam ical analogy and use a vocabulary borrowed from therm odynam ics (entropy, tem perature, chem ical potential, caloric curve, free energy, m icrocanonical and canonical ensembles,...) even if the initial problem giving rise to this variational problem is not directly connected to therm odynamics. Thus, we can directly transpose the methods developed in the context of ordinary them odynam ics (e.g., Legendre transform s, turning point argum ents, bifurcations,...) to a new context. For example, in the present study, the maxin ization of T sallis entropy at xed m ass and energy is a condition of nonlinear dynam ical stability for stellar polytropes via the V lasov equation and for polytropic vortices via the Euler equation. On the other hand, the minimization of T sallis free energy at xed m ass is connected to the nonlinear dynam ical stability of polytropic stars via the Euler-Jeans equations. It is also a condition of them odynam ical stability (in a generalized sense) for self-gravitating Langevin particles experiencing anom abus di usion and a condition of dynam ical stability for bacterial populations. A though the form alism is the same for all these systems, the results have a very di erent physical interpretation. Our results m ay also have unexpected applications in other dom ains of physics that we are not aw are of.

On a technical point of view, we have provided the complete equilibrium phase diagram of self-gravitating polytropic spheres for arbitrary value of the polytropic index n and space dimension D. Our study, generalizing the classical study of Em den [49] and Chandrasekhar [18], shows how the phase portraits previously reported in the literature (for particular dim ensions and particular polytropic indices) connect to each other in the full parameter space. From the geometrical structure of the generalized caloric curves, we can immediately determ ine the dom ains of stability of the polytropic spheres by using the turning point method [41]. These stability results have been con med by explicitly evaluating the second order variations of entropy and free energy. This eigenvalue method provides, in addition, the form of the density pro le that triggers the instability at the critical points. Interestingly, this study can be performed analytically or by using simple graphical constructions in the M ilne plane. We have found that complete stellar polytropes (with  $n < n_5 = (D + 2) = (D + 2)$ 2) if D > 2) 4 and unstable for D > 4. On the other hand, complete gaseous polyare stable for D 2 and for (D > 2, n) $\mathbf{g} = \mathbf{D} = \mathbf{D}$ tropes are stable for D 2)) and unstable for (D > 2) $n > n_3$ ). Polytropes with index  $n_{3=2} = D = 2$  correspond to classical white dwarf stars (i.e., a self-gravitating Ferm i gas at T = 0). They are self-con ned only for D < 2(1 +  $\frac{1}{2}$ ) and they are stable only for D < 4. For D > 4, quantum mechanics is not able to prevent gravitational collapse, even in the non-relativistic regime. In this sense, D = 4 is a critical dimension. Therefore, our dimension of space 2 < D = 3 < 4 is bounded by two critical dimensions. It seems that this remark has never been made before. The description of phase transitions in the self-gravitating Fermi gas at non-zero tem perature in dimension D will be considered in a future article [50]. Other possible extensions of our work would be to consider di erent equations of state such as the m odi ed isotherm al p =T ln (1  $=_0$ ) associated with an  $\left| \right| = \left| \left| \right|^{2} \right|$  $f \ln + (_{0})$ ) ln (<sub>0</sub> lgd r or the logotropic equation of state  $p = p_c [1 + A \ln (=_c)] [51]$  associated with  $S [] = p_c A$  ln d<sup>2</sup> r.

The concept of generalized therm odynam ics is rigorously justi ed in the case of stochastic (Langevin) particles experiencing anom alous di usion. This happens when the di usion coefcient in the Fokker-P lanck equation depends on the density of particles while the friction or drift is constant. In this paper, we have explicitly studied the nonlinear Sm oluchow skiP oisson system (for self-gravitating Langevin particles) corresponding to a power-law dependance of the di usion coe cient. This particular situation is connected to T sallis generalized therm odynam ics but m ore general Fokker-P lanck equations can be constructed and studied [20]. The connection between them odynam ical and dynam ical stability for this type of generalized Fokker-Planck equations has been established in the general case in [20]. The nonlinear Sm oluchowski-Poisson system can have physical applications for the chemotaxis of bacterial populations. The collapse and aggregation of bacterial populations is similar, in some respect, to the phenom enon of core collapse in globular clusters (or to the Jeans instability in m olecular cbuds) and the neglect of inertia is rigorously justi ed in biology at variance with astrophysics. In addition, biological systems are likely to experience anom alous di usion so that the NSP system can provide an interesting and relevant model for the problem of chem otaxis. We have shown that the solutions of the NSP system can either converge toward a complete polytrope or an incomplete polytrope restrained by the box, or lead to a situation of collapse. The determ ination of the scaling exponent in the microcanonical ensemble (constant energy) is dicult due to the extrem ely slow entry of the system in the scaling regime. However, it seems to be 1) ( = 2 for isotherm all spheres) as in the canonical given asymptotically by n = 2n = (n - 1)ensemble (constant tem perature). We expect that an exponent > n will be selected when the tem perature is allowed to vary in space and time. This problem will be considered in a future study [30].

## A Gravitational force in D dim ensions

The gravitational eld produced in r by a distribution of N particles with m ass m in a space of dimension D is

For D = 1, the gravitational eld created by a particle is independent on the distance. Thus, an object located in x experiences a force (by unit of mass)  $F = Gm (N^+ N)$ , where  $N^+$  is the number of particles in its right ( $x_i > x$ ) and N the number of particles in its left ( $x_i < x$ ).

The external gravitational eld created by a spherically sym metric distribution of matter with mass  ${\rm M}$  is

From this relation, we conclude that there exists an equilibrium solution with p(R) = 0 at  $T_c = GM = 4$ . We therefore recover the critical temperature of an isotherm al self-gravitating gas in two-dimensions (see, e.g., [3]). At  $T = T_c$ , the density prode is a D irac peak so that p(R) = 0. For  $T < T_c$ , there is no static solution and the system undergoes a gravitational collapse. This collapse was studied in [3] with the Sm oluchow ski-Poisson system.

# C Special properties of n<sub>3=2</sub> polytropes

In this Appendix, we consider polytropes with index  $n_{3=2} = D = 2$  in a space of dimension D 4. They correspond to D -dimensional \white dwarf" stars. A coording to Eq. (113), the curve () is extrem um for

# F Dynamical stability of gaseous spheres

In this section, we assume D > 2. A coording to Eq. (37), the energy of a polytropic star at equilibrium (u = 0) can be written

where K is the kinetic energy and W the potential energy. Now, for a complete polytrope  $(p_{\rm b} = 0)$ , the V irial theorem reads

Combining the foregoing relations, we get

A coording to Poincare's theorem, a gaseous starwith W > 0 is unstable [18]. For polytropic stars, this condition is equivalent to  $n > n_3$ .

M ore generally, the internal energy of a m ass dm of gas at tem perature T is  $dU = C_v dm T$ . Its kinetic energy is  $dK = \frac{D}{2} dm R T = \frac{D}{2} (C_p - C_v) dm T$  where R is the constant of perfect gases and  $C_v$ ,  $C_p$  are the speci c heats at constant volum e and constant pressure, respectively. Thus, we get

(241) 
$$U = \frac{2}{D(1)}K;$$

where  $= C_p = C_v$ . For a monoatom ic gas, = (D + 2) = D and U = K. Using the V irial theorem (239), the total energy of the star W = U + W can be written

The star is unstable for  $<_{crit} = 2(D - 1)=D$ . For D = 3, we recover the well-known result  $_{crit} = 4=3$ . For a polytropic gas, we recover the result  $_{crit} = 1 + 1=n_3$ .
