M onte Carlo simulations of the screening potential of the Yukawa one-component plasma.

A Monte Carlo scheme to sample the screening potential H (r) of Yukawa plasmas notably at short distances is presented. This scheme is based on an importance sampling technique. Comparisons with former results for the Coulom bic one-component plasma are given. Our Monte Carlo simulations yield an accurate estimate of H (r) as well for short range and long range interparticle distances.

I. IN TRODUCTION

In this work we present a M onte C arb scheme devised to compute the pair distribution function g(r) of a strongly coupled plasm a, notably at short distances, i.e. for values of r sm aller or of the order of the ionic radius, with a high accuracy. The model considered in our study is the Yukawa O ne-C om ponent plasm a (YOCP), i.e. a system made of N identical classical ions of charge Z e immersed in an uniform neutralizing background of electrons. The electric interaction between two ions is supposed to be of the form $v(r) = (Ze)^2 y(r)$ where y(r) = exp(r) = r(0) is the Yukawa potential and the screening parameter. In the limit ! 0 the YOCP reduces to the well-know n coulom bic one-component plasm a $(OCP)^1$. The congurational potential energy in a domain of the ordinary space \mathbb{R}^3 can thus be written as²

where $_{\rm B}$ = NZ e= is the uniform charge density of the background. The constant E which appears in the rhs of eq. (1.1) xes the zero of energy and reads as

In the therm odynam ic lim it the therm odynam ic, structural, and dynam ical properties of the YOCP depend solely upon two dimensionless parameters, namely the coupling parameter = $(Z e)^2 = a$ and the reduced screening parameter

= a where = $1=k_B T$ (k_B Boltzm ann constant, T tem perature) and a is the ionic radius (4 $a^3=3=1$, where = N = is the num ber density of particles).

The therm odynam ic properties of the YOCP are well-known now adays thanks to extensive M onte Carlo (MC) simulations performed either within periodical³ or hyperspherical² boundary conditions. M uch less is known about g(r) and the related screening function H (r) de ned as

H (r) plays an important role in estimating the enhancement factors for the therm onuclear reaction rates⁴. As for r ! 0 g(r) exp(ay(r)) the values of g(r) for r ! 0 are extremely small for large 's, which precludes a numerical study by means of standard MC simulations and biased MC schemes are therefore unavoidable. Such a scheme is presented in next sec (II), it is a synthesis of two biased schemes applied formerly in the determination of the cavity function of hard spheres⁵ in the one hand, and in the calculation of the screening function H (r) of the OCP in the other hand⁶.

Results of MC simulations are reported in sec (III) both for the OCP and the YOCP cases. They must be considered as prelim inary results, our ultim ate goal being to establish a complete data basis of screening functions H (r) for a wide range of (;).

II. SAM PLING THE SCREEN ING FUNCTION

In the canonical ensemble the pair distribution function g(r) is given by

where the brackets < :::> denote a canonical therm all average and is the volume. In eq. (2.1) $r_{12} = r_1 = r_2$ and we have implicitly assumed that the system was hom ogeneous which is veried if periodical boundary conditions are adopted. In practice g(r) can be computed in a standard MC calculation with a good precision only for $r > r_m$ in. For instance at 100 we have typically r_m in =a 1. In order to compute g(r) for $r < r_m$ in we follow the suggestion of 0 gata⁶ and rewrite eq. (2.1) as

In (2.2) w (r) is a priori an arbitrary function and O gata has shown how to take advantage of that to devise an e cient MC biased scheme.

The function q_w supports the following simple physical interpretation. Let us consider a mixture made of (N 2) Yukawa charges and two test particles labelled (1;2). These two particles interact with the (N 2) other ions via Yukawa potentials but their mutual potential energy is de ned as $w(r_{12}) + v(r_{12})$. For practical purposes, it is ay (r) + H (r) where H (r) is a good estimate of the true screening function clearly clever to choose w(r) =H (r). Indeed it follows from eqs. (1.3) and (2.2) that $g_w(r) / exp$ H (r) H (r) As a consequence, if H н, then gw (r) is practically constant and therefore easy to determ ine num erically. However we are only half the way since gw (r) is known only up to a multiplicative constant. This norm alization constant can be reexpressed, as discussed by Ogata⁶, as a di erence of free energies which can be determ ined in the course of a M C run as therm al averages. However, in the MC simulations of this author, the variance on these averages turn out to be quite large which precludes an accurate estimate. Therefore we adopted the method that Patey and Torrie devised for computing the cavity function of hard spheres⁵. Suppose that $q_{w}(r)$ has been computed by a MC simulation of the mixture described above for, let say, 0 < r=a < 2. In practice it can be achieved by the choice w (r) = ay (r) + H (r) for 0 < r=a < 2 and w (r) = 1 for r=a > 2. Then an unnormalized pair distribution $g_u(r) = g_w(r) = exp(w(r))$ can be computed in the range 0 < r=a < 2 and compared to the normalized $q_0(r)$ obtained by a standard MC simulation. This comparison in the range of distances where both g_0 (r) and g_u (r) can be determined precisely (i.e. $r_{m in} = a < r = a < 2$) yields an accurate determ ination of the wanted normalization constant. Therefore both g(r) and H (r) can be computed accuratly for all r's.

III. M ON TE CARLO SIM ULATIONS

The scenario of sec. II was scrupulously applied in our M C simulations which were performed within hyperspherical boundary conditions². For each pair of (;) a standard and a biased M C simulation was performed. The runs were divided in typically 20 sub-runs in order to compute the statistical errors by a method of blocks⁷. In the

prelim inary data reported here the considered system s involved N = 500 particles but a system atic study of nite size e ects is under way.

In the case of the OCP we chose for \overline{H} (r) the tof H (r) provided by O gata. However a small attractive potential \overline{H} (r) was added to \overline{H} (r) at short distances to enhance the sampling of g_v (r) at small r. The form of \overline{H} (r) is of course irrelevant, we retained a quadratic expression for convenience. In the case of the YOCP the bias function \overline{H} (r) at (; +) was chosen equal to the screening function H (r) obtained for the point (;).

To illustrate the method, we display in g. (1) a plot of the bias function H (r) and of the unnom alized g (r) at (= 40; = 1). As a result of the structure of the bias function H (r) at short distance g_w (r) exhibits a quite pronounced peak in this region. We show in g. (2) the logarithm of the ratio K (r) of the unnom alized g (r) by the properly nom alized g_0 (r) at the same point (= 40; = 1). As can be seen in the gure the normalization constant of g_u (r) can be obtained with a good accuracy by averaging K (r) for 1 < r=a < 2. The resulting function H (r) is displayed in g. (3) for r varying in the range 0 < r=a < 2. Note that in the region $f_{m-in} < r=a < 2$ where H (r) can be computed by a standard M C simulation it coincides alm ost perfectly with the H (r) computed by the biased scheme. In all cases the screening function can be accurately tted by the simple polynom ial $a_0 + a_2 (r=a)^2 + a_4 (r=a)^4 + a_6 (r=a)^6$ which traverses all the error bars.

In the case of the 0 CP, the theoretical value $a_2 = 1 = 4^{8 \{10\}}$ is roughly recovered although its num erical value seems to depend strongly upon the num ber of particles. For instance at = 40 one nds a = 0.234; 0.239; 0.249, and

0.25 for samples of respectively N = 500;1000;2000, and 3000 particles. A more system atic study of these nite volume e ects will be presented elsewhere. In the case of the OCP our results for H (r) dier by a smallbut signi cant amount of those of O gata (see g. (4)), but we have no m conclusion concerning these discrepancies. A bunch of H (r) for various is displayed in g. (5).

In the case of the YOCP the amplitude of the function H (r) at a given decreases steadily as increases as can be shown in g. (6) but the shape of the curves at short distances remains unchanged. A 6^{h} order even polynomial perfectly ts the numerical data in the range 0 < r=a < 2. A test of some theoretical predictions by Rosenfeld and Chabrier¹¹ concerning H (r) at small is planned for future work.




FIG.1. The bias function \overline{H} (r) (top curve, solid line) used at (= 40; = 1) to determ ine the function g_w (r) (bottom curve). The error bars on g_w (r) correspond to two standard deviations.




FIG.2. Logarithm of the ratio K (r) of the norm alized $g_0(r)$ (standard M C calculation) and the unnorm alized $g_u(r)$ (biased M C calculation) in the range r_m in < r < 2a at (= 40; = 1).




FIG.3. The screening function H (r) at (= 40; = 1) for a sample of N = 500 particles. The standard M C calculation allows only the determ ination of H (r) in the range $r_{m in} < r < 2a$ (curve on the right). The biased M C gives the curve in the range r < 2a. In the overlapping region the agreem ent between these two estimates is satisfactory. The solid curve is a 6th order even polynom ial of the M C data




FIG.4. The screening function H (r) for the OCP at = 40. Top curve: O gata result. Bottom curves: M C data for a sam ple of N = 500 ions (standard and biased simulations). The solid curve is a 6th order even polynom ial of the M C data.




FIG.5. The screening function H (r) for the OCP. From bottom to top = 1;2;10, and 100.




FIG.6. The screening function H (r) for the YOCP at = 40 and some values of . From top to bottom = 0;;0:2;0:4;0:6;0:3;1:;1:2;1:4;2; and 3.
