Di use waves in nonlinear disordered m edia⁰

I. IN TRODUCTION

The eld of multiple scattering of classical waves (electrom agnetic, acoustic and elastic waves, etc.) in disordered media has revived in the eighties [1] { [6], when the far-reaching analogies between the di use transport of waves and electrons in mesoscopic systems have been realized (see Ref. [7] for a comprehensive review of the latter issue). U sing classical waves to study such phenom ena as weak and strong localization, mesoscopic correlations and universal conductance uctuations (see Refs. [8]{ [10] for review s) appears to be advantageous in m any aspects: no need for low tem peratures and sm all sam ples, better control of the experim ental apparatus, possibility of more sensitive measurements, etc. In addition, experim ents with classical waves can be readily perform ed in the linear regime, excluding interaction between scattered waves and hence sim plifying the interpretation of experimental data, whereas the electron-electron interaction is always present in the realm of mesoscopic electronics and cannot simply be 'turned o ', introducing signi cant di culties in the theoreticalm odel [11].

The 'interaction' of classical waves, analogous in som e sense to the electron-electron interaction, can come about if the waves propagate in a nonlinear medium. Such an interaction is a matter of scienti c enquiry in the

elds of nonlinear optics [12], nonlinear acoustics [13], etc. Now adays, the latter are rapidly developing scienti c disciplines on their own right, having considerable fundam ental importance and num erous practical applications. Various nonlinear phenom ena (self-action: selfphase m odulation and self-focusing of pulses and beam s, harm onic generation, shock wave form ation, etc.) occur in hom ogeneous nonlinear media depending on the type and strength of the nonlinearity. The e ect of weak disorder on the propagation of nonlinear waves has also been studied both theoretically (treating it as a weak perturbation) and experimentally (e.g., for laser beam propagation through atm ospheric turbulence) [14]. Unfortunately, only few experiments [15] have been performed up to now on multiple, di use scattering of classical waves in nonlinear media. Theoretical analysis of the problem is more advanced (see the bibliography of Ref. [16]), but is still insu cient to stimulate further experimental e ort. M eanwhile, di use waves seem to be a good candidate for a detailed study of the combined e ect of disorder and nonlinearity (or interaction) on wave (or quantum particle) propagation, as compared to interacting electrons in disordered m esoscopic sam ples: the strength and the type of nonlinear wave 'interaction' can be readily controlled and the nonlinear term in the wave equation is often of sim ple algebraic form. D espite these in portant sim pli cations, di usion of classical waves in nonlinear m edia remains an involved problem and is far from being solved. The purpose of the present paper is to review our recent theoretical results [16]{[19] which are particularly susceptible to stim ulate the reader's interest, further theoretical analysis, and, hopefully, new experiments.

For the sake of concreteness, we restrict our consideration to the problem of self-action of a scalar monochromatic wave (frequency !) in a nonlinear disordered medium. This is described by the following wave equation:

where E (r;t) is the wave am plitude, c is the speed of the wave in the average medium, $J(r;t) = J_0(r) \exp((i!t))$ is a monochromatic source term, "(r) is the fractional

uctuation of the linear dielectric constant, and the nonlinear part of the dielectric constant "_{NL} (r;t) depends on the intensity I (r;t) = $f(r;t)^2$ of the wave. Eq. (1) describes, e.g., propagation of light in a medium with intensity-dependent refractive index and (as the reader m ight already have noted) we adopt the bptical' term inology from here on. Furtherm ore, we consider E in Eq. (1) to be a com plex quantity, thus neglecting the (possible) generation of the third harm onics, and restrict ourselves to a weak nonlinearity (see below for the de nition of weakness').

There are two fundam ental questions to consider concerning the propagation of waves in a disordered m edium with a weak nonlinearity. First, one can ask about the effect of nonlinearity on the phenom ena known for waves in linear disordered m edia. We partially answer this question in Sec. IV, where we sum marize the results of calculation of the angular correlation functions of scattered waves and the analysis of the coherent backscattering cone in a nonlinear disordered m edium. The second question is more challenging: can the weak nonlinearity give rise to new physical phenom ena which are not present in the linear m edium ? The answer to the latter question is yes' as we dem onstrate in Sec.V where the instability of

di use, multiple-scattered waves in a disordered medium with a weak nonlinearity is considered. In order to facilitate the presentation of our main results, we start by a very brief review of principal results known for waves in linear disordered (Sec. II) and hom ogeneous nonlinear (Sec. III) media.

II. WAVES IN LINEAR DISORDERED MEDIA

W aves propagating in a linear disordered m edium are described by Eq. (1) with $"_{NL}(r;t) = 0$. Despite its linearity, this problem is a rather involved one and it attracts a lot of attention (see, e.g., the articles in the present book and Refs. [9] and [10]). In what follows, we are interested uniquely in the di usion regime of wave propagation that is realized for k_0 ' 1, where $k_0 = ! = c$ and ' is the mean free path due to disorder. To sim plify still further the consideration, we assume that the correlation length of "(r) is much shorter than the wavelength and adopt the model of the Gaussian white-noise disorder: h "(r) "(\underline{r}) $\underline{i} = 4 = (k_0^4)$ (r \underline{r}), so that the scattering and the transport mean free paths coincide. Besides, we consider a disordered medium without absorption (i.e. both " and " $_{\rm N\,L}$ are real), except if the opposite is speci ed explicitly. In the regions of space located at distances greater than ' from the sources of waves and the boundaries of the sample, the average intensity hI (r) i then obeys a di usion equation [20]:

where D = c'=3 is the di usion constant and S (r;t) is the source term. In the following, we assume a timeindependent source term in Eq. (2): S (r;t) = S (r), yielding I (r;t) = I (r).

The average intensity hI (r)igiven by Eq. (2) is not sufcient to describe the intensity I (r) of the wave, since the latter exhibits large uctuations: I (r) = I (r) hI (r)i hI (r)i [2, 20]. The spatial correlation function of I (r;t) contains a short-range (r < `) but strong (1) contribution [2]:

where r = r r, I_0 is a typical value of hI (r)i, G (r; r_1) is the G reen's function of Eq. (2) with (@=@t) = 0, and the last expression in Eq. (4) is obtained assuming that G (r; r_1) is equal to its value in the in nite medium:

The short-range contribution to the intensity correlation function (3) describes the speckle structure of the spatial intensity distribution in disordered m edia, while the long-range contribution (4) testi es that di erent speckle spots are cor-1). The correlation funcrelated (weakly, since k_0 ' tions given by Eqs. (3) and (4) are commonly referred to as C⁽¹⁾ and C⁽²⁾, respectively. 0 ther contributions to the intensity correlation function can exist: C⁽³⁾ is a factor (k₀ ') ² 1 sm aller than C $^{(2)}$ [9] and C $^{(0)}$ (k₀)¹ is non-vanishing only if the source of waves has the size sm aller or of the order of the wavelength [21]. W e do not consider the two latter contributions here.

Short-and long-range correlation functions of the eld and intensity uctuations can be also de ned in the angular dom ain. For our purposes, it will be su cient to consider only the short-range correlations C⁽¹⁾. If a plane wave is incident on a disordered slab of thickness L (slab surfaces being perpendicular to the z-axis) with a wave vector $k_a = fq_a; k_{az}g$, where $q_a = fk_{ax}; k_{ay}g$, the eld (intensity) of the wave transm itted through the slab with a wave vector k_b is E $(k_a; k_b)$ [I $(k_a; k_b) =$ $E (k_a; k_b)j^2$]. If the above experiment is repeated for di erent incoming and outgoing wave vectors k_a^0 and k_b^0 , respectively, the norm alized correlation function of scattered elds

appears to have a rather sim ple form [8]:

The eld correlation in re ection, when both incident and scattered waves are on the same side of the slab, is [8,17]

1 is the extrapolation factor (= 2=3 in the di usion approximation), q' 1, and the sem i-in nite disordered medium is considered. The short-range correlation function of intensity uctuations, $C^{(1)}$, in transmission (re ection) geometry is obtained by taking the square of the absolute value of Eq. (6) Eq. (7)].

F inally, a well-studied phenom enon in the linear disordered medium is the coherent backscattering [1], consisting in a two-fold (with respect to the incoherent, di use background) enhancem ent of the average scattered intensity in the direction of exact backscattering ($k_{\rm b} = k_{\rm a}$). For norm al incidence ($q_{\rm a} = 0$), the angular line shape of the coherent backscattering cone can be approximately expressed using the function F_R de ned in Eq. (8):

III. WAVES IN HOMOGENEOUS NONLINEAR M E D IA

If "(r;t) = 0, Eq. (1) describes the propagation of waves in a hom ogeneous nonlinear medium (no scattering) with an intensity-dependent dielectric constant [12]. Below we consider the case of Kerr nonlinearity. If the nonlinear response of the medium is instantaneous and local, the dependence of $"_{NL}(r;t)$ on I(r;t) is rather simple: $"_{NL}(r;t) = "_2I(r;t)$, where $"_2$ is a nonlinear coe cient. In general, how ever, the nonlinear response is not instantaneous and can be modeled by a phenom enological equation of D ebye type for $"_{NL}$:

where $_{\rm N\,L}$ is the response time of the nonlinearity. M oreover, the non-locality of the nonlinear response of the medium can be taken into account by considering "NL (r;t) obeying an equation of di usion type:

where a_{NL} is some characteristic length, describing the degree of non-locality of the nonlinear response.

The physics of nonlinear optical phenomena in Kerr media is rather rich [12] and it is not our purpose to review it here. In the fram ework of our study, we would like, however, to call the attention of the reader to the following two simple but illustrative examples. First, if a nonlinear K err m edium, illum inated by a m onochromatic plane wave of intensity I_0 , is put in an optical resonator, the feedback provided by the resonator leads to the instability of the steady-state solution E(r;t) = E_0 (r) exp(i!t) and the intensity $I = \frac{1}{2} \int dt$ of the wave develops a time dependence [22]. This phenom enon occurs only at I_0 exceeding some threshold and the dynam ics of I (r;t) becom es progressively m ore com plex as Io increases. The second example concerns two counterpropagating light waves in a Kerr medium. Again, the steady-state solution develops an instability for the intensities of the waves exceeding a threshold [23]. The above simple examples suggest that the unstable regimes are fundam ental in nonlinear optics and this appears to be indeed true: instabilities, self-oscillations, pattern form ation, and spatio-tem poral chaos are observable in m any

nonlinear optical system s (see, e.g., Refs. [24] { [26] for review s). Even incoherent light beam s have been recently shown to exhibit pattern formation and optical turbulence' due to the so-called modulation instability [27], indicating that unstable behavior does not require the perfect coherence of the underlying wave eld.

IV. ANGULAR CORRELATIONS AND COHERENT BACKSCATTERING FOR WAVES IN NONLINEAR DISORDERED MEDIA

A fter having brie y reviewed the key features of wave propagation in linear disordered and hom ogeneous nonlinear media, we are now in a position to attack the central problem of the present paper: di use wave propagation in nonlinear disordered media. A particularly pictorial description of the latter can be developed if the nonlinearity is assumed to be weak enough to have no signi cante ect on the general di use character of wave propagation in the medium and the values of the di usion constant D and the mean free path '. This requires the honlinear scattering length' 'NL due to the nonlinear term in Eq. (1) to be much larger than '. $'_{\rm NL}$ can be estimated by assuming the short-range intensity correlation function in a nonlinear disordered medium to be approximately the same is in the linear one [see Eq. (3)]. Calculating the total scattering crossection of statistically isotropic uctuations of the nonlinear dielectric constant " $_2$ I (r) in the Born approximation, we obtain

and hence `_{NL} $(n^2k_0)^1$, where $n = n_2I_0$ is the typical value of the nonlinear correction to the refractive index, $n_2 = "_2=2$, and I_0 is the typical value of hI (r;t)i. The condition of weak nonlinearity, ` $N_{\rm NL}$, then becom es

where, we recall, k_0 ' 1. We adopt this condition throughout the rest of the paper.

W e start the analysis of the e ect of nonlinearity on multiple scattering of waves in disordered media by considering the angular correlation of scattered wave elds, $C_{aba^0b^0}$, as de ned in Eq. (5) (Sec. II), assuming the two incident waves to have di erent am plitudes (A for the wave with the wave vector k_a and A^0 for the wave with the wave vector k_a^0). Due to the nonlinearity of the medium, $C_{aba^0b^0}$ will now depend not only on k_a , k_a^0 , $k_{\rm b},$ and $k_{\rm b}^0,$ but also on A and A $^0.$ For simplicity, we put A^0 ! 0 (so that the e ect of the nonlinearity on the propagation of the second wave is negligible) and lim it

ourselves to the case of instantaneous ($_{NL} = 0$) local ($a_{NL} = 0$) nonlinearity.

The physical origin of the nonlinearity-induced modi-

cation of $C_{aba^0b^0}$ can be easily understood in the fram ework of the path-integral picture of wave propagation. The wave of am plitude A, propagating along som e wave path of length s through a nonlinear disordered m edium, acquires an additional, honlinear' phase shift $_{NL}$ with respect to the wave of am plitude A⁰! 0, propagating in an essentially linear m edium :

where we assume hI(r_1)i A^2 . In a linear medium, a similar phase di erence arises between two waves at di erent frequencies ! ϵ !⁰:

The form al analogy between Eqs. (16) and (17) suggests that as long as the nonlinearity a ects only the phase of the wave and not its am plitude (i.e. for a weak nonlinearity), the correlation function $C_{aba^0b^0}$ in a non-linear disordered medium should be approximately given by Eq. (18), where ! is replaced by $!n_2A^2$. This is indeed con med by a perturbative diagram matic calculation [17] [see the diagram of F ig. 1(a)], that allows one to obtain the lowest term in the series expansion of $C_{aba^0b^0}$ in n_2A^2 1. Applying then a hatural' ansatz f (x) $[i^2=(2x)]f^0(x)' f[(x^2 i^2)^{1=2}]$ yields [17]:

Here n $n_2 A^2$ is the typical value of the nonlinear part of the refractive index. The physical meaning of

is clear: it is the characteristic length for the loss of phase coherence between two waves following the same di usion path, one with a vanishing amplitude A^0 ! 0 and the other one with a nite amplitude A.By analogy with the case of frequency correlation [Eq.(18)], NL can be de ned as NL = 1= . The short-range correlation

function of intensity uctuations, $C_T^{(1)}$, can be obtained by taking a square of the absolute value of Eq. (19). We show this correlation function in Fig.1(b).

Similarly to the case of transmission geometry, correlation between di usely relected waves can also be calculated taking into account the additional dephasing due to the nonlinearity of the medium. A gain, assuming that the two incident waves have dierent amplitudes A and A^{0} ! 0, one inds for a semi-in nite disordered medium [17]

This result is to be compared to the linear' result (7). In Fig.2(a) we show the experimentally accessible short-range correlation function of intensity uctuations, $C_R^{(1)}$, obtained by taking a square of the absolute value of Eq. (21). Just as in a linear medium, two peaks occur at $q_a = 0$ and $q_a + q_b + q_a = 0$, respectively.

F inally, the coherent backscattering cone can be calculated at the same level of approximation [17]. If the

nonlinear coe cient " $_2$ in Eq. (1) is purely real, no deviation from the linear result (9) is found within the present theoretical fram ework. The contribution of the crossed diagram s to the intensity of backscattered wave is, how - ever, m odi ed if " $_2$ has a sm all imaginary part (i.e. in the presence of nonlinear absorption). This phenom enon can be described by introducing a generalized absorption length L_{a}^{NL} , accounting for both linear and nonlinear absorption:

A dditional absorption, introduced by the nonlinear term in Eq. (1), will lead to the rounding of the triangular peak shape of the coherent backscattering cone, as illustrated in Fig. 2 (b). M athem atically, this phenom enon is described by Eq. (9) with L_a replaced by L_a^{NL} .

To conclude this section, we would like to emphasize that in calculating the angular correlation functions [Eqs. (19), (21) and Figs.1(b), 2(a)] and the coherent backscattering cone [Fig.2(b)], we have completely neglected the uctuations of the wave intensity inside the disordered medium, replacing I(r) by hI(r)i $A^2 = const$ in the

very beginning Eq. (16)]. The intensity uctuations in disordered media are, however, known to be important and exhibit some nontrivial features [such as, e.g., longrange correlations, see Eq. (4)]. It is therefore important to analyze the role of these uctuations in the presence of nonlinearity, when the highly irregular spatial intensity distribution (speckle pattern) can give rise to a random modi cation of the dielectric constant (and, consequently, refractive index). Such an analysis is presented in the following section.

V. IN STABILITY OF DIFFUSE WAVES IN NONLINEAR DISORDERED MEDIA

A swe already mentioned in Sec. III, unstable regimes are encountered in many nonlinear optical systems. It is therefore natural to expect that they may appear in a disordered nonlinear medium as well. The origin of the instability in this case is relatively easy to understand in the framework of the path-integral picture of wave propagation [16].

A. Heuristic description

In the path-integral picture, the di usely scattered eld at some position r inside the disordered wave medium is represented as a sum of partial waves traveling along various di use paths. Due to the nonlinearity of the medium, the phase (r;t) of a given partial wave arriving at r at time t depends on the spatio-tem poral distribution of intensity I(r;t) (speckle pattern) inside the medium. At the same time, I (r;t) is a result of interference of m any partial waves, and, therefore, I (r;t) is sensitive to their phases (r;t). This leads to a sort of feedback m echanism : The phases of partial waves depend on the speckle pattern I (r;t), while the latter depends on the phases. It appears that such a feedback can destabilize the tim e-independent speckle pattern I (r), leading to I (r;t) that uctuates spontaneously with time, if the nonlinearity is strong enough [16]. As we show below, this phenom enon can be understood in reasonably sim ple term s in the case of local ($a_{NL} = 0$) and instantaneous $(_{NL} = 0)$ K err nonlinearity.

Consider a partial wave traveling along a typical di use path of length s_0 (t) $L^2 = `$ from the source of waves to some point r located at a distance L from the source. We assume that the path length s_0 (t) can vary slow ly with time due to, e.g., the motion of scattering centers [corresponding to a time-dependent disorder "(r;t) in Eq. (1)], while the initial and nalpoints of the path are

xed. The variations of \mathfrak{g} with time are assumed to be slow (i.e. \mathfrak{s}_0 does not change signi cantly during the time $T_D = L^2 = D$ required for the wave to cover the distance of order \mathfrak{s}_0). The phase (r;t) of the wave contains a linear' contribution $L(r;t) = k_0 s_0(t)$ and the honlinear one

where $"_{NL}(r_1;t_1)=2 = n_2 I(r_1;t_1)$ is the nonlinear part of the refractive index, s_1 is a curvilinear coordinate of the point r_1 along the path, $t_1 = t$ [3] (t) $q \models c$ is the time of wave passage through r_1 , and the integrals are along the path.

As we discussed in Sec. II, the correlation function of intensity uctuations h I (r) I (r₂) i in Eq. (27) contains two contributions: a short-range one Eq. (3)] and a long-range one Eq. (4)]. To perform the integration in Eq. (27), we replace $r = jr_1$ $r_2 j$ in the expression (3) for the short-range correlation function by s, assuming the wave path to be ballistic at distances shorter than '. In contrast, for r >' the wave path is di usive, and hence r in the expression (4) for the long-range correlation function can be substituted by (s')¹⁼². Performing then integrations in Eq. (27) yields

Note that Eq. (29) is a sum of two contributions. The rst one, $rf (L=')^2 k_0$ ', originates from the short-range correlation of intensity uctuations [Eq. (3)], while the second contribution, $n^2 (L=')^3$, is due to the long-range correlation Eq. (4)]. If p 1, the nonlinear term $^{2}_{\rm NL}$ represents just a small correction to the lin-²_L and our perturbation approach is likely ear one to be valid. In contrast, the above perturbation theory diverges for p > 1, since \sum_{NL}^{2} becomes larger than $^2_{\rm L}$. This suggests that p ' 1 is a critical point beyond which (i.e. for p > 1) the physics of the nonlinear problem is no longer similar to the physics of the linear one and hence the perturbation theory cannot be used. A lthough the mere breakdown of the perturbation theory does not perm it to draw any far-reaching conclusions about the speckle pattern beyond the critical point p' 1, a more rigorous analysis (see Secs. V B and V C) shows that p' 1 de nes the instability threshold of the multiple-scattering speckle pattern, and that at p > 1the latter should exhibit spontaneous tem poral uctuations even for a time-independent disorder "(r) (i.e. for vanishing mobility of scattering centers: D_B ! 0 and $_0$! 1 in the case of B row nian m otion).

It is pertinent to note the extensive nature of the bifurcation param eterp. A coording to Eq. (29), weak nonlinearity can be e ciently compensated by a su ciently large sample size L and p 1 can be reached even at vanishing n, provided that L is large enough. In the lim it $k_0 v^2$, one gets p ' $n^2 (L=')^3$ of large sam ple size L (as also found in Ref. [28]). This result is due to the long-range correlation (4) of intensity uctuations which dom inates in the integral of Eq. (27) because of its slow decrease ($/ jr_1 r_j^1$) and consequent extension over the whole disordered sample. Another remarkable feature of Eq. (29) is the independence of p of the sign of n. The phenom enon of the speckle pattern instability is therefore expected to develop in a similar way for both positive and negative nonlinear coe cients n_2 . This is not common for the instabilities in nonlinear systems

without disorder [22] { [27] since the latter are often related to the self-focusing e ect, arising at $n_2 > 0$ only. The instability discussed in the present paper is of different type and has nothing to do with the self-focusing [which is negligible if the condition (14) is satis ed]. This does not m ean, how ever, that the phenom ena sim ilar to those discussed in the present paper do not exist in homogeneous nonlinear media. In fact, it is easy to see that Eq. (23) describes nothing but the self-phase modulation [12] of the multiple-scattering speckle pattern. It is worth noting that the developm ent of the self-phase m odulation in a disordered m edium appears to be rather di erent from that in the hom ogeneous case. Indeed, in a hom ogeneous medium of size L the nonlinear phase shift is determ inistic and $NL = k_0 n_2 I_0 L$ for a wave of intensity I₀, while in the case of di usem ultiple scattering NL is random with the average value $h_{NL}i' k_0 n_2 I_0 (L^2=')$ $h_{NL}i^2$ ' p. The threshold of the 2 N L and variance speckle pattern instability p' 1 is then simply the point where the sam ple-to-sam ple uctuations of the nonlinear phase shift become of order unity.

To conclude this subsection, we would like to comment on the recent results on modulation instability (MI) of incoherent light beams in hom ogeneous nonlinear media [27]. In this case, a 2D speckle pattern (speckled beam) with a controlled degree of spatial and tem poral coherence is prepared by sending a coherent laser beam on a rotating di user. The beam is then incident on a hom ogeneous nonlinear medium (inorganic photorefractive crystal). Pattern form ation and 'optical turbulence' is observed if the intensity of the beam exceeds a speci c threshold, determ ined by the degree of coherence of the beam (coherent M I has no threshold). A lthough the study presented in this paper is also concerned with the instability of speckle patterns in nonlinear media, it di ers essentially from that of R ef. [27] at least in the follow ing important aspects: (a) the initially coherent wave loses its spatial coherence inside the medium, due to the multiple scattering on heterogeneities of the refractive index, (b) the tem poral coherence of the incident light is perfect (in the case of incoherent M I [27], the coherence time of the incident beam is much shorter than the response time of the medium $_{\rm N\,L}$), and (c) the incident light beam is completely destroyed by the scattering after a distance 'and light propagation is di usive in the bulk of the sample. In addition, di use multiple scattering of light results in a distributed feedback mechanism, absent in the case of M I.

B. Path-Integral Picture

A mathematically rigorous formulation of the heuristic analysis presented in the previous subsection has been performed in Ref. [16]. In addition to the condition of weak nonlinearity (14) we anticipate that the expected spontaneous uctuations of the speckle pattern beyond the instability threshold will be slow enough or, more

precisely, that the typical time of the speckle pattern dynam ics will be much longer than the typical time between two successive scattering events '=c.

For the sake of the mathematical sim plicity, we consider a plane monochrom atic wave incident on the stationary ["(r) is time-independent] sem i-in nite disordered medium (L! 1) with a nite (macroscopic) absorption length L_a ' and a local ($a_{\rm NL} = 0$) instantaneous ($_{NL} = 0$) Kerr nonlinearity. It appears that instead of replacing the intensity correlation function h I(n;t) I(n;t+ t) i in Eq. (25) by its linear' value (and thus constructing a sort of perturbation theory), one can obtain a self-consistent description of the speckle instability. The analysis [16] leads to a self-consistent equation for $E_{\rm E}$ = lnq, where $g_1() = hE(t)E(t+)i = \frac{1}{2}E(t)j^2$ is the time autocorrelation function of di usely re ected wave, and g denotes $\lim_{l \to 1} g_1()$:

where F () is a known monotonically decaying function and F (0) = 1.

Fig. 3(a) illustrates the graphical solution of Eq. (30)for som e realistic values of param eters. At strong enough absorption [two upper curves in Fig. 3 (a)], a unique solution = $_1 = 0$ exists, corresponding to $g_1 = \exp($) = 1. This means that the time autocorrelation function of di usely re ected wave g() does not decay with time, remaining equal to 1 for all (even for ! 1). The speckle pattern is therefore stationary (i.e. does not change with time). In contrast, for weak absorption [three lower curves in Fig. 3(a)] a second solution $= _{2} > 0$ arises, corresponding to $g_{1} = \exp($) < 1. Eq. (30) now has two xed points: = 1 = 0 and = $_2 > 0$. It is seen from Fig. 3(a) (see thick solid

lines with arrows) that an iterative solution of Eq. (30) starting at some > 0 converges to = 1 = 0 for strong enough absorption and to $= _2 > 0$ for weak absorption. = $_2 > 0$ is therefore a stationary point of Eq. (30) in the latter case, corresponding to the physically realizable solution beyond the instability threshold.

> 0 and $q_1 < 1$ signi es that the time autocorrelation function of di usely re ected wave g() decays with despite our assumption of stationary disorder [tim eindependent "(r)], although the present analysis does not allow us to estim ate the characteristic time scale of this decrease. Decaying g_1 () corresponds to an unstable (i.e. tim e-varying) speckle pattern. Note that in contrast to the uctuations of the speckle pattern due to the motion of scattering centers, employed in DWS to study the dynamics of the medium [5], the speckle dynamics in a stationary nonlinear random medium is spontaneous, i.e. it does not originate from the motion of scattering centers (since the latter are in m obile) but is intrinsic for the underlying nonlinear wave equation (1). Spontaneous speckle dynamics is irreversible and hence the instability threshold p' 1 is the point where the tim e-reversal sym m etry is spontaneously broken for the multiple-scattered waves.

Fig. 3 (b) shows the time autocorrelation function $g_1 =$ exp() obtained by solving Eq. (30) at k_0 ' = 100 and several values of '=La. The transition from the stable $(g_1 = 1)$ to unstable $(g_1 < 1)$ regime is clearly seen when $'=L_a > 0$. At $'=L_a = 0$ (no absorption), we determine that g1 < 1 at any, even in nitely small j nj. The border between stable $(q_1 = 1)$ and unstable $(q_1 < 1)$ regimes can be found analytically by requiring (Q=Q)F()1 at = 0. This yields p' 1 as the instability threshold, where the bifurcation parameter p is de ned by Eq. (29) with L replaced by La. The threshold values of j nj following from the condition p = 1 are shown in Fig. 3(b) by arrows.

C. Langevin Description

A lthough the path-integral approach, sketched in the two previous subsections, allow s us to predict the instability of the multiple-scattering speckle pattern in a nonlinear disordered medium and even to calculate q_1 () in the lim it ! 1, it does not perm it to estim ate the time scale of spontaneous intensity uctuations beyond the instability threshold. M eanwhile, this issue is of primary im portance in view of the possible experim ental observation of the instability phenomenon. In this subsection, we show that the spontaneous speckle dynam ics can be studied by using the Langevin approach [18, 19].

As in the previous subsections, we assume the nonlinearity to be local $(a_{NL} = 0)$, but consider arbitrary nonlinearity response time $_{\rm N\,L}$. The nonlinear part of the dielectric constant is assumed to be governed by Eq. (10). In addition, we neglect the absorption (assuming La L) and restrict our consideration to the case when

the developm ent of the speckle pattern instability is dom inated by the long-range intensity correlations. This requires the sample size to be large enough [L $k_0 ^{2}$, see Eq. (29) and its accompanying discussion] and the speckle dynamics to be slow (time scale of spontaneous $\frac{1}{2}$ [(k₀²)=L]²). The latter intensity uctuations condition follows from Eq. (27), where the lim its of integration over s should be set to c, if c \$ (or, T_D), since the correlation has simply equivalently, no time to establish beyond these limits due to the nite speed of wave propagation. Integration in Eq. (27) then vields

where the set term in square brackets the same as in Eq. (29)] results from the short-range correlation (3), while the second term is due to the long-range one (4). Requiring that the second term dom inates the rst, we obtain $T_D [(k_0 \sqrt{2})=L]^2$ as stated above.

The Langevin equation for the intensity uctuation I(r;t) reads [4]:

Being a ' ngerprint' of disorder, the Langevin currents will be modi ed if we modify the dielectric constant of the medium. In our case, the linear part of the dielectric constant is xed ["(r) in Eq. (1) is timeindependent], but its nonlinear part "NL (r;t) can vary with time, and it is relatively easy to obtain the following dynam ic equation for j_{ext} (r;t) [18, 19]:

where $q(r; r^0; t)$ is a random response function with zero mean and the correlation function $q^{(i)}(r;r^{0}; t)q^{(j)}(r_{1};r_{1}^{0}; t_{1})$ given by a sum of the diagrams (ii) and (iii) of Fig. 4 (a). Eqs. (32) and (33) together with Eq. (10) for " $_{\rm N\,L}$ form a self-consistent system of equations for the stability analysis of the speckle pattern.

Considernow an in nitesim alperiodic excitation of the stationary speckle pattern: $I(r;t) = I(r;) \exp(t)$, where $= i + \frac{1}{2} 0$ and > 0. Such an excitation can be either dam ped or am pli ed, depending on the sign of the Lyapunov exponent . The value of is determined by two competing processes: on the one hand, di usion tends to smear the excitation out, while on the other

hand, the distributed feedback sustains its existence. The m athem atical description of this competition is provided by Eqs. (32), (33), and (10) that after the substitution of I(r;t) = I(r;) exp(i t) [and sim ilarly for $\frac{1}{g_{xt}}$ (r;t) and "_{NL}(r;t)] lead to the following equation for p, , and [18, 19]:

where $_{D} = 1=T_{D} = D = L^{2}$ and the function F_{1} is shown in Fig. 4(b) for the case of the sample with open boundaries, while $F_{2}(x;y) = 1 + x^{2} + y^{2} + 2y$.

Let us rst consider the fast nonlinearity, assum ing _{NLD} 1 [18]. In this case, the nonlinear response takes much less time than the typical perturbation I (r;) needs to extend throughout the disordered sample and we can set F_2 (_{NL}; _{NL}) ' 1 in Eq. (34). The stability of the speckle pattern with respect to periodic excitations is then described by Fig. 4(b). For a given frequency , the sign of the Lyapunov exponent depends on the value of p. Excitations at frequencies corresponding to < 0 are dam ped exponentially and thus soon disappear. In contrast, excitations at frequencorresponding to > 0 are exponentially am plicies ed, which signi es the instability of the speckle pattern with respect to excitations at such frequencies. Noting is always negative for p < 1, we conclude that that all excitation are damped in this case and the speckle pattern is absolutely stable. In an experiment, any spontaneous excitation of the static speckle pattern will be suppressed and the speckle pattern will be independent of time: I(r;t) = I(r), as in the linear case. When p > 1, an interval of frequencies $0 < < m_{ax}$ starts to open

up with > 0. The speckle pattern thus becomes unstable with respect to excitations at low frequencies. In an experiment, any spontaneous excitation of the static speckle pattern at frequency 2 (0; $_{max}$) will be am – pli ed and one will observe a time-varying speckle pattern I (r;t). Note that the absolute instability threshold p' 1 agrees with the results of Secs. V A and V B, while completely di erent calculation techniques have been applied in the three cases.

Fig. 5(a) shows the frequency-dependent instability threshold for the disordered sample with open boundaries and fast nonlinear response. Detailed analysis [18] of Eq. (34) shows that the frequency-dependent threshold value of p scales as $1 + C_1 (=_D)^2$ (where C_1 1 is $_{\rm D}$ and as (= $_{\rm D}$) $^{1=2}$ at a num erical constant) at $_{\rm D}$. The latter result can also be obtained from Eq. (31) by setting 1= and applying $^{2}_{\rm NL}$ > as the instability condition. For a given value of p > 1, $1)^{1=2}$ the maximum excited frequency is max D (p forp 1 1 and max $_{\rm D} p^2$ for p 1 > 1.

Fig.5(b) illustrates the e ect of noninstantaneous nonlinearity on the frequency-dependent instability threshold for several values of $_{\rm N\,L}$ $_{\rm D}$ [19]. Obviously, slow nonlinear response of the medium rises the instability threshold for high-frequency excitations, while the absolute instability threshold p ' 1 remains the same, independent of the nonlinearity response time NL. The reason for this is that just above p = 1 the speckle pattern becom es unstable with respect to excitations at very low frequencies, for which $1 = _{NL}$ is always fulled and which, therefore, are not sensitive to the value of $_{\rm N\,L}$ [m athem atically, F₂ ($_{\rm N\,L}$; $_{\rm N\,L}$) ' 1 in Eq. (34)]. In the limit of slow nonlinearity ($_{\rm N\,L}$ $_{\rm D}$ $\,$ 1) and for 1 < p 1 1 we can set F_1 (= $_D$; = $_D$) ' 1 in Eq. (34) and nd the threshold value of p to scale as _{NL} (р 1+ ($_{\rm NL}$)² and $_{\rm max}$ 1)¹⁼².

As follows from the above analysis, a continuous low – frequency spectrum of frequencies (0; $_{m ax}$) is excited at p > 1. In addition, the Lyapunov exponent appears to

decrease m onotonically with , favoring no speci c frequency just above the threshold [19]. This allow sus to hypothesize that at p = 1 the speckle pattern undergoes a transition from a stationary to chaotic state. Such a behavior should be contrasted from the 'route to chaos' through a sequence of bifurcations, characteristic of m any nonlinear and, in particular, optical system s [22] [26].

VI. CONCLUSION

The present paper reviews some of the recent theoretical developm ents in the eld of multiple wave scattering in nonlinear disordered media. To be speci c, we consider optical waves and restrict ourselves to the case of K err nonlinearity. A ssum ing that the nonlinearity is weak, we derive the expressions for the angular correlation functions and the coherent backscattering cone in a nonlinear disordered m edium (Sec. IV). In both transm ission and re ection, the short-range angular correlation functions of intensity uctuations for two waves with di erent am plitudes (A and A^0 ! 0) appear to be given by the same expressions [Eqs. (6) and (7), respectively] as the angular correlation functions for waves at two di erent frequencies (! and $!^0 = !$!) in a linear medium, with ! replaced by $2 c = (3^{2})$, where is a new nonlinear characteristic length de ned by Eq. (20). The coherent backscattering cone is not a ected by the nonlinearity, as long as the nonlinear coe cient " $_2$ in Eq. (1) is purely real. If "2 has an imaginary part (which corresponds to the nonlinear absorption), the line shape of the cone is given by the same expression (9) as in an absorbing linear m edium, where the linear m acroscopic absorption length La should be replaced by the generalized absorption length L_a^{NL} de ned by Eq. (22).

For the nonlinearity strength exceeding a threshold p ' 1 [with the bifurcation parameter p given by Eq. (29)], we predict a new phenomenon | tem poral instability of them ultiple-scattering speckle pattern | to take place (Sec. V). The instability is due to a combined effect of the nonlinear self-phase modulation and the distributed feedback mechanism provided by multiple scattering and should manifest itself in spontaneous uctuations of the speckle pattern with time. Since the spontaneous dynamics of the speckle pattern is inteversible, the time-reversal symmetry is spontaneously broken when p surpasses 1. The important feature of our result is the extensive nature of the instability threshold, leading to an interesting possibility of obtaining unstable regimes even at very weak nonlinearities, provided that the disordered sample is large enough. To study the dynam ics of multiple-scattering speckle patterns beyond the instability threshold, we generalize the Langevin description of wave di usion in disordered media (Sec. V C). Explicit expressions for the characteristic time scale of spontaneous intensity uctuations are derived with account for the noninstantaneous nature of the nonlinearity. The results of this study allow us to hypothesize that the dynam ics of the speckle pattern m ay become chaotic im m ediately beyond the instability threshold, and that the cascade of bifurcations, typical for chaotic transitions in m any known nonlinear system s [22]{[26], m ight not be present in the considered case of di use waves.

F inally, we discuss the experim ental im plications of our results. W ith common nonlinearm aterials, such as, e.g., carbon disul de, n_2 ' 3 10¹⁴ cm²/W can be realized [12]. At I ' 1 MW / cm² this yields n ' 3 10^8 and the characteristic length de ned in Eq. (20) is '2 cm for '' 100 m and ' 0:5 m.Asfollowsfrom Eq.(19), . L is required to observe a sizeable e ect of the non linearity on the angular correlation function of transmitted light, and hence using a 2 cm -thick disordered sample should su ce to make the e ect of nonlinearity measurable in, e.g., a dense suspension of carbon disul de particles. In contrast, . ' is necessary to observe the e ect of the nonlinearity on the angular correlation function in the re ection geometry. This requires a stronger nonlinearity. In nem atic liquid crystals, for example, n up to 0:1 is achievable (see, e.g., Ref. [29]). Taking $n = 10^{-3}$ and ` 1 mm [30], we get 1 m m '. In the case of the coherent backscattering cone, very accurate experim ental techniques developed recently to m easure the angular dependence of backscattered light [31] give a hope that the e ect of the nonlinearity can be observable without any particular problem . Finally, observation of the tem poral instability of multiple-scattering speckle pattems, predicted in Sec. V, will require, st of all, large enough sample size L and as low absorption as possible. In the absence of absorption (or for the macroscopic 10² (realistic in absorption length $L_a \& L$), n_{NL} nem atic liquid crystals [29]) and L=' 20 will su ce to get p' 1 and reach the instability threshold. We note that in liquid crystals, the nonlinearity is due to the reorientation of molecules under the in uence of the electric

eld of the electrom agnetic wave and hence is essentially noninstantaneous. This emphasizes the importance of including the noninstantaneous nature of nonlinear response in our analysis (Sec.VC).
