# R elevance of m any-body interactions for correlated electrons in the strong-coupling lim it

M any-body interactions in e ective eld theories for disordered interacting electrons are considered. It is shown that three-body and higher interaction terms are generated in perturbation theory, and some of the physical consequences of these interactions are discussed. It is shown in particular that they will in general be important for any e ects governed by strong-coupling xed points. This im plies that the usual generalized nonlinear sigm a-m odel for disordered electron systems is incom plete, and not suitable for studying strong-coupling e ects.

#### I. IN TRODUCTION

E ective eld theories are a very useful tool, both in statistical mechanics and in particle physics.<sup>1</sup> The basic idea is to construct an \e ective" theory, valid at large length scales and long times, which contains only those degrees that are in portant in this regime, while all others have been integrated out. Since the e ective theory is simpler than the underlying fundam ental theory that contains all degrees of freedom explicitly, it is easier to solve. If the fundam ental theory is known, as is the case in condensed m atter physics, e ective theories can be derived from it. If it is not known, as in particle physics, the e ective theory can be guessed with feedback from experiments. In either case the elective theory in general contains features that are not present in the fundam entalorm icroscopic theory. For instance, interaction events between particles that are sequential occurences of fundam ental interactions on m icroscopic scales will appear as basic interactions on the coarse-grained length and time scales of the e ective theory. An example from particle physics is the Ferm i theory of beta decay, which assumed a point-like interaction between the particles involved.<sup>2</sup> Later, in more microscopic theories of the weak interaction, it became clear that there is internal structure in Ferm i's interaction related to the exchange of gauge bosons.<sup>3</sup>

In condensed m atter physics, the only interaction in the m icroscopic theory is the C oulom b interaction. W e will be concerned with electron-electron interactions in disordered m etals, and therefore we take the \fundam ental" interaction to be the screened C oulom b interaction. Let us consider processes in which two electrons interact at some point in space and time, and some time later a third electron interacts with one of the two some distance away from the rst interaction point. In an e ective theory that has integrated out the behavior at short length and time scales, such a process will appear as a

\fundam ental" interaction between three electrons, since the e ective theory can no longer resolve the individual m icroscopic interaction processes. In classical statistical mechanics the importance of such e ective many-body interactions is well known. An example is the expansion of transport coe cients in powers of the particle number density. To obtain the contribution at any given (su ciently high) order in the density one needs to consider collisions between arbitrarily many particles.<sup>4</sup> A nalogous e ects have been considered for many-electron system s,<sup>5</sup> although the connection with e ective many-body interactions was not made explicit. Furthermore, the construction of a complete e ective theory requires that any m any-body interactions that are generated in perturbation theory be included in further iterations of the renormalization process that integrates out the short-range degrees of freedom . This has never been done; existing e ective theories for disordered many-electron systems contain two-body interactions only.6

In the present paper, we show explicitly that manybody interactions in such systems are generated under renorm alization. The many-body interactions generated are of long range in space and time due to the di usive electron dynamics. As a consequence of their long-range nature, the naive renorm alization-group (RG) scale dimensions of these terms vanish in two-dimensions, which implies that they should be important in theories of the Anderson-M ott metal-insulator transition near twodimensions.<sup>6</sup> W e will clarify in what sense this is the case. W e will further show that these many-body interactions can lead to qualitatively new scaling behavior if the interactions are strong enough.

The organization of this paper is as follows. In Sec. II we give simple physical arguments for the existence of e ective many-body interactions and their expected structure. In Sec. III we perform an explicit calculation showing that such terms are indeed generated in perturbation theory, starting with a model that has two-body interactions only. In Sec. IV we discuss the physical con-

sequences of these terms, and in particular their relevance for strong-coupling problems. Section V contains a conclusion, and in the appendix we discuss some aspects of  $^4$ -theory that are analogous in some respects to our perturbative calculation.

# II. PHYSICAL ARGUMENTS FOR THE EXISTENCE OF EFFECTIVE MANY BODY INTERACTIONS

Let us consider an ensemble of interacting electrons in the presence of quenched disorder. For simplicity, we will model the screened C oulomb interaction by an instantaneous, point-like model interaction whose coupling constant we denote by K  $^{(2)}$ . The action will therefore contain a term

Here n is the electron number density eld, which is a function of position x and imaginary time , and

= 1=T is the inverse temperature. We use units such that ~ =  $k_B$  = 1. In the second line we have performed a Fourier transform from imaginary time to bosonic M atubara frequencies  $_n = 2$  Tn.

If neither the disorder nor the interaction is too strong,<sup>19</sup> the dynam ics of the electrons will be di usive. This means there are particle-hole excitations, or di usons, that are described by a di usive propagator




FIG.1: An elective three-body interaction mediated by three di usion propagators.

The exchange of di usons then provides an electric longranged interaction between the electrons. Consider, for instance, three electrons that are pairwise coupled by diffusion propagators, see Fig. 1. Each two-body interaction carries an am plitude K <sup>(2)</sup>, and we therefore expect this




FIG.2: An elective three-body interaction mediated by two di usion propagators.

process to contribute a term to the e ective action,

Here we have localized the di usons in imaginary time, i.e., we have neglected their dependence on the external frequency arguments. This implies an elective threeelectron interaction amplitude, de ned in analogy to Eq. (2.1), that is given by

In an elective theory that cannot resolve the positions x, y, and z, K  $^{(3;1)}$  will appear as a point-like three-electron interaction. For later referece we note that in m om entum space, and with the external m om enta put equal to zero, K  $^{(3;1)}$  reads

Notice that the frequency-m om entum integral in this expression is infrared divergent in all spatial dimensions d 4. This singularity will be cut o by any nonzero external m om enta and frequencies. Physically, this m eans that the three-body interaction is of long range in space and time, as was mentioned in the Introduction. We will come back to this point in Secs. III and IV below.

W hile K  $^{(3;1)}$  is perhaps the most obvious three-body interaction term, it is easy to see that there are others, including terms that are only quadratic in the two-body interaction amplitude K  $^{(2)}$ . Consider the situation in Fig.2, where two electrons coupled by the original shortranged two-body interaction interact with a third one by exchanging di usons. Since there are two electrons at the same point in space in this process, we expect the long-ranged e ective interaction to be mediated by a di uson squared. This leads to an e ective three electron interaction am plitude, at zero external frequencies,

It is obvious that there cannot be any three electron interaction terms that are linear in K  $^{(2)}$ .

A nalogous arguments lead to the conclusion that there are four-electron interaction terms, starting at order K  $^{(2)}$  <sup>3</sup>, etc. In the following section we will ascertain the existence of such many-body interactions by means of an explicit perturbative calculation for a speci c model.

III. GENERATION OF MANY-BODY INTERACTIONS IN PERTURBATION THEORY

#### A. Generalized nonlinear sigm a-m odel

We now turn to an explicit calculation that shows how many-body interactions are generated by renorm alizing models that contain two-body interactions only. For de niteness, we take as our starting point the generalized nonlinear sigm a-model for disordered, interacting electrons<sup>7</sup> that has been used extensively to describem etal-insulator transitions,<sup>6,8,9</sup> as wellasm agnetic transitions<sup>6</sup> in solids. The action reads,

Them atrix elements  $Q_{nm}$  carry fem ionic M atsubara frequency labels n;m, and replica labels to deal with the quenched disorder. The m atrix elements are them selves four-by-four m atrices to allow for spin and particle-hole degrees of freedom. They constitute the soft-m ode com – ponents of an underlying m atrix eld Q that com prises bilinear products of ferm ionic elds and according to the correspondence

Here all elds are understood to be taken at position x, and 1  $(n_1; 1)$ , etc., comprises both frequency and replica labels. It is convenient to expand the 4 matrices in a spin-quaternion basis,

Here  $_0 = s_0 = 1_2$  is the 2 2 unit matrix, and  $_j = s_j = i_j$ , (j = 1;2;3), with  $_{1;2;3}$  the Pauli matrices. In this basis, i = 0 and i = 1;2;3 describe the spin-singlet and the spin-triplet, respectively. An explicit calculation reveals that r = 0;3 corresponds to the particle-hole channel (i.e., products ), while r = 1;2 describes the particle particle channel (i.e., products

or ). In this basis, the electron number density eld as a function of x and a bosonic M atsubara frequency  $_{\rm n}$  is represented by

G and H in Eq. (3.1a) are coupling constants that represent the disorder strength and the frequency coupling, respectively. Their bare values are proportional to the resistivity in Boltzm ann approxim ation, and to the density of states in self-consistent Born approximation, respectively. is a frequency matrix with matrix elements

The nalterm in Eq. (3.1a) describes the two-body electron-electron interaction. From Eqs. (3.2,3.4) it is clear that it must be quadratic in  $\hat{Q}$ . If one separates the interaction into a spin-singlet interaction between num – ber densities, and a spin-triplet interaction between spin densities, A int reads

Here K  $^{(2;s)}$  and K  $^{(2;s)}$  are the spin-singlet and spintriplet two-body interaction amplitudes, respectively. In general, there also is an interaction amplitude in the particle-particle channel, which we neglect here.

F inally, for explicit calculations it is convenient to elim – inate the constraints given by Eq. (3.1b). This can be done by m eans of the block m atrix parametrization

Here the four block matrices represent, clockwise from upper left, them atrix elements of  $\hat{Q}$  with frequency labels  $n_1;n_2 > 0, n_1 > 0;n_2 < 0, n_1;n_2 < 0$ , and  $n_1 < 0;n_2 > 0$ .

From Eq. (3.4) it follows that a point-like, instantaneous three-body interaction term involving three num – ber density uctuations would take the form

We will now show that such a term is indeed produced by renormalizing the bare action A given in Eq. (3.1a).

#### B. Loop expansion

To proceed, we expand the action A, Eq. (3.1a), in powers of q. To Gaussian order we obtain a quadratic form whose inverse determ ines the Gaussian propagators. In Fourier space, the latter read

which are proportional to the basic di usion propagator de ned in Eq. (2.2).

W e now perform a system atic bop expansion, and concentrate on the renorm alizations of the interaction term s. For simplicity, we consider only the particle-hole channel degrees of freedom, i.e., we neglect the propagators with r = 1;2 above. A physical situation that realizes this approximation is, e.g., a system with magnetic impurities, which give the particle-particle channel propagators a mass, so they drop out of the soft-mode elective theory.<sup>6,8</sup>




FIG.3: Diagram s that renorm alize the two-body interaction.




FIG.4: Diagram s that can generate an e ective three-body interaction.

At one-loop order, the two-body interactions get renorm alized, and they acquire frequency and momentum dependences in the process. This e ect is due to the diagram s shown in Fig. 3, and it has been studied in detail before.<sup>6</sup> However, there also are three-body interactions generated in the process. Let us concentrate on the pure spin-singlet term given by Eq. (3.8). To low est order in powers of q, it will manifest itself in particular in a term

Here we have allowed for a frequency and real-space dependence of the three-body interaction amplitude, and for simplicity we only consider the  $^0_0$ q components of the matrices q. A vertex with the structure of Eq. (3.10) can in principle be generated by any of the three diagrams shown in Fig. 4.

It is easy to see that diagram (a) in Fig. 4 does not contribute to a three-body interaction; the realizations of this diagram that have the correct replica structure do not have a frequency structure consistent with Eq. (3.10). This is consistent with our conclusion, in Sec. II, that there are no contributions to K <sup>(3)</sup> that are linear in K <sup>(2)</sup>. Of the remaining two diagrams, (c) is at least of cubic order in K <sup>(2)</sup>, and in particular produces term s that have the structure of K <sup>(3;1)</sup> in Eq. (2.4a). D iagram (b) has contributions of the correct structure that are of O ((K <sup>(2)</sup>)<sup>2</sup>), as well as contributions of higher order. The easiest check for the existence of K <sup>(3)</sup> therefore consists of a system atic calculation of diagram (b), keeping only term s of second order in the two-body interaction am plitude K <sup>(2;s)</sup>. Such a calculation yields

This result demonstrates that a term with the structure of K<sup>(3;2)</sup>, Eq. (2.5), gets indeed generated upon renormalization of an action with a pure two-body interaction. In addition, there exist terms that represent K<sup>(3;1)</sup>, Eq. (2.4a), as well as spin-triplet and m ixed singlet-triplet three-body interactions. It is also plausible that four- and higher-body interaction terms are generated by the same mechanism, and the existence of particular diagram s with the appropriate structure is easily veried.

W e note that the momentum integral in Eq. (3.11b)diverges for sm allexternalw avevectors k, or sm allexternal frequencies, as  $1=k^2$  or 1=, in agreem ent with the remark after Eq. (2.4b). The RG interpretation of this divergence is given in the next section.

# IV. PHYSICAL EFFECTS DUE TO EFFECTIVE MANY-BODY INTERACTIONS

## A. Structure of renorm alization-group ow equations

Since structurally new term s have appeared in our action under renorm alization, we need to add these terms to the action and start the renorm alization process over again. The action as given by Eqs. (3.1,3.6) thus must be augmented by Eq. (3.8).<sup>20</sup> The renorm alization of this action then proceeds along standard lines. The result is obviously a generalization of the known ow equations for the model with two-particle interactions only. For our present purposes we are interested only in the general

structure of these ow equations, which can be obtained without a detailed calculation.

We choose the scale dimension of a length L to be [L] = 1, and that of imaginary time to be [] = d in d spatial dimensions.<sup>21</sup> The eld q(x) we choose to be dimensionless. The bare scale dimension of G is then , the bare scale dimensions of H , K  $^{(2;s)}$  and d 2 K  $^{(2;t)}$  are zero. The bare scale dimension of K  $^{(3)}$  is d, due to the extra factor of T that appears in the threebody interaction term, Eq. (3.8), compared to the twobody interaction. If we denote the renorm alized, scale dependent counterparts of these coupling constants by g,  $h_{k_{s}}$ ,  $k_{t}$ , and  $k_{3}$ , respectively, we thus have to zero-loop order

To nd the higher-loop order term s explicitly requires a detailed calculation. For  $k_3 = 0$ , the result is known com pletely to one-bop order, and selectively to two-bop order.<sup>6</sup> For all universality classes, the structure is,

In the presence of  $k_3$ , we need to consider, rst, the in uence of k<sub>3</sub> on the ow of the other coupling constants, and, second, the  $k_3$  - ow equation itself. Simple counting arguments show that k<sub>3</sub> cannot produce singular (in d = 2) one-loop renorm alizations of the other coupling constants. For instance, consider the second diagram in Fig. 3 with one of the vertices replaced by a three-body interaction. Due to the additional factor of T in Eq. (3.8) compared to Eqs. (3.6) this diagram will have an extra frequency integration com pared to the diagram with both vertices given by two-body interactions, and will thus not be infrared singular. The structure of the ow equation for  $k_3$  itself is therefore more important than the modi cations of Eqs. (4.2a - 4.2d), and the crucial question is whether is it possible to overcom e the negative bare scale dimension of  $k_3$ . The most interesting term is therefore the one-loop renormalization of  $k_3$ that is proportional to  $k_3$  itself. Such term s exist; they are realized, e.g., by diagram s (b) and (c) in Fig. 4 with one of the three-point vertices replaced by a three-body interaction. Simple counting arguments show that the structure of the k<sub>3</sub>- ow equation to one-bop order is

Note that the last term on the right-hand side of Eq. (4.2e) is independent of  $k_3$ . It represents the contributions that generate  $k_3$  in the rst place, for instance, the one given by Eqs. (3.11).

In general, adding a new RG variable to a set of ow equations can have any one of three e ects by virtue of the new eigenvalue it adds to the set of equations linearized about any xed point. First, it may be truly irrelevant in the sense that it does not qualitatively change any aspects of the RG ow in its absence. Second, it may be irrelevant with respect to a xed point that exists in its absence, but change the ow outside of the basin of attraction of this xed point. (It will in general also change the size of this basin of attraction.) Third, it may be relevant with respect to the original xed point. In the latter two cases, outside of the basin of attraction of the original xed point, if any, it may either lead to a new xed point, or to ow towards strong coupling. W ith this in mind, we next discuss possible types of xed points of the above ow equations.

## B. W eak-coupling xed points

In the usual perturbative RG treatment one looks for xed points of the ow equations, Eqs. (4.2), where g is small of O (), and s and t are at most of O (1). This is our de nition of a weak-coupling xed point.<sup>22</sup> It follows from Eq. (4.2e) that the new scaling operator introduced by the presence of  $k_3$  will have a scale dimension

of 2+0() with respect to such a xed point. This is assured by the bare scale dimension of  $k_3$ ,  $[k_3] =$ d, which cannot be overcome by the small one-loop term . In this context it is important to mention that  $k_3$  itself does have a component that is marginal in d = 2. This follows from the fact that the one-loop term in Eq. (4.2e)has a contribution that is independent of  $k_3$ , see the rem ark after that equation, and Eqs. (3.11). How ever, this component just relects the scaling behavior of the other coupling constants, g, h, k<sub>s</sub>, and k<sub>t</sub>, and it does not lead to a new eigenvalue of the linearized RG ow equations. In other words,  $k_3$  is not a proper scaling operator, and the scaling operator related to  $k_3$  has the components that are marginal in d = 2 projected out. An analogous phenom enon in <sup>4</sup>-theory is discussed in the Appendix.

W e also note that, alternatively, one could treat the three-body interaction generated by Eqs. (3.11) as a truly long-ranged interaction with a bare scale dimension of

2 . Such a procedure would lead to the same conclusion, since the part that is marginal in d = 2 would just related the scaling behavior of the two-body interaction amplitudes. The one-loop term independent of  $k_3$  thus related the long-range nature of the RG -generated three-body interaction; see also the remark at the end of Sec. III. This observation justiles our using a point-like three-body interaction amplitude despite the fact that the one generated in perturbation theory was long-ranged. In the Appendix we discuss a similar feature of  $\,^4$ -theory.

W e conclude that the many-body interactions are indeed important for weak-coupling xed points, as one would have expected. However, since they do not lead to new marginal (in d = 2) scaling operators, the relevant physics is already contained in the renorm alization of the two-body interaction constants. W eak-coupling xed points will thus alw aysbe perturbatively stable with respect to k<sub>3</sub>, and also with respect to higherm any-body interactions, i.e., they have a nite basin of attraction. This in turn implies that the coupling of  $k_3$  to the other coupling constants cannot change the critical behavior, it will merely lead to power-law corrections to scaling. In particular, all of the perturbative m etal-insulator transition xed points that are known to exist for the generalized nonlinear sigm a-m odel de ned in Sec. III are stable with respect to  $k_3$ .

#### C. Strong-coupling xed points

Let us now consider strong-coupling xed points, where the ratio of successive terms in the loop expansion is not necessarily some power of . This can happen if the xed point value of  $_{\rm t}$  is large, of O (1= ), or in nite, even if g is still of O (). O f course, another possibility is that g = O (1). No controlled theories exist of m etal-insulator transitions that are governed by such xed points, but they are structurally clearly possible. Explicit, if uncontrolled, examples of xed points where both g and an interaction coupling constant are of O (1)

have been given in Refs. 10 and  $11.^{23}$  It is also believed that strong-coupling physics governs the behavior in certain 2-d sytem s, where the interaction strength m ay be the dom inant energy scale in the problem  $.^{12}$ 

The arguments in the previous subsection that ensure the irrelevance of  $k_3$  obviously break down for such strong-coupling xed points. We stress that this may be true even if the xed-point value of g is still small. The point is that with, e.g., g = 0 () and t = 0 (1=),  $g_t = 0$  (1), and hence the one-bop term in Eq. (4.2e) can overwhelm the bare scale dimension of  $k_3$ . The same arguments hold for the higher many-body interaction terms, although to a lesser degree, since for them a larger negative bare scale dimension must be overcome in order to make them relevant.

We conclude that the many-body interaction terms cannot be dismissed a priori in any strong-coupling regime, where the dimensionless interaction amplitudes are large, even if the disorder is still small. In particular, they are likely to play a role in the resolution of the two-dimensionalm etal-insulator transition problem.

# V. SUMMARY, AND CONCLUSION

To sum marize, we have shown that many-body interactions are generated under renorm alization of an action for interacting disordered electrons that contains two-body interactions only. Such interactions turn out to be irrelevant with respect to the perturbative xed points that describe m etal-insulator transitions in  $d = 2 + ... H \, ow$ ever, they need to be exam inated, and they likely contribute to the leading behavior, in any strong-coupling theory. This im plies in particular that even if strongcoupling solutions for the generalized nonlinear sigm am odel with two-body interactions could be found, such solutions would be incom plete, and probably physically wrong. The task of determ ining the strong-coupling behavior of such system s, and in particular the situation in d = 2, is thus even harder than previously assum ed.

W e conclude by recapitulating two aspects of our technical developm ent that can easily lead to confusion. First of all, let us com e back to the infrared divergence of the integral in Eq. (3.11b). Naively, this infrared divergence seems to o set the extra factor of tem perature com pared to the two-body interaction, making the three-body interaction marginal by power counting in d = 2. The sam e argum ent applies to higher many-body interaction amplitudes, which carry additional factors of tem perature, but com e with even m ore divergent loop integrals. A swe show explicitly by analyzing an analogouse ect in

<sup>4</sup>-theory in the appendix, this sim ple argument is fallacious and the many-body interactions are perturbatively innelevant, but they are likely to play an important role in nonperturbative regimes. Second, we have focussed on one particular three-body interaction term, namely, a spin-singlet three-body interaction. For this term, we have calculated all contributions to second order in the spin-singlet two-body interaction within a well-de ned model. This proves the existence of many-body interactions in e ective eld theories for electrons, but our calculation is sensitive to only a small subclass of such term s. Many-body interactions coupling four and more electrons, spin-triplet interactions, and term s coupling singlet and triplet density uctuations certainly exist, and they all need to be examined in order to system -

atically deal with strong-coupling e ects. F inally, we note that existing theories of the Anderson-M ott transition seem to lead to the conclusion that it is very similar to an Anderson transition.<sup>24</sup> However, it is reasonable to assume that in strongly correlated systems the metal-insulator transition should more closely resem ble a M ott transition.<sup>13</sup> This suggests the existence of a saddle in parameter space separating the xed points that describe the two transitions. The disordered M ott transition is likely described by a strong-coupling xed point. As discussed after Eqs. (4.2), on the strongcoupling side of such a saddle the many-particle interactions are likely to be in portant, even if the weak-coupling Anderson or Anderson-Mott xed point is locally stable with respect to them . In this context it is interesting to note that a Landau theory for the Anderson-M ott transition in high dimensions  $(d > 6)^{14,15}$  found indeed that for weak interactions, an Anderson transition takes place with increasing disorder, while for strong interactions the metal-insulator transition has a di erent nature. It is likely that the many-body interactions discussed in this paper are important for understanding the missing link between this theory in high dimensions, and the usual treatment of the metal-insulator transition problem near two-dimensions.

# APPEND IX A :GENERATION OF HIGHER-ORDER TERMS IN $\ ^{4}$ -Theory

In this appendix we recall some aspects of  $^4$ -theory that are analogous to the generation of m any-body interactions discussed in the main part of the paper. See Refs. 16,17,18 for a derivation of the results sum m arized below.

Consider scalar <sup>4</sup>-theory, with an action




FIG.5: Diagram that generates a  $\,^{6}$  -term from  $\,^{4}$  -term s.

Upon renormalization, a  $^{6}$ -term with a coupling constant  $u_{6}$  is generated by means of the diagram shown in Fig. 5. This diagram represents a momentum inte-

gral over three propagators. In perturbation theory, and at criticality, this integral is strongly infrared divergent. N aively, this raises the question whether  $u_6$  can really be irrelevant with respect to the W ilson-Fisher xed point. To investigate this, we consider the RG ow equations. Adding a <sup>6</sup>-term to the action, one easily nds, within a momentum-shell RG, and to one-loop order,

where = 4 d. Linearization of these ow equations about the W ilson-Fisher xed point (r ; $u_4$ ; $u_6$ ) = (=6+0 (<sup>2</sup>); =9+0 (<sup>2</sup>); <sup>3</sup>=54+0 (<sup>4</sup>)) yields three RG eigenvalues

 $_1 = 1 = > 0$  is the inverse correlation length exponent,  $_2$  is the scale dimension of the least irrelevant operator, and  $_3$  is irrelevant even for = 0. The infrared properties of the triangle diagram thus do not lead to another (besides  $_2$ ) eigenvalue of 0 (). This is true even though it does lead to a leading scaling behavior of  $u_6$  that is given by  $u_6$  (b ! 1) b , as can be seen by solving the ow equations. However, this just means that  $u_6$  is not a proper scaling operator, since it couples to  $u_4$ . W ith  $u_4 = u_4$   $u_4$  and  $u_6 = u_6$   $u_6$ , the proper next-to-least irrelevant scaling operator is  $g_6 = u_6$   $(^2=2) u_4 + O(^3)$ . Its scale dimension is  $[g_6] = {}_3$ , so  $g_6$  is indeed irrelevant with scale dimension 2 in d = 4.

This phenomemon of the generation of a new operator that is irrelevant with respect to the perturbative xed point in d = 4is completely analogous to the irrelevance of the three-body interaction with respect to the perturbative m etal-insulator transition xed points in d = 2+, and the analogy extends to the long-rangedness of the new interaction. It is interesting to note, how ever, that there is no general a priori guarantee that  $q_6$  w ill no be relevant in, say, d = 3. Indeed, the bare scale dim ension of  $u_6$  is 2+2, which naively implies a marginal operator in d = 3. The one-loop correction switches the sign of the O ( ) correction, see Eq. (A 3c), so the oneloop approximation to  $_6$  makes  $g_6$  more irrelevant with increasing , not less. However, it is important to keep in m ind that, (1) this change of sign is a special property of <sup>4</sup>-theory, which can be seen only by means of an explicit calculation, and, (2) there is no guarantee that high-order terms in the -expansion will not have a posit ive sign and make  $_3$  positive in d = 3. In <sup>4</sup>-theory there are no indications that this is the case, but it could happen in a di erent, m ore com plicated eld theory.
