# LOCALIZATION LENGTH IN DOROKHOV'SM ICROSCOPIC MODELOF M ULTICHANNELW $\mathbb{R} E S$

#### Abstract

W e derive exact quantum expressions for the localization length $L_{c}$ for weak disorder in twoand three chain tight-binding system s coupled by random nearest-neighbour interchain hopping term $s$ and including random energies of the atom ic sites. These quasi-1D system $s$ are the twoand three channel versions of $D$ orokhov's m odel of localization in a wire of $N$ periodically arranged atom ic chains. W e nd that $L_{c}{ }^{1}=N:{ }^{1}$ for the considered system s w ith $\mathrm{N}=(1 ; 2 ; 3)$, where is $T$ houless' quantum expression for the inverse localization length in a single 1D A nderson chain, for weak disorder. The inverse localization length is de ned from the exponential decay of the tw o-probe Landauer conductance, which is determ ined from an earlier transfer matrix solution of the Schrodinger equation in a B loch basis. O ur exact expressions above di er qualitatively from D orokhov's localization length identi ed as the length scaling param eter in his scaling description of the distribution of the participation ratio. For $N=3$ we also discuss the case where the coupled chains are arranged on a strip rather than periodically on a tube. From the transferm atrix treatm ent we also obtain re ection coe cients $m$ atrices which allow us to nd $m$ ean free paths and to discuss their relation to localization lengths in the tw O-and three channel system $s$.

## I. IN TRODUCTION

$T$ he localization length ( $L_{c}$ ) of the quantum states is a fundam entalparam eter in $m$ esoscopic physics. In particular, for quasi-1D disordered system $s$ (w ires) of nite length $L$, it not only sets the scale beyond which the electron states are e ectively localized but it also determ ines the dom ain

in which the conductance $g_{L}$ displays classical 0 hm ic behaviour, $g_{L} / L^{1}$, corresponding to a di usive $m$ etallic regim $e$. H ere ' denotes the elastic $m$ ean free path and

where $N /{ }^{\mathrm{P}} \overline{\mathrm{A}}$ is the num ber of scattering channels in a wire of cross-sectional area $A$. The m etallic dom ain (1) does not exist for $1 D$ chains $(N=1$ ) and for real wires w ith $N \gg 1$ it requires the resistance to be less than som e relatively large threshold value. These fundam ental results have rst been established by Thouless [1] and are review ed in $[2,3]$.

On the other hand, the notion of scattering channels itself is im portant since it has perm itted the generalization of the well-known scaling equation for the evolution of the distribution of resistance (conductance) as a function of length in a 1D chain [4], in term s of the D orokhov $M$ ell-P ereyra-K um ar (D M PK) equation [5,6] for a distribution of scattering param eters related to the conductance in quasi-1D system s . The DMPK equation together w ith the num erous results derived from it has been review ed in [7 99].

D espite the im portant role played by the localization length in $m$ ulti-channel disordered system $\mathrm{s}, \mathrm{m}$ icroscopic analytic studies of it have rem ained scarce. This is the $m$ ore surprising as $L_{c}$ is actually an intrinsically m icroscopic quantum param eter of fundam ental im portance, as recalled above. N ote also that a rst principles derivation of a relation betw een the localization length and the $m$ ean free path such as (2) w ould require separate calculation ofboth quantities in a disordered atom istic $m$ ulti-channel system.

Som e years ago D orokhov [10] has discussed a solvable m odel ofm ulti-channellocalization consisting of N random tight-binding chains coupled by random nearest-neighbour interchain hopping term $s$ and having random site-energies.

D orokhov's aim was to relax the assum ption of isotropy of scattering param eters underlying the derivation of the DM PK equation [5;7] by replacing it by the weaker assum ption of equivalent scattering channels [8]. A fter a fairly sophisticated analysis, which we nd di cult to follow, D orokhov arrives at an evolution equation for the distribution of scattering variables (participation ratio [11]) which involves a single m icroscopically de ned scaling param eter, which he identi es w th the localization length [10]. D orokhov's expression for the localization length for weak disorder is independent of the num ber of channels $\mathbb{E}$ quation (12) below ], which seem s surprising! O $n$ the other hand, the popular $m$ odels of transport and localization in $m$ ultichannel $w$ ires such as the $T$ houless tunnel-junction $m$ odel [1,2], the random $m$ atrix and $m$ axim um entropy $m$ odels $5\{8$ ] and the non linear sigm a $m$ odel [9], do not address detailed (discrete) m icroscopic m odels w ith speci ed disorder.

In a recent paper [12] hereafter referred to as I, the author has derived exact analytical expressions for localization lengths for tw o-and three chain tight-binding system $s w$ ith random site energies but constant nearest-neighbour interchain (transverse) and intrachain (longitudinal) hopping param eters, forweak disorder. In this m odel the channels are generally non equivalent, being associated w ith distinct channelw avenum bers in the absence ofdisorder [12]. The localization length is de ned, as usual, by the rate of exponential decay of the conductance. The conductance is determ ined using a transfer $m$ atrix approach for obtaining the am plitude transm ission coe cients entering into the m ulti-channel Landauer form ula.
$M$ otivated by our doubts about the correctness of $D$ orokhov's result (which, in particular, is incorrect for a 1D chain), we have reconsidered the calculation of the localization length for the case of tw $O$ - and three equivalent channels in hism odel, using the exact transferm atrix $m$ ethod forw eak disorder developed in I. In view of the im portance of D orokhov's $m$ iscoscopic $m$ odel in the context of scaling theories for probability distributions of transport param eters in quasi-1D system $s$ it seem $s$ im portant to dispose of an accurate independent description of the localization length. O $n$ the other hand, the related analysis of re ection $m$ atrices $w i l l$ allow us to calculate $m$ ean free paths for the tw oand three channel system $s$ in the B om approxim ation and thus to test Eq. (2).

In Sect. II we recallthe Schrodinger tight-binding equations forD orokhov'sm odelfor the case oftw o-and three chain system s. D orokhov's m odel corresponds to periodic boundary conditions for the chains i.e. it describes equidistant chains arranged parallel to the axis on a tube. W e also consider an altemative three-chain $m$ odel with the parallel chains arranged on a planar strip, which corresponds to using free boundary conditions for the chains which are now non equivalent. In Sect. III we sum $m$ arize the $m$ ain points of the determ ination of the transfer- and scattering $m$ atrices in these $m$ odels. U sing the sam e param eterization of the $m$ atrix elem ents as in $I$, we lim it ourselves to the de nitions of these param eters in term $s$ of the random site energies and hopping rates in D orokhov'sm odel, referring to I for presentation of the explicit form $s$ of the corresponding $m$ atrices. The results and som e concluding rem arks are discussed in Sect. IV. In particular, we allude to a recently studied [13] weakly disordered multichain model including both interchain and intrachain nearest-neighbour random hopping but no site energy disorder. T his model generalizes a well-know n 1D random hopping tight-binding $m$ odel in which a delocalization transition has been found at the band centre [14]. W e give an exact expression for the localization length in this 1 D m odel, which readily reveals the delocalization transition in the $m$ iddle of the energy band.

## II. M ICROSCOPICMULTI-CHANNELMODEL

The N -chain D orokhov m odel [10] of a w ire consists of parallel linear chains of $N_{L}$ disordered sites each (of spacing $a=1$ and length $L=N_{L}$ a) connected at both ends to sem i-in nite ideal (non-disordered) chains constituting the leads. The sites on a given chain with its associated non-disordered parts are labelled by integers $1 \quad \mathrm{~m} \quad \mathrm{~N}_{\mathrm{L}}$ in the disordered region and by $m \quad 1$ and $m \quad N_{L}$ in the non-disordered ones, respectively. The disordered chains are coupled to each other by random hopping rates (transverse hopping) w ith vanishing $m$ ean values and, correspondingly the non-disordered chains are decoupled. T he system is described by the tight-binding Schrodinger equation

$H$ ere $E$ is the energy and $\underset{m}{i}$ denotes the amplitude of the wavefunction at a site $m$ on the ith chain; "ii ${ }_{n}^{i}$ is the random energy at a site $n$ on chain iwhile
is a random sym $m$ etric hopping param eter betw een a site $n$ on chain $i$ and the corresponding nearest-neighbour site $n$ on chain $j$. The above energies, including $E$, are m easured in units of a xed nearest-neighbourm atrix elem ent for hopping along the individual chains (longitudinal hopping). The random site energies and hopping param eters are assum ed to be identically distributed independent gaussian variables $w$ ith vanishing m ean and correlation [" $\left.{ }_{0}^{2} \quad(" 0)^{2}\right]$

W e note that Eqs. (3 a) describe a collection of coupled chains of xed separation, a, arranged parallel to the axis on a tube, which corresponds to periodic boundary conditions (pbc) for the chains. In the absence of disorder the chains are independent and equivalent and (3a) show s that they all couple in the sam e w ay to the disorder. T herefore these independent chains de ne N equivalent scattering channels [10].

W e now specialize to the cases of two-and three chain system $s w h i d h$ are the ob ject of this paper. For $N=2$ and $N=3 E q$. (3 a) m ay be w ritten

For com pleteness's sake, we also consider, for $N=3$, the case where the parallelchains are arranged on a planar strip which corresponds to free boundary conditions (fbc). In this case the Schrodinger equation is

C learly, in this case, the channels are non-equivalent, but nevertheless w ell-de ned.

A $s$ in $I$, we shall determ ine the inverse localization length from the rate of exponential decay of the conductance of the disordered $w$ ires $[1,2,15]$,

where averaging over the disorder $m$ ay be used, as usual, because of the self-averaging property of $\ln g$. $T$ he conductance is given by the Landauer two-probe conductance form ula [2,3],

where $t_{i j}$ denotes the am plitude transm itted in channel i at one end of the $w$ ire $w$ hen there is an incident am plitude in channel $j$ at the other end.

W e close this Section by recalling the result for the localization length obtained by D orokhov [10] for an N -channel $w$ ire described by ( $3, a$ ). In the notation of ( $3, a$ ) and ( $5, a, b$ ) it reads

which is independent of $N$. This surprising result follow s by com bining the expression for the localization length obtained from the scaling equation for the distribution of the participation ratio in the rst equality of (626) in Ref. [10], w ith the de nitions (2.9), (2.8) and (2 2). The Eq. (12) will be discussed further in Sect. IV .

## III. SUM M ARY OF ANALYSIS

H ere we sum $m$ arize the analytic study of transfer and scattering $m$ atrices for weakly disordered tw o-and three channel system $s$ of $I$, as applied to the $m$ odel of Sect. II. From this we obtain explicit results for the various intraand interchanneltransm ission and re ection coe cients which we shalluse for nding the localization length (9) and, as a check of our results, for verifying explicitly the current conservation property. T he choice of sim ilar notations to those used in I w ill allow us, conveniently, to refer to I for the explicit form $s$ of the above $m$ atrices.

## A. Transfer $m$ atrices

Transferm atrices, $Y_{n}$, for thin sliges enclosing only a single site $n$ per channel of the system described by (6-8) are de ned by rew riting these equations in the form

In order to study the re ection and transm ission of plane waves by a disordered wire we must use a basis corresponding to $w$ aves propagating independently from left to right and from right to left in the absence ofdisorder. Such a basis is provided by the $B$ loch waves supported by the system ( $3, a, b$ ) for vanishing disorder. The B loch waves are the solutions for real $k$ of the eigenvalue equation

correspond to $B$ loch w aves travelling from left to right and from right to left, respectively.
In the absence ofdisorder, the transferm atrices (14) and (15) are diagonalized in the basis ofB loch w ave am plitudes (20). In transform ing (13) to the Bloch wave basis and perform ing, in particular, the corresponding sim ilarity transform ation (de ned by the $m$ atrix $W$ of the eigenvectors in (18) [12]) of the transfer $m$ atrix $Y_{n}$ for $N=2$ and $N=3$, respectively, we use the sam e param eterization for $\Phi_{n} \quad W{ }^{1} Y_{n} W$ as in Eqs (22) ( $\mathbb{N}=2$ ) and (23) ( $N=3$ ) of I (where we now put $k_{1}=k_{2}=k_{3} \quad k$ ). Finally, the transfer $m$ atrices of the disordered wires of length $L=N_{L}$ a are the products of $B$ loch wave transfer $m$ atriges associated $w$ th the $N_{L}$ individual thin sliges $n$,

For weak disorder it is su cient to explicitate (24) to linear order in the random energies ${ }_{n}^{i}$ and ${ }_{n}^{i j}$ for the purpose of studying averages to low est order in the correlations ( $5 \mathrm{a}, \mathrm{b}$ ). These correlations im ply indeed that di erent slices in (24) are uncorrelated. The B loch w ave transfer m atrioes are given explicitly by Eqs (30) $(\mathbb{N}=2)$ and (32) ( $N=3$ ) of $I$, $w$ ith the param eters de ned in (21-23) above and the $w$ avenum bers $k_{1} ; k_{2} ; k_{3}$ replaced by $k$ in (19).
B. S cattering m atrices

The scattering of plane waves (re ection and transm ission) at and betw een the two ends of the random quasi-1D system $s$ is govemed by the $S$ m atrix,

As show $n$ in $I$, the wavefunction am plitudes at sites $n$ and $n \quad 1$ in the $B$ loch representation correspond to waves travelling from left to right and from right to left, respectively. Like in $I$, we thus renam e the wavefiunction am plitudes in the $B$ loch representation of the transfer equations (13),

The details of this som ew hat lengthy calculation are explicitated in I. The explicit form $s$ of the scattering $m$ atrices, Eqs (46-47) and (48,48 a-48.f) of $I$, for $N=2$ and $N=3$, respectively, are expressed in term $s$ of transfer $m$ atrix elem ents which are them selves de ned in term $s$ of general param eters given by (21-23) above in the case of D orokhov's m odel. These $S$ matrioes readily yield the transm ission and re ection subm atrioes in (25).

## IV.RESULTSAND CONCLUDING REMARKS

The explicit expressions of the transm ission-and re ection coe cients, $j_{i j} \jmath$ and $\dot{j}_{i j}{ }^{+} \jmath$, in term $s$ of the general param eters de ning the transferm atrices in I are given in an appendix in I.BY inserting the present param eter values (22) and (23) for the tw o- and three-channeld orokhov models in these expressions and averaging over the disorder, using (5 a) and (5 b), we obtain the follow ing results, exact to order " ${ }_{0}^{2}$ :

$N$ ext, by evaluating the averaged traces hT r $\hat{t}$ ( $\hat{€})^{+}$ji, successively for the three $m$ odels using (33-34), (36-40) and (43-44), respectively, we get:

T hese expressions are exact to order $"_{0}^{2}$ for w eak disorder.
It is instructive to com pare (49-51) w ith the localization length, for weak disorder in a one-dim ensionalchain w ith random site energies. In this case $T$ houless [16] obtained the exact expression

The constant value (12) obtained by D orokhov [10] for arbitrary $N$ di ers qualitatively from these exact results. U sing (19) and (52) D orokhov's expression $m$ ay be w ritten

W e also note, incidently, that in our analysis of the tw o-and three-channeld orokhov $m$ odels the localization length reduces precisely to the 1 D result (52) in the lim it ofno interchain hopping ( $\mathrm{N}_{\mathrm{n}}^{\mathrm{ij}}=0$ ), as expected. W e also note that a sim ilar calculation ofm ean free paths for the tw o-and three channelw ire $m$ odels $w$ ith constant interchain hopping rates discussed in I [12] also leadsto Eq. (60) for $\mathrm{N}=2$ and $\mathrm{N}=3$. The localization lengths for the m ultichannel system s in I are given by Eqs (58), (73) and (86) of that reference, respectively, and the corresponding re ection coe cients entering in (55) above, are given by Eqs (52-57), (67-72) and (83-85) of [12].

The Eq.(60) for the one-dim ensional case coincides with the relation between the localization length and the $m$ ean free path derived by Thouless from kinetic theory [19]. O ur treatm ent thus establishes a sim ilar exact relationship for two- and three-channel system $s$ both for Dorokhov's model and for the $m$ odel with constant interchain hopping in I. The exact universal expression (60) di ers qualitatively from Eq. (2) discussed earlier, $m$ ainly for $N \gg 1$ [1,2,6,7,9,10], and does not suggest the existence of a well-de ned di usive ( $m$ etallic) regim e, ${ }_{\mathrm{N}} \ll \mathrm{L} \ll \mathrm{L}_{\mathrm{c}}$, in few-channel system s . W e recall that in the above references the $m$ ean free path is introduced as a xed length scale beyond which $m$ etallic di usion takes place (when it is not inhibited by localization). O ur $m$ icroscopic analysis yields explicit expressions both for localization lengths and for $m$ ean free paths.
$F$ inally, from (50) and (51) it follow s that the di erence in transverse boundary conditions for the corresponding three-channelm odels has only a m inor in uence on the localization lengths.

The transferm atrix approach discussed in Im ay also be applied for studying the delocalization transition which has recently been found at the band centre in weakly disordered $m$ ulti-chain system s including both nearest-neighbour inter- and intrachain random hopping term s but no site energy-disorder [13]. This delocalization transition exists already in a one-dim ensionalchain $w$ ith random hopping, as has been known for som etim e [14]. In this case it $m$ ay

From a transfer $m$ atrix analysis of (61) sim ilar to that used for obtaining the transm ission coe cient and the corresponding localization length (52) for a w eakly disordered A nderson chain $[12,17]$ we get

This expression, which is exact to order ${ }_{0}^{2}$, displays the divergence of the localization length in the $m$ iddle of the energy band, $\mathrm{E}=0$.
