Low er bound for electron spin entanglem ent from beam splitter current correlations

We determ ine a lower bound for the entanglement of pairs of electron spins injected into a mesoscopic conductor. The bound can be expressed in terms of experimentally accessible quantities, the zero-frequency current correlators (shot noise power or cross-correlators) after transmission through an electronic beam splitter. The elect of spin relaxation (T_1 processes) and decoherence (T_2 processes) during the ballistic coherent transmission of the carriers in the wires is taken into account within B loch theory. The presence of a variable inhom ogeneous magnetic eld allows the determ ination of a useful lower bound for the entanglement of arbitrary entangled states. The decrease in entanglement due to thermally mixed states is studied. B oth the entanglement of the output of a source (entangler) and the relaxation (T_1) and decoherence (T_2) times can be determined.

Q uantum nonlocality has been an intriguing issue since the early days of quantum mechanics [1]. Nonlocale ects can come into play when a quantum system is composed of at least two subsystems which are spatially separated. D espite their simplicity, the Bell states of two distant quantum two-state subsystems (A and B)

exhibit the essential phenom enology of quantum nonlocality (e.g., they violate Bell's inequalities [2]) thus providing an ideal testing ground for quantum nonlocality. Here, we represent the two-state systems as spins 1/2 with basis states \spin up" j"i and \spin down" j#i with respect to an arbitrary xed direction in space.

W ith the developm ent of quantum inform ation theory [3], and in particular with quantum communication, it has become clear that EPR pairs can also play the role of a resource for operations that are in possible with purely classical means. In this context, two-state systems are referred to as quantum bits (qubits), and quantum nonlocality is related to the concept of entanglem ent (de ned below). A number of quantum inform ation processes{ quantum teleportation [4], quantum key distribution [5], quantum dense coding [6], etc.{have been successfully im plem ented using pairs of photons with entangled polarizations, i.e., in states such as Eqs. (1) and (2). Photons have the advantage that they are easily moved form one place to another, allow ing for experim ents involving space-like separations between detection events [2].

M ore recently, there has been increasing interest in the use of the spin of electrons in a solid-state environment for spin-based electronics [7] and as qubits for quantum communication on a mesoscopic scale, typically on the order of micrometers in semiconductor structures (e.g. quantum wires), was proposed [9]. R ather than achieving space-like separation between detection events on the two sites (this




FIG.1: Inset: Proposed setup with two-electron scattering at a beam splitter (BS) with transmittivity T. Electrons are injected pairwise from the entangler (E) into contacts 1 and 2 of the BS. The mean current I = hI i and one of the current correlators S are measured at the outgoing contacts ; = 3;4. Plot: Entanglement of formation E of the electron spins versus singlet delity F and the reduced correlator $f = S_{33}=2eIT(1 T)$. The curve illustrates the relation between noise and entanglement for W erner states. For general states, the curve represents a lower bound for the entanglement, i.e. allowed values for E and f (or, equivalently, F) are represented by points in the shaded region. Measuring f determines a lower bound for the entanglement E.

would require sub-picosecond detection), the idea here is to use quantum entanglement between parts of a coherently operating solid-state device (in the most extreme case, a quantum computer). It is then relevant to study the transport of spin-entangled electrons in a many-electron system and possible means of entanglement detection. Two-particle interference at a beam splitter (BS) combined with the measurement of current uctuations [10] (in general, the full counting statistics [11]) was identi ed as a detector for entanglement.

In this paper, we go one step further, providing a bwer bound for the am ount E of spin entanglem ent carried by individual pairs of electrons, related to the zero-frequency current correlators when m easured in a BS setup (Fig.1,

Inset) by injecting the electrons separately into the two ingoing leads (1 and 2) and m easuring either the current in one of the outgoing leads (= 3; 4)autocorrelator S or the cross-correlator S₃₄. It is assumed that the size of the scattering region is smaller than both the coherence length and the mean free path, allowing for ballistic and coherent transport. In the following, T will denote the transm ittivity of the BS, i.e. the probability to be scattered from lead 1 to lead 4 (or from 2 to 3). The ideal BS for the proposed setup does not give rise to backscattering (e.g. from lead 1 back into lead 1, or from 1 into 2, etc.). Wewill also analyze the eect of such backscattering processes, as they give rise to background shot noise which is unrelated to entanglem ent. During their transport, the electron spins will be exposed to decoherence and relaxation due to spin-dependent scattering caused by magnetic impurities, nuclear spins, or the spin-orbit coupling (see [12] for a review). We include these e ects within a Bloch equation form alism [13]. Com parison between our theory and experiment will (i) test proposed entanglers [14, 15, 16, 17, 18, 19, 20] and (ii) determ ine spin relaxation (T_1) and decoherence (T_2) times.

The materials and structures required for testing our theory, although at the forefront of current capabilities, appear to be feasible. The largest e orts seem to be necessary to realize the electron spin entangler [10] for which there exists a number of theoretical ideas, using norm al{[14, 15] or carbon-nanotube{superconductor junctions [16, 17, 18], or single [19], or coupled quantum dots [10, 20]. The electronic BS and the measurem ent of BS current correlators have been experim entally dem onstrated in a G aA s/A IG aA s heterostructure [21]. C oherent transport of electron spins over m ore than 100 m in G aA s has been observed [22].

Traditionally, current correlations, and in particular the quantum partition (shot) noise have been used to gain information about a scatterer beyond its conductance [23]. Here, we use a known scatterer (the BS) to gain information about the quantum state (more precisely, its entanglement) of the scattered particles. The correlation function between the currents I (t) and I (t) in two leads ; = 1;::;4 of the BS is de ned as

where I = I hI i, hI i = Tr(I), is the density of states in the leads, and is the density matrix of the injected electron pair (below, we suppress the orbital part of , see [10] for C oulom b e ects). Writing in the Bell pasis, Eqs. (1) and (2), = F j ih j+G_0j + ih + j+ _{j=} G_ij_ih_ij and S S (! = 0), we arrive at

Using the standard scattering approach [23], we have found earlier [10] that the singlet state j i gives rise to enhanced shot noise (and cross-correlators) at zero temperature, $S_{33}^{j} = S_{34}^{j} = 2eIT (1 T)f$, with the reduced correlator f = 2, as compared to the \classical" Poissonian value f = 1 [24]. The average currents are given by $I = hI_3 i = hI_4 i = e=h$. We also know that all triplet states are noiseless, $S^{j+i} = S^{j} = 0$ (; = 3;4). Both the current autocorrelations (shot noise) and cross-correlations are only due to the singlet component of the incident two-particle wavefunction,

Including backscattering with probability R_B , we nd

where I = (e=h)(1 R_B). Since $f^0 = S_{34}$ =2eIT (1 T) = 2F (1 R_B) f is smaller than f without backscattering and the entanglement of formation E is a monotonic function of f (see below and Fig. 1), we still obtain a lower bound on E (the bound will become less informative as R_B increases). Note that this does not hold for the autocorrelator S_{33} . How ever, one can determ ine R_B , e.g. by m easuring the shot noise power using normal Ferm i lead inputs [21] and then obtain f from either S_{33} or S_{34} .

The entanglem ent of a bipartite state $2 H_A$ H_B can be quantied by its eptanglement of formation [25] E () = $m in_{f(j_i i_i, p_i)g^2 E()} i_i p_i S_N$ (j_ii), where E() denotes the set of ensembles $f(j_i;p_i)g$ for which = ipijiih ij. We have used the von Neumann entropy of the reduced density matrix $_{\rm B}$ = Tr_A j ih j S_N (j i) = $T_B B \log B$ (logarithms are in base 2). A state with E > 0 (E = 1) is (m axim ally) entangled, whereas a state with E = 0 is separable (in the case of a pure state, it is a product A $_{\rm B}$). The Bell states Eq. (1) and (2) are maximally entangled. Neither local operations nor classical com m unication (LOCC) between subsystem s A and B can increase E. In quantum information theory, E() is the maximal ratio N = M of the number N of EPR pairs (maximally entangled states) required to form M copies of as N ! 1; E is the quantity that m easures how much of the resource (quantum entanglem ent) is available.

For arbitrary , E () cannot be expressed as a function of only its singlet delity F = h j j i. However, this is possible for the so-called W erner states [26]

being the unique rotationally invariant states with singlet delity $\underline{F} \cdot \underline{It}$ is known [25] that $\underline{E} \cdot (F) = H_2 \cdot (\underline{I=2} + \frac{F}{F} \cdot (\underline{I} - F))$ if $\underline{I=2} < F = 1$ and $\underline{E} \cdot (F)$




FIG. 2: Hom ogeneous magnetic eld h=0 and F=1. (a) f of the spin singlet state j i after ballistic transm ission through a BS as a function of the spin decoherence time T_2 , in units of the ballistic transm ission time $t_0=L=v_F$. D i erent curves correspond to di erent values of the spin relaxation time T_1 (same units). N ote that we only plotted the curves for T_2 $2T_1$. (b) f for a spin triplet state j + i. Since f 1, the lower bound on entanglem ent is zero, i.e. we cannot learm anything about entanglem ent of injected triplets at h=0. (c) Lower bound on the entanglem ent of form ation E.

E ($_{\rm F}$) = 0 if 0 F < 1=2, with the dyadic Shannon entropy H₂(x) = x log x (1 x) log (1 x). Together with Eq. (6), this enable us to express the entanglem ent of $_{\rm F}$ in term s of the reduced correlator f (F ig. 1).

W e generalize this result to arbitrary mixed states of two spins (qubits). Any state can be transformed into the W erner state $_{\rm F}$ with the same singlet delity F by a random bipartite rotation [25, 27], i.e. by choosing a random U 2 SU (2) and applying U U to . Since this operation involves only LOCC, E cannot increase,

The entanglem ent of form ation E (F) of the corresponding W erner state therefore provides a lower bound on the entanglem ent of (Fig.1). Thus, a noise signal exceeding the Poissonian limit (f > 1) in the BS setup can in principle be interpreted as a sign of entanglem ent between the electron spins injected into leads 1 and 2 [30].

We now include relaxation and decoherence into our analysis. At time t = 0, we start with a spin singlet (upper sign) or triplet (lower sign) state

We describe the dynam ics of (t) in a eld B k \hat{z} and in the presence of spin decoherence (T₂ processes) and relaxation (T₁) phenom enologically within a single-spin B loch equation for the polarization P = (h x i; h y i; h z i),

with $h_i i = Tr(i)$, $h = g_B B = (0;0;h)$, the stationary polarization P = (0;0;P) (note that P = h = 0), and the relaxation matrix $[B1]R_{ij} = i_jR_i$ with $R_1 = R_2 = T_2^{-1}$ and $R_3 = T_1^{-1}$. Solving Eq. (12), we obtain

or, in term s of the spin density m atrix,

with the matrix elements $_{ij} = hij jji and (i; j = "; #)$. We apply $_{h}$ (t) to both spins individually,

where h_i is the eld at electron i. Using Eq. (6) and F (t) = h j (t)j i at time t 0, we obtain

where $h = h_1$ h_2 . If the decoherence time $T_2^{(1;2)}$ of the

two electrons is di erent, then T_2 in Eq. (17) becomes $T_2^{EPR} = (1=T_2^{(1)} + 1=T_2^{(2)})^{-1}$. We de ne T_1^{EPR} similarly if P = 0. However, if P = 1, then exp(t=T_1) is replaced by exp(t=T_1^{(1)}) + exp(t=T_1^{(2)}).

A hom ogeneous eld, h = 0, does not a ect f. For slow relaxation, T_1 t, we nd f(t) = 1 e^{2t=T_2}. In Fig. 2a we plot f for h = 0 and F = 1 versus T_2 in units of the ballistic transmission time [24] $t_0 = L = v_F$ (L= length of ballistic trajectory, $v_F =$ Ferm i velocity). For unentangled triplet states, (0) = j""ih"" jj##ih## j we nd f 1=2 for all T_1 , T_2 , and F (Fig. 2b).




FIG.3: (a) Reduced current correlator f versus eld inhomogeneity $h = h_1$ h_2 (in units of h=t_0 g B, t_0= ballistic transmission time, g=g-factor, $_B = B \text{ ohr m agneton}$) for an injected singlet state and P = 1. Solid lines represent T_1 1 and $T_2 = 1;3;10;1$, grey dashed lines $T_1 = 3$ and $T_2 = 1;3$. For injected triplets, the plot is phase-shifted by , providing tight lower bounds at h = . T ight lower bounds for any input state can be determ ined by varying the direction of h. (b) P lot of f for a therm ally m ixed initial state versus $T_{\rm 2}\,$ (in t and P' = 1. The various curves correunits of t_0) for T_1 spond to $k_B T = J = 0;0:25;0:33;0:5;1$, where J and T denote the exchange energy and tem perature during the preparation of the state. Inset: The maximal f (at T_1 ; T_2 t₀) versus 1, E = 0) above the $k_B T = J$. There is no entanglem ent (f critical tem perature T $_{c} = 0.91 \text{ J}=k_{B}$.

An inhom ogeneous eld $h \notin 0$ (or, equivalently, a local controllable Rashba spin-orbit coupling [28]) has the e ect of continuously rotating singlets into triplets and vice versa (Fig. 3). This a lower bound of the triplet entanglement, $(0) = j_{+}$ ih $_{+}$ j which is as tight as Eq. (10) for the singlet,

where f (h) is the measured noise power (or crosscorrelator), E (F) is the entanglem ent of the W erner state F (Fig. 1). If a eld inhom ogeneity h can be created pointing in arbitrary directions in space, then the above result represents a tight low er bound for any injected entangled state. In particular, each maxim ally entangled state j i will be detected in this way, since there exists a $u = \exp(ih) 2 SU(2)$ such that u = j i. This rotation can also be done unilaterally, i.e. there is a v 2 SU(2) with v = 1j = j i (see also [28]).

Finally, we study the case where the spin state of the injected pair of carriers Eq. (11) is mixed, because it is prepared at a temperature T comparable to the energy splitting between spin states, typically (if the Zeem an e ect is negligible) the exchange energy J, i.e. the singlet-triplet splitting. In this case, $(0) = {}_{\rm F}$ with F = (1 + $3e^{J=k_{\rm B}T})^{-1}$ where $k_{\rm B}$ is Boltzm ann's constant. We only show the resulting f for T₁ there (the full expression will be reported elsewhere [29]),

which is the statistical mixture of Eq. (17) for the singlet and triplet with the appropriate Boltzm ann weights (Fig.3b). Above the critical tem perature T $_{\rm c}$ = 0:91 J=k_B there is no entanglem ent even for T_1;T_2 !~1 .
