Crossing of two Coulom b {B lockade R esonances

A bstract

W e investigate theoretically the transport of non { interacting electrons through an A haranov {B ohm (AB) interferom eter with two quantum dots (QD) embedded into its arms. In the Coulom b { blockade regime, transport through each QD proceeds via a single resonance. The resonances are coupled through the arm s of the AB device but may also be coupled directly. In the fram ework of the Landauer{Buttiker approach, we present expressions for the scattering matrix which depend explicitly on the energies of the two resonances and on the AB phase. We pay particular attention to the crossing of the two resonances.

1 Introduction

The crossing of two C oulom b{blockade resonances was studied in two recent experiments [1, 2]. In both cases, two quantum dots (Q D) were in bedded into the arm s of an A haranov{Bohm (AB) interferom eter. By changing the parameters of the experiment (various gate voltages and the magnetic ux through the AB device), it was possible to study the crossing properties of two isolated C oulom b{blockade resonances, one each due to one of the two Q D s. In the present paper we present a theoretical framework for the analysis of both experiments.

Figure 1 shows a schematic representation of both experiments. The AB ring contains the two QDs labelled QDL and QDR where L and R stand for left and right, respectively. The QDs are separated by barriers from the rest of the AB device. The latter consists of two parts. In Figure 1, the low er (upper) part is labelled 1 (2, respectively). Both parts are coupled to the outside world by a number of leads. In Figure 1, this number is two (three) for part 1 (part 2, respectively). In our theoretical treatment, the number of leads coupled to each part will be arbitrary. Typically, one of the leads coupled to part 1 (part 2) serves as source (sink, respectively) for the electrons. While the two QDs are not coupled directly to each other in the rst experiment [1], such a coupling does exist in the second experiment [2]. This coupling is indicated schematically by

the dotted horizontal line representing the wire connecting QDL and QDR. In Ref. [2], the strength of that coupling was controlled by a further gate. Figure 1 does not show the plunger gates which make it possible to control the energies of the C oulom b blockade resonances in either Q D. Thereby it is possible to have the energies of both Coulomb blockade resonances coincide. Experimentally, such crossings are seen in three{dim ensional plots of the conductance versus the plunger gate voltages V_L and V_R applied on QDL and QDR, respectively. Each Coulom b { b lockade resonance corresponds to a ridge. The ridges of resonances in QDL (QDR) run essentially parallel to V_R (V_L , respectively). The crossing of two such ridges marks the crossing of two Coulom b {blockade resonances. The coincidence of two resonances also a ects the interference pattern of the transm ission of an electron through the AB device. This pattern depends upon the magnetic ux through the device. The ux is due to a hom ogeneous magnetic eld perpendicular to the plane of the drawing. We are interested in weak magnetic elds only. (We recall that for a complete AB oscillation, the magnetic eld strength typically changes at most by several ten mT.) Therefore, we take into account only the AB phase due to the magnetic ux and neglect the in uence of the magnetic eld on the orbital motion of the electron. Gauge invariance then allows us to link the AB phase to the passage of the electron through a particular part of the AB device. In the absence of a direct coupling between the two QDs (i.e., without the dotted line in Figure 1), we choose the barrier separating QDL from part 1. W henever the electron leaves (enters) QDL for part 1 (from part 1), it picks up the phase factor exp (2i = 0) $(\exp(2i = 0), \text{ respectively})$ where 0 is the elementary ux quantum. For brevity, we write the phase factor as exp(i). In the presence of a direct link between the two QDs, the topology of the AB interferom eter changes from that of a ring to that of a gure eight, and we use a di erent convention in Section 5.

In Section 2 we de ne the H am iltonian for the system. In Section 3 we use the Landauer (Buttiker approach and present the generic form of the scattering matrix which describes the experimental setup of Ref. [1]. In Section 4, this scattering matrix is analysed especially with regard to the crossing of two Coulom b { b lockade resonances. In Section 5, we generalize our treatment to include the setup of R ef. [2]. In Section 6 we list the approximations and sum m arize our approach and results. M oreover, we address som e of the approxim ations m ade. In particular, we discuss the neglect of the mutual C oulom b interaction between the two electrons which are added to the system as the resonances become populated, and that of the Coulomb interaction between each of these electrons and those on the dots. We also address the role of the spins of both quantum dots and of the two added electrons. Throughout the paper, we disregard tem perature averaging for sim plicity. Likew ise, we disregard decoherence e ects although these are known to play som e role in the actual experiments. W e do so because part of the transport through the device is known to proceed coherently. Only this part will display a dependence on the AB phase. M oreover, decoherence has been thoroughly discussed in the literature, see, for instance, Ref. [3].

2 Hamiltonian

In de ning the Ham iltonian of the system, we proceed in fullanalogy to Refs. [4, 5]. These papers addressed the AB phase for a single QD placed in one of the arms of an AB interferom eter. (For a review of work on this problem, see Ref. [6]). We introduce ctitious barriers separating parts 1 and 2 of the AB device from the attached leads. Likewise, we consider parts 1 and 2 as separated from the two QDs. We impose boundary conditions on all these barriers such that as a result, we obtain self{adjoint single{particle H am iltonians H lead for the leads, H $_1$ and H $_2$ for the now separated parts 1 and 2, and H $_{\rm L}$ and H $_{\rm R}$ for the two QDs labelled QDL and QDR, respectively. Here H lead possesses a continuous spectrum while the spectra of H $_1$, H $_2$, H $_L$ and H $_R$ are discrete. W e label the leads attached to part 1 (part 2) by s = 1; ...; S (by t = 1; ...; T, respectively). The transverse modes (channels) in lead s (t) are labelled a = $1; :::; N_s$ (a = 1;:::;Nt, respectively), and correspondingly for the creation and annihilation operators c^y and c. The associated energies are labelled . The eigenvalues of H_1 (H_2) are labelled E_{1j} (E_{2j}), with j = 1; ...; 1 and associated creation and annihilation operators $c_{1\,i}^y$ ($c_{2\,i}^y$), and $c_{1\,j}$ ($c_{2\,j}$, respectively). We assume that transport through either QD occurs in the Coulom b {blockade regim e where the intrinsic widths of individual resonances are small compared to their spacings. (The spacing includes, of course, the charging energy). We also assume that the tem perature is sm all in com parison with the spacings. Under these conditions, it is legitim ate to assume that transport through either QD is dom inated by a single Coulom b{blockade resonance. We believe that this situation is met or nearly met in the experiments of Refs. [1, 2]. Thus, we admit only a single bound state with energy E_{L} (E_{L}) in QDL (QDR), with associated creation and annihilation operators d_L^y (d_R^y) and d_L (d_R , respectively). The energies E $_L$ and $E_{\rm \,L}\,$ include the charging energies. A ltogether, we have

H opping between the separate parts is induced by interaction term s containing tunneling m atrix elements,

The direct coupling of QDL and QDR (dashed line in Figure 1) is given by

In the absence of any direct coupling between QDL and QDR ($V_{LR} = 0$) we use gauge invariance to put the entire AB phase onto a single one of the barriers. W ithout loss of generality we choose the barrier separating QDL and part 1. Then, all the matrices V in Eqs. (2) are real and symmetric except for $V_{1j,L}$ which obeys

with $v_{1j;L}$ real and symmetric. For $V_{LR} \notin 0$, a modi cation is necessary and discussed in Section 5 below. The Ham iltonian H of the system is the sum of the term s de ned by Eqs. (1) to (3). We have not considered the possibility of spin (orbit coupling on either QD.

We have been very explicit in the construction of H . The reason is that we wanted to show that H is a sum of single{particle H am iltonians. This fact allow sus to use the Landauer{Buttiker approach to describe transport through the system. The ensuing use of the scattering matrix enables us to display explicitly the phase{ and energy{dependence of the conductance coe cients. W e have om itted the spins of as well as any possible interaction between the two electrons which will eventually populate the two resonances caused by E $_{\rm L}$ and $E_{\rm R}$. These points are taken up in Section 6.

3 Scattering M atrix: R ing Topology

The transport through the device is described by the Landauer (Buttiker form ula

Here I_s (I_t) is the current through lead s (lead t), respectively, and V_s (V_t) is the voltage applied to that lead. The conductance coe cients G $_{ss^0}$ are given by

and correspondingly for the index combinations (st); (ts) and (tt⁰). The sym – bol $S_{sa;s^0a^0}$ (E;) denotes the element of the scattering matrix S (E;) which connects channel a in lead s with channel a⁰ in lead s⁰ at energy E and magnetic ux . Time{reversal symmetry requires the scattering matrix to obey the relation

where T denotes the transpose.

The observable O describing a given experimental setup is determined by the experimental arrangement chosen (which of the leads are grounded, and in which of the leads is a current measured). For any such setup, O will be given as a rational function of the conductance coe cients G. This follows directly from Eq. (5). In order to present a general framework useful for the analysis of any such experiment, we focus attention on the scattering matrix S. W ith the help of the form ulas for S given below, it is possible to work out the dependence of the G's and, hence, of O on the energies of the two C oulom b {blockade resonances, and on the AB phase .

It is possible to derive the form of S from the H am iltonian H. This can be done along the lines of R efs. [4, 7]. We do not follow this course here because the explicit solution involves some lengthy algebra. Rather, we simply present the result which we believe to be intuitively obvious. In this and the next Section, we focus attention on the ring geometry and put $V_{\rm LR} = 0$.

The scattering matrix S can be written as the product of three unitary matrices,

W ithout any coupling between each of the QDs and parts 1 and 2 of the AB device (this condition can be met experimentally by increasing the heights of the two barriers de ning each QD), the resonant part S ^(res) (E;) is equal to the unit matrix, and S (E;) is, thus, equal to UU^T. The form of the latter matrix follows from the observation that parts 1 and 2 are unlinked. A unitary scattering matrix S ⁽¹⁾ (S ⁽²⁾) describes the non {resonant electron transport through unlinked part 1 (unlinked part 2, respectively). We assume that the energy dependence of both matrices is smooth over the energy interval de ned by the widths of the two C oulom b {blockade resonances introduced below. We accordingly neglect the energy dependence of both S ⁽¹⁾ and S ⁽²⁾. M oreover, both matrices do not dependent on the magnetic ux , see the remark at the end of Section 1. T im e{reversal invariance then im plies that both S ⁽¹⁾ and S ⁽²⁾ are sym metric. Thus, we can write for i = 1;2

Eq. (9) holds for every unitary and sym metric matrix. As explained in Refs. [3, 5], the unitary transformation U⁽ⁱ⁾ accomplishes the transformation from the space of physical channels to the space of eigenchannels. We accordingly write the matrices U⁽ⁱ⁾ explicitly in the form $U_{sa}^{(1)}$ and $U_{ta}^{(2)}$. Here $U_{sa}^{(1)}$ is the product of an orthogonal matrix $O_{sa}^{(1)}$, which diagonalizes the sym metric matrix

S⁽¹⁾ and of a diagonal matrix with entries exp(i⁽¹⁾) where the ⁽¹⁾'s are the eigenphaseshifts of S⁽¹⁾, and similarly for S⁽²⁾. The index () runs from 1 to N₁ (to N₂, respectively). Here the total number of channels N₁ in part 1 (N₂ in part 2) is given by N₁ = $_{\rm s}$ N_s (by N₂ = $_{\rm t}$ N_t, respectively). The matrix U is de ned in the total space of N = N₁ + N₂ channels. It is block{diagonal and given by

Inspection of Eq. (8) shows that for S $^{\rm (res)}$ = $1_{\rm N}$, the unit matrix in N dimensions, the scattering matrix S is block {diagonal and consists of the two matrices S $^{(1)}$ and S $^{(2)}$, as it must.

It is now obvious that S ^(res) di ers from the unit matrix by term s which represent the two C oulom b {blockade resonances, one each in QDL and QDR. M oreover, it is also clear that S ^(res) is de ned in the space of eigenchannels of both S ⁽¹⁾ and S ⁽²⁾. In this space, the coupling matrix elements W _P describing the hopping of an electron from the resonance in QDP (with P = L or R) to the eigenchannel (with = for part 1 and = for part 2) can be shown [8] to be real, save for the AB phase. We accordingly have for = 1;:::;N and P = L,R

with w_L real. We note that the W_P 's di er from but are linear in the $V_{P;sa}$'s and $V_{P;ta}$'s introduced in Section 2.

We can now express S $^{\rm (res)}$ in terms of the matrix elements W $_{\rm P}$, and of the energies E $_{\rm P}$ of the two C oulom b {blockade resonances. The latter can be varied experimentally by changing the plunger gate voltage on either QD.We observe that the matrices W $_{\rm P}$ map the space of N eigenchannels onto the space of the two C oulom b {blockade resonances, and vice versa for W $_{\rm P}$. The matrix S $^{\rm (res)}$ takes the form

Eqs. (6,8,13,14) constitute the central result of this Section. It is easy to check that the scattering matrix de ned by these equations is unitary and obeys Eq. (7).

For the bene t of the reader, we rewrite the S {matrix in a form which displays more clearly the physical role of the matrices U $^{(i)}$ with i = 1;2. We

The matrix D has the same form as in Eq. (14) but can also be written as

The transform ation (15) introduces complex matrix elements \overline{W} which guarantee unitarity of S in the presence of the non{diagonal unitary matrices S⁽¹⁾ and S⁽²⁾.

4 A nalysis. C rossing of T w o R esonances

The e ect of the two resonances which dom inate the scattering matrix is contained entirely in the matrix D de ned in Eq. (14). It is useful to display D in matrix form,

Our explicit notation combined with Eqs. (11) and (12) shows that $_{\rm L}$ and $_{\rm R}$ are real, positive and independent of the magnetic ux , and that the only dependence on occurs in $_{\rm LR}$ and in $_{\rm RL}$. The latter two quantities are complex and related by

W e use Eqs. (18) to (20) to display the structure of certain elements of the scattering m atrix S. W e recall that S decays into two independent scattering m atrices S⁽¹⁾ and S⁽²⁾ whenever we have W_P = 0 for all P, . Parts 1 and 2 of the AB interferom eter are linked only by the two C oulom b {blockade resonances with energies E_L and E_R. If the two resonance energies are su ciently di erent so that

we can use perturbation theory in $_{\rm LR}$ to invert D . K eeping only the lowest{ order terms in the expansion, we nd

The two amplitudes on the right {hand side of Eq. (22) can be interpreted in term s of two paths of the electron on its way from part 1 to part 2. The electron may pass either through QDL (rst term) or QDR (second term). As it passes through QDL, it picks up the AB phase contained in W_L. This phase will ect the interference pattern due to the product of the amplitudes corresponding to the two paths. W henever inequality (21) holds, the electron will not com plete one or several bops within the AB ring as it passes from part 1 to part 2. It is instructive to consider also the term s of next order. These terms are given by

The path associated with the rst amplitude leads the electron rst through QDR and then through QDL, and vice versa for the second amplitude. With $_{\rm LR}$ given by Eq. (19), we see that along the rst path QDL can be reached from QDR either via part 1 or via part 2, and correspondingly for path 2. In the rst (second) case, the AB phase does not (does) contribute to the scattering amplitude. This is correct because only in the second case does the electron complete a loop around the AB ring. A similar analysis of $S_{sa;s^0a^0}$ and of $S_{tb;t^0b^0}$ shows that whenever inequality (21) holds, the scattering is dom inated

by S⁽¹⁾ and S⁽²⁾, respectively. The consecutive passage through both C oulom b{ blockade resonances is strongly inhibited. We conclude that inequality (21) de nes a fairly uninteresting regime of parameters of the problem.

Interest, therefore, focuses on the regime where this inequality does not hold and where our perturbation expansion is not appropriate. This is the regime where the two Coulom b blockade resonances may cross. We shall see that the crossing displays novel features. P rior to calculating the exact result, it is useful to visualize the outcom e in terms of a perturbation expansion in powers of $_{\rm LR}$ and $_{RL}$. This expansion generates term softhe same form as in form ula (23) but of higher order in $_{LR}$ and $_{RL}$. Each propagator \mathbb{E} E_{P} + (i=2) $_{P}$]¹ occurring in the expansion signals a visit of the associated path to QDP with $P = L_{r}R$. The interm ittent factors $_{LR}$ and $_{RL}$ signal passage of the electron from QDR to QDL and vice versa. The passage may proceed via part 1 or part 2. Thus, the perturbation series stands for the in nite num ber of possibilities to connect the channels de ned by the indices of the scattering matrix, by paths. These paths may loop around the AB ring a number of times, then change direction, loop again, change direction back etc. until the electron leaves the AB ring. The AB phase picked up by the electron is the sum of all such phases picked up in the individual bops and given in term s of the total num ber of com pleted counter{clockwise loops m inus the total num ber of com pleted clockwise loops. We are about to calculate the form of the scattering matrix by diagonalizing the matrix D. This procedure amounts to summing over all the paths just mentioned. This is why the AB phase will show up in the denom inator of the result, see Eq. (27). (Experim entally, decoherence will actually lim it the num ber of loops that contribute signi cantly to the amplitude, see Ref. [1]).

We simplify the algebra by considering an AB ring which contains two perfectly identicalQDs and which itself is perfectly symmetric about a verticalaxis through the middle of Figure 1. Then, $_{\rm L} = _{\rm R} =$ (this denes the width). We write the complex eigenvalues of the matrix D in the form E "i with i= 1;2. Then

Let us suppose that we change the resonance energies of both dots in such a way that ($E_L + E_R$) is kept xed while $u = \int E_L = E_R$ jdecreases monotonically from an initially large value (in the sense of the inequality (21)). Then, the di erence $\int I_1 = I_2 j$ also decreases monotonically. Both resonances approach each other, retaining equalwidths. The di erence of resonance energies vanishes when ($E_L = E_R$)² = $j_{LR} f$: The two resonances coincide in energy and width. We deal with an exceptional point in the sense of R ef. [9]. At this point, the system possesses only a single eigenfunction. As we decrease u further, the two resonances separate, retain equal resonance energies but acquire di erent widths. At u = 0, the widths di er by $j_{LR} j$ the maximum amount possible.

The value of j $_{LR}$ j determ ines both, the value of u where the resonances coincide and the maximum di erence of their widths. This value depends upon

the AB phase . Indeed, from Eq. (19) we have

The value of $j_{LR} \stackrel{2}{j}$ oscillates periodically with magnetic ux between the maximum value 4 $\stackrel{2}{P}($ $w_L w_R + W_L W_R)^2$ and the minimum value 4 $\stackrel{2}{}($ $w_L w_R - W_L W_R)^2$. From Schwarz's inequality we conclude that the widths of the two resonances are always positive. To estimate the relative size of and of $j_{LR} j$ we note from Eq. (19) that = L = R is a sum of squares while $_{LR}$ is a sum over term swhich, aside from the AB phase, may have either sign. We expect that due to impurity scattering in parts 1 and 2 of the AB device, the W_P 's are G aussian random variables, see R ef. [5]. As a consequence, we have / N while $j_{LR} j$ uctuates strongly with a root{mean{ square variance which grows like N. Thus, the maximum dimense of the widths of the two resonances is expected to be of the order of = N.

The possibility of complete coalescence of two resonances displayed above is a phenom enon which is opposite to the well{known W igner{von Neum ann level repulsion e ect for bound states. The latter occurs whenever two bound states interact via a Herm itean interaction. Eq. (18) shows that in the present case, we deal with resonances with complex resonance energies to begin with, and with a coupling that is due to a Herm itean interaction multiplied by i, the imaginary unit. This unusual form of interaction occurs because the two resonances are not coupled directly but via the open channels in parts 1 and 2. Both di erences contribute towards a behavior which di ers from standard W igner{von N eum ann level repulsion. Such behavior has been discussed previously in the literature. To the best of our know ledge, the coupling of two resonances was rst studied explicitly by von B rentano et al. [10] in the context of Nuclear P hysics. This work was followed by an experim ental investigation [11]. R elated work was published in R ef. [12]. R ecent work [13] has focussed on the properties of exceptional points.

To display the features of the exceptional point where $(E_R - E_L)^2 = j_{LR} j_{and}^2$ and where $L_R = R$, we consider two slightly asymmetric QDs for which the two resonance widths L_L and R_R are not exactly equal. Then, the eigenvalues $"_{1;2}$ will never coincide exactly. This is seen from the expression of the discriminant which now has the value

In agine now a change of the the param eters of the system in such a way that the argument of the square root describes a closed loop in the complex plane around the exceptional point. Unfortunately, all these appealing features have no bearing on the properties of the scattering matrix S. This is because the energy E is always real. As a consequence, we can never reach the exceptional point, and the determ inant of the matrix D never vanishes for real values of E. The two eigenfunctions of D remain distinct. In view of the recent interest in exceptional points, we have nevertheless felt that a discussion of this topic is appropriate in the present context.

We return to the symmetric case. The matrix D can be diagonalized by a matrix A so that $D = A^{-1} (E 1_2)^{-1}$ ")A where " denotes the diagonal matrix diag ("₁; "₂). Using this form in Eq. (13), we obtain

Inserting thism atrix into Eqs. (6) yields the conductance coe cients and, hence, the dependence of any observable on the AB phase. The AB phase appears explicitly not only in the eigenvalues $"_{1;2}$ but also in the matrix A and, of course, in some of the W $_{\rm P}$'s. The matrix A can easily be calculated. Details are not given here.

For the sake of com pleteness, we discuss the limitations of a two { lead experiment. These limitations have played a role in previous studies of AB devices [6]. We recall that the scattering matrix S is unitary and obeys $S^{T}(E;) = S(E;)$. It follows that in general, we have $S_{sa;s^{0}a^{0}}(E;) = S_{s^{0}a^{0};sa}(E;)$ and correspondingly for the lead indices (s;t) and (t;t⁰). The cases where the two lead indices coincide are special and yield $S_{sa;sa^{0}}(E;) = S_{sa^{0};sa}(E;)$ and $S_{ta;ta^{0}}(E;) = S_{ta^{0};ta}(E;)$. For the conductance coe cients, this means that $G_{ss^{0}}(E;) = G_{s^{0}s}(E;)$, $G_{tt^{0}}(E;) = G_{t^{0}t}(E;)$ and $G_{st}(E;) = G_{ts}(E;)$ while $G_{ss}(E;) = G_{ss}(E;)$ and $G_{tt}(E;) = G_{tt}(E;)$. Unitarity then shows that for a two {lead experiment the G's are even in while this is not the case for the o { diagonal G's when we deal with more than two leads. This conclusion, rst drawn by Buttiker [14], is seen to be quite general and not a ected by the topology of our AB ring with two QD s.

If the two QDs are connected by a wire, the topology di ers from that of a ring analysed so far. The neccessary modi cations are quite straightforward, however. The AB ring is divided into two parts by the wire connecting the two QDs. Let $_1(_2)$ be the ux through the lower (the upper) part, respectively. In a manner completely analogous to Eqs. (11) and (12), we put $_1(_2)$ onto W $_L$ (W $_L$, respectively). With $_i = 2$ $_i = _0$, i = 1; 2, Eqs. (11) and (12) are thus replaced by

with $w_{\rm L}~$ real. A further modi cation accounts for the presence of the wire which furnishes a direct link between the two QDs. We represent this link by a realhopping matrix element $V_{\rm LR}$ = $V_{\rm R\,L}$. This element appears in the matrix D which now takes the form

Except for these modi cations, all form ulas in Section 3 rem ain unchanged.

For a discussion of the form of the matrix D in Eq. (30), we distinguish two limiting cases, where $j_{LR} j$ dominates $j_{RL} j$ or vice versa. It is obvious that for $j_{RL} j j_{LR} j$ we (approximately) retrieve our previous results since $_1 + _2 =$. The distribution of the AB phase over two sets of matrix elements only complicates the notation. Therefore, the interesting novel limiting case is the one where $j_{RL} j j_{LR} j$. We neglect $_{LR}$ in comparison with V_{RL} and consider again the symmetric case with $_{L} = _{R} =$. Explicitly, the matrix D is given by

The matrix D does not depend upon the AB phase (which now appears only in the matrix elements W in Eq. (13)). Moreover, the interaction V_{LR} causes standard level repulsion between the two resonances. The AB phase dependence of the conductance coe cients becomes complicated not because of the matrix D but because the electron may traverse several di erent paths on its way from the entrance channel to the exit channel. For instance, if the source (sink) is located in part 1 (part 2) of the AB device, there are four possible paths. O ne enters and leaves QDL, one enters and leaves QDL but leaves QDR, and one enters QDR and leaves QDL. The relative weight of the four contributions depends upon the eigenvectors and eigenvalues of the matrix D. A gain, these can be worked out straightforwardly.

Connections to these limiting cases can easily be calculated in terms of a power{series expansion in V_{LR} , or in $_{LR}$ and $_{RL}$. A full diagonalization of the matrix D in Eq. (30) is also possible, covers all the interm ediary cases, and yields interesting results. The eigenvalues " $_{1,2}$ are given by

The eigenvalues coincide whenever the argument of the square root vanishes, i.e., whenever

Eq. (33) extends the de nition of an exceptional point to the gure eight topology. We note that the right (hand side of Eq. (33) is a periodic function of \cdot

6 Summary and Discussion

We have presented a very general approach to the transport properties of an AB device containing two QDs.Ourmain assumptions are:

(i) The electrons do not interact. Then, we can use the Landauer{Buttiker approach and express every observable in terms of the conductance coe cients G. The latter are given as squares of the elements of the scattering matrix S.

(ii) For the description of the the two C oulom b {b lockade resonances, we use the single { level approximation.

(iii) The only relevant energy dependence of S is due to the two C oulom b{ blockade resonances, one in either QD. Then, scattering in parts 1 and 2 of the AB device is independent of energy, and the scattering matrix S attains the form of Eq. (8), with U ⁽¹⁾ and U ⁽²⁾ independent of energy and AB phase.

Under these assumptions, we have presented a comprehensive description of an AB device with the topology of a ring or of a gure eight. In particular, we have displayed explicitly the dependence of the S (matrix upon energy and AB phase. We have shown that a novel situation arises in the case of a ring topology. Here the two resonances (with complex energies) are coupled via the channels in part 1 and part 2 of the AB device. This coupling is given by a Herm itean matrix multiplied by the imaginary unit i. This case di ers fundamentally from the standard coupling of two bound states by a Herm itean interaction. The latter case leads to level repulsion, the form erm ay lead to coalescence of levels. It seems that this phenomenon has been observed in Ref. [1].

We now address the approximations we have made. Perhaps most importantly, we have neglected the Coulomb interaction between the two electrons populating the two QDs, and that between each of these and the electrons on

either QD. Inclusion of the C oulom b interaction would make it in possible to use the Landauer {Buttiker approach as we have done. A Itematives are discussed in a recent review [15]. The standard procedure employs rate equations for the occupation probabilities of the single { particle levels. How ever, this approach is manifestly unsuited to deal with phase correlations between scattering amplitudes. The latter are of central in portance for an AB device. A more elaborate approach [15] uses a description in terms of an elective Hamiltonian. This approach assumes that the single (particle states in the QD are described by random {m atrix theory. The e ective H am iltonian for the isolated Q D is obtained as the leading term in a system atic expansion in inverse powers of g, the dimensionless conductance. The two{term inal conductance is then obtained from the Kubo formula and another e ective Hamiltonian which includes the coupling to the leads. The latter is determ ined via a non{trivial theoretical derivation which in turn involves approximations. To the best of our know edge, this approach has never been used for a multi(term inal device involving an AB ring. Therefore, it is not known whether the approach is able to account for the phases which are relevant for the present system . At su ciently low tem peratures, the C oulom b interaction leads to K ondo { like e ects in Q D 's. Remarkably, the calculation of the phase of a QD embedded in an AB ring has recently been worked out in the K ondo regime [16], in spite of the di culties just m entioned to deal with the C oulom b interaction outside this regime.

In view of this situation, we can only o er a few qualitative remarks in support of the present approach. First, the Coulom b interaction has likew ise been neglected in Refs. [5, 4, 6] which addressed the AB phase for a single QD embedded in an AB ring. The results o ered what seems a realistic and useful description of the overall phase dependence of experim ental observables. Second, our use of the single { level approximation for each QD lends greater plausibility to the inclusion of the charging energy in the de nition of the energies labelled E_P . We admit, however, that the Coulomb energy between the two electrons (one on each QD) is not covered by this argument. Our neglect of the Coulomb interaction is not restricted to the neglect of the charging energy. We have likew ise neglected the spin {dependent interaction between electrons. The latter is induced via the exchange term and lifts the degeneracy between singlet and triplet states $[\beta, 15]$. This spin {dependent interaction plays a prom inent role in K ondo{type e ects. W e expect that this is likew ise the case in the present situation, especially when the two resonances overlap. Therefore, our approach can only be expected to work above the K ondo tem perature.

We believe that our other approximations are less severe. The single level approximation should work at and near an isolated Coulom b {blockade resonance whenever resonance width and temperature are small compared to the charging energy. The neglect of all other energy dependence but that due to the resonances in the scattering matrix should be excellent barring very special circum stances.




Figure 1: Schem atic representation of an AB interferom eter with 5 external leads and two quantum dots labelled QDL and QDR embedded into its arms. The dotted line represents a link between the two quantum dots.
