Phenom enological approach to a transition into the incommensurate phase for thin lm s

A phenom enological theory of the incom mensurate phase transition in thin lms is presented for the case of the single-component order parameter. The order parameter distribution over the lm is obtained under the assumption of slow ly-varying amplitude. The size e ect on the temperature of the phase transition into the incom mensurate phase has been considered.

I. IN TRODUCTION

Num erous recent experim ental studies of thin Im s and sm all particles m anufactured on the base of ferroelectric m aterials, such as BaTiD₃, PbTiD₃ and som e others (see, for exam ple, [1-8] and references therein) have shown that tem peratures of phase transitions into a polarized state change noticeably (mostly, being reduced) with particle size or In thickness decrease, the phase transitions sm eare out and the ferroelectric state is norm ally destroyed at som e particular linear size. Spontaneous polarization, susceptibility, coercive and switching elds are also a ected. Most of these features could be explained within theoretical models developed recently for ferroelectrics (see [9-15]). In particular, a phenom enological approach to the ferroelectric phase transitions in thin Im s and sm all particles was described in [9-11], while the Ising model was used in [12, 13]. The antiferroelectric phase transition in small particles and thin In swas considered later in [17] on the base of the Landau theory. In all papers cited above, the polar states in relevant bulk materials were nonmodulated and the spatial variation of the spontaneous polarization and other param eters was induced by surface only (disregarding uctuations). It is of interest to extend the phenom enological description of phase transitions in low-dimensional system s to transitions into modulated states; in particular, into the incom mensurate phase. Note that som e experimental studies of incom mensurate thin in swere made recently in [18]. The main di culty of the phenom enological consideration of the size e ect on the incom mensurate phase transition is due to the fact that the incommensurate phase in the bulk is described by a nonlinear fourth-order di erential equation for the order parameter contrary to the case of ferroelectrics or antiferroelectrics [19]. Thus, the boundary conditions for the order parameter, which were st suggested by de Gennes [20] and then were generally used in phenom enological approaches to the size e ect, do not su ce. How ever, as it will be shown below, som e assumptions allow us to reduce the problem to a simpler di erential equation and to analyze the incommensurate phase transition quantitatively. The boundary conditions for this approximate equation are deduced from the conditions for the fourth-order one.

In the present paper we suggest for the st time a phenom enological model of the transition into the incommensurate phase in thin Ims.

II. THEORETICALMODEL

Let us consider a thin m of thickness L. We assume that the x axis of the coordinate system is perpendicular to the m surfaces and the origin x = 0 coincides with the m middle. Notice that due to the geometry chosen, the order parameter depends only on x. The order parameter can be the spontaneous polarization if the sample undergoes a transition into the ferroelectric phase at lower temperatures, but the further treatment does not depend signi cantly on its physical nature and may be applied to incommensurate phases of any physical nature. The functional detim ining the equilibrium equation and the boundary condition can be written in the form

where A_0 ; B; C; D are phenom enological parameters, $A_0 > 0$; B > 0; C < 0; D > 0; T_0 is the characteristic tem – perature; the functions ((L=2)) and ((L=2)) determ ine the boundary conditions [22]. Having in m ind that the sym m etric solutions give usually the lowest m agnitude of the therm odynam ic potential in the case of sym m etric sam ples, we consider below only even functions of x for the order parameter distribution: (x) = (x) and only the region of x 0 will be considered explicitly. Varying the functional (), we obtain the Euler equation [21]:

describing the inhom ogeneous equilibrium state and the natural boundary conditions [21]

where F ((x); 0 ; 0) is the integrand of the functional (1), 0 $\frac{d}{dx}$; 00 $\frac{d^{2}}{dx^{2}}$. We choose the simplest relevant form for :

Using the boundary conditions (3) and (5), and the functional (1), we obtain:

These boundary conditions can be used for num erical solving of the fourth-order equation (2). How ever, we consider an approxim ate reduction of this equation to the second-order one, which will be solved exactly.

III. SLOW LY-VARY ING AMPLITUDE

It is known that the order parameter in the bulk incommensurate phase oscillates with a steady amplitude according to the equation $[19] = u \cos(qx)$; where the oscillation wave vector q is given by the relation

W hen the oscillation period in the bulk is implied to be much shorter than the lm thickness, i.e. $\mathcal{P} = C j L^2$, we can assume that the restricted geometry does not in uncess not iceably the period of the order parameter modulation

and yields only alterations in the amplitude u(x) as a function of x. Then the x dependence of in the lm can be written as

Under the assumption of $\mathcal{D} = C j$ L^2 it is reasonable to assume in the spirit of the slow ly-varying amplitude approach that variation of u(x) is smooth enough and its derivatives of order higher than the second one can be om itted. Then the relationship (9) leads to the following second-order di erential equation for the amplitude u:

This equation along with relevant boundary conditions yields a boundary value problem for the amplitude u within the thin lm. The boundary conditions for u can be deduced from the conditions for the fourth-order equation.

IV. BOUNDARY CONDITIONS FOR THE SECOND-ORDER EQUATION

The equation (10) must be supplemented with boundary conditions that can be derived from (6) and (7) using the slow ly-varying amplitude approach. We substitute the expression (9) into these conditions and neglecting higher derivatives of u(x) we obtain a set of equations:

E lim inating the sine and cosine functions from (11) and (12) and introducing the following notation for the logarithm ic derivative,

we obtain a quadratic equation for the logarithm ic derivative:

Its solution reads

The relation (13) plays a role of the boundary condition for the equation (10) for the amplitude. It has a form similar to the mentioned in the Introduction boundary condition of de Gennes. The discriminant $2 \frac{C^3}{4D}$ is always positive since C < 0; D > 0; therefore, is always real. The two roots of (14)

have opposite signes, but only one of them has a physical meaning at a given magnitude of qL. Indeed, compatibility of equations (11) and (12) implies that

This consideration suggests that the magnitude of q is rigidly determined by the condition (8). We have in this case an oscillating dependence of the amplitude logarithm ic derivative at the boundary on the the "sample phase thickness" qL and, therefore, on the temperature. A behaviour of the system is ruled really by more complicated equations than our ones obtained within the slow ly-varying amplitude approach. This means that the real system can violate some of our assumitions in the boundary layer in search of the energy minimum. One way is to tune q so that the energy is minimum. For thick samples qL is rather large and only a very small correction of q would su ce. A nother possibility is to change the wave number q only within some boundary layer. Only numerical analysis of the fourth-order equation can answer the question: which way is chosen by the system. It is easy to see that under the assumptions made the problem for the incommensurate phase transition is reduced to a boundary value problem which is very similar to that for the ferroelectric thin lm. The surface extrapolation length in 1(3) describes the di erence between the surface and the bulk and can be positive or negative. It is natural to suppose that for free thin

In s should be positive. Size e ect in thin $\ln s$ is noticeable when the extrapolation length value is comparable with the $\ln thickness$. Thus, if L is assumed to be much longer than the bulk modulation period 2 =q, the same is valid for : 2 =q. We consider in the next section the analytic solution for the second-order equation.

V. ANALYTIC SOLUTION




FIG.1: The phase portrait for eq. 4. A = 1000, B = 100, C = 200, D - 1, $T_0 = 1$. The dashed lines are the separatrices. The straight lines correspond to the boundary condition (7) at = 1 (1) and = -1 (2).

It is fuitful to analyze the phase portrait of the equation (4), which is presented in Fig. 1.

One can see two regions of solutions separated by separatrices which are shown by dashed lines in Fig. 1. The enclosed curves, which correspond to periodic solutions of (4), lie within the separatrices. The boundary condition eq. (7) bok on the phase diagram as a straight line with negative slope for positive extrapolation lengths and vice versa. It is seen from Fig.1 that for positive extrapolation lengths all possible solutions lie within the region enclosed by the separatrices.

The analytic solution of the equation (4) reads

where sn(z;k) is the Jacoby elliptic sine function [22], $u_0 = u(x = 0)$ is the value of u in the lm middle, k is the elliptic module:

(tn and dn are the Jacoby elliptic functions [22]).

The obtained solutions allow us to nd a distribution of the order parameter amplitude over the lm for some particular sets of phenomenological parameters, lm thickness, and temperature. They also allow us to nd a dependence of the phase transition temperature T_i on the lm thickness for a particular set of the phenomenological parameters, T_i stands for the temperature where u_0 (and therefore u(x)) vanishes.




FIG.2: The order parameter amplitude u versus $x (0 \times L=2)$ for positive at various tem peratures. L = 2; other parameters are given in the caption to Fig. 1. The dashed straight lines show the amplitude in the bulk at the same tem peratures.




FIG.3: The order parameter amplitude u versus x (0 x L=2) for negative at various temperatures. L = 2; other parameters are given in the caption to Fig. 1. The dashed straight lines show the amplitude in the bulk at the same temperatures.

The order parameter amplitude u versus x is depicted in Figs. 2 and 3 for some particular positive as well as negative values of for several magnitudes of the temperature. The phenom enological parameters used are listed in the gure caption. The general behaviour of u(x) for positive is similar to the behaviour of the spontaneous polarization in ferroelectric thin lm s, that is u decreases near the lm surfaces and its value in the lm middle is smaller than for the relevant bulk (Fig. 2).

For negative extrapolation lengths there can be two types of solutions for u(x) in agreem ent with the phase diagram (Fig. 1). The behaviour of the solution shown in Fig. 3 is similar to that discussed for ferroelectric thin lm s: u increases near the lm surfaces and its value in the lm middle is larger than for the relevant bulk.

The amplitude u within the lm for the second solution is smaller than in the bulk, while its absolute value increases near the surfaces, and the amplitude changes its sign at some x that is equivalent to a change of the incom m ensurate m odulation phase. However, calculation of the equilibrium therm odynamic potential of the lm for two solutions at the negative shows that the rst kind of solutions (with u is higher than in the bulk) is energetically m ore favourable.

The size dependence of the incom mensurate phase transition temperature for positive and negative extrapolation lengths is shown in Fig. 4.0 ne can see that T_i decreases with decreasing lm thickness at positive and vanishes at some critical thickness. Similar dependence was obtained for ferroelectric and antiferroelectric thin lm s, when was implied to be positive [9,17]. The size dependence of T_i for negative is opposite.

VI. CONCLUSIONS

In conclusion, the phenom enological theory of the incom mensurate phase transition in thin lm s is presented. It was shown that under the assumption of slow ly-varying am plitude of the order parameter the model can be reduced to a boundary value problem for the second-order di erential equation with conventional hom ogeneous boundary conditions that can be deduced from ones for the fourth-order equation. The am plitude of the order parameter was found to decrease near the lm surface for positive extrapolation lengths and to increase for negative extrapolation lengths. The tem perature T_i of the transition was shown to decrease with decreasing the lm thickness for positive extrapolation lengths, the phase transition cannot occur in lm s with thickness less than some critical value.




FIG.4: Size dependence of the transition tem perature.
