From phase separation to long-range order in a system of interacting electrons

A bstract

We study a system composed of fermions (electrons), hopping on a square lattice, and of immobile particles (ions), that is described by the spinless Falicov {K imball Hamiltonian augmented by a next-nearest-neighbor attractive interaction between the ions (a nearest-neighbor repulsive interaction between the ions can be included and does not alter the results). A part of the grand-canonical phase diagram of this system is constructed rigorously, when the coupling between the electrons and ions is much stronger than the hopping intensity of electrons. The obtained diagram implies that, at least for a few rational densities of particles, by increasing the hopping intensity the system can be driven from a state of phase separation to a state with a long-range order. This kind of transitions occurs also, when the hopping ferm ions are replaced by hopping hard-core bosons.

1 Introduction

Since forty years, it is the Hubbard or the extended Hubbard models that are most frequently studied when properties of strongly correlated electrons are to be investigated. The central issue is the phase diagram of these models. Despite the apparent simplicity of both models and concerted e orts of

m any researchers, the complicated structure of these phase diagrams, even at zero tem perature, has not been revealed com pletely and unquestionably; rigorous results are scarce. A few years ago Nakamura [1] predicted a new kind of quantum phase transition in the ground state of a half-lled extended Hubbard model chain. On a line, in the space of the two relevant interaction param eters (representing on-site and nearest-neighbor (nn.) repulsion due to Coulomb forces, expressed in the units of the hopping intensity), for large values of these parameters, the system is in the phase separated state, which is a mixture of a charge-density-wave phase and a spin-density-wave phase. The transition occurs when the param eters are decreased along the line, at a critical point where the parameters assume intermediate values (of the order of one). Thus, the transition region is hardly accessible by perturbation methods. A new state exhibits a long-range order, the so called bond-order-wave. There are many aspects of the phase diagram to be studied in connection with the new conjectured transition, and they are vigorously discussed in the physics literature recently [2{4]. In this paper we address just one aspect of the new transition that we nd remarkable. Namely, by increasing the hopping intensity of electrons the system is driven from a phase-separated state to a crystalline state with a long-range order. Our aim is to construct a model of interacting electrons (by the way we consider an analogous model of interacting hard-core bosons), where the existence of a transition exhibiting this feature can be dem onstrated rigorously. The model to be studied is a simplied version of the one band, spin 1=2 Hubbard model, known as the static approximation (one sort of electrons hops while the other sort is immobile), with the Hamiltonian H_{FK} , extended by a next-nearest-neighbor (n.n.) attractive interaction between the imm obile particles, given by the H am iltonian V. Thus the total H am iltonian of the system reads:

In the above form ulae, the underlying lattice is a square lattice, denoted , consisting of sites x;y;::: whose number is j j having the shape of a j j q j j torus. In (2,3) and below, the sum s $P_{\text{hx},\text{yi}_{i}}$, i = 1;2;3, stand for the sum m ation over all the i-th n.n. pairs of lattice sites, with each pair counted once.

The subsystem of mobile spinless electrons is described in terms of creation and annihilation operators of an electron at site $x: c_x^+$, c_x , respectively, satis-

fying the canonical anticom mutation relations, with t being the n.n. hopping intensity. The total electron-num ber operator is $N_e = \sum_{x} c_x^{\dagger} c_x$, and (with a little abuse of notation) the corresponding electron density is $e = N_e = jj$.

The subsystem of ions is described by a collection of pseudo-spins $f_{s_x}g_{x^2}$, with $s_x = 1$; 1 (1 if the site x is occupied by an ion and 1 if it is empty), called the ion con gurations. The total number of ions is $N_i = \sum_{x}^{P} (s_x + 1) = 2$ and the ion density is $i = N_i = j$. In contradistinction to the electron subsystem, the ions interact directly: two ions that occupy two nnn. sites attract each other, contributing the energy n = 16, with n > 0.

C learly, in the composite system, whose Ham iltonian is given by (1), with arbitrary electron-ion coupling U, the particle-num ber operators N_e , N_i , and pseudo-spins s_x , are conserved. Therefore the description of the classical subsystem in term softhe ion con gurations $S = fs_xg_{x2}$ remains valid. Whenever periodic con gurations of pseudo-spins are considered it is assumed that is su ciently large, so that it accommodates an integer number of elementary cells.

N ow adays, H_{FK} is widely known as the H am iltonian of the spinless Falicov { K in ball model, a simplied version of the H am iltonian put forward in [5]. A lot of results, including rigorous ones, like a proof of the existence of a phase transition [6,7] for instance, have been obtained for the system described by this H am iltonian (a review and an extensive list of references can be found in [8,9]).

In what follows, we shall study the ground-state phase diagram of the system de ned by (1) in the grand-canonical ensemble. That is, let

where $_{e, i}$ are the chem ical potentials of the electrons and ions, respectively, and let E_{s} ($_{e; i}$) be the ground-state energy of H ($_{e; i}$), for a given con guration S of the ions. Then, the ground-state energy of H ($_{e; i}$), E_{G} ($_{e; i}$), is de ned as E_{G} ($_{e; i}$) = m in f E_{s} ($_{e; i}$) :Sg. The m inimum is attained at the set G of the ground-state con gurations of ions. We shall determ ine the subsets of the ($_{e; i}$)-plane, where G consists of periodic con gurations of ions, uniform ly in the size of the underlying square lattice.

The paper is organized as follows. In the rst subsection of the next section we provide a number of symmetry properties of the ground-state energy, E_s ($_{e}$; $_i$), which facilitate the studies of the phase diagram that follow, and give the strong-coupling expansion of E_s ($_{e}$; $_i$) in the case of hopping fermions (subsection 2.1). Then, in subsection 2.2 we construct the grandcanonical phase diagram due to the ground-state energy truncated at fourth order of the strong-coupling expansion in the case of hopping fermions (this is su cient to draw our conclusions). A fler that, in subsection 2.3 we consider the grand-canonical phase diagram due to the ground-state energy truncated at fourth order of the strong-coupling expansion in the case of hopping hard-core bosons. Finally, in Section 3 we discuss the implications of the phase diagram obtained with the truncated e ective interaction, when the remainder of the strong-coupling expansion is taken into account.

2 G rand-canonical phase diagram in the strong coupling regime

2.1 Properties of E $_{\rm S}$ ($_{\rm e};$ $_{\rm i})$ and its strong-coupling expansion

In studies of grand-canonical phase diagram s an important role is played by unitary transform ations that exchange particles and holes: $c_x^+ c_x ! 1 c_x^+ c_x$ s_x , and for some $\begin{pmatrix} 0 \\ e \end{pmatrix}$; $\begin{pmatrix} 0 \\ i \end{pmatrix}$ leave the Ham iltonian H $\begin{pmatrix} e \\ i \end{pmatrix}$ invariand s_x ! ant. For the electron subsystem such a role is played by the transform ations: c_x^+ ! $_xc_x$, with $_x = 1$ at the even sublattice of and $_x = 1$ at the odd one. C learly, since H $_0$ is invariant under the joint hole{particle transform ation of electrons and ions, H ($_{e;i}$) is hole (particle invariant at the point (0;0). At the hole (particle symmetry point, the system under consideration has very special properties, which simplify studies of its phase diagram [7]. M oreover, by m eans of the de ned above hole (particle transform ations one can determ ine a number of symm etries of the grand-canonical phase diagram [10]. The peculiarity of the model is that the case of attraction (U < 0) and the case of repulsion (U > 0) are related by a unitary transformation (the hole { particle transform ation for ions): if S is a ground-state con guration at (e; i) for U > 0, then S is the ground-state conguration at (e; i)i) for U < 0.Consequently, without any loss of generality one can x the sign ofthe coupling constant U. Moreover (with the sign of U xed), there is the inversion symmetry of the grand-canonical phase diagram, that is, if S is a ground-state conguration at $(_{e};_{i})$, then S is the ground-state conguration at (i). Therefore, it is enough to determ ine the phase diagram in the half-plane specied by xing the sign of one of the chemical potentials. Additional properties em erge in the strong-coupling regime, i.e. for jJ j > 4t[10]. Speci cally, if the electron chemical potential is in the open interval $j_e j < j U j$ 4t, then for any two ion con quantions S, S⁰ the energy di erence $E_s(e; i) = E_{s^0}(e; i)$ is constant along the lines $e_i = const, w$ ith m inus sign referming to the case of positive U (repulsion) while the plus sign to the case of negative U (attraction). This property together with the inversion symmetry implies that in the stripe $j_e j < J j$ 4t of the (e; i)-plane it is enough to determ ine the phase diagram at the half-line $_{\rm e}$ = 0, $_{\rm i}$ < 0 (or $_{i} > 0$).

O ur aim in this paper is to investigate the ground-state phase diagram o the sym m etry point. A coording to the state of the art, this is feasible only in the strong-coupling regime. From now on, we shall consider exclusively the case of the strong positive coupling, i.e. U=t > 4. In this case, it is convenient to express all the parameters of H ($_{e}$; $_{i}$), in the units of jJ j i.e. we change t ! t=jJ j ⁿ ! ⁿ=jJ j etc, but keep the previous notation. Then, H₀ assumes the form

and the strong-coupling regime is given by the condition t < 1=4. The possibility of studying the phase diagram in the strong-coupling regime stems from the fact that in the open stripe $j_e j < 1$ 4t, the ion density $_i$ of a ground-state conguration determines the electron density: $_e = _i$ for U < 0, and $_e = 1$ $_i$ for U > 0. Then, one can form ally expand the ground-state energy E_s ($_e$; $_i$) in powers of t, what results in the so called electrice H am iltonian:

up to a term independent of the ion con guration and the chem ical potentials. In (6), P denotes the (2 2)-plaquette of the square lattice , s_P stands for the product of pseudo-spins assigned to the corners of P, and the remainder R⁽⁴⁾, which is independent of the chem ical potentials and \mathbf{u} , collects those term s of the expansion that are proportional to t^{2m} , with m = 3;4;:::. The expansion (6) (with $\mathbf{u} = 0$) was introduced and the phase diagram, according to the expansion truncated at the fourth order, was studied in [10]. It turns out how ever that, in the strong-coupling regime the expansion (6) is absolutely convergent, uniform ly in [11,12]. D ue to this fact, it is possible to establish rigorously a part of the phase diagram (that is the ground states are determined everywhere in the ($_{e}$; $_{i}$)-plane, except som e regions), by determining the phase diagram of the expansion truncated at the order k, that is according to the external phase diagram of the expansion truncated at the order k, that is according to the external phase diagram of the expansion truncated at the order k.

2.2 Construction of the phase diagram up to fourth order. The case of hopping ferm ions

To construct the phase diagram according to the e ective H am iltonian $E_s^{(k)}$ ($_e$; $_i$), we use the m-potential method introduced in [13], with technical developments given in [10{12]. By virtue of the comments in the preceding subsection, in what follows we set $_e = 0$ and $_i =$. In the order zero the elective H am iltonian reads:




Fig.1.G round-state phase diagram of E $_{\rm s}^{(0)}$ (0;).

Except the point = 0, $\mathbf{u} = 0$, where all the con gurations have the same energy, the plaquette potentials H $_{\rm p}^{(0)}$ are m inim ized by the restrictions to P of a few periodic con gurations on .For < 0 (> 0) it is the ferrom agnetic con guration S (S₊), where $s_x = 1$ at every site ($s_x = +1$ at every site), while at the half-line = 0, $\mathbf{u} > 0$, besides the ferrom agnetic con gurations S and S₊, these are the two antiferrom agnetic (or chessboard) con gurations S $_{cb}^{e}$, where $s_x = x$, and S $_{cb}^{\circ}$, where $s_x = x$, with x = 1 if x belongs to the even sublattice of and x = 1 otherwise. Moreover, out of the restrictions S $_{p}^{e}$, S₊ $_{p}^{e}$, S $_{cb}^{e}$, and S $_{cb}^{\circ}$ only four ground-state con gurations can be built, which coincide with the four con gurations. The phase diagram according to the e ective H am iltonian E $_{s}^{(0)}$ (0;) is shown in Fig.1.

In the next order, which takes into the account interactions proportional to t^2 , a n.n. antiferrom agnetic interaction appears. The elective H am iltonian reads

By determ ining the plaquette con gurations that m inim ize the potentials H $_{\rm P}^{(2)}$ one nds the ground-state phase diagram shown in Fig. 2. The boundary between S₊ and S , determ ined in the order zero, i.e. the half-line = 0, $\mathbf{u} > 0$, is replaced by the stripe of the width 4t², centered at this half-line. O utside this stripe the ground state rem ains ferrom agnetic. Inside the stripe, including its boundary on the line $\mathbf{u} = 0$, there are only two ground-state con gurations, the antiferrom agnetic ones. At the boundary of the stripe, given by = $2t^2$; $\mathbf{u} > 0$ ($= 2t^2$; $\mathbf{u} > 0$), there are exactly three ground-state con gurations S , $S^{\rm e}_{\rm cb}$, and $S^{\circ}_{\rm cb}$ (S₊, $S^{\rm e}_{\rm cb}$, and $S^{\circ}_{\rm cb}$). O nly at the points ($= 2t^2$; $\mathbf{u} = 0$) the number of ground-state con gurations grows exponentially with the size of the underlying lattice (like exp (constj j)). The H am iltonian

with the size of the underlying lattice (like exp(constj j)). The Ham litonian $E_s^{(2)}$ (0;) is known in the physics literature as the Fisher-stabilized Ising antiferrom agnet [14].

To proceed further and analyze the e ect of the fourth-order interactions, we make use of the inversion symmetry that enables us to x, without any loss of generality, the sign of the chemical potential. From now on, we restrict our investigations to the case < 0.

Let us emphasize that we are interested in the phase diagram for su ciently smallt. Therefore clearly, it is the neighborhood of radius O (t⁴) of the point = $2t^2$; n = 0, in the (; n)-plane, where the e ect of the fourth order interactions can be most signi cant. In this neighborhood, it is convenient to introduce the new coordinates, , ", as follow s:

In term s of , ", the e ective H am iltonian up to the order four can be written in the form :

where we have om itted the term $t^2 j j=2$. In (12,13), T stands for a (3 3)plaquette (later on called the T-plaquette) of the square lattice, whose sites are labeled from the left to the right, starting at the bottom left corner, so that s_5 is the pseudo-spin of the central site and its left-neighbor pseudo-spin is s_4 . The above form of $E_s^{(4)}$ (0;) shows manifestly that, in a neighborhood of the point = 0, " = 0 whose radius is 0 (1), those con gurations that contain pairs of n.n. sites, hx; yi₁, with pseudo-spins $s_x = s_y = 1$ cannot be the ground state con gurations (their energy is larger than the energy of the con gurations that do not contain such pairs by a large energy of the order 0 (t^2)). Therefore, in the considered region of the phase diagram, all the e ects due to the interactions up to fourth order are described by the e ective H am iltonian H $_e^{(4)}$, and the only adm issible con gurations are those that do not contain any pairs of n.n. sites with pseudo-spins taking the value 1.

To determ ine the phase diagram due to $H_e^{(4)}$ we use, as before, the m-potential m ethod. However, in contrast to the lower-order cases the analysis is not that straightforward. The potentials $H_T^{(4)}$ cannot serve as the m-potentials in the whole (;")-plane. This di culty can be overcom e by introducing the so called zero-potentials [10{12}. Here, we follow closely [11,12] and introduce the zero-potentials $K_T^{(4)}$ such that they are invariant with respect to the symmetries of H_0 and satisfy the condition




Fig. 3. All the adm issible T-plaquette con gurations (up to symmetries).

W e note that the potentials $k_{\rm T}^{\rm (i)}$ are invariant with respect to the sym m etries of the H am iltonian H $_0$ and they satisfy the condition (14). Consequently, the sam e properties are shared by the potentials K $_{\rm T}^{\rm (4)}$. Now, we can rewrite H $_{\rm e}^{\rm (4)}$ as follows




Fig. 4.G round-state phase diagram of H $_{e}^{(4)}$. By the crossing points of boundary-line segments we give their coordinates. The numbers in curly brackets, displayed by the arrows pointing towards the boundary-line segments, identify the additional minimizing T-plaquette con gurations. For more comments see the text.

and the problem is to nd, at each point (;"), the T-plaquette con gurations that m inim ize the potential $H_T^{(4)} + K_T^{(4)}$. Taking into account the symmetries of the H am iltonian, there are 20 adm issible T-plaquette con gurations whose energies have to be compared. These con gurations are displayed and labelled (as in [11]) in Fig. 3. The explicit analysis shows that the (;)-plane decom – poses into ve open domains S, S_{cb} , S_1 , S_2 , and S_3 , whose boundaries consist of straight-line segments, see Fig. 4. We shall adopt the same symbols to denote also the sets of ground-state con gurations in these domains. In each point (;") of a domain, it is possible to choose the values of the coe cients

i such that the set of T-plaquette con gurations m inim izing the potential H $_{\rm T}^{~(4)}$ + K $_{\rm T}^{~(4)}$, denoted S $_{\rm cbT}$, etc., is the sam e.Rem arkably, out of these m in-




Fig. 5. G round-state con gurations, which appear for < 0.

in izing T-plaquette con gurations (in a dom ain) one can construct exactly one, up to the symmetries of H₀, ground-state con guration on the lattice . The obtained con gurations turn out to be periodic. Specifically, one indicates the minimizing T-plaquette con gurations are: S_T = flg, S_{doff} = f17;20g, S_{1ff} = f2;8g, S_{2ff} = f2;5;11g, and S_{3ff} = f12;13g, where the numbers in the curly brackets stand for the labels, according to Fig. 3, of the minimizing T-plaquette con gurations, and the T-plaquette con gurations that can be obtained from the named ones, by applying symmetries of H₀, are om itted. Consequently, the sets of ground-state con gurations in the velopen domains are given by: S = fS g, S_{ab} = fS^e_{ab}; S^o_{ab}g, S₁ = fS¹₁g^{j=10}_{j=1}, S₂ = fS¹₂g^{j=8}, and S₃ = fS¹₃g^{j=6}, where the representative con gurations of S_{ab}, S₁, S₂, and S₃, are displayed in Fig. 5. The coe cients _i are given in the Table 1 included in Appendix.

For " = 0 the obtained phase diagram coincides with the phase diagram of the spinless $Falicov\{K \text{ in ball m odel [10,12]. If " < 12, when is increased, it$

crosses som e \critical" values, $_{\rm cr}$ ("), that lim it the -extent of the dom ains S , S₁, S₂, S₃, and S_{cb}. In particular, $_{\rm cr}$ (0) = 1=2, 2, 6, 21=2, respectively. Sim ilarly, as " is increased, it passes through three \critical" values " $_{\rm cr}$ = 4, 8, 12, that lim it the "-extent of the dom ains S₂, S₁, S₃, respectively. Thus, there is no S₂ ground-state con gurations for " > 4, etc. Above " = 12 the phase diagram is independent of ".

At the boundaries of the dom ains the situation is more involved. Let S, S^0 be two dom ains of the considered phase diagram. The set of the minimizing T - p laquette congurations at the boundary between S and S^0 consists always of $S_T [S_T^0]$, but it may contain also some additional T-plaquette congurations of minimal energy. If it is the case, a great many of ground-state congurations exists at the boundary. Except the boundary between S and S_{cb} , the number of ground-state congurations that can be built out of the minimizing T - p laquette congurations grows inde nitely with the size of the lattice.

Speci cally, at the boundary between S and S_{cb} the set of the minimizing T-plaquette con gurations is S $_{T}$ [S_{cbT}.Clearly, only the three periodic con gurations, S , S^o_{cb}, and S^o_{cb}, can be built out of them.

Then, at the boundary between S and S₃ the set of the minimizing T-plaquette con gurations is S $_{\rm T}$ [S₃ $_{\rm T}$ [f4;7;9g.A simple reasoning shows that in any ground-state con guration all the lattice lines with one of the slopes 1 or 1 are ordered ferrom agnetically. On any horizontal line of sites, every two consecutive sites with pseudo-spins 1 are separated by at least two sites with pseudo-spins 1. That is, the ground-state con gurations at the boundary <code>\interpolate"</code> between the con <code>qurations S₃</code> and S. The number of such congurations grows as exp (const j). The last segment of the boundary of S is the boundary between S and S₁. The set of the minimizing T-plaquette con gurations is S $_{\rm T}$ [S₁ $_{\rm T}$ [f3;4;9g. Therefore, ipping in S₁ any set of pseudo-spins 1, we obtain a ground-state con guration. Their number grows as exp (const j).

The situation at the boundary between S_1 and S_3 is more intricate. The set of the minimizing T-plaquette congurations is S_{1jT} [S_{3jT} [f6g. In any ground-state conguration the lattice lines with one of the slopes 2, 1=2, 2, or 1=2 are ordered ferrom agnetically. A long such a line, it is possible to build a stratum, of any width, that consists of elementary cells of S_1 kind ($\overline{5}$) squares) (see Fig. 5), then a stratum that consits of elementary cells of S_3 kind (diam onds), and so on. The number of such periodic congurations grows as exp (const j). Moreover, it is possible to build quasi-periodic tilings com – posed of square elementary cells and diam onds [15].

The three boundaries that remain to be described, have already been discussed in the literature. At the boundary between S_3 and S_{cb} , the set of the minimizing T-plaquette con gurations is S_{3T} [S_{cbT} [f19g. In any ground-state con guration the lattice lines with slope 1 or 1 are ordered ferrom agnetically. On every horizontal and every vertical line of sites, any two consecutive sites with pseudo-spins 1 are separated by either one or two sites with pseudospins equal to 1 [11]. Thus, the number of such con gurations grows as exp (const j).

N ext, at the boundary between S_2 and S_3 the set of them inimizing T-plaquette con gurations is $S_{2\#}$ [$S_{3\#}$ [f6g. In any ground-state con guration the lattice lines with one of the slopes 2, 1=2, 2, or 1=2 are ordered ferrom agnetically. If the slope is 2, on every vertical line of sites, any two consecutive sites with pseudo-spins 1 are separated by either two or three sites with pseudo-spins 1. If the slope is 1=2, on every horizontal line any two consecutive sites with pseudo-spins 1 are separated by either two or three sites with pseudo-spins 1.

1 [11]. The number of such congurations grows as exp (const j).

Finally at the boundary between S_1 and S_2 , the set of the minimizing T – plaquette con gurations is S_{1T} [S_{2T} . Here the situation is analogous to that of the boundary between S_1 and S_3 [15].

2.3 Construction of the phase diagram up to fourth order. The case of hopping hard-core bosons

In the case of hard-core bosons, the creation and annihilation operators at site $x: c_x^+$, c_x , respectively, satisfy the anticom mutation relations, as ferm ions, but in contrast to ferm ions they commute at di erent sites. Consequently, with the system of hard-core bosons, described by the Hamiltonian (5), we cannot associate a one-particle Hamiltonian and derive the small t e ective interaction as in the case of ferm ions. The elective interaction up to fourth order has been derived in [12] by means of a closed-loop expansion, and reads:

The above expansion is convergent absolutely if t < 1=16 and $j_e j < 1$ 16t. The latter condition in plies that $N_e + N_i = jj$. Setting in (18) $_e = 0$, $_i =$




Fig. 6.G round-state phase diagram of $H_e^{(4)}$. See description of Fig. 4.

 $2t^2 + t^4$, and dropping the remainder $\mathbb{R}^{(4)}$, we get the elective interaction up to fourth order, $\mathbb{E}_{\rm S}^{(4)}$ (0;), and the elective Ham iltonian, $\mathbb{H}_{\rm e}^{(4)}$, defined as in (12). Then, repeating all the steps of the construction of the phase diagram up to fourth order, carried out for fermions in the previous section, leads to the phase diagram displayed in Fig. 6. The diagram in Fig. 6 is described in the same way as the diagram in Fig. 4. If the phase diagram due to $\mathbb{E}_{\rm S}^{(4)}$ (0;) is limited to positive ", then it diers significantly from its counterpart for fermions, the S₂-domain is missing. But the analysis extended to negative values of " reveals the S₂-domain, and show s that the phase diagram of hardcore bosons, limited to "> 4, after translating by the vector (2;4) becomes identical with the phase diagram of fermions, limited to " > 0.

3 Discussion of the phase diagram and sum mary

The ground-state phases of the whole electron-ion system under consideration can be distinguished by their ground-state arrangem ents of ions. Thus, we can speak of S_{cb} -phase, where the arrangem ent of the ions is given by the chessboard con gurations, etc. Let us ignore for the moment the remainder R⁽⁴⁾ in the expansion (6). Then, it follows from the grand-canonical phase diagram due to the elective interaction truncated at fourth order that if $_{i} = _{e} = 1=2$,

then the ground-state phase is the S_{cb} -phase. M ore generally, consider a sequence of rational ion densities $_i = 0, 1=5, 1=4, 1=3, 1=2$ (and the corresponding electron densities $_e = 1$ $_i$). Then, for some densities of this sequence, depending on ", the ground-state phases of the system are characterized by crystalline, i.e. exibiting positional long-range order, arrangements of the ions, given by the ion congurations S , S_1, S_2, S_3 and S_{cb} , of the corresponding density. For " > 12, we can have only two crystalline phases: S -phase and S_{cb} -phase. At the half-line, given by = 9=2 and " > 12, these two phases and only these two ones coexist, i.e. any S that is not in S [S_{cb} has higher energy. Since,

where $H_{e}^{(4)}$, $H_{T}^{(4)}$, and $K_{T}^{(4)}$ are evaluated at = 9=2, and $E_{T}^{(;cb)}$ stands for the common value of $H_{T}^{(4)} + K_{T}^{(4)}$ obtained for S 2 S [S_{cb} and = 9=2, the coexistence of S -phase and S_{cb}-phase follows from the following inequality:

for any con guration S and " > 12. In (20), H_T⁽⁴⁾ and K_T⁽⁴⁾ are also evaluated at = 9=2, T_{jdb}(S) stands for the set of the T-plaquettes such that S_T does not coincide with T-plaquette con gurations labelled by 1, 17, 20 (we call T_{jdb}(S) the set of T-plaquette excitations relative to the con gurations in S [S_{db}), $T_{jdb}(S)$ j is the cardinality of T_{jdb}(S), and C⁽⁴⁾ is a constant (i.e. C⁽⁴⁾ is independent of S, t, ", and). The inequality (20), together with the variational argument constructed in [16], can be used to prove that for any density 0 < i < 1=2, the ground-state phase is a mixture (a state of phase separation) of the S -phase and S_{cb}-phase. Speci cally, the variational argument show sthat for " > 12 there is a constant c⁽⁴⁾ such that in any groundstate the number $T_{jdb}(S)$ j of T-plaquette excitations is bounded from above as follow s:

This means that, for 0 < i < 1=2 and su ciently large lattice, any groundstate con guration of ions consists of connected regions whose ion con gurations are restrictions to these regions of one of the con gurations S , S_{cb}^{e} , S_{cb}° . These connected regions are separated by dom ain walls that involve negligible, i.e. 0 (j j $^{1=2}$) (for large lattice), fraction of sites.

Now, let us x the ion density, $_{1} = 1=5 \text{ or } 1=4 \text{ or } 1=3$, and a su ciently sm all t. If we choose an initial value of " so that " = "=t⁴ is greater than 12 (i.e. initially the system is in the state of phase-separation), then by decreasing " su ciently the system is driven into a crystalline state. But obviously, the same result can be arrived at, if we x the value of " and an (su ciently sm all) initial value of to so that " = "=t⁴_{0} = 13, for instance, and then increase t. If not the fact that we have ignored the remainder R⁽⁴⁾ in the elective interaction, this would be the announced in the Introduction statement. Thus, it remains to be proven that the remainder R⁽⁴⁾ does not destroy the picture obtained with the truncated elective interaction E⁽⁴⁾_S.

First, we shall dem onstrate that if we take into account R $^{(4)}$, then there is a

(su ciently small) constant t₀ such that for t < t₀ the sets of ground-state con gurations of ions for densities $_{i} = 1=5, 1=4, 1=3$ coincide with the sets S₁, S₂, and S₃, respectively. Speci cally, we shall show that for t < t₀ there are nonem pty two-dimensional open domains S₁¹, S₂¹, and S₃¹ that are contained in the domains S₁, S₂, and S₃, respectively, and such that in S_j¹, j = 1;2;3, the set of ground-state con gurations is S_j. To achieve this we shall construct a lower bound for the energy di erence E_S (0; 2t² + t⁴) E_{S_j} (0; 2t² + t⁴), with S_j 2 S_j. C learly, we can restrict the set of all con gurations S to those that do not contain any pairs hx; yi₁ with S_x = s_y = 1.W ith this restriction,

Note that S_j is an open convex domain in the (;")-plane. For (;") 2 S_j , the function (;") ! $_j$ (;"), being the minimum of a nite set of positive linear functions, is concave, piecewise linear and positive. It vanishes only at the boundary of S_j . Therefore, there is a (su ciently small) t₀ such that for $t < t_0$ the value of r_jt^2 is less than the maximum of $_j$ over S_j . Then, the level set f(;"): $_j$ (;") > r_jt^2g is a nonempty convex open set, contained in domain S_j . At this level set the ground-state con gurations coincide with the con gurations from S_j .

Second, we shall show that for a su ciently small t the inequality (21) is modi ed by R $^{(4)}$ only slightly, so that the conclusions drawn from (21) remain

valid. The remainder R $^{(4)}$ can be estimated in the following way [16]:

Consequently, for any density 0 < i < 1=2 and n.n.n. interaction "> 12 + 64r , the ground-state phase is a mixture of the S -phase and S_{th}-phase.

Sum m ing up, let the ion density be one of $_i = 1=5, 1=4$, and 1=3, and let the corresponding electron density be $_e = 1$ $_i$. We restrict our considerations to the case $_i < 1=2$, since the situation for $_i > 1=2$ can be obtained by m eans of sym m etries (see subsection 2.1). Let the hopping intensity t be su ciently sm all. Then, we have proved that the considered system can be driven from the state of phase separation (the m ixture of S - and S_{cb}-phases) to a crystalline state with a long-range order, which is the S_j-phase whose particle densities are the chosen ones, by increasing quantum uctuations (m easured by t) due to the hopping electrons.

Finally, it is easy to see that if the considered model is augmented by a n.n. repulsion between the ions, then the above analysis of the phase diagram can be carried out without any essential modi cations. Thus, we arrive at the same conclusions concerning the transition from a state of phase separation to a state with a long-range order due to increasing hopping.

A similar discussion can be carried out in the case of hard-core bosons, with one exception. Our analysis shows that the transition from a state of phase separation to a state with a long-range order due to an increasing hopping occurs for densities $_{i} = 1=5, 1=3$.
