E lasticity-driven interaction between vortices in type-II superconductors

The contribution to the vortex lattice energy which is due to the vortex-induced strains is calculated covering all the magnetic eld range which de nes the vortex state. This contribution is compared with previously reported ones what shows that, in the most part of the vortex state, it has been notably underestimated until now. The reason of such underestimation is the assumption that only the vortex cores induce strains. In contrast to what is generally assumed, both core and non-core regions are important sources of strains in high-superconductors.

I. IN TRODUCTION

Since long time ago, much attention has been paid to the role of long-range strain elds in the vortex state of type-II superconductors. It is well known, for instance, that interaction between defectinduced strains and vortices causes pinning phenomena. These phenomena have been extensively studied almost since Abrikosov predicted the superconducting vortices (see, e.g., $Refs^{1,2,3,4,5,6,7,8}$). It is also known that vortex-induced strains give a contribution to the energies of the vortex lattices (VL). This contribution proves to be essential when discussing the observed correlations between VL's and crystal lattices in anisotropic superconductors. 10,11,12 The vortex-induced strainsm ight be im portant in vortex inertia also, because they contribute to the e ective m asses of vortices. 13

In this paper, we calculate the contribution to the VI energy which is due to the vortex—induced strains. Comparison with the previously reported calculations 10,11,12 shows that, for magnetic elds not so close to the upper critical eld H $_{\rm c2}$, this contribution has been notably underestimated until now. The reason of such underestimation is connected with the fact that, contrary to what is assumed in many occasions, the vortex core is not the primary source of strain when the G inzburg-Landau parameter of the superconductor is large.

To clarify this point we shall revise, rst of all, the strain induced by a single vortex. This strain is due to all the spatial variations of the density of superconducting electrons that the vortex provokes. The vortex core is a region of strong variations, but is not the only one. There also exist a region of sm ooth variations which is associated with the presence of superconducting currents. In high—superconductors, the size of the latter region is much larger than that of the core. Just because of this greater extension, the non-core variations of the density of superconducting electrons are what nally emerge as the main sources of strains.

P revious calculations 10,11,12 of the elasticity-driven interaction between vortices was based on models that as-

sume, from the beginning, that only the vortex cores induce strains. So an important source of strains in high-superconductors is overboked in all these works. But note that, even doing so, it was shown that this interaction was strong enough to explain the observed correlations between VL's and crystal lattices in NbSe₂. We revise this elasticity-driven interaction showing that the proper inclusion of all the sources of strain increases its importance in the corresponding problems.

Let us mention that we evaluate this interaction taking into account all the elastic degrees of freedom of free samples of nite size, i.e. taking into account that both hom ogeneous and inhom ogeneous deform ations are possible. In a general case, the elasticity-driven interaction between vortices include contributions due to both hom ogeneous and inhom ogeneous deform ations. In the elastically isotropic case the contribution due to the inhom ogeneous deform ations vanishes. But in any case, the order ofm agnitude of the total interaction coincides with that of the contribution which is due to the hom ogeneous deform ations.

The consideration of hom ogeneous deform ations provides us, in addition, an useful technical trick. It is based on to evaluate rst the VL energy in the case in which the superconductor is elastically isotropic and its shear is in nite. In this case, the calculations are m odulus free of approximations and are almost trivial. If = 1, the only elastic degree of freedom of the sample is its hom ogeneous dilatation. Therefore, using already known form ulas for the VL energy and taking into account the dependence on the dilatation of the corresponding coefcients, the elastic contribution can be easily computed. Asweshallsee, any isotropic case can be reproduced from this = 1 one. Moreover, the previously reported results can be easily checked by evaluating them for = 1and comparing them with those obtained considering this case from the beginning.

Let us mention also that we use the Fourier method when computing the VL energy in the elastically anisotropic case. This method permits to satisfy quite easily the boundary conditions of the elastic problem which correspond with those that take place in real ex-

perim ents. Thus, one avoids to reproduce spurious elects that a lack of attention to these conditions might give. One of such elect is, for instance, the sample form dependence of the elasticity-driven interaction between vortices (the same group of authors reported this dependence in $Ref.^{11}$ but not in $Ref.^{12}$).

II. ON THE ELASTIC EFFECTS W ITH IN THE LONDON LIM IT

W hen studying the in uence of the elasticity on the vortex properties, m any authors use an assum ption which might seem quite natural (see, e.g., Refs. 2,5,10,11,12). It consists of using the \London approximation" introduced by Abrikosov in Ref. (see also Ref. 15). However, the essence of this approximation could easily be misinterpreted. As it is frequently commented, within the London approximation the order parameter modulus varies signi cantly inside of the vortex cores only. Since the spontaneous deform ation associated with the superconductivity is proportional to square of the order param eterm odulus, it seem ed natural that only the core regions (.) are essential sources of stresses. It is just what is assumed in Refs. 2,5,10,11,12. However, one has to bear in m ind that supercurrents also produce an elastic e ect because they dim in ish the value of the order param eter modulus. Locally this diminishing is small. But since the supercurrents occupy a very broad region (. L), their e ect m ight be com parable and even m ore im portant, as virtually proves to be, than that of the cores.

To make this point more clear, let us recall how the vortex self-energy per unit length " $_0$ is calculated within the London limit. 14,15 Within this limit one assumes that, when calculating the supervelocity v_s from the Ginzburg-Landau equations, the density of superconducting electrons (the square of the order parameter modulus f^2) is constant in the corresponding equation. This makes it possible to not out explicitly the spatial distribution of the supervelocity. A free doing so, one can follow two dierent ways:

(a) Following de Gennes, 16 the vortex self-energy is presented as a sum of the magnetic eld energy and the kinetic energy of the superconducting electrons:

We use here the reduced units, see Ref. 14,15 , which are analogous of those dened in Eqs. (10) (see below)]. Integration is carried out taking into account the already found supervelocity, and considering that the density of superconducting electrons is constant. This approximation is justified by virtue of the high value of : f^2 diminishes significantly only at . , whereas $\sqrt[6]{g}$ does at & L.

(b) Following Abrikosov, 14,15 the vortex self energy is

(as before, we use here dimensionless quantities). The principal part of this integral arises from the second term, and it is associated with distances much larger than. In other words, those variations of f that takes place out of the vortex core are now essential.

As we see, to assume that within the London approximation f is constant out of the vortex cores is not always correct. But, as we have pointed out, this is just the assumption that unfortunately many authors made. For example, when studying the interaction between vortices and lattice defects, M iyahara et al. considered integrals which are similar to Eq. (2) but, at the same time, neglected all the spatial variations of f at &

It is quite surprising that this assum ption has not been critically revised up to now, especially by noting that, in principle, the importance of the out-of-core region for the elastic e ects could be understood since long ago. Galaiko 4 considered the interaction between vortices and dislocation-induced strains. He found that this interaction depends not only on , but also on $_{\rm L}$. However, he did not comment Ref. 2 and discussed neither the vortex-induced strain nor the strain-induced interaction between vortices. Ref. 3 is a recent example in which the out-of-core region is taken into account when studying an elasticity related problem: the structure of a superconducting vortex pinned by a screw dislocation.

III. ONE SINGLE VORTEX

A. Vortex-induced strain

Let us proceed with the calculation of the strain eld induced by one single vortex. When doing so, we shall account for all the spatial variations, core and non-core ones, that are associated with the vortex.

where h:::im eans volume average. We shall look for the solution of these equations for the case of a single vortex. The z-axis of the coordinate frame we choose is parallel to the vortex. The crystal frame is obtained from this coordinate frame by rotation.

It is clear that far enough from the vortex both the order parameter and the strain tensor tend to constant values; say $_{\rm s}$ and $u_{\rm ij}^{\rm s}$ respectively. Assuming that hj j²i ' j $_{\rm s}$ 2 , the equations of equilibrium reduce to

where the order param eter has been expressed as = fe^i , with v_s = 1r A the above mentioned supervelocity. Here = $_L$ = represents the G inzburg-Landau param eter in our case, which does not dier substantially from the conventional one (b $^\prime$ b).

The spatial distribution of the supervelocity v_s can be obtained from Eq. (11b) by assuming that f is constant there, i.e. within the London limit. Thus one nds that $v_s = {}^1K_1$ (), where K_1 is the MacDonald function (see, eg., Ref. 15).

In Eq. (11a), the term with u_{ij}^{v} results to be of order 2 because of Eqs. (11c) and (11d). Since 2 is small, the vortex-induced strain can be calculated to the lowest order in 2 neglecting the changes in f that the term u_{ij}^{v} in Eq. (11a) induces. In other words, f^{2} in Eqs. (11c) and (11d) can be taken as the solution of Eq. (11a) with 2 = 0. This solution can be written as f^{2} = 1 h, where h represents the vortex contribution. Using the same approximation that in Ref. we have

where A represents the section of the sample in perpendicular to the vortex (recall that we have split the total strain into $u_{ij}^s + u_{ij}^v$). Here $_{ij}$ accounts for the hom ogeneous deform ations that the vortex induces, and $u_i(q)$ is the i-th component of the displacement vector in Fourier space. Thus, Eqs. When calculating the strain tensor at a xed distance from the vortex [see Eq. (13)], the inhom ogeneous deformations are mainly given by those terms with q 1 . So the main contribution at 1 arises from q 1 . For these small q's, the function h(q) can be split into core and non-core contributions:

(here we have used the asymptotic form of v_s 1=() for 1 1, see Ref. 15).

But we retain it because, when dealing with the strain-induced interaction (see below), its contribution becomes signicant (this fact is well known in the theory of point defects, see e.g. Refs. 20). Note that the non-core contribution to , i.e. the logarithm ic term, could also be obtained from the well known expression of the vortex self-energy: according to A brikosov, 15 " $_{0}$ ' $_{2}$ (1 $_{2}$ f 4)d 2 ' 2 $_{1}$ h () d = $_{2}$ $_{1}$ h .

K ogan et al. 11 obtained a similar expression for vortexinduced strain considering an in nite medium. In such a case, the rst term of Eq.(17) vanishes at all. But the main dierence between Eq. (17) and the expression reported by K ogan et al. 11 resides in the corresponding values of . A ssum ing that only the vortex core induces strain, K ogan et al. reported a value $= ^2$. So they overlooked the logarithm ic term in $= (1 + 4 \ln) = (2^2)$ that arises because of non-core contributions. This implies that in the case of high—superconductors, K ogan et al. strongly underestim ated the vortex—induced strain.

B. E lasticity-driven interaction between vortices: Qualitative estimations

Let us now estimate the interaction energy of a VL which is associated with the strains that the vortices in-

duce. A swe have pointed out before, the inhom ogeneous part of these strains have been previously reported but neglecting non-core contributions (see, e.g., Ref. 11). If the distance between vortices is much longer than $_{\rm L}$, to take into account these non-core contributions reduces to modify the strains by a factor. In consequence, the interaction energy one obtains by taking into account both core and non-core contributions coincides, up to the corresponding factor, with previously reported ones. K ogan et al., 11 for instance, evaluated the interaction energy of a VL by sum ming up all pairwise contributions. Modifying this interaction energy by including the non-core contributions, one can see that

Here K = K stands for the order of magnitude of the relative change in the elastic moduli due to the normal-superconducting transition, and B represents the magnetic induction.

The interaction between vortices that arise due to the hom ogeneous strains can be easily estim ated as follows. It is clear that N vortices will induce a total (hom ogeneous) strain N , where is given by Eq. 1(5a), if the distance between them is large enough. When substituting this strain in the corresponding terms of VL energy:

(N) (N hhi) + (N 2)=2, one obtains r^2 2 2 =(2), where n = N=A is the vortex density. This is precisely the interaction term that we are looking for. Taking into account that the vortex density is n = B=(2), and 2 = = K=K [recall that we are using the dimensionless units dened in Eq. (10)]; this interaction can be estimated as

As we see, the order of magnitude of both interaction terms Eqs. (18) and (19) coincide. Consequently, either of them give us an estimate of the order of magnitude of the total interaction energy.

IV . VORTEX LATTICE: ELASTICALLY ISOTROPIC M ED IU M

It is convenient to begin the treatment of VL's considering the case elastically isotropic superconductors. In this case, the elastic contribution to the VL energy can be obtained, without any new approximation, from already known formulas for this VL energy. Such formulas are available for the regions H $_{\rm H_{cl}}$, H $_{\rm H_{c2}}$ (Refs. 14,15) and for intermediate elds H $_{\rm cl}$ H $_{\rm H_{c2}}$ (Refs. 16,21). They reasonably match at the boundaries of the corresponding regions. This perm its us to study the elastic e ects in isotropic superconductors with the same accuracy. We begin with the case = 1 where the calculations are elemental.

A. In nite shear modulus

The only elastic degree of freedom of a system which shearm odulus is in nite is its hom ogeneous dilatation. If the system is not clamped this hom ogeneous dilatation, say u, m ust be understood as a variational parameter. In the free energy (3), this variational parameter modies the coe cient of the term $j j^2$, which can be rewritten as a (u) = a + u.

Let us x the parameter u for a while, i.e., let us consider m om entaneously a clamped sample. Thus, after m in m izing w ith respect to all degrees of freedom excepting u, the free energy of the VL w ith respect to that of the superconducting state can be w ritten as a sum of two term s: a u-dependent VL energy v is the coe cient a (u), and the elastic energy.




FIG.1: Log-log plot of the coe cient of the attraction term B of the free energy as a function of them agnetic induction, taking into account (solid line) and neglecting (dashed line) non-core contributions. The regions indicated as (I), (I-II) and (II) (see text) are the corresponding ones for ' 100 (note that H_{c1} ' 10 $^4H_{c2}$ in this case).

taking into account that the ratio d= must be replaced by if d & $_{\rm L}$, and is a constant of order of unity (see Fig. 1).

A coording to what we have seen in the preceding section, the logarithm ic contribution to the coe cient due to non-core e ects. These e ects have been overlooked until now. As we show in Fig.1, the neglection of these non-core e ects leads to underestim ate the elasticity-driven interaction between vortices. And by virtue of the high value of , such a underestim ation is quite signi cant in alm ost all the mixed state.

B. Finite shear moduli

It is quite straightforward to extend the results that we have obtained for the = 1 case, to the most general isotropic one. Note that minimizing the free energy (3) with respect to all elastic degrees of freedom one obtains

where $K_{4=3} = K + 4 = 3$. The rst term of this expression renormalizes the coecient bof Eq. (1). This renormalization disappears in the limit ! 1 . The second term makes that the free energy becomes into a non-local functional. This non-locality remains as long as the shear m odulus does not vanish.

Working out from this functional one could recover the free energy (29) by ascribing the coe cients in Eq. (37) the values they assume in the case = 1, i.e. 2 = (2K $_{4=3}$) = 0 and 4 = (3K $_{4=3}$) = 1. This consideration does not change the functional form of Eq. (37) (only coe cients change). So one concludes that the free energy density of any isotropic type-II superconductor has the form of Eq. (29) with the corresponding renormalized constants:

Note that, because the resulting coe cient in Eq. (35) vanishes if = 0, it can be said that the elasticity-driven interaction between vortices is associated with the solidstate elasticity.

C. Comparison with previously reported results

Let us start this section by comparing our results with those reported in Refs. 10,11. In these references, intermediate elds far from Tc are considered. M ention that although strictly speaking the Ginzburg-Landau approach that we use is not valid far from T_c , it still gives correctly the orders of magnitude. So the comparison still makes sense. M ention also that in Refs. 10,11 the hom ogeneous part of the strains are om itted. In Ref. this om ission is mentioned explicitly, while in Ref. this om ission the fact that they consider in nite samples when calculating the interaction between vortex pairs. Therefore, as we argued in Sec. IIIB, we can only compare the order of magnitude (see below for a more detailed comparison). Such a comparison reveals that, as a result of the neglection of the non-core contributions to the interaction energy, this energy is notably underestimated in Refs. 10,11 through the most part of the mixed state (see Fig. 1). Such a underestimation is at least by factor \ln^2 close to H $_{\rm cl}$.

In R ef. 12 , treating the case H $_{\rm c2}$, both hom ogenous and inhom ogeneous strains are seem ingly taken into account. In accordance with Eq. (28) of this reference, the free energy in the isotropic case should be of the form

At rst glance, one could think that the last term of this expression and the last one of Eq. (33) di er only in a num erical factor. So the elasticity-driven interaction between vortices are reasonably well reproduced by either of them. However, a deeper inspection of Eq. (42) reveals that it is erroneous: the coe cient $_2$ (i) vanishes if = 1 and (ii) remains nite if = 0. Being the strain-driven interaction between vortices due to the speci c features of the solid-state elasticity, the results one obtains from Ref. in the above mentioned limiting cases cannot be correct. This motivates us to reconsider the problem treated in Ref. (Sec. VB below).

V. VORTEX LATTICE: ELASTICALLY AN ISOTROPIC M ED IUM

Let us reconsider the free energy (3) and, as usual (see Ref. 15), integrate by parts term with r . Thus, after using the Gauss' theorem and the boundary condition n i~r $\frac{2e}{c}A$ = 0 (n is the unit vector of the normal to the surface), one nds that:

The absence of correction inside the cores follows from the fact that, in these regions, Eq. (5a) can be linearized because of the sm allness of the order param eter m odulus (see, e.g., Ref. 15). Let us remark, even doing so, the vortex cores are taken into account: they act as strain sources.

The last term of this expression represents the strain-induced contribution to the VL energy. The term with q=0 is associated with the homogeneous strains. The elastic constants enter this term through an invariant combination [see Eq. (48)], so it does not depend on the orientation of the VL with respect to the crystal axes. This dependence arises from the term swith $q \in 0$.

Let us mention that this form ula dem onstrates that the elasticity-driven interaction between vortices does not depend on the sam ple form, unlike to the statement made in Ref. 11. Indeed, such a dependence would mean that contribution to the sum from the region of small q's is essential and comparable with the contribution of the rest of the sum. But the function h_0 () h_0 i is a periodic function de ned in a nite volume (neglecting the near-of-the surface distortions). Its Fourier spectrum does not contain small q's but has maxima at the non-zero reciprocal lattice vectors. The form and the size of the sam ple is rejected in the form and the width of these maxima and nowhere else. In fact, the sums over q's can be replaced by sums over the reciprocal lattice vectors of the VLQ. Putting

Let us emphasize that with this expression, one takes into account that both core and non-core regions act as strain sources. It can be straightforwardly illustrated close to H $_{\rm cl}$. Here, due to the large separation between vortices, the function \Re_0 in Eq. (53) practically coincides with that associated with one single vortex [see Eq. (12)]. In consequence the function \Re_0 (Q) varies slowly up to Q 1 and then rapidly drops to zero. So in Eq. (56) it can be taken as \Re_0 (Q) ' \Re_0 (0), which naturally split into core and non-core contributions [see Eqs. (16)]:

In the anisotropic case the sum over Q 's in Eq. (56) also yields a term / n, which renormalizes the vortex self-energy, and a term / n^2 which contributes to the elasticity-driven interaction between vortices. In this case, a dependence on the orientation of the VL with respect to the crystal axes is in plicit in these two terms.

Taking into account that j $_{\rm s}{\rm fb^0}$ H $_{\rm c}^2$ (K =K) and nH $_{\rm c}$ 2 B = , the elasticity-driven interaction can be estimated as

As we see, its order of magnitude coincides with that we obtained in Sec. IIIB from qualitative estimations, as well as with that of the exact results that we obtained in Sec. IV for the isotropic case. Let us mention that om itting in in these expressions, i.e. om itting the non-core contribution to the vortex-induced strain, they reproduce the previously reported results.¹¹

Let us now consider the VL's near H $_{\rm c2}$. When doing so, it is convenient to use the conventional dimensionless units instead of those dened in Eqs. (10). These conventional units can be obtained from Eqs. (10) by replacing j $_{\rm s}$ $_{\rm f}$ with a=b.

Following K ogan²⁴ one can easily obtain, now from the equations of equilibrium (5), the so-called A brikosov identities (see also R ef.^{14,15,25}). In presence of strain they read

Let us mention that the form of this expression for the free energy di ers substantially from that reported by M iranovic et al. in Ref.¹². The elasticity-driven interaction term that one obtains from Eq. (66) is several times smaller than the corresponding one in Ref.¹². The validity of Eq. (66) can be checked by noting that it reproduces the isotropic case [see expression (II) in Eq. (29)]. In contrast, the expression reported in Ref.¹² does

not (see Sec. IV C). The reason is that is it obtained from an expression analogous to Eq. (45), but erroneous Eq. (20) of Ref.¹²]. It reads

One can see here that the term $_{ij}u_{ij}j_{}^{2}$ is taken into account twice: one explicitly and another implicitly in the term $_{bj}f_{}^{2}=2$ which arises as result of the integration by parts showed at the beginning of this Section .

VI. CONCLUDING REMARKS

We have revised the contribution to the VL energy which is due to the vortex-induced strains, showing that essential corrections in the previous calculations are needed. The most important one is connected with the fact that, in high—superconductors, not only the vortex cores induce strains in a signicant way. There also exists a signicant contribution associated with the noncore regions which, in fact, the most important ones for the VL energies at low elds (H $_{\rm c2}$). As a result of the proper inclusion of all strain sources, the strength of the elasticity-driven interaction between vortices increases by a factor up to $_{\rm ln}^2$ compared with the previously reported ones.

It is known since long ago that the observed correlations between V L's and crystal lattices in dirty superconductors cannot be explained without the elasticity-driven interaction between vortices. This interaction has been proved to be important in clean superconductors also. For example, the V L's observed in NbSe₂ do not correspond to the minimum of the London energy. In Ref. Kogan et al. showed that, however, the dierence in the London energies of the two possible competing structures is smaller than the dierence in the energies of the corresponding elasticity-driven interactions. As we have mentioned, Kogan et al. underestim at the elasticity-driven interaction between vortices because they assumed that only the vortex cores induce strain but, even doing so, they pointed out the importance of this interaction in

NbSe₂. This importance is increased as a result of the present work, what should be taken into account especially in those cases in which previous estimates of the above mentioned dierences concluded that it was that of the London energy the most important one.

V₃Sim ight provide an example in which the latter case takesplace. In Ref.26 it was claim ed that in V3 Sithe contribution to the VL energy which is due to the (underestim ated) elasticity-driven interactions between vortices can be neglected compared to that contribution due to the nonlocal corrections to the London energy. But bear in m ind that (i) the order of magnitude of these two contributions is the same, as it was shown in Ref. 11 considering the vortex cores as the only sources of strains, and (ii) the strength of the elasticity-driven interaction is considerably stronger than it was reported, as we have shown in this paper. So it is quite probable that in V_3Si , as well as in other superconductors with large , this elasticity-driven interaction between vortices is not only com parable, but even m ore im portant than the nonlocal corrections to the London energy.
