A nom alous speci c heat jum p in the heavy ferm ion superconductor C eC oIn_5

We study the anomalously large species heat jump and its systematic change with pressure in $C \in C \circ In_5$ superconductor. Starting with the general free energy functional of the superconductor for a coupled electron boson system, we derived the analytic result of the species heat jump of the strong coupling superconductivity occurring in the coupled electron boson system. Then using the two component spin-ferm ion model we calculate the species heat coescient C(T)=T both for the normal and superconducting states and show a good agreement with the experiment of $C \in C \circ In_5$. Our result also clearly demonstrated that the species heat coescient C(T)=T of a coupled electron boson system can be freely interpreted as a renormalization either of the electronic or of the bosonic degrees of freedom.

The superconductivity (SC) in CeM $\rm In_5~(M=Co,Rh,Ir)$ heavy ferm ion (HF) series compounds $^{1/2}$ provides valuable inform ation about the superconductivity nearby a possible quantum critical point (QCP) due to the excellent tunability with pressure and magnetic elds. Besides a complicated phase diagram due to a competion/interplay between the magnetism and superconductivity, the superconducting properties as well as the normal state ones around the QCP exhibit various anomalous behaviors such as non-Fermiliquid (NFL) power law of temperature in the resistivity, pseudogap behavior above the superconducting critical temperature, the continuous evolving from the second order to the rest order phase transition of the superconductivity with magnetic elds, etd.

In a recent paper we proposed the two-component spin-ferm ion model as a generic pairing mechanism of this series of compounds CeM $\rm In_5$. In this work, it is shown that some of the standard features of the d-wave superconductivity mediated by magnetic uctuations becomes strongly modiled in the vicinity of the magnetic critical point. Indeed it is very natural to expect that such a strongly coupled ferm ion-boson superconductivity shows various anomalies deviating from the standard weak or strong coupling theory of superconductivity 5 .

In this paper we study anom alous property of the speci c heat coe cient C (T)=T in CeCoIn₅. Sparn et al.⁶ m easured C (T)=T of CeCoIn₅ with varying pressure and also with applying magnetic elds. The key ndings are that (1) suppressing the superconductivity with 8 Tesla elds C (T)=T show ln T divergence down to 0.4 K; (2) without the magnetic elds the same sample becomes superconducting at 2.3 K with the special cheat jump ratio C (T)=T0 (T0) 5, which is a huge jump considering C (T0)=T0 400m J=T0 k at the pressure of 15 kbar but the jump ratio C (T0)=T0 (T0) drops drastically. We think this peculiar behavior is another manifestation of the critical magnetic uctuations mediated superconductivity. The huge special cheat jump, indicating the

steep drop of the entropy below Tc, is actually consistent with the spin-ferm ion model if we consider that the critical m agnetic uctuations in this m odel is generated by the ferm ionic particle-hole excitations, which should be gapped below T_c . This means that below T_c not only the ferm ions su er the entropy drop by developing pairing correlation but also the spin uctuations should su er the entropy drop, which add up to make a larger speci cheat jum p. As will be shown below, however, this phenomena is actually very general so that it should occur even in the electron-phonon m ediated superconductors. The reason why it is phenomenal in CeCoIn5 is simply because the coupling of ferm ion-boson is strong and in particular the resulting bosonic mode is near critical. There is a recent work addressing the same problem as in this paper, but proposing a di erent mechanism for the enhanced C(T)=C(T).

W e start with the general free energy functional of the two component spin-ferm ion model, which is nothing but the same form as the one for electron-phonon model 8 {10.

are standard¹⁰, and the one important dierence is that D $_0$ (q) is not explicitly de ned in the spin-ferm ion model in contrast to the electron-phonon case, but only the total spin propagator is de ned phenomenologically as follows.

where I(T) de nes the distance from the magnetic quantum critical point (QCP) and A and are the coe cients determ ined by the Ferm i liquid parameters of the ferm ion sector 11. The elective spin correlation length and the relaxational energy scale are $^2 = A = I(T)$ and $!_{sf} = I(T)$, respectively, and the momenta q and are assumed to be in the two dimensions 12. We take as the unit energy scale in our numerical calculations. The bare spin propagator D₀ is assumed to be trivial regarding the critical low energy behavior and taken to be a constant. As usual, the above free energy functional is constructed in such way that it is stationary with respect to the variations of $_{1;2}$ and a la Luttinger-W and with the following denitions. This property of the functional is very important and utilized critically in our paper.

Now following Ref^{10}], neglecting the momentum dependence of $_{1;2}$ and using the denitions, $_{1}(P) = i!_{n}(1 \quad Z(!_{n}))$; and $(!_{n}) = _{2}(P) = Z(!_{n})$; we obtain after the momentum integration the following.

Note that the above equation didn't include the spin term yet 13 . But due to the stationary property of the total free energy functional asmentioned above, the species heat jump across the superconducting transition with the changes of $_1^{(n)}$! $_1^{(s)}$ and $_1^{(n)}$! $_1^{(s)}$ is solely determined by Eq.(7) with Z (! $_n$) = Z $_n^{(n)}$ (! $_n$) at T = T $_c$.

The Eq(7) can be written after the M atsubara frequency sum m ation using the contour integration as

This is our key result in this paper and we can read the speci cheat jump ratio as $\frac{C(T)}{C(T)} = \frac{Z}{Z+1} = \frac{\frac{g^2}{2-3} = T_c \, 13}{2-3}$. We see from this formula that the jump ratio is modi ed with the normal self-energy renormalization factor $\frac{Z}{Z+1}$, which is $\frac{1}{2}$ in the BCS $\lim it w ith Z = 1$ and can have a maximum value 1 in the lim it of Z (T)! 1 . Apparently $\frac{\mathbb{Z}}{\mathbb{Z}+1}$! 1 is the proper lim it for CeCoIn₅ and some other heavy ferm ion compounds exhibiting a large C (T)=T at low tem perature. We sum marize the consequences of this formula: (1) The jump ratio at most can be doubled to the BCS ratio assum ing $\frac{\varrho^{-2}}{\varrho T}$ is the same as the BCS lim it, ie. 9:42Tc; (2) Apparently the steeper slope of (T) can contribute an extra enhancem ent to the jum p ratio. And since our formula is an exact result, this formula can be utilized to estim ate the tem perature slope of $\,$ (T) at $T_{\scriptscriptstyle\rm C}$ from the experimental $\frac{C(T)}{C(T)}$ in the lim it of $\frac{Z}{Z+1}$! 1; (3) Finally, the interpretation of the large C (T)=T and its enhanced jump ratio from the heavily renormalized ferm ionic quasiparticle due to the scattering from the m agnetic uctuations seems to be legitim ate, if we can neglect the contribution from boson 13.

Now in order to calculate $C_{\text{total}}(T)$ above and below T_{c} , we need to calculate $_{1;2}^{(n);(s)}$ with a given D (q) $_{1;s}^{(n);(s)}$. But we found a more convenient way to proceed as follows. Adding $_{\text{int}}$ term to $_{\text{spin}}$ exactly cancels the cumbersome term (q)D (q) as

A di erent organization greatly simpli es fer so that all the renormalization e ect due to the interaction miraculously drops and furthermore the explicit (T) dependent term all cancels out in the nal result of Eq.(11). This amazing result is actually the consequence of the Eliashberg free energy functional built with the stationary property with respect to the variations of the self-energies. Considering that the Eliashberg free energy functional is not the exact free energy functional but a (Nonsistent approximate functional equivalent to the self-consistent Born approximation for the fermionic part and the random phase approximation (RPA) for the bosonic part, the exactness of Eq.(9) and Eq.(11) has a limited

m eaning. Nevertheless, besides the accuracy of this functional the insightful reason for this result is the equivalent relation of the following.

From the technical view point the above relation is trivial if we consider any linked-cluster diagram obtained from the free energy expansion with Hint8. However the physical interpretation is rather revealing. Namely, the interacting free energy = total bare and its derived entropy S all com es from the expansion of H int. Then depending on how to view or organize the same diagram s, we can view all interaction e ect as the renormalization of either the ferm ion sector or the bosonic sector 15. While theoretically we have this freedom, in experim ents the experim ental probe itself determ ines how to measure the contribution of H int through either ferm ionic or bosonic degree of freedom. However the therm odynam ic m easurem ent like the speci cheat measures simultaneously the both degrees of freedom and it is hard to know how much contribution comes from which degrees of freedom. Our analytic result clearly demonstrated that the speci cheat coe cient C (T)=T of a coupled ferm ion-boson system can be freely interpreted as a renormalization either of the electronic or of the bosonic degree of freedom, but not for both. This point should have a far-reaching consequence to the heavy ferm ion experim ents and its related interpretations. This im portant aspect will be dealt in the separate publication.

Now let us return to the calculation for the total C (T) $_{\rm tot}$. From Eq.(10) we can calculate the entropy S (T) $_{\rm spin+int}$ with the phenomenological D (q) given in Eq.(3) as follows.

In real calculation, we need to x parameters. Our unit energy scale is =1, and we take $_{!}=3$, A (q^m ax $_{!}$ Q)^2 = $\frac{^{!}_{q}^{m} ax}{2}$ = 1.0, and a = 1.0. For the ferm ionic part $_{fer}$, it is just the same form $_{l}$ as the non-interacting ferm ion free energy except ! = $\frac{^{n}_{l}^{m} ax}{k}$ + $\frac{^{n}_{l}^{m} ax}{k}$ (T), and therefore it develops some estructure below T_{c} but no discontinuity at T_{c} . Finally to $_{l}$ x the relative magnitude of $_{l}$ spin+int to $_{fer}$ we need to determ ine the spin density of states N $_{s}$ de ned as N $_{s}$ $_{0}^{\; !}$ = $\frac{1}{V}$ $_{q}^{m}$ ax . This can be determ ined using Eq.(12) at normal state, which gives the following relation

We assume $_n=\frac{j_nj}{D_0}$ in the derivation, but the above relation is not useful since both side of the equation diverges unless we introduce high frequency cut-o for $_n$ and l_n . Since the above relation should hold for a variation of $_n$, we derive another equivalent relation at T=0 as

A recent paper by Ref. [16] also use the similar procedure to $\,$ x the relation between N (0) and $\,$ Ns. Our ready to calculate C $_{\text{tot}}$ (T) using Eq.(11) and Eq.(13). For the calculation below Tc we need to know the temperature dependence of the gap function (T) and $_{\rm s}$ (T)). For the gap function we use the generalized BCS form (T) = $_0 \tanh (a^T \overline{T_c=T} 1)$, where a = 1:764 and $_0$ = 1:74T_c for BCS lim it, but for strong coupling superconductor these values can deviate largely from the BCS lim it and we take them as param eters. Now much unclear part is the behavior of $_{\rm S}$ (T) below T $_{\rm c}$. Qualitatively it should be cut o for 2_0 at T = 0 and sm oothly recover to the normal state form approaching T! T_c . The leading expansion of $_s$ (T) in 2 (T) gives $s = n \exp((T) = [!^2 + T^2])$; but for a larger value of (T) for T! O this form should not be very correct.




FIG .1. (C (T)=T) $_{\rm Spin+int}$ from $_{\rm spin}$ + $_{\rm int}$ contribution in unit of D $_{0}$ $^{2}=$ $~N_{\rm f}$ (0)




FIG.2. (C (T)=T) $_{\text{fer}}$ from $_{\text{fer}}$ contribution in unit of (2 2 =3)N $_{\text{f}}$ (0)

The num erical results are shown in Fig.(1) and Fig.(2). In Fig.(1) the speci cheat coe cient C (T)=T calculated from Eq.(13) are shown in unit of $\frac{D_0}{2}$ N (0). For our param eter choice producing Z >> 1 (For this we need the critical spin uctuations (x << 1) as well as the e ectivecoupling $\frac{D_0}{c}$ of 0(1)), the contribution of C(T)=T from fer Eq.(11) is negligibly small. Therefore we didn't add it to C(T)=T in Fig(1) but show it separately in Fig.(2) dem onstrating its qualitative features. In Fig.(1) the solid line is for the normal state C (T)=T with $I_0 = 0$ (the spin uctuations is at QCP), it indeed displays In T divergence with decreasing temperature. With SC transition at T = 0.2 (open square symbol) it shows the jump ratio C(T)=C(T) 5 with the choice of param eters¹⁷. Then increasing I_0 , the $\ln T$ divergence is quickly suppressed and at the same time the specie heat jump ratio drops with increasing T_{c} (T_{c} is increased by hand and the tem perature slope of (T) is reduced accordingly as $\frac{^{0}\left(T_{c1}\right)}{^{0}\left(T_{c2}\right)}=\frac{T_{c2}}{T_{c1}})$. W ith this rather crude phenom enologity cal choice of param eters our num erical results reproduce the experim ental features of C (T)=T in CeCoIn5 qualitatively as well as quantitatively.

In sum mary, starting with the general free energy functional for the coupled ferm ion-boson system, we derived an analytic formula of C (T)=C (T) for the general strong coupling superconductor. Then we calculate C (T)=T for the spin-ferm ion model and show that the salient features of C (T)=T of CeCoIn5 for both normal and superconducting states are successfully explained including its anom alous jump ratio C (T)=C (T) and the progressive reduction of it with increasing T_c. Also with di erent organization of the Eliashberg free energy functional, which lumps all the interaction e ect either into the bosonic or into the ferm ionic degrees of freedom, we clearly demonstrated that the e ect of the interaction in the total free energy or entropy of the coupled ferm ionboson system can be freely viewed as the renormalization of either the ferm ion sector or the boson sector. Finally, our results strongly support the idea that the two dim ensional critical magnetic uctuations plays an essential role in CeM In₅ HF compounds in producing a large and strongly temperature dependent C (T)=T and the SC pairing itself.

In the electron-phonon case, the term $_{\rm boson}$ (in this paper $_{\rm spin}$) is neglected with the argument that the change ($_{\rm s}$ $_{\rm n}$) 2 =E $_{\rm f}^{2}$ is sm all 10 . But this argument is wrong because the change of the free energy above and below $T_{\rm c}$ is

always O (2 =E $_{\rm f}^2$) and this small change is what makes the superconducting transition. As shown by Chester 14 even before the BCS theory, the actual change of phonon kinetic energy is just the same order of magnitude as the electronic part. The correct reason why still the term $_{\rm boson}$ can be neglected is that the contribution of the self-energy correction $_{\rm syn}$ in $_{\rm boson}$ exactly cancels between ln (D 1 (q)) and (q)D (q) terms for the small frequency limit. Then the actual contribution of $_{\rm boson}$ is just the one of the unrenormalized bare boson (or phonon) propagator, so it can be dropped.

- In order to compare with experiment, we should count the gap anisotropy which reduces the specic heat jump by the factor < 2 (k) > 2 = < 4 (k) > 18 (for d-wave gap, this value is 0.666.). In Fig.(1), we just multiplies 0.666 to the results below T_c for a better comparison with the experiment, but this articial procedure ruins the entropy conservation.
