# Epidem ic spreading with immunization and mutations

The spreading of infectious diseases with and without in m unization of individuals can be modeled by stochastic processes that exhibit a transition between an active phase of epidem ic spreading and an absorbing phase, where the disease dies out. In nature, however, the transmitted pathogen m ay also mutate, weakening the e ect of immunization. In order to study the in uence of mutations, we introduce a model that m im ics epidem ic spreading with immunization and mutations. The model exhibits a line of continuous phase transitions and includes the general epidem ic process (GEP) and directed percolation (DP) as special cases. Restricting to perfect immunization in two spatial dimensions we analyze the phase diagram and study the scaling behavior along the phase transition line as well as in the vicinity of the GEP point. We show that mutations lead generically to a crossover from the GEP to DP. U sing standard scaling arguments we also predict the form of the phase transition line close to the GEP point. It turns out that the protection gained by immunization is vitally decreased by the occurrence of mutations.

## I. IN TRODUCTION

The modeling of epidem ic spreading is a fascinating subject both in theoretical biology and statistical physics far from equilibrium [1, 2]. A possible approach is the study of stochastic models that m in ic the competition of infectious spreading and recovery by certain probabilistic rules. Depending on the rates for infection and recovery the disease m ay either spread over the population or disappear after some time.

The simplest models for epidem ic spreading assume that the individuals live on the sites of a d-dimensional lattice. At a given time each individual can be either infected or healthy. The system evolves according to certain probabilistic rules that resemble infection of nearest neighbors and spontaneous recovery. If the susceptibility to infections is su ciently large the epidem ic will spread while for low susceptibilities it will die out.

In most models it is assumed that the contagious disease is transmitted exclusively by direct contact. This means that the disease, once extinct, cannot appear again. The system is then trapped in a fully recovered state, which can be reached but not be left. Such a state, where the system is dynamically trapped, is called absorbing. The two regimes of spreading and extinction are usually separated by a so-called absorbing phase transition. In the supercritical regime, where infections dom inate, the epidemic may spread over the entire system, reaching a uctuating stationary state with a certain average density of infected individuals. In the subcritical regime, where recovery dominates, the system eventually reaches the fully recovered absorbing state. C bes to the transition the temporal evolution of the spreading process is characterized by large-scale uctuations. Theoretical interest in epidem ic spreading stems from the fact that this type of critical behavior is universal, i.e., it does not depend on the details of them odelunder consideration. The classi cation of all possible transitions from uctuating phases into absorbing states is currently one of the major goals of nonequilibrium statistical physics [3, 4].

In epidem ic models without in munization, where the pathogen (e.g. a virus) is transmitted to nearest neighbors, the critical behavior at the transition generically belongs to the universality class of directed percolation (DP) [5]. The DP class is very robust and plays an important role not only in epidem iology but also in various other elds such as Reggeon eld theory [6], interface depinning [7], population grow th [8], catalytic reactions [9], and owing sand [10] (for a review of possible experimental applications see [11]).

As a next step towards a more realistic description of epidem ic spreading one can take the e ect of immunization or weakening by infections into account [8, 12, 13, 14, 15]. The simplest way of implementing immunization is to change the initial susceptibility of an individual after the rst infection and keep it constant thereafter. G enerally such a process is controlled by two param eters, namely, a probability for rst infections and a reinfection probability. In the case of perfect immunization, where each individual can be infected only once, one obtains the so-called general epidem ic process' (GEP) [1, 2, 8]. It diers from DP in so far as the disease can only spread in those parts of the system which have not been infected before. Thus, starting with a single infected site in a nonim m une environm ent, the disease typically propagates in form of a solitary wave, leaving a region of imm une sites behind. Depending on the infection rate this wave may either spread over the entire system or stop before. The

transition between in nite and nite spreading is a criticalphenom enon which in this case belongs to the universality class of dynam ical isotropic percolation [16]. Note that unlike DP models, a GEP running on a nite system has no uctuating active state, instead the process term inates when it reaches the boundaries.

In nature, how ever, im m unization is a m uch m ore com plex phenom enon. For exam ple, the protection by im munization m ay abate as tim e proceeds. E ven m ore im portantly, the strategy of immunization competes with the ability of the contagious pathogen to mutate so that it can no longer be recognized by the immune system of previously infected individuals, weakening the e ect of immunization. The aim of the present work is to introduce and study a simple model which m im ics epidem ic spreading with immunization and mutation. To this end we generalize the model described in [14, 15] by including mutations as well as a mechanism for the competition between di erent species of pathogens. The model is controlled by three param eters, namely, a rst infection probability, a reinfection probability controlling the e ect of imm unization, and a probability for spontaneous mutations. Moreover, the model is de ned in such a way that it includes DP and GEP as special cases.

The article is structured as follows. In Sec. II we rst de ne the model. Restricting our analysis to the case of perfect immunization in two spatial dimensions, we discuss the phase diagram and the qualitative behavior of the model in Sec. III. In Sec. IV the critical behavior at the phase transition line is studied in detail while crossover phenomena in the vicinity of the GEP point are investigated in Sec. V. The article ends with concluding remarks in Sec.VI.

#### II. SIM ULATION MODEL

O urm odel is meant to describe the spreading of an infectious disease that evolves as follows. Individuals can be healthy or infected with a certain pathogen. D uring their illness infected individuals may infect or reinfect neighboring individuals with certain probabilities. M oreover, there is a probability that a pathogen m utates during transm ission. Because of the enorm ous number of possible m utations one usually obtains an entirely new type of pathogen which has not been involved before. To sim plify the m odel we also assume that each individual can be infected at a given time by no m ore than a single type of pathogen. If the individual is exposed sim ultaneously to several competing pathogens, one of them is random ly selected.

In m ore technical term s the m odel is de ned as follows. Individuals live on the sites of a d-dimensional simple cubic lattice. Each site m ay be either healthy (inactive) or infected (active) by a pathogen of type n, where n is a positive integer. M oreover, each site keeps track of all species of pathogens by which it has been infected in the past. Therefore, the state of a site is characterized by a number n together with a dynam ically generated list of all previous types of infections.

The model evolves in time by synchronous updates, i.e., in each time step the whole lattice is updated in parallel as follows:

- 1. Spreading: Each infected individual at time t transm its its pathogen n to its 2d nearest neighbors (target sites) at time t + 1.
- 2. Susceptibility: The transmitted pathogen reaches the target site at time t + 1 with probability p if this site has never been infected before by this species, otherwise it reaches the target site with probability q.
- 3. C om petition: If a target site is exposed to several transmitted pathogens, one of them is random ly selected with equal weight.
- 4. M utation and Infection: Before infecting the target site the selected pathogen mutates with probability , replacing n by a new integer num ber (drawn from a global counter) which has not been used before.
- 5. Im m unization: In case of a rst infection the type of pathogen is added to the list of species against which the site will be immune in the future.
- 6. R ecovery: All sites that have been active at time t recover until time t+ 1 unless they are not again infected during the update from t to t+ 1. Hence the time of illness is a single time step.

### III. PHASE DIAGRAM




FIG.1: Phase diagram of the model. The active and the inactive phases are separated by a curved line of continuous phase transitions, connecting the points of critical GEP and critical DP (see text). C incles m ark the num erically determined critical points. The inset shows the phase transition line for sm all .

In what follows we restrict our analysis to the special case of perfect immunization q = 0. In this case the model is controlled by only two parameters, namely, the probability of rst infections p and the probability of mutations . Moreover, we restrict ourselves to the case of d = 2 spatial dimensions. The corresponding phase diagram is shown in Fig.1. It comprises an active phase, where the epidemic spreads, and an inactive phase, where the disease dies out so that the system eventually enters the fully recovered absorbing state. B oth phases are separated by a curved phase transition line.

We rst note that the endpoints of the phase transition line correspond to well-known special cases. On the one hand, for = 0 the model reduces to the GEP on a square lattice [8], provided that only one type of pathogen is involved. In this case the critical value of p is exactly given by  $p_c = 1=2$  [16]. On the other hand, for

= 1 all transm itted pathogens mutate, i.e., the target sites are always infected with a new species so that in munization has no in uence. It is easy to see that in this

case the model reduces to directed bond percolation on a square lattice with  $p_c$  ' 0:28734 [17]. The other points on the phase transition line in Fig. 1 were determined num erically using seed-simulations (see Sec. IV A).

As already discussed in the Introduction, mutations generally weaken the e ect of immunization. This explains why the critical value of p decreases m onotonically with increasing mutation probability . Fig. 1 clearly shows that introducing mutations in a GEP has a strong in uence on p<sub>c</sub>, especially if is very small. Since the phase transition line approaches the GEP point with in nite slope (see inset in Fig. 1) a tiny increase of reduces the corresponding critical value of p dram atically. This indicates that mutations are a relevant perturbation and thus the spreading behavior of the model for > 0 is expected to dier from that of the GEP.On the other hand, for larger values > 0:1 the critical value of p decreases only moderately with increasing , indicating that the behavior of the model in this region is essentially the same as for = 1, where the transition is known to belong to DP.




FIG.2: Snapshots of seed-simulations at the phase transition. The black square marks the position of the seed. Each row shows a simulation for a xed value of and timest = 30, t = 100 and t = 225 (from left to right). From a) to d) values of are 0 (GEP), 0:003125, 0:05 and 1 (DP). Black (gray) dots denote active (immune) individuals (details in the text).

Fig. 2 shows snapshots of simulations at the critical point for di erent times and various values of . Infected individuals are represented by black dots. Moreover, individuals which are immune against at least one active type of pathogen are marked by gray dots. If a site is immune solely against pathogens that already became extinct the gray dot is removed. The snapshots shown in this gure suggest the follow ing qualitative behavior:

a) For = 0 the spreading process creates a growing cluster of immune sites with infected individuals located at the edges. As usual in the GEP, the region of immune sites is compact in the active phase

while it is fractal at the phase transition.

- b) For a sm allvalue of the disease rst behaves like a GEP (fort 100) while for larger times the spreading behavior changes and clearly diers from the GEP. A lthough there still is a region of immune individuals it does no longer provide e cient protection against infections since it is reinvaded by mutated pathogens.
- c) Increasing further the process changes its appearance already at an early stage. There are only sm all patches of immune sites and the process reminds more of DP than GEP.
- d) Finally for = 1 every transmitted pathogen mutates into a new one. In this case immunization has no in uence and the process reduces to DP. Since the disease is not driven away from immunized regions the spatial extension of an epidem ic at the phase transition grows much slower compared to a critical GEP.

B ased on these phenom enological observations we expect the model to behave initially in the same way as a GEP. A fler a certain tim emutations become relevant, allowing form er immune areas to be reinvaded. Especially close to the transition the process survives long enough to reach this crossover time. The visual appearance of the process is then increasingly similar to that of a DP process. The time it takes to observe the crossover from GEP to DP grows with decreasing and eventually diverges in the limit ! 0.

# IV. CRITICAL BEHAVIOR ALONG THE PHASE TRANSITION LINE

Phase transitions into absorbing states are usually characterized by simple scaling laws. In models for epidem ic spreading an important quantity is the probability  $P_s(t)$  that an epidem ic starting from a single infected seed in a healthy and non-immune environment survives at least until time t.

Let us rst recall the standard scaling laws for the survival probability. Let 4  $_{p} = p$  p denote the distance from criticality. If j  $_{p}j$  1 the survival probability rst decays as a power law P<sub>s</sub>(t) t until a certain timescale  $_{jj}$  j  $_{p}j$  <sup>11</sup> is reached from where on it either saturates at P<sub>s</sub>(1)  $_{p}$  <sup>11</sup> for  $_{p} > 0$  or decays exponentially for  $_{p} < 0$ , reaching a spatial extension  $_{?}$  j  $_{p}j$  <sup>?</sup>. A ssum ing scaling invariance this behavior can be described in terms of a scaling form

where () is a scaling function with the asymptotic behavior

such that the time dependence drops out for ! +1. The scaling function () and the triplet of critical exponents ( $_{jj}$ ; ?; ) are believed to characterize the universality class of the phase transition under consideration. W e note that this scaling form is known to be valid both for GEP and DP, although with di erent sets of critical exponents [18]

For the density in DP a similar scaling form as in Eq. (1) is valid (with the same exponents as in Eq. (3) for d = 2).

W e now analyze the critical behavior of the model, assum ing that the scaling form (1) is valid everywhere in the vicinity of the phase transition line. A lthough the qualitative discussion in Sec. I suggests DP behavior for 0 < 1 we note that this would be a non-trivial result since the so-called DP-conjecture does not apply in the present case. The DP-conjecture [19] states that phase transitions in two-state system swith a reachable absorbing state and short-range interactions belong to DP, provided that mem ory elects, non-conventional symmetries, and quenched disorder are absent. Contrarily the present model has many absorbing states and memorizes previous infections over a long time.

#### A. Seed sim ulations

Seed simulations start with a single infected site at the origin in a non-immune environment. Each run is stopped when it dies out or reaches a preset maximum time. We average over many runs with dierent realizations of randomness. In order to eliminate nite size e ects the lattice is always chosen large enough so that the epidemic never reaches its boundaries. As usual in this type of simulation we measure the survival probability  $P_s(t)$ , the number of active sites N (t) averaged over all runs, and the mean square spreading from the origin  $R^2$  (t) averaged over all active sites in surviving runs [20]. The scaling form (1) in plies that these quantities vary at criticality algebraically as

where  $z = {}_{k} = {}_{?}$  and z = d = z = 2 1 for GEP and z = d = z = 2 for DP [21].




FIG.3: Seed simulations: Behavior of  $P_s(t)$ , N(t),  $R^2(t)$  and N<sub>sp</sub>(t) at the phase transition for dimension for dimensing dimensing dimension for dime

Fig. 3 shows our results of seed-simulations along the phase transition line. We note that these simulations are numerically challenging since for each site a list of infections in the past has to be created and continuously updated. Therefore, numerical simulations are mainly liminated by the available memory and restricted the present study to a maximal temporal range of about  $10^4$  M onte C arb updates.

In order to determ ine the critical threshold  $p_c()$  we xed and varied p until  $P_s$  (t) displayed the exkept pected slope of DP in a log-log plot (dashed lines in Fig. 3). A though this procedure is in favor of DP scaling the m ere fact that it works consistently for all quantities in Eq. (4) con m s that the transition does belong to DP for any 0 <1 while GEP scaling can be ruled out. The data also shows the expected crossover. For small the curves roughly display the slope expected for GEP (dotted lines) before they cross over to DP, conm ing the crossover scenario discussed in the previous sections. Thus the introduction of mutations in a GEP is a relevant perturbation in the sense that it changes the asymptotic critical behavior of the model. At the phase transition the interplay between immunization and mutations drives the system tow ards DP.

W e note that the involvement of dierent species of pathogens in a spreading process with mutations allows one to introduce the number of active species N  $_{\rm sp}$  (t) as

an additional order parameter. As shown in paneld) of Fig.3, the num ber of active species at criticality increases in the same way as the number of infected individuals. Thus their quotient tends to a -dependent constant

# B. Full-lattice sim ulations

In this type of simulation we use a nite system of size L L with periodic boundary conditions. The initial con guration is a fully occupied lattice where all individuals are infected by di erent types of pathogens. (It would be also possible to occupy all sites with the same type of pathogen, but then the process would immediately be trapped in the absorbing state.) We measure the density of active sites (t) and the density of active species  $_{\rm sp}$  (t). In the case of directed bond percolation = 1 it is known that the density of active sites decays as (t) t. Exemplarily we perform ed a full-lattice

simulation for = 0.5 at the critical point, con m ing this type of decay with = 0.451. M oreover, like in seed simulations, the density of active species also decays as so (t) t.

The three exponents ; ;z in Eq. (4) that govem the spreading behavior at the transition depend only on two of the three independent critical exponents that are needed to characterize the universality class of DP (see Eq. (3)). In order to check the value of the third independent exponent we perform ed o -critical full-lattice sin ulations for = 0.5 and di erent values of  $0 < p_{p}$  1. A s is shown in F ig. 4 using the critical exponents and  $_{k}$ of DP one obtains a reasonable data collapse of the density (t). This supports the claim that along the phase transition line for > 0 indeed all three exponents goveming the scaling behavior of the spreading process are that of DP.




FIG.4: Data collapse of (t) for = 0.5 using the critical exponents of DP, i.e., = 0.451 and  $_{\rm k}$  = 1.295.

# V. CRITICAL BEHAVIOR IN THE VICINITY OF THE GEP POINT

In this section we investigate the in uence of mutations in the vicinity of the GEP point in order to address two questions, namely, how does the system cross over from GEP to DP and why does the phase transition line term inate in the GEP point with an in nite slope.

## A. Decay at the GEP point




FIG.5: Simulations at the GEP point p = 1=2; = 0 starting with a fully occupied lattice, where each site carries a di erent kind of infection. A lthough the lines are slightly curved, the decay of and sp may suggest a possible power-law behavior in the limit t ! 1 . As shown in the insets, the corresponding exponents can be extrapolated visually by plotting the e ective slope against 1 = t (see text).

A lready at the GEP point our model exhibits a new feature, namely, the competition of dierent types of infections in full-lattice simulations (see Sec. IV B). Starting the simulation in a nite system, where each site is initially infected by a dierent kind of pathogen, one observes a coarsening process of competing species, leading to a slow decay of the density of active sites and active species. As shown in Fig 5, the decay of these quantities suggests possibly asymptotic power laws, although the data display a considerable curvature in both cases. A ssum ing asymptotic power laws

at the GEP point we extrapolate the e ective exponents  $(t); \sim (t)$  visually for t ! 1 (see insets of Fig. 5), obtaining the estimates

suggesting that  $\sim = 2$  .

Regarding the limited accuracy of our numerical sin – ulations the conjecture of an asymptotic algebraic decay has to be taken with care. However, indirect support comes from the one-dimensional case. Here the GEP transition is shifted to  $p_c = 1$  and the dynamics of competing species reduces to a ballistic coalescence

process [22], for which asymptotic power laws could be derived exactly.

## B. -controlled transition at the GEP point

Let us now turn to the critical behavior in the vicinity of the GEP point. The GEP point in Fig. 1 can be approached either vertically by varying p or horizontally by varying . The critical behavior in vertical direction has been studied in detail in Refs. [8, 12, 13] and can be described in terms of the scaling form (1). Contrarily, m oving in horizontal direction by varying and keeping p = 1=2 xed one encounters mutations as a new feature, leading to a non-trivial uctuating active state.

As usual in critical phenom ena, the additional control parameter is associated with a novel critical exponent  $_k$ . Like  $_k$  this exponent is de ned in such a way




FIG.6: Data collapse of the survival probability.

is the correlation time in the stationary state for p = 1=2and 0 < 1. Similarly, the corresponding spatial correlation length is expected to scale as

where  $_{?} = _{k}$ =z. To verify this conjecture we measured the survival probability  $P_{s}(t)$  in seed simulations at p = 1=2 for two dimensions of . A coording to standard scaling theory this quantity should obey the scaling form

where ' 0:092 is the density decay exponent of the GEP.Eq. (10) in plies that the survival probability eventually saturates at a value  $P_s(1)$  \*. Using this scaling form we collapse the data sets in Fig. 6, obtaining the estimate

Turning to full-lattice simulations we can combine this scaling law with the results of the previous subsection, leading to the conjecture that (t) and  $_{\rm sp}$ (t) obey the scaling form s




FIG.7: Data collapse of and  $_{\rm sp}$  based on the scaling form s (12),(13) using the exponents of Eqs. (7),(11).

A gain this im plies that eventually the densities reach stationary values (1) \* and  $_{\rm sp}$  (1) - \*. A l-though there are deviations for sm all these scaling form s lead to reasonable data collapses, as shown in Fig. 7.

We now suggest an explanation for the num erically determ ined value of  $_{k} = 0.63$ . Initially the process behaves as a critical GEP until mutations become relevant at a typical time  $_{k}$ . Our argument is based on the assum ption that  $_{k}$  scales in the same way as the typical time at which the rst mutation occurs. W ith the mutation probability one needs on average <sup>1</sup> infections until the rst mutation occurs. As the process initially behaves as a critical GEP the number of infections grows as dtN (t) t<sup>+1</sup>. Hence we are led to

which is in perfect agreem ent with the num erical estim a-tion in Eq. (11).

## C. Curvature of transition line at the GEP point

So far the num erical analysis suggests that in the vicinity of the GEP point the epidem ic process with m utations is invariant under scaling transform ations of the form

As usual in the theory of critical phenomena, the phase transition line itself has to be invariant under scaling transformations. Comparing Eqs. (19) and (20) we are led to the conclusion that the form of the transition line for small values of is given by

Since  $\frac{\theta}{\theta}$  = 0.58 the phase transition line indeed terminates at the GEP point with an in nite slope.




FIG.8: Double-logarithm is plot of the phase transition line  $j_p()jfor$  1. The local slope of this curve leads to the e ective exponent which is shown in the inset together with its error bars. The extrapolation of the e ective exponent for ! 0 leads to an estimation of the value of in Eq. (27) which is in agreement with the prediction of Eq. (28).

In order to con m the relations (27),(28) we plotted j  $_{\rm p}$  jversus 1 in a double-logarithm ic representation in Fig.8. The local slope of this curve leads to the e ective exponent (inset in Fig.8) which can be extrapolated and leads to the estimation 0:41 (3), in agreement with the prediction in Eq. (28).

# VI. DISCUSSION AND CONCLUSION

In this paper we have introduced a m inim alm odel for epidem ic spreading with immunization and mutations. Apart from the probabilities for rst infections and reinfections p and q the m odel is controlled by a probability

that a transm itted pathogen mutates, creating a new pathogen which was not involved before. The model includes the GEP (= 0;q=0) and DP (= 1 or q = p) as special cases.

Restricting the analysis to the case of perfect in munization and two spatial dimensions we have shown that the transition between survival and extinction in our model belongs to the universality class of DP everywhere along the phase transition line except for the point where the model reduces to critical GEP. In the vicinity of the GEP point even a small mutation probability drives the system away from criticality into a uctuating active state. The crossover from GEP to DP can be described in terms of a suitable scaling theory, which involves a new exponent  $_k$ . This crossover exponent also determ ines the form of the phase transition line in the vicinity of the GEP point. We suggested an explanation for the value of  $_k$  which turns out to be in perfect agreement with the num erical analysis.

A lthough the model presented here is highly idealized (individuals on a square lattice, hom ogeneous infection probabilities, nearest-neighbor infections etc.) there is an important conclusion to be drawn regarding realistic spreading of epidem ics in nature. As in the model, realistic epidem ic spreading starts at a certain threshold determ ined by various parameters such as the average susceptibility, the interaction frequency, and the degree of im m unization and/or vaccination. M utations weaken the e ect of im m unization, thereby decreasing this threshold. An important message of our paper is that for a population which is mainly stabilized by immunization and/or vaccination this threshold varies nonlinearly with the mutation rate, in the present case roughly as the square root of . Thus even a sm all rate of mutations can signi cantly weaken the stability of a population at the onset of epidem ic spreading.

As a possible extension of the present study it would be interesting to investigate whether these properties can also be observed in epidem ic processes with long-range

infections [23] if m utations are introduced. M oreover, it would be interesting to study the surface critical behavior at the system 's boundaries [24].
