M agnetoresistance of atom ic-sized contacts: an ab-initio study

The magnetoresistance (MR) e ect in metallic atom ic-sized contacts is studied theoretically by means of rst-principle electronic structure calculations. We consider three-atom chains form ed from Co, Cu, Si, and Alatom s suspended between sem i-in nite Coleads. We employ the screened K orringa-K ohn-R ostoker G reen's function method for the electronic structure calculation and evaluate the conductance in the ballistic limit using the Landauer approach. The conductance through the constrictions relects the spin-splitting of the Coleads and causes high MR ratios, up to 50%. The in uence of the structural changes on the conductance is studied by considering di erent geometrical arrangements of atoms forming the chains. Our results show that the conductance through s-like states is robust against geometrical changes, whereas the transmission is strongly in uenced by the atom ic arrangement if p or d states contribute to the current.

The investigation of electron transport through m etallic atom ic-sized contacts has attracted a lot of attention during the last 15 years, and m ost achievem ents are sum marized in a recent review [1]. Using up-to-date experim ental techniques, such as mechanically controllable break junctions (MCBJ) [2] or scanning tunneling microscopy [3, 4], it is possible to fabricate nanocontacts with a single atom, atom ic chain or a molecule [5] in the constriction. The experiments reveal step-like changes of the conductance upon elongation of the nanocontacts [1, 2, 3, 4]. In case of noble (Au, Ag, Cu) [6, 7, 8] and alkalimetals (Li, Na, K) [7, 8, 9] conductance histogram s show a dom inant peak very close to one conductance quantum, $G_0 = 2e^2 = h$, and sm aller peaks close to integer conductance quanta. However, in case of transition m etals the situation di ers signi cantly [8, 10] and a broad distribution of conductance values is usually obtained.

To describe the nanocontacts theoretically, several methods have been developed by many groups during the last years. An approach based on the tight-binding (TB) Ham iltonian adapted for a nanocontact geometry was proposed in Refs. 12, 13. An important conclusion of TB m odels is that the conductance of single-atom contacts is related to the number of valence orbitals of the contact atom available at the Ferm ienergy [12, 14]. Lang and cow orkers [15, 16, 17, 18] and K obayashiand cow orkers [19, 20] studied the single-atom contacts [15], atom ic chains of Al [16, 19], Na [17, 20], and C [18] using abinitio calculations based on density functional (DF) theory with jellium electrodes. The formation mechanisms of atom ic chains m ade from di erent types of elements such as Ni, Pd, Pt, Cu, Ag and Au were investigated by m eans of m olecular dynam ics simulations [21]. These studies were triggered by the experim ental evidence of the formation of gold wires [4]. Recently Mehrez et al. [22] and Brandbyge et al. [23] presented fully selfconsistent DF calculations of the conductance of atom icsized contacts treating the electronic structure of both the contact and electrodes on the sam e footing.

In this paper, we present ab-initio calculations of the conductance of nanocontacts and focus on m agnetic system s. W e consider m agnetic sem i-in nite foc (001) C o electrodes joined by nanocontacts of di erent m aterials. W e assume that they take the form of short three-atom C o-, Cu-, Si- or A l-chains suspended between the leads as shown in F ig. 1. Our aim is to investigate whether such hybrid systems could exhibit a large m agnetoresistance (M R) e ect. W e wish to address the following theoretical questions: (i) W hat is the in uence of transition m etal electrodes on the conductance of nanocontacts? (ii) W hat is the e ect of the geom etrical and electronic structure of the nanocontacts on the transport properties? (iii) W hat are favorable conditions to increase the M R through a constriction?




FIG.1: Geometry of the nanocontacts: (a) linear con guration; (b) zigzag-like con guration.

The structure of the nanocontacts studied below is presented in Fig. 1. The experimental lattice constant $a_0 = 6.70$ a.u. of fcc Co was used in the calculations. In the rst conguration (Fig. 1a), we consider a linear three-atom chain with the 1st and the 3rd atom splaced above the Co (001) surfaces at the ideal positions of the fcc structure with the distance to the middle-atom of the chain being $a_0 = 2$ which is the nearest neighbor distance in the fcc lattice. In the second (zigzag-like) conguration (Fig. 1b), the atom ic chain is a continuation of the fcc structure along [001] direction, thus the symmetry is lower than in case of a linear chain. These two congurations were chosen to investigate the e ect of the geometrical arrangement on the conductance.

The electronic structure was calculated using the non-relativistic spin-polarized version of the screened Korringa-Kohn-Rostoker (KKR) Green's function method (for details, see Ref. 24). The potentials were assumed to be spherically symmetric around each atom.

However, the multipole expansion of the charge density was taken into account. The angular momentum cut-o for the wavefunctions and the Green's function was chosen to be $l_{max} = 3$ to ensure well converged results. W ithin the KKR method [24], the Green's function of the system s is obtained in two steps. First, we calculate the Green's function of the auxiliary system consisting of sem i-in nite leads separated by a vacuum barrier. Next, the impurity problem is solved self-consistently by embedding the chain, surrounding atom s and empty sites into the host system, in order to account for the charge and spin density redistribution e ects. We assumed parallel (P) and antiparallel (AP) magnetic con guration for the Co leads. The electronic structure of the constriction was calculated self-consistently for both cases.

B allistic conductance of the nanocontacts, g, was calculated using the Landauer theory as formulated by Baranger and Stone [25]. We consider two sem i-in nite Co (001) bulk leads connected by the scattering region. C onductance is calculated between two atom ic planes bcated in the ideal leads. We neglect tunneling current far away from the contact region and sum up current contributions in real space in the vicinity of the constriction. C onvergence was checked in order to achieve errors less than 5% in the conductance evaluation. A detailed description and convergence properties of the method can

be found in Ref. 26. The real space version of the m ethod em ployed here was presented also in Ref. 27.

In Table I we present m agnetic m om ents calculated for di erent atom ic chains. W e found that m agnetic m om ent isenhanced for the C o atom s in the C o constriction reaching values up to 2.06 $_{\rm B}$ for the central C o atom of the linear chain and 2.28 $_{\rm B}$ for the zigzag geom etry. In the AP con guration, due to sym m etry, the central atom s of the chains have zero m om ents and the m agnetic pro les are antisym m etric. In case of Cu, Si, and A l the induced m agnetic m om ents are sm all as can be seen from Table I.

O ur results for the M R at the Ferm i energy (E $_{\rm F}$) are sum m arized in Table II. We de ne a magnetoresistance ratio as M R = $(g_{\rm P} \quad g_{\rm AP})=g_{\rm AP}$ where $g_{\rm P}$, $g_{\rm AP}$ are the conductances for parallel and antiparallel magnetic conguration of the C o leads. The calculations predict a M R ratio of 30-40% for the C o constriction, and of 20% in case of the C u chain suspended between the leads. The results for A l and Si chains are particularly interesting. W e obtain M R around 50% for the linear con guration although magnetic moments are rather sm all (see Table I). The values decrease to 20% when the symmetry of the constriction is reduced.




FIG.2: Spin-dependent transm ission as a function of energy for di erent linear (left colum n) and zigzag-like (right colum n) chains suspended between C o electrodes with m agnetic m om ents oriented in parallel. The solid lines with up- and down-triangles correspond to transm ission for spin-up and spin-down electrons, respectively.




FIG. 3: Total transm ission for both spins as a function of energy for di erent atom ic chains suspended between the Co leads in case of parallel (black squares) and antiparallel (open squares) orientation of magnetic moments of Co. Transm ission for the parallel con guration is the sum of the transm ission for spin-up and spin-down electrons shown in Fig. 2. In case of the antiparallel con guration transm ission is the sam e for both spins.

In order to understand the relation between electronic structure and transport properties we consider the energy-dependent transm ission, T (E), through the constriction (Fig. 2 and Fig. 3). In the linear response the conductance per spin channel is related to the total transm ission as $g = e^2 = h \frac{1}{1} f f^0(E) gT(E) dE$, where $f^0(E)$ is the derivative of the Ferm i-D irac distribution function. For zero tem perature the conductance is $g = e^2 = h T (E_F)$. However, in case of an applied voltage, V, states in the energy window of eV close E_F are relevant for the electron transport.

In Fig.2 we present the transmission of Co, Cu, A land Si constructions between Co leads for both spin channels

for parallel magnetic con guration. We see that transmission for majority (spin-up) electrons is generally a rather smooth function of energy. However, for minority (spin-down) electrons the transmission exhibits rather complicated behavior as a function of energy caused by C o d states which also contribute to electron transport. In Fig. 3 we present the total transmission (sum of both spins), for parallel (P) con guration in comparison with the antiparallel (AP) con guration. The conductance of the considered system s is the transmission at the Ferm i energy, T (E_F), in units of e^2 =h. The di erence of the transmission between P and AP con guration at E_F is a measure of magnetoresistance.

Let us rst concentrate on C o constrictions (Fig.2a,b). The energy dependence of the transmission can be interpreted in terms of local densities of states (LDOS). For

this reason, in F ig. 4 we present the symmetry projected LDOS, s, p, $d_{3z^2-r^2}$, d_{xz} , d_{yz} , at the Co central atom of the linear chain. In case of linear con guration the d_{xy} , $d_{x^2-y^2}$ orbitals do not support current since they are oriented perpendicular to the current direction (z-axis) and form very sharp resonances in the LDOS of the centralCo site of the chain because of weak coupling with the orbitals of the neighboring sites. From F ig. 4a we see that Comaprity states close to E_F are mainly sp-like since the d band is fully occupied and located below 0:75 eV with respect to the Ferm i energy, while for m inority states the Ferm i level crosses the d band. This is also valid for the case of a Co zigzag chain.

The exam ination of the LDOS at the Cosites of the lin-




FIG. 4: Sym m etry projected local density of states (LDOS) at the Co atom s of the linear three-atom chain for the case of parallel orientation of magnetizations in the Co leads. We present the s, p and all d contributions relevant for a transport along the wire axis (z-axis). The contact Co atom is the chain atom next to the surface of the Co lead. Panel (a): s and p states of the central Co atom; panel (b): d_{3r^2} z² states of the central and contact Co atom s.

ear chain shows that due to the localized and directional character of the d orbitals in real space, transm ission is high only if the orbitals of the same symmetry at neighboring sites of the chain are coupled. This can be seen from Fig. 4b and c. For example, the minority d_{xz} and d_{yz} states at 1.2 eV (Fig. 4c) survive also at the neighboring atom (dotted line) and causes high transmission.

C om paring F igs.2a,b we can conclude that for C o constrictions the transm ission of spin-up electrons is rather insensitive to structural changes simulated by the linear and zigzag con gurations of the atom ic chains. On the contrary, the geom etrical arrangem ent of the constriction seems to be more important for d electrons. Reducing the symmetry of the atom ic chain by considering zigzag geom etry destroys coupling between d orbitals, therefore the transmission of spin-down electrons is reduced and we obtain a sm ooth energy dependence (see Fig.2b).

Our study is restricted to collinear magnetic con gurations. To estimate the in uence of this approximation we have considered also two-atom Co chains where a 180° dom ain wall is form ed in the antiparallel con guration. In that case M R at E_F was found to be approximately 15% and the overall behavior is not far from the one discussed above. Thus, our calculations predict a M R ratio rather sensitive to the geom etrical and m agnetic structure. In addition, the spherical potential approximation m ight lead to sm all shifts of the electronic states to di erent energies, com pared to a more accurate full-potential description. This might in uence the MR values at the Ferm i level reported in the paper. In particular, in cases where there is a strong variation of the transm ission with energy close to the Ferm i level, the reported MR values are expected to be less accurate. However, we believe that the con gurations under consideration give a representative order of magnitude of the MR e ect in Co nanocontacts, but cannot explain the MR ratio of Co contacts which was recently observed experim entally [28]. M oreover, our calculations for N i nanocontacts using a zigzag con guration (Fig. 1b) give a magnetoresistance value of 24% contrary to the MR ratios of hundred percent observed in electrodeposited Ninanocontacts. [28] Thus, our calculations show that within the accuracy of density functional theory the experim ental values cannot be explained assuming a clean, abrupt dom ain wall and ballistic transport. Further investigations in particular on the role of defects on m agnetotransport are required, since a recent study indicates a signi cant enhancem ent of the M R ratio if oxygen is assumed to be at the contact region [29].




FIG.5: Symmetry projected local density of states (LDOS) at the centralCu atom of the linear three-atom chain for the case of parallel orientation of magnetizations in the Co leads. Panel (a): s and p states; panel (b): $d_{3r^2} \ _{z^2}$, d_{xz} and d_{yz} states.

The next question is whether the electronic structure of the leads a ects the transport properties through constrictions? To answer this question the Co chains were replaced by Cu chains. It is wellknown that them a jority band of Co m atches the Cu band whereas the m inority band of Co di ers strongly from the Cu band. Our results show that induced m agnetic moments in the Cu chain are quite sm all (see Table I) and the spin-splitting of the LDOS is not signi cant (see Fig. 5). Consequently, the calculated di erence of the transm ission for the two spins is mainly caused by the Co leads (see Fig. 2c,d).

In case of the linear con guration there are highly conducting states around 12 eV both for spin-up and spindown channels. This is due to the matching of the Co d band to the Cu d states which are located in the en-0:75 eV (Fig. 5b). However, these ergy region below highly conducting channels are closed in the zigzag conguration (Fig. 2d) due to the same symmetry reasons discussed in case of the Co chains. Above 0:75 eV the electronic structure of spin-up C o states and C u states is sim ilar, thus the majority (spin-up) transmission of the Cu chains (Fig. 2, c, d) is similar to the majority transm ission of the Co chains (Fig. 2, a, b). The energy-dependent transm ission for spin-up electrons is smooth in both congurations. However, the transm ission of the spin-down electrons (Fig. 2c,d) is signi cantly reduced and, nally, a MR ratio of 15% at E_F is obtained (see Fig. 3c,d). The value $1.1 e^2 = h$ of the majority (spin-up) conductance at E_F for three-atom zigzag chain of Cu is in agreem ent with the conductance of an in nite monoatom ic zigzag chain of fcc Cu oriented along [001] direction. Since in that case only one band is crossing the Ferm i level, the conductance is $e^2 = h$ per spin channel. Finally, we conclude that the electronic structure of the leads strongly




FIG.6: Sym m etry projected local density of states (LDOS) at the Siatom s of the linear Sichain in case of parallel orientation of magnetizations in the Co leads. Solid line: central Siatom; dashed-dotted line: contact Siatom next to the Co surface. The peaks of the LDOS around 1.8 eV and near E_F have p_x ; p_y character.

in uences the transm ission through the constriction. The s-like states in the leads (m a jority states of C o) show a high transm ission through an s-like chain, how ever, due to the band m ism atch d-like m inority C o states are strongly scattered and show a low transm ission through the C u chain.

W e further consider conductance through chainsm ade from sp-elements connected to the leads. We have chosen Si and Al, since Si clusters of 2{20 atom s can be produced in the gas phase [30], thus m easurem ents sim ilar to Ref.5 m ight be possible. Although the induced m agnetic m om ents of A land Siatom s are sm all, the M R ratio can be rather large (see Tables I,II). This is due to the "splitting" of the energy-dependent transmission curves which re ects the spin-splitting of the Co bands (see Figs. Fig. 2e{h). For example, in case of a linear Sichain (Fig. 2g), the transmission of spin-up electrons increases up to 3 around 0:6 eV while the spin-down channel has low transm ission which rises only above E_F . As a consequence, the spin-polarization of the current at E_F is high, $P = (q_H - q_{\#}) = (q_H + q_{\#}) = 71\%$, which causes 50% MR (Fig. 3g,h). The characteristic jump of 2 in the transm ission that is obtained in both spin channels at di erent energies can be explained by m eans of the spinresolved LDOS at the Si sites (Fig. 6). The majority LDOS of the central atom shows a pronounced peak at

0.6 eV below E_F shaped like a van-H ove singularity in one dimensional system s. This peak has $p_x; p_y$ character. The same $p_x; p_y$ peak is seen in the minority band but it is shifted due to induced spin-splitting to higher energies just above E $_{\rm F}$. This state is responsible for the increase of the transmission by 2. The minority LDOS of the central Siatom shows another pronounced resonance at

1.8 eV below E_F which does not occur in the majority band and stems from the Co-Si interaction. This peak is also visible in the minority LDOS of the Si close to the Co surface. Since in the minority band the Si van-Hovelike state becomes unoccupied due to spin-splitting, the electrons occupy the state formed by the Co-Si interaction which leads to nearly zero magnetic moments in the Si chain. The same e ect of "splitting" of the energydependent transmission curves is also observed for Al, but the one-dimensional character of the $p_x; p_y$ state is less pronounced compared to Si, therefore the increase of the transmission of the linear Al chain is smoother (Fig. 2e).

In the zigzag con guration the $p_x; p_y$ degeneracy is lifted, so that for Si (Fig. 2h) the transmission increases in steps of 1 both for spin-up and spin-down channels. In case of A l the steps are not so pronounced (Fig. 2f). com paring the zigzag with the linear chains we see that the "splitting" of the transmission curves is conserved in all cases (Fig. 2e{h). The M R ratio, how ever, drops for both A l and Si zigzag chains (Table II).

In conclusion, we have presented ab-initio calculations of the conductance of magnetic atom ic-sized contacts. MR ratios up to 50% are predicted for di erent threeatom chains suspended between Co leads. Our results show that the conductance through s-like states is robust against structural changes whereas the transmission is strongly in uenced by the atom ic arrangement in the chain if p or d states contribute to the current. Furthermore, we have demonstrated that the spin-polarization of the ferrom agnetic leads induces a spin-polarization of the current although the induced magnetic moments in the chain could be rather small (Cu, Al, Si). The induced spin-splitting of the wire states due to ferrom agnetic leads is practically zero for s states but could be as large as 1 eV for p states. In case of sp chains (Al, Si) this causes strong spin-polarization of the current and, consequently, large M R values.
