Photoinduced 3D orientational order in side chain liquid crystalline azopolym ers

Abstract

We apply experimental technique based on the combination of methods dealing with principal refractive indices and absorption coe cients to study the photoinduced 3D orientational order in the lm s of liquid crystalline (LC) azopolymers. The technique is used to identify 3D orientational con gurations of trans azobenzene chrom ophores and to characterize the degree of ordering in term s of order parameters. We study two types of LC azopolymers which form structures with preferred in-plane and out-of-plane alignment of azochrom ophores, correspondingly. Using irradiation with the polarized light of two di erent wavelengths we nd that the kinetics of photoinduced anisotropy can be dom inated by either photo-reorientation (angular redistribution of trans chrom ophores) or photoselection (angular selective trans-cis isom erization) m echanism s depending on the wavelength. At early stages of irradiation the Ims of both azopolymers are biaxial. This biaxiality disappears on reaching a state of photo-saturation. In the regin e of photoselection the photo-saturated state of the lm is optically isotropic. But, in the case of the photo-reorientation m echanism, anisotropy of this state is uniaxial with the optical axis dependent on the preferential alignm ent of azochrom ophores. We form ulate the phenom enological model describing the kinetics of photoinduced an isotropy in term s of the isom er concentrations and the order param eter tensor. We present the num erical results for absorption coe cients that are found to be in good agreem ent with the experim ental data. The m odel is also used to interpret the e ect of changing the mechanism with the wavelength of the pumping light.

I. IN TRODUCTION

A zobenzene and its derivatives have been attracted much attention over the past few decades because of a number of fascinating features of these compounds. They were initially used in preparation of paints, because

of rich spectrum of colors that can be obtained depending on the chemical structure of azochrom ophores. Further investigations revealed strong photochrom ism (photom odi cation of color) of azobenzene derivatives. It was found that this e ect in azobenzene derivatives can be accompanied by a novel phenom enon that is known as photoinduced optical anisotropy (POA) and can be detected in dichroism and birefringence measurements [1].

The discovery of POA opened up a new chapter in studies of azobenzene com pounds. Neporent and Stolbova [2] described POA in viscous solutions of azodyes, then Todorov and co-workers [3] disclosed the same phenomenon in azodye-polymer blends. The anisotropy induced in these systems is rather unstable. The stable POA was observed later on in polymers containing chemically linked azochrom ophores (azopolym ers) [4]. It turned out that stable an isotropy can be induced in both amorphous and liquid crystalline (LC) azopolymers [4, 5, 6, 7, 8, 9, 10]. The e ciency of POA in LC azopolymers is generally much higher than it is for am orphous hom ologues. For example, the photoinduced birefringence can be as high as 0.3 [10] that is a typical value for lowmolecular-weight LCs [11].

It is commonly accepted that the macroscopic anisotropy detected in optical experin ents relects the microscopic orientational order of polym er fragm ents which is mainly determ ined by the order of azochrom ophores in trans con guration. There are two known phenomena underlying the process of orientational ordering of the azochrom ophores: (a) strong absorption dichroism of azobenzene groups that have the optical transition dipole moment approximately directed along the long molecular axis; (b) photochemically induced trans-cis isomerization and subsequent therm al and/or photochem ical cis-trans back isom erization of azobenzene m oieties.

It means that the rate of the photoinduced isom erization strongly depends on orientation of the azobenzene chrom ophores relative to the polarization vector of actinic light E. The fragments oriented perpendicular to E are alm ost inactive, whereas the groups with the long axes parallel to E are them ost active for isom erization.

ation, and were theoretically considered in Refs. [12, 13].

If cis isomers are long-living, the anisotropy is caused by angular selective burning of mesogenic trans isomers due to stimulated transitions to non-mesogenic cis form . The transition rate is angular dependent, so that the trans azochrom ophores normally oriented to E are the least burned. This direction will de ne the axis of the induced anisotropy. This regime of POA is known as the mechanism of angular hole burning (photoselection).

In the opposite case of short-living cis isomers, the azochromophores are excited many times during the POA generation period. These trans-cis-trans isom erization cycles are accompanied by rotations of the azochrom ophores that tend to assum e orientation transverse to E and m in im ize the absorption. Non-photosensitive groups can be involved in the process of reorientation due to cooperative motion [6, 14]. This regime is referred to as the photo-reorientation (angular redistribution) mechanism.

From the above it might be concluded that, whichever mechanism of the ordering is assumed, the exciting light causes preferential alignm ent of a zoben zene chrom ophores along the directions perpendicular to the polarization vector of the actinic light. In 3D space these directions form the plane norm al to E. It can be expected that the angular distribution of azochrom ophores in this plane is isotropic. From the experimental results, however, this is not the case. The uniaxial ordering with strongly preferred in-plane alignment was observed in Refs. [10, 15]. In addition, it was found that the photoinduced orientational structures can show biaxiality [8, 10, 16, 17, 18].

In the past years this spatial character of the photoinduced anisotropies has not received much attention and, until recently, it has been neglected in the bulk of experim entaland theoretical studies of POA in azobenzene containing polymers [4, 12, 13, 14, 19, 20, 21, 22, 23, 24]. On the other hand, the problem s related to the 3D orientational structures in polymeric Im s are currently of considerable in portance in the developm ent of new compensation lm s for liquid crystal (LC) displays [25] and the pretilt angle generation by the use of photoalignm ent m ethod of LC orientation [26].

The known methods suitable for the experim ental study of the 3D orientational distributions in polymer lms can be divided into two groups.

The methods of the rst group are based on absorption m easurem ents. These m ethods have the indisputable advantage that the order param eters of various molecular groups can be estimated from the results of these m easurem ents. Shortcom ings of the known absorption methods [8, 27] are the limited eld of applications and the strong approxin ations.

The second group includes the methods dealing with principal refractive indices. Recently several variations of the prism coupling m ethods have been applied to m easure the principal refractive indices in azopolym er

Im s [28, 29, 30]. These results, however, were not used for in-depth analysis of such features of the spatial ordering as biaxiality and spatial orientation of the optical axes depending on polymer chemical structure, irradiation conditions etc.

Our goal is a comprehensive investigation of the peculiarities of 3D orientational ordering in azopolym ers.

In our previous studies [10, 15, 18] we in the regime of photoselection.

[18] was found to be an experimental technique particularly suitable to characterize light induced anisotropy of orientational structures in azopolymer lms. We have investigated these structures depending on the polarization state of the actinic light [10] and on the molecular constitution [15]. It was additionally found that the kinetics of POA involving both uniaxial and biaxial structures can be theoretically described by using the phenom enological approach suggested in Ref. [18].

> In this work we concentrate on the features of the 3D orientation determined by the discussed above mechanism softhe photoinduced ordering. The dierent regimes of POA are realized experim entally by choosing appropriate polymers and irradiation conditions. There are two azopolymers of different structure used in this study and the optical anisotropy was induced by irradiating the sam ples at two di erent wavelengths. We nd that the regime of POA in one of the polymers strongly depends on the wavelength of the exciting light, whereas the other presents the case in which POA is governed by the photo-reorientation mechanism regardless of the wavelength.

> W e show that the experim ental results can be interpreted on the basis of the phenom enological model describing the kinetics of POA in terms of angular redistribution probabilities and order parameter correlation functions. This model can be deduced by using the procedure of Refs. [18, 31] and is found to give the results that are in good agreem ent with the experim ental data. W e also apply the model to calculate the outof-plane absorbance that cannot be directly estimated from the results of measurements

The polymers were dissolved in dichloretane up to concentration 3 weight % and spin coated on the quartz slides. The obtained In swere kept at room tem perature over one day for evaporation of the solvent. The thickness of the lm s of about 200-600 nm was measured with a pro lom eter. 


FIG.1: Chem ical structure of polymers.




FIG.2:UV/V is absorption spectra of polymer lms.

W e need to have the light com ing out of the quarter wave plate almost linearly polarized when the system analyzes the phase shift between two orthogonal eigenmodes of the sample. In our experimental setup this requirement can be met, when the x axis, directed along the polarization vector of the actinic light, is oriented horizontally or vertically. Dependencies of the analyzer rotation on the incidence angle of the testangle were measured for both vertical ing beam and horizontal orientation of the x axis. The value of n_x was measured with the Abbe refractom eter independently.

By using Berreman's 4 4 matrix method [35], the -dependencies of were calculated. Maxwell's equations for the light propagation through the system of polarizer, sample and quarter wave plate were solved num erically for the di erent con gurations of optical axes in the samples. The measured and computed versus curves were tted in the most probable con guration modelusing the measured value of n_x .

We conclude on alignment of the azobenzene fragments from the obtained values of $(n_y \quad n_x)d$ and $(n_z \quad n_x)d$ assuming that the preferred direction of these fragments coincides with the direction of the largest refractive index. More details on the method can be found in our previous publication [10].

In our setup designed for the null ellipsom etry measurements we used a low power He-Ne laser (= 632.8 nm), two G lan-Thom pson polarizers mounted on rotational stages from O rielC orp., a quarter wave plate from Edm und Scienti c and a sam ple holder mounted on the rotational stage. The light intensity was measured with a photodiode. The setup was automatically controlled by a personal computer. The rotation accuracy of the analyzer was better than 0.2 degree.

D. Absorption method

The UV/V is absorption measurements were carried out using a diode array spectrometer (O ceanOptics). The samples were set normally to the testing beam of a deuterium lamp. A G lan-Thompson prism mounted on a computer-driven stepper was used to control the polarization of the testing beam, E_t .

The UV spectra of both original and irradiated Im swere measured in the spectral range from 250 nm to 600 nm for the probing light linearly polarized along the x and y axes. From these data the optical density components D_x and D_y were estimated at the absorption maximum of azochrom ophores, t = 375 nm (for polymer P1) and t = 343 nm (for polymer P2).

In general, it is di cult to estimate the out-of-plane absorption coe cient D_z. This, however, can be done in the regime of POA where the fraction of cis isom ers is negligible (the photo-reorientation mechanism) by using them ethod proposed in Refs. [8, 36]. The key point is that the sum of all the principal absorption coe cients, D_{tot} = D_x + D_y + D_z, does not depend on irradiation doses. So, if the anisotropy is known to be uniaxial at time t₀ with either D_x(t₀) = D_z(t₀) or D_y(t₀) = D_z(t₀), this will yield the relation

where n_o is the optical axis and \hat{e}_i is the ith coordinate unit vector. The out-of-plane component D_z can now be computed from Eq. (1). In addition, we calculate the absorption order parameters $S_i^{(a)}$ de ned by the expression




FIG. 3: Nullellipsometry setup.

III. EXPERIMENTAL RESULTS


A. Non-irradiated lm s

Fig. 5(a) shows the experimentally measured curves of the phase shift versus incidence angle for the polymer P1. The curve 1 corresponds to the non-irradiated lm. The curves measured for vertical and horizontal position of the x-axis overlap. This im plies that the in-plane principle indices n_x and n_y are matched. Fig. 5(b) shows the measured versus curves for the polymer P2. The results obtained for the non-irradiated Im (curve 1) imply that, similar to the polymer P1, the in-plane birefringence is negligibly small. 0. 



(b) non-irradiated P1 polym er with $n_z < n_y = n_x$






(c) photo-saturated P1 polym er w ith $n_y > \ n_x = \ n_z$




FIG.5: M easured (circles and squares) and m odeled (solid lines) curves for analyzer angle versus incidence angle for polymer P1 (a) and polymer P2 (b).

In this case, the azobenzene fragments show planar alignment perpendicular to the UV light polarization.

The tted values of the in-plane, $(n_y n_x)d$, and out-of plane, $(n_z n_x)d$, retardation for P1 corresponding to various irradiation times e_x are presented in Fig. 6 (a). The in-plane birefringence increases and saturates as the irradiation time increases. Whereas the out-of-plane birefringence is a decreasing function of the irradiation time and the di erence between n_z and n_x become es negligible in the saturation state. Fig. 6(b) represents the results of the absorption measurements for P1 Im before irradiation and after subsequent irradiation steps. In accord with the null ellipsometry results after irradiation D_y is above D_x and the azochrom ophores are aligned along the y direction that is perpendicular to E.




FIG.6: (a) B irefringence, (b) principal absorption coe cients, and (c) order parameter components as a function of irradiation time at $_{ex}$ = 365 nm and I = 1.5 mW /cm² for polymer P1.

The curves D_x ($_{ex}$) and D_y ($_{ex}$) are typicalof the photo-reorientation mechanism [12, 13]. In this case the fraction of cis isomers is negligible and the out-of-plane absorption coe cient D_z depicted in Fig. 6(b) can be estimated by using Eq. (1) to calculate D_{tot} in the photo-saturated state where $D_x^{(st)} = D_z^{(st)}$. Fig. 6(c) shows the absorption order parameters $S_i^{(a)}$ computed from the expression (2).

The curve 2 in Fig. 5(b) shows the measured versus function for the lm of P2 irradiated with UV light over 60 m in. The

curves corresponding to the vertical and the horizontal positions of the x axis of the lm overlap. The tting gives $n_x = n_y = n_z$ and, thus, the angular distribution of azobenzene chrom ophores is isotropic.




FIG. 7: (a) Birefringence, (b) principal absorption coe cients, and (c) order parameter components as a function of irradiation time at $e_x = 365$ nm and I = 1.5 mW /cm² for polymer P2.




FIG.8: (a) B irefringence, (b) principal absorption coe cients, and (c) order parameter components as a function of irradiation time at $_{ex}$ = 488 nm and I = 0:7 W /cm² for polymer P1.




FIG.9: (a) Birefringence, (b) principal absorption coe cients, and (c) order param eter com ponents as a function of irradiation time at $_{\rm ex}$ = 488 nm and I = 0:7 W /cm 2 for polymer P2.




FIG. 10: Birefringence versus irradiation time for the pre-irradiated polymer P2 (see discussion in Sec. IIID).

The curing of P1 Im s at the tem peratures of nem atic and sm ectic m esophases followed by cooling down to room temperature destroys biaxiality of the photoinduced structures and enhances the uniaxial anisotropy. Similar e ects were observed at the short time (about 5 m in) curing in the isotropic state at 70°C . In this case the prolonged curing caused the disappearance of the induced anisotropy.

The curing of P2 lm s at tem peratures of nem atic and isotropic phases transform ed the structure of negative uniaxial medium into the positive uniaxial con guration with azochrom ophores aligned perpendicular to the lm substrate.

2. Absorption cross sections

The above m entioned photo-induced reorientation accompanying photochem ical process makes it extremely di cult to estimate the coe cients of the molecular extinction in polymer lms. For this purpose we applied the method well known for polymer solutions [39]. Both polymers were dissolved in toluene at concentration 5 10 3 g/l. Theoretical considerations of this section deal with the kinetics of POA that determines how amount of photoinduced anisotropy characterized by either absorption dichroism or birefringence evolves in time upon illum ination and after switching it o . Below we brie y discuss the simple phenom enological model describing the kinetics of POA in terms of the order parameter tensor and the concentrations of azochromophores. More details on the model and the underlying phenom enological approach can be found in Refs. [18, 31]).

We can now consider the simplest modication of the parabolic approximation obtained by rescaling the order param eter com ponents: $hS_{ii}i_{tr}$! $hS_{ii}i_{tr}$ and use the mean eld param eterization (26) to estim ate its accuracy. The coe cient is computed from the condition that there are no uctuations provided the molecules are perfectly aligned along the coordinate unit vector \hat{e}_i : $G_{ii;ii}^{(tr)} = 0$ at $hS_{ii}i_{tr} = \frac{1}{p}1$. It gives the value of equal to $(1 + 0.6^{\circ} 30) = 7$. The results of num erical analysis reported in [31] shows that this heuristic procedure gives reasonably accurate approximation for correlators of the mean eld distributions (26).

V. NUMERICAL RESULTS

In this section we employ our model to interpret the experimental data of the UV absorption measurements for dierent irradiation doses. The principal absorption $\cos - \cosh D_i$ can be related to the concentrations and the order parameters as follows

Eq. (32) implies that the method of total absorption based on Eq. (1) is applicable when the fraction of cis fragments is negligible, n_{cis} 0. In this case from Eq. (32) the absorption order parameters (2) are proportional to $S_i: S_i^{(a)} = u^{(a)} = (3 + u^{(a)})S_i$.

The theoretical curves are computed by solving the kinetic equations of the model discussed in the previous section. Initial values of the order parameters S (0) and S (0) are taken from the experimental data measured at $_{\rm ex}$ = 488 nm. Since the system is initially at the equilibrium state, the remaining part of the initial conditions is: S_p(0) = S (0), S_p(0) = S (0), n_{tr}(0) = 1 and n_{cis}(0) = 0.

From the other hand, reaching the photosteady state orientational structure of the polymers is characterized by dierent uniaxial anisotropies: $S_x^{(st)} = S_z^{(st)} < S_y^{(st)}$ (polymerP1) and $S_x^{(st)} < S_y^{(st)} = S_z^{(st)}$ (polymer P2). So, as is shown in Figs. 6{ 9, the transient anisotropic structures are inevitably biaxial. These biaxial e ects are related to the dierence between the initial anisotropy of polymer lms and the anisotropy of the photo-saturated state.

Numerical calculations in the presence of irradiation were followed by computing the stationary values of S and S to which the order parameters decay after switching o the irradiation at time t_0 . For the polymer P2 the lifetime of the cis fragments was found to be much longer than the periods exam ined and we can safely neglect $_{c}$. If $_{c} = 0$ the kinetic equations in the absence of irradiation can be easily solved to yield the stationary value of S_{i} and $S_{i}^{(p)}$: $pn_{tr}(t_{0})S_{i}(t_{0}) + trS_{i}^{(p)}(t_{0}) = ,$ $_{p}n_{tr}(t_{0}) + _{tr}$. There is no furwhere ther relaxation after reaching this stationary state and its anisotropy is long term stable. The lifetime of cis forms in polymer P1 is $_{c} = 12$ s and the kinetic equations need to be solved num erically. This, however, does not a ect the conclusion about the long term stability of POA.

> For these polymers the absorption anisotropy parameters and the quantum e ciencies are unknown and need to be tted. We used the value of S_{st} as an adjustable parameter, so that the anisotropy parameters u and u^(a) can be derived from Eq. (34) and from the experimental value of the absorption order parameter $S_{\rm st}^{\,\rm (a)}$ m easured at $e_x = 488 \text{ nm}$ in the photosteady state.

It is illustrated in Figs. 6(b) and 8(b), where the measured and the calculated curves are in good agreem ent and correspond to the photoreorientation m echanism .

In polym er P 2 cis isom ers are long-living with negligibly small relaxation rate . The parameter r is now the ratio of the rates qLI and qI that characterize cis ! trans and trans ! cis stimulated transitions, correspondingly. This ratio is determined by the quantum e ciencies, tr! cis and cis! tr, and the absorption cross sections, $\frac{(tr)}{2}$ and cis. In this case we can have both mechanisms depending on the wavelength of excitation.

Fig. 9 presents the case in which the wavelength of light is far from the absorption m axin um, $_{ex}$ = 488 nm. It seen that, sim ilar to polymer P1, the kinetics of the absorption coe cients, presented in Fig. 9(b), is typical for photo-reorientation m echanism . A coording to Table I, the value of r is 69:1 and we can use Eqs. (33)-(34) to estimate the fraction $n_{cis}^{(st)}$ at about 0.02. It means that in this case the cis ! trans transitions stimulated by the exciting light will e ciently deplete the cis state and the absorption coe cients are controlled by the terms proportional to the order parameter of trans molecules (see Eq. (32)).

By contrast, Fig. 7 (b) shows that the experim ental dependencies for both D $_{\rm x}$ and D $_{\rm v}$ are decreasing functions of the irradiation time at the wavelength, $e_x = 365 \text{ nm}$, near the maximum of absorption band. It indicates that the kinetics of POA is governed by the mechanism of photoselection. In this case we have r = 0.03 and $n_{cis}^{(st)} = 0.98$. The method described in Sec. IID is now inapplicable, so the out-of-plane absorption co-

VI. DISCUSSION CONCLU-AND SIONS

In Sec.V we have introduced the param eter r that can be written as the ratio of the characteristic tim e of trans-cis isom erization, $e_x = 1 = (q_t I)$, to the time characterizing decay of the cis state in the presence of irradiation, $\sim_{c} = 1 = (_{c} + q_{c}I)$. We have also shown that depending on the value of this param eter the kinetics of POA is governed by either photoselection or photo-reorientation m echanism s.

For large values of r, r 1, we have ex, so that the lifetime of cis iso-~c m ers under irradiation $\sim_{\rm c}$ is short and the isomers are short-living. In this case the photoreorientation mechanism is found to dom inate the kinetics of POA. The opposite case of sm all values of r characterizes the regime of photoselection, where \sim_{c} ex and cis isomers are long-living in the presence of irradiation.

It should be stressed that the mechanism of photoselection cannot occur in polymers with high rate of therm al cis-trans isom erization c, where the time of trans-cis isomerization _{ex} is longer than the lifetime of cis isomers c = 1 = c > c. In our study this case is represented by polymer P1 in which the mechanism of photo-reorientation dom inates at both wavelengths of excitation.

In polym er P 2 $_{\rm c}$ is very sm all and the relaxation time \sim_{c} is determined by the rate of cis-trans photoisom erization q.I. W hen the wavelength of the exciting light is in n absorption band of azochrom ophores, this rate is higher than the rate of trans-cis isom erization, q.I. So, at $e_x = 488$ nm the photoreorientation mechanism dominates in both polymers.

Forpolym erP2 thism eans that there is nothing to prevent the cis state from being populated under the action of UV light and the kinetics of POA is now governed by the mechanism of photoselection.

The photochem ical properties of azopolymers are determined in large part by the molecular structure of azochrom ophores, which incorporates the azobenzene core and substitutes. For instance, su ciently polarized azochromophores (push-pull chrom ophores) usually have short-living cis isomers. On the other hand, the chrom ophores containing long alkyl substitutes are characterized by long-living cis form . Our results show that the polymers under consideration comply with these rules.

In addition, the molecular structure of azopolymers determines self-organization of azochrom ophores, which in turn a ects 3D orientational ordering. By self-organization is meant a number of complex processes related to the spontaneous alignment and aggregation of anisotropic azobenzene chrom ophores, processes of collective orientation, self-assembling at the interfaces etc. The initial anisotropy of non-irradiated polymer

In s is de ned by these processes. W e found that the azochrom ophores in P1 lm s prefer in-plane orientation, whereas the preferential alignment of the fragments in P2 lms is hom eotropic. The factors responsible for this di erence have not been studied in any detail yet.

The intrinsic self-organization of azochromophores also plays a part in the ordering stimulated by actinic light [15]. The excitation of azochrom ophores stimulates these processes of self-organization that are slowed down in the glassy state. The contribution of self-organization processes may ex- der irradiation im plies their collective orienplain di erent anisotropies observed in poly- tation and liquid crystallinity. The negative in-plane order induced in polymer P2 by the light with $e_x = 488 \text{ nm}$ m ay be explained by assuming the dominating role of the photo-reorientation mechanism. Generally, we know from experience that the negative uniaxial anisotropy with the optical axis parallel to the polarization vector of the exciting light can be easily induced in polym ers showing preference to outof-plane alignm ent of azochrom ophores.

The photosaturated state of polymer P2 In s invadiated at $e_x = 365$ nm is found to be optically isotropic with $n_x = n_y = n_z$. As we have already noted in Sec. IIIB 2, extremely low concentration of trans chromophores will render the lm e ectively isotropic. This is the case even if the angular distribution of trans isomers retains an amount of anisotropy caused by the angular selective character of the burning process. From the other hand, non-m esogenic cis isom ers at high concentrations could result in disordering e ects up to suppressing LC properties of azopolym ers [46]. From our optical m easurem ents we cannot unam biguously conclude on signi cance of these e ects for polymer P2.

Thus, in the regime of photo-reorientation the orientational structures observed in the photo-saturation state are uniaxial with optical axes determ ined by the polarization of the light and by the favored orientation of the azochrom ophores. In the case of photoselection these structures are optically isotropic. The anisotropic structures induced at early stages of irradiation are biaxial. These transient structures are form ed in passing from the initial uniaxial structure to the state of photo-saturation.

Self-organization of azochrom ophores un-

non-photosensitive fragments (matrix) that is in uenced by the orientation of azochromophores. According to Refs. [14, 24], the latter factor seems to be of crucial importance in stabilizing the photoinduced order.

In our experiments the photoinduced anisotropy has been seen to be stable over at least several weeks. The anisotropy can be erased and rewritten by the light. This long term stability of the induced order in plies e ective orientation of polymer matrix in both photo-reorientation and photoselection regimes of POA.

In order to interpret the experim ental results on the kinetics of the photoinduced absorption dichroism we employed the theoretical model formulated by using the phenom enological approach of Refs. [18, 31]. This approach describes the kinetics of POA in terms of one-particle angular distribution functions and angular redistribution probabilities. The probabilities enter the photoisom erization rates and de ne coupling between the azochromophores and the anisotropic eld represented by the distribution function of the polymer matrix fp. This anisotropic eld re ects the presence of long-living angular correlations and stabilizes the photoinduced anisotropy.

The key assumption of the model is that the cis fragments are isotropic and do not a ect the ordering kinetics directly. Certainly, this is the sim plest case to start from before studying more complicated models. So, we studied the predictions of this sim ple model for both polymers to test its applicability. To this end we have estimated a number of photochem ical parameters that enter the model from the experim ental data. Only the absorption anisotropy parameters and the quantum yields need to be adjusted. The comparison between the numerical results and the experim ental data shows that the model correctly captures the basic features of POA in a zopolymers.

order parameters $S_i^{(a)}$ in the photoselection regim e where the experim entalm ethod of estim ation is inapplicable. The model has also been applied to estimate concentrations of isom ers, quantum yields of photoisom erization and anisotropy of molecular absorption. It provides a criterion for the occurrence of di erent m echanism s and describes the biaxiality e ects.

So, we have demonstrated that the phenom enological approach of [18, 31] can be used as a useful tool for studying photoinduced ordering processes in azopolymers. But it should be noted that theoretical approaches of this sort, by de nition, do not involve explicit considerations of m icroscopic details of azopolym er physics. A more com prehensive study is required to relate the effective parameters of our model and physicalparam eters characterizing interactions between molecular units of polymers. For example, the initial anisotropy of polymer lm s is taken into account through the initial conditions for the kinetic equations and the theory then properly describes the biaxiality effects. But the process of structure form ation in non-irradiated polymer lms is well beyond the scope of the model and such description cannot serve as an explanation of biaxiality. Sim ilarly, the suppressed out-of-plane reorientation of azochrom ophores in polym er P1 is treated as a constraint in posed by the polym eric environm ent and is taken into consideration by modifying the order parameter correlation functions.

Our results show that neglecting the inuence of cis isomers on the orientational order of the anisotropic trans isom ers does not lead to considerable discrepancies between the theoretical results and the experin ental data. In general, the presence of non-mesogenic cis isomers could give rise to deterioration of the photoinduced order of trans fragments.
