# Photoinduced 3D orientational order in side chain liquid crystalline azopolym ers

#### Abstract

We apply experim ental technique based on the com bination of $m$ ethods dealing $w$ ith principal refractive indices and absonption coe cients to study the photoinduced 3D orientational order in the m sof liquid crystalline (LC) azopolym ers. The technique is used to identify 3D orientational con gurations of trans azobenzene chrom ophores and to characterize the degree of ordering in term s of order param eters. We study two types of LC azopolym ers which form structures $w$ th preferred in-plane and out-of-plane alignm ent of azochrom ophores, correspondingly. U sing irradiation w th the polarized light of tw o di erent wavelengths we nd that the kinetics of photoinduced an isotropy can be dom inated by either photo-reorientation (angular redistribution of trans chrom ophores) or photoselection (angular selective trans-cis isom erization) m echanism $s$ depending on the wavelength. At early stages of irradiation the m s of both azopolym ers are biaxial. This biaxiality disappears on reaching a state of photo-saturation. In the regim e of photoselection the photo-saturated state of the m is optically isotropic. But, in the case of the photo-reorientation $m$ echanism, anisotropy of this state is uniaxialw th the optical axis dependent on the preferential alignm ent of azochrom ophores. W e form ulate the phenom enological m odel describing the kinetics of photoinduced anisotropy in term s of the isom er concentrations and the order param eter tensor. W e present the num erical results for absonption coe cients that are found to be in good agree$m$ ent $w$ th the experim ental data. The $m$ odel is also used to interpret the e ect of changing the

## I. INTRODUCTION

A zobenzene and its derivatives have been attracted $m$ uch attention over the past few decades because of a num ber of fascinating features of these com pounds. They were initially used in preparation of paints, because

[^0]of rich spectrum of colors that can be obtained depending on the chem ical structure of azochrom ophores. Further investigations revealed strong photochrom ism (photom odi cation of color) of azobenzene derivatives. It was found that this e ect in azobenzene derivatives can be accom panied by a novel phenom enon that is known as photoinduced optical anisotropy (POA) and can be detected in dichroism and birefringence $m$ easurem ents $\left.{ }_{[1]}^{1 / 1}\right]$.

The discovery of POA opened up a new chapter in studies of azobenzene com pounds. N eporent and Stolbova $\overline{[ }]$ ] described POA in viscous solutions of azodyes, then Todorov and co-workers $\left.{ }_{[10}^{-1}\right]$ disclosed the sam e phenom enon in azodye-polym er blends. The anisotropy induced in these system $s$ is rather unstable. The stable POA was observed later on in polym ens containing chem ically linked azochrom ophores (azopolym ers) [位]. It tumed out that stable anisotropy can be induced in both am onphous and liquid crystalline (LC ) azopolym ers $[\overline{1}, r, 1$ The e ciency of POA in LC azopolym ers is generally much higher than it is for am orphous hom ologues. For exam ple, the photoinduced birefringence can be as high as 0.3 [100] that is a typical value for lowm olecular-w eight LC s [ī11].

It is com $m$ only accepted that the $m$ acroscopic anisotropy detected in optical experim ents re ects the $m$ icroscopic orientational order of polym er fragm ents which is m ainly determ ined by the order of azochrom ophores in trans con guration. There are two known phenom ena underlying the process of orientational ordering of the azochrom ophores: (a) strong absonption dichroism of azobenzene groups that have the optical transition dipole $m$ om ent approxim ately directed along the long m olecular axis; (b) photochem ically induced trans-cis isom erization and subsequent them al and/or photochem ical cistrans back isom erization of azobenzene $m$ oieties.

It $m$ eans that the rate of the photoinduced isom erization strongly depends on orientation of the azobenzene chrom ophores relative to the polarization vector of actinic light E . The fragm ents oriented penpendicular to $E$ are alm ost inactive, whereas the groups w ith the long axes parallelto $E$ are them ost active for isom erization.

There are two di erent regim es of the photoinduced ordering. These regim es are usually recognized as two lim iting cases related to the lifetim e of cis isom ens under irradi-
ation, and were theoretically considered in


If cis isomers are long-living, the anisotropy is caused by angular selective buming of $m$ esogenic trans isom ers due to stim ulated transitions to non-m esogenic cis form. The transition rate is angular dependent, so that the trans azochrom ophores norm ally oriented to E are the least bumed. This direction $w i l l$ de ne the axis of the induced anisotropy. This regim e of POA is known as the mechanism of angular hole buming (photoselection).

In the opposite case of short-living cis isom ers, the azochrom ophores are excited $m$ any tim es during the POA generation period. T hese trans-cis-trans isom erization cycles are accom panied by rotations of the azochrom ophores that tend to assum e orientation transverse to $E$ and $m$ inim ize the $a b-$ sonption. N on-photosensitive groups can be involved in the process of reorientation due to cooperative m otion $\left[\overline{6},{ }^{\prime}, 1 \overline{1} \overline{4} 1\right] . \mathrm{T}$ his regim e is referred to as the photo-reorientation (angular redistribution) m echanism .

From the above it $m$ ight be concluded that, whichever mechanism of the ordering is assum ed, the exciting light causes preferentialalignm ent ofazobenzene chrom ophores along the directions perpendicular to the polarization vector of the actinic light. In 3D space these directions form the plane norm al to E. It can be expected that the angular distribution of azochrom ophores in this plane is isotropic. From the experim ental results, however, this is not the case. The uniaxial ordering $w$ ith strongly preferred in-plane alignm ent was observed in Refs. $[\overline{1} 0 \overline{0}, 1 \overline{1}$ In addition, it was found that the photoinduced orientational stnuctures can show biaxialty

This implies that actually the system is not spherically sym $m$ etric in the absence of light and som e of the above directions are preferred depending on a number of additional factors such as irradiation conditions, chem icalstructure ofpolym ers, surface inter-
action etc. These factors com bined w ith the action of light $m$ ay result in a large variety of orientational con gurations (uniaxial, biaxial, splayed) characterized by di erent spatial orientations of the principal axes.

In the past years this spatial character of the photoinduced anisotropies has not received much attention and, until recently, it has been neglected in the bulk of experim entaland theoretical studies ofP OA in azoben-

 the problem s related to the 3D orientational structures in polym eric m s are currently of considerable im portance in the developm ent of new com pensation m s for liquid crystal (LC ) displays [2]-1] and the pretilt angle generation by the use of photoalignm ent $m$ ethod of LC orientation [2]

The known $m$ ethods suitable for the experim ental study of the 3D orientationaldistributions in polym er $\mathrm{m} s$ can be divided into two groups.

The methods of the rst group are based on absonption $m$ easurem ents. Thesem ethods have the indisputable advantage that the order param eters of various $m$ olecular groups can be estim ated from the results of these $m$ easurem ents. Shortcom ings of the known
 eld of applications and the strong approxim ations.

The second group includes the $m$ ethods dealing $w$ th principal refractive indiges. $\mathrm{Re}-$ cently several variations of the prism cou$p l i n g m$ ethods have been applied to $m$ easure the principal refractive indices in azopolym er
 were not used for in-depth analysis of such features of the spatial ordering as biaxiality and spatial orientation of the opticalaxes depending on polym er chem ical structure, irradiation conditions etc.

O ur goal is a com prehensive investigation of the peculiarities of 3D orientational ordering in azopolym ers.

were $m$ ainly concemed with the e ects related to the peculiarities of azopolym er selforganization that, in addition to the sym me etry axis de ned by the light polarization, affect the light-induced 3D ordering. T he com bination of $m$ ethods described in Ref. [ī $\overline{1}]$ was found to be an experim ental technique particularly suitable to characterize light induced anisotropy of orientational structures in azopolym er lm s . W e have investigated these structures depending on the polarization state of the actinic light $[1 \overline{1} 0 \overline{1}]$ and on the m olecular constitution [ī-1.]. It was additionally found that the kinetics of POA involving both uniaxial and biaxial structures can be theoretically described by using the phenom enological approach suggested in Ref.

In this work we concentrate on the features of the 3D orientation determ ined by the discussed abovem echanism softhe photoinduced ordering. The di erent regin es of POA are realized experim entally by choosing appropriate polym ers and irradiation conditions. There are two azopolym ens of different structure used in this study and the optical anisotropy was induced by irradiating the sam ples at tw o di erent wavelengths. $W e$ nd that the regime of POA in one of the polym ers strongly depends on the wavelength of the exciting light, whereas the other presents the case in which POA is govemed by the photo-reorientation $m$ echanism regardless of the w avelength.

W e show that the experim ental results can be interpreted on the basis of the phenom enologicalm odel describing the kinetics of POA in term $s$ of angular redistribution probabilities and order param eter correlation functions. This model can be deduced by us-
 found to give the results that are in good agreem ent w th the experim ental data. W e also apply the model to calculate the outofplane absorbance that cannot be directly estim ated from the results of $m$ easurem ents in the regim e of photoselection.

T he paper is organized as follow s. Sec. 1 It contains the details on the combination of null ellipsom etry and absonption $m$ ethods used in this study as an experim ental procedure. The experim entally $m$ easured dependencies of birefringence and absonption didhroism on the illum ination doses are presented in Sec. 位 We draw together these results to unambiguously identify the anisotropy of the orientational structures induced in azopolym er lm sand to $m$ easure the ordering ofazochrom ophores through the absorption order param eter. A nisotropy of the initialstructures and of the structures in the regim e ofphotosaturation is found to be uniaxial in both azopolym ers. At early stages of irradiation the transient anisotropic structures are biaxial. It is show $n$ that under certain conditions the regim e of the kinetics of POA can be changed w th the wavelength of the pum ping light. W e also discuss therm al stability of the photoinduced anisotropy and experim ental estim ates of the photochem icalparam eters needed for theoretical calcula-
 $m$ odel form ulated by using the phenom enological approach of $\left[\underline{1} \bar{Z}_{-}, 1,1 \overline{1}_{1}\right]$. W e discuss the physical assum ptions underlying the model and $m$ ake brief com $m$ ents on the derivation of the kinetic equations for the concentrations of isom ers and the order param eter tensor. In Sec. 'IV'I we present num erical results for the absorption coe cients and the order param eters in relation to the irradiation dose calculated by solving the equations of the model. W e com pare these results with the experim ental data and com $m$ ent on the predictions of the m odel conceming biaxiality e ects, stability and the regim es of POA. $F$ inally, general discussion of our results and som e concluding rem arks are given in Sec. $\bar{N}$
II. EXPERIMENTALPROCEDURE
A. Polym ers

The chem ical form ulas of two azopoly$m$ ers used in our experim ents are presented in Fig. ${ }^{1} \bar{I}_{1}$. T he details on synthesis of the poly$m$ ers P 1 and P 2 can be found in Ref. [了̄2̄] and in Ref. [ַ̄3̄], correspondingly. T he poly$m$ ers were characterized by elem ental analysis and 1H NM R spectroscopy. M olecular weight of the polym ens was determ ined by gel perm eation chrom atography. T he average m olecular weight of P 1 and P 2 is estim ated at $13,500 \mathrm{~g} / \mathrm{m} \mathrm{ol}$ and $36,000 \mathrm{~g} / \mathrm{m} \mathrm{ol}$, respectively. B oth m aterials are comb-like polym ers w ith azobenzene fragm ents in side chains connected by exible alkyl spacers to the polym er backbone. The azobenzene chrom ophore of the polym er P 1 contains polar $\mathrm{NO}_{2}$ end group that has strong acceptor properties. The azobenzene chrom ophore of polym er P 2 contains hydrophobic alkyl tail $\mathrm{OC}_{4} \mathrm{H}_{9}$. The phase transitions in the polym ens were investigated by di erential scanning calorim etry and polarization $m$ icroscopy. B oth azopolym ens are found to possess liquid crystalline properties in the respective tem perature regions. Polym er P 1 form s sm ectic A and nem atic m esophases w thin the tem perature range $44^{\circ} \mathrm{C}\left\{52^{\circ} \mathrm{C}\right.$ and $52^{\circ} \mathrm{C}\left\{55^{\circ} \mathrm{C}\right.$, respectively. Polym er P 2 has a nem atic mesophase within the tem perature interval $112^{\circ} \mathrm{C}\left\{140^{\circ} \mathrm{C}\right.$. Both polym ers are solids at room tem perature.

## B. Sam ple preparation

The polym ens were dissolved in didhloretane up to concentration 3 weight \% and spin coated on the quartz slides. The obtained lm sw ere kept at room tem perature over one day for evaporation of the solvent. $T$ he thickness of the m s of about $200-600 \mathrm{~nm}$ was $m$ easured w ith a pro lom eter. T he UV/V is spectra of the m s m easured by silicon array spectrom eter (O ceanO ptics Inc.) are pre-

sented in Fig.'ī. It can be seen that the position of the $m$ ost intensive absonption band ( band of azobenzene chrom ophore) depends on the end substitute of the chrom ophore. The wavelength of the m axim al absonption, $m$ ax, for polym er P1 containing chrom ophore w ith push-pullproperties is shifted to the red as com pared to $m$ ax for P 2 .

The anisotropy in the $\mathrm{m} s$ was induced under irradiation from two di erent sources of light w ith di erent wavelengths ex and intensities I:

1. an $\mathrm{Ar}^{+}$laser w ith ex $=488 \mathrm{~nm}$ and $\mathrm{I}=0: 7 \mathrm{~W} / \mathrm{cm}^{2}$;
2. a mercury lamp with ex $=365 \mathrm{~nm}$ and $I=1: 5 \mathrm{~mW} / \mathrm{cm}^{2}$. In this case the
light w as selected by an interference ter and polarized w ith a G lan-Tom pson polarization prism .

The wavelengths 365 nm and 488 nm fallinto and $n$ absonption band of azopolym ers, respectively. In both cases the m swere irradiated at norm al incidence of the actinic light. The irradiation was carried out in several steps followed by studies of the orientational structure. The resulting tim e of irradiation was calculated by adding irradiation tim es of all irradiation steps assum ing accum ulation of the structural changes. The tim e interval betw een irradiation and structural studies was about 15 m in. The reason for tim e delay betw een these processes w illlbe discussed below.

C. N ull ellip som etry m ethod

Instead of the prism coupling methods com $m$ only used for the estim ation of principal refractive indiges we applied null ellipsom etry technique [ $\overline{3} \overline{4} \overline{4}]$ dealing $w$ ith birefringence com ponents. By this $m$ eans we have avoided some disadvantages of prism cou$p l i n g m$ ethod such as the problem ofm aking optical contact between the prism and the polym er layer.

The optical schem e of our m ethod is presented in Fig. 'ה্র. . T he polym er m is placed betw een crossed polarizer and analyzer and a quarter wave plate $w$ th the optic axes oriented parallel to the polarization direction of the polarizer. T he light beam, which w avelength is far aw ay from the absorption band of the polym er, is passing through the optical system. T he elliptically polarized beam passing through the sample is transform ed into the linearly polarized light by m eans
of the quarter w ave plate. T he polarization plane of this light is tumed w ith respect to the polarization direction of the polarizer. This rotation is related to the phase retardation acquired by the light beam after passing through the lm under investigation. It can be com pensated by rotating the analyzer by the angle that encodes inform ation on the phase retardation.

Thism ethod used for the norm alincidence of the testing light is know $n$ as the Senam ont technique. It is suitable for the in-plane birefringence $m$ easurem ents.

Using oblique incidence of the testing beam we have extended this $m$ ethod for esti$m$ ation ofboth in-plane, $n_{y} \quad n_{x}$, and out-ofplane $n_{z} \quad n_{x}$ birefringence $\left(n_{x}, n_{y}\right.$ and $n_{z}$ are the principal refractive indices of the m ). In this case, the angle depends on the in-plane retardation ( $n_{y} \quad n_{x}$ ) d, the out-of-plane retardation $\left(n_{z} \quad n_{x}\right) d$ and the absolute value of a
refractive index of the biaxial m , say, $\mathrm{n}_{\mathrm{x}}$.

W e need to have the light com ing out of the quarter wave plate alm ost linearly polarized when the system analyzes the phase shift between two orthogonal eigenm odes of the sam ple. In our experim ental setup this requirem ent can be $m$ et, when the $x$ axis, directed along the polarization vector of the actinic light, is oriented horizontally or vertically. D ependencies of the analyzer rotation angle on the incidence angle of the testing beam were $m$ easured for both vertical and horizontal orientation of the x axis. The value of $n_{x}$ was $m$ easured $w$ ith the Abbe refractom eter independently.

By using Berrem an's $4 \quad 4 \mathrm{~m}$ atrix $m$ ethod [ $\left.\mathrm{B} 5{ }^{2} 5\right]$, the -dependencies of were calculated. M axw ell's equations for the light propagation through the system of polarizer, sam ple and quarter wave plate were solved num erically for the di erent con gurations of optical axes in the sam ples. The $m$ easured and computed versus curves were tted in the $m$ ost probable con guration $m$ odelusing the $m$ easured value of $n_{x}$.

W e conclude on alignm ent of the azobenzene fragm ents from the obtained values of $\left(\begin{array}{ll}n_{y} & n_{z}\end{array}\right) d$ and ( $\left.\begin{array}{ll}n_{z} & n_{x}\end{array}\right) d$ assum ing that the preferred direction of these fragm ents coincides w ith the direction of the largest refractive index. M ore details on the $m$ ethod can be found in our previous publication [1]O-1].

In our setup designed for the null ellipsom etry $m$ easurem ents we used a low power HeNe laser ( $=632: 8 \mathrm{~nm}$ ), two G lanThom pson polarizers $m$ ounted on rotational stages from O rielC orp ., a quarter wave plate from Edm und Scienti c and a sam ple holder $m$ ounted on the rotational stage. The light intensity was m easured with a photodiode. T he setup was autom atically controlled by a personal com puter. The rotation accuracy of the analyzer was better than 02 degree.

## D . A bsorption m ethod

The UV/V is absonption m easurem ents were carried out using a diode array spectrom eter (O ceanO ptics). The sam ples were set norm ally to the testing beam of a deuterium lamp. A $G$ lan-T hom pson prism $m$ ounted on a com puter-driven stepper was used to control the polarization of the testing beam, $E_{t}$.

The UV spectra of both original and irradiated m s were m easured in the spectral range from 250 nm to 600 nm for the probing light linearly polarized along the $x$ and y axes. From these data the optical density com ponents $\mathrm{D}_{\mathrm{x}}$ and $\mathrm{D}_{\mathrm{y}}$ w ere estim ated at the absonption $m$ axim um of azochrom ophores, $t=375 \mathrm{~nm}$ (for polym er P1) and $t=$ 343 nm (for polym er P 2).

In general, it is di cult to estim ate the out-of-plane absonption coe cient D ${ }_{z}$. This, how ever, can be done in the regim e ofPOA where the fraction of cis isom ers is negligible (the photo-reorientation $m$ echanism ) by using them ethod proposed in Refs. $[\overline{0}, 1,1] \overline{6} \overline{-1}]$. The key point is that the sum of all the principal absonption coe cients, $\mathrm{D}_{\text {tot }}=\mathrm{D}_{\mathrm{x}}+\mathrm{D}_{\mathrm{y}}+\mathrm{D}_{\mathrm{z}}$, does not depend on irradiation doses. So, if the anisotropy is known to be uniaxial at time $t_{0} w$ th either $D_{x}\left(t_{0}\right)=D_{z}\left(t_{0}\right)$ or $D_{y}\left(t_{0}\right)=D_{z}\left(t_{0}\right)$, this will yield the relation

where $n_{0}$ is the optical axis and $e_{i}$ is the ith coordinate unit vector. T he out-ofplane com ponent $D_{z}$ can now be com puted from Eq. (II). In addition, we calculate the absonption order param eters $S_{i}^{(a)}$ de ned by the expression

In Sec. 'IVI'! we nd that in the regime of photo-reorientation the param eters $S_{i}^{(a)}$ are

proportional to the diagonal com ponents of the order param eter tensor of trans azochrom ophores.
III. EXPERIMENTALRESULTS
A. $N$ on-irradiated $\operatorname{lm} s$

Fig. ${ }_{-15}^{1}$ (a) show s the experim entally m easured curves of the phase shift versus incidence angle for the polym er P 1. T he curve 1 corresponds to the non-irradiated m . The curves $m$ easured for vertical and horizontal position of the $x$-axis overlap. This im plies that the in-plane principle indioes $\mathrm{n}_{\mathrm{x}}$ and $\mathrm{n}_{\mathrm{y}}$ are $m$ atched. The $m$, how ever, possess out-of-plane birefringence. The tting gives the value $\left(\begin{array}{ll}n_{z} & n_{x}\end{array}\right) d=20 \mathrm{~nm} . \mathrm{U}$ sing the value of the lm thickness $\mathrm{d}=200 \mathrm{~nm}$, we have $n_{z} \quad n_{\mathrm{x}}=0: 1$ and the relation $\mathrm{n}_{\mathrm{x}}=\mathrm{n}_{\mathrm{y}}<\mathrm{n}_{\mathrm{z}}$ that suggests preferred in-plane alignm ent w th random orientation of azobenzene frag$m$ ents in the plane of the m . Optically, this structure corresponds to the negative C plate depicted in Fig. 'ī̀ (ā)'.

Fig. 保(b) shows the $m$ easured versus curves for the polym er P 2. The results obtained for the non-irradiated lm (curve 1) im ply that, sim ilar to the polym er P1, the in-plane birefringence is negligibly sm all

So, the m of the polym er P2 is a positive uniaxial medium with the optical axis nom al to the lm surface (positive C m show n in F ig. 'ī $\left.\overline{1}(\overline{0})_{1}^{( }\right)$'i $)$and the azobenzene fragm ents oriented hom eotropically.

B . Irradiation at ex $=365 \mathrm{~nm}$

1. Polym er P 1

The curves 2 and 2' in Fig. '151 (a) show the $m$ easured versus curves for the polym er P 1 after 60 m in of V light irradiation. Curves 2 and $2^{\prime}$ correspond to vertical and horizontalposition ofx-axis of the m . Since negative and positive phase shift at $=0$ cor-

The tted values of the in-plane, ( $n_{y}$ $\left.n_{x}\right)$ d, and out-of plane, $\left(\begin{array}{ll}n_{z} & n_{s}\end{array}\right)$ d, retardation for P 1 corresponding to various irradiation tim es ex are presented in Fig. 'बَ-1 (a). The in-plane birefringence increases and saturates as the irradiation time increases. W hereas the out-of-plane birefringence is a decreasing function of the irradiation tim e and the di erence betw een $n_{z}$ and $n_{x}$ becom es negligible in the saturation state. At early stages of irradiation all the refractive indiges are di erent

curves corresponding to the vertical and the horizontal positions of the x axis of the m overlap. The tting gives $\mathrm{n}_{\mathrm{x}}=\mathrm{n}_{\mathrm{y}}=\mathrm{n}_{\mathrm{z}}$ and, thus, the angular distribution of azobenzene chrom ophores is isotropic.

Fig. ${ }_{-1} \overline{1}_{1}(a)$ shows the tted values of $\left(n_{y}\right.$ saturate at large irradiation doses. At the $\left.n_{x}\right) d$ and $\left(n_{z} \quad n_{x}\right) d$, obtained for various initial irradiation stage $n_{z}>n_{y}>n_{x}$ and irradiation tim es of P2. The dependencies of $\left(n_{y} \quad n_{x}\right) d$ and $\left(n_{z} \quad n_{x}\right) d$ on the irradiation time go through the $m$ axim um and the m is biaxial. In the photosaturated state $\mathrm{n}_{\mathrm{x}}=\mathrm{n}_{\mathrm{y}}=\mathrm{n}_{\mathrm{z}}$ and, as is illustrated in Fig.' 1 ( $(\mathrm{d})$ ', the m is isotropic.

The experim entally $m$ easured $D_{x}\left(e_{x}\right)$ and $D_{y}($ ex $)$ curves are show $n$ in $F$ ig. ${ }_{1}^{2 i n}(b)$. B oth curves decrease w ith increasing the irradiation dose. This behavior is typical of the $m$ echanism of photoselection this regim e the exciting light w ill cause angular selective depopulating of the trans state, so that the fraction of trans isom ers rapidly grows sm aller with illum ination time. This process \{ the so-called angular selective buming $\{$ dom inates the kinetics ofP $O A$ and gives rise to dim inution of both absonption coe cients $D_{x}$ and $D_{y}$. The isotropy of the photosaturated state then can be explained by negligibly sm all concentrations of trans chrom ophores at large irradiation doses. This point will be discussed at greater length in Sec. 武立.

## C . Irradiation at ex $=488 \mathrm{~nm}$

## 1. Polym er P 1

In Fig.' radiation w ith ex $=488 \mathrm{~nm}$ ( ex $=300 \mathrm{~m}$ in) are denoted as 3 and $3^{\prime}$. Sim ilar to the case where ex $=365 \mathrm{~nm}$, the relation between the principal refractive indioes is $\mathrm{n}_{\mathrm{y}}>\mathrm{n}_{\mathrm{x}}=\mathrm{n}_{\mathrm{z}}$. So, the induced orientational con gurations do not di er and correspond to a uniaxial inplane alignm ent w ith the optical properties of a positive A plate. From the other hand, the value of in plane retardation ( $n_{y} \quad n_{x}$ )d is considerably higher than it is for ex $=365 \mathrm{~nm}$ and reaches 60 .

The ( $n_{y} \quad n_{x}$ )d and ( $\left.n_{Y} \quad n_{x}\right) d$ versus ex kinetic curves for the lm and irradiation conditions under consideration are presented in Fig. 'isín (a). The results are qualitatively sim ilar to those obtained for ex $=$ 365 nm : biaxial alignm ent of the azobenzene chrom ophores at the early stages of irradiation and the uniaxial structure in the photosaturated state. The $\mathrm{D}_{\mathrm{x}}(\mathrm{ex})$ and $\mathrm{D}_{\mathrm{y}}(\mathrm{ex})$ curves presented in $F$ ig. 'ig (b) indicate inplane angular redistribution of the azobenzene chrom ophores and the preferentialalign-
$m$ ent along the direction penpendicular to E . In addition, we used Eq. ([i]) to com pute the curve for the out-of-plane com ponent $D_{z}($ ex $)$
 dencies of the absonption order param eters on the irradiation tim e calculated from Eq. (2, $)$.

## 2. Polym er P 2

The curves 3 and 3' in Fig.' ${ }^{5}$ $m$ easured versus dependencies for the m of P 2 irradiated w ith the actinic light at ex $=488 \mathrm{~nm}$ over 300 m in. As above, the curves corresponding to the vertical and the horizontal position of the x axis are labelled 3 and $3^{\prime}$, respectively. The tting yields $\left(\begin{array}{lll}n_{y} & n_{x}\end{array}\right) d=\left(\begin{array}{ll}n_{z} & n_{x}\end{array}\right) d=60 \mathrm{~nm}$ and $n_{y}=n_{z}>n_{x}$. So, the induced orientational structure is uniaxial. The optical axis of this structure lies in the $1 m$ plane and is directed along the polarization vector of the actinic light. The principal refractive index for the optical axis direction has the lowest value. T he sam e optical properties possess crystal plate called as negative
 case of azopolym er lm stands for random orientation of azochrom ophores in the plane perpendicular to vector E . This is precisely the structure which can be expected from the na ve symmetry considerations discussed in Sec. I.

The tting results, ( $n_{y} \quad n_{x}$ )d and ( $n_{y}$ $n_{x}$ )d, plotted as functions of irradiation time ex are presented in Fig. ' $19-1(a)$. The curves converge approaching the saturated state. The transient photoinduced structures are biaxial.

The $D_{x}(e x)$ and $D_{y}(e x)$ curves for the case under investigation are show $n$ in Fig. 'I ${ }_{-1}(\mathrm{~b})$. By contrast to the case presented in Fig. $\bar{i}_{1}(\mathrm{~b})$, these curves clearly indicate that the regim e ofPOA is dom inated by the photo-reorientation $m$ echanism tī the out-ofplane coe cient $D_{z}$ can be esti$m$ ated by applying the procedure described in Sec. 'IIID'. to the case in which the known

A fter the rst step of UV irradiation P2
Im was optically isotropic. But sim ilar to the case of one step irradiation at ex $=$ 488 nm , the subsequent irradiation have generated the anisotropy of a negative $A \quad \mathrm{~m}$. The corresponding ( $\left.\begin{array}{lll}n_{y} & n_{x}\end{array}\right) d$ and $\left(\begin{array}{ll}n_{y} & n_{x}\end{array}\right) d$ versus ex kinetic curves are presented in Fig. iilon. It is seen that pre-irradiation w ith UV light strongly accelerate form ation of the saturated structure as com pared to the case of one step irradiation (see Fig. $\overline{9}$ (a)). But
for both P1 and P 2 m s this structure in itself is not a ected by pre-irradiation. Thus, the structure is com pletely determ ined by the last step of irradiation.
E. Therm al stability of the photoinduced structures

At room tem perature, we have not detected any changes in ordering of nonirradiated m s for several weeks. The photoinduced uniaxial and biaxial anisotropies, form ed in polym er $\mathrm{m} s$ after sw itching 0 the exciting light, persisted over the sam e period of time.

W e have also studied the in uence of the elevated tem peratures on the orientational
structures．T he baking of the non－irradiated P1 lm s at tem peratures of $m$ esophases and isotropic phase did not change considerably the in itialorder．In contrast，P 2 m shad the out－ofplane alignm ent of azobenzene chro－ m ophores enhanced after the treatm ent at tem peratures ofboth nem aticm esophase and isotropic phase．For instanc，baking of P 2
m at $150^{\circ} \mathrm{C}$ over 5 m in led to the increase in birefringence from（ $n_{e} \quad n_{b}$ ）d $=35 \mathrm{~nm}$ to $\left(n_{e} \quad n_{0}\right) d=55 \mathrm{~nm}$ ．

The curing of P1 m s at the tem pera－ tures of nem atic and sm ectic $m$ esophases fol－ lowed by cooling down to room tem perature destroys biaxiality of the photoinduced struc－ tures and enhances the uniaxial anisotropy． Sim ilar e ects were observed at the short time（about 5 m in）curing in the isotropic state at $70^{\circ} \mathrm{C}$ ．In this case the prolonged cur－ ing caused the disappearance of the induced anisotropy．

The curing of P2 m s at tem peratures of nem atic and isotropic phases transform ed the structure of negative uniaxial $m$ edium into the positive uniaxial con guration $w$ th azochrom ophores aligned perpendicular to the m substrate．

## F．Photochem ical param eters

T here are a num ber of param eters used in subsequent calculations for theoretical inter－ pretation of the experim ental results．In this subsection we dw ellbrie $y$ on the experim en－ tal results used to estim ate the lifetim e of the cis form， c ，and the absonption cross sections of isom ers，（cis）and（tr）．

## 1．Lifetim e of cis isom ers

The lifetime c of cis isomers was es－ tim ated by studying the relaxation of UV spectrum modi ed by irradiation $w$ th non－ polarized light at ex $=365 \mathrm{~nm}$ ．The pum p－ ing and testing light were directed alm ost norm ally to the m ．The wavelength of
non－polarized testing light was adjusted at the $m$ axim um of absonption band of the studied polym er（ 375 nm and 343 nm for polym ers P 1 and P 2，respectively）．

Tem poral evolution of the absorbance af－ ter switching $o$ the pum ping was m easured． $T$ he curves then were tted by using the tw o－ exponential approxim ation taken in the fol－ low ing form

In the case of polym er P 1 relaxation is dom inated by the fast com ponent that cor－ responds to the largest am plitude and can be attributed to cis－trans backw ard isom er－ ization of the chrom ophores trapped in a
 now be estim ated as a decay tim efor the bulk of cis isom ers to yield c $1: 2 \mathrm{~s}$ ．

The origin of slower and less pronounced com ponent could be caused by therm al cis－ trans isom erization of the other fraction of azobenzene $m$ oieties，which are strongly re－ stricted in their $m$ olecular dynam ics by the polym er $m$ atrix．Their reaction requires a stronger reorganization of the polym er m $\overline{\mathrm{B}} \overline{\mathrm{Z}} \overline{1}]$ ．Since the waiting tim e in our ex－ perim ents was about 15 m in，we can safely assum e all cis isom ers in polym er P 1 relaxed back to the trans isom eric form ．

For polym er P2 the largest contribution com es from the slow est com ponent $w$ th $2=$ 440 m in．This tim e gives an estim ate for the lifetim e of cis isom ers，c 440 m in．

There is a di culty in estim ating c with this $m$ ethod．In addition to trans－cis photoi－ som erization，the UV spectrum can also be in uenced by photo－reorientation．The non－ polarized light $m$ ay cause out－ofplane reori－ entation of azobenzene chrom ophores reduc－ ing the UV absorption．This out－ofplane reorientation，how ever，cannot be e ective
in polymer P1 which shows strong preference to in-plane reorientation. For polym er P 2 the out-of-plane reorientation of azochrom ophores has been additionally checked by the absonption $m$ easurem ent at the oblique incidence oftesting beam. A $n$ increase in the polym er absonption at 343 nm under UV irradiation has not been detected. Thus it is safe to assum e that the observed relaxation can be solely attributed to cis-trans them al isom erization.

## 2. Absonption cross sections

The abovem entioned photo-induced reorientation accom panying photochem ical process $m$ akes it extrem ely di cult to estim ate the coe cients of the molecular extinction in polym er ms . For this purpose we applied the $m$ ethod well know $n$ for polym er solutions $\left[\frac{3}{3} 9-1\right.$. Both polym ens were dissolved in toluene at concentration $510^{3} \mathrm{~g} / \mathrm{l}$. The $\mathrm{UV} / \mathrm{V}$ is spectra of the polym er solutionsw ere $m$ easured before and during irradiation. In the latter case the solutions were in the photo-saturated state. Each spectrum was decom posed into three com ponents of $G$ aussian shape denoted as $D_{c}^{(\mathrm{i})}(), D_{t}^{(\mathrm{i})}()$ and $D_{n}^{(i)}()$ in the expression

where the index i labels the spectra of the non-irradiated ( $i=0$ ) and the irradiated solution ( $i=1$ ). The rst two term $s$ on the right hand side of Eq. ( $\overline{-}, \mathbf{i}), D_{c}^{(i)}()$ and $D_{t}^{(i)}()$, can be assigned to absorption of cis and trans isom ers, respectively. The last term, $D_{n}^{(i)}()$, corresponds to $n$ absonption where the contributions from cis and trans isom ers cannot be separated.

We can now relate the com ponents $D_{t}^{(i)}$ and $D{ }_{c}^{(i)}$ to the absonption cross sections of isom ers, ${ }^{\text {(cis) }}$ and ${ }^{(t r)}$, and the concentrations of isom ers, $\mathrm{C}_{\mathrm{tr}}^{(\mathrm{i})}$ and $\mathrm{C}_{\mathrm{cis}}^{(\mathrm{i})}$, in the nonirradiated $\mathrm{m} \quad(\mathrm{i}=0)$ and in the photo-

IV. MODEL

Theoretical considerations of this section deal with the kinetics of POA that determ ines how am ount of photoinduced anisotropy characterized by either absonption didroism or birefringence evolyes in time upon illum ination and after sw itching it 0 . Below we brie y discuss the simple phenom enological model describing the kinetics ofPOA in term $s$ of the order param eter tensor and the concentrations of azochro$m$ ophores. ( $M$ ore details on the $m$ odel and the underlying phenom enological approach


We shall assume that the azobenzene groups in the ground state are of trans form (trans molecules) and the orientation of the molecular axis is de ned by the unit vector $\hat{\mathrm{A}}=(\sin \cos , \sin \sin , \infty)$, where

$0: 5$ and 1. This w ould lead to physically absurd results and the parabolic approxim ation severely breaks dow $n$.

In order to restore the correct behavior, we need either to m odify the approxim ation ( $2 \overline{5} \overline{1}_{1}$ ) or to dealw th a system of coupled equations for high order harm onics. T he latter involves truncating the expansion for the distribution function $f_{t r}$ at su ciently large j. But us ing this approach to treat the case of order param eters $S_{i}$ close to the end points would require large scale com putations com plicated by the convergence and stability problem s.

In this paper we shall use an altemative procedure by assum ing that the angular distribution ofm esogenic groups in azopolym ers can be taken in the form ofdistribution functions used in the variationalm ean eld theo-

In polym er P 1 the part of the correlation functions responsible for out-of-plane reorientation is appeared to be suppressed by polym eric environm ent. A s in Ref. V. NUMERICALRESULTS

In this section we em ploy our m odel to interpret the experim ental data of the UV absonption $m$ easurem ents for di erent irradiation doses. The principal absonption coe cients $D_{i}$ can be related to the concentrations and the order param eters as follow s

The theoretical curves are com puted by solving the kinetic equations of them odeldiscussed in the previous section. In itial values of the order param eters $S(0)$ and $S(0)$ are taken from the experim ental data $m$ easured at ex $=488 \mathrm{~nm}$. Since the system is initially at the equilibrium state, the rem aining part of the initialconditions is: $S_{p}(0)=S(0)$, $S_{p}(0)=S(0), n_{\text {tr }}(0)=1$ and $\mathrm{n}_{\mathrm{cis}}(0)=0$.

A nisotropy of non-irradiated $\mathrm{m} s$ is uniaxial for both polym ers: $S_{z}^{(a)}(0)=0: 18<$ $S_{x}^{(a)}(0)=S_{y}^{(a)}(0)=0: 09$ (polym er P 1) and $S_{z}^{(a)}(0)=0: 07>S_{x}^{(a)}(0)=S_{y}^{(a)}(0)=0: 035$ (polym er P 2). From the other hand, reaching the photosteady state orientationalstructure of the polym ers is characterized by di erent uniaxial anisotropies: $\mathrm{S}_{\mathrm{x}}^{(\text {st) }}=\mathrm{S}_{\mathrm{z}}{ }^{\text {(st) }}<\mathrm{S}_{\mathrm{y}}{ }^{\text {(st) }}$ (polym er P 1) and $\mathrm{S}_{\mathrm{x}}^{(\text {st) }}<\mathrm{S}_{\mathrm{y}}^{(\text {st) }}=\mathrm{S}_{\mathrm{z}}^{(\mathrm{st})}$ (poly$m$ er P 2). So, as is shown in Figs. ${ }_{1}^{1}\left\{\begin{array}{l}1 \\ \hline 19\end{array}\right.$ the transient anisotropic structures are inevitably biaxial. These biaxial e ects are related to the di erence between the initial anisotropy of polym er $\mathrm{m} s$ and the anisotropy of the photo-saturated state.

N um erical calculations in the presence of irradiation were followed by com puting the stationary values of $S$ and $S$ to which the orderparam eters decay after.sw itching o the irradiation at tim eto. For the polym erP 2 the lifetim e of the cis fragm ents $w$ as found to be much longer than the periods exam ined and we can safely neglect $c$. There is no further relaxation after reaching this stationary state and its anisotropy is long term stable. The lifetim e of cis form $s$ in polym er P 1 is $c_{c}=1.2 \mathrm{~s}$ and the kinetic equations need to be solved num erically. This, how ever, does not a ect the conclusion about the long term stability of P OA.

A ccording to Ref. [1] $\overline{-1} 4]$, the relaxation tim e characterizing decay of $D_{i}(t)$ to its stationary value after sw itching $o$ the irradiation in polym er P1 can be estim ated at about $t=15 \mathrm{~m}$ in. The experim ental estim ate for polym er $P 2$ is $t=30 \mathrm{~min}$. The theoretical value of this relaxation tim e, deduced from solution of the kinetic equations in the $a b-$ sence of irradiation, is $t \quad 1=(p+t r)$. So, in the sim plest case, we can assum e both relaxation tim es, $p(p=1=p)$ and $\operatorname{tr}(t r=$ $\left.1={ }_{\mathrm{tr}}\right)$, to be equal 30 m in ( P 1 ) and 60 m in (P2) . Table $\ddagger$ show $s$ the estim ates for the $a b-$
sonption cross section of cis m olecules (cis) and the average absorption cross section of trans fragm ents, $\quad(\mathrm{tr})=\left(\begin{array}{c}(\mathrm{tr}) \\ \mathrm{j})\end{array} 2_{\text {? }}^{(\mathrm{tr})} \mathrm{f}\right)=3, \mathrm{ob}-$ tained from the UV spectra of the polym ers dissolved in toluene.

For these polymers the absonption anisotropy param eters and the quantum e ciencies are unknown and need to be tted. W e used the value of $S_{\text {st }}$ as an adjustable param eter, so that the anisotropy param eters $u$ and $u^{(a)}$ can be derived from Eq. ( $\overline{3} \overline{4} \overline{4})$ and from the experim ental value of the absorption order param eter $\mathrm{S}_{\mathrm{st}}^{(a)} \mathrm{m}$ easured at ex $=488 \mathrm{~nm}$ in the photosteady state.

T he num erical results presented in F igs.i't${ }_{1}^{19}$ are com puted at $u^{(a)}=13: 0$ and $q_{t t}=2: 9$ (polym er P 1); $u^{(a)}=11: 0$ and $q_{f t}=2: 15$ (polym er P 2). T he quantum e ciencies are listed in Table it and are of the sam e order of $m$ agnitude as the experim ental values for other azobenzene com pounds [4̄51]

In order to characterize the regim e of POA, we can use the fraction ofcis fragm ents in the photo-stationary state. From Eq. (ī్̄) this fraction is given by

At sm all values of r Eq. ( $\left.\overline{3} \overline{3}_{1}^{\prime}\right)$ w ill yield the fraction $\mathrm{n}_{\mathrm{cis}}^{(\mathrm{st})}$ that is close to the unity and we have the kinetics of O A in the regim e of photoselection. In the opposite case of su ciently large values of $r$ the photosteady fraction of cis m olecules $w$ ill be very $s m$ all that is typical of the photo-reorientation m echanism.

W hen, as in polym er P 1, cis isom ers are short-living, so that the rate of them al relaxation $c$ is relatively large, the values of
the param eter $r$ listed in Table if are large at both w avelengths of the exciting light. In this case the fractions of cis isom ers in the photosaturated state com puted from Eqs. ( $\overline{3} \overline{3} \overline{1})$ )( $\overline{3} \overline{4} 4)$ are negligibly sm all: $\mathrm{n}_{\text {cis }}^{(\text {st) }} 0: 003$ at ex $=365 \mathrm{~nm}$ and $\mathrm{n}_{\text {cis }}^{\text {(st) }} \quad 0: 002$ at ex $=$ 488 nm . So, we have the kinetics of POA in the regim e of photo-reorientation. It is ilustrated in Figs. ' ${ }_{-1}^{1}$ (b) and ${ }_{-1}^{1 /-1}$ (b), where the $m$ easured and the calculated curves are in good agreem ent and correspond to the photoreorientation $m$ echanism.

In polym er P 2 cis isom ers are long-living w th negligibly sm all relaxation rate c . The param eter $r$ is now the ratio of the rates $q_{L} I$ and $q_{ \pm} I$ that characterize cis ! trans and trans ! cis stimulated transitions, correspondingly. This ratio is determ ined by the quantum e ciencies, tr! cis and cis! tr, and the absonption cross sections, ? ${ }^{(t r)}$ and cis. In this case we can have both $m$ echanism $s$ depending on the wavelength of excitation.

F ig.' ${ }^{\prime}$ - presents the case in which the w avelength of light is far from the absonption m axin um, ex $=488 \mathrm{~nm}$. It seen that, sim ilar to polym er P1, the kinetics of the absorption coe cients, presented in Fig. \$(b), is typical for photo-reorientation $m$ echanism . A ccording to Tabl l can use Eqs. $(\overline{3} \overline{3} \overline{-1})-\left(\frac{3}{3} \overline{4}\right)$ to estim ate the fraction $n_{\text {cis }}^{(\text {st) }}$ at about $0: 02$. It $m$ eans that in this case the cis! trans transitions stim ulated by the exciting light will e ciently deplete the cis state and the absonption coe cients are controlled by the term s proportional to the order param eter of trans m olecules (see Eq. ( $\overline{3} 2 \overline{2})$ ).

By contrast, F ig. $\mathrm{I}_{1}(\mathrm{~b})$ show s that the experim ental dependencies forboth $D_{x}$ and $D_{y}$ are decreasing functions of the irradiation time at the wavelength, ex $=365 \mathrm{~nm}$, near the maxim um of absorption band. It indicates that the kinetics of POA is govemed by the $m$ echanism of photoselection. In this case we have $r=0: 03$ and $n_{\text {cis }}^{\text {(st) }}=0: 98$. The $m$ ethod described in Sec. 'ĪĪD.' is now inapplicable, so the out-of-plane absonption $00-$
e cient $D_{z}$ and the order param eters $S_{i}^{(a)}$ can only be estim ated theoretically. These curves calculated from our $m$ odel are show $n$

VI. D ISCUSSION AND CONCLUSIO N S

In Sec.ī̄'l we have introduced the param eter $r$ that can be w ritten as the ratio of the characteristic tim e oftrans-cis isom erization, ex $=1=(q I)$, to the tim e characterizing decay of the cis state in the presence of irradiation, $\sim_{c}=1=\left(c+q_{c} I\right) \cdot W$ e have also show $n$ that depending on the value of this param eter the kinetics ofPOA is govemed by either photoselection or photo-reorientation $m$ echanism s.

For large values of $r, r \quad 1$, we have $\sim_{c}$ ex, so that the lifetime of cis iso$m$ ers under irradiation $\sim_{c}$ is short and the iso$m$ ers are short-living. In this case the photoreorientation m echanism is found to dom inate the kinetics of POA. The opposite case of $s m$ all values of $r$ characterizes the regim $e$ ofphotoselection, where $\sim_{c}$ ex and cis isom ers are long-living in the presence of irradiation.

It should be stressed that the $m$ echanism of photoselection cannot occur in polym ers w th high rate of therm al cis-trans isom erization $c$, where the time of trans-cis iso$m$ erization ex is longer than the lifetim e of cis isom ers ${ }_{c}=1={ }_{c}>\sim_{c}$. In our study this case is represented by polym er P1 in which the $m$ echanism of photo-reorientation dom inates at both wavelengths of excitation.

In polym er P2 c is very sm all and the relaxation time $\sim_{c}$ is determ ined by the rate of cis-trans photoisom erization $q_{c} I$. W hen the wavelength of the exciting light is in $n$ absorption band of azochrom ophores, this rate is higher than the rate of trans-cis isom erization, $q_{\mathbb{L}}$ I. So, at ex $=488 \mathrm{~nm}$ the photoreorientation $m$ echanism dom inates in both polym ers.

By contrast to $n$ absonption band,
absorption bands of isom ers are well separated. The wavelength ex $=365 \mathrm{~nm}$ lies w thin absonption band of trans chrom ophores, so that the rate $\mathrm{q}_{2} \mathrm{I}$ is low as compared to qI. Forpolym erP 2 thism eans that there is nothing to prevent the cis state from being populated under the action of UV light and the kinetics ofPOA is now govemed by the $m$ echanism of photoselection.

The photochem ical properties of azopoly$m$ ers are determ ined in large part by the m olecular structure of azochrom ophores, which inconporates the azobenzene core and substitutes. For instance, su ciently polarized azochrom ophores (push-pull chrom ophores) usually have short-living cis iso$m$ ers. On the other hand, the chrom ophores containing long alkyl substitutes are characterized by long-living cis form. O ur results show that the polym ers under consideration com ply w ith these rules.

In addition, the m olecular structure of azopolym ers determ ines self-organization of azochrom ophores, which in tum a ects 3D orientational ordering. By self-organization is meant a number of complex processes related to the spontaneous alignm ent and aggregation of anisotropic azobenzene chrom ophores, processes of collective orientation, self-assembling at the interfaces etc. The initial anisotropy of non-irradiated polym er
m s is de ned by these processes. W e found that the azochrom ophores in P1 1 m s prefer in-plane orientation, whereas the preferential alignm ent of the fragm ents in P 2 lm is hom eotropic. The factors responsible for this di erence have not been studied in any detail yet.

The intrinsic self-organization of azochrom ophores also plays a part in the ordering stim ulated by actinic light [15]. The excitation of azochrom ophores stim ulates these processes of self-organization that are slow ed down in the glassy state. The contribution of self-organization processes may explain di erent anisotropies observed in poly$m$ ers P1 and P2 on reaching the state of
photo-saturation. The positive in-plane order, observed in polym er P1, is determ ined by the strong preference of azochrom ophores to in-plane alignm ent.

The negative in-plane order induced in polym er P 2 by the light w ith ex $=488 \mathrm{~nm}$ $m$ ay be explained by assum ing the dom inating role of the photo-reorientation $m$ echanism. Generally, we know from experience that the negative uniaxial anisotropy $w$ ith the optical axis parallel to the polarization vector of the exciting light can be easily induced in polym ers show ing preference to out-of-plane alignm ent of azochrom ophores.

The photosaturated state of polym er P 2 m s irradiated at ex $=365 \mathrm{~nm}$ is found to be optically isotropic w th $\mathrm{n}_{\mathrm{x}}=\mathrm{n}_{\mathrm{y}}=\mathrm{n}_{\mathrm{z}}$. As we have already noted in Sec. extrem ely low concentration of trans chromophores will render the m e ectively isotropic. This is the case even if the angular distribution of trans isom ers retains an am ount of anisotropy caused by the angular selective character of the buming process. From the other hand, non-m esogenic cis isom ers at high concentrations could result in disordering e ects up to suppressing LC properties of azopolym ers [4] G$]$. From our optical $m$ easurem ents we cannot unam biguously conclude on signi cance of these e ects for polym er P 2.

Thus, in the regim e ofphoto-reorientation the orientational structures observed in the photo-saturation state are uniaxial w ith optical axes determ ined by the polarization of the light and by the favored orientation of the azochrom ophores. In the case of photoselection these structures are optically isotropic. The anisotropic structures induced at early stages of irradiation are biaxial. These transient structures are form ed in passing from the initial uniaxial structure to the state of photo-saturation.

Self-organization of azochrom ophores under irradiation im plies their collective orientation and liquid crystallinity. T he other collective $m$ ode is related to the orientation of
non-photosensitive fragm ents ( $m$ atrix) that is in uenced by the orientation of azochro-
 latter factor seem s to be of crucial im portance in stabilizing the photoinduced order.

In our experim ents the photoinduced anisotropy has been seen to be stable over at least several weeks. T he anisotropy can be erased and rew rilten by the light. This long term stability of the induced order im plies e ective orientation of polym er $m$ atrix in both photo-reorientation and photoselection regim es of POA.

In order to interpret the experim ental results on the kinetics of the photoinduced absorption dichroism we em ployed the theoretical model form ulated by using the phenom enological approach of Refs . $[1]$ $T$ his approach describes the kinetics of POA in term $s$ of one-particle angular distribution functions and angular redistribution probabilities. T he probabilities enter the photoiso$m$ erization rates and de ne coupling betw een the azochrom ophores and the anisotropic eld represented by the distribution function of the polym er $m$ atrix $f_{p}$. This anisotropic eld re ects the presence of long-living angular correlations and stabilizes the photoinduced anisotropy.

The key assum ption of the $m$ odel is that the cis fragm ents are isotropic and do not a ect the ordering kinetics directly. Certainly, this is the sim plest case to start from before studying $m$ ore com plicated models. So, we studied the predictions of this sim ple m odel for both polym ers to test its applicability. To this end we have estim ated a num ber of photochem ical param eters that enter the $m$ odel from the experim ental data. Only the absonption anisotropy param eters and the quantum yields need to be adjusted. The com parison between the num erical results and the experim ental data show s that the model correctly captures the basic features of POA in azopolym ers.

W e have additionally calculated the out-of-plane absorbance $D_{z}$ and the absonption
order param eters $S_{i}^{(a)}$ in the photoselection regim ew here the experim entalm ethod ofestim ation is inapplicable. T he m odel has also been applied to estim ate concentrations of isom ers, quantum yields of photoisom erization and anisotropy of $m$ olecular absonption. It provides a criterion for the occurrence of di erent $m$ echanism $s$ and describes the biaxiality e ects.

So, we have dem onstrated that the phenom enological approach of $\left[\begin{array}{ll}{[10} \\ \hline 1 & 1 \\ 13 & 1 \\ 1\end{array}\right]$ can be used as a useful tool for studying photoinduced ordering processes in azopolym ers. But it should be noted that theoretical approaches of this sort, by de nition, do not involve explicit considerations ofm icroscopic details of azopolym er physics. A m ore com prehensive study is required to relate the effective param eters of our m odel and physicalparam eters characterizing interactions between molecular units of polym ers. For exam ple, the initialanisotropy of polym er lm s is taken into account through the initial conditions for the kinetic equations and the theory then properly describes the biaxiality effects. B ut the process of structure form ation in non-irradiated polym er $\mathrm{m} s$ is well beyond the scope of them odeland such description cannot serve as an explanation of biaxiality. Sim ilarly, the suppressed out-of-plane reorientation of azochrom ophores in polym er P 1 is treated as a constraint im posed by the polym eric environm ent and is taken into consideration by m odifying the order param eter correlation functions.

O ur results show that neglecting the inuence of cis isom ers on the orientational order of the anisotropic trans isom ens does not lead to considerable discrepancies between the theoretical results and the experim ental data. In general, the presence of non-m esogenic cis isom ers could give rise to deterioration of the photoinduced order of trans fragm ents. In the regim e of photoselection this e ect will eventually produce nearly isotropic angular distribution of trans isom ers. O $n$ the other hand, our m odel pre-
dicts that in polym er P 2 this distribution is alw ays anisotropic w ith non-vanishing order param eters of trans fragm ents. (In this case the order param eters are not proportional to $S_{i}^{(a)}$ depicted in $F$ ig. ${ }_{1}^{1 \overline{7}}$ (c) that go to zero due to depletion of the trans state.) Though the m odel is successful in describing our experi$m$ ents, it can be modi ed to study the case in which the disordering e ect caused by cis isom ers cannot be disregarded.
