## A new mechanism of hypersensitive transport in tilted sharp ratchets induced by noise atness

The noise-atness-induced hypersensitive transport of overdam ped B rownian particles in a tilted ratchet system driven by multiplicative nonequilibrium three-level M arkovian noise and additive white noise is considered. At low temperatures the enhancement of current is very sensitive to the applied sm all static tilting force. It is established that the enhancement of m obility depends non-monotonically on the parameters (atness, correlation time) of multiplicative noise. The optimal values of noise parameters maximizing the mobility are found.

Recently, noise-induced hypersensitivity to sm all tim edependent signals in nonlinear system s with multiplicative noise has been the topic of a number of physical investigations [1 {4]. A motivation in this eld has come from num erical, analytical, and experim ental studies of a nonlinear K ram ers oscillator with multiplicative white noise [1,4]. Under the e ect of intense multiplicative noise, the system is able to amplify an ultrasmall determ inistic ac signal (of the order of, e.g., 10  $^{20}$  ) up to the value of the order of unity [1]. A flerwards, a related phenom enon such as noise-induced hypersensitive transport was found in some other systems with multiplicative dichotom ous noise [2,3]. Noise-induced hypersensitive transport was also established in a phase model, ie., d' = dt = a bsin', with a strong symmetric multiplicative colored noise. It was shown that in such a system a macroscopic ux (current) of matter appears under the e ect of ultrasm all dc driving [2]. It is im portant to notice that the physical mechanism underlying the phenom enon of hypersensitive transport presented in Refs. [2,3] is based on the assumption that the periodic potential is smooth. It is easy to see that in the case of a periodic sharp potential the above mechanism cannot bring forth any hypersensitive transport.

Theoretical investigations [5[9] indicate that noiseinduced nonequilibrium e ects are sensitive to noise atness, which is de ned as the ratio of the fourth m om ent to the square of the second m om ent of the noise process. A lthough its signi cance is obvious, the role of the

atness of uctuations has not been researched to any signi cant degree to-date. In the present paper we assume the multiplicative noise to be a zero-mean trichotomous Markovian stochastic process [10]. It is remarkable that for trichotomous noises the atness parameter ', contrary to the cases of the Gaussian colored noise (' = 3) and symmetric dichotomous noise (' = 1), can have any value from 1 to 1. The atness as an extra degree of freedom (in comparison with dichotomous noise) can prove useful when modelling actual uctuations, e.g., therm al transitions between three con gurations or states. This is the reason why we choose in the phase space of possible non-equilibrium models the

trichotom ous noise. A lthough both dichotom ous and trichotom ous processes may be too rough approxim ations of the actual non-equilibrium uctuations, the latter is more exible, including all cases of dichotom ous processes and, as such, revealing the essence of its peculiarities. A further virtue of the models with trichotom ous noise is that they constitute a case adm itting exact analytical solutions for som e nonlinear stochastic problem s, such as colored-noise-induced transitions [10] and reversals of noise-induced ow [9].

The main purpose of this paper is to establish a new mechanism of hypersensitive transport, demonstrating that the atness of multiplicative noise can generate hypersensitive response to the small external static force in a tilted sharp ratchet system. We will show that in the region of hypersensitive response the value of mobility can be controlled by means of therm al noise. For low tem peratures, we nd that the mobility exhibits resonant behavior at interm ediate values of the param eters of the multiplicative noise ( atness, correlation tim e).

W e consider an overdam ped multinoise tilted ratchet, where particles move in a one-dimensional spatially periodic potential of the form V (x;t) = V (x)Z (t), where Z (t) is a trichotom ous process [10] and V (x) is a piecewise linear function, which has one maximum perperiod. The additional force consists of therm al noise with tem perature D, and an external static force F. The system is described by the dimensionless Langevin equation

where V (x) =  $\nabla$  (x)= $\nabla_0$ ;  $\nabla$  (x) is a spatially periodic function with period  $\Gamma$  and  $\nabla_0 = \nabla_{m ax}$   $\nabla_{m in}$ . The usual dimensionalized physical variables are indicated by tildes and the space and time coordinates read X = X =  $\Gamma$ and t =  $t\nabla_0 = \Gamma^2$  with being the friction coe cient;  $F' = \nabla_0 F = \Gamma$  is a constant external force. The thermal noise satis esh (t)i = 0 and h (t) (t\_2)i = 2D (t\_1 t). Regarding the random function Z (t), we assume it to be a zero-mean trichotom ous M arkovian stochastic process [10] which consists of jumps among three values z = f1;0; 1g. The jumps follow in time according to a Poisson process, while the values occur with the stationary probabilities  $P_s(1) = P_s(1) = q$  and  $P_s(0) = 1$  2q. In a stationary state, the uctuation process statis es hZ (t)i = 0 and hZ (t + )Z (t)i = 2qexp(), where the switching rate is the reciprocal of the noise correlation time  $_c = 1 =$ . The trichotom ous process is a special case of the kangaroo process [5] with a atness parameter  $' = hZ^4$  (t)i=hZ (t)i<sup>2</sup> = 1=(2q). At large atnesses our trichotom ous noise essentially coincides with the threelevel noise used by B ier [6] and E lston and D cering [7].

The master equation corresponding to Eq. (1) reads

where  $n = z_n h(x) + F$  D Q and P (x;t) is the probability density for the combined process  $(x;z_n;t)$ ,  $n;m = 1;2;3; z_1 = 1; z_2 = 0; z_3 =$ 1, and  $U_{ik} = [q + (1 \quad 3q)_{i2} \quad i_k]$ . The stationary current  $J = \int_{n} j_{n}(x)$  is then evaluated via the current densities  $j_n(x) = (z_n h(x) + F \quad D(Q_x)P_n^s(x)$ , where  $P_n^s(x)$  is the stationary probability density in the state  $(x;z_n)$ . To calculate the stationary probability density in the x space, P (x) =  $\begin{bmatrix} & & \\ & n \end{bmatrix} P_n^{s}(x)$ , and the stationary current, J = const, six conditions are imposed on the solutions of Eq. (2), namely, the conditions of periodicity  $P_n^s(x) = P_n^s(x + 1)$ ; n = 1;2;3; and norm alization of  $P_n^{s}(x)$  over the period interval L = 1 of the ratchet potential  $Z_{p}(t)V(x)$ , which read  $\prod_{0}^{K_{1}} P_{1}^{s}(x) dx = \prod_{0}^{K_{1}} P_{3}^{s}(x) dx = q$ and  $\begin{bmatrix} R_1 \\ 0 \end{bmatrix} P_2^s (x) dx = 1$ 2q.




FIG.1. The mechanism of hypersensitive transport. The lines depict the net potentials  $V_n(x) = z_n V(x)$  Fx with  $z_1 = 1, z_2 = 0$ , and  $z_3 = 1$ . A particle cannot move of its own accord along the potentials  $V_1$  and  $V_3$ . However, if one allows switching between the potentials  $V_n$ , n = 1;2;3, the particle will move downhill along the trajectory 12:3:4:6.

To derive an exact form ula for J, we assume that the potential Z (t)V (x) = Z (t)V (x 1) in Eq. (1) is piecewise linear (saw tooth like) and its asymmetry is determ ined by a parameter d 2 (0;1), with V (x) being symmetric when d = 1=2. A schematic representation of the three con gurations assumed by the "net potentials"  $V_n(x) = z_n V(x)$  F x associated with the right hand side of Eq. (1) is shown in Fig. 1. Regarding the symmetry of the dynamic system (1), we notice that J(F) = J(F)and J(F;d) = J(F;1 d). Thus we may con neourselves to the case d 1=2 and F 0. Obviously, for F = 0, the system is e ectively isotropic and no current can occur. In the case of zero tem perature the both noise levels  $z_{n=1;3} =$ 1 in Eq. (1), where F  $m \inf 1=d; 1=(1 d)g,$ give zero ux. However, if one allows switching between the three dynamic laws  $V_n(x)$ , n = 1;2;3; the resulting motion will have a net ux which can be much greater that the ux by the dynamic law  $V_2 = F x$ . If the rate of reaching the minim alenergy in each well considerably exceeds the switching rate , the leading part of the net ux is achieved in the following way: a particle locked in the potential m in im um 1 sw itches to point 2, then slow ly moves to point 3, switches to point 4 (or to 5 with equal probability), and rapidly slides down to point 6 (or from 5 back to 1), etc (see Fig. 1 and cfRef.

[11]). In this case hypersensitive transport is possible and can be intuitively understood. The described scheme is valid only in the absence of therm allocise. O therw ise, a particle is able to pass by a therm ally activated escape across the potential barriers in both directions. However, it predom inantly moves to the right and hypersensitive transport still occurs (at least at su ciently low tem – peratures). As the "force" h(x) = dV(x)=dx is piecewisely constant,  $h(x) = h_1 = 1=d$  for  $x \ 2 \ (0;d) \ (m \ odl)$ , and  $h(x) = h_2 = 1=(1 \ d)$  for  $x \ 2 \ (d;1) \ (m \ odl)$ , Eq. (2) splits up into two linear di erential equations with constant coe cients for the two vector functions  $P_i^s(x) = (P_{1i}^s; P_{2i}^s; P_{3i}^s) \ (i = 1;2)$  de ned on the intervals (0;d) and (d;1), respectively. The solution reads

where C<sub>ik</sub> are constants of integration, the constants A<sub>n</sub> and A<sub>nik</sub> are given by A<sub>1</sub> = A<sub>3</sub> = qJ=F, A<sub>2</sub> = (1 2q)J=F, A<sub>nik</sub> = (D<sub>ik</sub> F)  $D_{ik}^2$  (F  $zh_i$ ) ik ] for n = 1;3, A<sub>2ik</sub> =  $2h_i^2$  ik (A<sub>1ik</sub> + A<sub>3ik</sub>), and f ik; k = 1;:::;5g is the set of roots of the algebraic equation




FIG.2. The current J vs applied force F in the region of the hypersensitive response. The atness parameter equals ' = 2.5 and the switching rate = 8. Solid straight line: D = 0, d = 0.5. Dotted line: D = 4 10<sup>8</sup>, d = 0.5. Dashed line: D = 4 10<sup>8</sup>, d = 0.2. Solid curved line: D = 4 10<sup>8</sup>, d = 0.05. The led dots on the solid straight line are obtained by m eans of M onte C arlo simulations. Notice the jump of the current from the zero level to the solid line corresponding to the in nite derivative of J (F) at F = 0.




FIG. 3. The mobility m = J=F vs the atness parameter q = 1=(2') at d = 1=2,  $D = 4 \ 10^8$ , and  $F = 10^5$ . The curves computed from the exact formula for the current J correspond to the values of = 8=3, = 1, = 8, = 0:1, = 100 from top to bottom. The non-monotonic sequence of the values of stems from the bell-shaped dependence J = J(). Note that the maximum of the mobility lies at q = 1=6 and = 8=3. The dots were computed by means of the asymptotic formula (7).

E leven conditions for the ten constants of integration of Eq. (3) and for the probability current J can be determined at the points of discontinuity, by requiring continuity, periodicity, and normalization of  $P_i^s(x)$ . This procedure leads to an inhom ogeneous set of eleven linear algebraic equations. Now, an exact formula for the current J can be obtained as a quotient of two determinants of the eleventh degree. The exact formula, being complex and cumbersome, will not be presented here,

however, it will be used to nd (i) the dependence of the current J on the tilting force F and the dependence of the mobility m = J=F on the atness ' = 1=(2q), which are displayed in Figs. 2 and 3, respectively, and (ii) the asymptotic limits of the current J at low temperature and sm all external force.

Figure 2 shows the induced current J as a function of the external force F for two di erent values of tem perature and for three di erent values of d with xed ' = 2.5 and = 8. In this gure, one also observes the hypersensitive response at very low forcing, which apparently gets m ore and m ore pronounced as the therm alnoise strength D decreases. For the case D = 0;d = 0.5, the results of M onte C arlo simulations of the current J = J (F) are also presented. The tendency apparent in Fig.2, namely a decrease in the mobility for very low forcing as the asym m etry of the potential grow s, is also valid for large asym m etries, e.g., when d < 0.05.

To obtain more insight, we shall now study some asymptotic limits of the current.

At the fast-noise limit, we allow to become large, holding all the other parameters xed. Thus, at very high frequencies of colored uctuations, the system is under the in uence of the average uctuating potential. In the

! 1 lim it, the current is then given by

The form of the leading term of the current J is not con ned to the fast-noise limit. It is also valid for the asymptotic limit of a high temperature, D >> 1, and in the case of a large "load" force F (F ! 1, all the other parameters xed).

At the long-correlation-time lim it ! 0, the equations (2) for  $P_1^s(x)$ ;  $P_2^s(x)$ , and  $P_3^s(x)$  are decoupled and the total current is given by the average of each current for the corresponding potential congurations. In the case of the symmetric potential, d = 1=2, the current J saturates at the value

For F < 2, we can see that the current J tends to  $(1 \quad 2q)F$  as D ! 0. This result is consistent with the physical intuition that the probability densities  $P_1^{s}(x)$  and  $P_3^{s}(x)$  are -distributed at determ inistic stationary states (m inim um s of potentials): the random variable Z takes values 1 for a su ciently long time to allow the determ inistic stationary state to be form ed.

In the case of zero tem perature, D = 0, and symmetric potential, d = 1=2, one nds from the exact formula that on the assumption F < 2 the current equals

Thus, at the low -force  $\lim_{t \to \infty} it$ , F ! 0, the current will saturate at the nite value

As J(F = 0) = 0, the hypersensitive response is extrem ely pronounced in this case, with the current picking up with an in nite derivative at F = 0 (see also Fig. 2). The asymptotic current  $J_a$  exhibits a bell-shaped (resonance) form as or q are varied. The optim alcorrelation time m that maximizes the current equals 1=8, and the optim al atness  $m = 1 = (2q_n) = 2$ . It is remarkable that in the case of a dichotom ous noise q = 1=2, the hypersensitive response disappears and in the low forcing limit the leading-order term of the current is proportional to  $F : J = F(+12)=(+8)^2$ .

At the low forcing lim it, F 1, a natural way to investigate the behaviour of J is to apply small F perturbation expansions. A stationary solution of Eqs. (3) and (4) with  $D \in 0$ , d = 1=2 is constructed in terms of integer powers of F. The current can be expressed as  $J = Fm_1 + F^2m_2 + \dots$  W e shall calculate the leading term of the current Fm<sub>1</sub>. Notably, the analysis of this section is valid for the values of param eters satisfying the condition  $F < (2q D)^{1=2}$ . This condition results from the assumption that the higher-order terms in the expansion of the roots of Eq. (4) are asymptotically smaller than the lower-order terms held in the calculation. At su ciently small tem perature, D m inf1;2q ;8q= q, the formula for the leading-order term  $Fm_1$  of the current is

Here the symbol G stands for the terms which do not increase as D ! 0. An extrem e sensitivity of the mobility m to therm almoise can be seen from the factor D <sup>1=2</sup> in Eq. (7) that increases unboundedly as D ! 0. It can be seen easily that the functional dependence of the mobility on the atness ' and on the correlation time <sub>c</sub> is of a bell-shaped form. The mobility m<sub>1</sub> reaches a maximum at the atness '<sub>m</sub> = 3 and at the correlation time <sub>m</sub> = 3=8. The dependence of the mobility m = J=F on the parameters q and for a xed force value F =  $10^5$  and for a xed temperature D = 4  $10^8$  is shown in Fig. 3. We can see that the exact results.

Let us note that the su cient condition,  $F < \frac{P}{2q D}$ , has a distinct physical meaning: the characteristic distance of therm ald i usion D = is larger than the typicaldistance F = for the particle driven by the determ inistic force F in the state z = 0 of the trichotom ous noise. Let us look at the latter statem ent m ore closely on the assum ption that 1. For this assumption within the interval (0;1), the probability distributions  $P_n^s(x)$ , n = 1;3, are, evidently, concentrated at x = 0 (or x = 1=2). Next, we shall consider the trajectory (1:2:3:4:6) in Fig. 1. The particles locked at the potential minimum 1 (x = d = 1=2) will go at the initial time t = 0 to point 2, where z = 0. The rst time when the noise turns to either z = 1 or z = 1 is denoted by  $t_0$ . As the time of movement from 4 to 6 is much less than  $t_0$ , it is easy to nd that during the time interval (0;t) the center of m ass has shifted by

In the case of a trichotom ous noise the probability W (t) that in a certain time interval (0;t) the transitions z = 0! z = 1 do not occur, is given by W (t) = exp( 2q t). The probability that the transition z=0! z= 1 occurs within the time interval (t;t + dt) is q dt. Consequently,

Considering that the average number of transitions per unit of time into the state z = 0 is 2q (1 2q), we obtain  $J = 2q (1 2q)h4 \times i F (1 2q) 2q = 8^{D} D$ . Thus, we have obtained an earlier result, namely, Eq. (7) for

1. Form ula (7) is one of our main results. Note that the above procedure can be repeated in a straightforward but tedious way for more complicated cases involving asymmetric potentials and potentials with several extrem a perperiod. The phenomen is robust enough to survive a modi cation of the multiplicative noise. The key-factor is the noise atness, indicating how long the noise level dwells on the state z = 0. If the atness parameter is greater than 1, the elect does exist. For example, the multiplicative noise can also be a G aussian stationary process.

It is quite remarkable that the above results are also applicable for amplifying adiabatic time-dependent signals, i.e., signals of much greater periods than the characteristic time of establishing a stationary distribution, even in the case of a small input signal-to-noise ratio F = D 1.

W e em phasize that our mechanism of hypersensitive transport is of a qualitatively di erent nature from a recently found e ect, where a noise-induced enhancement of the current of Brownian particles in a tilted ratchet system has also been established [2,3]. In the latter scenario, a system with a periodic sm ooth potential exhibits hypersensitivity under the e ect of multiplicative dichotom ous noise because of noise-induced escape through xed points of the dynamics. This occurs because the stable and unstable xed points of the alternative dynamics, which coincide in the absence of the tilt F, are shifted apart by a sm all force (see also R ef. [11]). In the mechanism reported here, we have a sharp periodic potential: the stable and unstable xed points of the dynam ics coincide also for any sm all tilt. The crossing of the location of the xed points is achieved by a combined in uence of the atness of the multiplicative noise and a sm all tilt-forcing.

In a general case, if the potential is smooth and the atness of multiplicative noise is greater than 1, both mechanisms splay an important role and should be taken into account. Our calculations show that the factor F = D in Eq. (7) is generated by thermaldi usion in the state z = 0, while the circum stance that the potential is sharp has no e ect on this factor. On the other hand, for adiabatic switching, the mechanism described in Ref. [2] generates the current J F = D. Consequently, our

mechanism for su ciently small switching rates induces hypersensitive transport more e ectively than the one proposed by G inzburg and Pustovoit. This conclusion is in agreement with the results of Ref. [2], presenting numerical simulations of the phenomenon of hypersensitive transport based on a phase model with the multiplicative colored G aussian noise (' = 3). It is established that in the case of low switching rates the transport for the G aussian noise appears to be more e ective than for dichotom ous stimuli. Regrettably, the authors of Ref. [2] did not consider the role of noise atness and the physics of this discrepancy.

In conclusion, the reported mechanism of generating hypersensitive transport by the atness of multiplicative noise is of general relevance form any physical, biological, and chem ical systems, and may provide another possibility to control signal amplication. The sensitivity of system response to small input signals can be either enhanced or suppressed by changing the noise parameters ( atness, correlation time, temperature). In agreement with Ref. [L2], we believe that the phenomenon proposed may also shed some light on the ability of biological systems to detect weak signals in a noisy environment.
