# A far-from -equilibrium uctuation-dissipation relation for an Ising-G lauber-like m odel

A bstract. We derive an exact expression of the response function to an in nites in al magnetic eld for an Ising-G lauber-like model with arbitrary exchange couplings. The result is expressed in terms of therm odynam ic averages and does not depend on the initial conditions or on the dimension of the space. The response function is related to time-derivatives of a complicated correlation function and so the expression is a generalisation of the equilibrium uctuation-dissipation theorem in the special case of this model. Correspondence with the Ising-G lauber model is discussed. A discrete-time version of the relation is implemented in M onte C arb simulations and then used to study the aging regime of the ferrom agnetic two-dimensional Ising-G lauber model quenched from the param agnetic phase to the ferrom agnetic one. Our approach has the originality to give direct access to the response function and the uctuation-dissipation ratio.

#### 1. Introduction

The knowledge about out-of-equilibrium processes is far from being as advanced as for systems at therm odynamical equilibrium. In particular, the uctuation-dissipation theorem (FDT) which holds at equilibrium is known to be violated out-of-equilibrium. This theorem states that at equilibrium the response function  $R^{eq}$  (t s) at time t to an in nitesimal eld applied to the system at time s < t is related to the time-derivative of the two-time autocorrelation function  $C^{eq}$  (t s):

In the Ising case, the response function reads  $R_{ji}(t;s) = \frac{h_j(t)i}{h_i(s)}$  and the correlation function  $C_{ji}(t;s) = h_j(t)_i(s)i$ . Based on a mean-eld study of spin-glasses, Cugliandolo et al. [1] have conjectured that for asymptotically large times the FDT can be generalised by adding a multiplicative factor X (t;s) which moreover depends on time only through the correlation function:

The quantity  $^{e}$  (t;s) = X (C (t;s)) is interpreted as an elective inverse temperature. Exact results have been obtained for the ferrom agnetic Ising chain [2, 3] that con in this conjecture. Unfortunately, the response function is rarely so easily accessible for more complex systems. Both numerically and experimentally, only the integrated response function is usually measured by applying a nite magnetic eld to the system during a nite time. In the so-called TRM scheme, the magnetic eld is applied between the times 0 and s and the magnetisation is measured at time t. Assuming the equation (2) valid for any times t and s, one can relate the integrated response function to the uctuation-dissipation (FD) ratio:

The FD ratio X (t;s) can thus be obtained as the slope of the integrated response function (t;s) when plotted versus the correlation function C (t;s). This method has been applied to the numerical study of many system s: 2d and 3d-Ising ferrom agnets [4], 3d Edwards-Anderson model [5, 4], 3d and 4d-G aussian Ising spin-glasses [6], 2d Ising ferrom agnet with dipolar interactions [7], Heisenberg anti-ferrom agnet on the K agom e lattice [8] ::: The conjecture (2) has also recently been checked experimentally for a spin-glass [9]. More details may be found in the reviews [10, 11]. However, the integrated response function depends linearly on the FD ratio only if the conjecture (2) holds, which has not been demonstrated for any of the previously cited system s. W e will see in the case of the hom ogeneous Ising model that this approach may lead to misinterpretations and erroneous values of X (t;s). The generalisation of the equilibrium FD T has recently becom e an increasingly popular issue. Let us mention two of them : an approximate generalisation of the FD T to metastable system s [12] (limited to dynamics having a transition rate W with only one negative eigenvalue) that has been successfully com pared to num erical data for the 2D -Ising m odel and a generalisation of the FDT for trap m odels [13].

In the present work, we study the dynam ics of an Ising-G lauber-like model. In the section 1, we describe the model and its dynamics which are studied analytically in the section 2. The response function to an in nitesimal magnetic eld is exactly calculated far-from -equilibrium. It turns out that the response function is no more related to a time-derivative of the spin-spin correlation function but to time-derivatives of a more complicated correlation function. The equilibrium limit is shown to have the usual form. In the section 3, a discrete time version of this expression is implemented in Monte Carlo simulations. Our approach presents several advantages: (i) we can compute directly the response function and not only the integrated response function, (ii) we obtain the response function to an in nitesimal magnetic eld so that we avoid non-linear e ects due to the use of a nite magnetic eld, (iii) the FD ratio can be computed without resorting to Cugliandolo conjecture (2) and (iv) we can calculate the response function R (t; s) and the FD ratio X (t; s) for any time t and s < t during one single M onte C arb simulation. W e perform ed M onte C arb simulations of the twodim ensional hom ogeneous Ising m odel quenched at and below the critical tem perature T<sub>c</sub>. In both cases, the expected scaling behaviour of the response function in the aging regime is well reproduced by the numerical data. The value of the exponent a, still controversial, is estimated and the FD ratio is computed. Our estimate of  $X_1$  at  $T_c$ turns out to be compatible with previous work and the scaling behaviour of X (t;s) below T<sub>c</sub> is well reproduced. In both cases, the FD ratio depend on time not only through the correlation function.

#### 2.0 ur Ising-G lauber-like m odel

#### 2.1. U seful relations on M arkov processes

We consider a classical Ising model whose degrees of freedom are N scalar variables i = 1 located at the nodes of a d-dimensional lattice. Let us denote by } (f g;t) the probability to observe the system in the state f g at time t. We rst de ne a discrete-time M arkov chain by the master equation

where W (f g ! f  ${}^{0}g$ ;t) is the transition rate per unit time from the state f g to the state f  ${}^{0}g$  at time t. The condition  ${}^{P}_{f {}^{0}g}W$  (f g ! f  ${}^{0}g$ ;t) = 1 ensures the norm ation of the probability } (f g;t) at any time t. The system is not forced to make a transition at each time step, i.e. the transition rate may have non-zero diagonal elements W (f g ! f g;t). In the continuous-time limit t ! 0, the master equation (4) goes to

M oreover, one can work out a master equation for the times. It reads

This last equation might be obtained simply by using for example the identity  $\frac{\theta}{\theta s}$  } (f g;t) = 0.

W hen the transition rates do not depend on time, the conditional probability f(g;t)f(g;s) is a function of t(s,s). This can be shown easily by introducing the matrix notation f(g;t)f(g;s) = hf(g)f(t;s) f(g). The master equation (8) reads then:

where the initial condition  $f^{00}(g;s) = \int_{f^{00}(g;s)} e^{-g} has been used. This dependence$ only on t s, even far-from -equilibrium, will be used latter in the calculation of theresponse function.

#### 2.2. The model and its dynam ics

The Ising model is defined by its equilibrium probability distribution  $e_{eq}$  (f g) which reads with general exchange couplings:

where ferrom agnetic couplings correspond to  $J_{k1} > 0$ . The condition of stationarity  $\frac{\theta}{\theta t}_{eq}$  (f g) = 0 leads according to the master equation (5) to a constrain on the transition rates:

This last unnecessary but su cient condition is fulled by the heat-bath single-spin ip dynamics de ned by the following transition rates:

In this last expression, only the single-spin ip  $_{k}$  !  $_{k}^{0}$  is allowed. The product of K ronecker deltas ensures that all other spins are not modi ed during the transition. A fter the transition, the spin  $_{k}$  takes the new value  $_{k}^{0}$  chosen according to the equilibrium probability distribution  $}_{eq}$  (f g). In the case of the Ising chain, the transition rates (16) are equivalent to G lauber's ones [14]. We will use a slightly di erent dynam ics consisting in a sequential update of spins. Let us choose a sequence of lattice sites f (t) 2 f1;:::N g;8t = n t;n 2 Ng and let us de ne the transition rates in discrete time as

In comparison to G lauber dynamics, only the spin-ip involving the spin  $_{(t)}$  is possible at time t. In the continuous-time limit, the two dynamics are equivalent up to a rescaling of time t ! t=N (found for example in the de nition of a M onte C arb step). Indeed, when iterating N times the master equation (4), one obtains

and the G lauber dynamics is recovered if  $f(t + n t)g_{n=0:::N-1}$  is any circular permutation of the set of lattice sites f1;:::N g. The equivalence of the two dynamics may not hold in the thermodynamic limit N ! + 1. The time-dependence of the transition rates (18) breaks the time-translation invariance of the conditional probabilities. However, the elective transition rate in equation (19) is time-independent and thus the time-translation invariance is restored in the continuous-time limit if f(t)g is periodic of period N t. Again, this may be no more true in the thermodynamic limit. In the following, we will assume that f(t)g satis es the two above-presented conditions, i.e. being periodic of period N t and that any N consecutive values are a circular permutation of f1;:::N g.

#### 3. Fluctuation-dissipation relation

#### 3.1. Far-from -equilibrium uctuation-dissipation relation

A magnetic eld  $h_i$  is coupled to the spin  $_i$  between the times s and s + t. During this interval of time, the transition rates are changed to

in order to take into account the additional Zeem an term  $h_{i\ i}$  in the Ham iltonian of the equilibrium probability distribution (13). The transition rates are all identical to the case  $h_i = 0$  apart from the single-spin ip W  $_i^h$  involving the spin  $_i$ .

W<sup>h</sup><sub>i</sub> being the only quantity depending on the magnetic eld in equation (21), only remains the second term when (s) = i after derivating with respect to the magnetic "eld. The derivative leads then to

This quantity is the magnetisation on site j at time t when an in nitesimal magnetic eld is applied to the site i between s and s + t, i.e. an integrated response function that we will denote \_\_\_\_\_i (t; [s; s + t]). The derivative of the transition rate W  $_{i}^{h}$  de ned by equation (20) is easily taken and reads

It turns out to involve the transition rate of the zero- eld dynam ics (17). Due to this property, the integrated response function can be expressed in terms of therm odynam ic averages of the zero- eld dynam ics. Inserting (23) into (22), the integrated response function is rewritten as

where  $\sum_{i}^{W} e^{iss}(s) = \tanh \sum_{k \in i}^{P} J_{ik \ k}(s)$  is the equilibrium value of the spin  $_{i}$  in the W eiss eld created by all other spins at time s. Relation (30) generalises equation (1). The response function  $R_{ji}(t;s)$  turns out to be related to time-derivatives of the correlation function of the spin  $_{j}$  at time t with the uctuations of the spin  $_{i}$  at time s around the equilibrium average  $\sum_{i}^{W} e^{iss}(s)$  of this spin in its W eiss eld. In this sense, this relation is still a uctuation-dissipation relation but valid far-from -equilibrium . No assumption has been made on the dimension of the space or on the set of exchange couplings  $J_{k1}$  during the calculation. Moreover, it applies for any initial conditions } (f g; 0). The appearance of the prefactor  $1 + \frac{\theta}{\theta s} + \frac{\theta}{\theta t}$  is not related to the equilibrium

probability distribution of the model but comes from the Markovian properties of the dynamics. Generalised response functions are easily calculated along the same lines than equation (30). The second-order term for example reads

These relations are moreover easily extended to other models. The relations (30) to (32) hold for the O (n) or the q-state Potts for example where  $_i$  (s) has to be replaced by the local order parameter at time s on the site i and  $_i^{W eiss}$  (s) by its average value in the W eiss edd. Since equations (30) to (32) involve a constraint on the sequence of spin- ips, their generalisation to the Ising-G lauber model is not trivial. However, they will be of great interest for M onte C arlo simulations.

#### 3.2. Equilibrium limit

W e will show in this section that the usual expression of the FDT (1) is recovered in the equilibrium limit. At equilibrium, the probability distribution  $}_{eq}$  (f g) does not depend on time. As a consequence, the integrated response function can be written according to equation (26) as

The hyperbolic tangent can be expressed in terms of the transition ratio of the zero-eld dynamics (17):

Inserting in equation (33), the integrated response function reads h = v

The rst term can be expressed as a therm odynam ic average while in the second, one needs to get rid rst of the transition rate. The K ronecker delta constrains the only possible spin- ip to involve site i at time s. As a consequence,  $W_i$  (f<sup>00</sup>g! f<sup>0</sup>g) can be replaced by  $W_{(s)}$  (f<sup>00</sup>g! f<sup>00</sup>g! f<sup>00</sup>g) and the master equation (9) can be applied to equation (35). M oreover, one can show that

where the last m ember is simply equation (30) at equilibrium. One recovers the usual equilibrium uctuation-dissipation relation up to a K ronecker delta due the fact that the response function is non-zero only for times at which a spin- ip involving the spin connected to the magnetic eld occurs.

#### 4. M onte Carlo simulations of the 2d-Ising m odel

The discrete-time analogous of expression (30) of the response function enables to study the aging displayed by the Ising-G lauber model more accurately than in previous works that were based on the numerical estimate of the integrated response function. In the

rst part of this section, the algorithm is given. In the second part, simulations of the G lauber dynamics of the two-dimensional Ising model during a quench from the param agnetic phase to the ferrom agnetic one are presented. The system is expected to display aging, associated with the existence of growing domains corresponding to competing ferrom agnetic states [15]. Reversible processes occur in the bulk of domains while domain wall rearrangements are irreversible. We will distinguish between quenches at the critical temperature  $T_c$  and below. In both cases, lattice sizes 128 128,256 256

and 362 362 were simulated and the data averaged over 3000, 10000 and 5000 initial con gurations respectively. For all data, error bars were estimated as the standard deviation around the average value.

#### 4.1. D iscrete response function

During a M onte C arb simulation, the time is a discrete variable and the time step is set to t = 1. M onte C arb simulations in plement indeed the M arkov process de ned by the master equation (4) with the choice t = 1. Since simulations are always made on nite systems, dynamics with sequential and parallel updates are equivalent in the large-time limit up to a time-renormalisation corresponding to the de nition of a M onte C arb Step (M C S). The response function can only be de ned for continuous time processes. However, the integrated response function during one spin- ip  $_{i}$ !  $_{i}^{0}$ is the best estimator for the response function R<sub>ij</sub>(t;s) that we can de ne. Inserting t = 1 into equation (25), the estimator of the response function is simply


where  $\sum_{i}^{W \text{ eiss}}(s) = \tanh \sum_{k \in i}^{P} J_{ik} \sum_{k}^{0} (s)$ . In the following, we will be interested only on response functions of the form  $R_{ii}(t;s)$ . In order to reduce statistical uctuations, we have then estimated the response function R(t;s) as the average over all spin- ips during one MCS:

The calculation of this quantity is quite simple. Let evolve the simulation until time s. For each of the N next spin- ips  $_{i}$ !  $_{i}^{0}$ , store the quantity  $_{i}^{0}$   $_{i}^{W eiss}$ . Note that  $_{i}^{0}$  m ay be equal to  $_{i}$  m eaning that the system has not changed during this time step. However, in strict application of equation (40), one has nevertheless to store  $_{i}$   $_{i}^{W eiss}$ . A fter N spin- ips, let the system evolve again until time t. Calculate the response function for each site i by multiplying the quantity  $_{i}^{0}$   $_{i}^{W eiss}$  stored by the new value of the spin  $_{i}$  and add all these one-site response functions. Repeat the simulation can be easily calculated by numerical integration of the response function.

The time-derivative of the correlation function  $\frac{e}{e_s}C_{ji}$  (t; s) at times can be estimated by h<sub>j</sub>(t) <sub>i</sub>(s + 1) <sub>i</sub>(s) i. Again, this quantity is averaged over all spin-ips during one MCS. The FD ratio (2) can be estimated as

## 4.2. Quench at the critical tem perature

D using a quench at the critical tem perature  $T_c$ , the asymptotic decay of the correlation function has been conjectured to be [16, 17]


$$C (t;s) = s^{a}C_{c}(t=s)$$
(43)

where  $a_c = \frac{2}{z_c}$  and  $C_c(x)$  is a scaling function that asymptotically behaves as  $C_c(x)_{x=1}$ x  $c^{z=z_c}$ . c is the critical autocorrelation exponent [18] and  $z_c$  the dynamical exponent. Similarly, the asymptotic behaviour of the response function is

$$R(t;s) = s^{1} R_{c}(t=s)$$
(44)

where the scaling function  $R_c(x)$  behaves asymptotically as  $R_c(x) \underset{x = 1}{x = 1} x^{-z_c}$  too. By integrating over s, one obtains a relation similar to (44) for the integrated response function that has been checked by large-scale M onte C arb simulations [19]. However, the relation (44) is asymptotic so is not expected to hold for the response function R (t; s) with sm all values of s that are them ain contribution to the integrated response function. A sa consequence, it is dicult to test the asymptotic behaviour of the response function in this way. O ur approach permits us to avoid these problems and to test directly the relation (44).

The numerical data are plotted in gure 1. For the largest lattice size (L = 362) and the smallest value of s (s = 10), errors bars are at most 6 % of the value of the response function while for the largest (s = 320), they increase up to 12 %. Indeed, in the last case, the response function is of order of 1=N  $_{con g}$  and so can not be sampled accurately. Nevertheless, a fairly good collapse of the data is observed indicating that

 $R_{c}$  (t=s) =  $s^{1+a_{c}}R$  (t;s) is indeed a scaling function (actually we have used (t s)=s instead of t=s but this has no consequence on the asymptotic behaviour).

W e computed the FD ratio X (t;s) using the estim ator previously derived and whose expression is given by equation (42). The error bars are quite large. The num erical data are plotted in gure 2 for the largest lattice size (L = 362). In contradistinction to Cugliandolo conjecture (2), the inset of gure 2 shows that the FD ratio does not depend on time only through the correlation function. However, it seems that it may be the case in the lim it C (t;s) ! 0. On the other hand, it seems that the FD ratio depends on time only through t=s and reach a plateau for large enough values of t that we may estimate roughly to be  $X_1$  ' 0:33(2). The same value is obtained for L = 256 and L = 362 excluding any possibility of nite-size e ects. The limit X  $_1$ has been conjectured to be universal [17] but incom patible values have been given by di erent groups:  $X_1 = 0.26(1)$  [20] and  $X_1 = 0.340(5)$  [21] by M onte C arb simulations and  $X_1$  ' 0.35 [22] for the O (1)-model in dimension d = 4 . Our estimate is compatible with the last two ones. The estimate  $X_1 = 0.26(1)$  has probably been measured for a too-short time t, far from the region where Cugliandolo conjecture (2) and thus equation (3) hold. This puts stress upon the danger of using equation (3) to compute the FD ratio.

## 4.3. Quench below the critical tem perature

The same analysis can be done below  $T_c$ . In this regime, The correlation function decays as [16, 17]

$$C (t;s) \underset{t;s=1}{\overset{M}{=} eq} C (t=s)$$





Figure 3. Response function of the 2D-Ising model during a quench at the temperatures  $T = J=0.6' \frac{3}{4}T_c$  (inset) and collapse of the scaling function for di erent values of s. The data were obtained for a lattice 256 256 and averaged over 10000 initial con gurations. Each curve is surrounded by a clouds of dots corresponding to the lower and upper bounds of the error bars.

where  $M_{eq}$  is the equilibrium magnetisation and C(x) a scaling function that asymptotically behaves as  $C(x) = x^{-z}$ . The autocorrelation exponent and the dynamical exponent z are expected to take values which are dimension those at  $T_c$ . The response function is expected to scale as [16, 17]

$$R(t;s) = s^{1} \Re(t=s)$$
(46)

where R (x) x <sup>=z</sup>. A controversy exists concerning the value of a that has been estim ated to be either 1=4 [23] or 1=2 [24, 25]. Our num erical data are presented in the gure 3. We studied lattice sizes only up to L = 256 but calculations were made for two temperatures: J=0:6 '  $\frac{3}{4}$ T<sub>c</sub> and J=0.9 ' T<sub>c</sub>=2. The error bars are much smaller than in the critical case for small values of s. The relative error is at most 2:6 % for s = 10 at  $\frac{3}{4}$ T<sub>c</sub> but increase faster with s: the relative error increases up to 11 % for s = 80. As a consequence, the study was limited to the values of s ranging from s = 10 to s = 80. The response function displays the expected scaling behaviour (46) with a = 1=2. However, the collapse is not perfect, especially for the smallest values of s but a very small variation of a does not in prove it signi cantly. The value a = 1=4 in particular in proves the collapse for the small values of s only. The response function has probably strong corrections to scaling. Note that corrections have already been taken into account for the study of the scaling behaviour of the integrated response function [19, 26].

Combining the relations (45) and (46), the FD ratio X (t;s) = R (t;s) =  $\frac{\theta}{\theta s}$ C (t;s) is predicted to vanish as s <sup>a</sup> below T<sub>c</sub>. Our num erical estimates for T = J=0:6 '  $\frac{3}{4}$ T<sub>c</sub> are plotted in gure 4. The statistical errors decrease with the tem perature so that the

data are less uctuating than at  $T_c$ . As expected, the FD ratio is equal to 1 for sm all values oft s, signalling that the main contribution to the response function is due to equilibrium processes. On the other hand, it vanishes in the limit t s 1 as s<sup>1=2</sup>. As shown in gure 4, the data for s<sup>1=2</sup>X (t; s) collapse for large values of t=s. M oreover, gure 4 shows unambiguously that the FD ratio does not depend on time only through the correlation function. This makes the relation (3) invalid. The study of the violation of the equilibrium FDT by the usual method relying on the equation (3) would have led to erroneous values of the FD ratio.

## 5. Conclusion

U sing a form alism similar to Kubo's one in the quantum case, we derive an exact expression of the response function of an Ising-G lauber-like model far-from equilibrium (equation (30)). At least for nite systems, the dynamics of our model is equivalent to the G lauber dynamics up to a time-renorm alisation t! t=N. The derivation is possible because the dynamics consists in a sequential update of the spins and the transition rate under a magnetic eld can be written as a product of the transition. The response function turns out to be related to time-derivatives of a correlation function involving the uctuations of the spin excited by the magnetic eld around its equilibrium average in its W eiss eld. In this sense, the expression is a generalisation of the equilibrium uctuation-dissipation. O ur expression is quite general: no assumption has been made during its derivation on the dimension of the space, the set of exchange couplings or the initial conditions. M oreover, it can be easily extended to other classical m odels. G eneralised and non-linear response functions can be obtained analogously. H ow ever,

the continuous-time expression (30) m ay not hold in the therm odynam ic limit. A nalytic results would be desirable. Unfortunately, the response function calculated for the Isingchain by G lauber itself in his original paper [14] does not help because the magnetic eld was coupled di erently to the system (by a multiplicative factor to make the calculation feasible while we coupled the eld by a modi cation of the transition rate corresponding to the addition of the Zeem an interaction in the equilibrium probability distribution). G eneralisation to the Ising-G lauber model is not trivial because equation (39) sets a constrain on the sequence of spin- ips. N evertheless, It is tem pting to imagine that like the equilibrium FDT (39), equations (30) to (32) hold for the Ising-G lauberm odel when suppressing this constrain on the sequence of spin- ips.

The expression (30) of the response function is then in plan ented in M onte C arlo simulations. Our approach gives access to the response function and the FD ratio directly. In particular, the FD ratio can be obtained without assuming the validity of the Cugliandob conjecture (2). We then study numerically the homogeneous two-dimensional Ising-G lauber model quenched from the paramagnetic phase to the ferrom agnetic one. Both the response function and the FD ratio display the expected scaling behaviour both at  $T_c$  and below  $T_c$ . The values, still controversial, of a and  $X_1$  are estimated to be equal to 1=2 and 0:33(2) respectively, in agreement with some previous works. The Cugliandob conjecture (2) does not hold for this model apart perhaps at  $T_c$  in the limit of vanishing correlation functions. This would explain discrepancies of previous estimates of  $X_1$  relying on Cugliandob conjecture. The above-presented numerical procedure may be extended to many di erent systems and would provided a unam biguous test of Cugliandob conjecture. We are currently studying the dynam ics of spin-glasses in this fram ework.
