#### Abstract

Theduality relation for thee ective conductivity e of 2D isotropicheterophase system $s$ is used for obtaining the exact results for e at arbitrary num ber of phases N : The exact values of e correspond to the xed points of the duality transform ations. The new exact results for e, generalizing the well-known exact values of e for $N=2 ; 3$; are found. It is show $n$ that for $N \quad 3$ there exist the whole hyperplanes in the space of phase concentrations, on which e takes constant values. These results are checked in the fram ew ork of various approxim ations for di erent random heterophase system s.

## 1. Introduction

The properties of the electrical transport of classical inhom ogeneous (random ly or regularly) heterophase system s , consisting of $\mathrm{N}(\mathbb{N} \quad$ 2) phases with di erent conductivities $i(i=1 ; 2 ;::: \%$ ) ; have a great signi cance for practioe. The $m$ ain problem in theory of the electrical transport in these system $s$ is a calculation of the e ective conductivity e at arbitrary conductivities and phase concentrations [1] D. Despite of seem ing sim plicity of this problem only a few exact results have been obtained so far and allof them for two-dim ensional
 quence of the well-known duality between potential and tangent (or divergent free) elds in two dim ensions. T his very im portant relation has been obtained rstly for isotropic tw o-phase system s , w here it can be represented in the form,

It allow sto nd the exact universal, rem arkably sim ple, form ula for e at equal phase concentrations $x_{1}=x_{2}=1=2$

A nalogous exact result for e; coinciding w ith (2), hasbeen obtained in $N=3$ case by D ykhne [13 are equal $x_{1}=x_{2}=x$ : These exact values of e tumed out to be very useful for various applications of the theory, especially the equation (2), which has

[^0]been im plem ented for checking of various approxim ate expressions for $e$ and

 it cannot give exact results for them (except isotropic system $s$ in $m$ agnetic eld [4] $\underline{[1}_{1}^{\prime}$ ).

In this letter, using a general duality relation, we will obtain exact results for e of 2D isotropic heterophase system Sw th arbitrary num ber N ofphases. $T$ hey generalize the above results for $\mathrm{N}=2$;3: In particular, it w ill be show n that for $\mathrm{N}>2$; contrary to the $\mathrm{N}=2$ case, there exist the whole hyperplanes in the space ofconcentrations, on which e takes constant values. T he obtained results are checked in the fram ew ork of various approxim ate schem es.

## 2. Sym m etry, duality and xed points

W e begin w ith a discussion of som e general properties of the e ective conductivity e of N -phase system $\mathrm{S} w$ ith the partial conductivities i 0 ( $i=$ $\left.\frac{1}{\mathrm{P}} ; 2 ;::: ; \mathrm{N}\right)$ and concentrations $\mathrm{x}_{\mathrm{i}}$; which satisfy the nom alization condition ${ }_{i=1}^{N} x_{i}=1$ : The ective conductivity $m$ ust be a sym $m$ etric function of pairs of argum ents ( $\mathrm{x}_{\mathrm{i}} ; i$ ) and a hom ogeneous (a degree 1) function of i : For this reason it is invariant under all perm utations

Here $z_{i}=i=s$; where $s$ is som e norm alizing conductivity. For our purposes it w illloe convenient to choose it in the sym $m$ etrical form $s=\left(s_{N}\right)^{1=N}$; where $S_{N}=\mathrm{Q}_{\mathrm{i}=1}^{\mathrm{N}} \mathrm{i}$ is the N th elem entary symm etrical function. $T$ hen

As a result the function $f$ is a symmetrical function of $N$ pairs ( $x_{i} ; z_{i}$ ); only N 1 of them are independent.

The e ective conductivity of N -phase system $\mathrm{s} m$ ust satisfy the follow ing naturalboundary conditions: 1) e of N -phase system with $\mathrm{n}(2 \mathrm{n} \mathrm{N}$ ) equalpartialconductivitiesm ust reduce to e ofsystem with N $\mathrm{n}+1$ phases and the concentrations of the phases $w$ ith equal conductivities $m$ ust add; 2) it has not depend on partial $i$ and $m$ ust reduce to the e ective conductivity of (N 1)-phase system, if the concentration of this phase $x_{i}=0 ; 3$ ) it must reduce to som epartial $i$, if $x_{i}=1$ :

A duality relation for e exists for any two-dim ensional $N$-phase system
 concentrations is

where 0 is som e arditrary constant conductivity, characterizing a duality transform ation.

It is usefiul to note that the relation (4) can be w riltten also in the other form

which means that e at the inverse values of the partial conductivities is equal to the inverse e. For this reason it can be nam ed also the inversion relation for e ective conductivity.

The m utually inverse values are related: their product is equal ${ }_{0}^{2}$ ( F ig.la). W e w ill use also, for brevity, the notations of the form fxg for allwhole sets of variables like $x_{i}(i=1 ;:: ; j N):$

An existence of the exact dually (or inversion) relation is very im portant property of two-dim ensional inhom ogeneous system s. It can be used for the obtaining of exact values of e ective conductivity. For this one needs to know the properties of the partial inversion transform ations

where $I$ is the identity operator. Each partial inversion transform ation acts only on the partial conductivity of the corresponding phase. Strictly speaking, the inversion transform ation is well de ned only for all i 60 ; but one can extrapolate it form ally on the case $i=0$ : In this case it transform $s$ a system $w$ ith $i=0$ (a dielectric phase) into a system $w$ ith $i=1$ (an idealconducting phase).

The transform ation $J_{0}^{(i)}$ has only one xed point $i=0: T$ he $i$ th and jth partial inversions, having the sam e param eter ${ }_{0}^{2}=$ i j (we denote them $J_{i j}^{(i)}$ and $J_{i j}^{(j)}$ respectively), are very im portant, because they change $i$ into j and vice versa

T he physical sense has only the product of all partial inversions w ith the sam e param eter 0

Giving to 0 di erent values, one can obtain various relations, connecting e at di erent values of its argum ents, which can serve for checking of solutions found by other $m$ ethods.

Since in our problem $J_{0}$ acts on a space of sym m etrical hom ogeneous functions it is useful to consider its action on the basic elem entary sym m etrical functions $S_{k}(f \quad g) \quad\left(f \quad g=\left(1 ;::: ; N_{1}\right)\right.$ )

Since $e$ is a hom ogeneous functions of degree 1, it will be convenient to pass (for $i \in 0$ ) to the pro jective variables $z_{i}$ and to introduce pro jective basic sym $m$ etrical functions $\mathrm{S}_{\mathrm{k}}$

W e use the generalduality relations $\left(4,4^{\prime}\right)$ for the obtaining an exact closed equation for $e$ at some special values of $i$ and $x_{i}$ : It follow from (4) that such equation can be obtained if one nds a transform ation $T(J ; P)$, consisting from inversions and perm utations, and a com bination ofargum ents ( $f x^{0} \mathrm{~g} ; \mathrm{f}^{0} \mathrm{~g}$ ), which is a xed point of $T$

Thus, $\left(15,15^{\prime}\right)$ give a general form of the exact values of $e$ in these xed points. The last equalities in (15) and (15') give a strong constraint on possible xed point values of ${ }_{i}$ :

In case of $N=2$ such xed point exists at arbitrary i ( $i=1$; 2 ); but only at the equalphase concentrations $\mathrm{x}_{1}=\mathrm{x}_{2}=1=2$, when the interchanging inversion $J_{12}$ is com pensated by the perm utation of the pairs of argum ents. It gives the known $K$ eller \{ $D$ ykhne result (2). The sim ilar xed point in case of $\mathrm{N}=3$ was found by D ykhne [ $[\underline{Z}]$ at equal phase concentrations ( $\mathrm{x}_{\mathrm{i}}=\mathrm{x}$ ( $\mathrm{i}=$ $1 ; 2)$ ) and the additional constraint on 3

which rem ains 3 unchanged under the duality transform ation. The corresponding exact value for e coincides $w$ ith (2) in accordance $w$ ith ( $\mathbf{1 5}^{\prime}$ ).

It $m$ eans that at these values of partial conductivities $e$ is xed and does not depend on $x$ ! N ote that this value of e ensures the right values in the lim its $\mathrm{x}!1=2$ and x ! 0; when they must be $\mathrm{P} \frac{12}{1}$ and 3 respectively.

Of course, one can choose the pairs w ith equal concentrations by various ways. For exam ple, if the phases 1 and 3 have the equal concentrations $x$ and ${ }_{0}^{2}=13={ }_{2}^{2}$; then one obtains

The corresponding lines of equal concentrations of di erent phases on the concentration phase diagram are shown on Fig.1b, where they coincide w ith the bisectrisses of the triangle (this triangle is a concentration space of $\mathrm{N}=3$ system $s$ due to the nom alization condition $\left.{ }_{1}^{3} x_{i}=1\right)$. Their unique intersection
point corresponds to the case of equal concentrations of all phases. It follow s from above results that under the conditions (16)-(18) e rem ains xed and does not change along the corresponding lines! It is worthw hile to note that now, contrary to the $N=2$ case, the exact value of $e$ at the point of equal phase concentrations $\mathrm{x}_{1}=\mathrm{x}_{2}=\mathrm{x}_{3}=1=3$ cannot be de ne from the duality relation in general case. It can be found only in the above xed points and its value depends on the choice of xed point. All these values are di erent. D ue to the additional constraints on $i$, the form of possible exact values of $e$ adm its also a value of the conductivity of the third phase. For this reason one can say that a structure of the xed points and a form of corresponding exact values are de ned by the involved interchanging inversion transform ations and the additional constraints.

## 3. G eneral N -phase case

W e show now that the duality relation (4) for N -phase system s adm its a generalization of these results on the N -phase system s .

Of course, for system s with $\mathrm{N}>3$; there are sim ilar xed points, when $x_{i}=x_{j}$ and allother $\quad(1 ; i ; j)$ are equalbetw een them selves. But this case is trivial, since it reduces to the 3 -phase case. Fortunately, the new possibilities appear for $\mathrm{N}>3$ :

Let us consider rstly a case when $N$ is even $N=2 M$ : $T$ hen a new xed point is possible, which corresponds to $M$ pairs of phases with equal concentrations and equal products of the corresponding conductivities. For example, the xed point

$N$ ote that the equal concentrations of the phase pairs $y_{a}(a=1 ;:: ; \mathrm{M})$ can be arbitrary, except the norm alizing condition ${ }_{a=1}^{M} 2 y_{a}=1$ : The exact value (20) does not depend on $Y_{a}$ and ensures again the correct values for $e$ in the lim its $y_{a}$ ! $0 ; 1(a=1 ;:: ; \mathrm{M})$ : Ofcourse, the sim ilar xed points exist for otherways of the partition of N phases into the pairsw ith equalconcentrations. A num ber of such points is equal \# ${ }_{2 \mathrm{M}}=\left(\begin{array}{ll}(2 \mathrm{M} & 1\end{array}\right)!!:$ The exact values of e in these points have alw ays the sam e general form

where possible pairs ij correspond to the phases with equal concentrations in the corresponding xed points.

N ow we consider a case when N is odd $\mathrm{N}=2 \mathrm{M}+1$ : In this case a new xed point is possible if the above conditions of the even case (19) are supplem ented by a condition on $2 M+1$ analogous to the $D$ ykhne condition for $N=3$ case

The corresponding e ective conductivity has again the exact value (20), coinciding $w$ ith the exact value of system $w$ ith $N=2 M . O$ fcourse, the other xed points related w ith various w ays of choice of the phase pairs $w$ ith equal concentrations are possible. Their num ber is equal to $\#_{(2 \mathrm{M}+1)}=(2 \mathrm{M}+1) \#_{2 \mathrm{M}}=$ $(2 M+1)$ !!: A general form of the exact values of e rem ains the same as in the even case w ith an additional equality

where the pairs ij correspond to the phases with equal concentrations and $k$ corresponds to the unpaired phases.

It follow s from $(21,23)$ that the exact values of $e$ at the point, where all phase concentrations are equal, are not uníversal.

O ne can show that only the xed points of type $(19,22)$ and their various Berm ytations are adm issible for all dual transform ations of the form $T(J ; P)=$
$J_{a} P_{b}$; where, for clarity, both products are assum ed to be nite, and the action of the product of inversions $J={ }_{Q} \quad J_{a} m$ ust be equalto (or com pensated by) the product of pem utations $\mathrm{P}=\mathrm{P}_{\mathrm{b}}$ (w e will not consider here possible, $m$ ore sophisticated, form s of $T$ ). $J=I$ : If (26) gives a perm utation of any pair $a_{i} \$ a_{k}$; (i\&k); than it follow $s$ from (26) that again $A_{2}=0$ : As is known any perm utation $P$ decom poses into product of independent chains of sim ple perm utations. Then, considering all possible chains sim ilar to the abovem entioned sim plest case of pair perm utation, one can see that equations (26) take place only when $A_{2}=0$ : In case of odd $\mathrm{L}=1$ equations (25) take the form

It follow s from (29) that this is possible only if $a_{1}=a_{2}=a_{3}=a ; A_{1}=2 a$; but this corresponds to the one phase case. C onsequently, the equations (27) can take place if and only if the perm utation $P$ decom poses into product of pair perm utations (for $N=2 \mathrm{M}$ ) or into product of pair perm utations and one identical transform ation (for $N=2 \mathrm{M}+1$ ). Then one obtains in case of pair perm utations of type $a_{2 i} \quad \$ a_{2 i}$ the next equalities

4. Checking ofexact results for random heterophase system s

The existence of the xed point hyperplanes in space of concentrations and a nonuniversality of the corresponding exact values at the point of all equal concentrations for all $\mathrm{N} \quad 3 \mathrm{can}$ be con m ed for random heterophase system s in the fram ew ork of corresponding approxim ate schem es $\left[\begin{array}{l}{[1,1,9}\end{array}\right]$. O ne needs only that such approxim ate schem e satis es the dually relation.

Firstly we w ill show how these properties look like in the EM approxim ation for $N$-phase square lattice random resistor netw ork ( $R$ RN) system s . This approxim ation gives the follow ing equation for determ ination of e ['] $\left.{ }^{\mathbf{T}}\right]$

where all ${ }^{P}{ }_{\alpha_{1}<i_{2}<:::<i_{k}}$ do not contain $i_{1}=i$ : The coe cients $a_{k}$ are the ho$m$ ogeneous functions of $i$ ofdegree $k$ and the linear functions of concentrations $x_{i}$ : For this reason they are related only $w$ th the corresponding sym $m$ etrical functions $s_{k}$ and their "averages" $s_{k}$ or $s_{k}$ (since there are di erent ways to de ne averaged $s_{k}$ ). The eq. (32) m ust have one physicalsolution e 0:

It is easy to see that $e$ determ ined from the equation (32) satis es the duality (and inversion) relation (4), since the equation (31) for the inverse conductivities has the next property (for all $i \in 0$ )

N ow we pass to the case of pairw ise equal concentrations. Unfortunately, a com plete analysis in this case is rather com plicated and, at the $m$ om ent, it is not done in general form. For this reason we have considered only the system $s$ w ith $N=4 ; 5 ; 6$ : It is convenient to consider the odd and even cases separately. $W$ e begin $w$ th the even case $N=4 ; 6$ : D ue to apparent perm utation sym $m$ etry $S_{N}$, it willbe enough to consider only xed points (19). For $N=4 ; 6$ at the xed points

In the odd case $N=2 M+1$ we have checked for $M=1 ; 2$ that the necessary conditions $\hat{a}_{k}=\hat{a}_{N} k$; are satis ed at the xed point (22). As a result the polynom ial in the de ning eq.(34) reduces also to the factorized form

which $m$ eans that in the odd cases the EM approxim ation hasalso the xed point hyperplanes in the concentration space and that at these xed points there are alw ays the solution, which reduces at these points to the corresponding exact values (23).
$W$ e are sure that the EM approxim ation for general $N$ contains all xed points $(19,22)$ w th the corresponding exact values.

N ow we check the obtained exact results in fram ew ork oftw o other approxi$m$ ations applicable for som e random heterophase system s . T hey w ere introduced rstly for two-phase system $s$ in $\left[\overline{9}_{1}^{\prime}\right]$ and generalized later on N -phase system s in [10]. Fortunately, they give for e the expressionsm ore sim ple than the EM approxim ation.

W e begin $w$ th the nite $m$ axim alscale average (FM SA) approxim ation valid for random system $s w$ th com pact inclusions. T he corresponding approxim ate expression for e of $N$-phase system $s$ is $\left.[\underline{\underline{9}}, 1,1]_{1}^{1}\right]$

It is interesting that in this case $e$ at the point of all equal concentrations $x_{i}=1=\mathrm{N}$ always coincide w th $\mathrm{s}_{\mathrm{N}}^{1=\mathrm{N}}$; (i.e. for arbitrary $i_{i}$ :

A nother approxim ate expression for $e$ is valid for the com posite random heterophase $m$ odels $\left[\frac{1}{9}\right]$. It has the follow ing form in $N$-phase case [10 $\left.{ }^{-1}\right]$

By direct substitution of the xed points values (19),(22) into (46) one can also reproduce the exact values from (20), (21), (23).

## 5. C onclusion

U sing the exact duality relation, sym $m$ etry and inversion properties of 2 D isotropic heterophase system $s$ we have found all possible exact values of their e ective conductivities. T he obtained results take place for various heterophase system $s$ (regular and nonregular as well as random ), satisfying the duality relation (4), and show very interesting properties. Especially, an existence of hyperplanes in the concentration space with constant $e$ is unusual. It will be very desirable to check them experim entally.
