EXACT RESULTS FOR CONDUCTIVITY OF 2D ISOTROPIC HETEROPHASE SYSTEM S

The duality relation for the elective conductivity $_{\rm e}$ of 2D isotropic heterophase systems is used for obtaining the exact results for $_{\rm e}$ at arbitrary number of phases N: The exact values of $_{\rm e}$ correspond to the xed points of the duality transform ations. The new exact results for $_{\rm e}$, generalizing the well-known exact values of $_{\rm e}$ for N = 2;3; are found. It is shown that for N 3 there exist the whole hyperplanes in the space of phase concentrations, on which $_{\rm e}$ takes constant values. These results are checked in the fram ework of various approxim ations for di erent random heterophase system s.

1. Introduction

The properties of the electrical transport of classical inhom ogeneous (random ly or regularly) heterophase system s, consisting of N (N 2) phases with di erent conductivities $_i$ (i = 1;2; ...;N); have a great signi cance for practice. The main problem in theory of the electrical transport in these systems is a calculation of the electric conductivity $_e$ at arbitrary conductivities and phase concentrations [1]. Despite of seem ing sim plicity of this problem only a few exact results have been obtained so far and all of them for two-dimensional system s [2, 3]. They are based on the exact duality relation, which is a consequence of the well-known duality between potential and tangent (or divergent free) elds in two dimensions. This very important relation has been obtained rstly for isotropic two-phase system s, where it can be represented in the form, connecting $_e$ at adjoint concentrations x and 1 x [2, 3]

It allows to nd the exact universal, remarkably simple, formula for $_{\rm e}$ at equal phase concentrations x_1 = x_2 = 1=2

A nalogous exact result for $_{e}$; coinciding with (2), has been obtained in N = 3 case by D ykhne [3], when $_{1 2} = \frac{2}{3}$ and the concentrations of two rst phases are equal $x_1 = x_2 = x$: These exact values of $_{e}$ turned out to be very useful for various applications of the theory, especially the equation (2), which has

been in plemented for checking of various approximate expressions for $_{\rm e}$ and in the percolation theory [5, 6]. The dual relation (1) admits the generalizations on anisotropic systems and polycrystals, systems in magnetic eld [2, 3, 4], but it cannot give exact results for them (except isotropic systems in magnetic eld [4]).

In this letter, using a general duality relation, we will obtain exact results for $_{\rm e}$ of 2D isotropic heterophase system s with arbitrary number N of phases. They generalize the above results for N = 2;3: In particular, it will be shown that for N > 2; contrary to the N = 2 case, there exist the whole hyperplanes in the space of concentrations, on which $_{\rm e}$ takes constant values. The obtained results are checked in the fram ework of various approxim ate schem es.

2. Symmetry, duality and xed points

We begin with a discussion of some general properties of the elective conductivity $_{e}$ of N -phase systems with the partial conductivities $_{i}$ 0 (i = 1;2;:::;N) and concentrations x_{i} ; which satisfy the normalization condition $_{i=1}^{P}x_{i} = 1$: The elective conductivity must be a symmetric function of pairs of arguments (x_{i} ; $_{i}$) and a homogeneous (a degree 1) function of $_{i}$: For this reason it is invariant under all permutations

where P_{ij} is the permutation of the ith and jth pairs of argum ents, and can be represented in the next form

Here $z_i = {}_i = {}_s$; where ${}_s$ is some norm alizing conductivity. For our purposes it will be convenient to choose it in the symmetrical form ${}_s = (s_N)^{1=N}$; where $s_N = {}^Q {}_{i=1}^N {}_i$ is the N-th elementary symmetrical function. Then

As a result the function f is a symmetrical function of N pairs $(x_i; z_i)$; only N 1 of them are independent.

The elective conductivity of N -phase system s must satisfy the following natural boundary conditions: 1) $_{\rm e}$ of N -phase system with n (2 n N) equal partial conductivities must reduce to $_{\rm e}$ of system with N n+1 phases and the concentrations of the phases with equal conductivities must add; 2) it has not depend on partial $_{\rm i}$ and must reduce to the elective conductivity of (N $_{\rm i}$)-phase system, if the concentration of this phase $x_{\rm i}$ = 0; 3) it must reduce to some partial $_{\rm i}$, if $x_{\rm i}$ = 1:

A duality relation for $_{\rm e}$ exists for any two-dimensional N -phase system (see, for example, [7, 8]). Its most general form for $_{\rm e}$ valid at arbitrary phase concentrations is

where $_0$ is some arbitrary constant conductivity, characterizing a duality transform ation.

It is useful to note that the relation (4) can be written also in the other form

which means that $_{\rm e}$ at the inverse values of the partial conductivities $_{\rm i}$ is equal to the inverse $_{\rm e}$. For this reason it can be named also the inversion relation for elective conductivity.

The mutually inverse values are related: their product is equal 2_0 (Fig.la). We will use also, for brevity, the notations of the form fxg for all whole sets of variables like x_i (i = 1;::;N):

An existence of the exact duality (or inversion) relation is very important property of two-dimensional inhomogeneous systems. It can be used for the obtaining of exact values of elective conductivity. For this one needs to know the properties of the partial inversion transform ations

where I is the identity operator. Each partial inversion transform ation acts only on the partial conductivity of the corresponding phase. Strictly speaking, the inversion transform ation is well de ned only for all $_{i} \notin 0$; but one can extrapolate it form ally on the case $_{i} = 0$: In this case it transforms a system with $_{i} = 0$ (a dielectric phase) into a system with $_{i} = 1$ (an ideal conducting phase).

The transform ation $J_{0}^{(i)}$ has only one xed point i = 0: The ith and jth partial inversions, having the same parameter ${}_{0}^{2} = i_{j}$ (we denote them $J_{ij}^{(i)}$ and $J_{ij}^{(j)}$ respectively), are very in portant, because they change i into j and vice versa

The physical sense has only the product of all partial inversions with the same parameter $_{\rm 0}$

G iving to $_0$ di erent values, one can obtain various relations, connecting $_{\rm e}$ at di erent values of its arguments, which can serve for checking of solutions found by other m ethods.

Since in our problem J_0 acts on a space of symmetrical homogeneous functions it is useful to consider its action on the basic elementary symmetrical functions s_k (f g) (f g = (1;:::; N))

It follows from (8) that only s_N transforms into itself. Since $_e$ is a hom ogeneous functions of degree 1, it will be convenient to pass (for $_i \notin 0$) to the projective variables z_i and to introduce projective basic symmetrical functions \hat{s}_k

i.e. the inversion J₀ for any ₀ inverses z_i and interchanges adjoint \hat{s}_k : This property strongly simplify a search of possible xed points needed for obtaining the exact equations for _e: In particular, the duality relation for functions f has the next form

We use the general duality relations (4,4') for the obtaining an exact closed equation for $_{\rm e}$ at some special values of $_{\rm i}$ and $x_{\rm i}$: It follows from (4) that such equation can be obtained if one nds a transform ation T (J;P), consisting from inversions and permutations, and a combination of arguments (fx⁰g;f⁰g), which is a xed point of T

Then, in plem enting this transform ation to $_{e}$ (fx⁰g; f⁰g) in (4), one obtains the following exact equation for $_{e}$ at these arguments

Here $_0$ is a parameter of the inversion, entering in T (J;P): The corresponding exact equation for function f has the form

i.e. the exact value of f at any xed point is equal to 1. Consequently, the possible exact values for $_{\rm e}$ at these xed pointsmust satisfy the next equalities




Fig.1. (a) A schematic plot of possible values of $_{i}$; (i = 1;2); satisfying the relation $_{1 2} = _{0}^{2}$ with some xed value $_{0}$; (b) a concentration phase diagram for N = 3, the bisectrisses correspond to the pairwise equal phase concentrations.

Thus, (15,15') give a general form of the exact values of $_{\rm e}$ in these xed points. The last equalities in (15) and (15') give a strong constraint on possible xed point values of $_{\rm i}$:

In case of N = 2 such xed point exists at arbitrary _i (i = 1;2); but only at the equal phase concentrations $x_1 = x_2 = 1=2$, when the interchanging inversion J_{12} is compensated by the permutation of the pairs of arguments. It gives the known K eller { Dykhne result (2). The similar xed point in case of N = 3 was found by Dykhne [3] at equal phase concentrations ($x_i = x$ (i = 1;2)) and the additional constraint on _3

which remains $_3$ unchanged under the duality transformation. The corresponding exact value for $_{\rm e}$ coincides with (2) in accordance with (15').

It means that at these values of partial conductivities $_{e}$ is xed and does not depend on x! Note that this value of $_{e}$ ensures the right values in the lim its x! 1=2 and x! 0; when they must be $p = \frac{p}{1 + 2}$ and $_{3}$ respectively.

Of course, one can choose the pairs with equal concentrations by various ways. For example, if the phases 1 and 3 have the equal concentrations x and ${}^2_0 = {}_1_3 = {}^2_2$; then one obtains

The corresponding lines of equal concentrations of di erent phases on the concentration phase diagram are shown on Fig.lb, where they coincide with the bisectrisses of the triangle (this triangle is a concentration space of N = 3 systems due to the norm alization condition $P_1^3 x_i = 1$). Their unique intersection

point corresponds to the case of equal concentrations of all phases. It follows from above results that under the conditions (16)–(18) $_{\rm e}$ remains xed and does not change along the corresponding lines! It is worthwhile to note that now, contrary to the N = 2 case, the exact value of $_{\rm e}$ at the point of equal phase concentrations $x_1 = x_2 = x_3 = 1=3$ cannot be de ne from the duality relation in general case. It can be found only in the above xed points and its value depends on the choice of xed point. All these values are di erent. Due to the additional constraints on $_{\rm i}$, the form of possible exact values of $_{\rm e}$ adm its also a value of the conductivity of the third phase. For this reason one can say that a structure of the xed points and a form of corresponding exact values are de ned by the involved interchanging inversion transform ations and the additional constraints.

3. General N -phase case

We show now that the duality relation (4) for N -phase systems admits a generalization of these results on the N -phase systems.

Of course, for system s with N > 3; there are similar xed points, when $x_i = x_j$ and all other $_1$ (l f i; j) are equal between them selves. But this case is trivial, since it reduces to the 3-phase case. Fortunately, the new possibilities appear for N > 3:

Let us consider rstly a case when N is even N = 2M: Then a new xed point is possible, which corresponds to M pairs of phases with equal concentrations and equal products of the corresponding conductivities. For example, the xed point

is possible. But all $_{i}$ in the phase pairs must be di erent. In other words the conductivities of these pairs correspond to M di erent points on the curve (see Fig.1a)

Note that the equal concentrations of the phase pairs y_a (a = 1;::::M) can be arbitrary, except the normalizing condition $P_{a=1}^{P} 2y_a = 1$: The exact value (20) does not depend on y_a and ensures again the correct values for e in the lim its y_a ! 0; 1 (a = 1;::::M): Of course, the sim ilar xed points exist for otherways of the partition of N phases into the pairs with equal concentrations. A number of such points is equal $\#_{2M} = (2M \quad 1)$!!: The exact values of ein these points have always the same general form

where possible pairs ij correspond to the phases with equal concentrations in the corresponding xed points.

Now we consider a case when N is odd N = 2M + 1: In this case a new xed point is possible if the above conditions of the even case (19) are supplemented by a condition on $_{2M + 1}$ analogous to the D ykhne condition for N = 3 case

The corresponding elective conductivity has again the exact value (20), coinciding with the exact value of system with N = 2M . O focurse, the other xed points related with various ways of choice of the phase pairs with equal concentrations are possible. Their number is equal to $\#_{(2M + 1)} = (2M + 1) \#_{2M} = (2M + 1)!!$: A general form of the exact values of $_{\rm e}$ remains the same as in the even case with an additional equality

where the pairs ij correspond to the phases with equal concentrations and $\,k\,$ corresponds to the unpaired phases.

It follows from (21,23) that the exact values of $_{\rm e}$ at the point, where all phase concentrations are equal, are not universal.

One can show that only the xed points of type (19,22) and their various gem ytations are admissible for all dual transform ations of the form T (J;P) =

 $J_a P_b$; where, for clarity, both products are assumed to be nite, and the action of the product of inversions $J = Q J_a$ must be equal to (or compensated by) the product of permutations $P = P_b$ (we will not consider here possible, more sophisticated, form s of T). To do this it is useful to pass from partial conductivities i to their logarithms $a_i = \ln_i$; ($1 a_i 1$): Then the partial inversion transform ation $J_0^{(i)}$ acts on a_i as a rejection a_i ! A a_i ; A = $2 \ln_0$: The inversion J_0 acts on the set of variables fag in the following way

Let us consider rstly a case of even L = 2: Then one obtains from (25)

The set of equations (26) is very restrictive. If any a_i remains unchanged, than $A_2 = 0$ and all other a_i also remain unchanged. It means that in this case

J = I: If (26) gives a permutation of any pair $a_1 \$ $a_k; (i \in k);$ than it follows from (26) that again $A_2 = 0: As is known any permutation P decomposes into product of independent chains of simple permutations. Then, considering all possible chains similar to the abovem entioned simplest case of pair permutation, one can see that equations (26) take place only when <math>A_2 = 0: In case of odd$ L = 1 equations (25) take the form

If (27) gives a permutation of some pair $a_i \ a_k$; (i \in k); then one obtains for $a_i;a_k$ only one equality (since in this case both equations coincide)

In case of any larger chains of permutation one obtains additional equalities, which have only trivial solution. For example, in case of 3-chain (1 ! 2 ! 3 ! 1) they are

It follows from (29) that this is possible only if $a_1 = a_2 = a_3 = a$; $A_1 = 2a$; but this corresponds to the one phase case. Consequently, the equations (27) can take place if and only if the permutation P decomposes into product of pair permutations (for N = 2M) or into product of pair permutations and one identical transformation (for N = 2M + 1). Then one obtains in case of pair permutations of type a_{2i-1} \$ a_{2i} the next equalities

All other solutions can be obtain from (30) by various permutations. These solutions give exactly the xed points (19,22) after returning to the variables f g:

4. Checking of exact results for random heterophase systems

The existence of the xed point hyperplanes in space of concentrations and a nonuniversality of the corresponding exact values at the point of all equal concentrations for all N 3 can be con m ed for random heterophase systems in the fram ework of corresponding approxim ate schem es [5, 9]. O ne needs only that such approxim ate schem e satis es the duality relation.

Firstly we will show how these properties look like in the EM approximation for N -phase square lattice random resistor network (RRN) systems. This approximation gives the following equation for determination of $_{\rm e}$ [5]

where all $P_{i_1 < i_2 < \dots < i_k}$ do not contain $i_1 = i$: The coe cients a k are the homogeneous functions of i of degree k and the linear functions of concentrations x_i : For this reason they are related only with the corresponding symmetrical functions s_k and their "averages" s_k or s_k (since there are dimension ways to de ne averaged s_k). The eq. (32) must have one physical solution e 0:

It is easy to see that $_{\rm e}$ determ ined from the equation (32) satisfies the duality (and inversion) relation (4), since the equation (31) for the inverse conductivities has the next property (for all $_{\rm i} \in 0$)

M or eover, since $a_N = s_N$, one can pass directly to the sim ilar equation for f by dividing all its term s on s_N

Firstly we consider the case of equal concentrations $x_i = 1 = N$: Then one can see that the coe cients \hat{a}_k and f must depend only on symmetrical functions \hat{s}_k (k = 1; ...; N 1)

It is easy to check that they are satisfied at the xed points (19), (22) and that the coe cients \hat{a}_k satisfy at these points the equations

Since all coe cients of P $_{\rm N}$ $_1$ (f) are positive, one can see from (40) and (41) that equations (32) and (34) have always only one physical solution at any xed point (19),(22)

which coincides with the corresponding exact values from (21), (23).

Now we pass to the case of pairwise equal concentrations. Unfortunately, a complete analysis in this case is rather complicated and, at the moment, it is not done in general form. For this reason we have considered only the system s with N = 4;5;6: It is convenient to consider the odd and even cases separately. We begin with the even case N = 4;6: Due to apparent permutation symmetry S_N , it will be enough to consider only xed points (19). For N = 4;6 at the xed points

one can show by direct calculation, using equalities (38), that for all y_i

Thus the polynom ial in equation (34) reduces also to the factorized form

where the polynom ials $P_{3,5}(f;y)$ have the form (41), but now the coe cients \hat{a}_k depend on concentrations y: Due to factorization, eqs.(32),(34) have the required solutions of the form (20).

In the odd case N = 2M + 1 we have checked for M = 1;2 that the necessary conditions $\hat{a}_k = \hat{a}_{N-k}$; are satisfied at the xed point (22). As a result the polynomial in the dening eq.(34) reduces also to the factorized form

which m eans that in the odd cases the EM approximation has also the xed point hyperplanes in the concentration space and that at these xed points there are always the solution, which reduces at these points to the corresponding exact values (23).

We are sure that the EM approximation for general N contains all xed points (19,22) with the corresponding exact values.

Now we check the obtained exact results in fram ework of two other approximations applicable for some random heterophase systems. They were introduced rstly for two-phase systems in [9] and generalized later on N -phase systems in [10]. Fortunately, they give for $_{\rm e}$ the expressions more simple than the EM approximation.

We begin with the nite maximal scale average (FM SA) approximation valid for random systems with compact inclusions. The corresponding approximate expression for $_{\rm e}$ of N -phase systems is [9, 10]

It is easy to check that (45) reproduces at the corresponding xed points the exact values from (20),(21),(23) due to the norm alization condition for concentrations

It is interesting that in this case $_{e}$ at the point of all equal concentrations $x_{i} = 1$ -N always coincide with $s_{N}^{1=N}$; (i.e. for arbitrary $_{i}$:

Another approximate expression for $_{e}$ is valid for the composite random heterophase models [9]. It has the following form in N -phase case [10]

By direct substitution of the xed points values (19), (22) into (46) one can also reproduce the exact values from (20), (21), (23).

5. Conclusion

U sing the exact duality relation, symmetry and inversion properties of 2D isotropic heterophase systems we have found all possible exact values of their e ective conductivities. The obtained results take place for various heterophase systems (regular and nonregular as well as random), satisfying the duality relation (4), and show very interesting properties. Especially, an existence of hyperplanes in the concentration space with constant $_{\rm e}$ is unusual. It will be very desirable to check them experimentally.
