## Solar Flare Interm ittency and the Earth's Tem perature A nom alies

We argue that earth's short-term temperature anomalies and the solar are intermittency are linked. The analysis is based upon the study of the scaling of both the spreading and the entropy of the di usion generated by the uctuations of the temperature time series. The joint use of these two m ethods evidences the presence of a Levy component in the temporal persistence of the temperature data sets that corresponds to the one that would be induced by the solar are intermittency. The m ean m onthly temperature datasets cover the period from 1856 to 2002.

The historical recognition that the sun warm s the earth has suggested a direct connection between the average global tem perature and solar activity. Consequently any signi cant changes in solar activity should result in equivalent changes in the earth's global tem perature. The literature on the solar in uence on the earth's tem perature is quite extensive [1, 2, 3], indicating the importance of the problem and that there are m any issues that require further investigation. Herein we address the relation between the statistics of solar are activity and the uctuations in the earth's global tem perature.

The dynam ics of the sun's surface is turbulent, as is evidenced by changes in solar are activity, with 11 or 22 year solar cycles [2, 3] and strong erratic uctuations associated with solar are interm ittency [3, 4, 5, 6]. Solar irradiance changes in accordance with the frequency of solar ares because each are releases more energy than the background irradiance [3]. This time variation in the frequency of solar ares induces a similar pseudoperiodic cycle in the earth's average tem perature, as well. as produces trends that m ove the global tem perature up or down for tens or even hundreds of years [1, 2, 3]. However, it is less evident that short-term (weekly and m onthly) changes in the global tem perature are tied to solar activity whose short-time uctuations would have the intermittent dynamics of solar ares. Traditional m easures, such as cross-correlation functions, would not show the connection between short-time uctuations in the global tem perature and solar are activity, because of the strong nonlinear hydrodynam ic interactions across the earth's surface. For example, the hydrodynam ic interaction of the atm osphere over land and water, would suppress any direct correlation between the interm ittent sun's irradiance and the earth regions' short-time response.

This letter focuses on an alternate approach to establishing the connection between the sun's irradiance and the earth's temperature uctuations. A link between the two phenomena is detected through a detailed scaling analysis of the time series for the earth's temperature and the time series for the solar are frequency.

Considering a solar are as an event, the tim e series for

the number of solar areshas been interpreted as a waiting time distribution function between events. The solar are waiting time distribution function is determined to be an inverse power-law probability density function (iplpdf) [4, 5, 6]. Such dynam ical stochastic processes can be described by generalizations of random walks. A Levy-ight, for example, is such a process with a diverging second m om ent. A Levy-walk, on the other hand, visits the same spatial sites as does a Levy-ight, but each step takes a nite time and the second moment is nite. The time necessary to complete a step in a Levy-walk is specied by an inverse power-law waiting time distribution function, as rst noticed by Shlesinger et al. [8]. It has been determined [4] that a Levy-walk can describe the interm ittent solar are signal. Scafetta et al. [7, 9] established that, in general, the presence of a Levy-walk process in a given tim e series can be detected by the joint use of two separate scaling techniques, the D i usion Entropy Analysis (DEA) and Standard Deviation Analysis (SDA). We apply the same approach to the analysis of tem perature data sets and com pare them with the Levywalk statistics induced by solar are intermittency.




FIG. 1: G lobal and local Earth tem perature anomalies in C elsius degree (years: 1856-2002).

W e study the earth's tem perature anom a lies both globally and locally, that is, North-South hem ispheres and Land-O cean regions, see Fig. 1. The technical term tem perature anom alies denotes tem perature departures from the 1961-1990 m ean tem perature value. These data are recognized in the geophysical community as among the m ost accurate data les for global air tem perature, and globalsea surface tem perature (SST) [10]. The basic data set of global earth's tem perature anom alies (H adC RUT ) is a combination of Land air tem perature anom alies [11] (CRUTEM 1) and sea-surface tem perature anom alies [12] on a 5 x 5 grid-box basis. The merging of the two data sets is discussed in Parker et al. [12] and more recently in Jones et al. [13]. The Land surface time series are calculated using data from the G lobal H istorical C lim atology Network (Version 2) and sea-surface tem perature anom alies from the United Kingdom MOHSST data set and the NCEP Optimum Interpolated SSTs (Version2). The data that we analyze are mean monthly temperature anom alies downloaded from C lim atic Research Unit,

UK, [14] (G bbal and North-South tem peratures, 1856-2002) and from National C limatic D ata Center, USA, [15] (Land-O cean tem peratures, 1880-2002).

The analysis of the above data sets is done with both DEA and SDA techniques. These m ethods are based on the prescription that the numbers in a time series f<sub>i</sub>g are the uctuations of a di usion trajectory; see Refs. [4, 7, 9] for details. Therefore, we shift our attention from the time series f<sub>i</sub>g to the probability density function (pdf) p(x;t) of the corresponding di usion process. Here x denotes the variable collecting the uctuations and is referred to as the di usion variable. The scaling property of p(x;t) takes the form

where is the scaling exponent. The DEA [7] is based on the evaluation of the Shannon entropy, S (t), using the pdf (1). If the scaling condition of Eq. (1) holds true, it is easy to prove that the entropy is

$$S (t) = p(x;t) \ln [p(x;t)] = A + \ln (t); \quad (2)$$

where A is a constant. The SDA [7], instead, is based on the evaluation of the standard deviation D (t) using the same pdf (1) and yields to

where H is the Hurst exponent [7, 16].

The Levy-walk statistics is a particular form of anom alous di usion obtained by generalizing the CentralLim it Theorem [17]. While all theoretical details can be found in Refs. [4, 7, 9] and in the enclosed references, here we show the properties of a Levy-walk using a model that simulates solar are interm ittency. We generate an arti-




FIG.2: Fig. 2a shows a computer-generated interm ittent sequences of impulses. Fig. 2b shows the frequency of impulses for 1700 time units.

cial sequence f ig distributed according to an iplpdf,

where T is a positive constant. In the computergenerated example, we use T = 90 and = 2:5, that is, we use 2 < < < 3, so as to violate the constraint of a nite variance on the central lim it theorem that is necessary for obtaining Levy-walk statistics. The sequence of waiting times f jg is used to generate a time series f ig given by i = p1 only at the occurrence of the events, that is, for  $i = \begin{bmatrix} m \\ j=1 & j \end{bmatrix}$ ; [a] is the integer part of a. However, in the interval between two events, that is, for  $\underset{j=1}{\overset{m}{j=1}}$   $\underset{j=1}{\overset{r}{j=1}}$   $\underset{j=1}{\overset{r}{j=1}}$   $\underset{j=1}{\overset{r}{j=1}}$ , we assume  $\underset{i}{\overset{r}{i=0}}$ . As shown in Ref. [4, 7, 9] by using results of Refs. [17, 18, 19] the time series f ig generates a di usion process with a scaling exponent = 1 = (1). Moreover, this particular approach to Levy statistics yields a di usion process with nite second moments, as in the Levy-walk [8]. Consequently, it is possible to evaluate the scaling exponent of the standard deviation, H, via Eq. (3). Fig. 2a shows the rst 1650 data points in the computer-generated sequence  $f_{iq}$ , which correspond to the rst 5.5 time units, of a 510,000 long data sequence f ig. In Fig. 2b we show the sequence of frequencies fftg of in pulses for each time unit where we use 1 time unit = 300 natural units of .

The analysis is based on the comparison of the scaling exponents and H measured by DEA and SDA respectively. It has been shown [7, 9] that if a time series is characterized by G aussian statistics, the two scaling exponents are identical, that is, = H . If, instead, the process under study is characterized by a Levy-walk, the two scaling exponents and H can be both related to the exponent of the waiting time iplpdf of the underling interm ittent process generating the Levy statistics. In the Levy-walk case the scaling exponent H is slightly larger than and the two exponents are related to and




FIG.3: DEA and SDA of the computer-generated Levy-walk sequences shown in Figs. 2a and 2b. The two straight lines show the two theoretical scaling coe cients = 0:67 and H = 0:75 for = 2:5.

W e refer to (5) as the Levy-walk di usion relation. The assessment of the property expressed by Eq. and measured for the hard x-ray solar ares waiting time series [4], is used in this letter to verify the conjecture that the earth's global temperature inherits the interm ittent Levy-like nature of solar ares, within the temporal range from few weeks to few months.

In the computer-generated model we interpret the uctuations in the frequency of the pulses shown in Fig. 2b as inducing a similar memory pattern in the monthly m ean global tem perature uctuations. Infact, a higher solar are frequency in plies a higherm onthly solar activity. The DEA and SDA of the computer-generated data are shown in Fig. 3. These data are twith Eqs. (2) and (3) yielding the two scaling  $\cos cients = 0.67$  and H = 0.75. These coe cients are consistent with = 2.5obtained by using Eq. (5); the known input value for this realization of the model. The large picture in Fig. 3 refers to the analysis of the original 510,000 data-point sequence  $f_{ig}$ . The inset refers to the analysis of 1700 data-point frequency sequence fftg shown in Fig. 2b, a length compatible with the length of the mean monthly tem perature datasets here analyzed. The two graphs in Fig. 3 show very good agreem ent with Levy-walk theory, that is, with Eq. (5) because both time series produce sim ilar di usion trajectories. In particular, the small inset in Fig. 3 shows the typical bifurcation associated to the two scaling laws that characterize Levy-walk statistics and that the statistics generated by only N = 1700frequency data points is rich enough to obtain a satisfac-




FIG. 4: DEA and SDA of the North-South hem isphere and Land-O cean region temperature anom alies. The scaling exponent H and are reported in the gure, the error is 0:02.

tory pdfwith Levy-walk scaling properties.

Fig. 4 shows the num erical results by applying DEA and SDA to the temperature uctuation data of the four regions of the earth. On the ordinate axis we plot  $\ln [D (t)=D (1)]$  and S (t) S (1); thus, all curves start from 0. The scaling exponents and H are obtained by thing the rst 10 points. This analysis for the G lobal tem perature (not shown in the gure) yields  $= 0.90 \quad 0.02$  and H = 0.95 0.02. The high values of the exponents im ply a strong persistence in the tem perature uctuations. Both scaling exponents and H are slightly larger for the South hem isphere than for the N orth hem isphere and for the O cean than for the Land. A reasonable explanation is that the O cean is an alm ost stationary system with a very high e ective heat capacity. The Land, instead, is subject to stronger random uctuations (as Fig. 1 show s) due to a lower e ective heat capacity and a higher morphological variability due, for example, to the presence of deserts, forests, mountains and valleys. Finally, we note that the standard deviation scaling exponents H are larger than the di usion entropy scaling exponents and seem to ful 11 the Levy-walk di usion relation (5) within the accuracy of our statistical analysis.

The scaling behavior in the tem perature anom alies can be related to the intermittency of the solar are activity through the mechanism suggested by the model depicted in Figs. 2 and 3. In fact, the waiting time distribution of solar ares is characterized by an iplpdf of the type of Eq. (4) with = 2:14 0:05 [4]. This value of would imply a Levy-walk with  $= 0.88 \quad 0.02$  and H = 0:02 (5) for a shu ed dataset that would destroy 0:93 any tem poral correlation among ares and conserve only the Levy component; see Ref. [4] about the e ect of the shu ing on these data. We observe that the di erence of the above two scaling exponent values gives H 0:05 0:02; that is a value com patible with the di erence between H and measured for all the temperature data sets. In particular, H = 0.05 0.02 for the G lobal




FIG.5: DEA of the unshu ed waiting time of solar area sequence during the period 1991-2000. The value of the scaling exponent is  $= 0.94 \quad 0.02$ .

tem perature and for both South and O cean regions and H = 0.04 0.02 for N orth and Land regions.

To understand the actual values that we measure for H and we rst notice that the waiting time sequence of solar areas is weakly correlated [4]. Therefore, the elective value of for the original unshuled sequence is slightly larger than that calculated via the waiting time iplpdf exponent for areas [4], = 0.94 0.02, as Fig. 5 shows. We observe that this value of is perfectly compatible with = 0.93 0.02 measured for the 0 cean temperature. The 0 cean, in fact, is the region of the earth that should best mirror solar activity because it is the largest

and most hom ogeneous region of the earth with a very high e ective heat capacity; properties that retain correlated events in the tem perature. A lso we observe that the occurrence of uncorrelated events would slightly reduce the Levy-likem em ory and increase the Gaussianity of the data. This might explain why the scaling exponents H and as well as their di erence slightly decreases (0.04 against 0.05) between the North and Land regions. Finally, Fig. 5 shows that the scaling properties for the waiting time of solar ares last at least 200 consecutive ares and the waiting time for clusters of 200 solar ares may last for several months. The largest waiting time between two consecutive solar ares, during the period 1991-2000, is alm ost 3 m onths [4], and on average there are alm ost 60 solar aresperm onth. Therefore, the tem poral resolution of these clusters is compatible with the tem poral range of scaling of the tem perature data sets that last at least 1 to alm ost 20 m onths, as Fig. 4 shows.

In conclusion, the a nity of the scaling exponents obtained through our analysis suggest that the earth's tem – perature anom alies inherits a Levy-walk m em ory com ponent from the interm ittency of solar ares. We obtain reliable scaling properties within a short time interval, ranging from a few weeks to a few m onths. M orever, the joint use of SDA and DEA has proved to be very useful in detecting a signi cant Levy com ponent in the time series and, in general, it m ay suggest the presence of a link between a phenom enon under study and an interm ittent process characterized by a waiting time iplpdf.
