Optically-induced lensing e ect on a Bose-Einstein condensate expanding in a moving lattice

We report the experimental observation of a lensing election a Bose-Einstein condensate expanding in a moving 1D optical lattice. The elect of the periodic potential can be described by an elective mass dependent on the condensate quasi-momentum. By changing the velocity of the atoms in the frame of the optical lattice we induce a focusing of the condensate along the lattice direction. The experimental results are compared with the numerical predictions of an elective 1D theoretical model. Besides, a precise band spectroscopy of the system is carried out by looking at the real-space propagation of the atom ic wavepacket in the optical lattice.

The experimental realization of Bose-Einstein condensation allowed signicant advances in the eld of atom optics. Forces resulting from the interaction with coherent light can be used to manipulate coherent matter waves [1]. Bragg scattering from two pulsed laser beams [2] has provided a simple tool for the implementation of atom ic m irrors, beam splitters and di raction gratings. Superradiant Rayleigh scattering has been used as the gain m echanism for the development of a coherent matter waves amplier Bl. Atom lasers have been realized, providing pulsed and quasi-cw sources of coherent matterwaves [4]. Nonlinearities in the atom icwave equation have been exploited in experim ents of nonlinear atom optics, such as the realization of four wave mixing [5] or the observation of soliton propagation [6]. One main di erence between atoms and photons is the mass, which can be modied by the presence of a periodic potential, such as that resulting from the interference of two counterpropagating laser beams. The super uid behavior of a condensate in such an optical lattice has been studied in [7] showing the role of the e ective mass in shifting the collective mode frequencies. The possibility of achieving experim ental control over the e ective mass allows the dispersion management of the matter wavepacket. Several fascinating e ects are predicted to appear in the negative e ective mass regime, such as the formation of gap solitons in a condensate with repulsive interactions [8].

In this Letter we dem onstrate the possibility to change the expansion of a Bose-E instein condensate (BEC) using a moving optical lattice, which acts as a lens form atter waves, focusing or defocusing the atom ic cloud along the direction of the lattice, as recently predicted in [9]. The observed center-of-m ass dynam ics can be well explained in term sofband structure and B loch states, familiar concepts to solid state physics. This picture has been conmed by many experimental results, including the observation of B loch oscillations [10] and an extensive work




FIG. 1: Schem atics of the experim ental procedure. A fter releasing the condensate from the magnetic trap (A) we adiabatically ram p the intensity of an optical lattice moving at velocity $v_{\rm L}$. We let the condensate expand in the periodic potential and after 10 ms at the maximum light intensity we look at the position and dimensions of the atom ic cloud by absorption in aging along the radial horizontal direction (B).

on loading and manipulating a condensate in an optical lattice [11]. In the rest fram e of the lattice the eigenenergies of the system are E_n (q), where q is the quasim om entum and n the band index. According to band theory, the velocity in the n-th band is $v_n = h^{-1} @E_n = @q$ and the e ective mass is $m = h^2 (e^2 E_n = eq^2)^1$. We demonstrate that the expansion of the condensate is strongly modied by the change in the single particle e ective mass m, which enters the diusive (kinetic) term in the Gross-Pitaevskii equation. The expansion of a BEC in a static optical lattice has been already studied in [12]. Here we use a moving optical lattice to load the condensate in quasim om entum states with dierente ective mass. This ability to access regions of negative e ective m assallows us to change the sign of the matter wave dispersion, inducing the condensate to compress along the lattice direction instead of expanding [9].


The experiment is performed on a Bose-Einstein con-

densate of 87 R b produced in a standard double m agneto-optical trap apparatus by m eans of combined laser and RF-evaporative cooling. The evaporation is performed in a Io e-P ritchard m agnetic trap with frequencies $_{\rm X}$ = 8.8 Hz and $_{\rm 2}$ = 90 Hz along the axial and radial directions respectively. We typically produce condensates of

 10^5 atom s in the hyper ne level $\frac{1}{5} = 1$; m_F = of the ground state. The optical lattice is provided by two counterpropagating phase-locked laser beam saligned along the axial direction of the cigar-shaped condensate. The two beams are circularly polarized and blue-detuned $0.5 \, \text{nm}$ from the Rb D 2 line at = $780 \, \text{nm}$. The interference of the two beams, derived by the same TiSa laser and controlled by two independent acousto-optic modulators, produces an optical lattice moving at velocity =2, where is the frequency di erence of the two beams. In the laboratory frame the resulting potential can be written as $V = sE_R cos^2 [k(x v_L t)]$, where k = 2 = is the modulus of the wavevector and s measures the depth of the optical lattice in units of the recoil energy $E_R = h^2 k^2 = 2m$.

The experim ent is perform ed as follows (see Fig. 1). After producing the BEC, we switch o the magnetic trap and let the atom ic cloud expand. A fter 1 m s of expansion we adiabatically switch on the moving lattice by ram ping the intensity of the two laser beam s in 2 m s. W e let the condensate expand in the lattice and after a total expansion time of 13 ms we take an absorption image of the cloud along the radial horizontal direction looking at the position and dimensions of the condensate. We note that the waist of the laser beam s (about 2.0 mm) is big enough to provide a constant light intensity during the entire expansion of the condensate. This loading procedure allows us to project the condensate in a B loch state of well-de ned energy and quasim om entum [11]. We veri ed the adiabaticity of this procedure by checking that, applying the reverse ram p to switch o the lattice, at the end of the expansion we still have only one mom entum component in the atom ic cloud (i.e. we have populated only one energy band). In our experim ents we typically m ove the optical lattice with velocities v_L between 0 and $2v_B$, where $v_B = q_B = m = hk = m = 5:89 mm/s is the$ recoil velocity of an atom absorbing one lattice photon. As a result of the adiabatic loading we can access different energy bands: for $0 < v_L < v_B$ we populate the rst band, while for $v_B < v_L < 2v_B$ the second band is populated.




FIG. 2: a) Velocity of the condensate in the frame of the moving lattice for the lowest two energy bands and two different optical intensities: s=1.3 (closed circles) and s=3.8 (open circles). The experimental data are obtained from the measured displacements of the condensate center-of-mass after the expansion inside the lattice. The lines are calculated from band theory. b) E ective mass of the condensate in the lowest two energy bands for s=1.3. The experimental points (closed circles) are obtained by numerically evaluating the incremental ratios v=q from the data shown above. The lines are calculated from band theory. We remember that $v_{\rm B}=q_{\rm B}=m=h\,{\rm k}=m$.

From the measured positions of the condensate center-ofm ass at the end of the expansion we extract the velocity of the atom s inside the periodic potential. In the moving frame of the lattice the atom ic velocity is given by $v=v_L$ x=t, where x is the axial displacement of the condensate and t is the time of expansion inside the optical lattice (Fig. 1). In Fig. 2a we report the experimental velocities as a function of quasimomentum for two dierent lattice depths: s=1.3(1) and s=3.8(1). The error bars include the indetermination in t due to the adiabatic s itching on of the optical lattice. The lines

shown in the gure are obtained from the calculation of the velocity in the rst two energy bands. The measured spectrum of velocities shows a very good agreement with theory. We note that the theoretical curves are derived from the simple one-particle model neglecting the elect of interactions. As a matter of fact, since the experiment is performed after some expansion, we expect that interactions play a negligible role on the energy spectrum (after 2 ms of expansion the interaction energy has been almost completely converted into kinetic energy). An adequate sampling of the experimental velocities allows us to reconstruct the elective mass by evaluating




FIG .3: Absorption im ages of the expanded condensate. From left to right: a) normal expansion of the condensate without lattice; b) axial compression in a lattice with s = 2:9 and $v_{\rm L}$ = 0:9 $v_{\rm B}$; c) enhanced axial expansion in a lattice with s = 2:9 and $v_{\rm L}$ = 1:1 $v_{\rm B}$ (where $v_{\rm B}$ = $q_{\rm B}$ =m = hk=m). In the lower part we report the axial and radial dimensions of the condensate after expansion in an optical lattice with s = 2:9 as a function of the quasim omentum. The experimental points (closed and open circles) show the Thomas-Fermi radii of the cloud extracted from a 2D to fithe density distribution. The dotted lines show the dimensions of the expanded condensate in the absence of the optical lattice. The continuous and dashed lines are theoretical calculations obtained from the 1D elective model described in the text.

the derivative @v=@q from the nite increment between consecutive points. In Fig. 2b we report the results of such analysis on the data taken at s=1:3 together with the theoretical curve. This experimental study allows us to make a precise spectroscopy of the energy bands, measuring the velocity spectrum and thee ectivem assofthe condensate in the periodic potential.

However, the most interesting feature of this experiment concerns the observed dependence of the dimensions of the expanded condensate on dierent lattice velocities (hence dierent quasimomenta of the condensate in the frame of the moving lattice). Typical absorption images for dierent q are reported in the upper part of Fig. 3. In the bottom of Fig. 3 we report the measured Thomas-Fermi radii of the condensate as obtained from a 2D to fithe measured density distribution [13]. We note that, approaching the boundary of the rst Brillouin zone for q $^{<}$ qs, the axial dimension of the condensate gets

sm aller as a consequence of the modi ed e ective mass m < 0 (see Fig. 3b). In fact, it is easy to show that a change of sign in the e ective mass corresponds to a time-reversed evolution under the in uence of an inverted external potential (if present). Since in our case the condensate is initially expanding outwards, when m becomes negative an inversion of dynamics takes place [14]. This contraction continues for times much longer than those considered in this experiment, until the wavepacket eventually reaches its minimum allowed size (when dynamics inverts again).




FIG. 4: A spect ratio of the condensate after 13 m s of expansion in an optical lattice with s=2.9. The dotted line shows the aspect ratio of the expanded condensate in the absence of the optical lattice. The continuous lines is a theoretical calculation obtained from the 1D e ective model described in the text.

This focusing e ect along the axial direction is balanced by an increased expansion along the radial axis, that we attribute to an e ect of interactions. In fact, due to the compression along the lattice direction, the fast radial expansion is further enhanced by the increase of the mean-eld energy. When the condensate is loaded in the second band, for $q > q_B$, the axial expansion is enhanced due to the strong positive curvature of the second energy band near the zone boundary, where 0 < m < m(see Fig. 3c). As one would expect, in this case the radial dynamics is not modied, since the residual meaneld energy is further reduced by the fast axial expansion, causing a suppression of the non-linear coupling between the axial and radial dynamics. In Fig. 4 we also show the (radial to axial) aspect ratio of the condensate [15], which is characterized by a marked discontinuity across the boundary between the rst and second zone as predicted in [9].

To get further insight on the behavior of the condensate during the expansion, we have analyzed the experim ental results by means of the 1D elective model pre-

sented in [9]. A coording to this model, the full 3D G ross-P itaevskii description of the system is rst dynam ically rescaled by using the unitary scaling and gauge transform ations of [16, 17], and then reduced to an elective 1D equation (dr-GPE) by a gaussian factorization of the radial wavefunction [18]. Despite its 1D nature, the model is capable to account both for the axial and radial dynamics of the system, as discussed in [9]. In the present case the factorization of the wavefunction is further justiced by the fact that during the expansion the axial and radial degrees of freedom almost decouple.

A ctually, Fig. 3 shows that the model qualitatively reproduces the behavior observed in the experiment, even though it does not t precisely the data. In particular, approaching the st zone boundary, the observed focusing e ect along the axial direction is slightly smaller than the calculated one, and at the same time the expansion along the radial direction (not directly a ected by the lattice) is enhanced. Instead, in the second band the radial behavior is well reproduced by the model, whereas there is still a discrepancy concerning the axial expansion. We remark that in the region near to the band edge $(0.95q_B < q < 1.05q_B)$ the process of switching on the optical lattice is no longer adiabatic, and the description is complicated by the fact that more than one energy band gets populated. Indeed what we actually see in the experim ent is a superposition of two atom ic clouds with di erent shapes resulting from the minor population of a

di erent energy band. At the present stage of the experim ent, we cannot increase arbitrarily the ram p time of the lattice intensity as the condensate, under the e ect of gravity, falls out of the lattice beam s.

In conclusion, we have achieved a lensing e ect on a Bose-E instein condensate expanding inside a moving optical lattice. Tuning the velocity of the lattice we can set the lensing power of the periodic potential, all the way from focusing to defocusing of the atomic cloud. The demonstrated experimental control of the matter wave dispersion is likely to open new possibilities in the eld of atom optics, including the observation of non linear e ects such as the generation of gap solitons. The experimental techniques introduced in this work will also allow future high precision studies of the band structure of a Bose-E instein condensate in an optical lattice.
