## Fractal structure of the e ective action in (quasi-) planar m odels with long-range interactions

We derive the elds in a class of (quasi-) planar models with longrange interactions. This class of models can be relevant for high temperature superconductors and graphite. The fractal structure of the elds elds of the potential is revealed and its physical interpretation is presented. It is argued that the multi-branched fractal structure of the potential relevance of an in nite tower of excitonic bound states that occur as a result of the long-range interactions.

For a long time, there has been a great interest in low dimensional quantum eld theories. Typical examples are the 1 + 1 dimensional G ross-N even model and the 2 + 1 dimensional quantum electrodynamics (Q ED<sub>2+1</sub>). They have been used as very instructive toy models of relativistic system s with complicated dynamics. In addition to that, it is quite remarkable that these same models m in ic some intrinsic properties of the dynamics of non-Ferm i liquids. In particular, numerous recent studies suggest that high-T<sub>c</sub> superconductors and graphite could be described well by a (quasi-) planar QED<sub>2+1</sub> [1, 2, 3, 4, 5, 6, 7].

The di culties in studying strongly correlated system s such as high-T<sub>c</sub> superconductors and graphite m ight be related in part to the presence of long range C ou lom b like interactions between quasiparticles. This lim its considerably the use of m any powerful techniques that used to work well in models with short-range interactions. One of such tools is the celebrated G inzburg-Landau (GL) effective action. A method of the derivation of the GL action for com posite operators in system s with short-range interactions has been known since the work of Gorkov [8]. Its generalization to systems with a spontaneous sym em try breaking driven by long-range interactions is far from being straightforward. In relativistic eld theories, a method of the derivation of the elective action in models with long-range interactions (driven by gauge elds) was elaborated in Ref. [9].

Recently, using the method of Ref. [9], the elective potential has been derived in the so-called reduced QED [7]. In such a model, while quasiparticles are conned to a 2-dimensional plane, the electrom agnetic interaction between them is three dimensional in nature. The model is relevant for a class of condensed matter systems that include highly oriented pyrolytic graphite among others [6, 7]. In this letter, we will reveal a remarkable property of the elective potential in reduced QED, not considered in Ref. [7]. It will be shown that the potential has a multibranched fractal structure relecting the presence of an in nite tower of excitonic bound states (a clear signature of long-range interactions). It is also in portant that, as was shown in Ref. [7], reduced QED is intimately connected with QED<sub>2+1</sub>, relevant for cuprates [1, 2, 3]. In fact, as will be discussed below, the qualitative features of the elective potential in reduced QED are common for a wide class of models with long-range interactions, in particular, for QED<sub>2+1</sub>.

We start from a general de nition of the e ective action in a theory in which the spontaneous symmetry breaking phenomenon is driven by the local composite order parameter h0j jDi, where is the Dirac spinor of the quasiparticle eld and is the (Dirac) conjugate spinor. Following the conventional way (see for example Ref. [10]), we introduce the generating functional W (J) for the Green functions of the corresponding composite eld through the path integral:

where J(x) is the source for composite eld and  $L_{qp}(x)$  is the lagrangian density of quasiparticles in the model at hand. Then, by de nition, the eld ective action for the eld (x) h0j (x) j0i is given by the Legendre transform of the generating functional W(J),

where the external source J(x) on the right hand side is expressed in terms of the eld (x) by inverting the relation

The elective action () in Eq. (2) provides a natural fram ework for describing the low energy dynam ics in the model at hand. It is common to expand this action in

powers of space-time derivatives of the eld :

where V () is the effective potential. The ellipsis denote higher derivative terms as well as contributions of the N am bu-G oldstone bosons if the latter are required by the G oldstone theorem. By making use the de nition in Eqs. (2) and (3), we derive the following relation:

In the lim it of a vanishing external source, this equation turns into an equation of motion for the composite eld

(x). In a particular case of constant congurations, the equation reads dV=d=0.

By keeping the external source on the right hand side of Eq. (5) nonzero but constant in space-time, we derive the following convenient representation for the elective potential:

where w (J) W (J)= $V_{2+1}$ , and  $V_{2+1}$  is the space-time volume. Thus, the crucial point for evaluating V is how the source J, playing here the role of the bare ferm ion gap, depends on the composite eld . It will be shown below, following the approach of Ref. [9], that the function J() can be determined from a modiled gap equation, including the bare gap J.

The model under consideration is the same as the model used in Ref. [6, 7] to study a metal-insulator phase transition in highly oriented pyrolytic graphite. We assume that the ferm ionic quasiparticles are conned to a at 2-dimensional plane, while the electrom agnetic eld is free to propagate in the 3-dimensional bulk. The spatial coordinates on a plane are denoted by r = (x; y) and the orthogonal direction is labeled by the z coordinate.

The lagrangian density of the electrom agnetic eld (in the bulk) is given by

where "<sub>0</sub> is the dielectric constant, <sub>0</sub> is the magnetic permeability, A<sub>0</sub> and A are the scalar and vector potentials, and electric and magnetic elds are  $\mathbf{E} = \mathbf{\hat{r}} \mathbf{A}_0 = \frac{1}{c} \mathbf{G}_t \mathbf{A}$ ,  $\mathbf{\hat{B}} = \mathbf{\hat{r}} = \mathbf{\hat{A}} \cdot \mathbf{W}$  enote that the interaction terms, with the quasiparticle charge density and current  $\mathbf{\hat{j}}$ , were explicitly included in the lagrangian density in Eq. (7). In addition to that, the lagrangian density of quasiparticles them selves (living only on the plane) should be specified. It reads

where  $v_F$  is the Ferm i velocity, (t;r) is a 4-component spinor, =  $y^{0}$ , and the 4 4 D irac -m atrices furnish a reducible representation of the C Li ord (D irac) algebra in 2 + 1 dimensions.

We consider the case when the ferm ion elds carry an additional,  $\langle \text{avor", index i} = 1;2;:::;N_f$ . Then, the sym metry of the lagrangian (8) is U (2N<sub>f</sub>). Adding a bare quasiparticle gap (mass) term  $_{\text{br}}$  into the lagrangian density (8) would reduce the U (2N<sub>f</sub>) sym metry down to the U (N<sub>f</sub>) U (N<sub>f</sub>). Therefore the dynam ical generation of the gap would lead to the spontaneous breakdown of the U (2N<sub>f</sub>) down to the U (N<sub>f</sub>).

P roceeding as in Ref. [7], we integrate out the bulk gauge bosons from the action. Then, up to relativistic corrections of order  $(v_F = c)^2$ , we are left with the following action of interacting planar quasiparticles:

where the bare potential U  $_0$  (t;  $j_2$ ) takes the following sim – ple form :

Note, however, that the polarization e ects may considerably modify this bare C oulom b potential. Thus, after taking this into account, the interaction is given by

where the polarization function (!;jk) is proportional (with a factor of  $2 = "_0$ ) to the time component of the photon polarization tensor.

The starting point in our derivation of the elective potential for the composite eld is the gap equation in a model with a nonzero constant external source J [see Eq. (1)]. By noticing that the external source term J enters the action in exactly the sam e way as the quasiparticle bare m ass term, we easily derive the corresponding gap equation [7],

where the approximate expression for the kernel K (p;q) is given by K (p;q) = (p q)=p+ (q p)=q: In the most important region of momenta jqj  $_q=v_F$  where the pairing dynamics dominates, the only role of the term ( $_q=v_F$ )<sup>2</sup> in the denominator of the integrand on the right-hand side of Eq.(12) is to provide a cuto in the

infrared region. Therefore, one can drop this term , instead introducing the explicit infrared cuto  $=v_F$  in the integral, where the gap is de ned from the condition

 $_{q=~=v_{\rm F}}$  . This is the essence of the so called bifurcation approximation. As a result, we arrive at the following equation:

where ' =a is the ultraviolet cuto (a is a lattice size). The last integral equation is equivalent to the di erential equation,

with appropriate boundary conditions. A non-trivial solution to the gap equation, satisfying the infrared boundary condition,

exists only for 1=4, and it takes the following form :

where =  $\sqrt[P]{4}$  1 and = arctan . The critical value  $_{\rm c}$  = 1=4 corresponds to a continuous quantum phase transition.

In addition, the ultraviolet boundary condition,

produces the relation:

This relation determ ines J as a function of the gap  $\cdot$  If one supplies it with a similar representation for the com – posite eld (), expression (6) could be used directly to derive the elective potential,

As follows from the de nition, the expression for as a function of is given by the trace of the quasiparticle propagator (multiplied by the factor i). Thus,

Note that the second line of this equation follows from Eq. (12) after di erentiating its both sides with respect to momentum p and substituting p = .

In order to get the most convenient representation for the potential, we introduce a new parameter  $_0$  which denotes the dynamical gap in the case of a vanishing external source. It is determined from Eq. (18) at J = 0:

Therefore the critical coupling  $_{\rm c}$  = 1=4 corresponds to a continuous phase transition of in nite order.

By making use of the last equation, we obtain a rather convenient representation of the functions J() and ():

F inally, by substituting these into Eq. (19) and perform – ing the integration on the right hand side, we arrive at the following parametric form of the elective potential:

A round the globalm inimum,  $_0 = (_0)$ , the potential is approximated as




FIG .1: The schematic fractal structure of the e ective potential V ( ) that appears as the consequence of the long range interaction .

This expression may suggest that there is nothing unusual about the potential given by the parametric representation in Eqs. (24) and (25). A closer look, how ever, reveals a rather rich, fractal, structure of V () with in nite num ber of branches near the origin = 0 (see Fig. 1 and discussion below).

The extrem a of the potential V () are determined by the equation dV=d = J() = 0. By solving this equation, we obtain an in nite set of solutions for :

The corresponding values of  $\binom{(n)}{\min}$  are determined by Eq. (25). It is easy to check that the second derivative of the potential calculated at every extrem al point in Eq. (27) is positive,  $d^2V = d^2 > 0$ . Therefore, these extrem a are localminima. The values of the potential at these minima  $\binom{(n)}{\min}$  are calculated to be

We see that the solution with n = 0 gives the largest value of the ferm ion gap and the low est value of the potential. Therefore, it corresponds to the globalm in im um of V (), or in other words, to the most stable (ground) state in the model at hand.

It is natural to expect that the potential also has m axim a lying between those m inim a. However, the situation is m ore subtle: while, as a function of parameter , the potential does have m axim a, it does not have them as a function of . Instead, the potential V () has turning points there, see Fig.1. Indeed, the rst derivative of the potential (24) with respect to the parameter is zero at the following m axim a:

(with n = 0;1;:::). At the same time, the nst derivative of -eld with respect to is also zero at these points. As a result, the derivative of the potential with respect to , i.e.,  $dV = d = \frac{dV}{d} = \frac{d}{d}$ , is nonzero there.

From our analysis, we see that the potential V (), dened parametrically in Eqs. (24) and (25), is a multibranched and multi-valued function of . The location of the branching (turning) points are determined by the values of the gap parameter given in Eq. (29). Each branch of the e ective potential has a local minimum at  $= {n \choose min}$ . We also notice that, while the locations of the branching points converge to = 0 in the limit n ! 1, the shape of all higher branches (after an overall scaling transform ation) resembles the shape of the rst branch. Therefore, the potential around the origin exhibits a fractal structure. This is shown schem atically in Fig.1.

Wewill now demonstrate that the fractal structure of the potential re ects a rich spectrum of excitonic com posites in this model. It is well known (see, for example, Ref. [10]) that, because of the W and identities for currents connected with spontaneously broken symmetries, the gap equation coincides with the Bethe-Salpeter equation for corresponding gapless N am bu-G oldstone com posites (gapless excitons in the present case). Therefore, the innite number of the solutions  $m_{min}^{(n)}$  in Eq. (27) for the gap in plies that there are gapless excitons in each of the vacua corresponding to di erent values of n. The genuine, stable, vacuum is of course that with n = 0. Let us show that the excitonic composites, which are gapless in the false vacua with n > 0, become gapped in the genuine vacuum with n = 0. Indeed, the transition from a false vacuum (with n > 0) to the genuine one corresponds to (n) min ! (0) increasing the ferm ion gap, o, withm in out changing the dynam ics. Therefore, as a result of this increase of the gap of their constituents, these excitonic com posites should becom e gapped. Thus we conclude that the fractal structure of the potential re ects the presence of an in nite tower of gapped excitons that are radial excitations of the gapless N am bu-G oldstone com posites. It is clear that this e ect is intim ately connected with the long-range interactions in this model.

A con mation of this point comes from studying the elective potential at nite temperature T and/or chem – ical potential . Because of the D ebye screening, both T and lead to a dynamical infrared cuto for interactions. Our studies show that the (dis-)appearance of the higher order branches is very sensitive to the values of temperature and the chemical potential. In particular, all branches with n > n\_0 disappear at a temperature in the region  $\frac{1}{2} \frac{(n_0+1)}{m \ln} < T < \frac{1}{2} \frac{(n_0)}{m \ln}$ , or at a chemical potential in the region  $\frac{1}{2} \frac{(n_0+1)}{m \ln} < T < \frac{1}{2} \frac{(n_0)}{m \ln}$ , or at a chemical potential in the region The process of the process of the process of the set of the process of the set of the process.

It is also clear that this picture should be quite general and valid for a wide class of models with long-range interactions. In particular, we have found that a sim ilar fractal structure takes place in the elective action of  $Q \ge D_{2+1}$  relevant for cuprates.
