# Fractal structure of the ective action in (quasi-) planar models with long-range interactions

#### Abstract

W e derive the ective potential for com posite elds in a class of (quasi-) planarm odels w ith longrange interactions. This class of $m$ odels can be relevant for high tem perature superconductors and graphite. The fractal structure of the e ective potential is revealed and its physical interpretation is presented. It is argued that the m ulti-branched fractal structure of the potential re ects the presence of an in nite tow er of excitonic bound states that occur as a result of the long-range interactions.

For a long tim e, there has been a great interest in low dim ensional quantum eld theories. Typical exam ples are the $1+1$ dim ensional $G$ ross -N eveu m odel and the $2+1$ dim ensional quantum electrodynam ics ( $\mathrm{EED}_{2+1}$ ). They have been used as very instructive toy models of relativistic system $s w$ ith com plicated dynam ics. In addition to that, it is quite rem arkable that these sam em odels $m$ im ic som e intrinsic properties of the dynam ics of non $F e r m$ i liquids. In particular, num erous recent studies suggest that high $-T_{c}$ superconductors and graphite could be described well by a (quasi-) planar QED $2+1$


The di culties in studying strongly correlated system s such as high $-T_{c}$ superconductors and graphite $m$ ight be related in part to the presence of long range C oulom b like interactions betw een quasiparticles. This lim its considerably the use ofm any powerful techniques that used to work well in m odels $w$ th short-range interactions. O ne of such tools is the celebrated G inzburg-Landau (G L) effective action. A $m$ ethod of the derivation of the $G L$ action for com posite operators in system $s w$ th short-range interactions has been known since the work of $G$ orkov [8] ${ }^{1}$ ]. Its generalization to system s w ith a spontaneous sym em try breaking driven by long-range interactions is far from being straightforw ard. In relativistic eld theories, a $m$ ethod of the derivation of the e ective action in $m$ odels $w$ ith long-range interactions (driven by gauge elds) w as elaborated in Ref. [1, ${ }_{1}^{\prime}$.
Recently, using the $m$ ethod of Ref. $[\underline{1}[1]$, the e ective potential has been derived in the so-called reduced Q ED $[\bar{T}]$. In such a m odel, while quasiparticles are con ned to a 2-dim ensionalplane, the electrom agnetic interaction betw een them is three dim ensional in nature. Them odel is relevant for a class of condensed $m$ atter system $s$ that include highly oriented pyrolytic graphite am ong others
 of the e ective potential in reduced Q ED , not considered in Ref. $\bar{T}]$. It w illbe show $n$ that the potential has a m ultibranched fractal structure re ecting the presence of an in nite tow er of excitonic bound states (a clear signature
of long-range interactions). It is also im portant that, as was shown in Ref. $[\underline{1} 1]$, reduced QED is intim ately con-
 fact, as will be discussed below, the qualitative features of the e ective potential in reduced QED are com $m$ on for $a \mathrm{w}$ ide class of m odels w th long-range interactions, in particular, for $Q E D_{2+1}$.
$W$ e start from a general de nition of the e ective action in a theory in which the spontaneous sym $m$ etry breaking phenom enon is driven by the local com posite order param eter h0j j0i, where is the D irac spinor of the quasiparticle eld and is the (D irac) conjugate spinor. Follow ing the conventional way (see for exam ple Ref. $[1][])$, we introduœ the generating functional $W$ ( $J$ ) for the $G$ reen functions of the corresponding com posite eld through the path integral:

where $J(x)$ is the source for com posite eld and $L_{q p}(x)$ is the lagrangian density of quasiparticles in the m odel at hand. Then, by de nition, the e ective action for the eld (x) h0j (x)j0i is given by the Legendre transform of the generating functionalW (J),

where the extemal source $J(x)$ on the right hand side is expressed in term $s$ of the eld (x) by inverting the relation

The e ective action ( ) in Eq. (2) provides a natural fram ew ork for describing the low energy dynam ics in the m odel at hand. It is com m on to expand this action in
powers of space-tim e derivatives of the eld :

where V ( ) is the efective potential. The ellipsis denote higher derivative term $s$ as well as contributions of the N am bu-G oldstone bosons if the latter are required by the G oldstone theorem. By making use the de nition in Eqs. ( $\overline{2})$ and $(\underline{3})$, we derive the follow ing relation:

In the lim it of a vanishing extemal source, this equation tums into an equation ofm otion for the com posite eld
$(x)$. In a particular case of constant con gurations, the equation reads $d V=d=0$.

By keeping the extemal source on the right hand side of Eq. (5) nonzero but constant in space-tim e, we derive the follow ing convenient representation for the e ective potential:

where w (J) $\quad W(J)=V_{2+1}$, and $V_{2+1}$ is the space-tim e volum e. Thus, the crucial point for evaluating $V$ is how the source $J$, playing here the role of the bare ferm ion gap, depends on the com posite eld. It will be shown below, follow ing the approach of $R$ ef. $\left[\frac{[10}{9}\right]$, that the function $J()$ can be determ ined from a modi ed gap equation, including the bare gap $J$.

The model under consideration is the same as the m odelused in Ref. [ $\overline{6}, \overline{1}, \overline{1}$,$] to study a m etal-insulator phase$ transition in highly oriented pyrolytic graphite. W e as sum e that the ferm ionic quasiparticles are con ned to a
at 2-dim ensional plane, while the electrom agnetic eld is free to propagate in the 3 -dim ensionalbulk. T he spatial coordinates on a plane are denoted by $x=(x ; y)$ and the orthogonaldirection is labeled by the $z$ coordinate.
$T$ he lagrangian density of the electrom agnetic eld (in the bulk) is given by

where " 0 is the dielectric constant, 0 is them agnetic per$m$ eability, $A_{0}$ and $\AA$ are the scalar and vector potentials, and electric and $m$ agnetic elds are $E=\widetilde{r} A_{0} \quad \frac{1}{c} @_{t} \mathbb{A}$, $\mathrm{B}=\tilde{\mathrm{r}} \quad \mathbb{A} . \mathrm{W}$ e note that the interaction term s , w th the quasiparticle charge density and current $\tilde{y}$, w ere explicitly included in the lagrangian density in Eq. ( $\bar{I}_{1}$ ). In addition to that, the lagrangian density of quasiparticles them selves (living only on the plane) should be speci ed. It reads

where $\mathrm{v}_{\mathrm{F}}$ is the Ferm i velocity, ( $\mathrm{t} \boldsymbol{;} \boldsymbol{x}$ ) is a 4-com ponent spinor, $=y 0$, and the 44 D irac m atrices fumish a reducible representation of the $C$ li ord (D irac) algebra in $2+1$ dim ensions.

W e consider the case when the ferm ion elds carry an additional, \avor", index $i=1 ; 2 ;::: ; \mathrm{N}_{\mathrm{f}}$. Then, the sym $m$ etry of the lagrangian ( $\mathbf{8}_{1}^{\prime}$ ) is $U\left(2 \mathrm{~N}_{\mathrm{f}}\right)$. A dding a bare quasiparticle gap ( $m$ ass) term br into the lagrangian density ( $\bar{l}_{1}^{-1}$ ) w ould reduce the $U\left(2 \mathrm{~N}_{\mathrm{f}}\right)$ sym $m$ etry dow $n$ to the $U\left(\mathbb{N}_{f}\right) \quad U\left(\mathbb{N}_{f}\right)$. Therefore the dynam icalgeneration of the gap would lead to the spontaneous breakdown of the $U\left(2 N_{f}\right)$ down to the $U_{-}\left(\mathbb{N}_{f}\right) \quad U\left(\mathbb{N}_{f}\right)$.

P roceeding as in Ref. $\left[\bar{p}_{1}\right]$, we integrate out the bulk gauge bosons from the action. Then, up to relativistic corrections of order $\left(\mathrm{v}_{\mathrm{F}}=\mathrm{C}\right)^{2}$, we are left w ith the follow ing action of interacting planar quasiparticles:

$N$ ote, how ever, that the polarization e ects $m$ ay considerably m odify this bare C oulom b potential. Thus, after taking this into account, the interaction is given by
where the polarization function (! ; $j \widetilde{k})$ is proportional ( w th a factor of $2={ }^{\prime} 0$ ) to the tim e com ponent of the photon polarization tensor.

The starting point in our derivation of the e ective potential for the com posite eld is the gap equation in a m odel w th a nonzero constant extemal source $J$ [see Eq. ( $\left.\left.\underline{1}^{1}\right)\right]$. By noticing that the extemal source term $J$ enters the action in exactly the sam ew ay as the quasiparticle bare $m$ ass term, we easily derive the corresponding gap equation $\overline{7}]$,

infrared region. Therefore, one can drop this term, instead introducing the explicit infrared cuto $=V_{F}$ in the integral, where the gap is de ned from the condition
$\mathrm{q}==\mathrm{v}_{\mathrm{F}}$. This is the essence of the so called bifurcation approxim ation. As a result, we arrive at the follow ing equation:

$N$ ote that the second line of this equation follow $s$ from Eq. (12) after di erentiating its both sides $w$ ith respect to m om entum p and substituting $\mathrm{p}=$.

In order to get the $m$ ost convenient representation for the potential, we introduce a new param eter 0 which denotes the dynam ical gap in the case of a vanishing extemal source. It is determ ined from Eq. (18) at $J=0$ :

This expression $m$ ay suggest that there is nothing unusual about the potential given by the param etric representation in Eqs. (24) and (2-1). A closer look, how ever, reveals a rather rich, fractal, structure ofV ( ) w ith in nite num ber of branches near the origin $=0$ (see Fig. $\underline{I}_{1}^{\prime 1}$ and discussion below ).

The extrem a of the potential $V()$ are determ ined by the equation $d V=d=J()=0$. By solving this equation, we obtain an in nite set of solutions for :

The corresponding values of $\binom{(n)}{m$ in } are determ ined by Eq. (25). It is easy to check that the second derivative of the potential calculated at every extrem al point in Eq. $\left.{ }^{2} 2_{1}\right]_{1}$ is positive, $d^{2} V=d^{2}>0$. Therefore, these extrem a are localm inim a. The values of the potential at these $m$ inim a $\binom{(n)}{m$ in } are calculated to be

W e see that the solution w ith $\mathrm{n}=0$ gives the largest value of the ferm ion gap and the low est value of the potential. $T$ herefore, it corresponds to the globalm inim um ofV ( ), or in other words, to the m ost stable (ground) state in the $m$ odel at hand.

It is natural to expect that the potentialalso hasm axin a lying betw een those minim a. H ow ever, the situation is $m$ ore subtle: while, as a function of param eter, the potential does have $m$ axim a, it does not have them as a function of . Instead, the potentialV ( ) has tuming points there, see Fig. ${ }^{-111} 1$. Indeed, the rst derivative of the potential (24) w ith respect to the param eter is zero at the follow ing $m$ axim a:

( w th $\mathrm{n}=0 ; 1 ;:::$ ). A the sam e time, the nst derivative of - eld w th respect to is also zero at these points. A s a result, the derivative of the potential $w$ ith respect to , i.e., $d V=d \quad \frac{d V}{d}=\frac{d}{d}$, is nonzero there.

From our analysis, we see that the potentialV ( ), dened param etrically in Eqs. (2 $2 \overline{4}_{-}^{\prime}$ ) and ( $2 \overline{5} \overline{5}_{1}^{\prime}$ ), is a multibranched and multi-valued function of . The location of the branching (tuming) points are determ ined by the values of the gap param eter given in Eq. ( $2 \mathbf{2}_{1}^{\prime}$ ). Each
branch of the e ective potential has a localm inim um at
$=\quad \quad \begin{aligned} & (n) \\ & m\end{aligned}$ in.$W$ e also notioe that, while the locations of the branching points converge to $=0$ in the lim it $\mathrm{n}!1$, the shape of allhigher branches (after an overall scaling transform ation) resembles the shape of the rst branch. Therefore, the potential around the origin exhibits a fractal structure. $T$ his is show $n$ schem atically in Fig. ${ }^{17} 11$.

W ew ill now dem onstrate that the fractal structure of the potential re ects a rich spectrum of excitonic com posites in this m odel. It is well known (see, for exam ple, Ref. $[1-101])$ that, because of the $W$ ard identities for currents connected with spontaneously broken symmetries, the gap equation coincides $w$ th the $B$ ethe-Salpeter equation for corresponding gapless N am bu-G oldstone com posites (gapless excitons in the present case). Therefore, the innite num ber of the solutions ${ }_{\mathrm{m}}^{\mathrm{m})}$ in in Eq. $\left[2 \bar{z}_{1}\right)$ for the gap im plies that there are gapless excitons in each of the vacua corresponding to di erent values of $n$. The genuine, stable, vacuum is of course that w ith $\mathrm{n}=0$. Let us show that the excitonic com posites, which are gapless in the false vacua $w$ th $n>0$, becom egapped in the genuine vacuum w th $\mathrm{n}=0$. Indeed, the transition from a false vacuum ( $w$ ith $n>0$ ) to the genuine one corresponds to increasing the ferm ion gap, $\mathrm{m}_{\mathrm{m}}^{\mathrm{m}}$ in ! $\mathrm{m}_{\mathrm{m}}^{(0)} 0$ in without changing the dynam ics. T herefore, as a result of this increase of the gap of their constituents, these excitonic com posites should becom e gapped. Thus we conchude that the fractal structure of the potential re ects the presence of an in nite tow er of gapped excitons that are radial excitations of the gapless $N$ am bu- G oldstone com posites. It is clear that this e ect is intim ately connected w th the long-range interactions in this m odel.

A con $m$ ation of this point com es from studying the e ective potential at nite tem perature $T$ and/or chem ical potential . Because of the Debye screening, both $T$ and lead to a dynam ical infrared cuto for interactions. Our studies show that the (dis-)appearance of the higher order branches is very sensitive to the values of tem perature and the chem ical potential. In particular, allbranches $w$ ith $n>n_{0}$ disappear at a tem perature in the region $\frac{1}{2} \underset{\mathrm{~m} \text { in }}{\left(\mathrm{n}_{0}+1\right)}<\underset{p_{-}}{T}<\frac{1}{2} \underset{\mathrm{~m}}{\left(\mathrm{n}_{0}\right)}$ in , or at a chem ical potential in the region $\mathrm{P}_{\overline{2}}^{\underset{m \text { in }}{\left(\mathrm{n}_{0}+1\right)}}<\mathrm{P}_{\overline{2}}^{\underset{m}{\left(n_{0}\right)}} \underset{\mathrm{m} \text { in }}{(\mathrm{m}}$. $T$ his observation re ects the process of $\backslash m$ elting" ofthose bound states whose binding energy is of order $T$ (or ) or less.

It is also clear that this picture should be quite general and valid for a w ide class ofm odels w ith long-range interactions. In particular, we have found that a sim ilar fractal structure takes place in the e ective action of QED ${ }_{2+1}$ relevant for cuprates.
