## Bloch oscillations in Fermigases

The possibility of Bloch oscillations for a degenerate and super uid Ferm i gas of atoms in an optical lattice is considered. For a one-component degenerate gas the oscillations are suppressed for high temperatures and band llings. For a two-component gas, Landau criterion is used for specifying the regime where Bloch oscillations of the super uid may be observed. We show how the amplitude of Bloch oscillations varies along the BCS-BEC crossover.

The experimental realization of optical lattices for bosonic atoms has led to several landmark experiments [1, 2, 3]. Very recently similar potentials have become available for trapping the fermionic isotopes as well [4, 5]. An increase in the super uid transition temperature when using potentials created by standing light waves has been predicted [6]. For trapped cold atoms, the famous BCS-BEC crossover problem [7, 8] could be studied by tuning the interaction strength between the atom susing Feshbach resonances [5, 9]. In optical lattices the whole BCS-BEC crossover could be scanned experimentally also in an even simpler way by modulating the light intensity. We consider Bloch oscillations in these systems and show that they can be used as a tool for studying the crossover.

B loch oscillations are a pure quantum phenom enon occurring in a periodic potential. They have never been observed in a natural lattice for electrons as predicted in [10] because the scattering time of the electrons by lattice defects or in purities is much shorter than the B loch period. However, B loch oscillations have recently been observed in semiconductor superlattices [11], for quasiparticles penetrating the cores of a vortex lattice in a cuprate superconductor [12], and for periodic optical systems such as waveguide arrays [13]. A lso cold bosonic atoms and super uids in optical lattices have been shown to be clean and controllable systems well suited for the observation of B loch oscillations [2, 3].

Several novel aspects of the physics of Bloch oscillations arise for ferm ionic atoms in optical lattices. i) Impurity scattering can be made negligible, and the particle number controlled at will to produce any band lling. Even when Bloch oscillations were originally proposed for fermions, the elect of the Fermisea has not played a major role. Due to impurity and defect scattering, the studies of transport in presence of a constant force have focused on drift velocities rather than oscillations. In this letter we generalize the semiclassical single particle description of Bloch oscillations to arbitrary band llings. ii) The possibility of an oscillating fermionic super uid becomes relevant. We derive the Landau criterion for

the optical lattice imposing the Cooper pair size to be of the order or smaller than the lattice spacing. For solid state systems, the Cooper pair radius is usually much larger than the lattice spacing and periodicity irrelevant for the super uid, therefore the system is treated as homogeneous when calculating supercurrents. We calculate the super uid velocity in the periodic potential and show that pairing, leading to smoothening of the Fermiedge, suppresses Bloch oscillations.

Using six counter-propagating laser beams of wavelength , an isotropic 3D simple cubic lattice potential can be created which is of the form  $\frac{1}{2} \int_{-\infty}^{\infty} \frac{dx}{dx} \, dx = 0$

where  $V_0$  is proportional to the laser intensity and a = =2. With the Bloch ansatz the Schrodinger equation leads to a band structure in the energy spectrum  $"_n$  (k). O ne-com ponent degenerate Fermigas at low tem peratures can be considered as non-interacting since pwave scattering is negligible and s-wave scattering suppressed by Ferm i statistics. We are interested in high enough values of  $V_0$  such that tunneling is small and tight binding approximation can be applied. The dispersion relation for the lowest band becomes "(k) =  $cos(k_x a)$  $cos(k_ya)$   $cos(k_za)$ ], where the band width  $J = \frac{2}{E_R} E_R = \frac{V_0}{E_R} \exp$ is obtained using the W KB-approximation and  $E_R$  is the recoilenergy of the lattice [6].

interactions [14]. We de ne the lim its of the one-band approximation for the physical potential Eq.(1) by dem anding the lowest band gap to be bigger than the e ective interaction U (note that U > jgj for the param eters of interest). The band gap can be estimated by approxim ating the cosine potential well by a quadratic one. Dem anding the corresponding harm onic oscillator energy to be greater than U gives the condition  $\frac{V_0}{E_B} < \frac{1}{4^{-2}}$   $\frac{a}{a_s i}$ Since a > jas jim posed by considering on-site interactions only, the condition is easily valid in general, and for the param eters of Fig. 2 in particular. Estimates made using exact num erical band gaps in 1D support this argum ent. O ne-band approximation is su cient because larger Vo m eans steeper optical potential wells which not only increase the e ective interaction U but also the band gaps.

B loch oscillations for a single atom can be characterized considering the mean velocity of a particle in a B loch state  $v(n;k) = hn;k \dot{r}; \dot{n}; k i given by$

When a particle in the Bloch state  $n;k_0i$  is adiabatically a ected by a constant external force  $F=F_x\hat{x}$  weak enough not to induce interband transitions, it evolves up to a phase factor into the state n;k (t) i according to  $k(t)=k_0+\frac{Fta}{h}$ . The time evolution has a period  $B=h=(F_x;a)$ , corresponding to the time required for the quasim omentum to scan the whole Brillouin zone. If the force is applied adiabatically, it provides momentum to the system but not energy because the elective mass (given by m (")  $\frac{1}{h^2} = \frac{1}{h^2} \frac{e^2}{\theta k^2}$ ) is not always positive. For optical lattices the force (or tilt: V=F return in the Ham iltonian) can be realized by accelerating the lattice [2, 3]. Using the tight-binding dispersion relation the velocity of an atom oscillates like

For cold bosonic atoms and condensates [2, 3] nearly all of the population is in the lowest mode of the optical potential, Eq.(3) therefore describes the oscillation of the whole gas. We generalize the result for the case when many momentum states of the band (at T=0, the states with wave vector k  $k_F$ ) are occupied. We calculate the velocity of the whole gas as the average over the normalized temperature-dependent distribution function (the Fermi distribution f) of the particles:




FIG. 1: The average velocity in  $\frac{Ja}{h}$  units as a function of time for a half led band. The plotted lines correspond to atom s in the normal state at dierent temperatures T=J, 0:5J and 0:1J. Bigger amplitudes correspond to lower temperatures.

U sing the tight-binding dispersion relation for the B loch energies we obtain the oscillations shown in Fig. 1. At

T = 0, Eq.(4) reduces to

This shows that macroscopic coherent oscillation e ect can still be observed if the band is not full, but the am plitude is suppressed by the band  $\,$  lling  $k_{xF}$  a. The e  $\,$  ect of the tem perature can be seen in Fig. 1: the amplitude starts to decrease at tem peratures of the order T but is still non-negligible at half J. These results are valid for the one-com ponent degenerate Ferm igas at low tem peratures. In the two-component Fermigas, atoms in the dierent hyper ne states interact with each other which may lead to a super uid state. Above Tc, weak interactions can be described by a mean eld shift in the chem ical potential, leading to no qualitative changes in Bloch oscillations. Inelastic scattering and consequent dam ping of B loch oscillations can be described e.g. by balance equations [15]. In the following we consider the super uid case where qualitative changes are expected.

In order to observe B loch oscillations of the super uid Ferm i gas, the critical velocity of the super uid should not be reached before the edge of the B rillouin zone. A BCS-superconductor can carry a persistent current quntil a critical velocity,  $v_c=\frac{1}{p_F}$ . For higher current values, even at T=0, it m ight be energetically favorable to break Cooper pairs and create a pair of quasiparticles [16]. This costs 2 in binding energy and decreases the B loch energy by  $j_{k+q}$   $_{k-q}$  j  $2 \not\!\!E_D$  j. Therefore, for the current to be stable  $\not\!\!E_D$  j < . This is the Landau criterion of super uidity. For a tight binding lattice dispersion relation, we rewrite the condition as J sin (qa) sin  $k_F$  a < . To complete a B loch oscillation, sin (qa) should achieve its maximum value 1, i.e.




FIG. 2: The transition temperature, Landau criterion at T=0 and the amplitude of the velocity B loch oscillations for  $^6\mathrm{L\,i}$  atoms in hyper ne states with scattering length  $a_s=2.5\,$   $100_0$  for a half led 3D CO $_2$  laser lattice (a =  $10^5\,a_0$ ) as a function of the lattice depth. The amplitudes of the oscillations at  $T=2.3T_{\rm c}^{\rm m~ax}$  (horizontal line) are denoted by for the normal state oscillations, for the super uid velocity at T=0 Eq.(12) and in the boson limit Eq.(13) pair size l=a=3 by and + for pair size l=a=4. The Landau criterion condition Eq.(6) requires =J > 1 for the half led band. Here  $E_R$  is the recoil energy and  $E_F^f$  is the Ferm i energy for free ferm ions with the same density.

For weak coupling, =J is given by the BCS theory, and in the attractive Hubbard model in the strong coupling

lim it the gap at T = 0 is given by =  $\frac{U}{2}$  for half lling [14]. U sing these estim ates, we show in Fig.2 the relation (6) for a gas of  $^6\mathrm{L\,i}$  atoms together with the transition temperature. To relate the criterion to the Cooper pair size, we rewrite Eq.(6) in terms of the BCS coherence length  $_0 = \frac{h v_F}{}$  and insert J sin ( $k_F$  a) =  $h v_F$  =a which yields  $_0 <$  a= . The observation of B loch oscillations is thus restricted to super uids with BCS coherence length smaller than the lattice periodicity. This is the intermediate { strong coupling regime. The length argument can be also understood by thinking that the pairs have to be smaller than the lattice sites in order to see it as a periodic potential.

For calculating the super uid velocity a space dependent description of the super uid has to be used. We combine the BCS ansatz with the Bloch ansatz for the lattice potential using the Bogoliubov { de Gennes (BdG) equations [17]. As given by the Landau criterion above, the interesting regime is the intermediate { strong coupling one. Note that even in the strong-coupling limit, the algebra of the BCS theory can be applied to all coupling strengths [8, 18] together with an extra denition for the chemical potential which in the weak coupling limit is given just by the Fermienergy of the non-interacting gas. The BdG equations are:

When the external potential is periodic one can use the Bloch ansatz for u and v because by self-consistency the Hartree and pairing elds are also periodic. We obtain

where k are the Bloch enveloping functions, such that  $[H(r)] k e^{ik} = k k e^{ik}$ .

To describe B loch oscillations we im pose the adiabatic condition, that is, m omenta evolve according to k! k+F ta=h k+q, i.e. we consider BCS state with a drift (again only in x-direction). The solutions of the BdG equations take the form

solutions for which  $E_k^{+q} > 0$ , i.e. m in  $(E_A^2 + j q^2) = j^q j > E_D$ . Rem arkably, this condition is the same as obtained using the Landau criterion.

In the BCS ansatz, a common momentum g can be added to all particles, leading to correlations of the type  $h_{k+q}^{y} c_{k+q}^{y}$  i. The super uid net momentum becom es 2q.0 ne can form ally calculate this obvious result also by using the plane wave ansatz  $u_k = ju_k \dot{p}^{i(k+q)} r$ ,  $v_k = jv_k j e^{i(k+q) r}$  [17] (Eq.(10) with = 1) and introducing an (unnormalized) order parameter wave function  $q(r) = e^{i2q} C$ , where C is given by Eq.(10) to be a constant in r. Expectation values like momentum (p = iQ=Qr) can be calculated: hpi = h q (r) j  $i@=@rj^q(r)i=h^q(r)j^q(r)i=2q.$  The order parameter wave function is de ned in the spirit of (but not with a one-to-one correspondence to) the G inzburg-Landau theory with a space dependent wave function whose absolute value equals the gap. In case of Ferm ionic atom s the G inzburg-Landau approach has been used to describe harm onic con nem ent [19] and vortices [20]. For the periodic potential we introduce the order parameter wave function in the form  $j^q(r)i = \frac{1}{k} j^q(r)i$ , where using

The super uid velocity for selected parameters is shown in Fig. 2. We have also calculated the thermal quasiparticle contribution but is turns out to be negligible.

In the composite boson lim it, one could describe the center-of-m ass movement of the composite particle by de ning J = J(m ! 2m). In order to give a simple estim ate for the e ect of the Ferm i statistics, we interpret  $f(k;q)^{\frac{2}{3}}$   $f(k)^{\frac{2}{3}}$  in Eq.(12) as rejecting the internal wavefunction of the pair in the composite boson lim it, c.f. [7, 8]. The average velocity for the bosons becomes  $hv_{xB}i / \frac{J-a}{h} \sin qa^{-1} + f(k)j^2 \cos k_x a$ . If the pairs were extremely strongly bound, the internal wave function in real space is a delta-function, corresponding to a constant in k-space. This means  $hv_B i = 0$  since the cosine integration in Eq.(12) would extend to the whole k-space with equal weight, i.e. there are no empty states in the Brillouin zone as required for Bloch oscillations. For on-site pairs, we use  $f(r)^{\frac{2}{3}} / \exp(r^2=l^2)$ leading to  $f(k)^{\frac{2}{3}}$  / N exp (  $1^2k^2=4$ ), therefore the suppression factor for the Bloch oscillations becomes S N dk exp ( $1^2k^2=4$ ) coska, where 1 is the pair size. As a rough estim ate for the average velocity we thus obtain

This is shown in Fig. 2 for pair sizes l=a=3 and l=a=4. It gives an order-of-magnitude estimate, approaching the results given by the BCS algebra.

A nother way of treating the composite boson lim it is to derive a G ross-P itaevskiitype of equation for the com posite bosons with M = 2m and with a repulsive nonlinear interaction term  $n_B U_B = n_B 4 h^2 a_B = M$  ,  $a_B = 2a_S$ where  $a_s$  is the renormalized s-wave scattering length [21]. If the non-linear term is small compared to the Bloch energy  $E_B = h^2 = (M a^2)$ , the nonlinearity leads only to a change in the band width J [3]. Therefore, com posite bosons oscillate but with a modied amplitude. Large non-linearity would not allow Bloch oscillations, corresponding to a large suppression factor in the above discussion. Note that the Landau criterion for a superuid Bose gas gives the critical velocity  $v_{sound} =$ which is orders of magnitude bigger than Eq.(13) for half lling and parameters in Fig. 2. Problems arise only in the extrem ely em pty lattice lim it.

In sum m ary, we have de ned a set of tools for qualitative and quantitative description of B loch oscillations for the BCS-BEC crossover regime. The amplitude of

the oscillations decreases when the crossover is scanned, in general due to the shrinking of the bandwidth. However, the change from the normal to the super uid state description leads to a drastic change in the amplitude. This is due to smoothening of the Ferm i-edge by pairing. Bloch oscillations could be used for exploring pairing correlations since any localization in space (pair size) leads to broadening in momentum which suppresses the amplitude in the same way as band lling in the noninteracting gas. A chievem ent of super uidity is still a great challenge, but even at  $T >> T_c$ , the e ect of collisions on Bloch oscillations can be studied producing information useful for applications of Bloch oscillations such as production of Terahertz radiation [15, 22]. Observation of oscillating ferm ionic atom s in optical lattices would contribute to the quest for a steadily driven ferm ionic B loch oscillator.
