D ispersion m anagem ent for atom ic m atter w aves

W e dem onstrate the control of the dispersion of m atter wave packets utilizing periodic potentials. This is analogous to the technique of dispersion m anagem ent known in photon optics. M atter wave packets are realized by B ose-E instein condensates of ⁸⁷Rb in an optical dipole potential acting as a one-dim ensional waveguide. A weak optical lattice is used to control the dispersion relation of the m atter waves during the propagation of the wave packets. The dynam ics are observed in position space and interpreted using the concept of e ective m ass. By switching from positive to negative e ective m ass, the dynam ics can be reversed. The breakdown of the approxim ation of constant, as well as experimental signatures of an in nite e ective m ass are studied.

The broadening of particle wave packets due to the free space dispersion is one of the most prominent quantum phenomena cited in almost every textbook of quantum mechanics. The realization of Bose-E instein condensates of dilute gases allows for the direct observation of wave packet dynamics in real space on a macroscopic scale [1]. U sing periodic potentials it becomes feasible to experimentally study to what extent the matter wave dispersion relation can be engineered. This approach is similar to dispersion management for light pulses in spatially periodic refractive index structures [2].

First experiments in this direction have already been undertaken in the context of B loch oscillations of therm al atom s [3] and condensates [4]. The modi cation of the dipole mode oscillation frequency of a condensate due to the changed dispersion relation in the presence of a periodic potential has been studied in detail [5, 6]. In contrast to these experiments where the center of mass motion was studied, we are investigating the evolution of the spatial distribution of the atom ic cloud in a quasi. one-dimensional situation. For the wave packet dynam ics many new e ects are expected due to the interplay between nonlinearity resulting from atom -atom interaction and dispersion. In particular, non-spreading wave packets such as gap solitons [7] and self trapped states [8] are predicted. Our experim ents show that even propagation in the linear regime with modi ed dispersion can change the shape of an initially Gaussian wave packet signi cantly.




FIG.1: Controlling the dispersion of an atom ic wave packet in a waveguide using a periodic potential. Shown are absorption in ages of the wave packet averaged over four realizations (left) and the corresponding density distributions n (x;t) along the waveguide (right). (a) Initial wave packet. (b,c) Im ages taken after an overall propagation time of t = 26 m s for different dispersion regimes with di erent e ective m asses as indicated. (d) W ave packet subjected to dispersion m anagement: an initial stage of expansion for t = 17 m s with norm al dispersion is followed by propagation with anom alous dispersion for t = 9 m s. The broadening in the norm al dispersion.

For atom icm atterwaves inside a one-dimensional opticalwaveguide, we have achieved dispersion management by applying a weak periodic potential with adjustable velocity. Fig. 1 shows the results of an experiment in which the propagation of an atom ic wave packet is studied in the normal (Fig. 1b) and anom alous (Fig. 1c) dispersion regime corresponding to positive and negative e ective mass, respectively. A broadening of the wave packet is observed in both cases. The faster spreading in the case of anom alous dispersion is a consequence of the smaller absolute value of the negative e ective mass. How ever, if

we switch from one regime to the other during the propagation by changing the velocity of the periodic potential, the e ects of norm al and anom abus dispersion cancel. The wave packet, which has initially broadened under the in uence of norm all dispersion, reverses its expansion and com presses until it regains its initial shape (Fig.1d). This is a direct proof of the realization of negative e ective m ass.

The concept of e ective m assm e [9] allows to describe

the dynam ics of matter wave packets inside a periodic potential in a simple way via a modi ed dispersion relation. The periodic potential in our experiments is well described by




FIG. 2: (a) Band structure in the rst Brillouin zone for atoms in an optical lattice with $V_0 = 1.2 E_G$ (solid), parabolic approximation to the lowest energy band at q = G = 2 (dashed), corresponding group velocity (b) and e ective mass (c) in the lowest energy band. The vertical dashed lines at $q = q_1$ indicate where $jn_e \ j = 1$. (d-f) Spatial densities of the wave packet after t = 60 m s of propagation with $q_c = G = 2$ for dimensional frame of the optical lattice. The solid lines represent the theoretical predictions using linear propagation with the exact band structure and the quasimom nentum distribution given in graph (c). The dashed lines in G raph (d-f) represent the prediction of the constant e ective mass approximation.

$$V(x) = \frac{V_0}{2} \cos(Gx)$$

with a modulation depth V_0 on the order of the grating recoil energy $E_G = h^2 G^2 = 8m$, with G = 2 =d where d = 417 nm represents the spatial period. The energy spectrum of atoms inside the periodic potential exhibits a band structure E_n (g) which is a periodic function of quasimomentum q with periodicity G corresponding to the width of the st Brillouin zone (Fig. 2a). In our experiment, we prepare condensates in the lowest energy band (n = 0) with a quasimomentum distribution w (g) centered at $q = q_c$ with an rm swidth q G [10].

It has been shown by Steel et al. [11] that in this case the condensate wave function in a quasi onedimensional situation can be described by $(x;t) = A(x;t)_{q_c}(x) \exp((iE_0(q_c)t=h))$, where q_c represents the B loch function in the lowest energy band corresponding to the central quasim on entum. The evolution of the envelope function A (x;t), norm alized to the total num ber of atom s N₀, is described by

The strength of the atom -atom interaction is given by $g = {}_{n1}2h!_{?}a$, with the transverse trapping frequency of the waveguide $!_{?}$, the swave scattering length a, and a renorm alization factor ${}_{n1} = 1 = d {}_{0}^{R_{d}} dx j {}_{q_{c}} d$. Besides the modi cation of the nonlinear term the periodic potential leads to a group velocity of the envelope A (x;t) determ ined by the energy band via $v_{g}(q_{c}) = h^{-1} (@E_{0}(q)=@q) j_{t_{c}}$ (Fig.2b). In addition, the kinetic energy term describing the dispersion of the wave packet is modi ed by the elective mass (Fig.2c)

$$m_{e} (q_{c}) = h^{2} \frac{\theta^{2} E_{0}(q)}{\theta q^{2}} = \frac{1}{q_{c}}$$

It is important to note that group velocity and e ective m ass are assumed to be constant during the propagation. Since the approximation of constant e ective m ass corresponds to a parabolic approximation of the energy band, it is only valid for su ciently small q as can be seen in Fig. 2.

The general solution of Eq. (1) is a di cult task, but simple analytic expressions can be found in the special cases of negligible and dominating atom -atom interaction. Om itting the last term in Eq. (1) it is straightforward to see that j_{n_e} j controls the magnitude of the dispersion term and thus the tim escale of the wave packet broadening. A change in sign of m_e corresponds to tim e reversal of the dynam ics in a fram e m oving with velocity v_g . In the regim e where the atom -atom interaction is dom inating, e.g. during the initial expansion of a condensate, the evolution of the envelope function can be found in standard nonlinear optics textbooks [12] and in form of scaling solutions in the context of B ose-E instein condensates [13]. Note that in this regime the kinetic energy term is still relevant and thus a change of the sign of the e ective m ass will reverse the dynam ics.

In the following we will analyze the obtained experimental results in more detail. The initial wave packet shown in Fig.1a) is characterized by $x_0 = 14.8$ (6) m (x is the rm s width of a Gaussian t) and shows the density distribution of a Bose-Einstein condensate of2 1⁴0 atom s in a three-dimensional dipole trap. Before releasing the atom ic cloud into the one dimensional waveguide, a weak periodic potential along the waveguide is adiabatically ram ped up to $V_0 = 2:8(2) E_G$ within 6ms. This turns the initial Gaussian momentum distribution of the atoms into a Gaussian distribution of quasim om enta w (q) centered at $q_c = 0$ in the lowest energy band of the lattice with a corresponding e ective mass m $_{\rm e}$ = 1.25m . The density distribution shown in Fig. 1b) is a result of propagation within the stationary periodic potential for t = 26m s and exhibits a spread $x_0^2 = 18:4(12)$ m in contrast to of x = x (t) ² $x_f = 202(14)$ m for expansion without periodic potential. The resulting ratio $x_f = x = 1:10(15)$ indicates that the evolution is dom inated by the nonlinearity, in which case one expects $x_f = x$ m_e =m = 1:11 [14]. In the case of linear propagation one expects $x_f = x =$ $m_e = m = 1:25.$

The dynamics in the anom alous dispersion regime are investigated by initially accelerating the periodic potential within 3m s to a velocity $v = v_G = hG = 2m$, thus preparing the atom ic wave packet at the edge of the Brillouin zone, where $m_e = 0.5m$. The velocity is kept constant during the subsequent expansion. In the regime of negative mass a condensate exhibits collapse dynam ics sim ilar to condensates with attractive atom atom interaction. Two-dimensional calculations for our experim ental situation reveal that this collapse happens within the initial 3-6m s of propagation. This leads to a fast reduction of the density and therefore of the nonlinearity due to excitation of transverse states. An indication of the population of transverse states is the observed increase of the transverse spatial extension of the wave packets for anom alous dispersion by alm ost a factor of two. The optical resolution of our setup does not allow for a quantitative analysis of the transverse broadening. The measured spread of x = 38:5(15) m after 23m s of expansion leads to a ratio $x_f = x = 0.46(5)$. This ratio represents an upper lim it due to the initial collapse, indicating that a coherent nonlinear evolution in one dim ension cannot describe the experim ental results.

In the case of dispersion management Fig. 1d) the

wave packet was not subjected to normal dispersion for 17ms at $q_c = 0$. The time of subsequent propagation with anomalous dispersion at $q_c = G=2$ was adjusted to achieve the minimal wave packet size of x = 15.4(2) m. The minimum was achieved for times ranging from 7ms to 9ms which is in rough agreement with the expected time resulting from elective mass considerations 0.5=1.25 17ms = 10.7ms. The experimental results exhibit a rapid increase of the wave packet width for overall propagation times longer than 27ms also indicating collapse dynamics.

B efore presenting the detailed experim ental studies of the applicability of the constant e ective m ass approxim ation and evidence of in nite m asses, we turn to a brief description of our setup.

The wave packets have been realized with a ${}^{87}\text{Rb}$ Bose-Einstein condensate. The atoms are collected in a magneto-optical trap and subsequently baded into a magnetic time-orbiting potential trap. By evaporative cooling we produce a cold atom ic cloud which is then transferred into an optical dipole trap realized by two focused NdXAG laser beam s with 60 m waist crossing at the center of the magnetic trap. Further evaporative cooling is achieved by lowering the optical potential leading to pure Bose-Einstein condensates with up to 3 1⁴0 atom s in the f = 2; $m_F = +2i$ state. By switching o one dipole trap beam the atom ic matter wave is released into a trap acting as a one-dimensional waveguide with radial trapping frequency $!_2 = 2$ 80 Hz and longitudinal trapping frequency $!_k = 2$ 1:5 Hz.

The periodic potential is realized by a far o -resonant standing light wave with a single beam peak intensity of up to $5W/cm^2$. The chosen detuning of 2 nm to the blue o the D 2 line leads to a spontaneous emission rate below 1 H z. The frequency and phase of the individual laser beam s are controlled by acousto-optic m odulators driven by a two channel arbitrary waveform generator allowing for full control of the velocity and am plitude of the periodic potential. The light intensity and thus the absolute value of the potential depth was calibrated independently by analyzing results on B ragg scattering [15] and Landau Zener tunneling [4].

The wave packet evolution inside the combined potential of the waveguide and the lattice is studied by taking absorption in ages of the atom ic density distribution after a variable time delay. The density proles along the waveguide, n(x;t), are obtained by integrating the absorption in ages over the transverse dimension z.

Since the assumption of a constant e ective m assused so far is only an approximation, it is important to check its applicability in experiments. Therefore we investigate the dynam ics of wave packets prepared at the Brilbuin zone edge ($q_c = G = 2$) for di erent potential depths. The observed density pro les after 60 m s of propagation are shown in Fig. 2d-f). While both the initial wave packet shape n (x;0) and the quasim om entum distribution w (q) are measured to be approximately Gaussian, the wave packet changes its shape during evolution. We attribute this distortion to the invalidity of the constant e ective mass approximation, which assumes that the populated quasim om enta experience the sam e negative curvature of E_0 (g). Since the range of quasimom enta ful lling this criterion becom es smaller with decreasing m odulation depth, a more pronounced distortion of the wave packet shape for weak potentials is expected (see Fig.2d).

This explanation is con med more quantitatively by comparing the observed wave packets with the results of an integration of Eq.(1) neglecting the nonlinear term. Since the initial collapse of the condensate cannot be described by a linear theory, we take a G aussian function tted to the density distribution measured at 20m s as the initial wave packet for the num erical propagation. Due to the fact that this is not a minimum uncertainty wave packet we add a quadratic phase in real space such that the Fourier transform of the wave packet is consistent with the measured momentum distribution. In rst approximation this takes into account the initial expansion including the repulsive atom -atom interaction. For




FIG. 3: G roup velocities of steep edges emerging from an initial wave packet with signi cant overlap with q_1 in quasimomentum space. The measured velocities of the indicated positions (arrows in insets) agree very well with the expected maximum and minimum velocity in the lowest band (solid line) corresponding to the in nite masses. The dashed line represents the prediction of the weak potential approximation [9]. For potentials smaller than 2 E_G (diamonds) data are obtained by preparing the initial wave packet at q = G = 2 leading to two steep edges (see inset). For higher potentials (circles) the wave packet is prepared at q = G = 4 to ensure population of the quasimom entum corresponding to in nite mass.

the subsequent propagation of 40 m s we use the full expression for E₀ (q) which is obtained num erically. Finally we convolute the obtained density distribution with the optical resolution of our setup. In Fig. 2d-f) we compare the data with the linear theory described above (solid line) and with the constant e ective m ass approxim ation (dashed line). C learly the e ective m ass approxim ation cannot explain the observed distortion and it strongly overestim ates the expansion velocity for weak potentials. A dditionally, for small potential m odulation depths new features appear in the central part of the wave packet which cannot be explained using the linear theory. We are currently investigating these features in m ore detail.

The observed distortion is mainly a consequence of another very interesting feature of the band structure: the existence of jn_e j = 1 for certain quasimomenta $q = q_1$ (see Fig. 2c). A diverging mass implies that the group velocity is extrem aland the dispersion vanishes as can be seen from Eq. (1). As a consequence an atom ic ensemble whose quasimomentum distribution is overlapping $q = q_1$ will develop steep edges as can be seen in Fig. 2d). These edges propagate with the maximum group velocity of the lowest band.

The system atic investigation of the velocities of the edges is shown in Fig.3 for di erent values of V_0. In order to get a signi cant overlap of w (q) with $q = q_1$, we pre-

pare atom ic ensembles with q = 0:17G=2 at $q_c = G=2$ realized by Bose-Einstein condensates of 2 140 atom s with a spatial extension of x = 15 m. The velocities of the edges are derived from two in ages taken at 20 m s and 60 m s, respectively. In each image the position of the edge is evaluated at the levels indicated by the arrows in the insets of Fig. 3 (50% and 25% of the maximum density). Since the momentum spread is too sm all to populate the in nite mass points for potentials deeper than $2E_{G}$ the atom ic ensemble was then prepared at $q_c = G = 4$ by accelerating the periodic potential to the corresponding velocity $v = v_G = 2$. The resulting wave packet shapes are asymmetric exhibiting a steep edge on one side which becomes less pronounced for potentials deeper than $5 E_{G}$. The obtained experimental results in Fig. 3 are in excellent agreement with the num erically calculated band structure predictions. In contrast to the good agreem ent of the maximum velocity for all potentialdepths we nd that for $V_0 > 5 E_G$ the group velocity of the center of m ass is only 10% of the expected velocity deduced from the dispersion relation at $q_c = G = 4$. This could be an indication of entering the tight binding regime where the nonlinear e ect of self trapping, ie. stopping and non-spreading wave packets, has been predicted by Trom bettoniet al. [8]. We are currently investigating the transport properties in this regime in m ore detail.

In conclusion, we have demonstrated experimentally that the dispersion of atom ic matter waves in a waveguide can be controlled using a weak periodic potential. Matter wave packets with positive, negative and in nite e ective masses are studied in the regime of weak and intermediate potential heights. The preparation of matter waves with engineered dispersion ($m_e < 0$) is an important prerequisite for the experimental investigation of atom ic gap solitons and other e ects arising from the coherent interplay of nonlinearity and dispersion in periodic potentials.
