V iolation of self-sim ilarity in the expansion of a 1D Bose gas

The expansion of a 1D Bose gas is investigated employing the Lieb-Liniger equation of state within the local density approximation. We show that during the expansion the density prole of the gas does not follow a self-sim ilar solution, as one would expect from a simple scaling Ansatz. We carry out a variational calculation, which recovers the numerical results for the expansion, the equilibrium properties of the density prole, and the frequency of the lowest compressional mode. The variational approach allows for the analysis of the expansion in all interaction regimes between the mean eld and the Tonks-G irardeau limits, and in particular shows the range of parameters for which the expansion violates self-sim ilarity.

I. IN TRODUCTION

The experimental achievement of Bose-Einstein condensation (BEC) [1] has aroused a large interest in the physics of ultracold atom ic gases. Am ong the topics related to this eld, the physics of low dimensional atom ic gases has recently attracted signi cant attention. The developm ent of the trapping techniques has allowed for the realization of very an isotropic geom etries, where the con nement is so strong in one or two dimensions, that at low tem peratures the transversalm otion is \frozen", and does not contribute to the dynam ics of the system . In this way two-[2, 3, 4, 5] and one-dimensional [2, 6, 7]system s have been accomplished. Low-dimensional gases present signi cantly di erent properties com pared to the three-dimensional ones. A remarkable example is provided by the existence of quasi-condensation [8, 9, 10, 11], whose e ects have been recently observed experim entally [12].

During the last years, the 1D Bose gases have been the subject of growing interest, in particular the limit of in penetrable bosons [13], which behave to a large extent as a noninteracting Ferm i system, acquiring some remarkable properties. The conditions for the experimental realization of strongly correlated 1D gases are rather restrictive [8, 14], since a large radial compression, a su ciently sm all density, and eventually a large scattering length are needed. Fortunately, recent experimental developments have opened perspectives in this sense. E specially interesting is the possibility to modify at will the interatom ic interactions by means of Feshbach resonances [15], and the capability of loading an atom ic gas in an optical lattice [16].

From the theoretical side, the physics of 1D B ose gases was rst investigated by G irardeau [13], who considered the lim it of impenetrable bosons, also called Tonks-G irardeau (IG) gas, pointing out a non trivial relation with the physics of ideal Ferm i gases. This analysis was later extended by Lieb and Liniger [21], who solved analytically the problem for any regime of interactions, using Bethe Ansatz. Yang and Yang [22] extended the analysis including nite temperature e ects. Recently, the experim ental accessibility of trapped gases, have encouraged the investigation of the harm onically trapped case. The Bose-Ferm i (BF) mapping has been employed to the case of an inhom ogeneous gas in the TG lim it [23]. How ever, there is unfortunately, to the best of our know edge, no exact solution for arbitrary interaction strength in the case of trapped gases. The problem of the equilibrium of a trapped gas can be analyzed using a local density approximation and employing the Lieb-Liniger (LL) equation of state locally to evaluate the equilibrium density pro les [17]. A similar formalism has been recently employed to analyze the collective oscillations in the presence of harm onic trapping [18]. Both Refs. [17] and [18] have shown the occurrence of a continuous transition from the mean eld (MF) regime to the TG one as the intensity of the interaction is varied. Recently, G angardt and Shlyapnikov [19] have discussed the stability and phase coherence of 1D trapped Bose gases. These authors have analyzed the local correlation properties and found that inelastic decay processes, such as three body recombination, are suppressed in the TG regime, and interm ediate regim esbetween MF and TG. This fact opens prom ising perspectives towards the accomplishment of strongly interacting 1D Bose gases with large number of particles. This analysis have been very recently extended to the case of nite tem peratures [24].

The expansion of a one-dimensionalBose gas in a guide was analyzed in Ref. [20], by means of a hydrodynamic approach based on the local LL model. The expansion dynamics was shown to be dierent for dierent interaction strengths, and its analysis could be employed to discern between the TG and MF regimes. In particular, the self-similar solution is violated.

In this paper, we extend the analysis of Ref.[20] by introducing a variational approach, which perm its us to study the asymptotic regime at large expansion times. This method is shown to be in excellent agreement with previous direct numerical simulations, and additionally perm its us to recover the results of Refs. [17] and [18]. More importantly, our variational approach allows us to determ ine the regime of parameters for which the selfsim ilarity of the expansion is violated.

The paper is organized as follows. In Sec. II we in-

troduce the localLL m odel which we employ to analyze the expansion dynam ics. In Sec. III we brie y discuss the num erical results obtained in Ref. [20]. In Sec. IV we present a variational approach which allows us to investigate in detail the expansion dynam ics for arbitrary regim es of param eters. Finally we conclude in Sec.V.

II. LOCAL LIEB-LIN IGER MODEL

We analyze in the following a dilute gas of N bosons conned in a very elongated harmonic trap with radial and axial frequencies ! and $!_z$ (! $!_z$). We assume that the transversal connement is strong enough so that the interaction energy per particle is smaller than the zero-point energy ~! of the transversal trap. In this way, the transversal dynamics is electively \frozen" and the system can be considered as dynamically 1D. In this section we brie y review the form alism introduced in Ref. [17].

W e assume that the interparticle interaction can be approximated by a delta function pseudopotential. Therefore the H am iltonian that describes the physics of the 1D gas becomes

is the hom ogeneous H am iltonian in absence of the harmonic trap, m is the atom icm ass and $g_{1D} = 2^{-2} = m a_{1D}$. The scattering problem under one-dimensional constraints was analyzed in detail by O Ishanii [14], and it is characterized by the one-dimensional scattering length $a_{1D} = (a^2=2a)[1 C (a=a)]$, with a the three-dimensional scattering length, $a = \frac{P}{2^{\sim}=m}$! the oscillator length in the radial direction, and C = 1.4603:::. As shown by Lieb and Liniger [21], the hom ogeneous H am iltonian \hat{H}_{1D}^0 can be diagonalized exactly by means of Bethe Ansatz [25]. In the them odynam ic lim it, a 1D gas at zero tem perature with a given linear density n, is characterized by the energy per particle

W e assume next that at each point z the gas is in local equilibrium, with local energy per particle provided by Eq. (3). Then, one can obtain the corresponding hydrodynam ic equations for the density and the atom ic velocity

is the G ibbs free energy per particle.

Note that for the case of n $j\!a_{1D}$ j ! 1 , one obtains $le(n) = g_{1D} n$, retrieving the 1D G ross-P itaevskii equation (GPE) [26], whereas for the case $n \dot{a}_{1D} \dot{j}! 0$, one $^{2}\sim^{2}n^{2}=2m$, and the equation of Ref. gets le(n) =[27] is recovered. The system has only one control param eter [8, 17, 18], nam ely $A = N ja_{1D} j^2 = a_z^2$, where $a_z = \frac{1}{2} \sim m |_z$ is the harm on ic oscillator length in the z direction. The regime A 1 corresponds to the MF lim it, in which the stationary-state density pro le has a parabolic form . On the other hand, the regime A 1 corresponds to the TG regime, which is characterized by a stationary-state density pro le with the form of a square root of a parabola.

III. NUMERICAL RESULTS

In Ref. [20], equations (3),(5),(6),(9) were employed to simulate numerically the expansion of a 1D gas in the fram ework of the hydrodynamic formalism. The expansion follows the sudden removal of the axial con nement, while the radial one is kept xed. In particular, it was observed that during the expansion the density prole is well described by the expression




FIG.1: Time evolution of the exponent s(t) for A = 0.43, ! = 2 20kHz and N = 200 atoms (!_z = 2 1.8Hz at t = 0). Our variational result (dashed line) shows a very good agreement with the results obtained from the direct resolution of Eqs. (7) and (8).

where n_m (t) provides the appropriate normalization, R (t) is the radius of the cloud, and the exponent s(t) takes the value s(0) = 1 for an initial MF gas. The function s(t) decreases m onotonically in time, approaching an asymptotic value (see Fig. 1). Therefore, contrary to the expansion dynamics for a BEC [28, 29, 30], the self-similarity of the density prole is violated.

At this point we discuss the physics behind this violation of the self-sim ilarity. If the local chem ical potential presents a xed power law dependence on the density, $_{le}$ / n , it is easy to show from the hydrodynam ic equations (7) and (8), that there exists a self-sim ilar solution of the form $n = (n_0 = b)$ (1) $(z=bR)^2)^{1=}$, where $b = \frac{1}{2} = b^{+1}$. For the particular case of the TG gas, the scaling law can be also obtained from the exact BF m apping [20]. However, since le is obtained from the LL equations, the dependence of le on n is quadratic for a low density and linear for a large one. Therefore, le does not full a xed power law dependence during the expansion, and the self-sim ilarity is violated. In particular, as the expansion proceeds the whole system approaches the low density regime, and consequently the exponent s decreases m onotonically. In the next section, we analyze in more detail this e ect.

In this section, we complete our understanding of the expansion of a one-dimensional Bose gas in a guide by means of a variational Ansatz using a Lagrangian formalism. The Lagrangian density for the system is of the form

where the velocity eld is de ned as v = 0 = 0. The equations of motion are obtained from the functional derivation of the action A = L dtdz: A = = 0 (continuity equation), A = n = 0 (which after partial derivation with respect to z provides the Euler equation). From the num erical results we have observed that the density is at any time well described by Eq. (10). Therefore, we

assume the following Ansatz for the density

where b and s are time dependent variables, R is the initial Thom as Ferm i radius, and C (s) is related to the norm alization to the total number of particles. For the eld we consider the following form :

where and are time dependent parameters. We stress at this point, that in the analysis of the self-sim ilar expansion of a BEC [28, 29, 30], a quadratic ansatz (in z) for the eld provides the exact solution. However, for the problem under consideration in this paper, it is necessary to include higher order terms to account for the violation of the self-sim ilarity. We have checked that terms of higher order than z^4 introduces only sm all corrections, and therefore we reduce to the form of Eq. (13).




FIG.2: Equilibrium values (at t = 0 before opening the trap) of the exponent s, as a function of the parameter A. The dashed lines denote the M F lim it, $s_0 = 1$, and the TG one, $s_0 = 1=2$.




FIG. 3: Frequency of the lowest compressional mode as a function of the parameter ${\tt A}$.

W e are interested in the dynam ics of the param eters b and s, related to the size and the shape of the cloud, respectively. Integrating the Lagrangian density in z, L = Ldz, one nds a Lagrangian for the above mentioned param eters:

W e perform a gauge transform ation [31]

The resulting Lagrangian is of the form L = L(;;b;b;s;s). Imposing the conservation laws @L=@ = @L=@ = 0, we obtain a Lagrangian depending only on the two relevant parameters s and b, of the form L = K V, where

where $E_{1D} = \sim^2 = 2m ja_{1D} f$ is the typical energy associated with the interatom ic interactions. In Eq. (17), we use the function B (b;s) = dy (1 y^2)^s (n (y))= E_{1D} , where we integrate over the rescaled axial coordinate y = z=Rb. In Eqs. (17) and (18), we de ne the dimensionless central density $_0 = n_0 ja_{1D} j$ where n_0 is the initial central density, and the parameter $s_0 = s(t = 0)$. We have additionally employed the auxiliary functions $f_n(s) = y^n (1 - y^2)^s dy$, and the coe cients

From the Lagrangian L, one obtains the corresponding Euler-Lagrange equations for the parameters b and s. In

order to nd the initial conditions $_0$ and s_0 for the expansion, we have num erically m inim ized the potential V in the presence of the harm onic trap for di erent values of A, assuming b = 1 (see Fig.2). When A 1, s_0 tends to 1, as expected for the MF case. On the contrary, when A 1, s_0 tends to 1=2 (TG pro le). As expected from Ref. [17], for A 1, $_0$ / $A^{1=2}$, whereas for A 1, the MF dependence $_0$ / $A^{2=3}$ is recovered.

Our variational approach allows us to calculate the lowest compressional mode, o ering an alternative m ethod as the one discussed in Ref. [18]. Expanding the potentialV around the equilibrium solution up to second order in b (see Fig. 3), and neglecting for sm all oscillations the tim e-dependence of s, we obtain

Our results show a continuous transition from the MF value, $!_m = \frac{1}{3}!_z$, to the TG one, $!_m = 2!_z$, in excellent agreement with the results obtained by m eans of a sum rule form alism [18].




FIG.4: Expansion velocity. A symptotic value of bas a function of the parameter ${\rm A}$.




FIG. 5: V iolation of the self-similarity. Value of $= s_1 = s_0$ as a function of the parameter A. The value = 1 denotes self-similarity.

From the corresponding Euler-Lagrange equations, we have obtained the dynam ics of b(t) and s(t). We have checked in all our calculations that the energy and num – ber of particles remain a constant of motion. We have compared the variational results with our simulations based on the exact resolution of the hydrodynam ic equations [20], obtaining an excellent agreem ent (see Fig. 1).

We have analyzed the asymptotic value, b_1 , for dierent values of A. It is easy to obtain, that for a power law dependence of the local chem ical potential $_{\rm le}$ / n, the derivative of the scaling parameter asymptotically approaches a value $b_1 = 2 = !_z$. Therefore a continuous transition from $b_1 = !_z$ (TG) to $b_1 = 2!_z$ (MF) is expected. We recover this dependence from our variational calculations (see Fig. 4).

W e have analyzed the behavior of s during the expansion dynamics for dierent values of A. In particular, we have de ned the asymptotic ratio = $s_1 = s_0$, with $s_1 = s(t ! 1)$ (see Fig. 5). Deeply in the TG regime 1), ' 1, i.e. in those ex-(A) 1) or in the MF one (A trem e regim es, the expansion is well-described by a selfsim ilar solution. How ever, for interm ediate values, < 1, i.e. the expansion is not self-sim ilar. The self-sim ilarity is maximally violated in the vicinity of A = 1, although departs signi cantly from 1 for a range 0:01. A . 100. The behavior at large A can be understood as follows. If the gas is at t = 0 deeply in the M F regime, the change of the functional dependence of le with the density occurs at very long expansion times, when the initial interaction energy of the gas has been fully transferred into kinetic energy. Therefore, for large values of A the self-sim ilarity is recovered.

V. CONCLUSIONS

In this paper, we have extended the analysis of R ef. [20] on the expansion dynam ics of a one-dimensional B ose gas

in a guide. We have shown that the expansion violates under certain conditions the self-sim ilarity, and in this sense di ers signi cantly from the expansion dynam ics of a BEC.We have shown that the problem can be solved by employing the hydrodynam ic approach, and the local Lieb-Linigerm odel. W e have developed a variational approach based on a Lagrangian form alism to study the expansion for any regime of parameters. We have identied the possible physical situations at which self-sim ilarity is violated. This should occur in a rather wide range of parameters (0:01 . A . 100). The particular properties of the expansion of a gas in the strongly-interacting regime could therefore be employed to discern between m ean-eld and strongly-interacting regimes. In addition, the asymptotic behavior of the expanded cloud could be em ployed to discrim inate between di erent initial interaction regimes of the system .

O ur discussion has been restricted to the analysis of the density properties. In fact the present form alism cannot describe the dynam ics of the coherence in the system, i.e. we are limited to the diagonal terms of the corresponding single-particle density matrix. The description of the non diagonal terms s lies beyond the scope of this paper, and requires other techniques of analysis [19, 32].
