## Optim al Paths in Disordered Complex Networks

We study the optim aldistance in networks, 'opt, de ned as the length of the path m in in izing the total weight, in the presence of disorder. Disorder is introduced by assigning random weights to the links or nodes. For strong disorder, where the maximal weight along the path dominates the sum, we not that 'opt N  $^{1=3}$  in both Erd-Renyi (ER) and Watts-Strogatz (WS) networks. For scale free (SF) networks, with degree distribution P (k) k, we not that 'opt scales as N  $^{(3)=(-1)}$  for 3 < 4 and as N  $^{1=3}$  for 4. Thus, for these networks, the small-world nature is destroyed. For 2 < 43, our numerical results suggest that 'opt scales as In  $^1$  N. We also not numerically that for weak disorder 'opt In N for both the ER and WS models as well as for SF networks.

Recently much attention has been focused on the topic of complex networks which characterize many biological, social, and communication systems [1, 2, 3]. The networks can be visualized by nodes representing individuals, organizations, or computers and by links between them representing their interactions.

The classicalm odel for random networks is the Erd $\!\!$  Renyi (ER) model [4,5]. An important quantity characterizing networks is the average distance (minimal hopping) 'min between two nodes in the network of total N nodes. For the Erd $\!\!$  Servi network, and the related, more realistic W atts-Strogatz (W S) network [6] 'min scales as ln N [7], which leads to the concept of 'six degrees of separation".

In most studies, all links in the network are regarded as identical and thus the relevant parameter for information ow including e cient routing, searching, and transport is  $'_{m in}$ . In practice, however, the weights (e.g., the quality or cost) of links are usually not equal, and thus the length of the optim alpath m in im izing the sum of weights is usually longer than the distance. In many cases, the selection of the path is controlled by the sum of weights (e.g., total cost) and this case corresponds to regular or weak disorder. However, in other cases, for example, when a transmission at a constant high rate is needed (e.g., in broadcasting video records over the Internet) the narrowest band link in the path between the transmitter and receiver controls the rate of transmission. This situation in which one link controls the selection of the path is called the strong disorder limit. In this Letter we show that disorder or inhomogeneity in the weight of links may increase the distance dramatically, destroying the \sm all-world" nature of the networks.

To implement the disorder, we assign a weight or \cost" to each link or node. For example, the weight could be the time  $_i$  required to transit the link i. The optimal path connecting nodes A and B is the one for which  $_i$  is a minimum. While in weak disorder all links contribute to the sum, in strong disorder one term

The strong disorder lim it m ay be naturally realized in the vicinity of the absolute zero tem perature if passing through a link is an activation process with a random activation energy  $_i$  and  $_i$  = exp( $_i$ ), where is inverse tem perature [8]. Let us assume that the energy spectrum is discrete and that the minimal dierence between energy levels is . It can be easily shown that if > ln 2= , the value of  $_i$  is dominated by the largest term,  $_{max}$ . Thus if we have two dierent paths characterized by the sums p  $_i$  i and  $_i$  i, such that  $_{max}$  >  $_{max}^0$ , it follows that  $_i$  i >  $_i^0$ , such that

To generate ER graphs, we start with zN links and for each link random ly select from the totalN (N 1)=2 possible pairs of nodes a pair that is connected by this link. The WS network [6] is implemented by placing the N nodes on a circle. Initially, each node i is connected with z nodes i+ 1; i+ 2; ::; i+ z and periodic boundaries are implemented. Thus each node has a degree 2z and the total number of links is zN. Next we random ly remove a fraction p of the links and use them to connect random ly-selected pairs of nodes. When p=1, we obtain a model very similar to the ER graph.

To generate scale-free (SF) graphs, we employ the M olloy-Reed algorithm [9] in which each node is rst assigned a random integer k from a power law distribution P  $(k > k) = (k=k_0)^{+1}$ , where  $k_0$  is the m inimal number of links for each node. Next we random by select a node and try to connect each of its k links with random by selected k nodes that still have free positions for links.

We expect that the optimal path length in the weak disorder case will not be considerably dierent from the shortest path, as found for regular lattices [10] and random graphs [11]. Thus we expect that the scaling for the shortest path  $\dot{m}_{in}$  ln N will also be valid for the optimal path in weak disorder, but with a dierent prefactor depending on the details of the graph.

In the case of strong disorder, we present the following theoretical argum ents. C ieplak et al.[12] showed that nding the optim alpath between nodes A and B in the

strong disorder lim it is equivalent to the following procedure. First, we sort all M links of the network in the descending order of their weights, so that the rst link in this list has the largest weight. Since the sum of the weights on any path between nodes A and B is dom inated by a single link with the largest weight, the optim alpath cannot go through the rst link in the list, provided there is a path between A and B which avoids this link. Thus the rst link in the list can be elim in ated and now our problem is reduced to the problem of nding the minimal path on the network of M can continue to rem ove links from the top of the list one by one until we pick a link whose removal destroys the connectivity between A and B. This means that all the remaining paths between A and B go through this singlyconnecting or \red" link [13] and all these paths have the sam e largest weight corresponding to the \red" link. To continue optim ization among these paths we must select the paths with the minimal second largest term, minimal third largest term and so on. So we must continue to rem ove links in the descending order of their weights unless they are \red" until a single path between A and B, consisting of only \red" links remains. Since the assigning of weights to the links is random so is their ordering. Hence the optim ization procedure in the strong disorder lim it is statistically equivalent to removing the links in random order unless the connectivity between nodes A and B is destroyed.

At the beginning of this process, the chances of losing connectivity by rem oving a random link are very low, so the process corresponds exactly to diluting the network, which is identical to the percolation model. Only when the concentration of the remaining links approaches the percolation threshold will the chances of removing a singly-connected \red" link [13] become signicant, indicating that the optimal path must be on the percolation backbone connecting A and B. Since the network is not embedded in space but has an in nite dimensionality, we expect from percolation theory that loops are not relevant at criticality [14]. Thus, the shortest path must also be the optimal path.

We begin by considering the case of the ER graph that, at criticality, is equivalent to percolation on the Cayley tree or percolation at the upper critical dimension  $d_c=6$ . For the ER graph, it is known that the mass of the incipient in nite cluster S scales as N  $^{2=3}$  [4]. This result can also be obtained in the framework of percolation theory for  $d_c=6$ . Since S  $_{\rm R}$   $^{\rm d}_{\rm f}$  and N  $_{\rm R}$   $^{\rm d}$  (where  $d_{\rm f}$  is the fractal dimension and R the diameter of the cluster), it follows that S  $_{\rm N}$   $^{\rm d}_{\rm f}=d$  and for  $d_c=6$ ,  $d_{\rm f}=4$  [15]

It is also known [15] that, at criticality, at the upper critical dimension, S  $\binom{d}{m}$  in with  $d_1 = 2$ , [15] and thus




FIG. 1: Scaling plot of 'opt on W S graphs for weak disorder as a function  $\ln N = n_0$  for various values of p and z=2. The inset shows the log-log plot of  $n_0$  versus pz. The dierent symbols represent dierent p values: p=0.001 (4), p=0.002 (), p=0.004 (), p=0.008 (5), p=0.016 (+), p=0.032 () p=0.064 (), and p=0.128 (2). Similar results have been obtained for z=1, 4, and 8. Those results scale according to Eq. (4).

for large N  $\,$  and large p will be in the same universality class as  ${\rm E\,R}$  .

For SF networks, we can also use the percolation results at criticality. It was found [16] that  $d_{\nu}=2$  for >4,  $d_{\nu}=(2)=(3)$  for 3<4,  $N^{2=3}$  for y=1 fo




FIG. 2: (a) The dependence of 'opt on N  $^{1=3}$  for ER graphs for the strong disorder case obtained by direct optim ization (+) and by random ly rem oving links ( ). The linear asymptote has a slope of 3.27. A lso shown are the successive slopes multiplied by 50 for direct optim ization ( ) and for random ly rem oving links ( ). (b) Scaling plot of 'opt in W S graphs for strong disorder as a function  $(N=n_0)^{1=3}$  for various values of p and z=2. The symbols indicating values of p are the same as in Fig. 1. The inset shows a log-log plot of  $n_0$  versus p for z=2.

To test these theoretical predictions, we perform num erical sin ulations in the strong disorder lim it by random ly rem oving links (or nodes) for ER, WS, and SF networks and use the Dijkstra algorithm [17] for the weak disorder case. We also perform additional sin ulations for the case of strong disorder on ER networks using direct optim ization with Dijkstra algorithm of the sum of weights and nd results identical to the results obtained by random ly rem oving links, see Fig. 2a.

Results for weak disorder for W S graphs with dierent pare shown in Fig. 1. We propose a scaling formula for  $_{\rm opt}$  similar to the formula derived in [18, 19] for the minimal distance on the W S graphs with a dierent rewiring probability p

where  $n_0$  (p;z) 1=pz is the characteristic graph size at which the crossover from large to small world behavior occurs,  $n_1$  (z) z is a correction factor, and F (x) is the scaling function

The scaling variable  $x = N = n_0$  indicates the number of nodes with long range links. As p! 0, this quantity scales as N pz. The quantity  $n_0$  (p;z) 1=pz indicates a typical short-range neighborhood of a node with long range links. We can think about this graph as an ER graph consisting of N = n0 e ective nodes, each representing a typical short-range chain-like neighborhood of size  $n_0$ . Thus we conclude that an optimal path connecting any two nodes is proportional to  $\ln (N = n_0)$ , as in an ER graph, tim es an average path length through a chain of short-range links. This average path is proportional to the length of this chain no and inversely proportional to the average range  $n_1(z)$  of a link in this chain. Ideally  $n_1(z) = z$ , but in reality it can signi cantly deviate from z due to nite size e ects. Figure 1 shows the scaled optim alpath  $_{opt}=n_0$  versus the scaled variable N =  $n_0$  for z = 2 and dierent values of p. The inset in Fig. 1 shows 1=pz as p! 0.that n₀

In contrast, for Eq. (4) to be in agreem ent with Eq. (2)




FIG. 3: (a) The dependence of 'opt on  $\ln N$  for SF graphs in the weak disorder case for various values of shown on the graph. The behavior of the asymptotic slope versus shown as an inset. (b) The dependence of 'opt on 'min. The curves from left to right represent increasing values of given in (a).




FIG. 4: (a) The dependence of 'opt on N  $^{1-3}$  for 4. (b) The dependence of 'opt  $^{1}$  N on N  $^{1-3}$  for  $^{1}$  4. (c) The dependence of 'opt on N  $^{(3)-(1)}$  for  $^{1}$  5 < 4. (d) The dependence of 'opt on  $^{1}$  N for 3.

for the strong disorder limit, we have (see Fig. 2),

For large enough z and p! 1, we recover ER network for which 'opt does not depend on z. Thus we can assume  $n_0(1;z)=1$ . U sing similar scaling arguments as in case of weak disorder, we assume that as p! = 0, 'opt  $z^{2-3}N$ , and hence  $n_1(z) = z^{2-3}$ .

For SF networks, the behavior of the optim alpath in the weak disorder lim it is shown in Fig. 3 for dierent degree distribution exponents . Here we plot  $`_{opt}$  as a function of  $\ln N$  . All the curves have linear asym ptotes, but the slopes depend on ,

This result is analogous to the behavior of the shortest path  $_{\rm m~in}$   $\ln$  N for 3 < < 4. However, for 2 < < 3,

 $'_{m \ in}$  scales as  $\ln \ln N$  [20] while  $'_{opt}$  is signicantly larger and scales as  $\ln N$  (Fig. 3b). Thus weak disorder does not change the universality class of the length of the optimal path except in the case of \ulber ultra-sm all" worlds 2 < < 3.

In contrast, strong disorder dram atically changes the universality class of the optim al path. Theoretical considerations Eqs. (2) and (3)] predict that in the case of W S and ER (Fig. 2) and SF graphs with  $_{\rm opt}$  = N  $^{1=3}$ , while for SF graphs with 3 < N  $^{(-3)=(-1)}$  . Figure 4a shows the linear behavior of 'opt versus N 1=3 for 4. The quality of the linear t becomes poor for ! 4. At this value, the logarithm ic divergence of the second m om ent of the degree distribution occurs and one expects logarithm ic corrections, i.e.,  $_{opt}$  N  $^{1=3}$ =  $\ln$  N (see Fig. 4b). Figure 4c shows the asymptotic linear behavior of 'opt versus N (3) = (1) for 3 < 34. Theoretically, as ! 3,  $_{opt}$  = ( 3)=( 1)! 0, and thus one can expect for = 3 a logarithm ic dependence of `opt versus N . Interestingly, for 2 < < 3 our num erical results for the strong disorder lim it suggest that 'opt scales faster than  $\ln N$  . The num erical results can be tto  $'_{
m opt}$  ( $\ln N$ )  $^1$ (see Fig. 4d). Note that the correct asymptotic behavior may be dierent and this result represents only a crossover regime. We obtain the same results for the SF networks in which the weights are associated with nodes rather then links. The exact nature of the percolation

cluster at < 3 is not clear, since in this regime the tarmsition does not occur at a nite concentration [14].

In sum mary, we study the optimal distance in ER, WS, and SF networks in the presence of strong and weak disorder. We nd that in ER and WS networks and for strong disorder, the optimal distance 'opt scales as N  $^{1=3}$ . We also study the strong disorder  $\lim$  it in SF networks theoretically and by simulations and nd that  $_{\text{opt}}$  scales as N  $^{1=3}$  for > 4 and as N  $^{(3)=(1)}$  for < 4. Thus, the optimal distance increases dramatically in strong disorder when it is compared to the known small world result 'm in In N and the \small world" nature for these networks is destroyed. Our sim ulations also suggest that for 2 < < 3, 'opt scales as In 1 N, which is also much faster than the \ultra-small ln(lnN) [20]. We also nd num erworld" result 'm in ically that in weak disorder 'opt In N in all types of networks studied.

W e simulate strong disorder by selecting 0  $_{\rm i}<1$  from a uniform distribution, using a 48-bit random number generator, so that there are no two identical values of  $_{\rm i}$  in a system of any size that we study. In this case  $2^{-48}$  and we can select  $2^{48}$  to guarantee the strong disorder limit.
