Cluster model of glass transition in simple liquids

On the basis of microscopic statistical mechanics of simple liquids the orientational interaction between clusters consisting of a particle and its nearest neighbors is estimated. It is shown that there are ranges of density and temperature where the interaction changes sign as a function of a radius of a cluster. The model of interacting cubic and icosahedral clusters is proposed and solved in mean-eld replica symmetric approximation. It is shown that the glass order parameter grows smoothly upon cooling, the transition temperature being identieed with the temperature of the replica symmetry breaking. It is shown that upon cooling a Lennard-Jones system, cubic clusters freeze rst. The transition temperature for icosahedral clusters is about temperature being identied with the temperature of the local structure of Lennard-Jones glass in the vicinity of glass transition should be most probably cubic.

D espite the growing interest to physical properties of liquids and glasses (see, for example, for the recent reviews [1, 2, 3]), nature of structural glass transition is still puzzling. W hile the experimental and phenomenological knowledge of non-ergodic amorphous phases has considerably improved in last time [1], progress in rst-principle statistical mechanical studies of structural glasses is much more slow.

One of the promising ways to study the structural glasses is to explore the analogy between the phase transitions in spin glasses (which are well understood now [3, 4]) and the structural glass transition. In some extent this is motivated by the fact that the structure of the dynam ical equations for the appropriate correlation functions of super-cooled liquids and p-spin spin glass model 3) are identical in the mean-eld (MF) approximation [3, 5, 6], so this model may be used to describe, at least qualitatively, the properties of structural glasses. The main obstacle in this way is the absence in structural glasses of quenched disorder (in contrast to the spin glasses). Spin glasses are microscopically quite di erent from liquids and thus seem not suitable for their description. Furtherm ore, this approach does not include any inform ation on the local structure of super-cooled liquids and glasses. In this paper we propose the scenario where the analog of quenched disorder in Lennard-Jones system appears in natural way allow ing to apply the m ethods of spin glass theory to investigation of the structural glass transition.

The structure of supercooled liquids and glasses is incompletely understood even for simplest systems. Frenkel [7] has suggested a qualitative picture of local structure of a dense supercooled liquid: he supposed that in sm all volum es it has a crystal-like structure. On the other hand, as was argued by Frank [8], an icosahedral cluster of 13 particles has a signi cantly lower energy than m ore obvious arrangements having the symmetry of FCC or HCP crystals. It was inferred from the com puter simulations of a dense supercooled Lennard-Jones liquid [9] that the local symmetry of simple liquids is determined by defective or fragmented icosahedralbuilding blocks that exhibit a ve-fold symmetry. However, as was shown later, in a supercooled Lennard-Jones liquid, sm all crystalline FCC clusters nucleate following the tem perature quench [10]. It seems that the local structure of a supercooled Lennard-Jones liquid is a result of com petition between FCC and icosahedral local symmetries [11].

The concept of interacting clusters was used in phenom enological theories of bond orientational order [12, 13] or "orientationalm elting" [14, 15]. The m icroscopic approach to description of the bond-orientational order (or hexatic phase in two dim ensions) was developed in [11, 16, 17, 18]. In the present Letter we use this approach to analyze the intercluster interaction and to introduce the m odel of glass transition in a Lennard-Jones liquid which elucidates the structural properties of the corresponding glass.

Our starting point is the expression for the free energy of the system as a functional of a pair distribution function $g_2(r_i;r_0)$ which has the form [11, 16]:

Here $S_{k+1}(r_1::r_{k+1})$ is the irreducible cluster sum of M ayer functions connecting (at least doubly) k + 1 particles, is the mean number density, $(r r_0)$ - interparticle potential, = h=(2 m k_B T)¹⁼².

In an isotropic liquid pair distribution function $g_2(r;r_0)$ depends on jr r_0 jonly: $g_2(r;r_0) = g(jr r_0j)$, where g(r) is the radial distribution function. In the state with bond orientational order rotational sym m etry of the pair distribution function is broken:

 $g(r;r_0)$ has the symmetry of the local environment of the particle at r_0 and may be approximately written in the form [11, 16]:

Here determines the direction of the vector r r_0 , and r_s is the size of the cluster, which is approximately equal to the diameter of the rst coordination shell. Function f () gives the probability of cluster orientation and may be expanded in a series in spherical harmonics:

In expansion (4) only the terms corresponding to the bcalcluster symmetry should be retained. Coecients f_{lm} are the order parameters for the phase transition to the anisotropic phase.

To estimate the intercluster interaction, let us expand the free energy (1) up to the second order in $g(r;r_0)$. Om itting the -independent terms, one has:

The angles $_1$ and $_2$ determ ine the directions of the vectors $r = r_1$ r_0 and $r^0 = r_2$ r_0 .

A fter substituting (3) and (6) in (5) we obtain:

Function F (r_s) may be interpreted as the mean-eld orientational interaction energy of the system of clusters having the size r_s . To get the full energy of the system one should integrate (7) over the probability of noting the cluster with the size r_s which is given by the function $r^2g(r)$ in the vicinity of the rst maximum.

As was shown in [11] there is a simple approximation for $(r_1; r_1^0; r_2)$ which gives rather good results for the Lennard-Jones potential $_{LJ}(r)$:




FIG.1: $J_1(r_s)$ for l = 4 and 6 along with $r_s^2 g(r_s)$ in the vicinity of the rst peak as functions of r_s for dimensionless temperature T = 1.0 and density = 1.2.

U sing Eq. (8) one can obtain the estimation for $J_1(\mathbf{r}_s)$ as a function of \mathbf{r}_s . Fig.1 represents $J_1(\mathbf{r}_s)$ for l = 4 and 6 along with $r^2g(\mathbf{r})$ in the vicinity of the rst peak. It is seen that $J_1(\mathbf{r}_s)$ changes sign. From Eq. (7) and Fig. 1 one can conclude that the frustration appears as a result of variations in the sizes of clusters due to local density

uctuations. Such kind of behaviour leads to frustration which is analogous to that in spin glasses.

To study the transition in the system of interacting clusters we introduce the simple lattice H am iltonian:

The functions U_{lm} ($_{\rm i}$) the lattice harm onics for the space groups corresponding to the cluster symmetry. Taking into account that < U_{lm} ($_{\rm i}$) >= f_{lm}, one can see that in the M F approximation the energy calculated from Eq. (9) coincides with the intercluster energy (7) under appropriate choice of $J_{\rm ij}^1$.

To simplify the problem we neglect in H am iltonian (9) all the terms except for the ones corresponding to the unit representation of the space group. Furtherm ore, we consider only the cases l = 4 and l = 6 which represent the cases of cubic and icosahedral symmetries. This Ising-like modelm ay be called a "m inim al" model. The H am iltonian of the m inim alm odel has the form :

Functions \hat{U} U(';) are the combinations of the spherical harmonics. We will consider separately symmetries of "simple" cube (l = 4;m = 0; 4), cube (l = 6;m = 0; 4) and icosahedron (l = 6;m = 0; 5) correspondingly [13, 21]. The trace in this case is de ned as follows: Tr(:::) $_{0}^{2}$ d' $_{0}^{2}$ dcos()(:::). For example, for l = 4 one has:

The interactions J_{ij} are such that the M F approxim ation gives exact solution (an in nite-range interaction). It is easily seen that in the minimal model (10) without disorder in the fram ework of the M F approximation there is a rst order phase transition to the state with bond orientational order. From Fig. 1 it is clear that, as the rst approximation, J_{ij}^{l} may be random interaction with G aussian probability distribution.

Then the free energy in the replica-symmetric approxim ation is equal to [19, 20]:

Here t = $\mathfrak{F}=k_{B} T$ and

The order parameters are: m is the regular order parameter (an analog of magnetic moment in spin glasses), q is the glass order parameter and p is an auxiliary order parameter. The extrem um conditions for the free energy




FIG. 2: Order parameters m and $q^{1=2}$ as functions of $T=\mathcal{J}$; $\mathcal{J}_0 = 0$. Dotted vertical curve shows the temperature $T_{A_{-T}}$ which separates stable and unstable regions of the replica symmetric theory; the glass transition occurs at $T_{A_{-T}}$. "Simple" cube corresponds to l=4; m = 0; 4, cube to l=6; m = 0; 4 and icosahedron to l=6; m = 0; 5.

(13) give the following equations for these order param - eters:

where h:::i = Tr(:::e)=Tre and $\overline{(:::)} = \prod_{1}^{n} \frac{pdz}{2}e^{z^2-2}$ [:::]. The temperature dependence of the order parameters is represented in Fig.2. One can see that the glass phase grows smoothly upon cooling. The similar behavior takes place in a quadrupolar glass [19, 20, 23]. It is not clear now whether the appearance of the nonzero bond-orientational order is an artifact of the model or an inherent property of the glass transition in the Lennard-Jones system.

We de ne the transition temperature as the replica symmetry breaking temperature. The replica symmetric solution is stable unless the replicon mode energy $_{\rm repl}$ is nonzero [20, 22]. For our model we have




FIG. 3: Evolution of the temperature $T_{A_{T}}$ with $J_0=J'$ is shown in the gure for the symmetries of cube and icosahedron for l = 6; below $T_{A_{T}}$ the replica symmetric MF solution becomes unstable. The free energy F $(T_{A_{T}} (J_0=J'))=N k_B T_{A_{T}}$ is shown in the inset.

where hh:::ii denotes the irreducible correlator. The tem perature T_{A} , corresponding to $_{rep1} = 0$ de nes the

glass transition. In the Fig. 3 we plot the dependence T_{A_T} on \mathcal{G}_0 for l = 6. From Fig. 3 one can conclude that in the vicinity of the glass transition the cubic local symmetry appears rst and, taking into account the contribution of the terms with l = 4, is preferable for the Lennard-Jones glass. This conclusion is in agreement with the result in Ref. [11], where it was shown that the correlation length of the cubic bond orientational order exceeds the icosahedral one.

From the condition of marginal stability [3, 6] we also evaluated numerically the so-called dynamical transition temperature T_D at $\mathcal{J}_0=0$ and found that within the accuracy of calculations T_D and $T_{\rm A}_{\rm T}$ coincide. One can expect that in them inim alm odel (10) full replica symmetry breaking should occur (as in the Sherrington-K irkpatrick model [4]) but further investigation is necessary to elucidate this question.

In sum m ary, using the approach developed previously for study of a bond-orientational order in sim ple liquids [11], we estim ated the orientational interaction between clusters consisting of a particle and its nearest neighbors. It is shown that there are ranges of density and tem perature where the interaction changes sign as a function of a radius of a cluster, the probability of a radius being determ ined by the radial distribution function of a liquid in the vicinity of the rst peak. The m odel of interacting cubic and icosahedral clusters was solved in m ean- eld replica symmetric approximation. Due to absence of re-

ection symmetry [20] the glass order parameter grows smoothly upon cooling. The transition temperature is identied with the temperature replica symmetry breakW e thank V.V.B razhkin for stimulating discussions.
