Probing hum an response times

Abstract

In a recent preprint [4], the tem poral dynam ics of an e-m ail network has been investigated by JP.Edkm ann, E.M oses and D.Sergi. Speci cally, the time period between an e-m ail message and its reply were recorded. It will be shown here that their data agrees quantitatively with the fram e work proposed to explain a recent experiment on the response of \internauts" to a new s publication [8] despite di erences in communication channels, topics, time-scale and socio-econom ic characteristics of the two population. This suggest a generalized response time distribution t¹ for hum an populations in the absence of deadlines with important implications for psychological and social studies as well the study of dynam ical networks.

1 Introduction

There can be little doubt that the W orld-W ide-W eb (W W W) and Internet e-m ail provides two of the most e cient m ethods for retrieving and distributing information. As such, it carries an enormous potential with respect to sale and m arketing of all kinds of products. A rather troublesom e feature from a research perspective of many \old-age" com m unication channels, such as new spapers, radio and TV, interpersonal contacts and so forth, is that the di usion of information through these channels is in general very di cult and/or time consum ing to probe. This is not so with the W W w and e-m ail. The fact that these com m unication channels are com puter-based and access in principle unrestricted provides a rather unique opportunity to study in realtime how fast individuals respond to a new piece of information. It is generally believed that the rate of di usion of information in a given population depends on a num ber of socio-econom ical factors such as education, cultural status, exposure to mass m edia and interpersonal channels etc. [1]. The evidence presented here propose otherw ise.

A long a complementary line of research the W W W has provide a similarly unique opportunity to study fast evolving (sociological or computer) networks [2]. M ost studies of the W W W have until now focused on the more easily accessed statistical properties such as the connectivity of the W W (the distributions of outgoing and incoming links etc.) and a consensus that the W W W is scalefree has been established. As the W W or any other sociological network is constantly evolving any such investigation can only deliver a \snap-shot" picture of the network. The assumption is then that the dynamical features of the network is reasonably stable over the time-scales considered and that the results are representative over time. However, in order to correctly describe networks between interacting hum ans one must estim ate characteristics speci c to the nature of the \nodes", e.g., psychological traits of hum ans, as one m ay otherwise be mislead when generalizing from a \snapshot" analysis. In fact, little is known about the internaut population's response to some external or internal event. W ith respect to commercial exploitation of the W W w it is obviously the response




Figure 1: Cumulative number of downloads N (t) as a function of time. The tisN (t) = a ln (t=b) + kt with a 583, b 0:80 days and k 2:2 days 1 .

of the internaut population to some new piece of information which is of prime interest and not the topology or connectivity of the underlying network itself.

The purpose of the present paper is to provide for a characterization of the psychological/sociological traits of interacting hum and in absence of form all deadlines. Using empirical data of response time distributions of internaut individuals/populations when exposed to a new piece of information, a surprisingly robust \law " for hum an response times will be put forward.

2 Response to an Internet Interview : Experiment I

The N asdaq crash culm inating on Friday the 14th of A pril 2000 caught m any people with surprise and shook the stock m arket quite forcefully. As always, m any di erent reasons for the crash were given ranging from the anti-trust case against M icroSoft to an \irrational exuberance" of the participants on the stock m arket. The author also had bid for the cause [3], which was m ade public on M onday the 17th of A pril 2000 on the Los A km os preprint server. As a result, a forty m inute interview with the author called \The W orld (N ot) A coording to GARCH " was published on Friday the 26th of M ay 2000 on a \radio website" (www.wallstreetuncut.com) In addition, the URL to the author's papers was announced m aking it clear that work on stock m arket crashes in general and the recent N asdaq crash in particular could be found using the posted URL. As the m ain subject of the interview was a som ew hat technical discussion about whether stock m arket crashes could be predicted, it seem s reasonable to assume that the population in a socio-econom ic context was relatively hom ogeneous. The experim ent proceeded as follows. The num ber of dow n loads of papers from the authors hom epage as a function of time (days) from the appearance of the interview was recorded. In gure 1, the cum ulative num ber of dow n loads N (t) as a function of time t after the appearance of the interview is shown on a

sem i-logarithm ic scale. The data is over one and half decade surprisingly well-captured by the relation

Here k represents a constant background rate. A fler approximately 60 days, the data breaks away from the tted line. The reason is the appearance of the author's URL on the Social Science Research Network server (www.ssm.com) causing a second advertisement. Hence, the experiment became inuenced by an additional distribution channel and was consequently halted after 69 days.

3 Response times in Email Interchange: Experiment II

In a recent preprint [4], the tem poral dynam ics of an e-m ail network has been investigated by JP. E ckm ann, E. M oses and D. Sergi. Speci cally, the time period between an e-m ail message and its reply was recorded. The data set contains 3188 users interchanging 309129 m essages and was obtained from the log-les from one of the m ain m ail servers of an university. In one sense, this experiment is the \ckenest" as only a single distribution channel can exist. However, as each em ailmessage contains di erent information it is also the \dirtiest" with respect to the information distributed. Furthermore, it seems reasonable to assume that the population in a socio-econom ic context is quite heterogeneous opposed to that of the rst experiment. In gure 2, we see that the cumulative distribution of time periods between an e-m ailmessages and its reply N (t) can be modeled in terms of a response time t of the recipient of the e-m ailmessage,

Here the constant c as a rst approximation incorporates the fact that the measured time is not the true response time. The prime reason for the \shift" c is that most people do not download new e-mail m essages instantaneously but instead every 10 m inutes or so. Furtherm ore, som e tim e is obviously needed in order to formulate and write the reply. The values of the t parameters are a = 0.14, b = 0.21 and c = 0.25, see qure caption for details of the tting procedure. We clearly see that equation (2) is an excellent approximation of the data over three decades. An additional feature of the data that can be rationalized is the rst \ wiggle" occurring around 10 16 hours. M any people send e-m ail m essages just before leaving their work place. Since people generally share the sam e working hours (provided that they live in the same time zone), those messages are not answered before the next day. The main result to be extracted from this experiment compared to the previous one is that the response time distribution of the population exposed to new information is independent of the speci c nature of the new inform ation. This suggest that the observed behaviour indeed has its origin in psychological traits of the population. Furtherm ore, it should be noted that whereas the previous experiment deals with time scales of up to 2 months, this experiment deals with time scales up to only one week, i.e., a di erence in time scales of approxim ately a factor often. Nevertheless, the same distribution is obtained. This suggest that the di erence in time scales are mainly due to di erences in communication channels, i.e., im personal or personal.

4 D iscussion

The results show n in gures 1 and 2 suggests that the general response rate of a hum an population n (t) is that of a power law n (t) 1=(t+c) where c depends on the details of the distribution channel(s) used.




Figure 2: Cumulative distribution of responses as a function of time. The tisN (t) = $a \ln ((t + c) = b)$ with a 0:14, b 0:21 hours and c 0:25 hours. Due to the \wiggles", the thas been stabilized by rst estimating c from the data and then thing a and b keeping c xed.

Such power law dependence of the rate of \events" are found in both natural and sociological system s. Two quite di erent examples are the Om ori law for the rate of aftershocks as a function of time e lapsed since the main shock [5] and the distribution of returns in the SP 500 exceeding a speci ed threshold as a function of time elapsed since the \m ain event", i.e., the \crash", [6]. A m ore appealing analogy, at least on a qualitative level, is provided by the relaxation of spin glasses subjected to a magnetic eld: At time tafter the appearance of the interview (experiment I), the exposed population consists of two groups, namely those who have not down baded a paper and those who have. Sim ilarly with respect to experiment II, at any time t the population considered consists of two groups, namely those who have an e-m ail to answer and those who have not. The transition from the rst state to the second dem ands the crossing of some threshold speci c to each individual. We thus im agine that the announcem ent of the URL/the reception of emails plays the role a \ eld" to which the exposed population is subjected and study the relaxation process by monitoring the number of down loads/the number of replies as a function of time. Hence, we may view the process of down loading/replying as a di usion process in a random potential, where the act of down bading/replying is similar to that of a barrier-crossing in the Trap m odel of spin glasses [7]. The m ost pressing unanswered question raised by the two experiments is whether the observed power law only is a characteristic of the entire population or if it is also true for an individual over time. A qualitative argument that \ensemble averaging" may be the same as \time averaging" on the individual level (\ergodicity") is that people react very di erently to the same piece of information, i.e., one cannot generally deduce why people react on a speci c piece of information. The reason is that individuals perceive the same piece of inform ation quite di erently due to individual psychology despite similar socio-economical status, e.g., not all rich people have an ambition to get richer because of the risk and/or work-load involved. This interpretations is supported by the results from the second experiment, where the new piece of information is changes with time and individual

and nevertheless we get the same functional relationship between the time of the presentation of the new information and the response time distribution of the population. However, it seems a prioria quite form idable task to empirically verify whether these considerations are valid or not.
