## Solvation vs. freezing in a heteropolym er globule

## Abstract

W e address the response of a random heteropolym er to preferential solvation of certain m onom er types at the globule-solvent interface. For each set of m onom ers that can comprise the m olecule's surface, we represent the ensemble of allowed congurations by a Gaussian distribution of energy levels, whose m ean and variance depend on the set's composition. W ithin such a random energy m odel, m ean surface composition is proportional to solvation strength under m ost conditions. The breadth of this linear response regime arises from approximate statistical independence of surface and volume energies. For a diverse set of m onom er types, the excess of solvophilic m onom ers at the surface is large only for very strong solvent preference, even in the ground state. A polymer chain collapses into a compact globular state in poor solvent. A chain with quenched sequence of chemically di erent units can further undergo a freezing transition, in which the freedom of chain shape uctuations is sacri ced for the choice of optim al spatial contacts between m onom ers. This freezing, or folding, is subject to constraints in posed by chain connectivity, quenched sequence, and excluded volum e. The e ects of frustration due to these constraints are well understood [1, 2, 3]. However well developed, current theories of heteropolymer freezing ignore one obvious fact, namely that some chain segments are m ore favorably solvated than others. By contrast, m uch of the protein literature presumes preferential solvation to be a leading determinant of tertiary structure. It is commonly held that a protein's surface is composed of hydrophilic units, while hydrophobic units are invariably buried in the core.

For heteropolymers in general, it is clear that energy gained through preferential exposure of solvophilic units comes at a cost. Constraining particular units to the globule surface restricts the selection of contacting monomer pairs inside the globule, exacerbating frustration. In other words, when the sequence of units has not been designed in an intelligent way, as is the case for the random sequence heteropolymer, preferential exposure may signic cantly reduce the availability of low energy conformations. The question thus arises: what is the e ect of solvation on heteropolymer freezing, or more specic cally, how large an excess of solvophilic units at the globule surface is consistent with freezing?

This question was rst discussed by two of us [4] in the context of studies of mechanical stretching of heteroplymers. Using a replica approach, we found that solvent preference of strength for particular monomers at the surface lowers ground state energy  $E_g$  by an amount K<sup>2</sup>=T<sub>fr</sub>. Here, K N<sup>2=3</sup> is the number of monomers exposed to the solvent, N is the number of monomers comprising the molecule, and T<sub>fr</sub> is the freezing temperature below which the ground state dominates. For strong solvation this approach apparently fails. In particular, K <sup>2</sup>=T<sub>fr</sub> can exceed the maximum possible solvation energy (without distortion of globule shape), K , corresponding to a completely solvophilic surface.

This Letter describes a more comprehensive treatment of solvation based on the R andom Energy M odel (REM) of D errida [5]. It is well known [1, 2, 3, 6] that this simplest m odel of freezing in spin glasses captures remarkably well the essential features of heteropolymer freezing in three dimensions. The mapping of heteropolymer problem on the REM is achieved by approximating energies of all  $M = e^{sN}$  di erent conformations of a random sequence heteropolymer as M independent random variables drawn from the Gaussian distribution w (E) / exp E  $\overline{E}^2 = 2N^2$ . In the volume approximation, when energy of every conformation is solely due to N m onomer-m onomer contacts, this distribution is fully determined by the mean  $\overline{B}$  and variance  $B^2$  of contact energies, so that  $\overline{E} = N \overline{B}$  and  $^2 = B^2$ .

The simplest way to incorporate surface into this picture is to imagine that contacts between surface monomers and solvent are also, in elect, statistically independent random variables. The variance of surface energy, K<sup>2</sup>, then adds to that of volume energy. We use the saddle point of the partition function,  $Z = e^{sN} e^{R} dE w$  (E)  $e^{E} = T$ , to estimate the energy of representative conformations,  $E = \overline{E} = N e^{2} = T K^{2} = T$ . The lower bound of the spectrum is reached when  $e^{sN} w$  (E) '1, yielding a typical ground state energy:

Correspondingly,  $T_{fr}' = B = 2s$ . The nalterm in Eq. 1, i.e., the change in ground state energy due to solvation, is (within a factor of order unity) K<sup>2</sup>= $T_{fr}$ , just as found in the replica approach of Ref. [4].

There are several reasons to be skeptical of the suggested independence of surface and volum e energies. First, removing a speci c set of monom ers from the globule interior to the surface modi es the distribution of contacting monom ers. Secondly, there are a nite num ber of solvophilic monom ers in a given molecule (possibly fewer than K). When a large fraction is placed on the surface, the supply of solvophilic monom ers is strongly depleted, and solvation energy saturates. Finally, certain choices of surface monom ers constrain conguration space more strongly than others.

We exam ine these e ects using a model in which each monom er is labeled by a quenched variable . When a monom er with label resides on the surface, it is assigned a solvation energy . Solvophilic species are thus characterized by > 0, while < 0 for solvophobic species. In its total e ect the solvent preference can be viewed as an external eld that couples linearly to net surface composition,  $C_{surf} = \frac{P}{12 \text{ surf}} i$ . W ithin the globule, a contacting pair of monom ers, of type and  $^{\circ}$ , is ascribed energy B  $_{\circ} = \overline{B} + B = ^{\circ}$ . For simplicity we restrict attention to distributions of monom er types, p(), with zero mean and unit variance:

In agine that a certain set of m onom ers is constrained to sit on the surface. We denote this set as G. In our model energetic consequences of such a constraint depend only on the distribution, f(), of m onom er types in G. For example, the elective distribution of contacting m onom ers (i.e., those remaining inside the globule when G is removed),  $p_e()$ , m ay be written as  $p_e() = p() + \frac{K}{N} [p() f()]$ . The elective mean and variance of contact energies are then  $\overline{B}_e = \overline{B} + (K = N)_G$  and  $B_e = B + (K = N)_G$ , respectively. For distributions satisfying Eq. 2,  $_G = 0$  and  $_G = 2 B^2 [1 P ( - 1)]$ . Similarly, the solvation energy per surface monom er is  $_G = P ( - 1) P ( -$ 

We express the number of accessible conformations when all monomers in G are conned to the surface as  $M_G = e^{N - K + e_G}$ . Here,  $e_G$  is the entropy loss per surface monomer for particular of G. Though smaller than M,  $M_G$  is still exponentially large in N. In general  $e_G$  is not simply a functional of f(0), but is instead a complicated function of G. We will assume that for any species of f(0), the average of  $e_G$  over all consistent realizations of G is a constant independent of f(0). In order to recover the appropriate total number of conformations after summing over G, we choose this constant to be  $T = K^{-1} \ln \frac{N}{K}$  ' ln (N e=K).

We consider a separate REM for each possible choice of surface G. In doing so, we assume that allowed conform ations in the corresponding subensembles are su ciently diverse that their energies are G aussian distributed, with

Ultimately, we must reconstruct the fullensemble of compact chain uctuations by superposing all possible subensembles, i.e., by summing over G. This convolution of REM s, each representing a distinct choice of G, constitutes our caricature of a random heteropolymer with solvated surface.

Consider the ground state of the full ensemble, i.e., the lowest of subensemble ground state energies,  $E_g = m in_G E_g$  (G). Interfacial energy clearly favors a solvophilic surface, but does it yield the lowest ground state? Let us rst exam ine a typical value of  $E_g$  (G) for speci cG. The condition  $M_G w_G [E_g^{(typ)} (G)]'$  1 yields:

This most probable ground state energy is indeed m inimized by an exclusively solvophilic choice of G. There are many distinct choices of G, however, leading to the same value of  $E_g^{(typ)}$  (G). It is therefore crucial to account for variations in  $E_g$  (G) among similar subensem – bles. A coording to the statistics of extrem e values[7], the probability that the low est energy in a particular subensem ble deviates from  $E_g^{(typ)}$  (G) by an amount  $E_g$  (G) =  $E_g$  (G)  $E_g^{(typ)}$  (G) is

C om pared to the G aussian distribution of energies within a subensemble, W [ $E_g$  (G)] decays very slow by for  $E_g$  (G) < 0. When many subensembles share a common value of  $E_g^{(typ)}$  (G), their range of  $E_g$  (G) will be broad.

The vast majority of subensembles have unremarkable surface energy. The number with  $j_{surf}(G)j = K$  and  $E_g(G) = E$  is thus roughly  $e^{TK} W$  (E). Since the tail of W [ $E_g(G)$ ] is exponential, we expect 0 (1) of the subensembles with insigning cant surface energy to have  $jE_g(G)j=0$  (K). In other words, the variations in volume energy among these subensembles are comparable in magnitude to the largest possible surface energy. This result may be viewed as the consequence of an elective entropy that remains in portant even at low temperature. The collection of subensembles with appreciable surface energy is much smaller than  $e^{TK}$ , and its entropy is correspondingly low. The ground state surface is uniform ly solvophilic only when solvent preference is strong enough to oligit to get this entropy cost.

Because  $w_G$  (E) depends only on f(), it is natural to group all subensembles with the same number density of m onom er types. We have shown that accounting for the disparity in sizes of these groups is essential. The number of ways to choose K m onom ers with distribution f() from a pool of N m onom ers with distribution p() is  $e^{N \operatorname{sffg}}$ , where

The density () K f() = N p() and its corresponding entropy, sffg, are precisely those relevant for Langmuir adsorption of an ideal gas mixture onto K distinguishable sites.

At and above the freezing tem perature, equilibrium of a subensemble group is dominated by the saddle point of the partition function

Volume terms independent of f () have been collected as  $\overline{F} = N = \overline{B}$  Ts  $\hat{B} = 2T \cdot Ac-$  cording to Eqs. 9 and 10, the binding energy in our analogy to Langmuir adsorption varies with particle type as  $(B^2=T)^2$ .

The full partition function of the polymer, a sum over all Z ffg, is dominated by the subensemble group with lowest free energy:

W e calculate the optim al surface distribution, f (), variationally, using a Lagrange multiplier to enforce proper norm alization of (). We thereby obtain

Finally, evaluating F ffg at f ( ) yields our approximation for the total free energy F =  $\overline{F} + F_{surf}$ , with

Eqs. 12{14, appropriate for T  $T_{fr}$ , are our principal results. They express the equilibrium distribution of m onom er types on the polym er surface and the corresponding interfacial free energy density in terms of m odel parameters and an e ective fugacity for surface m onom ers,

In order to make these results concrete we consider some limiting cases and speci c forms of p(). First, let us assume that preferential solvation does not lead to a signi cant depletion of any monomer type inside the globule, so that K f() N p() for every . Then, Eq. 12 requires that  $e^{()}$  1, simplifying the above expressions to yield f() / p() exp[()] and

To simplify this result even further, let us consider a binary distribution, p() = (1=2)[(+1)+(1)], which corresponds to the minimum of chemical diversity. In this case depletion is invariably weak, since taking K m onom ers away to the surface cannot exhaust the total stock, N=2, of either m onom er type. Eq. 15 then trivially yields

For =T  $1, F_{surf}$  / K <sup>2</sup>=2T, precisely as obtained by assuming statistical independence of surface and volume. Since net surface composition is conjugate to solvation strength, its equilibrium value may be computed by dimensioning Eq. 16 with respect to , yielding:

In this limit net surface composition is proportional to the  $\ \text{eld}$ ". The above results may therefore be understood in simple terms as a manifestation of linear response. From Eq. 17 we identify a susceptibility ' K=T, corresponding to surface uctuations of size  $hC_{surf}^2 i_{=0} = K$  in the absence of solvation. In other words, the excess of solvophilic monomers at the surface is governed by K electively independent random variables. This simple behavior results directly from the prevalence of variations in volum electron surface interactions. But when ' T, solvation wins out. Linear response then breaks down due to saturation, as  $F_{surf}=K$  and  $C_{surf}$  approach their limiting values of and K.

Properties of the ground state are obtained by evaluating Eq. 17 and 16 at  $T = T_{\rm fr}$ . Dependence on the interaction parameter B is implicit (through  $T_{\rm fr}$ ) below the freezing transition. For  $T > T_{\rm fr}$ , however, surface response is insensitive to B. In particular, <sub>G</sub> vanishes, since no binary choice of f() can change the second moment of the contact energy distribution. As a consequence, surface and volume behave independently for arbitrary

The opposite extreme of monomer diversity is described by a smooth form of p(), describing a continuous variety of chemical identities. We take a Gaussian distribution,

 $p() / exp(^{2}=2)$  as a simple example. For weak solvation, =T < 1, p() is now here significantly depleted, and Eq.15 remains an appropriate approximation. Gaussian integration yields

to leading order in B=T. (The basic assumption that monom er contacts are statistically independent is plausible only for  $B=T_{fr}=\frac{p}{2s}$  1[8].) The rst term in Eq. 18 again re ects linear response. The second term describes the bene t in monom er contact energy due to partial removal of some monom er types from the globule interior. This e ect is independent of solvation strength to leading order and dom inates interfacial free energy for very small .

For such a diverse set of m onom ertypes, surface response saturates only when a m olecule's supply of the m ost solvophilic type is exhausted. A ssum ing weak depletion is clearly inappropriate here. A maxim ally solvophilic surface is obtained when K f () = N p() for  $m_{ax}$ , and f () = 0 for  $m_{ax}$ . The cuto point  $m_{ax}$  is determined by normalization:

For G aussian p(), Eq. 19 gives  $_{max} = \frac{q}{2 \ln (N = K)}$ ,  $\frac{q}{(2=3) \ln N}$ . Because this choice of surface composition uniquely species a monomer set G, the associated entropy sffg vanishes. Free energy is then easily estimated from Eq. 9, giving  $F_{surf}=K$ ,  $m_{ax}$ . C om – paring this result with the free energy of linear response, we estimate that saturation occurs around,  $2T_{max}$ ,  $T^{p}$  in N. Reaching this crossover may thus require much stronger solvation, and result in more favorable surface energy, than in the binary case. The relevant distinction between these distributions is the existence of extrem ely solvophilic monom ers, whose small numbers entail considerable entropic cost in constraining them to the surface.




FIG.1: Response of a random heteropolymer to surface solvation, shown in the plane of tem perature T and solvation strength . Crossover lines are the result of equating free energies, or ground state energies for T <  $T_{\rm fr}$ . For a binary distribution of m onom er types, the weak response regime is absent, and  $m_{\rm ax} = 1$ .

Fig.1 sum marizes the mechanisms of surface response we have identified. These results support a view of surface solvation energy and volum elenergy as statistically independent random variables. In particular, the linear response corresponding to this notion is valid over a wide range of temperature and solvation strength. Saturation at large , though a nonlinear elect, does not truly arise from correlation of surface and volum e. It is instead a consequence of the nitude of surface area or of the number of solvophilic monom ers. The regime of weak response, in which  $F_{surf}=K$   $B^4=T^3$ , does reject coupling of surface and volum e. But it involves monom er contact energies alone, as indicated by insensitivity to

. Within our model, contributions from more intimate connections between surface and volume are small compared to unity when K N.

The diversity of am ino acid m onom ers com prising proteins lies som ewhere between those of binary and G aussian distributions. The surface behavior we have described should thus be relevant for chains of these units arranged in random sequence. Speci cally, we predict that preferential solvation m ust be m uch larger than typical therm al uctuations in order to stabilize a strictly solvophilic surface. Sequences found in nature, how ever, are not random in at least one respect in portant to freezing. Their ground states lie well below the e ective continuum of non-native energies. The in uence of this energy gap on surface solvation requires a consideration of sequence design that is beyond this discussion.
