## Traveling Front Solutions to D irected D i usion Lim ited Aggregation, D igital Search Trees and the Lem pel-Ziv D ata C om pression A lgorithm

W e use the traveling front approach to derive exact asymptotic results for the statistics of the number of particles in a class of directed di usion limited aggregation models on a Cayley tree. W e point out that some aspects of these models are closely connected to two di erent problems s in computer science, namely the digital search tree problem in data structures and the Lem pel-Z iv algorithm for data compression. The statistics of the number of particles studied here is related to the statistics of height in digital search trees which, in turn, is related to the statistics of the length of the longest word form ed by the Lem pel-Z iv algorithm. Im plications of our results to these computer science problem s are pointed out.

I. IN TRODUCTION

The simple model of di usion limited aggregation (DLA), ever since its introduction by W itten and Sander in 1981 [1], has continued to play a central role in understanding the fractal grow th phenom ena. B esides raising a num ber of conceptual issues regarding pattern form ation, thism odel has also found num erous applications in physical processes ranging from dielectric breakdown [2] and Hele-Shaw uid ow [3] to electrodeposition [4] and dendritic growth [5]. In the sim plest version of this model, one considers, for example, a square lattice where the origin is a seed. Particles are released sequentially from the boundary. Each particle perform sa random walk in space and when it com es in contact with the growing cluster around the central seed, it sticks to the cluster and thus the cluster grows. This growing DLA cluster has a fractal structure with m any branches that are separated by deep 'fiprds'. Despite various advances, characterizing this fractal pattern quantitatively has remained a major theoretical challenge for the past two decades [6]. One clear picture that has emerged out of various studies is that the key e ect responsible for this complex pattern is the dynam ical 'screening' : a new ly arriving particle has m ore probability to attach to the 'tip' sites com pared to other boundary sites that are deep inside a Yjord'. As a result, the faster growing parts of the cluster boundary shield or screen other boundary sites from further grow th.




FIG.1. A typical history of the DDLA process till saturation on a Cayley tree with height l = 4. The occupied nodes contain a black led circle inside them and the number next to an occupied site denotes the particle number.

To understand this dynam ical screening e ect more quantitatively, it is desirable to construct a simpler model which incorporates the screening e ect and yet is analytically tractable. Bradley and Strenski [7] introduced such a model where particles undergo a directed di usion lim ited aggregation (DDLA) on a Cayley tree. Physically this corresponds to the situation when there is a strong external eld such as the gravity or an electric eld which forces the particles to choose an overall direction of m otion. In this D D LA m odel, one starts with a C ayley tree of height 1 (see Fig. 1) where all the  $2^1$  1 sites of the lattice are initially empty. Then a particle is introduced at the top site and it performs a directed (downwards) random walk (from any site it chooses one of the two daughter sites at random and m oves there) till it reaches one of the bottom leaves and can descend no m ore. It then occupies that leaf site.

Then a second particle is introduced from the top site and it also performs a directed random walk. This second particle will stop if it happens to reach a site such that atleast one of the daughter nodes of that site is already occupied. It can not descend any m ore and it rests at that site for all subsequent times. Note that in this m odel, each site can contain at m ost one particle. Then a third particle is released from the top and so on. B asically, after reaching any site, say the i-th site, a particle

attem pts to hop down to one of the two daughter nodes of i and it actually m oves to the target site provided both the daughter nodes of i are empty. If at least one of them is occupied, the particle can not descend any further and it rests at site i forever. Then the next particle is added and the process continues until no m ore particles can be put in, i.e. when the top site gets occupied. The tree is then said to be saturated. One such history of the process till its saturation is shown in Fig. 1. A typical snapshot of the saturated tree (see Fig. 1) shows that the cluster has voids of various sizes. A useful quantity to characterize the pattern of the cluster is the total num ber of particles  $n_1$  in the saturated tree. C learly  $n_1$  is a random variable, varying from one history of the process to another. The quantities of central in portance in this problem are the average density,  $1 = m_1 i = [2^1 \ 1]$  and the

uctuations of n around its average value. How do these two quantities behave asym ptotically for a large tree, i.e. when 1! 1?

W hile it was easy to write down the basic recursion relations (see later in Section II) for certain probabilities associated with the DDLA process on a tree, they turned out to be nonlinear [7] and hence it was di cult to determ ine even the asymptotic behavior of 1 for large 1. Bradley and Strenski studied the recursion relations num erically and found, som ew hat unexpectedly, that  $_1$ decays slow er than exponentially with 1 for large 1 but the precise nature of this decay was not evident from their num erics [7]. Later A ldous and Shields [8] studied via rigorous probabilistic m ethods a com pletely di erent m odel namely a continuous time version of the so called digital search tree (DST) problem relevant in computer science [9,10,8,11{14]. As we will see later in Section-VI, these two models namely the DDLA and the DST share the sam e recursion relation, though for very di erent quantities. The rigorous results of A blous and Shields [8], when translated back in the DDLA language, would indicate a streched exponential decay for the average den-2<sup>1</sup> for large 1. Recently a more re ned sity, 1 result on DST was derived by Knessland Szpankowsky [15]. Unaw are of the DDLA or the DST model, Hastings and Halsey also studied independently a related model recently [16] and used extrem al argum ents to conclude the sam e streched exponential decay for the average density.

The m ethods used by the m athem aticians, though rigorous, lack physical transparency. On the other hand, the extrem al arguments used by Hastings and Halsey, though physically intuituive, are heuristic. Moreover, it is not easy to derive quantitative results regarding uctuations of the number of particles  $n_1$  via these m ethods. For example, how does the width w (l) =  $m_1^2 i m_1 i^2$  behave as a function of l? Besides, none of these m ethods are easily adaptable to extract the leading asym ptotic behaviors in more general models such as one that we will

consider in this paper. Our approach in this paper would be to use the powerful techniques (suitably adapted for our problem) of traveling fronts, originally developed in the context of nonlinear reaction-di usion systems and population dynamics [17{19]. The techniques of traveling fronts have found a host of very useful applications [20]. Recently we have pointed out that in m any extrem e value problems in both physics and com puter science, one can successfully use the traveling front techniques to derive exact asym ptotic results for the statistics of the extrem um of a set of correlated random variables [21{24]. The present paper points out yet another useful application of the traveling front techniques, nam ely in a generalized D D LA problem with relevance to a class of search tree problems in com puter science.

The traveling front method, though technically not rigorous in the strict m athem atical sense, has the follow ing advantages over the other methods used in the DDLA problem : (i) this method is not model speci c, is more general and is easily adapdable to more general models such as the ones that will be studied in this paper, (ii) it is easy to im plem ent and is physically transparent and (iii) it provides a very cheap way to extract the leading asym potic behavior exactly without using too much mathematics. Besides rederiving the known results in the standard DDLA problem, this method also allows us to derive m any new results in m ore generalized m odels. For example, we show that in the DDLA model, the random variable  $n_1$  approaches to its average value, n!  $m_1$  in the l! 1 limit. This is the example of the extrem e concentration of m easure, i.e., the distribution of  $n_1$  tends to a delta function. In particular, we show that the width of the distribution decays slow ly as 1<sup>1=2</sup> as 1! 1. Furtherm ore, we a power law, w (1) point out the close connection between the DDLA problem and the DST problem widely studied by computer scientists [9,10,8]. The later problem is also related to the wellknown Lempel-Ziv algorithm used in data compression [25]. Som e of the results derived in this paper will constitute new results in these computer science problem s.

The rest of the paper is organized as follows. In the next section we introduce a generalized b-D LA m odel (where b is a positive integer). The original D LA m odel of B radley and Strenski is a special case of this b-D D LA m odel with b = 1. We then derive the asymptotic statistics of the number of particles in the b-D D LA m odel using the traveling front technique, suitably adapted for this m odel. In Section III, we generalize these results to the case when the Cayley tree has m > 2 branches. Section IV considers the D D LA m odel with a bias when a particle has m ore probability to go to the left branch com pared to the right one. In Section V, we point out the detailed connections between the D D LA m odel, the D ST problem in com puter science, and the Lem pel-Z iv parsing algorithm and discuss the in plications of our re-

sults for the generalized b-DDLA model in the context of computer science. Finally a brief summary and a conclusion along with a list of open problems are o ered in Section VI.

# II. THE B-DDLA MODEL AND ITS TRAVELING FRONT SOLUTION

Here we introduce a generalized b-D D LA m odel where the hard' screening of the usual DDLA model is 'softened' in the following sense. As in the usual DDLA model, one starts with an empty Cayley tree of height l and the particles are introduced sequentially at the top site and they go down the tree one at a tim e by perform ing a random walk. However, now each site can contain at most b particles where b is a positive integer. During its journey downward, when a new particle arrives at an empty site, say the i-th site, it tries to move to one of the daughter nodes of i chosen at random . It actually m oves to the target site provided both the daughter sites contain less than b particles. If either of them contains b particles, i.e. is completely full, then the incom ing particle can not move down any further and it then stays at site i forever. Thus, in this model, a site can incorporate Screening' if and only if it has full capacity, i.e. when it has b particles. O there ise it fails to screen. This model thus m in ics the physical situation when one single particle is incapable of stopping an incom ing particle to go down, but the screening com es into play only as a collective e ect when there are b particles in the site. This is like a tunnelling e ect, where a particle can go through a barrier provided the barrier is not too high. However, the rate of tunnelling goes to zero when the barrier height crosses a threshold. In our model, the parameter b acts like the threshold value. C = 1 this model reduces to the original DDLA model studied by Bradley and Strenski [7].

As in the b = 1 case, the tree is going to be saturated after a nite number of particles have been added to it. This happens when the top site contains b particles. No further particles can then be put in. The number of particles  $n_1$  required to saturate the tree of height 1 is clearly a random variable, uctuating from one history of the process to another. The main question we address is: what is the statistics of  $n_1$  for large 1? In particular, we would compute the average density at saturation,  $_1 = \frac{1}{q} \frac{n_1 i = [2^1 \quad 1]}{n_1 i^2}$  for large 1.

Following B radley and Strenski [7] for the b = 1 case, we de ne  $G_1(n)$  to be the probability that the tree of height l is not saturated after the addition of n particles, i.e. the top site is not yet led by b particles after n particles have been added to the tree. It is easy to see that  $G_1(n)$  satis es the following recursion relation,

for all 1 and n 0. It is useful to think of las 'space' and n as time'. The Eq. (1) is supplemented with the boundary' condition,  $G_1(n) = 1$  for all 0 n (b 1) and  $G_1(n) = 0$  for all n b and the 'initial' condition,  $G_1(n) = 1$  for 0 n (b 1) for all 1. The recursion relation in Eq. (1) is easy to understand. Suppose we have added (n + b) particles to a tree of height (l + 1)(the left hand side of Eq. (1)). The condition that the top site is not yet led by b particles indicates that before the addition of the last b particles, the two daughter nodes of the top site must have both remained unsaturated. This is because, if either one or both of them had been saturated after the addition of n particles, then any further added particle would not be able to go down and would rest at the top site, and hence the top site would then get saturated after the addition of (n + b) particles. The two daughter nodes are the roots of two uncorrelated subtrees, each of height 1. Hence the probability that both remain unsaturated is given by their product. A lso, the num ber of particles  $n_1$  that enter, for example, to the left subtree (out of a total number of n particles that enter both subtrees) must have a binom ial distribution, thus explaining the right hand side of Eq. (1).

Note that for xed n > 0, the probability  $G_1(n) ! 0$ as l! 1 and  $G_1(n)$ ! 1 as l! 1. For later analysis, it turns out to be convenient to de ne the complementary probability,  $F_1(n) = 1$   $G_1(n)$ , that has the opposite behavior as a function of l, namely  $F_1(n)$ ! 1 as l! 1 and  $F_1(n)$ ! 0 as l! 1 for any xed n > 0. The quantity  $F_1(n)$  denotes the probability that the tree of height l gets saturated before n particles are added. From Eq. (1), one nds that  $F_1(n)$  satis es the recursion,




FIG.2. Schem atic behavior of the probability  $F_1(n)$  as a function of 1 for di erent xed values of n. The three curves correspond to di erent values of n increasing from left to right. The y axis is dimensionless while the x axis has arbitrary units.

with the boundary condition,  $F_1(n) = 0$  for 0 - n(b 1) and  $F_1(n) = 1$  for n b and the initial condition,  $F_1(n) = 0$  for 0 - n (b 1) for all  $1 \cdot It$  is useful to think by xing the time' n while varying the space' 1. Clearly  $F_1(n) ! 0$  as  $1 \cdot 1$ , since almost surely a tree of in nite height will not be saturated before the addition a

xed, nite number n of particles. On the other side, for xed n,  $F_1(n)$  ! 1 as l! 0. For a given xed n, as one increases 1 from 0 to 1, the function  $F_1(n)$  starts o at the value 1 at l = 0 and then drops o to 0 beyond som e characteristic length scale 1 (n), as shown schem atically in Fig. (2). As n increases, this characteristic length scale 1 (n) also increases (see Fig. (2)), thus giving rise to a traveling front structure with the front located at 1 (n). In fact, we will see later that in the lim it of large 1 (when one can treat 1 as a continuous variable) and large n, the width w (n) of the front goes to zero, indicating that asymptotically the function  $F_1(n)$  becomes a Heaviside theta function,  $F_1(n)$  ! (1 (n) 1).

Note that Eq. (2) is nonlinear and hence is diffult to solve exactly. However, the exact asymptotic informations regarding the position 1 (n) of the front and its width can be deduced by adapting the traveling front techniques that were originally devised to deal with nonlinear partial di erential equations in reaction-di fusion systems [17] and pupulation dynamics [18,19]. The basic idea behind this approach is very sim ple. If there is a front 1 (n), then ahead of the front 1 > 1 (n),  $F_1$ (n) is very sm all and hence one can neglect the nonlinear term (the second term) on the right hand side of Eq. (2) and one simply gets a linear recursion,

Suppose one could solve this linear equation exactly satisfying the required initial condition. Now one expects that the solution of the linear equation (3) and the 'real' solution of the nonlinear equation (2) will coincide in the regime beyond the front, i.e. for l > 1 (n). On the other hand, the two solutions will start di ering from each other as one decreases l below 1 (n), where the solution of the nonlinear equation (2) will tend to 1 where as the solution of the linear equation (3) will grow beyond 1 with decreasing 1 (as there is no nonlinear term to control the solution). Thus, as one decreases 1 from in-

nity, the front position 1 (n) is approximately the value of 1 at which the solution of the linear equation becomes

O (1). Thus, according to this approach, one rst solves the linear equation (3) to obtain  $F_1(n)_{jinear}$  and then reads o the front position l(n) from the condition,  $F_{1(n)}(n)_{jinear}$  O (1). By O (1), one means that at l = l(n), the solution  $F_1(n)$  should not diverge or decay exponentially with increasing n. Note that this is a slightly generalized version of the usual traveling front m ethod [20,21] where one usually has a linear operator with constant coe cients which adm its an exponentially decaying solution of the form exp[ (x vt)] with constant width. The present approach is more general and works even when the linear operator does not adm it an exponentially decaying solution with a constant width.

Under this traveling front approach, our task thus reduces to solving the linear equation (3) which, however, is still nontrivial. To proceed, we de ne a som ew hat unusual generating function,

Using Eq. (3) one can then show that  $F_1(s)$  satis es a rather simple recursion in 1,

for all 1. The steps leading to Eq. (5), starting from Eqs. (3) and (4), are not completely straightforward. Hence we present this derivation in the Appendix. The recursion in Eq. (5) starts with the initial value  $F_1$  (s) which needs to be calculated separately. Noting that  $F_1$  (n) = 0 for 0 n (b 1) and  $F_1$  (n) = 1 forn b, we nd from the de nition in Eq. (4) $F_1$  (s) = 1=[s(1+s)<sup>b</sup>]. Iterating Eq. (5) and using the expression for l = 1, we get

We then write the sum inside the exponential in Eq. (6) in two parts using the Euler-M aclaurin summation form ula,  $S(l;s) = P_{11}^{1} \ln (1 + 2^k s) = I(l;s) + R(l;s)$  where  $I(l;s) = R_1 \ln (1 + 2^x s) dx$  and R(l;s) = S(l;s) I(l;s) is the residual term. The integral I(l;s) can be done and one gets,  $I(l;s) = [Y(2^{1}s) Y(s)] = \ln 2$  where the function Y(z) is given by

The structure of these expressions suggests a natural scaling limit, s! 0, 1! 1 but keeping the product  $z = s2^1$ 

xed but arbitrary. We also treat l as a continuous variable in this limit. Furtherm ore, we focus only near the tail of the scaling regime, i.e. when z >> 1. In this regime, it is su cient to keep only the rst term in the second line of Eq. (7) for the expression of Y (z). Besides, one can also check that the residual term is subleading in this regime. Keeping only the leading term s we get

W e still need to invert the generating function in Eq. (4) to obtain the asymptotic behavior of  $F_1(n)$ . The scaling lim it corresponds to taking n ! 1, l! 1 but keeping the ratio  $2^{l}=n$  xed but arbitrary. Using Eq. (8) and inverting Eq. (4) (using the B rom wich inversion form ula and then using the standard steepest descent m ethod), we do not the follow ing leading asymptotic behavior,

valid in the tail  $l > log_2(n)$ .

H aving obtained the asymptotic solution (9) of the linear equation (3), the location of the front l (n) can be read o from the equation,  $F_1$  (n)  $j_{inear}$  O (1). Using this criterion in Eq. (9), we not that the front position l (n) is given by the quadratic equation,

As we decrease 1 from 1, we will encounter the larger root rst, which will correctly locate the front position. From Eq. (10), we get, for large n, the asymptotic front position

Furthermore, substituting l = l(n) + y in Eq. (9) and expanding, for small y, we nd to leading order,  $F_1(n) = \exp \left[\frac{2b\ln(2)\ln(n)}{2b\ln(2)\ln(n)}(l + l(n))\right]$ , indicating that the width of the distribution, characterizing the uctuation of laround its average value l(n), decreases extrem ely slow by with n as,

as n ! 1 . The fact that the width vanishes in the n ! 1 lim it shows that the probability  $F_1(n)$  ! (l (n) l), thus indicating an extrem e concentration of m easure, i.e. the random variable l! l (n).

In the above analysis, we kept n xed and studied the behavior of  $F_1(n)$  as a function of 1. A lternately, as is more suited for the DDLA problem, one can keep 1 xed

and vary n. It follows from Eq. (9) that in the scaling lim it mentioned above, the random variable  $\log_2(n)$  approaches to its mean value  $\operatorname{hlog}_2(n)$  i = 1  $2\operatorname{l=b}$ . Due to the extrem e concentration of measure, it follows then that n !  $\operatorname{hn}_1$   $2^{1}$   $2\operatorname{l=b}$  in the scaling lim it. This means that the average density  $_1 = \operatorname{hn}_i = (2^1 \ 1)$  decays as a stretched exponential for large l,

Note that the leading order behaviors of the widths in Eqs. (12) and (14) are compatible with each other with the identi cation n 2. The Eqs. (11), (12), (13) and (14) constitute the main results of this section.

# III.GENERALIZATION TO A TREE W ITH M BRANCHES

In this section we generalize our results for the b-DDLA in the previous section (obtained for a tree with m = 2 branches) to a tree with m = 2 branches. In this case, during its downward journey from the top, a particle from a given site attempts to hop to any of the m daughter nodes with equal probability 1=m and can actually hop to the target site provided none of the m daughter nodes is full with b particles. If it fails to hop, the particle stays at its current site for all subsequent time. The probability G<sub>1</sub>(n) that a tree of height 1 is yet to be saturated after the addition of n particles satis es the generalized recursion relation,

where the variables  $n_i$ 's satisfy the constraint  $\prod_{i=1}^{P} n_i = m$ . Thus the binom ial coe cient in Eq. (1) of the previous section gets replaced by a multinom inal. The rest of the analysis is straightforw and and sim ilar to the previous section. We de ne as usual, the com plem entary probability,  $F_1(n) = 1$   $G_1(n)$ , which satis es the recursion,

where we have used the sym metry that all branches are sim ilar to each other.

As before, we solve the equation (16) retaining only the linear terms and neglecting the nonlinear terms. We de ne the generating function as in Eq. (4). Following the derivation presented in the Appendix and using the initial condition, we get the solution

The asymptotic analysis is exactly similar to the previous section, except that the proper scaling limit now is s ! 0, 1 ! 1 but keeping the product sm<sup>1</sup> xed but arbitrary. We do not repeat the steps here but present only the nalresults. We nd that as in the m = 2 case, there is a front whose asymptotic location 1 (n) is given by

and the width w (1) of the random variable  $\log_m (n)$  around its average value  $h\log_m (n)i = 1$  21=b decreases algebraically for large 1,

w (1) 
$$q \frac{1}{2b \ln^2 (m)}$$

Note that, interestingly, the asymptotic average value  $hlog_m(n)i = 1$  21=b is actually independent of m.

### IV.B-DDLA MODELW ITH BIASED HOPPING

In this section we consider the b-DDLA model on a m = 2 tree where the particles perform biased random walk on their way down the tree. More precisely, when a particle arrives at any given site i on its way down after being introduced at the top site, it attempts to hop to the left daughter of the node i with probability p and to the right daughter with probability q = 1 p. As before, it actually moves to the target site provided both the daughter nodes have less than b particles. If at least one of them is full with b particles, then the particle rests at site i for all subsequent times. Then a new particle is added and the process continues till the top site gets

led with b particles. Once again, we are interested in the statistics of the number of particles  $n_1$  when the tree of height 1 gets saturated. We de ne, as before,  $G_1(n)$  to be the probability that the tree of height 1 remains unsaturated, i.e. the top site remains un led upto the addition of n particles. Following the same logic as in Section II, one easily nds the recursion relation,

$$G_{l+1}(n+b) = \begin{cases} X^{n} & n \\ & p^{n_{1}}q^{n-n_{1}}G_{l}(n_{1})G_{l}(n-n_{1}); \\ & n_{1}=0 \end{cases}$$
(22)

for all 1 and n 0.

The complementary probability,  $F_1(n) = 1$   $G_1(n)$ , then satis es the recursion,

$$F_{l+1}(n+b) = \begin{cases} X^{n} & n \\ n_{1} = 0 \end{cases} p^{n_{1}}q^{l_{n_{1}}} [F_{1}(n_{1}) + F_{1}(n - n_{1})] \\ + nonlinear term s; \end{cases}$$
(23)

with the boundary condition  $F_1(n) = 0$  for 0 n (b 1) and  $F_1(n) = 1$  for n b. As before, we solve the equation (23) keeping only the linear term s and neglecting the nonlinear term s. This is done via de ning the generating function  $F_1(s)$  as in Eq. (4). Following the same line of derivation presented in the Appendix, we obtain the following recursion relation,

$$F_{1+1}(s) = \frac{1}{p(1+s)^{b}}F_{1}(s=p) + \frac{1}{q(1+s)^{b}}F_{1}(s=q);$$
 (24)

which starts from the initial function,  $F_1(s) = 1 = [s(1 + s)]$ . One can, in principle, iterate Eq. (24) starting with l = 1 and obtain the expressions for  $F_1(s)$  for all l. Fortunately, in the scaling regime s ! 0, one does not need the full expression for  $F_1(s)$ . Note that in the unbiased case p = q = 1=2, the appropriate scaling regime w as s ! 0, 1! 1 but keeping the product  $z = s2^1$  xed but arbitrary. In the biased case, it is clear from Eq. (24) that the appropriate scaling regime w all s ! 0, 1! 1 but keeping the product  $z = s^1$  xed where = m in (1=p;1=q). Thus in this scaling limit, one can approximate Eq. (24) by

$$F_{1+1}(s) = \frac{1+s}{(1+s)^{b}} F_{1}(s)$$
: (25)

The term s neglected in going to Eq. (25) from Eq. (24) only contribute to subleading order. Iterating the reduced Eq. (25) starting with  $F_1(s) = 1=[s(1 + s)]$ , one obtains

$$\mathbf{F}_{1}(\mathbf{s}) = \frac{1}{\mathbf{s} \left[ (1+\mathbf{s}) (1+\mathbf{s}) (1+\mathbf{s}) (1+\mathbf{s}) \right]^{b}};$$

We then invert the transform in Eq. (26) using the same asymptotic method as in Section II, the details of which we do not repeat. The nal asymptotic form of the distribution  $F_1(n)$  is given by,

$$F_1(n) = \exp \frac{\ln(n)}{2} (\log n)^2$$

valid in the scaling regime, n ! 1 , 1! 1 but with the ratio  $y = 2^{1}=n$  xed at a large value y >> 1. The front position can be read o from the condition  $F_1$  (n)  $j_{inear}$  0 (1) which gives, to leading order, 1 (n) log (n). Note the di erence with the unbiased case. Unlike the unbiased case in Section II where the width vanishes for large n, here the width of the distribution remains of 0 (1) in the large n ! 1 limit, w (1) ! 1= In . This result also indicates that the average density of particles varies as  $ln_1i$  <sup>1</sup> for large 1. Thus, unlike the unbiased case where the average density decays as a stretched exponential for large 1, the average large 1,

where = m in (1=p; 1=q). Besides, it follows from Eq. (27) that the uctuations of the variable log (n) around its average value 1 are characterized by a G aussian tail with width of O (1).

### V.CONNECTION TO DIGITAL SEARCH TREES AND THE LEMPEL-ZIV PARSING ALGORTHIM




FIG.3. A typical digital search tree constructed from a data string  $fx_1;x_2;x_3;x_4;x_5g$  of 5 elements.

In this section we point out the connection between our generalized b-DDLA model to the so called digital search tree problem in computer science [9,10,8,11{13,26]which, in tum, is also related [14] to the Lem pel-Ziv data com pression algorithm [25]. Suppose we have a data string  $fx_1; x_2; :::; x_n g$  which needs to be stored on a binary tree. According to the digital search tree (DST) algorithm, one proceeds as follows. Initially all the nodes of the tree are empty. The rst arriving element x is put at the root of the tree. Each node can contain at most one element. The second element  $x_2$  is put at one of the daughter nodes of the root chosen at random . Then for the next element  $x_3$ , one again starts at the root and choses one of the daughter nodes at random . If the chosen node is empty,  $x_3$  goes there. But if the chosen node, say i, happens to be the one that contains  $x_2$ , then one chooses one of the two daughter nodes of i at random and puts  $x_3$  there. Then one stores the fourth element  $x_4$  following the same algorithm and so on. Essentially each element  $x_i$  performs a directed random walk down the tree till it nds an empty site which it then occupies. The process stops when all the n elements have been stored and the resulting tree is called a DST (see Fig. 3). Note that according to this DST algorithm, the

actual value of a data element say  $x_i$  is not important. This is contrast to other search trees, such as the random binary search trees [9,10] where the actual value of  $x_i$  is used in constructing the tree.

The statistics of various quantities such as the distribution of the number of occupied nodes at a given depth (known as the pro le of the DST) have been studied in great detail in the computer science literature [14]. Flaplet and R ichm ond [12] introduced a generalized version of the DST where each node can contain at most belements. In this b-D ST, an incoming element x<sub>i</sub> perform s, as in the b = 1 case, a directed random walk downwards. However, when  $x_i$  reaches a new site, say k, it will stay forever at k provided the num ber of already existing elements at k is less than b. If the site k already contains b elements, then one chooses one of the daughter nodes of k and the element  $x_i$  hops there. This generalized b-D ST problem has many applications in computer science, notably in the maintenance of paged hashing tables [12]. F la jolet and R ichm ond studied, for exam ple, the average num ber of non-empty nodes in a b-D ST as a function of the data size n and the param eter b.

O ne important characteristic of a b-D ST is its height. The height l of a tree with n elements is de ned as the depth, counted from the root, of the farthest element in the tree. C learly l is a random variable, uctuating from one realization of the tree to another and also it is an extrem e variable (denoting the maximum depth). A natural question is: what is the probability distribution of the height? Let us de ne  $Q_1(n)$  to be the probability that the height of tree with n elements is l. It is easy to see that  $Q_1(n)$  satis es the following recursion relation

$$Q_{1+1}(n+b) = \frac{1}{2^{n}} \sum_{n_{1}=0}^{X^{n}} n Q_{1}(n_{1})Q_{1}(n n_{1}); \quad (29)$$

for all l 1 and n 0, with the additional condition that  $Q_1(n) = 1$  for all 0 n b and  $Q_1(n) = 0$ . For the case b = 1, this recursion relation was recently studied by K nessland Szpankowsky [15] using rigorous methods. The recurrence in Eq. (29) is a generalized version of the b = 1 case and can be understood as follows. Consider a tree with a total number of (n + b) elements. The rst b elements will be stored in the root and the rest of the n elem ents will be distributed to the left and right daughter subtrees. The probability that one of the subtrees, say the left one, gets  $n_1$  elements out of a total n elements is simply given by the binom ial distribution. A lso, since the condition that the height of the full tree is 1+ 1 (the left hand side of Eq. (29)) indicates that the height of both of the daughter subtrees must be 1. Since the two daughter subtrees are completely independent, this probability is given by their product.

Note that the recursion relation in Eq. (29) for the height distribution  $Q_1(n)$  in the b-D ST is identical to the recursion in Eq. (1) in Section II for the probabilities  $G_1(n)$  in the b-D D LA problem, except for the slight difference in the initial values  $Q_1(n)$  and  $G_1(n)$ . This slight di erence does not a ect the asymptotic behaviors. So, one can apply all the results obtained via the traveling front approach in Section II for the b-D D LA model directly to the b-D ST problem. In particular, the result in Eq. (11) indicates that the average height of the b-D ST has the asymptotic follow ing behavior for large n,

$$l(n) \log_2(n) + \frac{r}{b} \log_2(n)$$
: (30)

For b = 1, this result coincides with that of A klous and Shields [B] obtained by probabilistic m ethods. Note that for b = 1 case, a more re-ned result including additional subleading terms to Eq. (30) was recently obtained in Ref. [15] using rigorous m ethods. How ever, for general b, we are not aware of any rigorous results in the com – puter science literature and our Eq. (30) seems to be the

rst result for the average height of a b-D ST. Furtherm ore, Eq. (12) in Section II predicts that the standard deviation of the height around its average value decays extrem ely slow ly with large n, w (n)  $1 = \frac{2 \ln (2) \ln (n)}{2 \ln (n)}$ . This result on the variance of the height in b-D ST also seem s not to have been obtained by other m ethods before.

We now turn to the Lempel-Ziv algorithm for data compression [25]. The connection between this algorithm and the DST problem was known before [8,14]. The Lempel-Ziv algorithm is central to many universal data compression schemes and have many applications such as in the e cient transfer of data [14]. This basic scheme of this algorithm is very simple: it takes a given data string, say a sequence of binary digits such as 1100011011101110, and partitions it into Words'. W ords' are subsequences of variable sizes which are never repeated and are constructed by employing the rule that a new Word' is the shortest subsequence not seen in the past as a Word'. This is best understood by an example.




FIG. 4. The gure shows how the partitioning of a sequence 11000110111011110 into Words' (1) (10) (0) (01) (101) (11) (011) (110) using the Lem pel-Z iv parsing algorithm can be represented as a digital search tree. The length of a Word' is equal to its depth in the tree m easured from the empty root at the top.

Consider the binary sequence 11000110111011110 and construct words' starting from the left end using the Lem pel-Ziv algorithm. Starting from the left end, the

rst digit encountered is 1. Since 1 has not occurred before as a word', one can form the rst word' (1). Now we move to the next element which also happens to be 1. But, now since (1) is already a word', the shortest seqment we can use to form a word' is (10). Similarly, the next word would be (0) since (0) has not occurred before as a word'. One keeps repeating the procedure and at the end, the original sequence is partitioned into the follow ing sequence of words': (1)(10)(0)(01)(101)(11)(011)(110). The original data is thus compressed into these words. Even though the words' are relatively short in the begining, it turns out that they become bigger quite rapidly. One of the interesting questions of practical in portance in this scheme is the statistics of the longest word' when the original data string is random . For concreteness, let us consider a random binary sequence of initial data and focus on the rst n words'. Let l be the length of the longest word' am ongst these n words. C learly 1 is a random variable since the underlying binary sequence is random . W e are interested in the statistics of las a function ofn.

There is a natural representation of this parsing algorithm in terms of a DST [14]. Consider a binary tree whose nodes are initially empty. In fact, the root of this tree is always going to be empty (see Fig. 4). Now we take the st of the Lem pel-Ziv parsed words' and exam ine its rst digit. If the rst digit of this word' is 1, we put this word' in the right daughter node of the root. On the other hand, if the rst digit is 0, we put this word at the left daughter node. This new ly occupied node is now full and can not accom odate any other word'. Then we consider the second word' and look at its rst digit. If the rst digit is 1 (0), we go to the right (left) daughter node. Let us call this node i. If this node i is empty, we put the word' there. If i is already occupied by the rst word', then we need to exam ine the second digit of our second word' and depending on its value (1 or 0), we go respectively to the right or to to the left daughter node of i and put our second Word' at this new site. This process is repeated until all the words are stored and the resulting tree is clearly a DST, since at each step the decision to go to the left or to the right occurs random ly (due to the random ness of the underlying binary sequence where each digit can be either 0 or 1 with equal probability). The construction of this DST from the parsed words (1) (10) (0) (01) (101) (11) (011) (110) is shown in Fig. 4.

It is clear from the algorithm that the depth of a given word' in the D ST (m easured from the empty root) is precisely the equal to the length of the word' (see Fig. 4). In particular, the longest word' will also be the farthest from the root. Thus the length 1 of the longest word is precisely the height of the corresponding D ST. There is a generalized Lem pel-Z iv algorithm where during the partitioning into words', any particular word' is allowed to be repeated at most b tim es [14]. Then the corresponding D ST is precisely a b-D ST. Thus our results regarding the average height 1 (n) and its width apply as well to the longest word' in the generalized Lem pel-Z iv algorithm.

#### VI.CONCLUSIONS

In this paper we have used a suitably adapted version of the traveling front approach to derive exact asym ptotic results for the statistics of the number of particles in a generalized directed di usion limited aggregation problem. We have pointed out a close connection of this problem to two separate problems in computer science, namely the digital search tree problem and the Lempel-Ziv algorithm used for data compression. Our results for the number of particles in the generalized b-D D LA m odel have direct relevance to the statistics of height in the digital search tree problem and to the statistics of the longest word in the Lempel-Ziv algorithm.

The traveling front approach has recently been used successfully [22,23] to derive exact asym ptotic results for heights in a number of growing search tree problems in computer science. This paper shows that the scope of this approach can be extended to include yet another di erent class of search trees, namely the digital search tree. The main advantage of this method is that it provides an easy way to derive the leading asymptotic behavior exactly in a variety of extrem e value problem s [21].

The present study leads to a number of interesting, open problem swhich we list below.

Undirected DLA problem on a tree: In this paper, we have focused on a directed m odel for sim plicity, where the particles undergo di usion but only in the overall down-ward direction. It would be interesting to extend the traveling front approach to an undirected m odel such as the one studied by Hastings and Halsey [16].

Subleading Corrections in the biased DDLA problem: U sing traveling front approach, we managed to calculate only the leading behavior of the average density in the biased DDLA model (see Section IV). It would be interesting to compute the subleading corrections to this leading behavior.

DDLA model with stochastic screening: In this paper, we have studied a D D LA m odelwhere the screening is determ inistic in the sense that a particle, on its way downwards, stops de nitely when it reaches at a site such that at least one of the daughter nodes of that site is occupied. It would be interesting to consider a stochastic screening version de ned as follows. For sim plicity, we de ne the model for b = 1 case, though it can be trivially generalized to b > 1 case also. The particles are introduced sequentially from the top as before and a new particle is introduced only when the previous particle has com pletely stopped moving. On its way down, at each site ia particle perform s the following steps: if both the daughter nodes of i are already occupied, the particle rests at i for all subsequent times and then a new particle is added. If both the daughter nodes are empty, then the particle chooses one of the daughter nodes at random and moves there. If, how ever, only one of the daughter nodes (say the left one) is occupied but the other one (the right one) is empty, then with probability p (0 p 1) the particle m oves to the right daughter node and with probability p) it rests at i for all subsequent times. Clearly (1 the case p = 0 corresponds to the determ inistic screening model studied in Section II. On the other hand, for p = 1, it is obvious that at the saturation the tree will be completely full and the density will be exactly 1. It would be interesting to compute the statistics of density in this stochastic screening model.

D isordered b-D D LA model: In the present paper, we considered the b-D D LA model when all the nodes of the tree have the same capacity b. In a disordered version of the problem, this node capacity  $b_i$  of a site i may vary from one site to another. O ne can consider  $b_i$ 's to be a set of quenched variables (as in the usual models in disordered system s), each drawn independently from a specie ed distribution p(b). Then, for a given xed set of  $\beta$ s, one would rst like to compute, for example, the average num ber of particles  $h_1$  at saturation, and then average this quantity over the disorder to obtain  $\overline{h_1}$ , where  $\cdots$ 

denotes the average over the  $b_i$ 's. It would also be interesting to compute the sample to sample uctuations of the average density  $hn_1i$ .

#### APPENDIX: DERIVATION OF THE GENERATING FUNCTION

In this appendix, we present the derivation of Eq. (5) where  $F_1(s)$  is de ned in Eq. (4). Our starting point is the linear equation (3). We rst de ne the exponential generating function,

Multiplying both sides of Eq. (3) by  $z^n = n!$  and summing over n, it is easy to see that  $H_1(z)$  satisfies the b-th order nonlocal differential equation,

$$\frac{d^{b}H_{1+1}(z)}{dz^{b}} = 2H_{1}(z=2)e^{z=2}; \qquad (A2)$$

for all 1. This recursion in Eq. (A 2) starts from the initial function H<sub>1</sub>(z) which needs to be computed separately. Using F<sub>1</sub>(n) = 0 for 0 n (b 1) and F<sub>1</sub>(n) = 1 for n b, we nd H<sub>1</sub>(z) =  $P_{k=0}^{p b 1} z^{k} = k!$ . The next step is to de nea new function,

$$U_1(z) = H_1(z)e^{z} = \sum_{n=0}^{X^{1}} F_1(n) \frac{z^{n}}{n!}e^{z}$$
 (A3)

From Eq. (A1), it follows, after a few steps of algebra, that  $U_1(z)$  satis es the di erential equation,

for all 1 starting with the initial function,  $U_1(z) = e^{z} \frac{P_{b1}}{k=0} z^k = k!$ .

 $R_1$  We now de ne the Laplace transform,  $U_1(s) = 0$  $U_1(z)e^{sz} dz$ . Taking the Laplace transform in Eq. (A 3), we get

$$U_{1}(s) = \sum_{n=0}^{X} F_{1}(n) \frac{1}{(1+s)^{n+1}} = F_{1}(s); \quad (A5)$$

where we have used the identity  $\begin{bmatrix} R_1 \\ 0 \end{bmatrix} e^z z^n dz = n!$  and the de nition of  $F_1(s)$  in Eq. (5). Next we take the Laplace transform on both sides of Eq. (A 4). Using the initial conditions for n = 0, one can show easily that  $d^k U_1(z) = dz^k j_{z=0} = 0$  for all 1 and k (b 1). Using this condition and doing integration by parts, one nds

Summing the left hand side of Eq. (A 6) and identifying  $U_1(s) = F_1(s)$  as in Eq. (A 5) then gives the desired recursion relation
