### Anticipated synchronization: a m etaphorical linear view

W e study the regime of anticipated synchronization recently described on a number of dynam ical system s including chaotic and noisy ones. We use simple linear caricatures to show the minimal setups able to reproduce the basic facts described.

### I. IN TRODUCTION

The coupling of dynam ical system s can lead to the synchronization of their outputs [1]. Recently, attention has been given to the a peculiar phenom enon introduced by Voss [2, 3, 4, 5] where one system synchronizes not with the present state but with som e future state of another system. This regime, called anticipated synchronization, has been demonstrated theoretically and numerically in disparate dynam ical systems including discrete or continuous, chaotic and noisy excitable, and quasi-periodic ones [6, 7, 8, 9, 10]. Experimental results have considered either electronic circuit in plementations of the dynam ical equations [5, 9] or lasers running in the chaotic regime both in one-directional [11] and bidirectional coupling [12, 13, 14, 15].

From the viewpoint of an external observer, the dynam ics of anticipated synchronization can be seen as if one system is forecasting the state of the other. It is unclear, however, under which general conditions a given dynam ical system would or not exhibit such dynam ics. The phenom enon in itself is rather counterintuitive because, depending on the setting, m ixes notions of synchrony and order with the dynam ics of chaos and disorder. Furtherm ore, it is not immediately apparent whether or not nonlinearities are essential for the process. This paper is dedicated to answer these concerns, by analyzing the m inim al setup able to exhibit the m ore fundam ental aspects of this phenom ena.

The paper o ers three perspectives covering from the simplest scenario to the more complex ones. Section II is a brief overview of anticipated synchronization as described in recent work. Section III discusses a toy model describing the trivial situation of two \particles" moving with uniform trajectory in which one attempts to closely follow the other using the scheme described in the anticipated synchronization literature. These particles can be seen as an special case of the dynamical system presented in Section IV, where the case of two coupled m aps is analyzed from a dynamical system sperspective and the condition for anticipated synchronization derived analytically. The same system is revisited in Section V, but now from a Control System spoint of view, both for continuous and discrete cases. The paper closes by listing the most relevant conditions one would expect to see in all cases of anticipated synchronization.

# II. OVERVIEW OF ANTICIPATED SYNCHRONIZATION.

Two di erent schem es have been proposed in order to achieve anticipated synchronization [2]. Both schem es use, in a way or another, delay lines which allow forecasting of a master trajectory by a slave identical system.

The rst scheme uses the technique of complete replacement. It considers a dynamical system, x (t) (known as the master system) whose dynamics involves a delayed feedback of the form :

$$\underline{x}(t) = x(t) + f(x(t));$$

being > 0 a constant, and f a given, generally non{ linear, function. The dynam ics of the slave system, y (t), is obtained by a similar equation in which the delay term has been completely replaced by the master system. Namely, the evolution equation for y (t) is:

$$y(t) = y(t) + f(x(t))$$
 (2)

It is easy to see that the manifold y(t) = x(t + ), in which the slave anticipates by a time the actual output of the master, is a stable solution of the dynam ical equations (1-2). This follows readily from the (exact) evolu-(t) for the delayed di erence tion equation -(t) =(t) = y(t) x(t+). This result is independent of both the function f(x) under consideration, or the arbitrarily large delay time . The structural stability of the asym ptotic solution has been dem onstrated by im plem entation in electronic circuits [5]. Of course, the result is more rem arkable when the dynam ics of the master has a high degree of unpredictability, i.e. by choosing f(x) and such that the dynam ics of the master is chaotic. In this scheme, and beyond the mathematical result, the anticipation mechanism can be understood from the fact that the dynamics of the master at time t in uences its own dynam ics at a time later, whereas it enters the dynam ics of the slave im m ediately at time t. In other words, it is as if the slave system y (t) has anticipated know ledge

of an essential part of the dynam ics of the m aster system  $\boldsymbol{x}$  (t) .

The second scheme is one that includes only delay in the slave dynamics [2]. This is de ned by the following dynam ical equations for the master and slave system s:

$$\underline{x}(t) = f(x(t)) \underline{y}(t) = f(y(t)) + K [x(t) y(t )];$$
 (3)

where f (x (t)) is an arbitrary function and K is a coupling strength m atrix. It is easy to show that the anticipated synchronization manifold y (t) = x (t + ) is again a solution of this set of equations. At variance with the case of com plete replacem ent, its stability can only be ful lled in a limited range of parameters for and K. Despite this restriction, how ever, we believe that this method of anticipated synchronization deserves more attention than that of complete replacement because the anticipation is included as an external param eter and does not time in uence the dynam ics of the master system . Therefore, in principle, any dynamical system can be predicted by using this scheme. Again, the anticipation is more relevant when the dynam ics of the master is unpredictable by other sim ple m eans.

Recently an extension of the schemew as introduced to include anticipation in non{autonomous systems [9, 10]. Speci cally, it has been considered the following set of equations:

$$\underline{x}(t) = f(x(t)) + I(t)$$

$$\underline{y}(t) = f(y(t)) + I(t) + K[x(t) y(t)];$$

where the new term I(t) represents an external input acting on both, master and slave, system s. Although the anticipated manifold  $y(t) = x(t + \cdot)$  is no longer an exact solution of the previous equations (except in the case of a periodic forcing  $I(t + \cdot) = I(t)$ ), it has been shown that several features of the dynam ics of the master can indeed be predicted by the slave. For instance, it is possible to predict the peaks red by an excitable system subjected to a random external forcing [9, 10]. We stress that in this case the random forcing induces peak ring at uncorrelated and unpredictable times.

In this second scheme, Eqs. (3-4), the actual mechanism leading to synchronization is much more elusive and, despite the wide variety of work, it is still unclear which are the relevant conditions and requirements for two dynamical systems to exhibit this type of anticipated synchronization. For instance, one would like to understand whether or not nonlinear aspects of the dynamics are needed for the system sto exhibit anticipated synchronization. In the same line to what extent anticipation can be arbitrarily long is of relevance for practical purposes.

# III. TW O PARTICLES FOLLOW ING EACH OTHER

The intention in this section is to undress the anticipated synchronization models of irrelevant aspects, to be able to identify the essential mechanisms at play. The goal is to have a system hom obgous to the more general ones described in the anticipated synchronization literature. We rst look at the simplest linear one, thus we choose a dynam ical system of two particles moving uniform ly in a one-dimensional space. We consider a particle following a uniform motion

$$\underline{\mathbf{x}}(\mathbf{t}) = \mathbf{v}; \tag{5}$$

where x (t) is the position of the particle at time t and v its velocity. Following the scheme in anticipated synchronization to forecast (and \synchronize" with) the position of the master particle we consider another (\slave") particle whose trajectory is given by

$$y(t) = v + K (x(t) y(t));$$
 (6)

where K is the strength of the coupling between the master particle (Eq. (5)) and the slave (Eq. (6)). To achieve the anticipation, the solution y(t) = x(t + ) has to be a stable solution. The stability can be studied analyzing the behavior of the delayed di erence (t) = y(t) = x(t + ). We obtain

$$-(t) = K (t ) :$$
 (7)

The condition for local stability of the solution (t) = 0(y(t) = x(t+)) is given by [16, 17]

$$K < \frac{1}{2}$$
: (8)

This indicates that in order to observe an anticipated solution of the slave particle within this scheme, the product of the coupling with the anticipation time has to be smaller than a certain value. Larger values produce an over-correction and the slave is unable to anticipate. This expression qualitatively reproduces the numerical results obtained by several researchers.

It is interesting to note that if the two systems are not identical, e.g., the velocities are diment, then

$$\underline{y}(t) = v^0 + K (x(t) y(t)) :$$
 (9)

then we obtain the same stability condition. However the anticipation is not perfect in the sense that the slave anticipates with a constant m ism atch  $y(t) = x(t + ) + \frac{v^0 \quad v}{K}$ . The m ism atch decreases with increasing coupling constant K.

M ore generally one could obtain a stability equation of the from

leading to the conditions [16, 17]

or,

$$K > jA j$$
 and  $< \frac{\cos^{-1}(A = K)}{(K^2 A^2)^{1-2}};$  (12)

where the principal value is taken (0  $\cos^{1}(A = K)$ ).

### IV. A DYNAM ICAL SYSTEM S PERSPECTIVE: TW O COUPLED MAPS

Let us consider the sam e two particles of the previous section but now m oving with the m ore general dynam ics given by the following coupled m aps:

$$x_{k+1} = x_k + a \mod (m)$$
  
 $y_{k+1} = y_k + a + (x_k - y_{k-n}) \mod (m);$ 
(13)

where > 0 and a are constants. If > 1 the  $x_k$  form a chaotic map, whereas = 1 leads to a quasiperiodic map and for < 1 the map converges to  $x_k = a = (1 )$ . The necessary n + 2 initial conditions are the set  $(x_0; y_n; y_{n+1}; 1; y_0)$ .

W e are interested in the possibility of the coupled m aps leading to anticipated synchronization, i.e. in having

$$\mathbf{y}_{k} = \mathbf{x}_{n+k} : \tag{14}$$

as an asymptotic solution for the maps. To this end, we consider the map satis ed by the delayed di erence  $_{k} = x_{n+k}$   $y_{k}$ :

$$k+1 = k \quad k \quad n$$

An analysis complementary to ours can be found in [8]. The ansatz  $_{k} = {}^{k}$  leads to

The (com plex) constants  $C_1$ ;:::; $C_{n+1}$  are determ ined by the initial conditions. The \_i, i = 1;:::;n + 1 are the solutions of the polynom ial equation:

A necessary and su cient condition for anticipated synchronization to hold and to be asymptotically stable is that  $\lim_{k \to 1} = 0$ , or equivalently  $j_i j < 1$ ; 8i = 1;:::;n + 1. We analyze now the range of validity of this condition as a function of the parameters , n and . It turns out that anticipated synchronization occurs if 2 ( 1; c), where the value of c depends on and n. We consider three cases:

1.- < 1. We treat for completeness this case, although it is the less interesting from the practical point of view, since them apstend asymptotically to a x point (in practise, after a nite number of steps). A lthough a full analytical solution does not seem to be available in this case, it is possible to obtain the asymptotic behavior in the case of large anticipation n:

2.- = 1. In this case, the dynam ics is quasi-periodic. The interval of anticipated synchronization can be found analytically as:

$$_{\rm c} = 2 \sin \frac{1}{2(2n+1)}$$

In the lim it n ! 1,  $_{\rm c}$   $\frac{}{2n}$ , the same as the continuous case considered in the previous section. A gain, anticipation is possible for arbitrarily large n.

3.- > 1. This is the more interesting case since the maps are chaotic. It turns out that the condition j<sub>i</sub>j< 1 is only satis ed for < 1 +  $\frac{1}{n}$ . A lternatively, for xed > 1 the maximum anticipation time is

$$n_{m ax} = \frac{1}{1} > 1;$$




FIG. 1: The anticipated synchronization regime is achieved for values of and n in between the upper (solid) line and the lower (dashed) line. For = 1 the solid line is the analytical result Eq. (19), whereas for = 0.5 and = 1.1 the dots have been computed num erically and the solid line is a guide to the eye.

 (20)

where [k] denotes the integer part of x. A nticipated synchronization is found for 2 (  $1;_{\rm c}$ ) but only for  $n < n_{m \ ax}$ . In this case of > 1 we have not been able to nd any analytical approximation or asymptotic expression and the values of  $_{\rm c}$  need to be computed nummerically. The previous results are summarized in Fig.1






FIG. 2: Power spectrum u: (arbitrary units) of the series of  $u_k$  pulses generated by Eq. 13 with parameters = 1:1, a = 0:1 and m = 1.

Let us now analyze the predictability of the map, taking = 1:1, n = 6, for which the synchronization lim its are 2 (0:1;0:19395). First, for visualization purposes, we transform the output of the master map into a series of random spikes by de ning a new \ ring" sequence  $u_k$ as  $u_k = 1$  if  $x_k > u$  and  $u_k = 0$  if  $x_k < u$ , with u a convenient threshold value. Sim ilarly for the slave map, we de ne  $v_k = 1$  if  $y_k > u$  and  $v_k = 0$  if  $y_k < u$ . In the case of = 1:1 the tim ing of the pulses does not have any regularity. As shown in Fig.2, the power spectrum of the  $u_k$  signal is at, show ing the absence of any preferred tim e scale, the series is highly unpredictable.

In Fig. 3 we show that, in accordance with the previous analysis, each pulse of the master system  $u_k$  is anticipated n = 6 units of time by a pulse in the slave system  $v_{k-n}$  for a coupling  $= 0.16\ 2\ (0.1;0.19395)$  (middle panel). For too large or too small values of the coupling , the synchronization is lost. The existence of a minimum and maximum value for the coupling in order to have anticipated synchronization, which appears here as a property of simple linear maps, has also been observed in more complex chaotic [2] and excitable non-autonom ous systems [10]. These maps can be seen as well as a case of integrate and re dynamics, often used as caricatures of neural system s.

#### V. A CONTROL SYSTEM S PERSPECTIVE

From an engineer view point, the slave dynam ical system following a master, shown in the previous section, is seen as a cascade of control system blocks. In this section anticipated synchronization is analyzed from this C ontrol System perspective. In both, the continuous and discrete time systems, x (t) will be seen as the output of a rst

order open loop system with no feedback, and the slave y (t) (controlled signal) represents the output of an identical system but with delayed time feedback and driven by the master system x(t) (the reference signal). With enough loop gain in the feedback loop, the control will act as a servo mechanism which minimizes the error between the reference (master x (t)) and its own delayed output y (t ). Hence, the internal variable y (t) will be a prediction of x (t).

# A. Two particles following each other seen as a servo m echanism

The example of the two particles following each other described by equations (5) and (6) can be seen as a servo mechanism where the position of the controlled particle y(t = ) is compared with a reference signal x(t). The integrator nature of the loop provides enough gain so that in steady state the error will vanish and the two signals will match.

Equation (5) represents a pure integrator to input v. Denoting by X (s) the Laplace transform of x (t) and assum ing zero initial conditions for x (t = 0), the Laplace transform of  $\underline{x}$ (t) will be sX (s). A loo, since the constant velocity v is represented as an external step input, its Laplace transform V (s) will be equal to v=s. Thus we can write

$$X (s) = \frac{v}{s^2}$$
: (21)

This represents a transfer function, in the Laplace domain, with a pole at the origin of the s plane. If v is constant the output is a ram p x(t) = vt.

Repeating the same process for Eq. (6) we can write

$$sY(s) = \frac{v}{s} + K(X(s)) e^{-s}Y(s));$$
 (22)

from where we obtain

$$Y(s) = \frac{v=s}{(s+Ke^{-s})} + \frac{KX(s)}{(s+Ke^{-s})} :$$
(23)

Applying the inverse Laplace Transform to Eq. (23) we can obtain the tem poral evolution of the output for any given input. The dynam ics of the error in the servom echanism can also be obtain by subtracting X (s) Y (s):

The input/output relation, (transfer function in control system term s), between X (s) and Y (s) is given by the ratio of these two functions (considering zero external input):

$$G_{cl}(s) = \frac{Y(s)}{X(s)} = \frac{K=s}{1+\frac{K}{s}e^{-s}}$$




FIG.4: Block diagram of the continuous-time servom echanism system (Eq. (22) (24)) represented by a transfer function in the Laplace dom ain.

Equations (22) { (24) can be represented in a block diagram, as in Fig. 4, with direct gain G (s) =  $\frac{K}{s}$  and feedback gain H (s) = e<sup>s</sup>. In more general terms, the closed loop transfer function is given by

$$G_{cl}(s) = \frac{Y(s)}{X(s)} = \frac{G(s)}{1 + G(s)H(s)}$$
 (25)

It follows that if the loop gain G (s)H (s) 1, the closed loop transfer function will be given by the feedback term  $G_{cl}$  ' (H (s)) <sup>1</sup>. For our example this means that Y (s) ' X (s)e <sup>s</sup>, and applying the inverse Laplace transform y(t) ' x(t+ ). This was the expected result that proves that the delayed position of the second particle, after som e transient, will follow the position of the

rst one. Likewise, y(t) will be moving ahead of x(t) in a predictive manner.

To perform a stability analysis, the roots of the denom – inator  $s + K e^{-s} = 0$  must be found. If we replace s by i! a frequency analysis can be obtained. This is usually done drawing real and in aginary parts of the transfer function with the Nyquist diagram or using the Bode plots, representing module and phase separately. The term G (i!) ' K=i! has a gain whose module decreases with ! and becomes unity for ! = K, and a constant phase equal to =2. The transfer function of the delay H (i!) has a constant module equal to one

and a phase that decreases with w

$$(!) = \arg[e^{i!}] = !$$

A coording to the standard stability criteria for linear systems the module of the gain of G (!) H (!) must be smaller than 1 when the phase crosses the boundary (meaning the denominator of  $G_{cl}(s)$  is zero). Substituting ! = K the total phase contribution (K + =2) at the unity gain point should be smaller than , recovering Eq. (8)

#### B. Discrete System

A discrete system similar to the coupled maps described by Eq. (13) (but without the mod (m) constrain) can be seen, in engineering terms, as a discrete time control system s written as two di erence equations: one for the master  $x_k$  and the other for the slave  $y_k$ . The equations (13) without the mod (m) constrain can be rewritten for time k

$$x_{k+1} = x_k + a$$
 (29)

$$y_{k+1} = y_k + a + (x_k - y_{k-n})$$
 (30)




FIG.5: Block diagram of the discrete-time servom echanism system Eq. (34) represented by a transfer function in the Z-transform domain.

To solve Eqs. (29) { (30), we will use the Z -transform [18]. If Z fx<sub>k</sub>g is the Z -transform of  $x_k$  denoted as X (z) and Z fx<sub>k</sub> 1g is the Z -transform of  $x_{k-1}$  obtained by multiplying X (z) by z<sup>-1</sup>, applying these rules to both equations, we obtain

$$X (z) = \frac{Z fag}{1 z^{1}}$$

$$Y(z) = \frac{Z fag + z^{-1}X(z)}{1 z^{-1} z^{-(n+1)}};$$

where Z-transform of a, Z fag, depends on the type of input a. For our case, a is constant and

$$Z(a) = \frac{az}{z a} :$$
(33)

As in the continuous system, we are interested in the transfer function between X (z) and Y (z). Any feedback system can be viewed as a direct transfer function G (z) and a feedback block H (z) whose output will be sub-tracted from the reference, to obtain the error signal. In our case

$$Y(z) = \frac{G_1(z)G_2(z)X(z) + G_2(z)Z(a)}{1 + G_1(z)G_2(z)H(z)};$$
 (34)

where  $G_1(z) = z^1$ ,  $G_2(z) = (1 z^1)^1$ , and  $H(z) = z^n$ . In the engineering literature, these equations are often represented using block diagram s, as shown in Fig. 5. The closed loop transfer function in this case is given by

$$G_{cl}(z) = \frac{Y(z)}{X(z)} = \frac{z^{-1}}{1 - z^{-1} + z^{-n} z^{-1}} : \quad (35)$$

U sing the same arguments as in the previous subsection, if the loop gain  $G_1(z)G_2(z)H(z)$  1 we can approximate  $G_{c1}$  ' (H (z)) <sup>1</sup>. This yields to Y (z) '  $z^n X(z)$ 

indicating that the output  $y_k$  predicts  $x_k$  by n sampling periods.

To analyze the stability we analyze the conditions when the denom inator of Eq. (34) equals zero. Thus to ensure stability the roots of the denom inator must lie inside the circle given by

$$z^{n}(z) = ;$$
 (36)

recovering Eq. (17).

VI. CONCLUSIONS

As stated at the outset, the purpose of this paper is to undress the models of anticipated synchronization to be able to see the essentials of this intriguing dynam ics, which in summary are:

i) The phenom enon of anticipated synchronization in itselfdoes not rely on nonlinear properties of the dynam – ics, indeed, as shown in Sect. IV nonlinearities make the anticipation harder or im possible.

ii) Some aspects of the problem are naturally understood by looking it from a Control System's approach, where the delayed term are seen as an \error signal" in a servo mechanism control loop (Sect.V).

iii) As shown by the derivation using simple stability criteria (Sect. III and IV), the boundaries of the anticipated synchronization (i.e., the fundam ental diagram in F ig.1 of coupling strength versus the delay) are expected to be universal for this kind of system s.

O verall, these results account for the necessary qualitative features two system smust have in order to exhibit anticipated synchronization. By clarifying under which conditions the phenom enon would be observable, som e questions will naturally arise opening new application of these ideas. From the argum ents discussed here it seem s that \synchronizing in advance" and \controlling the future state" can be equivalent objectives describing the aim of the process of anticipated synchronization. In that sense it might be worth to study possible connections with system s that learn to master such objectives, as for instance the task of a neural net adapting to capture a ying object.
