# Two-way shape memory e ect and mechanical properties of Pulse D ischarge Sintered N $i_{2,18}$ M $n_{0.82}$ G a

M echanical and shape m em ory properties of a polycrystalline N  $i_{2:18}$  M  $n_{0:82}$  G a alloy prepared by a PD S (P ulse D ischarge Sintering) m ethod were investigated. It was found that the material dem onstrates the two-way shape m em ory e ect after a loading – unloading cycle perform ed in the martenstic state, i. e. essentially without special training. The sam ples exhibiting the two-way shape m em ory e ect show a signi cant enhancem ent in the magnitude of magnetic-eld-induced strain.

#### I. IN TRODUCTION

Beginning from 1996 when U llakko and co-worker<sup>1</sup> reported on a magnetic- ekd-induced strain of about 0.2% in a non-stoichiom etric N i-M n-G a single crystal, research in this ekd has attracted a considerable attention due to the great technological potential of this e ect. Later this phenom enon was found in other com pounds exhibiting shape m em ory e ect when in the ferrom agnetic state, such as Fe-Pd and Fe-Pt.<sup>2,3</sup> W hereas Fe-Pt and Fe-Pd show magnetic- ekd-induced strains not exceeding 1%, in N i-M n-G a single crystals the values of magnetic- ekd-induced strains not exceeding 1%, of the norm of this phenom enon is believed to be the redistribution of di erent tw in variants under action of a magnetic ekd.<sup>5</sup> Since these giant strains are attained in com paratively low magnetic ekds (less then 1.5 T), they are easy

suppressed by an external stress. For instance, the 6% eld-induced strain was completely blocked by a com – pressive stress of order 2 M Pa.<sup>4</sup> This suggests that the giant magnetostrains arising from the process of twin-boundary motion m ight be useful for large stroke and sm all force applications.


A nother way to attain a large m agnetic-eld-induced strain in the ferrom agnetic shape m en ory alloys is a shift of the m artensitic transition temperature caused by a m agnetic eld.<sup>6,7</sup> However, in this case the m agnitude of the applied eld must be high in order to overcome the temperature hysteresis of m artensitic transform ation. From general consideration, it can be expected that the m axim um achievable strain in this case is equal to the striction of the two-way shape m en ory e ect. The work output has to be large (as in conventional shape m en ory alloys), which can be useful for m ediate stroke and large force applications.

From the point of view of widespread use of magnetic-

eld-induced strains, observed in the ferrom agnetic shape m em ory alloys, there is a need to investigate polycrystalline m aterials. P revious studies of a series of N  $i_{2+x}Mn_1 \ _xGa \ (x = 0.16 \ 0.20)$  showed that, am ong the composition studied, N  $i_{2.18}Mn_{0.82}Ga$  is characterized by a considerable striction of transition.<sup>8</sup> B ecause of that we have studied N  $i_{2.18}Mn_{0.82}Ga$  prepared by a Pulse D ischarge Sintering (PDS) process.

## II. SAMPLES PREPARATION AND MEASUREMENTS

Ingots of the N 12:18M no:82G a composition were prepared by arc-m elting of high-purity initial elements. The ingots were annealed at 1100 K for 9 days and quenched in ice water. A part of the arc-melted ingots was used to fabricate PDS samples. For this aim the arc-melted ingots initially were crushed into particles and ground into ne powder with a particle size less than 53 m. Meshed powder was led in a graphite die with two graphite punches. The die was set in a pulse discharge system (Sodick Co., Ltd). The pulse discharge system was evacuated to a vacuum of 3 Pa prior to the sintering process. Maximum pressure and tem perature during the PDS process were equal to 80 M Pa and 1173 K, respectively. D isc-shaped billets with thickness of 6 mm were sintered. X -ray di raction m easurem ents of the sam ples, perform ed in a wide tem perature range, show ed that the high-tem perature austenitic structure has a cubic m odi cation whereas the low-tem perature martensitic phase has a com plex tetragonally based crystal structure. Sam pleswith dimensions of 3 6 mm<sup>3</sup> were spark-cut from the billets. Tem perature and m agnetic eld dependencies of strain were measured by a strain gage technique. For this aim a non-magnetic strain gage with a compensated tem perature range from 273 to 423 K was attached along






FIG.1: Tem perature dependencies of Young's modulus of a N  $i_{2:18}$  M  $n_{0:82}$  G a PDS sam ple.

the longest dimension of the samples. The conguration of the experimental setup allowed detecting the relative change in the length of a specimen with an accuracy of 0.005%. The samples were inserted into a variable tem – perature chamber of a superconducting magnet. Tem – perature was monitored by a Lake Shore calibrated platinum resistance therm on eter with an accuracy of 0.1 K. Stress-strain measurements and compression of samples were done at room temperature by an Instron machine.

## III. RESULTS AND DISCUSSION

Shown in Fig. 1 are the tem perature dependencies of Young's modulus of a N $_{2:18}$ M n<sub>0:82</sub>G a PDS sample during heating and cooling. These dependencies were obtained from ultrasonicm easurem entsperform ed in a tem - perature interval from 173 to 373 K. The value of Young's modulus was evaluated through the form ula

$$E = \frac{v_s^2 (3v_1^2 - 4v_s^2)}{(v_1^2 - v_s^2)}$$

where ,  $v_1$  and  $v_s$  are the density of the m aterial and the velocities of longitudinal and shear waves, respectively. M arked dips on the tem perature dependencies of Y oung's m odulus correspond to the direct and reverse m artensitic transform ations. As evident from Fig. 1, the Y oung's

m odulus of N  $i_{2:18} M \ n_{0:82} G$  a at room tem perature is equal to 95 G Pa.

The results of compression tests for N  $i_{2:18}$ M  $n_{0:82}$ G a prepared by the PDS m ethod and by a conventional arcm elting technique are shown in Fig.2. The compression tests were done at room temperature with the same speed of compression for both the sam ples. The comparison of these curves clearly indicates that the PDS sample shows higher yield strength than the arc-m elted one. This characteristic is of importance for some practical applications, and it m akes the PDS m aterials m ore attractive in this sense.




FIG. 3: Temperature dependencies of strain in a N  $i_{2:18}$ M n<sub>0:82</sub>G a PD S sample m easured in zero and 5 T m agnetic elds.

Figure 3 shows the tem perature dependencies of strain measured in a Ni2:18M no:82G a PDS sample upon cooling and heating in zero and 5 T m agnetic elds. In zero magnetic eld the sam ple length monotonously increases upon heating up to the onset of the reverse martensitic transform ation,  $A_s = 343$  K. The martensite - austenite transform ation is accompanied by a rapid increase in the sample length, which attens out at austenite nish tem perature  $A_f = 357 \text{ K}$ . Subsequent cooling down results in the direct m artensitic transform ation at M  $_{\rm S}$  = 342 K , which is accompanied by a shortening of the sample. As evident from Fig. 3, the striction of the transition is approxim ately 0.18%. The tem perature dependencies of strain measured in a magnetic eld of 5 T revealed that the striction of the transition remains essentially the same as in the case of the measurements without m agnetic eld. The results of the m easurements performed in zero and 5 T m agnetic elds leads to the conclusion that the application of the magnetic eld results in an upward shift of the characteristic temperatures of the martensitic transition with a rate of about 1 K/T. This value agrees very well with the results reported for polycrystalline N  $i_{2^+\,x}M$   $n_{1^-\,x}G$  a prepared by arc-melting m ethod.




FIG. 4: Compression-induced two-way shape memory effect in a N  $i_{2:18}$ M n<sub>0:82</sub>Ga PDS sample (curve 2). Curve 1 shows the temperature dependencies of strain in a stress-free N  $i_{2:18}$ M n<sub>0:82</sub>G a PDS sample.

An interesting feature of the PDS samples is that the two-way shape memory e ect can be induced in these materials by a simple loading - unloading cycle. This feature is presented in Fig. 4. Indeed, the increase in the sam ple length caused by the martensitic transition is approximately 0.18% in the case of the sample which was not subjected to compression. Another sample cut from the same ingot was compressed for 2% at room temperature in the martensitic state. A fter unloading the residual deform ation was approximately 1.2% (Fig. 2). The sam ple recovered approxim ately 75% of its initial length upon the rst heating, showing shape memory e ect. The subsequent cooling - heating process revealed that for this sample the change in the length associated with the martensitic transform ation increased twofold as com pared with the uncompressed sample and reached 0.4% . It is also seen from Fig. 4 that the change in slope of the curves at the characteristic tem peratures of martensitic transformation in the compressed sample becomes less pronounced than in the compression-free sample. Further them ocyclings dem onstrated that this com pression-

induced two-way shape m em ory e ect does not degrade and the 0.4% change in the length of the sample is very well reproducible at least up to the tenth heating -cooling cycle. It is interesting to note that a well-de ned twoway shape m em ory e ect has also been found recently in N iM n-G a thin  $\ln s$ .<sup>9</sup>

To study this compression-induced two-way shape memory e ect in more detail, several Ni2:18M no:82Ga PDS samples were compressed for values of strain, ranging from 1 to 6% . A fter unloading the residual deform ation in these samples was from 0.4 to 4%, respectively. The behavior of the sam ples upon the rst heating process was found to be dependent on the value of residual deformation. Thus, the sample with 0.4% residual deform at ion showed a perfect shape memory e ect whereas the sample with the largest residual deform ation did not exhibit shape m em ory e ect, which m eans that the residualdeform ation in this sample was essentially plastic one. The two-way shape memory e ect was found only in the samples compressed for 2 and 3%. Together with the observation that the sample compressed for 2 and 3% did not revert the original shape com pletely after the rst heating, these facts evidence that the two-way shape m em ory e ect appears when the applied stress exceeds

m em ory e ect appears when the applied stress exceeds som e critical lim it which is enough for the occurrence of an irreversible slip. W e suggest that it arises from the strain eld of dislocations induced upon com pression.

The measurements of magnetic-eld-induced strain




FIG. 5: Strain induced by a magnetic eld in the temperature interval of the direct martensitic transformation in a N  $i_{2,18}$ M n<sub>0:82</sub>G a sample, exhibiting two-way shape memory effect.

in the temperature interval of the martensitic transformation in the PDS-sintered N  $i_{2:18}$ M  $n_{0:82}$ G a samples showed that these samples exhibit rather small values of magnetic-eld-induced strain even in high (up to 5 T) magnetic elds. For instance, in the compression-free N  $i_{2:18}$ M  $n_{0:82}$ G a sample this value is equal to 0.02% in a 5 T magnetic eld. However, in the case of the samples which demonstrate the compression-induced two-way

shape memory e ect the magnetic-eld-induced strain is six times greater as compared to the samples without two-way shape memory e ect. In fact, such a tendency could be expected, since in this case the magneticeld-induced strain is due to the shift of the martensitic transition temperature caused by the applied magnetic eld. The magnetic-eld-induced strain is proportional to the relative change in the dimension of the sample per 1 K and this characteristic is much better in the sam ples with the two-way shape memory e ect. It can be suggested that an appropriate training procedure of the PDS material will results in enhancement of the magnitude of the two-way shape memory e ect, leading to an increase in the value of magnetic-eld-induced strain. It should be noted, however, that the strain of about 0.12% is not perfectly recovered. Figure 5 shows that the reversible magnetic-eld-induced strain is equal to 0.06% . This value of magnetic-eld-induced strain has been reversible form any cycles of application and rem ovalof the magnetic eld.

IV. CONCLUSION

In conclusion, the most interesting ndings of this study are that the two-way shape memory e ect can be induced in the N  $i_{2:18}$ M  $n_{0:82}$ G a PD S m aterials by an ordinary compression of the sam ples in the martensitic state. The sam ples with the two-way shape memory e ect show a signi cant enhancement in the magnitude of magnetic-eld-induced strain observed in the temperature interval of martensitic transformation.
