# A pplication of the B ogolyubov's theory of weakly non-ideal B ose gas on the $A+A, A+B, B+B$ reaction-di usion system

#### Abstract

$T$ heoretical $m$ ethods for dealing $w$ ith di usion-controlled reactions inevitably rely on som e kind of approxim ation and to nd the one that works on a particular problem is not always easy. In here the approxim ation used by Bogolyubov to study weakly non-ideal Bose gas, to be refereed to as weakly non-ideal Bose gas approxim ation (W BGA), is applied in the analysis of of the three reaction-di usion models (i) $\mathrm{A}+\mathrm{A}$ ! ; , (ii) $\mathrm{A}+\mathrm{B}$ ! ; and (iii) $\mathrm{A}+\mathrm{A}$; $\mathrm{B}+\mathrm{B}$; $\mathrm{A}+\mathrm{B}$ ! ; (the ABBA model). The two types of $W$ BGA are considered, the simpler W BGA-I and m ore com plicated W BGA-II. A llm odels are de ned on the lattice to facilitate com parison $w$ ith com puter experim ent (sim ulation). It is found that the $W$ BGA describes $A+B$ reaction well, it reproduces correct $d=4$ density decay exponent. H owever, it fails in the case of the $A+A$ reaction and the ABBA model. (To cure de ciency of $W$ BGA in dealing with $A+A$ model the hybrid of $W$ BGA and $K$ irkw ood superposition approxim ation is suggested.) It is shown that the W BGA-I is identical to the dressed tree calculation suggested by Lee in J. Phys. A 27, 2633 (1994), and that the dressed tree calculation does not lead to the $d / 2$ density decay exponent when applied to the A + A reaction, as norm ally believed, but it predicts $d / 4$ decay exponent. Last, the usage of the sm all $n_{0}$ approxim ation suggested by M attis and G lasser in Rev . M od. Phys. 70 (3), 979 (1998) is questioned if used beyond $\mathrm{A}+\mathrm{B}$ reaction-di usion m odel.


## I. IN TRODUCTION

A variety ofm ethods have been used to study di usioncontrolled reactions (see, e.g., refs. [1] [1, $\left.\underline{g}_{6}^{\prime}\right]$ for review ) ranging from sim plest pair-like or Sm oluchow skiiapproach [g] tow ards $m$ ore sophisticated $m$ ethods such as $m$ any particle density function form alism [4] [15'] and eld theory In here, we focus on the eld theory approach which is exact but, like in any other theory, one needs approxim ations to solve the problem. The particular way of m aking approxim ate calculations w ill be analyzed, the B ogolyubov's theory of weakly non-ideal B ose gas [1] to be referred to in the follow ing as $W$ eakly non-ideal Bose G as A pproxim ation (W BGA).

The eld theory is very attractive since it o ens system atic way to do calculation and there are well known procedures how to represent stochastic dynam ics of reactiondi usion system s as eld theory. Such mapping can be carried out for lattice-and o-lattice $m$ odels, see [ $\left[\frac{1}{6}\right]$ and $\left[{ }_{1}^{1}\right]$ respectively for description. Final result is that the dynam ics is govemed by a second quantized H am ittonian H $\left(a ; a^{Y}\right)$,

and system con guration at tim et can be extracted from state vector ( $t$ ). A 11 observables can be expressed as a eld theoretic averages over products of creation and annihilation operators $a^{y}$ and a.

There is no need whatsoever to resort to the use of eld theory as all calculations could be done w ithout it. T he reasons for using it are $m$ ostly practical. $F$ ield theory is a powerful book-keeping devioe. First, approxim ations involved can be $m$ ade $m$ ore transparent and, second, due to this transparency it is relatively straightforw ard to borrow approxim ations from other problem s (and related form s of eld theory).

H owever, despite its elegance, when applied to the reaction-di usion system $s$, eld theory seem $s$ to work with lim ited success. M ost often the only practical procedure of solving eld theory is perturbative calculation. Diusion is set up as the zeroth order problem and reaction is perturbation. Problem is that in the most interesting regim e, when dim ension of the system is low (bellow som e critical dim ension), perturbation series diverges due to infra-red divergences. A ny non-eld theoretic approach which aim s at perturbative treatm ent w ill su er in a sim ilarway.
$T$ he infra-read divergences are nom ally controlled in the fram ew ork of the renom alization group ( $\mathrm{R} G$ ) tech-
nique. W hen applying RG, the initial density is relevant param eter and grow sunder renorm alization process. G row ing initial densities lead to in nities in expressions which have to be controlled. So far, such control exists only in the lim ited am ount of cases, the A + A reaction being the sim plest exam ple. C learly, there is a need to avoid perturbative treatm ent (together with RG) and look for altemative ways of calculation. In here, focus is on the W BGA.

The W BGA was used to study reaction-di usion system s previously $[8$ term $s$, the basic idea behind W BGA is to neglect the products containing three or higher num ber of annihilation operators having non-zero wave vector in the H am iltonian. This procedure leads to closed set of equations for particle density and correlation functions. Solving these equations am ounts to resum $m$ ation of in nite series of diagrams. In this way W BGA appears as a non-perturbative technique which can be used to control infra-red divergences of perturbation series. In the follow ing, we w ill distinguish betw een tw o types of approxim ations to be refereed to as W BGA-I orW BGA-II which result in linear or nonlinear set of equations ofm otion respectively.

On the m ore intuitive basis, the neglect of uctuations on the shorter length scale (large $k$ vectors) has to do w ith the slow ness ofdi usion. For in itialconditionsw hen particle density is uniform there is no $k \in 0$ com ponent in average particle density and the density pro le is at. Since di usion is a very slow process one expects that this pro le is kept all the tim e up to a sm all perturbation. This picture is likely to be true when particle density is low when com pared to the reaction range, which is sum $m$ arized in the condition that $n r^{d} \quad 1$ where $n$ and $r$ denote the particle density and the reaction range $\left[{ }_{[1}^{9}\right]$. N aturally, there are other scales in the problem (w hich change in tim e) and this kind ofthinking can not be em ployed w ithout encountering problem s [4] really has to test the W BGA on the particular m odel to see whether it works.

To analyze properties of the W BGA m ethod, we apply it in the analysis of three di usion-controlled reactions (i) the $A+A$, (ii) the $A+B$ and (iii) the ABBA model. $T$ he $A B B A$ m odel includes $A+A, A+B$ and $B+B$ reactions sim ultaneously which allow sfor com petitions betw een A + A and A + B reactions (see ref. [14 details). The A + A and A + B m odels have been studied by variety of m ethods (see, e.g., ref. [1]] for review). In here, the focus is on the W BGA studies. A part from few initial studies of the A + A and A + B m odels the W BGA have not been widely used. T hese early applications of $W B G A$ on $A+A$ and $A+B$ reaction-di usion system sare $m$ ostly done for stationary situation (and decay from it) and are listed in refs. [11] $(A+A)$ and [12 13$](A+B)$. A lso, the W BGA reappears in paper [6] where it is used to study the A + B reaction.

The purpose of this work is tw ofold. $F$ irst, we study $A+A$ and $A+B$ reactions $w$ ith uncorrelated initial conditions w ith particles Poisson-distributed $\left[\bar{T}_{1}\right]$ at in itial timet=0. In previous work which em ployed W BGA m ethod in refs. $[110[1]$ it was assum ed that particles are initially correlated, w th a initial condition being prepared in a som ew hat special way [1d]. Second, onœ the workings of the W BGA approxim ation is ilhum inated, we apply the W BGA m ethod to analyze the more com plicated ABBA model. This model was studied previously w ith eld theoretic RG technique using -expansion and num erical sim ulation $[1] l^{1}[15]$. The ABBA m odel describes a m ixture of the $A+A$ and $A+B$ reactions which occur at the same time. The $A+A(A+B)$ com ponent bias kinetics tow ards $d=2(d=4)$ decay exponent and it is not a prioriclear which exponent w ill prevail. The anal-
 $w$ th $d=2$ decay exponent and di erent am plitudes.

The A + A m odelhas been studied by variety ofm ethods and lot is know about it's behavior. T he study most relevant for this work is given in ref. [19]. For uncorrelated initial conditions particle density $n$ decays asym $p-$ totically as $n \quad A(D t)^{d=2}$ for $d<2$ while there is logarithm ic correction at $d=2$ as $n \quad \ln (D t)=(8 \mathrm{D} t)$, $w$ here d denotes dim ension ofsystem, $t$ is tim $e$ and $D$ denotes di usion constant. Amplitude A is uni̇versal num ber independent on the details of the m odel. A lso, the exact splution of the m odel is possible at $\mathrm{d}=1 \mathrm{where}$ $\mathrm{n} \quad 1=8 \mathrm{Dt}$ [2d].
$T$ he $d=2$ decay exponent of the $A+A$ reaction is robust in a sense that even sim plest pair like approach (e.g. Sm oluchow skii) predicts this exponent. Thus, it is natural to test $W B G A$ on the $A+A \mathrm{model}$. It will be shown that, som ew hat surprisingly, W BGA fails to describe A + A reaction: W B GA-I predicts d=4 decay exponent while W BGA-II gives m ean eld exponent.

Taking slightly $m$ ore complicated reaction schem e, such as the A + B, leads to very hard problem where calculation $m$ ethods start to di er in their predictions. T he nature of the asym ptotics of $A+B$ reaction when in itial num ber of A and B particles is equal has been hotly debated for decades. For exam ple, Sm oluchow skiiapproach predicts $\mathrm{d}=2$ decay exponent $[4 / 1$ m ethod predicts correct $\mathrm{d}=4$ decay for $3<\mathrm{d}<4$ [2]in $\overline{1}_{1}^{1}$, while for other dim ensions nothing can be said in the RG fram ework. Strangely enough, seem ingly the most soph isticated coupled-cluster technique argues for $m$ ean
eld exponent [221. The true decay is govemed by $\mathrm{d}=4$ exponent as shown by work of Bram son and Lebow itz which provided strict $m$ athem atical proof [231]. It will be show $n$ that when particles are initially uncorrelated, i.e. P oisson-distributed, both the W BGA-I and W BGAIIpredict $d=4$ decay exponent. Strangely enough, W B G A fails on sim pler A + A reaction while it describes properly $m$ ore com plicated A $+B$ reaction.

The paper is organized as follow s. In section the
$m$ odel to be studied is speci ed in detail, and $m$ apping to the eld theory is described. The outcom e of this section is H am iltonian which describes the m ost generaltw o species reaction-di usion $m$ odel. In section iIIT equations of $m$ otion for density and correlation functions are derived usingW BGA m ethod. In section '든', theW BGA approach is used to describe A + A moodel, w th application
 W BGA-II in section 'IVI Bl. A lso in section 'IV A' equivalence of dressed tree calculation with $W$ BGA-I is shown. Section IIV Ci discusses $m$ odi cation of $K$ irkw ood superposition approxim ation in the spirit of W GA. In section Vi A + B m odel is studied by using $W$ BGA-I and W BGA'IIm ethods. Finally, the analysis of the $m$ ost com plicated of three $m$ odels studied here, the ABBA model, is presented in section $\ddagger$. W orkings of W B A -I are_analyzed in section NAA and of W BGA -II in section NIB. The step by step $m$ erger of W BGA and $K$ inkw ood superposition approxim ation is discussed in $V$ IC'. The sum $m$ ary and outline of future w ork is given in section
II. THE MODELAND THEMAPPINGTOTHE FIELD THEORY

The $m$ apping to the eld theory $w i l l$ be carried out for the $m$ ost generaltw o-species reaction-di usion $m$ odel. $T$ he $A+A, A+B$ and the ABBA m odelw illbe obtained as special cases. It w illbe assum ed that particles can not be created, neither by extemal source, nor by birth process. In the $m$ ost general version of the tw o species reactiondi usion modeleach of the $A$ or $B$ particles jumps onto the one of the neighboring lattioe sites $w$ ith rate (or diffusion constant) $D_{A}$ or $D_{B}$, irrespectively of occupation num ber of the site where particle jum ps to. A part from di using particles annihilate in pairs. Particle sitting at lattioe site x and particle sitting at the site y are assum ed to annihilate w th rate ${ }_{x y}$. This is schem atically denoted as

where ; $=A ; B$ and $x ; y=1 ; 2 ; 3 ;::: ; V$. It is assum ed that there are L lattice sites in one direction, and for d dim ensions total num ber of sites equals $V=L^{d}$. Labels $x$ and $y$ denote lattice sites.

The stochastic dynam ics of the most general twospecies $m$ odel is govemed by the $m$ aster equation of the system. The master equation describes transitions between di erent con gurations c. The con guration of the system is speci ed by the occupancy of lattioe sites at certain time $t$;

$T$ he form of the $m$ aster equation describing reactions can not be $m$ ade $m$ ore com pact since distinction has to be $m$ ade betw een reaction on the sam e and di erent lattioe sites. For exam ple, the term describing A + A reaction at the sam e lattice site has the pre-factor $n_{x}\left(\begin{array}{ll}n_{x} & 1) \text { while }\end{array}\right.$ for two di erent sites another form $n_{x} n_{y}$ has to be used.

Them aster equation $(\overline{4}(\overline{4})$ is the rst order di erential equation and one has to specify initial condition in the form $P(c ; 0)$ for all $c$. In the follow ing it $w$ ill be assum ed that $P(c ; 0)$ is $P$ oisson distribution $w$ ith averages denoted
by $n_{0 ; A}$ and $n_{0 ; B}$ for $A$ and $B$ particles respectively．This $m$ eans that $P(c ; 0)$ factorises，

This is som ewhat surprising as even sim plest pair-approach, e.g. Sm oluchow skiim ethod, describes exponent of A + A correctly. C learly A + A reaction can not be viewed as a weakly interacting B ose-gas. T he question is what is the m inim um m odi cation of W BGA which willprovide correct result for the $A+A$ m odel? $T$ his question $w i l l$ be answ ered in the next subsection.

The goal of the present section is to understand strengths and w eaknesses ofW BGA approach by testing it on the ABBA m odelwhich combines A + A and A + B reactions. These reactions have been studied in previous sections but now they are allowed to occur sim ultaneously. It is interesting to see how W BGA approach perform $s$ in such situation. C learly, there are plenty of possibilities how to com bine A + A and A + B reactions, but the way they are com bined in the ABBA model gives rise to $m$ any interesting e ects. (For exam ple, there is survival of $m$ inority species, recovery of initial density ratio, dependence of am plitudes on initial densities and reaction

In the follow ing $m$ ore term $s$ w ill be $m$ odi ed by using K irkw ood supenposition approxim ation．The dash－dot line in F ig． 2 show s a solution of equations（not shown here）obtained from m odifying $A+A$ and $B+B$ reaction sectors using shortened $K$ irkw ood supenposition approx－ im ation in the Eq．（IT12）describing tim e evolution of AB correlation function．Equations obtained in this way are identical to the $\left(1544_{1}^{(1)}-(15 \mathrm{a}) \mathrm{w}\right.$ th only di erence that Eq．（156）changes in ${ }^{-1}$ w ay that term sproportional to drop out．In Fig． 2 it can be seen that even ifall propor－ tional term $s$ are $m$ odi ed the density ratio curve clim bs to in nity，which indicates that $m$ inority species dies out， which is not correct behavior．H ow ever，the overalltrend
gets better as the dash-dot curve lies bellow dotted one and is pushed tow ards sim ulation curve.

To continue this line of increm ental changes the equations of $m$ otion where studied where even the $A+B$ reaction sector was modi ed using shortened K irkwood superposition approxim ation (all term s proportional to
were modied). Equations obtained in this way are sam e as in (154) (156) the only di erence being in the fact that all seem ingly $O(n)$ term $s$ drop out. $T$ hus in

 spectively. These equations are not shown explicitly to save the space but it should be clear how they look like. The num erical solution for this set of equations is shown in F ig. 2 as dashed line. [It is possible to analytically extract density decay asym ptotics for this truncated set of equations which gives $n_{A}(t) \quad$ (const)t ${ }^{d=2}$ and $n_{B}$ ( $t$ ) (consl) $t^{d=4}$.]

The set ofequationsw here $K$ irkw ood supenposition approxim ation has been applied fully agrees w th the nu$m$ erical sim ulation $m$ uch better than the rest which are $m$ ixture of W BGA and K irkw ood supenposition approxim ation. This is strong indication that, at least for the ABBA model, the $K$ irkwood superposition approxim ation is superior to the W BGA m ethod. For exam ple, in Fig. 2, the trend in all curves im prove as the content of superposition approxim ation is increased in equations of m otion (dotted line is w orse as it clim bs fastest, dash-dot line is a bit better, while only dashed line where superposition approxim ation is im plem ented fully saturates to constant). A s the goal of the present study is to understand W BGA m ethod better, the $m$ ore detailed analysis of ABBA reaction based on $K$ irkwood superposition approxim ation $w$ illbe presented in forthcom ing publication.
VII. C ON CLUSION S

The goal of this study was to test workings of W BGA and to relate som e seem ingly independent calculation schem es available in the literature. In particular, this work has addressed few im portant issues.
(1) It was shown that W BGA-I is equivalent to the dressed tree calculation introduced in ref. [19], and this equivalence holds for any $m$ odel where particles annihilate in pairs. Furthem ore, it was shown that for the A + A reaction the dressed tree calculation results in $d=4$ density decay exponent. Thus the contradictory claim $s$

(2) The W BGA m ethod describes $A+B$ reaction well, but does not work for A+A and ABBA models, and it is reasonable to expect that there are $m$ ore $m$ odels that can not be described by $W$ BGA. In the case of ABBA m odel $W$ BGA predicts faster vanishing of $m i-$ nority species which is suggestive of the $A+B$ like be-
havior rather than the behavior of the ABBA model as found in refs. [14 12 behavior is very hard to get rid o as successively correcting $m$ ore and $m$ ore term $s$ in equations of $m$ otion for ABBA m odel by using $K$ irkwood superposition approxim ation results in faster vanishing of $m$ inority species. $T$ he vanishing ofm inority species persists until all term $s$ are $m$ odi ed by $K$ irkw ood supenposition approxim ation. TheW BGA em phasize A + B reaction sector too strongly in the ABBA model.
(3) Findings of this work suggest that form alism em ployed by $M$ attis-G lasser in [ $[\underline{[G]}]$ where sm all $n_{0}$ expansion is introduced (and applied to study A + B m odel) is som ew hat questionable. This procedure works on $A+B$ m odel, but m ight not work for other m odels. It can be shown (by rescaling $a^{y} n_{0}!a^{y}$ and $a=n_{0}!$ a) that for the type ofm odels studied in here, the sm all $n_{0}$ approxim ation of ref. [G] am ounts to taking aw ay three body term $s$ in H am ittonian given in Eq. (211) or (2d) (e.g. operators of the type $a^{y}$ aa and likew ise any m ixture of a orb operators). The neglect of these term s am ounts exactly to W BGA-I approach, i.e. neglect of seem ingly $O\left(n^{3}\right)$ term $s$ in equations of motion for correlation functions; for exam ple, equations $\left(54_{1}^{\prime}\right)-\left(55_{1}^{\prime}\right)$ of section 'IV A' $(A+A)$,
 here it has been shown that W BGA-I set ōfequations result in incorrect $d=4$ density decay exponent when used for A A A and ABBA m odels. For these reasons, sm all $n_{0}$ expansion, which e ectively $m$ eans taking aw ay three body term in Ham iltonian, can not be trusted if used beyond A + B m odel.
(4) The K irkwood superposition approxim ation was form ulated for the case of lattioe dynam ics $w$ th $m$ ultiple occupancy of lattioe sites allow ed. There is strong indication from the present analysis that K irkw ood superposition approxim ation is superior to the W BGA m ethod, at least when applied to the A + A and ABBA m odels. H ow ever, one has to be careful in claim ing superiority of $K$ irkw ood superposition approxim ation over $W$ BGA approach since in here it was shown that $K$ irkwood superposition approxim ation describes A B BA m odelqualitatively, but it rem ains to be seen whether it w orks on the A + B m odelwhich W BGA describes well. Sim ilar study (w here only single occupancy of lattice sites w as allow ed and reaction range was assum ed short but nite) showed that $K$ irkw ood supenposition approxim ation can describe $A+B$ reaction [ $\left[\begin{array}{l}1 \\ 1\end{array}\right]$, and claim of superposition approxim ation superiority is likely to be correct but, nevertheless, such clam has to be tested throughly.

The application of $K$ irkw ood superposition approxi$m$ ation to the ABBA and A + B m odels $w$ illbe presented in the forthcom ing publication as there are $m$ any interesting technical details that need to be sorted out. For exam ple, from present study there are som e indications (results not shown here) that when using $K$ irkwood superposition approxim ation for extrem ely short range re-
action, such as on-site reaction studied here, care has to be taken so that them odynam ic lim it is accounted for properly. It seem sthat one has to approach $K$ irkw ood superposition approxim ation through form alism developed in section ${ }^{\prime} \mathrm{IV} \mathrm{C}$.

To conclude, it would be interesting to have a relatively sim ple approxim ation at hand, not far aw ay from pair approxim ation, which could be used to extract qualitative asym ptotics for arbitrary reaction-di usion $m$ odel. C learly such program is am bitious since in reality one is bound to $m$ ake approxim ation which is related to the particularm odelbut, nevertheless, it is w orth a try. T he $A+A$ and $A+B$ reaction-di usion models (or combination of them ) are excellent bench $-m$ ark $m$ odels and any successfiul approxim ation should strive to describe these reactions properly. P resent study is a attem pt in this direction.
