A pplication of the Bogolyubov's theory of weakly non-ideal Bose gas on the A + A , A + B , B + B reaction-di usion system

Theoretical methods for dealing with di usion-controlled reactions inevitably rely on some kind of approximation and to nd the one that works on a particular problem is not always easy. In here the approximation used by Bogolyubov to study weakly non-ideal Bose gas, to be refereed to as weakly non-ideal Bose gas approximation (W BGA), is applied in the analysis of of the three reaction-diusion models (i) A + A !;, (ii) A + B !; and (iii) A + A; B + B; A + B !; (the ABBA model). The two types of W BGA are considered, the simpler W BGA-I and more com plicated W BGA-II.Allm odels are de ned on the lattice to facilitate com parison with com puter experiment (simulation). It is found that the WBGA describes A+B reaction well, it reproduces correct d=4 density decay exponent. However, it fails in the case of the A+A reaction and the ABBA model. (To cure de ciency of W BGA in dealing with A+A model the hybrid of W BGA and K irkwood superposition approximation is suggested.) It is shown that the W BGA-I is identical to the dressed tree calculation suggested by Lee in J. Phys. A 27, 2633 (1994), and that the dressed tree calculation does not lead to the d/2 density decay exponent when applied to the A + Areaction, as norm ally believed, but it predicts d/4 decay exponent. Last, the usage of the sm all n_0 approxim ation suggested by M attis and G lasser in Rev. M od. Phys. 70 (3), 979 (1998) is questioned if used beyond A + B reaction-di usion m odel.

I. IN TRODUCTION

A variety ofm ethods have been used to study di usioncontrolled reactions (see, e.g., refs. [1 {8] for review) ranging from sim plest pair-like or Sm oluchow skii approach [9] tow ards m ore sophisticated m ethods such as m any particle density function form alism [4,5] and eld theory [6{8]. In here, we focus on the eld theory approach which is exact but, like in any other theory, one needs approxim ations to solve the problem . The particular way of m aking approxim ate calculations will be analyzed, the B ogolyubov's theory of weakly non-ideal B ose gas [10], to be referred to in the following as W eakly non-ideal B ose G as Approxim ation (W BGA).

The eld theory is very attractive since it o ers system – atic way to do calculation and there are well known procedures how to represent stochastic dynam ics of reactiondi usion systems as eld theory. Such mapping can be carried out for lattice-and o -lattice models, see [6] and [9] respectively for description. Final result is that the dynam ics is governed by a second quantized H am iltonian H (a; a^y),

and system con guration at time t can be extracted from state vector (t). All observables can be expressed as a eld theoretic averages over products of creation and annihilation operators a^y and a.

There is no need whatsoever to resort to the use of eld theory as all calculations could be done without it. The reasons for using it are mostly practical. Field theory is a powerful book-keeping device. First, approximations involved can be made more transparent and, second, due to this transparency it is relatively straightforward to borrow approximations from other problems (and related forms of eld theory).

However, despite its elegance, when applied to the reaction-di usion systems, eld theory seems to work with limited success. Most often the only practical procedure of solving eld theory is perturbative calculation. D i usion is set up as the zeroth order problem and reaction is perturbation. Problem is that in the most interesting regime, when dimension of the system is low (bellow some critical dimension), perturbation series diverges due to infra-red divergences. A ny non- eld theoretic approach which aim s at perturbative treatment will su er in a similar way.

The infra-read divergences are norm ally controlled in the fram ework of the renorm alization group (RG) technique. W hen applying RG, the initial density is relevant parameter and grow sunder renorm alization process. G row ing initial densities lead to in nities in expressions which have to be controlled. So far, such control exists only in the limited amount of cases, the A + A reaction being the sim plest example. C learly, there is a need to avoid perturbative treatment (together with RG) and look for alternative ways of calculation. In here, focus is on the W BGA.

The W BGA was used to study reaction-di usion systems previously $[8,9,11\{13\}]$. In somewhat technical terms, the basic idea behind W BGA is to neglect the products containing three or higher number of annihilation operators having non-zero wave vector in the H am iltonian. This procedure leads to closed set of equations for particle density and correlation functions. Solving these equations amounts to resummation of in nite series of diagrams. In this way W BGA appears as a non-perturbative technique which can be used to control infra-red divergences of perturbation series. In the following, we will distinguish between two types of approximations to be refereed to as W BGA -I or W BGA -II which result in linear or nonlinear set of equations of motion respectively.

On the more intuitive basis, the neglect of uctuations on the shorter length scale (large k vectors) has to do with the slow ness of di usion. For initial conditions when particle density is uniform there is no k 6 0 component in average particle density and the density prole is at. Since di usion is a very slow process one expects that this pro le is kept all the time up to a sm all perturbation. This picture is likely to be true when particle density is low when compared to the reaction range, which is sum marized in the condition that nr^d 1 where n and r denote the particle density and the reaction range [9]. Naturally, there are other scales in the problem (which change in time) and this kind of thinking can not be employed without encountering problem s [4]. In reality, one really has to test the W BGA on the particular model to see whether it works.

To analyze properties of the W BGA method, we apply it in the analysis of three di usion-controlled reactions (i) the A + A, (ii) the A + B and (iii) the ABBA model. The ABBA model includes A+A, A+B and B+B reactions simultaneously which allows for competitions between A+A and A+B reactions (see ref. [14,15] for more details). The A+A and A+B m odels have been studied by variety of m ethods (see, e.g., ref. [16] for review). In here, the focus is on the W BGA studies. A part from few initial studies of the A + A and A + B m odels the W BGA have not been widely used. These early applications of W BGA on A+A and A+B reaction-di usion system s are mostly done for stationary situation (and decay from it) and are listed in refs. [11] (A + A) and [12,13] (A + B). Also, the WBGA reappears in paper [6] where it is used to study the A+B reaction.

The purpose of this work is twofold. First, we study A+A and A+B reactions with uncorrelated initial conditions with particles Poisson-distributed [17] at initial time t = 0. In previous work which employed W BGA m ethod in refs. [11{13] it was assumed that particles are initially correlated, with a initial condition being prepared in a som ew hat special way [18]. Second, once the workings of the WBGA approximation is illuminated, we apply the W BGA method to analyze the more com plicated ABBA model. This model was studied previously with eld theoretic RG technique using -expansion and num erical simulation [14,15]. The ABBA model describes a mixture of the A + A and A + B reactions which occur at the same time. The A + A (A + B) component bias kinetics tow ards d=2 (d=4) decay exponent and it is not a priori clear which exponent will prevail. The analysis in [14,15] shows that both A and B particles decay with d=2 decay exponent and di erent am plitudes.

The A + A model has been studied by variety of methods and lot is know about it's behavior. The study most relevant for this work is given in ref. [19]. For uncorrelated initial conditions particle density n decays asymptotically as n A (D t) $d^{=2}$ for d < 2 while there is logarithm ic correction at d = 2 as n ln (D t)=(8 D t), where d denotes dimension of system, t is time and D denotes di usion constant. Amplitude A is universal number independent on the details of the model. Also, the exact solution of the model is possible at d = 1 where n 1= 8 D t [20].

The d=2 decay exponent of the A+A reaction is robust in a sense that even simplest pair like approach (e.g. Smoluchowskii) predicts this exponent. Thus, it is natural to test W BGA on the A+A m odel. It will be shown that, somewhat surprisingly, W BGA fails to describe A+A reaction: W BGA-I predicts d=4 decay exponent while W BGA-II gives mean eld exponent.

Taking slightly more complicated reaction scheme, such as the A + B, leads to very hard problem where calculation m ethods start to di er in their predictions. The nature of the asymptotics of A + B reaction when initial num ber of A and B particles is equal has been hotly debated for decades. For example, Sm oluchow skii approach predicts d=2 decay exponent [4,5,9]. Field theoretic RG m ethod predicts correct d=4 decay for 3 < d < 4 [21], while for other dimensions nothing can be said in the RG fram ework. Strangely enough, seem ingly the most sophisticated coupled-cluster technique argues for m ean eld exponent [22]. The true decay is governed by d=4 exponent as shown by work of Bram son and Lebow itz which provided strict mathematical proof [23]. It will be shown that when particles are initially uncorrelated, i.e. Poisson-distributed, both the W BGA-I and W BGA-II predict d=4 decay exponent. Strangely enough, W BGA fails on sim pler A + A reaction while it describes properly m ore com plicated A + B reaction.

The paper is organized as follows. In section Π the

model to be studied is specied in detail, and mapping to the eld theory is described. The outcom e of this section is H am iltonian which describes the most general two species reaction-di usion m odel. In section III equations of motion for density and correlation functions are derived using W BGA method. In section IV the W BGA approach is used to describe A + A model, with application ofW BGA-I discussed in section IV A, and application of WBGA-II in section IVB. Also in section IVA equivalence of dressed tree calculation with W BGA-I is shown. Section IV C discusses modi cation of K irkwood superposition approximation in the spirit of WBGA. In section V A + B m odel is studied by using W BGA-I and W BGA-II m ethods. F inally, the analysis of the m ost com plicated of three models studied here, the ABBA model, is presented in section VI. W orkings of WBGA-I are analyzed in section VIA and of WBGA-II in section VIB. The step by step m erger of W BGA and K irkwood superposition approximation is discussed in VIC. The summary and outline of future work is given in section VII.

II. THE MODEL AND THE MAPPING TO THE FIELD THEORY

The mapping to the eld theory will be carried out for them ost general two-species reaction-di usion model. The A + A, A + B and the ABBA model will be obtained as special cases. It will be assumed that particles can not be created, neither by external source, nor by birth process. In the most general version of the two species reaction-di usion model each of the A or B particles jumps onto the one of the neighboring lattice sites with rate (or diffusion constant) D_A or D_B, irrespectively of occupation number of the site where particle jumps to. A part from di using particles annihilate in pairs. Particle sitting at lattice site x and particle sitting at the site y are assumed to annihilate with rate $_{\rm xy}$. This is schematically denoted as

where ; = A;B and x;y = 1;2;3;:::;V. It is assumed that there are L lattice sites in one direction, and for d dimensions total number of sites equals $V = L^d$. Labels x and y denote lattice sites.

The stochastic dynamics of the most general twospecies model is governed by the master equation of the system. The master equation describes transitions between di erent con gurations c. The con guration of the system is speci ed by the occupancy of lattice sites at certain time t;

Diusion and reaction contribute independently to change of P (c;t);

The form of the master equation describing reactions can not be made more compact since distinction has to be made between reaction on the same and di erent lattice sites. For example, the term describing A + A reaction at the same lattice site has the pre-factor $n_x (n_x \ 1)$ while for two di erent sites another form $n_x n_y$ has to be used.

The master equation (4) is the rst order di erential equation and one has to specify initial condition in the form P (c; 0) for all c. In the following it will be assumed that P (c; 0) is P oisson distribution with averages denoted

by $n_{0;A}$ and $n_{0;B}$ for A and B particles respectively. This m eans that P (c;0) factorises,

P lease note that expression for H_R has the m ore compact form than the expression for related part of the m aster equation (6) as all sums in (12) over x and y are unrestricted (a rst sign of convenient book-keeping). A lso the fact that reactions A + A, B + B and A + B happen independently from each other in uences the form of H_R ; contributions describing A + A (rst line of Eq. 12), B + B(second line) and A + B (third line) enter additively.

where O (n_x) denotes any function which depends on particle numbers in arbitrary way. The generalization of Eq. (15) for more complicated form for O $(n_x; m_y; :::)$ is trivial. Vector h1j is given by

being left eigenvector of a_x^y and b_x^y with eigenvalue 1. To see that Eq. (15) indeed evaluates observables correctly one can expand function O in Taylor series in n_x and check that for every term in Taylor series Eq. (15) works.

Following ref. [6], since $h ja_x^y \in 0$, it is useful to transform Eq. (15) slightly in order to obtain form where h j changes into the vacuum state h 0 j. This makes calculation somewhat easier since one can use property of the vacuum that $h 0 ja_x^y = 0$. To do the transformation follow – ing identity proves useful,

P lease note that Eq. (27) is an approximation which is valid for smallk. The form in Eq. (28) is exact. Once the explicit form of H is known one can proceed with calculation of particle density, as shown in the next section.

III. EQUATIONS OF MOTION FOR DENSITY AND THE CORRELATION FUNCTIONS

Equation (18) sum marizes how observables are calculated within the eld theory form alism. We continue with the speci c case of local particle densities n_A (x;t) and n_B (x;t), which can be calculated with $O = a_x^y a_x$ and $O = b_x^y b_x$ respectively; using (18) one gets n_A (x;t) = $ha_x i$ and n_B (x;t) = $hb_x i$, or more explicitly

If initial conditions are translationally invariant, which is the case for Poisson-distributed particles, local particles densities are position independent, i.e. $n_A (x;t) = n_A (t)$ and $n_B (x;t) = n_B (t)$. where the sum over x divided by $\frac{p}{V}$ was recognized as k = 0 component of a_k and b_k .

The equations of motion for $n_{\rm A}$ (t) and $n_{\rm B}$ (t) can be derived as follows. $n_{\rm A}$ (t) and $n_{\rm B}$ (t) are proportional to $ha_0\,i$ and $hb_0\,i$ respectively, and it is su cient to derive equations for them . Taking time derivative of $ha_0\,i$ and $hb_0\,i$ gives,

Few comments about the inversion symmetry (in k-space) of $_{k}$; = A;B are in order. By construction, $_{k}$ (t) = $_{k}$ (t) for = A;B since these functions represent correlations for same operator types. It is not obvious whether this property holds for $_{k}^{AB}$ which describes correlations for di erent operators type. Using Eq. The last term s in Eqs. (40)-(42), which are product of density and correlator, and appear to be third order in density $0 (n^3)$, lead to non-linear equations of motion. These terms come from averages of the type $ha_k a_q a_l i$ where one of fk;q;lg m om enta is zero while rem aining two are not. One example would be $ha_0a_ka_1i$ which is approximatively equal to $ha_0 i ha_k a_1 i$. (Same discussion would apply irrespectively which operator one uses in average, a_k or b_k .) Being third order in density, it is tem pting to neglect these 0 (n^3) term s, since one expects that leading contribution should come from terms which are second order in density $0 (n^2)$, e.g. rst and second term s on the right hand side of Eq. (40) and likew ise for Eqs. (41) and (42). To test the e ect of neglecting or keeping 0 (n³) terms two approximations will be studied W BGA-Ior W BGA-II with O (n³) term s taken away or kept in the calculation. W BGA-I approximation results in a linear set of equations which makes the analytical analysis possible. A lso, as form ulated above, the WBGA-II and WBGA appear to be equivalent. In the following, the term W BGA will im ply both W BGA-I and W BGA-II.

The equations of motion for the three models we wish to study, the A + A, A + B and ABBA are easily extracted from the most general form given in (35)–(36) and (40)–(42). To obtain equations of motion for the ABBA model one simply sets $D_A = D_B = D$ and

An obvious distinction is being m ade between K ronecker delta-function x_{iy} and the symbol which denotes the reaction rate. Thus particles have to meet at the same lattice site in order to react. Further, to obtain the A + A m odel one simply sets = 0 (this decouples A + A and B + B reactions, i.e. particles A and B m ove and react independently of each other). To get A + B m odel one takes = 0 which rules out the A + A reaction. In the following section we continue with analysis of the A + A m odel within W BGA framework.

Equations (54)-(55) and Eq. (62) are fully equivalent. Both equations have been dealt with before, how ever, in a very di erent context. Eq. (62) was obtained in ref. [19] through a diagram matic technique and referred to as the dressed-tree calculation. Thus in here we have shown that W BGA-I is equivalent to the dressed tree calculation. Eqs. (54)-(55) have been also obtained in the study of the entirely di erent A + B m odel in ref. [6].

Studies [19] and [6] suggest contradictory result: ref. [19] argues that the dressed tree calculation gives d=2decay exponent for particle density, while ref. [6] argues for the d=4 decay exponent. In ref. [19] it was incorrectly concluded that dressed-tree calculation results in the d=2 exponent, which basically cam e from balancing w rong terms in Laplace transform ed version of Eq. (62). In here calculation done in ref. [19] will be repeated to show how to balance terms correctly. A lso, calculation w ill justify approximations employed in ref. [6] m ore rigorously as the method of calculation employs Laplace Transform and well know Tauberian theorems which relate smalls with large t behavior. In this way all the approximations are controlled.

Again, carrying out similar type of matching procedure would give negative am plitude. Finally, the = d=2 avenue has to be given up. At this stage one is left by the second (b) way of balancing, i.e. matching constant n_0 term on the left hand side of (71) with s² d⁼² on the right hand side. (The remaining terms, e.g. such as the s on the left hand side can be balanced by considering sub-leading corrections to n (s)). This way of balancing immediately gives = d=4 and

(True enough, n_0 is constant but it is multiplied by g(s).) Thus n_2 (s) indeed has to be m atched with $g(s)n_0$. This procedure results in am plitude A_b obtained previously. Also, by using form (57), one can show that am plitude A_b as given in Eq. (73) is valid even for d > 2. A nalysis can be repeated with nite value of with the same outcom e. B effore proceeding, it is in portant to mentioned that procedure outlined above does not work at d 4 and it has to be modi ed.

The main ndings of this subsection are twofold. First, it has been shown that dressed tree calculation is equivalent to W BGA-I. Second, it was shown that W BGA-I (and dressed tree calculation) fail to describe A + A reaction predicting d=4 decay exponent;

All ndings of this subsection are sum marized in Fig.1. The num erical treatment of Eqs. (54) and (55) con rm s asymptotic decay given in Eq. (74). Equations (54) and (55) were solved previously num erically in ref. [6]. In here, the features of the decay curves are som ew hat different from the ones obtained in ref. [6]. For example, curves shown in this work have concave form (bend upward), while curves in q. 1 of ref. [6] are convex (bend dow nw ard) as if asym ptotics have not yet been reached. A lso, in here, there is no intersection of curves, which can be found in ref. [6]. These di erence could com e from the num erical treatm ent. A part from using double precision, to obtain curves in Fig. 1 the method of integration was used which integrates exactly $\int_{0}^{t} dt^{0}(t - t)^{d=2} f(t^{0})$ provided f(t) is piecewise linear in t. The more detailed description of num erical treatm ent is shown in the appendix B

In the next subsection it will be shown that, in the case

of A + A reaction, weaknesses of W B G A -Im ethod extend to W B G A -II level.

For large t, W BG A-II gives exactly the same a symptotics as the pure mean eld treatment.

Thus main nding so far is that both W BGA-I and W BGA-II fail to describe A + A reaction. This is somewhat surprising as even simplest pair-approach, e.g. Sm oluchow skiim ethod, describes exponent of A + A correctly. C learly A + A reaction can not be viewed as a weakly interacting Bose-gas. The question is what is the minimum modi cation of W BGA which will provide correct result for the A + A model? This question will be answered in the next subsection.

C.The hybrid of W BGA and K irkwood superposition approxim ation

To see how to improve W BGA one has to clarify what went wrong in the rst place. We start from problem atic equation (40) which becomes (48) when term swith $\frac{AB}{k}$ are set to zero. To trace why W BGA fails it is useful to rewrite Eq. (40) as it looks one step before W BGA is made, and we keep only term s describing A + A reaction:

It is interesting to note that instead of (85) one could carry out K inkwood superposition approximation in a different way, e.g. as $h_x n_y n_z i$ $h_x n_y i h_x n_z i h_y n_z i = n^3$. (There is no such ambiguity when only single occupancy of site is allowed.) When multiple site occupancy is allowed, as considered here, we argue that Eq. (85) is more accurate way to implement K irkwood superposition approximation.

By boking at equation (84) it is possible to understand W BGA better. Eq. (84) suggests that W BGA is somewhat equivalent to the additive expansion of correlation functions. It has been argued that such additive approximation is inferior to the K irkwood superposition approximation [4,5]. This in turn explains why W BGA fails to describe the A + A reaction.

C learly, to correctly describe A+A reaction one has to use K inkwood superposition approximation, which we modify further in the spirit of W BGA, assuming that higher order products of annihilation operators a_k ; b_k with k \leftarrow 0 are small, and accounting for therm odynamic limit (extracting a_0 or b_0 out of eld theoretic averages). This is done in two stages. First, K inkwood superposition approximation in Eq. (85) is rephrased in the k-space which gives [26]

First term on the right hand side of (88) can be neglected since it leads to mean eld behavior (as shown in section IV B). Interestingly enough, both W BGA-I and W BGA-II approaches lead to correct d=4 exponent when used to solve A + B m odel.

In some sense the W BGA approach seem s to be suited rather well for A + B reaction. Q uite the contrary can be said for A + A reaction as shown previously. To understand workings of W BGA on the more generalm odel the ABBA m odel will be studied in the next section.

VI.W BGA APPLIED TO THE ABBA MODEL

The ABBA model was suggested in refs. [14,15] and it has a number of interesting properties. The model is obtained as the special case of the general two species model discussed in section II where A + A and B + B reactions occur with same reaction rate , while A + B with reactions rate , and > is taken. The fact that A and B species have equal di usion constants is very in portant since it leads to survival of minority species. M inority species is the one with smaller concentration at t = 0, and we chose B to be minority, i.e. $n_{0;A} > n_{0;B}$. By survival it is meant that particle density ratio saturates to constant u (t) n_A (t)= n_B (t) ! const as t ! 1. (The mean eld analysis predicts vanishing of minority species u (t) ! 1 as t ! 1 . Also, sim ilar model has been studied in ref. [27] where it was shown that if D $_{\rm A}$ $\stackrel{6}{=}$ D $_{\rm B}$ only one type of species survives.)

The goal of the present section is to understand strengths and weaknesses of WBGA approach by testing it on the ABBA model which combines A+A and A+B reactions. These reactions have been studied in previous sections but now they are allowed to occur simultaneously. It is interesting to see how WBGA approach performs in such situation. C learly, there are plenty of possibilities how to combine A+A and A+B reactions, but the way they are combined in the ABBA model gives rise to m any interesting e ects. (For example, there is survival of m inority species, recovery of initial density ratio, dependence of am plitudes on initial densities and reaction rates [28], please see refs. [14,15] for details).

W e start from equations of motion given in section III which describe very general two species reaction-di usion model. A ssum ptions in Eq. (46) describe content of the ABBA model. Using (46) in Eqs. (35)-(36) gives

A coording to W BGA-I both particles decay with d=4 exponent and am plitudes given above. The W BGA-I predicts same decay exponent as for the pure A+A m odel. As in the case of A+A reaction, the value for d=4 exponent obtained here is not correct. The computer simulation and -expansion analysis of this reaction suggest d=2 exponent [14,15]. To see what happens when O (n^3) term s are kept in (110)-(112) we proceed with W BGA-II calculation.

The explicit form of constants c_1 , c_2 , c_3 , c_4 , c_5 and c_6 is not interesting since aim is to show that terms containing these constants are sub-leading to the mean eld terms. To see that terms originating from J(t;0) are subleading one really has to calculate U explicitly. For example, not knowing that contribution from $!_1$ is absent in (144), there would be a need to compare t² (asymptotics of the mean eld n_B^2 term in 144) with t $^{(d=2+4)}$ (coming from J(t;0) and $!_1$ eigenvalue). One would conclude that = = can not be too large if mean eld asymptotics is to hold. In reality, there is no such bound on ratio = since eigenvalue $!_1$ does not appear in Eq. (144), but this can only be seen after explicit calculation.

M ain ndings so far is that W BGA describes ABBA and A+A m odel in the same way. For both m odels the W BGA-I (W BGA-II) predict d=4 (m ean eld) density decay exponents. In the next section attempt will be m ade to improve W BGA m ethod in order to obtain correct value of density decay exponent for ABBA m odel.

C.The hybrid of W BGA/K irkwood applied to A + A and B + B sectors

How deep the weakness of W BGA goes? W hat needs to be changed in equations of motion (110)-(112) in order to get correct decay exponent? To answer these questions we begin by modifying the A+A and B+B reaction sectors in (110)-(112) by using the recipe from section IV C. It was already remarked in the section II that contributions to H describing di erent reaction sectors enter additively, and this feature is receted in equations of motion (110)-(112). Because of this it is possible to focus on term s describing in uence of A+A and B+B reactions, i.e. term s proportional to , which govern decay exponents of the ABBA model. At the moment term s proportional in (110)-(112) that describe A+B reaction will not be changed.

The num erical solution of the set of equations above is shown in Fig. 2 (dotted line). The full line is a result of M onte C arb simulation where particle densities are obtained as ensemble averages over 500 runs (sim ulation is repeated 500 times with a shift in the random num ber generator). The Eqs. (154)-(156) do not describe ABBA model properly, not even qualitatively, since m inority species die out faster (the particle density ratio grows to in nity) while the simulation shows that density ratio should saturate to a constant value (full line). Thus the attempt of modifying terms describing A + Aand B+B reaction sector in AA and BB correlation functions by using shortened K irkwood superposition approxim ation does not cure weaknesses of W BGA approach. The inspection of individual density decays reveals that the equations above correctly describe decay of m a prity (const)t d=2, but fail do describe decay species, i.e. n_A ofm inority species $n_{\rm B}$.

In the follow ing m ore term s will be m odi ed by using K irkw ood superposition approximation. The dash-dot line in Fig. 2 shows a solution of equations (not shown here) obtained from m odifying A + A and B + B reaction sectors using shortened K irkw ood superposition approximation in the Eq. (112) describing time evolution of AB correlation function. Equations obtained in this way are identical to the (154)-(156) with only di erence that Eq. (156) changes in a way that term s proportional to drop out. In Fig.2 it can be seen that even if all proportional terms are m odi ed the density ratio curve clim bs to in nity, which indicates that m inority species dies out, which is not correct behavior. How ever, the overall trend

gets better as the dash-dot curve lies bellow dotted one and is pushed towards simulation curve.

To continue this line of incremental changes the equations of motion where studied where even the A + B reaction sector was modified using shortened K inkwood superposition approximation (all terms proportional to

were modied). Equations obtained in this way are same as in (154)-(156) the only dierence being in the fact that all seemingly O (n) terms drop out. Thus in the (154)-(156) only diusion term and terms $_{\rm AA}$,

 $_{BB}$ and $_{AB}$ are kept in (154), (155) and (156) respectively. These equations are not shown explicitly to save the space but it should be clear how they look like. The numerical solution for this set of equations is shown in Fig. 2 as dashed line. [It is possible to analytically extract density decay asymptotics for this truncated set of equations which gives n_A (t) (const)t $d^{d=2}$ and n_B (t) (const)t $d^{d=4}$.]

The set of equations where K inkwood superposition approximation has been applied fully agrees with the numerical simulation much better than the rest which are m ixture of W BGA and K irkwood superposition approxim ation. This is strong indication that, at least for the ABBA model, the Kirkwood superposition approximation is superior to the W BGA method. For example, in Fig. 2, the trend in all curves in prove as the content of superposition approximation is increased in equations of motion (dotted line is worse as it clim bs fastest, dash-dot line is a bit better, while only dashed line where superposition approximation is implemented fully saturates to constant). As the goal of the present study is to understand W BGA method better, the more detailed analysis of ABBA reaction based on K irkwood superposition approximation will be presented in forth coming publication.

V II. C O N C LU S IO N S

The goal of this study was to test workings of W BGA and to relate some seemingly independent calculation schemes available in the literature. In particular, this work has addressed few in portant issues.

(1) It was shown that W BGA-I is equivalent to the dressed tree calculation introduced in ref. [19], and this equivalence holds for any model where particles annihilate in pairs. Furthermore, it was shown that for the A + A reaction the dressed tree calculation results in d=4 density decay exponent. Thus the contradictory claims of refs. [19] and [6] have been sorted out.

(2) The W BGA m ethod describes A+B reaction well, but does not work for A+A and ABBA models, and it is reasonable to expect that there are more models that can not be described by W BGA. In the case of ABBA model W BGA predicts faster vanishing of m inority species which is suggestive of the A+B like behavior rather than the behavior of the ABBA model as found in refs. [14,15]. This bias towards A + B type behavior is very hard to get rid o as successively correcting more and more terms in equations of motion for ABBA model by using K inkwood superposition approxim ation results in faster vanishing of minority species. The vanishing of minority species persists until all terms are modiled by K inkwood superposition approximation. The W BGA emphasize A + B reaction sector too strongly in the ABBA model.

(3) Findings of this work suggest that form alism em ployed by M attis-G lasser in [6] where sm all n_0 expansion is introduced (and applied to study A + B m odel) is som ew hat questionable. This procedure works on A + B model, but might not work for other models. It can be shown (by rescaling $a^y n_0 ! a^y$ and $a=n_0 ! a$) that for the type of m odels studied in here, the sm all no approxim ation of ref. [6] amounts to taking away three body term s in Ham iltonian given in Eq. (21) or (28) (e.g. operators of the type a^y aa and likew ise any mixture of a or b operators). The neglect of these terms amounts exactly to W BGA-I approach, i.e. neglect of seem ingly O (n^3) terms in equations of motion for correlation functions; for example, equations (54)-(55) of section IV A (A+A), or equations (113)-(117) from section VIA (ABBA). In here it has been shown that W BGA-I set of equations result in incorrect d=4 density decay exponent when used for A+A and ABBA models. For these reasons, sm all n₀ expansion, which e ectively means taking away three body term in Hamiltonian, can not be trusted if used beyond A + B m odel.

(4) The Kirkwood superposition approximation was form ulated for the case of lattice dynam ics with multiple occupancy of lattice sites allowed. There is strong indication from the present analysis that K irkwood superposition approximation is superior to the W BGA method, at least when applied to the A+A and ABBA models. However, one has to be careful in claim ing superiority of Kirkwood superposition approximation over WBGA approach since in here it was shown that Kirkwood superposition approximation describes ABBA model qualitatively, but it rem ains to be seen whether it works on the A+B model which W BGA describes well. Sim ilar study (where only single occupancy of lattice sites was allowed and reaction range was assumed short but nite) showed that K inkwood superposition approximation can describe A + B reaction [4], and claim of superposition approxim ation superiority is likely to be correct but, nevertheless, such claim has to be tested throughly.

The application of K irkwood superposition approxim ation to the ABBA and A + B m odels will be presented in the forthcom ing publication as there are m any interesting technical details that need to be sorted out. For example, from present study there are some indications (results not shown here) that when using K irkwood superposition approxim ation for extrem ely short range reaction, such as on-site reaction studied here, care has to be taken so that therm odynam ic lim it is accounted for properly. It seems that one has to approach K inkwood superposition approximation through formalism developed in section IV C.

To conclude, it would be interesting to have a relatively simple approximation at hand, not far away from pair approximation, which could be used to extract qualitative asymptotics for arbitrary reaction-di usion model. Clearly such program is ambitious since in reality one is bound to make approximation which is related to the particularm odel but, nevertheless, it is worth a try. The A + A and A + B reaction-di usion models (or combination of them) are excellent bench-mark models and any successful approximation should strive to describe these reactions properly. Present study is a attempt in this direction.




FIG.1. FIG 1. The num erical solution of Eqs. (54-55) for d = 1;15;25;3 (solid lines). The dotted lines indicate asymptotics as given by Eq. (74). Time is given in seconds and particle density n (t) is dimensionless in units of particles per site. Initial density n_0 was set equal to 1, and reaction rate = 1s¹ was used.




FIG.2. FIG 2. The num erical solution of Eqs. (152-156) for d = 1 with increasing am ount of K irkwood superposition approxim ation embedded (dotted, dash-dot and dashed line). Fullcurve is result of a M onte C arlo simulation (average of 500 runs). Parameters used are L = 1000, n_A (0) = 2, n_B (0) = 1, = 1 and = 2.
