Appearance of H alf-M etallicity in the Quaternary H eusler A lloys

I report systematic rst-principle calculations of the quaternary Heusler alloys like $Co_2 [Cr_1 \times Mn_x]Al, Co_2MnAl_x \times Sn_x]$ and $Fe_1 \times Co_x \ge MnAl$. I show that when the two limiting cases (x=0 or 1) correspond to a half-metallic compound, so do the intermediate cases. Moreover the total spin moment M_t in $_B$ scales linearly with the total number of valence electrons Z_t (and thus with the concentration x) following the relation $M_t = Z_t$ 24, independently of the origin of the extra valence electrons, con m ing the Slater-Pauling behavior of the normal Heusler alloys. Finally I discuss in all cases the trends in the atom ic projected DOSs and in the atom ic spin m om ents.

I. IN TRODUCTION

Heusler alloys consist a large fam ily of interm etallic compounds which attract regularly considerable attention due to the variety of magnetic phenomena which they present. Lately the interest has been focused on the ones being halfm etals (HM)¹² like N iM nSb or $Co_2M nSn^{1,2,3,4}$ These compounds are ferrom agnets for which the minority spin-band presents a gap and the Ferm i level falls within this gap. Thus the spin polarization at the Ferm i level is 100% and these materials are of special interest for spintronic applications;^{5,6} the spin of the electron and not the charge is used as the property to control the device. Contrary to other HM system s like the diluted m agnetic sem iconductors or the m anganites and some oxides,⁶ the half- and full-H eusler alloys (e.g. NM nSb and Co₂M nSn, respectively) and the zinc-blende com pounds like C rA s' present very high Curie tem peratures making them attractive for industrial applications.

Lately I have devoted a lot of work on the latter com pounds trying to address three main points i) the origin of the half-m etallicity^{3,4,7} ii) w hether the half-m etallicity is preserved at the surfaces or $\ln \overline{S'}^8$ and iii) to predict new half-m etallic m aterials which m ay present better grow th on top of sem iconductors.^{3,4,7} U sing rst principle calculations it was shown in the case of the ordered halfHeusler alloys like N M nSb that the gap is form ed between the occupied bonding d states resulting from the interaction between the higher-and the lower-valent transition m etal atom s and the corresponding antibonding states.³ For the full-H eusler alloys like Co_2M nSn the situation is more complicated since there are also states located only at the C o sites and the resulting gap is tiny.⁴ The total spin m om ent for the latter com pounds is given by the relation M $_{t}$ = Z_{t} -24, where M $_{t}$ is the total spin m om ent in $_{\rm B}$ and $Z_{\rm t}$ the total num ber of valence electrons. I will discuss this behavior in detail in a later paragraph.




FIG.1: Calculated total spin moment M_t in _B for a variety of compounds as a function of the concentration x (x=0,0.1,0.2,...,0.9,1). I assumed that the lattice constant varies linearly with the concentration x. W ith lled geometrical objects the cases obeying the rule M_t = Z_t 24 where Z_t is the total number of valence electrons; this is the so-called Slater-Pauling behavior.

In the present contribution I will conclude this study by exam ining the behavior of the so-called quaternary Heusler alloys. In the latter compounds, one of the four sites is occupied by two di erent kinds of neighboring elements like $Co_2 [Cr_{1 \times} Mn_x] A l where the Y site is oc-$

cupied by CrorMn atoms (see Fig. 1 in Ref. 4 for the de nition of the structure). To perform this study I used the Korringa-Kohn-Rostoker (KKR) method⁹ developed by Professor A kai, which has been already used with success to study the magnetic sem iconductors.¹⁰ The atom ic disorder at a speci c site is in plem ented using the coherent potential approximation (CPA). The space is divided in non-overlapping mu n-tin spheres and the vanishing charge in the interstitial region is considered to be constant and charge neutrality is in posed. Such an approximation is reasonable to describe a close-packed structure like the one of the Heusler alloys. To check the validity of this description I com pared the total spin m om ent with the full-potential calculations perform ed in Ref. 4. For all the com pounds with the exception of Co₂VA lboth m ethods produced sim ilarm aquetic properties for the experim ental lattice constants.¹¹ V 3d wavefunctions have a large extent and the mu n-tin approximation is not adequate to describe the V m agnetism; thus I had to use a lattice constant 4% larger than the experim ental one to get a half-m etallic com pound, as predicted by the fullpotential KKR for the experim ental lattice constant. I assumed that the lattice constant varies linearly with the concentration x which has been veri ed for several quatemary alloys.¹¹ Finally I should mention that the total spin m om ent is not exactly an integer due to num erical inaccuracies. To decide whether an alloy is half-m etallic or not I used the total DOS as a criterion, as was also the case in the previous studies.^{3,4,7} I will stly focus my study on the behavior of the total spin m om ent for several cases and show that it follow s the Slater-Pauling behavior when the lim iting cases are half-m etals. A fterwards I will study the case where the Y site (see Fig. 1 in Ref. 4) is occupied by two di erent elements like Co [Cr_{1 x} M n_x]A l, followed by the case when there are two di erent types of sp atom s like $Co_2M n [A \downarrow_x Sn_x]$. Final case is when the X sites are disordered like $\mathbb{F}e_1 \times Co_x \ge M$ nAl. At the end I sum m arize and conclude.

As it was shown in Ref. 4 the total spin moment in the case of the half-metallic full-Heusler alloys obeys the rule $M_t = Z_t$ 24, where M_t is the total spin moment in $_B$ and Z_t the total number of valence electrons. The 24 arises from the fact that there are in total 12 occu-

pied m inority states; e.g. in the case of Co_2M nAlAl provides one minority s band very low in energy and three m inority p bands which accommodate also transition metal d electrons. There are also ve occupied bonding d bands created from the interaction between the Mn and the Co atoms. The Ferm i level falls within the gap created by the occupied triple degenerated d states and the unoccupied double degenerated d states which are exclusively located at the Co sites and are perm itted by the symmetry of the crystal. The moments behavior is the well-known Slater-Pauling behavior known from the binary alloys. In the latter compounds the spin m om ent decreases with Z_t since the spin-up states are completely occupied and the extra electrons occupy spin-down states reducing the total spin m om ent. In the case of the full Heusler alloys the Ferm i level is xed within the minority band gap and the extra electrons as we change the chem ical elements occupy exclusively spin-up states and the total spin m om ent increases. U sing the KKR-CPA method we calculated the total spin moment for several quaternary alloys taking into account several possible com binations of chem ical elements and assuming in all case a concentration increment of 0.1. I resume my results in Fig. 1. The rst possible

case is when I have two di erent low-valent transition metal atoms at the Y site like $Co_2 [Cr_1 \times Mn_x]Al$. The total spin moment varies linearly between the 3 $_{\rm B}$ of $Co_2CrAl and$ the 4 B of $Co_2M nAl$. In the case of the $C\,o_2 \, [\!C\,r_{\!1}\,_x\,Fe_{\!x}\,]\!A\,land\,C\,o_2\,[\!M\,n_{\!1}\,_x\,Fe_{\!x}\,]\!A\,lcom$ pounds and up to around x=0.6 the total spin m om ent show s the SP behavior but for larger concentrations it slightly deviates to account for the not integer value of Co_2 FeAl⁴ This behavior on the gure is clearly seen when we compare the lines for the C o₂ M n_{1 x} Fe_x A land C o₂ M n A l_{1 x} Sn_x] com pounds; the latter fam ily follow ing the SP behavior. The second case is when one m ixes the sp elements, but as I just mentioned these compounds also obey the rule for the total spin m om ents. The third and nal case is to mix the higher valent transition metal atoms like in $[Fe_{1 \times} Co_{x}]_{M}$ nAland $[Rh_{1 \times} Co_{x}]_{M}$ nAlalloys. In the rst case the total spin m om ent varies linearly between the 2 and 4 $_{\rm B}$ of Fe₂M nAl and Co₂M nAl compounds, respectively. Rh is isoelectronic to Co and for the second fam ily of com pounds we nd a constant integer value of $4_{\rm B}$ for all the concentrations. A special case is M n₂VA 1 which has less than 24 electrons and the total spin moment is -2 B. If now Im ix Mn and Co Iget a fam ily of com pounds where the total spin m om ent varies linearly between the -2 $_{\rm B}$ and the 2 $_{\rm B}$ and for x= 0.5 I get the case of a param agnetic com pound consisting of m agnetic elements. Thus all the compounds obey the rule M $_{t}$ = Z $_{t}$ -24, showing the Slater-Pauling behavior regardless of the origin of the extra charge. In the next paragraphs I will analyze in detail every case.

The st large family of quaternary alloys which are susceptible to be HM s are the ones where there are two kinds, Y and Y², of low-valent transition m etal atom s: $X_2 (Y_1 \times Y_x^2)Z$, where X stands for the high-valent transition m etalatom and Z for the sp atom . Iw ill concentrate m y analysis on Co₂ [C $r_1 \times M n_x$]A L A lready in Ref. 4 it was shown that both Co₂C rAl and Co₂M nAl are HM s with a total spin m om ent of 3 _B and 4 _B, respectively.




FIG. 2: A tom -projected DOS of Co₂ [Cr₁ $_{\rm x}$ M n_x]Al for three di erent values of x: 0.1,0.5,0.9. The DOS's have been scaled to one atom .

In Fig. 2 I present the atom -projected DOS and in Table I the spin m om ents scaled to one atom for several concentrations. For all concentrations, one gets a HM system since the Ferm i level falls within the m inority gap. The width of the gap is the same for all compounds since the gap is formed between states located exclusively at the Co sites and which are little a ected by the lower-valent transition m etal atom s like M n and Cr.⁴ This is clearly seen in Fig. 2 where the gap in the case of the Cr and M n atom s is much larger than for the Co atom s. The total spin m om ent scales linearly between the two extremes re-

ecting the half-m etallicity. For low M n concentrations, the M n atom acts like an impurity and the e_q and t_{2q} electrons are well separated. This is clearly seen in the MnDOS, where for smallMn concentration there is a double peak in the majority band just below the Fermi level. The lower peak is the eq electrons and the higher peak the t_{2q} electrons of M n. W hen the M n concentration increases these states overlap and they can not be any more distinguished and M n shows a more itinerantlike magnetism. The states lower in energy around -3 eV are t_{2q} -like states which couple to the p states of A l and 11 the bands created by the latter ones. In the case of Cr the behavior is the inverse. It is for the case of high Cr concentrations, where the e_g and t_{2g} are distinguished. For low Cr concentrations the population of the occupied m inority states is larger and they are lower in energy than for high concentrations attracting also the unoccupied states lower in energy and resulting to a smaller spin moment. The di erences in the Co DOS mainly arise from the di erent position of the Cr and M n m a prity bands through the C oulom b interaction and the Co spin moment only slightly changes with the concentration. Finally in the case of Co₂ [Cr_{1 x} Fe_x]Al

and $Co_2 M n_{1 \times} Fe_x A l com pounds the situation is sim i$ lar but the Common ents show more important changessince Fe can not account only by itself for the extra electron and the Common ent has also to reach a higher value.This was discussed in detail in Ref. 4.

Now I will go on with the case of the $X_2 Y [Z_1 \times Z_x^2]$ com pounds, where I change the charge at the Z site. I studied both the C o₂M n [A l_{1 x} S i_x] and C o₂M n [A l_{1 x} Sn_x]. Si and Sn are isoelectronic and both fam ilies present the same behavior, thus I will restrict my presentation to the second fam ily. The moment changes from 4 up to $_{\rm B}$ linearly and thus all the interm ediate cases are 5 HM s. In Table II I have gathered the atom -resolved spinm om ents. The sp atom s show a practically constant m om ent and the extra charge is taken into account by the transition metal atoms. If I bok carefully at the Mn m a prity spin band (not presented here), there are unoccupied states at the vicinity of the Ferm i level which pass under the Ferm i level and becom e occupied as the concentration of Sn increases. Thus the Mn spin moment increases practically linearly from 2.6 to 3.2 $_{\rm B}$. The higher polarization of the M n d states polarizes also the Co bands since they form a common majority band and the Common entincreases by $0.2_{\rm B}$.




FIG. 3: Atom projected DOS in the case that both X sites are occupied by Co and Fe with 50% probability (system is denoted by $[Fe_{0.5}Co_{0.5} \ \mbox{M nA l}]$ and when one sublattice is occupied exclusively by Fe and the other by Co atom s (system is denoted by FeC oM nA l). All compounds are half-m etals. The numbers in the legends are the atom ic spin m om ents in $_{\rm B}$ and the larger ones are the total spin m om ents.

The last case I will discuss is when I m ix the highvalent transition metal atoms. The rst fam ily is the $[Fe_{1x} Co_{x}]_{2}M$ nAl, where the total spin moment increases from 2 to 4 $_{\rm B}$ with the concentration. The Almoment stays small and is negligible while the M n m om ent is 2.6 $_{\rm B}$ for all concentrations. The Fe m om ent varies form 0.32 to 0.26 _B and the Co one from 0.63 to 0.75 $_{\rm B}$. Thus the atom ic spin m om ents change little and the increase in the total spin m om ent arises exclusively from the substitution of Fe by Co. It is also interesting to compare Fe0:5Co0:52MnAl with FeCoMnAl. In the latter compound one of the sublattices is occupied exclusively by Fe atoms and the other by Co ones. Both systems are HMs as can be seen in Fig. 3 and the total spin moment is 3 $_{\rm B}$. Both compounds show similar atom ic spin moments, thus the exact position of the Fe and Co atoms is not so relevant for the magnetic properties, which are

controlled mainly by the concentration of the chemical elements. If I compare the DOSs presented in Fig. 3, I see that the atom projected ones have the same characteristics although the ones for FeC oM nAl are more spiky. The main di erence is a small majority gap just below the Ferm i level in FeC oM nAl which is washed out for $[Fe_{0.5}Co_{0.5}]_{\rm b}M$ nAl. This gap is the signature of the order.

The second family of compounds is the $\mathbb{R}h_{1 \times} Co_x \mathbb{R}M$ nAl. Rh and Co are isoelectronic elements and the total spin moment is 4 $_B$ for all concentrations. A loo RhC oM nAl is a HM with magnetic properties similar to $\mathbb{R}h_{0.5}Co_{0.5}\mathbb{R}M$ nAl as it was the case for the compounds containing Fe. Since Rh moment is much smaller than the Co one, the Mn moment has to increase considerably, from 2.6 to 3.4 $_B$, with the increase of Rh concentration to keep the total spin

m om ent constant,.

A special case uder study is the M n_{1 x} C o_x \downarrow VA l fam – ily. For this compound the spin m om ent changes from 2 to 2 _B with the concentration x. As shown in R ef. 4 the M n and V atom s in M n₂VA l are antiferrom agnetically coupled and V carries a large spin m om ent, while in C o₂VA l the C o and V atom s are ferrom agnetically coupled and the m om ent is mainly carried by the C o atom s. For x= 0.5 there is the case of a compound with zero total spin m om ent but with m agnetic constituents; m^{M n} = 0.47 _B, m^{C o} = 0.20 _B and m^V = 0.23 _B. The M n spin m om ent decreases from 1.45 _B to -0.35 with the concentration x while the C o spin m om ent increases from 0.2 to 0.95 _B and the V one decreases from 0.8 to 0.16 _B.

In this contribution I expanded the study already perform ed for the ordered Heusler alloys to cover also the quaternary Heusler compounds like Co2 [Cr1 x Mnx]Al, $Co_2Mn[A_{1x}Sn_x]$ and $Fe_{1x}Co_x_2MnAl$. Using the Korringa-Kohn-Rostokerm ethod in the coherent potential approximation I have shown that independently from which site is disordered, all compounds are half-m etals and the total spin m om ent M $_{\rm t}$ scales linearly with the total number of valence electrons Z₊ following the rule M $_{t}$ = Z $_{t}$ 24, thus M $_{t}$ scales also linearly with the concentration x. Depending of the fam ily under study the atom ic spin m om ents change in a way that the above rule, known also as the Slater-Pauling behavior, is obeyed. Finally an interesting case is $M n_{1 x} C o_{x} \ge VA l where the$ moment scales linearly from $2_{\rm B}$ to $2_{\rm B}$ and for x = 0:5 the total spin m om ent is zero but the constituents are m agnetic.
