The multifractal characterization of the distribution over disorder of the mean rst-passage time in a nite chain is revisited. Both, absorbing-absorbing and rejecting-absorbing boundaries are considered. Two models of dichotom is disorder are compared and our analysis claries the origin of the multifractality. The phenomenon is only present when the dijusion is anomalous.

I. IN TRODUCTION

In the past two decades, a great e ort has been devoted to the study of di usion and transport in disordered media by models based on random walks [1, 2, 3]. Basically, the dynamics of the system can be described by a master equation for a particular probability distribution. Two alternative ways are usually employed. The rst one is based on the probability P (r;t) that the walker is on site r at tim e t when starting from the origin at <math>t = 0. The second way consists of analyzing the statistics of the exit time from a given region. In both cases, there are exact enum eration techniques which enable us to calculate the corresponding observable in all the possible disorder con gurations. Thus, we can num erically reckon the distribution over disorder of the probability P (r;t), or the m om ents hP^q (r;t)i of this distribution [3, 4, 5, 6, 7, 8, 9]. In an analogousm anner, we can num erically evaluate the distribution of the mean rst-passage time (MFPT) over disorder, or its m om ents [10, 11, 12, 13, 14, 15, 16],

where (T) is the distribution over disorder and q is a real number not necessarily integer. The crucial point of di usion in disordered media is that transport can be anom alous, i.e., the mean square displacement of a random walk scales with time as $r^2 = D t^{2=d_w}$, where $d_w > 2$ is the anom alous di usion exponent. A relevant property of the anom alous di usion is that it leads to broad distributions. Their moments cannot be described by a single exponent but an in nite hierarchy of exponents is needed to characterize them [9, 13]. This fact

In this work, we revisit the Sinaim odel and we address

enables us to study the distributions over disorder with the multifractal form alism [17, 18].

Random walks on random fractals (such as the in nite percolation cluster at criticality) are processes with anom alous di usion, which are characterized by logarithm ically broad distribution functions re ecting an underlying multifractal structure [3, 4, 6, 7, 8, 10]. An important issue in these systems is the nature of the multifractality based on the dynamical process or in the steady state (as the voltage drop distribution in percolation). For the voltage drop distribution, the multifractal behavior is well established for all values of q [3]; whereas for the dynamical di usive process the multifractality only appears in a range of values of q [8]. Another property of these processes is that while the multifractal behavior appears in the distribution of the probability P (r;t), it is not present in the mean number of distinct sites visited by a particle di using on the percolating cluster [19]. Another dynamical process with \ultra-anom alous" slow motion is the Sinai model [20] for diusion in a linear chain in the presence of random elds. For this model, the mean square displacement of a random walk follows asymptotically r^2 ln⁴ t. Several studies [5, 11, 12, 14, 15, 21] have established the multifractal properties of the model. However, the origin of the multifractality in this process is yet an open question.

the last question. Particularly, we compare the behavior of the MFPT distributions over disorder and its moments for two processes with dichotomic disorder. One of them is the Sinaim odel and the other is a nonanomalous biased random walk in a nite disordered chain. The outline of

ized by the scaling exponents (q) in Sec. IV, where we employ the multifractal formalism [17, 18] to calculate the exponents (q) of the corresponding partition function. Also, the generalized Renyi dimensions D(q), and the spectra f() are given in that section. Finally, in Sec. V, we brie y summarize the results of our work.

II. M EAN FIRST-PASSAGE TIM E IN QUENCHED DISORDERED CHAINS

We consider the continuous time dynamics of a random walk on a discrete one-dimensional lattice with nearest neighbor hopping. The walker jumps from site n to site n+1 with transition probability per unit time w_n^+ , or to site n-1 with transition probability per unit time w_n^+ , or to site n-1 with transition probability per unit time w_n^- . We are concerned with the exit time of the walker from the nite interval $D=[\ M\ ;L\]$ on the chain, with at least one absorbing end. The average of the survival time until the absorption, over realizations of the random walk, is the MFPT. Recently, we have obtained a general exact expression for the MFPT for a xed set of transition probabilities fw $_j$ g [22]. Let T_n denote the MFPT if the walker initially began at site n 2 D . For an interval with both absorbing extremes (w $_{(M+1)}^+$ = w $_{L+1}^-$ = 0) we get

In this work we x the starting point n=0 (de ning T T_0) and we consider two possible boundary conditions. The rst one is the interval [L;L] with absorbing-absorbing (AA) extrem es. The total number of sites, N_s , in the interval is 2L+1. The M FPT for this case is given by Eq. (2) taking M=L. The second case is the interval [0;L] with rejecting-absorbing (RA) ends. Here, $N_s=L+1$ and from Eq. (2), taking n=0, M=0, and $M_0=0$, we im $M_0=0$, we im $M_0=0$ botain for the M FPT [22],

The e ect of the re-ecting boundary is the striking \sin – pli cation of the structure of the equation for the M FPT .

This fact leads us to consider also the AA boundary conditions in the problem of multifractality of the MFPT distribution over disorder.

In nite discrete systems, we can enumerate all the congurations N of disorder. We denote by T $_{(i)}$ the MFPT for the ith realization of the quenched disorder. We stress that all the congurations of disorder are equally probable. However, the resulting values T $_{(i)}$ are distributed by (T), the MFPT distribution over disorder. Thus, we can compute exactly the moments of the MFPT distribution, given the set of values fT $_{(i)}$; i=1;::::N g, from the denition given by Eq. (1),

In particular, the M FPT averaged over disorder results in M (1). For dichotom ic models of disorder, in a chain with N $_{\rm S}$ sites, there are N = $2^{\rm N}$ $_{\rm S}$ possible realizations of the random lattice, which can be easily enumerated. The set of values fT $_{\rm (i)}$; i = 1;:::;N g can be exactly calculated employing expression (2) for the AA boundary conditions, or by Eq. (3) for the RA extremes.

III. MODELS OF DISORDERED CHAINS

Now, we assume that the hopping probabilities w_j are strictly positive random variables, chosen independently from site to site and identically distributed. A dditionally, we adm it that the site transition probabilities are not necessarily symmetric in the sense that $w_j^+ \notin w_j$. Thus, we can incorporate the elects of bias in to the chain by external elds.

We select the rst distribution for the transition probabilities in such a way that they satisfy the Sinai condition [20], namely, the random variable $\ln w_{i}^{+} = w_{i}$ has zero mean and nite variance 2. Thus, we consider a dichotom ic model by de ning $w_j = 1$ w_j^+ and prescribing w_{i}^{+} to be equal to 1=2 w ith equal probabilities. The parameter measures the strength of disorder, and can take values between 0 and 1=2. = 0 corresponds to a simple homogeneous random walk, and for > 0 we get a disordered random walk with local bias (random eld). It is easily veri ed that the above prescriptions satisfy the Sinai condition. Particularly, we obtain $^2 = \ln^2$ (), where () (1 + 2) = (1 2).In the asymptotic limit! 1=2, the variance diverges. The MFPT averaged over disorder for the dichotom ic Sinai m odel diverges as $()^{N_s}$ for N_s ! 1, where $(1 + 4) = (1 \quad 4)$ [23], whereas the typical value of the rst-passage time, de ned as exp (hln T i), diverges $P = \frac{P}{1 + \frac{P}{2}}$ $N_s=2$ [24]. Here, the brackets h slower, as exp denote the average over disorder. Therefore, the distribution of the MFPT over the Sinaidisorder has a power-law tail [25].




FIG. 1: Num erical evaluation of $T_{m\ ax}$ as a function of N $_{s}$ for chains with the AA ends and L from 1 to 13.

It is easily seen that the largest value of the M FPT, $T_{m\ ax}$, is obtained for the RA ends when at all the sites, the right jump transition is 1=2 $\,$, and the left jump transition is 1=2+ $\,$. In the asymptotic lim it of N $_{\rm S}$! 1 , we obtain $T_{m\ ax}$ $^{N\ s}$ [14]. For the AA extremes, $T_{m\ ax}$ cannot be easily evaluated. Thus, instead of an analytical expression, in F ig. 1 we show a numerical calculation of $T_{m\ ax}$ for several values of . We see that asymptotically log $(T_{m\ ax})$ N_{s} , as in the RA case.




FIG. 2: Histogram of (T) for a chain with L = 7, the AA boundary conditions, and the Sinai disorder with = 0.25. We are using the rescaled variable $\ln T = \ln T_{m~ax}$ and uniform buckets of width equal to $2^9 \cdot T_{m~ax} = 9824$.

In Fig. 2, we show the histogram of the distribution (T) over the dichotom ic Sinai disorder. The gure was constructed computing Eq. (2) for M = L = 7 (N $_{\rm S}$ = 15), and using all the possible congurations of disorder. A related gure, for the histogram of (T) for chains with the RA extremes, can be seen in Ref. [14]. The distribution (T) has previously been studied [25] for the RA boundary conditions and results broad.

Our second random biased model for the transition probabilities is de ned by $w_j = w_j^+$ and prescribing w_j^+ to be equal to 1=2 or 3=2 w ith equal probabilities. In this case, the parameter measures the strength of the bias, and can take values between 0 and 1=2. In the limit of = 0, we get a disordered symmetrical random walk. This dichotomic model corresponds to a class of weak disorder with global bias. The quantities $k = 1 = w_j^+$ result nite for all k = 1. Therefore, the model does not present anomalous diusion [1]. For the MFPT averaged over disorder with the AA boundary conditions, we obtain up to rst order in [22, 26],

The asymmetry in the hopping transitions links the strength of the bias with the uctuation of the disorder, de ned by F $_2$ $_1^2$ = $_1^2$. In our particular case, we get $_1$ = 4=3, and F = 1=4. On the other hand, for the RA extremes, we obtain up to rst order in [22],

Strikingly, for these boundary conditions, the uctuation of the disorder is not present in the averaged M FPT . This fact relies on the di erence in the structures of Eqs. (2) and (3). In the limit of L! 1, M (1) diverges as L^2 independently of the boundary conditions.




FIG. 3: Histogram of (T) for a chain with L=7, the AA boundary conditions, and weak disorder with =0.25. We are using uniform intervals of width equal to 2^9 . $T_{max}=31.75$.




FIG. 4: Sketches of the particle potential for both kinds of disorder and small : (a) The Sinaim odel. The di erence between two consecutive peaks is 2 , with random sign. (b) Weak disorder. The dierence between one peak and the following is always .

In Fig. 3, we show the histogram of the corresponding distribution (I) over dichotom ic weak disorder. Here, we do not obtain a broad but a more localized distribution. We must stress the dierence in the scales used to construct the plots in Figs. 2 and 3. This fact is the rst indication of the di erent nature in the distribution over disorder between both models. Both models were constructed to get $w_i^+ = 1$, and the main dierence among them is in the role of the parameter . This parameter controls the disorder in the Sinaim odel and regulates the bias in the second model. Thus, in the Sinaim odel the bias is local, i.e., the direction of the bias is random ly drawn in each site, whereas in the second model, we are considering a globalbias eld which points to the right in all sites. A ssum ing that the jump probabilities per unit tim e involve the Arrhenius factor (see Ref. [26]), the landscape for the particle potential is schem atically sketched in Fig. 4 for both models.

IV. MULTIFRACTAL ANALYSIS

In order to characterize the divergences of the m om ents of the M FPT distribution over disorder, we postulate that in the lim it N $_{\rm S}$! 1 , the qth m om ent obeys the scaling relation M (q) N $^{\rm (q)}$. In order to verify this ansatz, we have numerically reckoned log M (q)] vs N $_{\rm S}$. For chains with the AA ends, we take L from 1 to 13 and use Eq. (2) for evaluating the set fT $_{\rm (i)}$; i = 1;:::;N g, for a given L. For chains with the RA boundary conditions, we take L from 1 to 20 and use Eq. (3) for calculating the values T $_{\rm (i)}$, for a xed size of the chain. For all values of and q, and for both m odels of disorder, with the AA or RA extremes, we obtain straight lines.




FIG. 5: Plot of the scaling exponents $\,$ (q) for chains with the AA boundary conditions and the Sinai disorder.




FIG. 6: Plot of the scaling exponents $\ (q)$ for chains with the RA boundary conditions and Sinai disorder.

The slope of the linear tting for the Sinaim odel with the AA (RA) ends is plotted in Fig. 5 (Fig. 6) as functions of q, for three values of . For all , we obtain that (q) is a monotonically increasing function with (0) = 0, which is due to the normalization condition of the distribution. We observe that for large values of , (q) is a nonlinear function; whereas in the limit of weak disorder, (q) becomes a linear function. For the model of weak disorder, we obtain (q) = q, where > 0 is a decreasing function of . Therefore, for weak disorder, we get a single gap exponent for describing the moments of the MFPT distribution. The analysis with both kinds of boundary conditions leads us to qualitatively similar behaviors for the exponents (q), for both models of disorder described in Sec. III.

Now, let us de ne the partition function as follows [17]:

A gain, we postulate that in the lim it N $_{\rm S}$! 1, the partition function obeys a scaling relation. Thus, we write Z (q) N $^{\rm (q)}$. It is well known that for nonmultifractal distributions, the exponents (q) are linear functions on q, namely, (q) = q 1. The multifractality appears with a nontrivial dependence of the scaling exponents on q. For all values of and q, and for both models of disorder, we obtain straight lines when we plot $\log[Z]$ (q)] vs N $_{\rm S}$. Therefore, the scaling ansatz is veri ed. Here, we have also used L from 1 to 13 for the AA ends, and L from 1 to 20 for the RA extremes.




FIG. 7: Plot of the scaling exponents (q) for chains with the AA boundary conditions and the Sinai disorder, using L from 5 to 13. The solid line corresponds to the linear relation q 1.




FIG. 8: Plot of the scaling exponents (q) for chains with the RA boundary conditions and the Sinai disorder, using L from 6 to 14. The solid line corresponds to the linear relation q=1.

In Fig. 7 (Fig. 8), we plot (q) for chains with the dichotom ous Sinaim odel, the AA (RA) ends, and for three representative values of . The functions (q) satisfy (0) = 1. Additionally, we get (1) = 0, which is due to the normalization condition of Z (q). In the lim it of ! 0, (q) q 1, and for strong disorder, (q) exhibits a nonlinear dependence. Thus, the multifractality for the Sinaim odel is unam biguously established, independently of the boundary conditions. For the model of weak disorder, we obtain (q) = q - 1 for all values of , within the accuracy of the num erical evaluations. Therefore, we have not found multifractality in our model of weak disorder, neither with the AA nor with the RA boundary conditions. This result reinforces the idea that the multifractal phenom enon is only related to anom alous di usion. Both models are based on the same dichotomic rule for assigning values to the transition probabilities. Moreover, in both cases we found $w_{i}^{+} = 1$. In spite of these sim ilar characteristics, the selected models have quite different behaviors. The random eld resulting from the Sinai condition is at the basis of the anom alous di usion and the origin of the multifractal behavior of the M FPT

distribution over disorder.

The simple plots obtained in the graphs for the functions (q) suggest us that the multifractality is due to the presence of a binom ial multiplicative process. For this process, the mass exponents are [18]

where $p_1+p_2=1$. This expression im m ediately satis es the conditions (0) = 1 and (1) = 0, and in the lim it $p_1=p_2=1$ =2, results in (q) = q 1. For $p_1<1$ =2, we get the lim it expressions

In our case, the param eters p_1 and p_2 are functions of the strength of disorder (). In Table I, the values of the tting of (q), using the two param eters p_1 and p_2 , are displayed for both kinds of boundary conditions. We only obtain a good quality of tting for small values of . For strong disorder, the condition $p_1 + p_2 = 1$ is relaxed and we can only tboth asymptotic regimes of the curves for q! 1. This fact is a strong indication that the nature of the multifractal phenomenon is more complex than a multiplicative rule.

A usual characterization of multifractality is the gen-




FIG. 9: Generalized dimensions D (q) for chains with the AA boundary conditions and the Sinai disorder.




FIG. 10: Generalized dimensions D (q) for chains with the RA boundary conditions and the Sinai disorder.

In Fig. 9 (Fig. 10) we depict the generalized dimension spectra for the same conditions and values of as given by Fig. 7 (Fig. 8). We not that D (q) is a monotonically decreasing function of q, and satisfies D (0) = 1, which is the dimension of the support of the distribution.

Taking the Legendre transform of (q), we can obtain the multifractal spectrum f() = (q) + q, where the Lipschitz-Holder exponent is the derivative of (q) with respect to q. Figure 11 (Fig. 12) shows the f() spectra for the same conditions and values of as given by Fig. 7 (Fig. 8). For strong disorder, the curve f() become sbroad, whereas for f() the spectrum collapses to the point (1;1). As is known, the maximum value of f() is the fractal dimension of the support of the measure.

In this work, we have chosen the scaling param eter N

to characterize the system size. In Ref. [14], a sim ilar multifractal analysis for the Sinai disorder and the RA boundary conditions was based on the scaling parameter $T_{m\ ax}$. We have seen in Sec. III that $T_{m\ ax}$ / N . However, this choice of the scaling parameter leads to spurious results, such as the variation of D (0) with . This




FIG. 11: Multifractal spectra f() for chains with the AA boundary conditions and the Sinai disorder.




FIG. 12: Multifractal spectra f() for chains with the RA boundary conditions and the Sinai disorder.

phenom enon is an artifact of the mathematical selection

of the scaling param eter, and not a characteristic property of the system under analysis. On the other hand, for one-dim ensional system s, we expect that the dim ension of the support of the multifractal measure is equal to 1.

Finally, we derive the relation between the exponents (q) and (q). From the de nitions given by Eqs. (4) and (7), we immediatly obtain

U sing the scaling ansatz in the last equation and taking logarithm s, we get

Particularly, the last relation satis es inmediately that (0) = 1 and (1) = 0. From the result quoted in Sec. III, for chains with the RA ends, we found $(1) = \log_2(1)$.

V. CONCLUDING REMARKS

In this work, we have considered the distribution of the M FPT over two classes of disorder, the Sinai and another dichotom icm odelwith global bias and nonanom alous diffusion. Our results con m us that the multifractality is related only to anom alous di usion.

The multifractal behavior in the MFPT distribution over the Sinai disorder is not a consequence of the multiplicative structure of Eq. (2) or (3) (the expressions for the MFPT for a xed realization of disorder), as was stated in a previous report [14]. The multifractality is an inherent attribute of the strong disorder in the Sinai model, and is well established for both kinds of boundary conditions. Moreover, the multifractal signature found in the spectra obtained suggests us that the origin of the phenom enon is more complex than a binom ialmultiplicative process.
