Optical Response of Solid CO₂ as a Tool for the Determ ination of the H igh P ressure P hase

We report rst-principles calculations of the frequency dependent linear and second-order optical properties of the two probable extended-solid phases of CO_2 (V, i.e. $I\overline{4}2d$ and $P2_12_12_1$. C om pared to the parent C m ca phase the linear optical susceptibility of both phases is much smaller. We nd that $I\overline{4}2d$ and $P2_12_12_1$ di er substantially in their linear optical response in the higher energy regime. The nonlinear optical responses of the two possible crystal structures di er by roughly a factor of ve. Since the di erences in the nonlinear optical spectra are pronounced in the low energy regime, i.e. below the band gap of diam ond, measurem ents with the sample inside the diam ond anvil cell are feasible. We therefore suggest optical experiments in comparison with our calculated data as a tool for the unam biguous identi cation of the high pressure phase of CO_2 .

A few years after the synthesis of the extended-solid phase of CO_2 at 40 GPa the crystal structure of this phase is still not known. This phase was found to be sim ilar to one of the noncentrosym metric polym orphs of quartz [1, 2] and was designated as CO_2 {V. Since solid CO_2 has very high tensile strength (com parable to that of boron nitride [3]) this discovery could be very useful in device applications. There is also considerable interest in the role of CO_2 in planetary geology [4].

Experimental work done to identify the exact crystal structure of CO₂ at high pressure suggests a low sym m etry tridym ite phase ($P 2_1 2_1 2_1$) [5]. The presence of a nonlinear optical signal also indicated the absence of inversion sym m etry in the crystal structure [1]. M ost of the theoretical work has been concentrated around the lattice relaxations and total energy calculations in search of the minimum energy structure [6, 7, 8]. Theory predicts the -cristobalite phase (I42d) to be low er in energy than $P 2_1 2_1 2_1$ by around 0.19 eV per formula unit [7]. However, none of the SiO $_2$ -like polym orphs of CO $_2$ gave a satisfactory t to the experimental XRD data [5,8]. O ther possible quartz polym orphs have been elim inated by their much higher total energies [6]. Since all experim ents were perform ed at elevated tem peratures (1800K) and the theoretical energy di erence between the two phases is small, the energy minimization is not su cient to solve the discrepancy between theory and experiments and to predict the actual high pressure phase. In order to understand the nature of this phase transition there is the need for analyzing other physical properties and

nding a satisfactory agreem ent between theory and experiment. Since the two probable phases have very dierent electronic structure it is possible to distinguish them by their optical response. So far, neither a theoretical or experimental study of the linear optical response have been performed. Although second harmonic generation (SHG) by CO_2 has been seen experimentally, there exist no experimental data or calculations of the frequency de-

pendent SHG susceptibility. The aim of the present work is to show that the linear and nonlinear optical spectra indeed allow an unambiguous identi cation of the CO₂ { V crystal structure. To this extent we have calculated the linear and second-order optical response of solid carbon dioxide, CO₂ {V, in the two possible phases. The linear optical spectra of these probable phases are com pared to each other and also to that of the Cm ca phase, which under high pressure and temperature conditions leads to CO_2 {V. Since quartz is often used as a standard in second-harm onic (SH) experim ents, a detailed com parison is made between the second-order optical response of the two CO_2 {V phases and that of SiO₂ (I42d phase). W e propose that on basis of our results, future experin ental work will help to resolve the present disagreem ent between theory and experim ent and hence clarify the high pressure phase of CO_2 .

Total energy calculations are performed using the state-of-the-art full-potential linearized augm ented plane wave FPLAPW method implemented in the W EN2k code [9]. For the exchange-correlation potential we use the generalized gradient approximation (GGA) derived by Perdew and W ang [10]. The detailed form alism for the determination of the linear susceptibility tensor (1) (!) within the FPLAPW form alism has been presented before [11]. The susceptibility for the SHG ⁽²⁾ (2!;!;!) has been calculated using an extension to this program [12]. The SHG susceptibility obtained satis es all the theoretical sum rules presented by Scandolo and Bassani [13]. All the calculations are converged in term s of basis functions as well as in the size of the k-point mesh representing the Brillouin zone. The optical properties are calculated on a mesh of 1500 k-points in the irreducible wedge of the Brillouin zone.

The phases of CO₂ under investigation in the present work are the Cm ca phase and the two probable extendedsolid phases for CO₂ {V, namely I42d and P $2_12_12_1$. For the P $2_12_12_1$ phase the starting point is the experimental lattice parameters [5] with the atom ic positions of the $C 222_1$ phase (which is the supergroup of the space group $P2_12_12_1$). In a st step, the lattice parameters are kept constant at the experim ental values and the intemal parameters are fully relaxed. This structure is referred to as $P 2_1 2_1 2_1$ (expt in the present work. Next, the lattice and the internal parameters are simultaneously relaxed (keeping a constant volum e [14]) to attain the minimum energy con guration. This structure is referred to as $P 2_1 2_1 2_1$ {rel. The energy low ering on going from $P 2_1 2_1 2_1$ (expt to the $P 2_1 2_1 2_1$ (rel structure is 0.81) eV per form ula unit, which is around 0.16 eV m ore than the previous theoretical value [7]. The larger energy in the present calculations com pared to the previous theoretical value could be due to the di erence in the m ethod of calculation, since in the previous work the pseudopotential approach was used [7]. In case of the I42d phase, due to the lack of experim ental data, the starting lattice constants and internal parameters are taken to be those of SiO_2 in the same phase. Then the atom s as well as the cell volume are fully relaxed to attain the minimum energy con guration. The lattice parameters for all the structures are presented in Table I. In accordance with the previous theoretical work [7, 8] we nd -cristobalite (142d) to be lower in energy com pared to the P 212121 { relphase. The di erence in energy between the P $2_12_12_1$ {rel and the theoretically determ ined I42d phase at 40 GPa is $0.38 \text{ eV}/\text{CO}_2$.




FIG.1: The magnitude of the linear susceptibility components for solid CO₂ in (a) the Cm ca phase, (b) the $I\overline{4}2d$ phase at 40 GPa, (c) the P $_{21}2_{1}2_{1}$ (expt structure and (d) the P $_{21}2_{1}2_{1}$ (rel structure.

The results for the linear optical spectra of CO $_2\,$ in




FIG. 2: The magnitude of the second-harmonic generation susceptibility components xyz and zyx for (a) SiO₂ in the I $\overline{4}2d$ phase, (b) CO₂ in the I $\overline{4}2d$ phase at 40 GPa, (c) in the P $2_12_12_1$ {expt structure and (d) in the P $2_12_12_1$ {relstructure.

various phases are presented in Fig. 1. None of the optical spectra are scissors corrected. Both the P $2_1 2_1 2_1$ and the I42d phase are taken at 40 GPa. The Cm ca phase shows a strong an isotropy with $j_{yy}^{(1)}$ (!) jm uch larger in am plitude than $j_{xx}^{(1)}$ (!) j and $j_{zz}^{(1)}$ (!) j lying in between the two. The reason for this anisotropy is the orientation of the molecules within the crystal. The neighbouring m olecules are parallel to each other in the ab plane and form a herringbone pattern in the ac and bc planes Fig. 2(b) in Ref. 15]. This causes the yy and zz polarized transition matrix elements (TMEs) to be large. On the other hand the xx polarized TMEs are close to zero, leading to sm all values for $j_{xx}^{(1)}(!)j_{zz}^{(1)}(!)j_{zz}$ is sm aller than $j_{yy}^{(1)}$ (!) jbecause the lattice parameter b is smaller than c. On going from the low pressure Cm ca phase to any other phase of CO $_2\text{--}V$, j $_{yy}^{(1)}$ (!) j and the anisotropy between $j_{yy}^{(1)}$ (!) jand $j_{xx}^{(1)}$ (!) jdecrease dram atically. The latter fact can again be explained by the orientation of the molecules inside the unit cell Fig. 3E and 3F in Ref. 8]. The neighbouring CO_2 m olecules are nom ore parallel or perpendicular in any direction leading to a weakening of the very strong transitions and an enhancem ent of the TMEs which were forbidden in the Cmca phase. For all the probable phases of CO_2 {V the spectral weights are shifted to higher energies. The optical band gap of the $P 2_1 2_1 2_1$ (expt structure is smaller than that of the C m ca phase, while the other two structures show alm ost equal optical band gaps, which are higher than that of the C m ca phase. C om pared to the C m ca phase the m axin um peak height is around 3 tim es smaller in the $\overline{142d}$ phase, while it is about 4 times smaller in the P $2_12_12_1$ structures. Beyond 11 eV, the response of all the probable phases of CO₂ {V is on average sim ilar in m agnitude, but di ers in the amount of anisotropy.

For I42d there are two independent tensor com ponents. Compared to the zz component, the xx component is approxim ately upto 2 tim es as large in the energy range below 10 eV. Upto 10.5 eV and between 11.5 and 13 eV the e ect is opposite, while the two are nearly the same for higher energies. For the $P 2_1 2_1 2_1$ structures there are three inequivalent components and the anisotropy between the xx and zz components is very sm all com pared to the I42d phase. We also nd the lattice relaxation e ects which have already been described in detail by Dong et al. [7]. They have some consequences for the optical spectra. On going from the Cm ca phase to $P 2_1 2_1 2_1$ (expt, the optical band gap decreases, while it increases in case of P 212121 (rel. A nother noticeable feature is that the anisotropy is much larger in the P 2₁2₁2₁ {expt structure. Since CO₂ {V is not quenchable into am bient pressure at room tem perature the optical m easurem ents need to be perform ed with the sam ple inside the diam ond anvil cell (DAC). The band gap of diam ond is 5.5eV. Therefore the energy regime below 5.5eV is most interesting, since the optical response in this energy regime is purely from the sample inside the DAC. The di erence between the linear optical spectra of various probable phases of CO₂ below this energy range is not as pronounced as in the higher energy regime. The results though are of theoretical interest and help in identication of various features in the nonlinear optical spectra (which is rather di cult to do from the band structure plots), but may not be very good in phase distinction under these experim ental conditions.

The nonlinear optical properties are much more sensitive to small changes in the band structure than the linear optical spectra. The calculated m agnitude of the SHG susceptibility by CO₂ {V in various probable phases are presented in Fig. 2. Due to the presence of inversion symmetry in the Cm caphase the SHG susceptibility is zero. The second-order response of SiO₂ (I $\overline{4}$ 2d), which is often used as standard in SHG experiments, is also presented in the gure. In the energy range between 3 and 5.5 eV them agnitude of the SHG susceptibility by CO_2 in the P $2_12_12_1$ {expt phase is 1.5 {2 tim es sm aller than that of quartz. On the other hand the I42d phase of CO_2 shows a SHG susceptibility 3{4 times larger than that of SiO₂. These pronounced di erences make the phases easily identi able. The energy range of 3{5.5 eV lies below the band gap of diam ond and corresponds to laser light of wavelengths between 413.3 - 247.9 nm. Previous SH experim ents were perform ed using laser light of 1054 nm wavelength [1], which correspond to 1.176 eV. At this energy our calculated value of $j_1^{(2)}(2!;!;!)j$ for CO₂ in the I42d phase is 2.7 times larger than that of SiO₂. W hile, the SHG susceptibility by CO_2 in the $P2_12_12_1$ { expt phase is 2.6 times smaller than that of SiO₂. The previous experim entalwork [5] reports the SH conversion e ciency of the CO₂ {V phase, which is not just proportional to the square of the SHG susceptibility but also depends on the input intensity and sample parameters. So no direct com parison of the existing experim ental data can be made with the present results. Since the di erence in the second-order response by the probable phases of CO_2 -V are more pronounced in the energy range between 3 and 5.5 eV than in between $1\{2 \text{ eV}, \text{experim ents}\}$ at higher energies would be favourable. Experimental determ ination of the SHG susceptibility by CO2 {V and SiO_2 , over som e frequency range, and a com parison with our work could lead to conclusive results.

The two structures of the P 212121 phase are also di erentiable by their SHG response. Due to the large optical band gap of $P 2_1 2_1 2_1$ {rel the SHG susceptibility is approximately 3 times smaller than that of P $2_12_12_1$ (expt. As shown in Ref. 7 the XRD patterns for neither of these structures m atches the experiments. The theoretically calculated XRD pattern of $P 2_1 2_1 2_1$ {rel shows a better agreem ent with the experim ental XRD pattern at higher values of 2 (9{13 degrees), while the XRD pattern for $P 2_1 2_1 2_1$ (expt is in better agreem ent at low values of (6{8 degrees). It is possible that under the experi-2 m ental conditions of high tem peratures the m aterial is a polycrystalline m ixture of these two structures or has a con guration in between the two, in which case the di erence between the optical spectra of the two phases would represent a measure of the uncertainty in the optical response of this phase. Despite this fact, we want to point out that in general the di erences in the optical response between the two phases are much more pronounced than \the lattice relaxation e ects" for the $P 2_1 2_1 2_1$ phase making them distinguishable by optical probes.

The optical coe cients in the static lim it are directly measurable quantities. The calculated inequivalent com – ponents of $_1$ (0) and j $^{(2)}$ (0) jare presented in the Table II.

In the C m ca phase, the anisotropy between ${}_{1}^{xx}(0)$ and ${}_{1}^{yy}(0)$ is 54%, and between ${}_{1}^{xx}(0)$ and ${}_{1}^{zz}(0)$ it is 41%. In the I42d phase, the anisotropy between the xx and zz components is 6% only. For the tridym ite phase at experim ental lattice parameters (P $2_12_12_1$ (expt) them axim um anisotropy found between ${}_{1}^{yy}(0)$ and ${}_{1}^{zz}(0)$ (28%), while between ${}_{1}^{xx}(0)$ and ${}_{1}^{zz}(0)$ it is only 1%. In the case of P $2_12_12_1$ (rel the anisotropy between the xx and zz components is 7%, and between the xx and zz components is close to zero.

A mongst the phases under investigation in the present work the anisotropy in the xyz and zyx components of j⁽²⁾(0)j is maximum for P $2_12_12_1$ {expt with 86 % and minimum for I42d with 7%. P $2_12_12_1$ {rel lies in between the two with an anisotropy of 67 %. For SiO₂ in the I42d phase, our calculated values of j⁽²⁾(0)j and j⁽²⁾(0)j are 0.28 and 0.20 10 ⁸ esu, respectively. It may be noted that the anisotropy as well as the magnitude of $\binom{(2)}{1}$ (0) for CO₂ in the P $2_12_12_1$ {expt phase are close to that of SiO₂. The fact that j⁽²⁾(0)jof CO₂ is around 3 tim es larger in the I42d phase, and 5{10 tim es sm aller in the P $2_12_12_1$ {rel phase com pared to SiO₂ makes the distinction between the two phases clear and hence the identi cation of the high pressure phase feasible.


In sum m ary we nd that the optical properties are excellent tools for an unam biguous determ ination of the high pressure phase of CO_2 . Particularly, the second-order response of CO_2 (V com pared to that of SiO₂ can be used for phase determ ination even with the sample inside

the DAC. Experim ents of this kind and a detailed com – parison with the present theoretical results would shed light on the existing discrepancy between theory and experim ents regarding the space group of the CO $_2$ {V phase.

In a first step, the lattice parameters are kept constant at the experimental values and the internal parameters are fully relaxed. This structure is referred to as $P2_12_12_1$ -expt in the present work. Next, the lattice and the internal parameters are simultaneously relaxed (keeping a constant volume [14]) to attain the minimum energy configuration. This structure is referred to as $P2_12_12_1$ -rel. The energy lowering on going from $P2_12_12_1$ -expt to the $P2_12_12_1$ -rel structure is 0.81 eV per formula unit, which is around 0.16 eV more than the previous theoretical value [7]. The larger energy in the present calculations compared to the previous theoretical value could be due to the difference in the method of calculation, since in the previous work the pseudopotential approach was used [7]. In case of the $I\overline{4}2d$ phase, due to the lack of experimental data, the starting lattice constants and internal parameters are taken to be those of SiO_2 in the same phase. Then the atoms as well as the cell volume are fully relaxed to attain the minimum energy configuration. The lattice parameters for all the structures are presented in Table I. In accordance with the previous theoretical work [7, 8] we find β -cristobalite (I $\overline{4}2d$) to be lower in energy compared to the $P2_12_12_1$ -rel phase. The difference in energy between the $P2_12_12_1$ -rel and the theoretically determined $I\overline{4}2d$ phase at 40 GPa is $0.38 \text{ eV}/\text{CO}_2$.




FIG. 1: The magnitude of the linear susceptibility components for solid CO_2 in (a) the Cmca phase, (b) the $I\overline{4}2d$ phase at 40 GPa, (c) the $P2_12_12_1-expt$ structure and (d) the $P2_12_12_1-rel$ structure.

The results for the linear optical spectra of CO_2 in




FIG. 2: The magnitude of the second-harmonic generation susceptibility components xyz and zyx for (a) SiO₂ in the $I\overline{4}2d$ phase, (b) CO₂ in the $I\overline{4}2d$ phase at 40 GPa, (c) in the $P2_12_12_1-expt$ structure and (d) in the $P2_12_12_1-rel$ structure.

various phases are presented in Fig. 1. None of the optical spectra are scissors corrected. Both the $P2_12_12_1$ and the $I\overline{4}2d$ phase are taken at 40 GPa. The *Cmca* phase shows a strong anisotropy with $|\chi_{yy}^{(1)}(\omega)|$ much larger in amplitude than $|\chi_{xx}^{(1)}(\omega)|$, and $|\chi_{zx}^{(1)}(\omega)|$ lying in between the two. The reason for this anisotropy is the orientation of the molecules within the crystal. The neighbouring molecules are parallel to each other in the *ab* plane and form a herringbone pattern in the ac and bc planes [Fig. 2(b) in Ref. 15]. This causes the yy and zz polarized transition matrix elements (TMEs) to be large. On the other hand the xx polarized TMEs are close to zero, leading to small values for $|\chi_{xx}^{(1)}(\omega)|$. $|\chi_{zz}^{(1)}(\omega)|$ is smaller than $|\chi_{yy}^{(1)}(\omega)|$ because the lattice parameter b is smaller than c. On going from the low pressure Cmca phase to any other phase of CO₂-V, $|\chi_{yy}^{(1)}(\omega)|$ and the anisotropy between $|\chi_{yy}^{(1)}(\omega)|$ and $|\chi_{xx}^{(1)}(\omega)|$ decrease dramatically. The latter fact can again be explained by the orientation of the molecules inside the unit cell [Fig. 3E and 3F in Ref. 8]. The neighbouring CO_2 molecules are no more parallel or perpendicular in any direction leading to a weakening of the very strong transitions and an enhancement of the TMEs which were forbidden in the Cmca phase. For all the probable phases of CO_2 -V the spectral weights are shifted to higher energies. The optical band gap of the $P2_12_12_1$ -expt structure is smaller than that of the Cmca phase, while the other two structures show almost equal optical band gaps, which are higher than that of the Cmca phase. Compared to the Cmca phase the maximum peak height is around 3 times smaller in the $I\overline{4}2d$ phase, while it is about 4 times smaller in the $P2_12_12_1$ structures. Beyond 11 eV, the response of all the probable phases of CO_2 -V is on average similar in magnitude, but differs in the amount of anisotropy.

For $I\overline{4}2d$ there are two independent tensor components. Compared to the zz component, the xx component is approximately up to 2 times as large in the energy range below 10 eV. Upto 10.5 eV and between 11.5 and 13 eV the effect is opposite, while the two are nearly the same for higher energies. For the $P2_12_12_1$ structures there are three inequivalent components and the anisotropy between the xx and zz components is very small compared to the $I\overline{4}2d$ phase. We also find the lattice relaxation effects which have already been described in detail by Dong *et al.* [7]. They have some consequences for the optical spectra. On going from the Cmcaphase to $P2_12_12_1$ -expt, the optical band gap decreases, while it increases in case of $P2_12_12_1$ -rel. Another noticeable feature is that the anisotropy is much larger in the $P2_12_12_1$ -expt structure. Since CO₂-V is not quenchable into ambient pressure at room temperature the optical measurements need to be performed with the sample inside the diamond anvil cell (DAC). The band gap of diamond is 5.5eV. Therefore the energy regime below 5.5eV is most interesting, since the optical response in this energy regime is purely from the sample inside the DAC. The difference between the linear optical spectra of various probable phases of CO_2 below this energy range is not as pronounced as in the higher energy regime. The results though are of theoretical interest and help in identification of various features in the nonlinear optical spectra (which is rather difficult to do from the band structure plots), but may not be very good in phase distinction under these experimental conditions.

The nonlinear optical properties are much more sensitive to small changes in the band structure than the linear optical spectra. The calculated magnitude of the SHG susceptibility by CO_2 -V in various probable phases are presented in Fig. 2. Due to the presence of inversion symmetry in the Cmca phase the SHG susceptibility is zero. The second-order response of SiO_2 ($I\overline{4}2d$), which is often used as standard in SHG experiments, is also presented in the figure. In the energy range between 3 and 5.5 eV the magnitude of the SHG susceptibility by CO_2 in the $P2_12_12_1$ -expt phase is 1.5-2 times smaller than that of quartz. On the other hand the $I\overline{4}2d$ phase of CO_2 shows a SHG susceptibility 3–4 times larger than that of SiO_2 . These pronounced differences make the phases easily identifiable. The energy range of 3-5.5 eV lies below the band gap of diamond and corresponds to laser light of wavelengths between 413.3 - 247.9 nm. Previous SH experiments were performed using laser light of 1054 nm wavelength [1], which correspond to 1.176 eV. At this energy our calculated value of $|\chi_1^{(2)}(2\omega, \omega, \omega)|$ for CO₂ in the $I\overline{4}2d$ phase is 2.7 times larger than that of SiO₂. While, the SHG susceptibility by CO_2 in the $P2_12_12_1$ expt phase is 2.6 times smaller than that of SiO₂. The previous experimental work [5] reports the SH conversion efficiency of the CO₂–V phase, which is not just proportional to the square of the SHG susceptibility but also depends on the input intensity and sample parameters. So no direct comparison of the existing experimental data can be made with the present results. Since the difference in the second-order response by the probable phases of CO_2 -V are more pronounced in the energy range between 3 and 5.5 eV than in between 1-2 eV, experiments at higher energies would be favourable. Experimental determination of the SHG susceptibility by CO_2-V and SiO₂, over some frequency range, and a comparison with our work could lead to conclusive results.

The two structures of the $P2_12_12_1$ phase are also differentiable by their SHG response. Due to the large optical band gap of $P2_12_12_1$ -rel the SHG susceptibility is approximately 3 times smaller than that of $P2_12_12_1-expt$. As shown in Ref. 7 the XRD patterns for neither of these structures matches the experiments. The theoretically calculated XRD pattern of $P2_12_12_1-rel$ shows a better agreement with the experimental XRD pattern at higher values of 2θ (9–13 degrees), while the XRD pattern for $P2_12_12_1$ -expt is in better agreement at low values of 2θ (6–8 degrees). It is possible that under the experimental conditions of high temperatures the material is a polycrystalline mixture of these two structures or has a configuration in between the two, in which case the difference between the optical spectra of the two phases would represent a measure of the uncertainty in the optical response of this phase. Despite this fact, we want to point out that in general the differences in the optical response between the two phases are much more pronounced than "the lattice relaxation effects" for the

 $P2_12_12_1$ phase making them distinguishable by optical probes.

The optical coefficients in the static limit are directly measurable quantities. The calculated inequivalent components of $\epsilon_1(0)$ and $|\chi^{(2)}(0)|$ are presented in the Table II.

In the Cmca phase, the anisotropy between $\epsilon_1^{xx}(0)$ and $\epsilon_1^{yy}(0)$ is 54%, and between $\epsilon_1^{xx}(0)$ and $\epsilon_1^{zz}(0)$ it is 41%. In the $I\overline{4}2d$ phase, the anisotropy between the xx and zz components is 6% only. For the tridymite phase at experimental lattice parameters $(P2_12_12_1-expt)$ the maximum anisotropy found between $\epsilon_1^{yy}(0)$ and $\epsilon_1^{zz}(0)$ (28%), while between $\epsilon_1^{xx}(0)$ and $\epsilon_1^{zz}(0)$ it is only 1%. In the case of $P2_12_12_1-rel$ the anisotropy between the xx and yy components is 7%, and between the xx and zz components is close to zero.

Amongst the phases under investigation in the present work the anisotropy in the xyz and zyx components of $|\chi^{(2)}(0)|$ is maximum for $P2_12_12_1-expt$ with 86 % and minimum for $I\overline{4}2d$ with 7%. $P2_12_12_1-rel$ lies in between the two with an anisotropy of 67 %. For SiO₂ in the $I\overline{4}2d$ phase, our calculated values of $|\chi^{(2)}_{xyz}(0)|$ and $|\chi^{(2)}_{zyx}(0)|$ are 0.28 and 0.20 ×10⁻⁸ esu, respectively. It may be noted that the anisotropy as well as the magnitude of $\chi^{(2)}_1(0)$ for CO₂ in the $P2_12_12_1-expt$ phase are close to that of SiO₂. The fact that $|\chi^{(2)}(0)|$ of CO₂ is around 3 times larger in the $I\overline{4}2d$ phase, and 5–10 times smaller in the $P2_12_12_1-rel$ phase compared to SiO₂ makes the distinction between the two phases clear and hence the identification of the high pressure phase feasible.

In summary we find that the optical properties are excellent tools for an unambiguous determination of the high pressure phase of CO_2 . Particularly, the secondorder response of CO_2 -V compared to that of SiO_2 can be used for phase determination even with the sample inside the DAC. Experiments of this kind and a detailed comparison with the present theoretical results would shed light on the existing discrepancy between theory and experiments regarding the space group of the CO_2-V phase.
